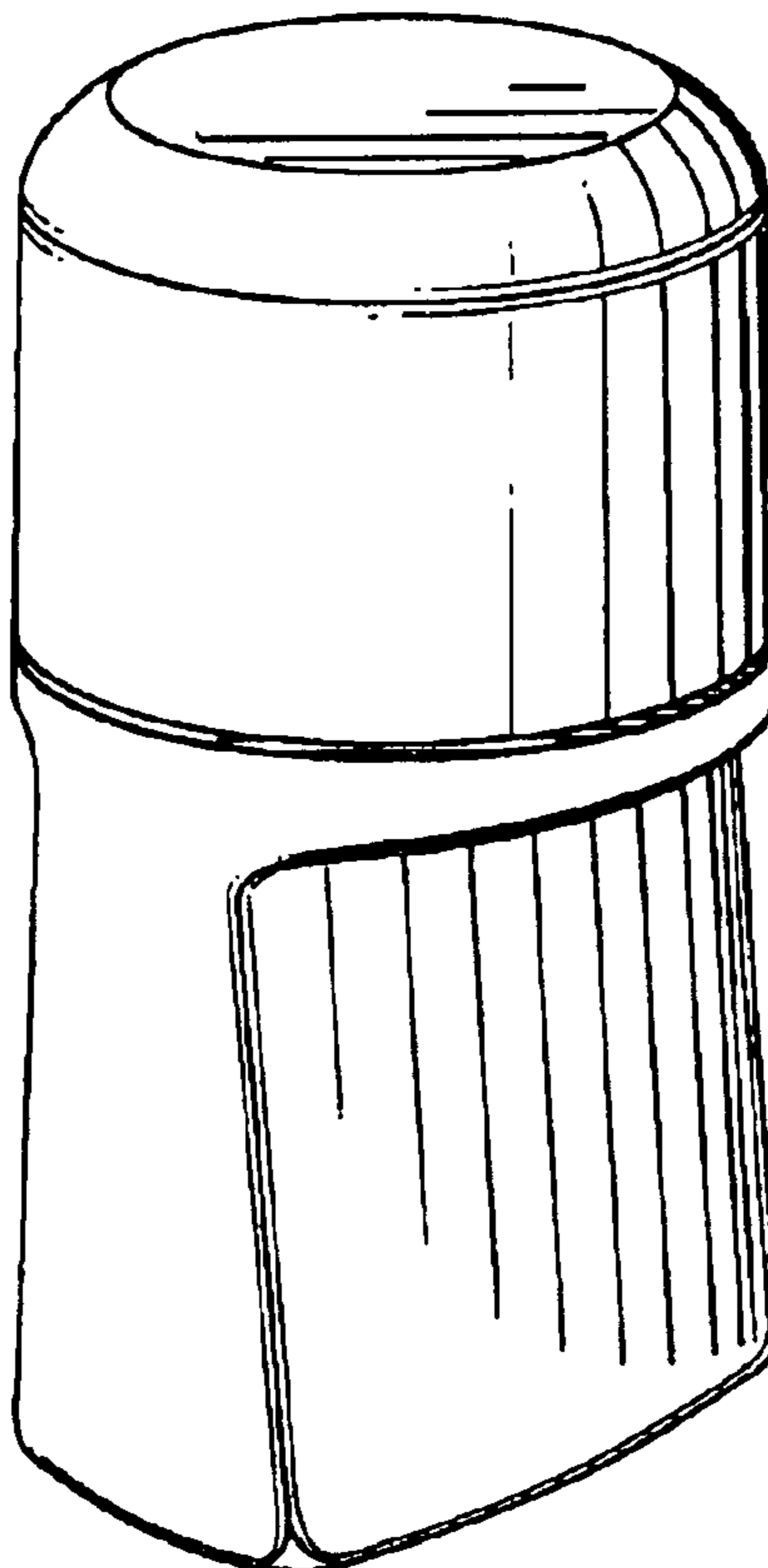
(57) **CLAIM**

The ornamental design for a bottle, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of the bottle of the design;
FIG. 2 is a front elevational view thereof;
FIG. 3 is a side elevational view as seen from the right hand
side of FIG. 1;
FIG. 4 is a top plan view thereof;
FIG. 5 is a rear elevational view thereof; and,
FIG. 6 is a side elevational view as seen from the left hand
side of FIG. 1.

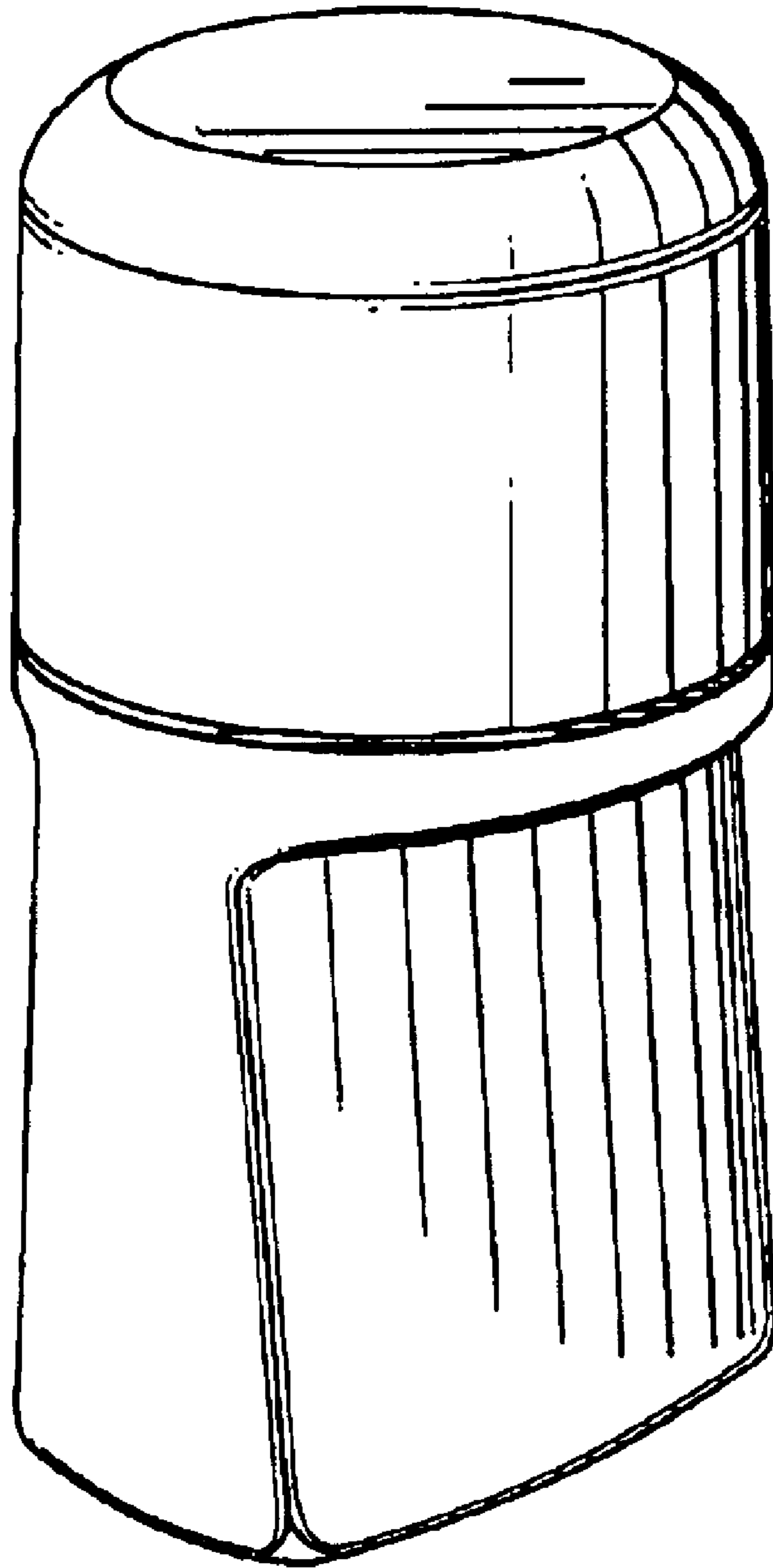

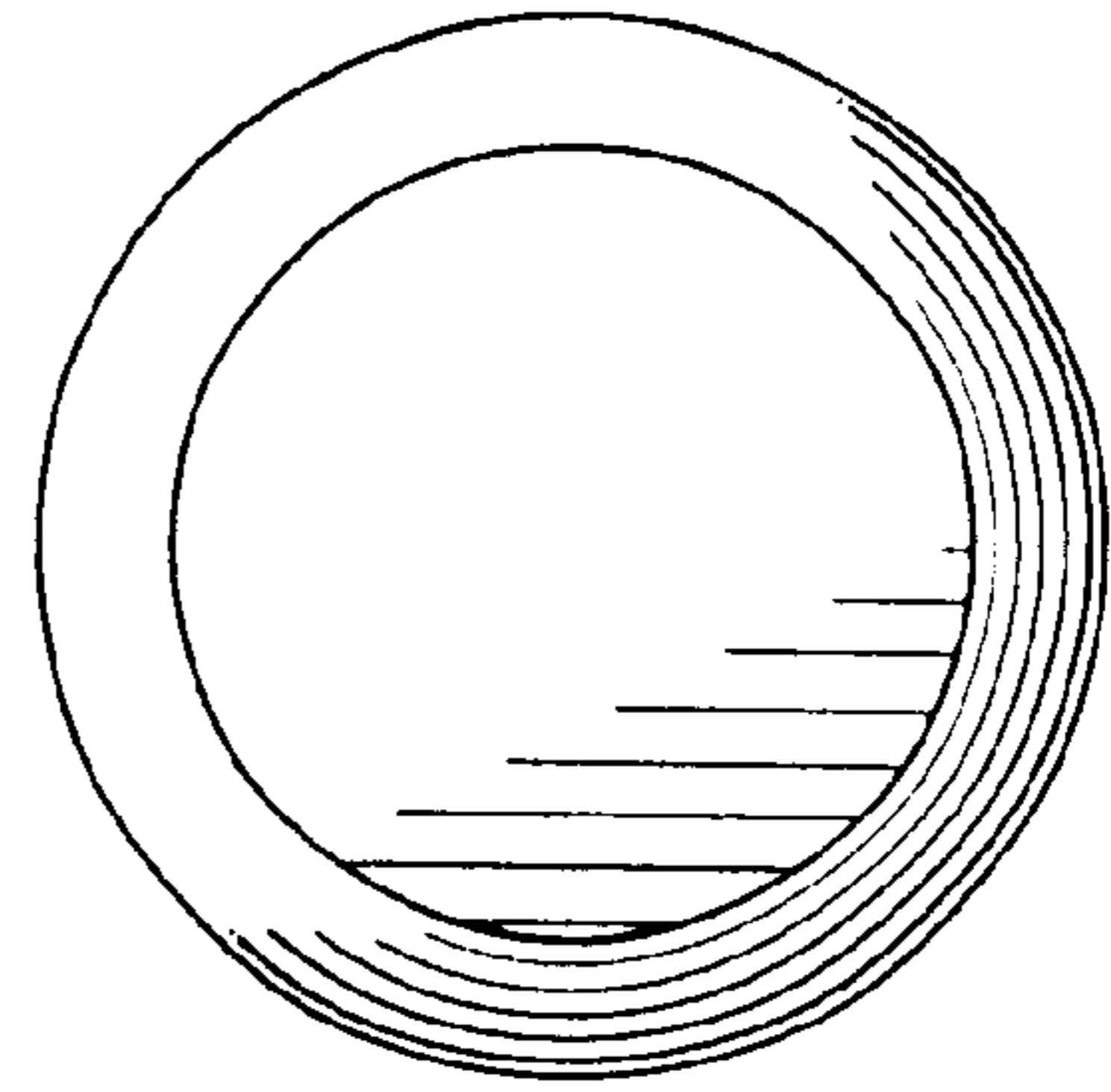

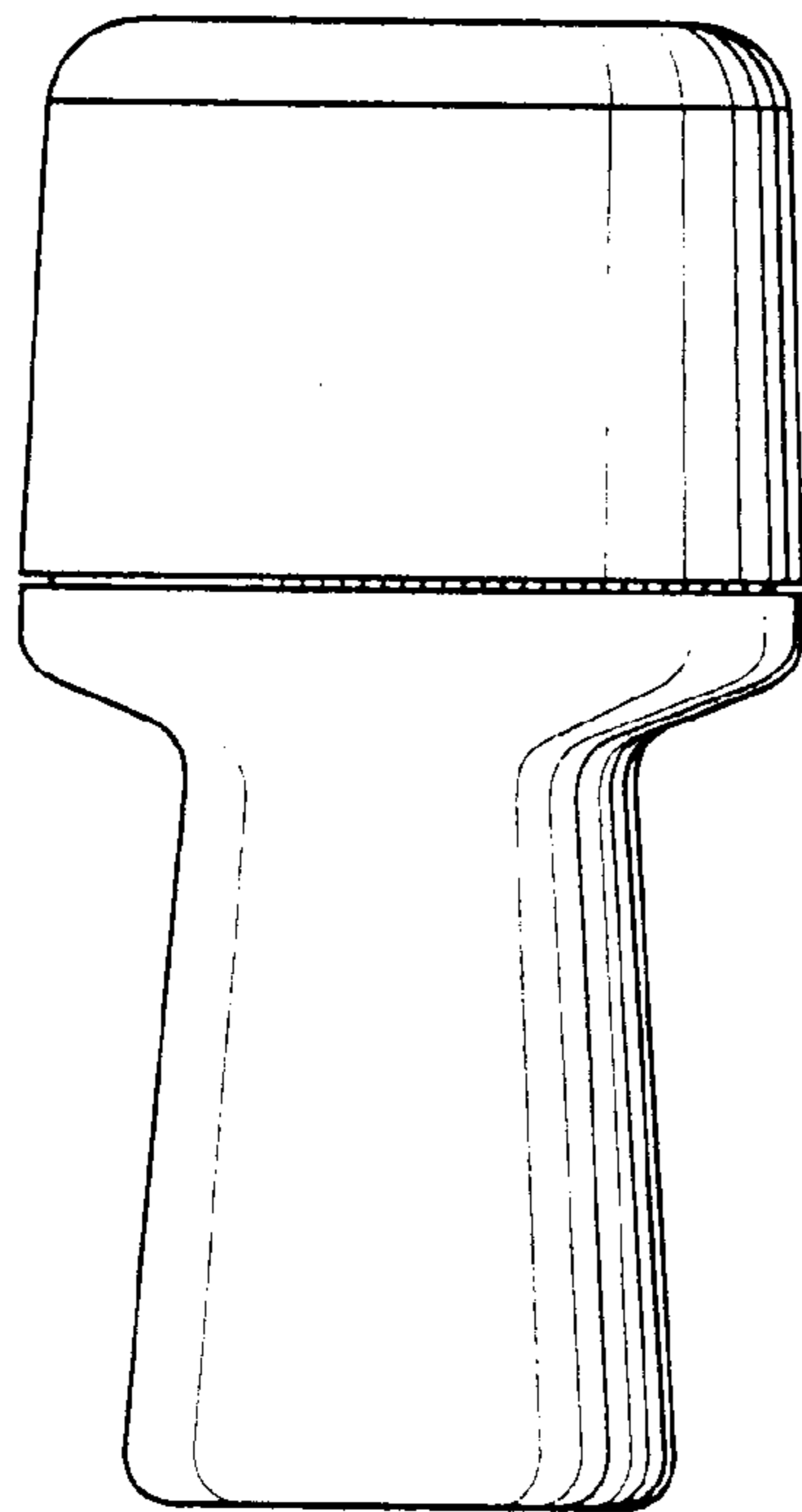

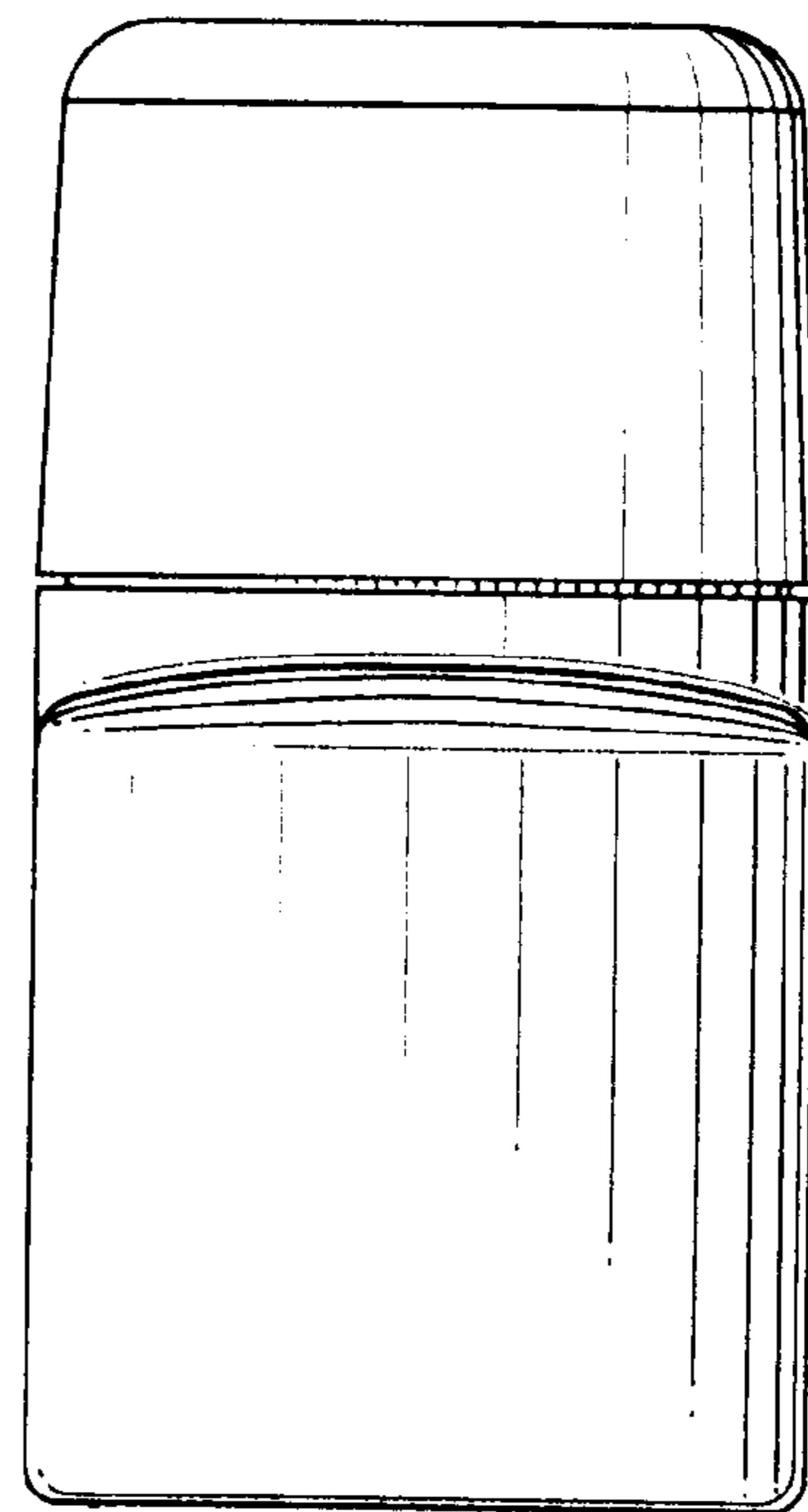

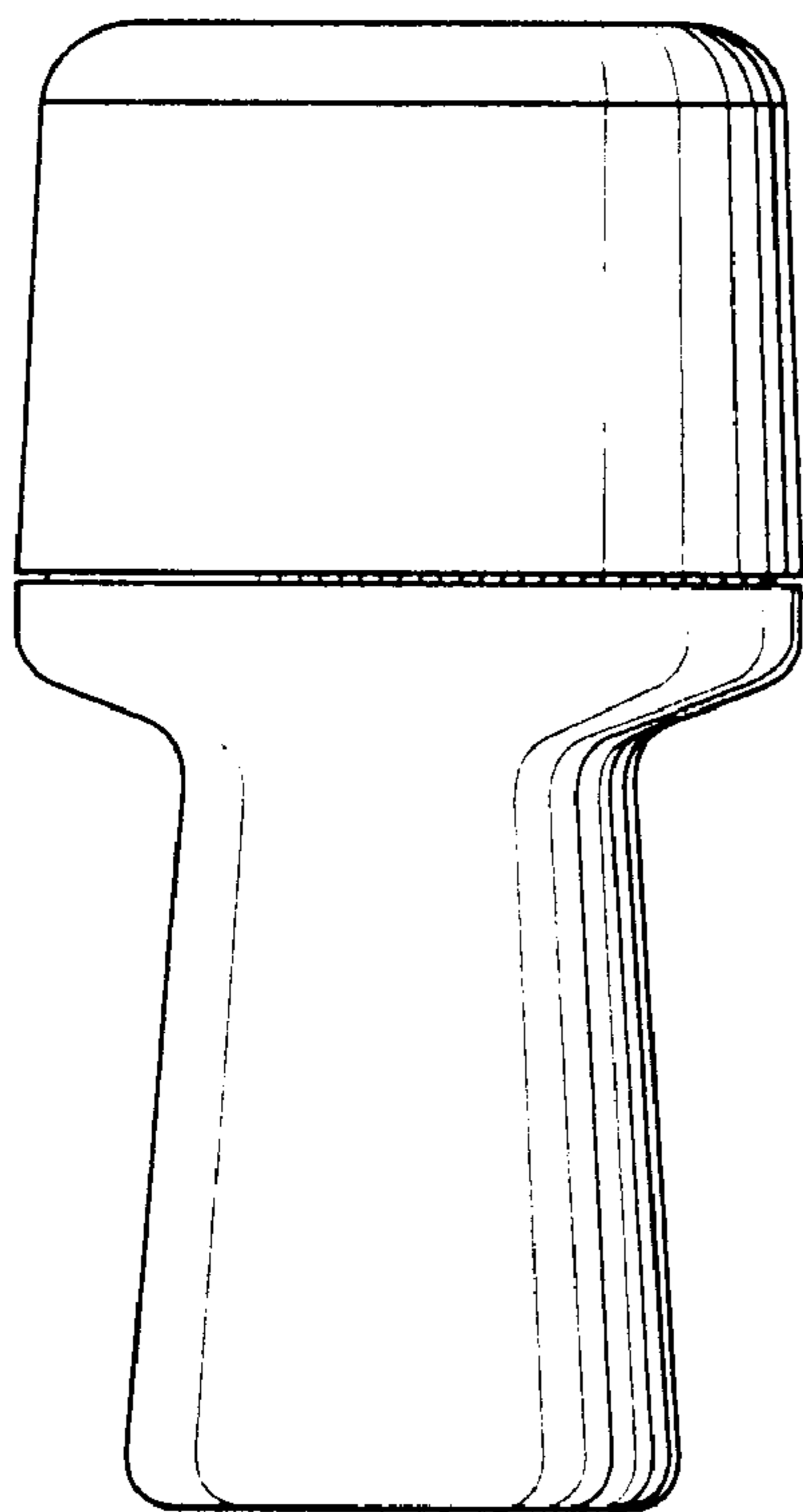

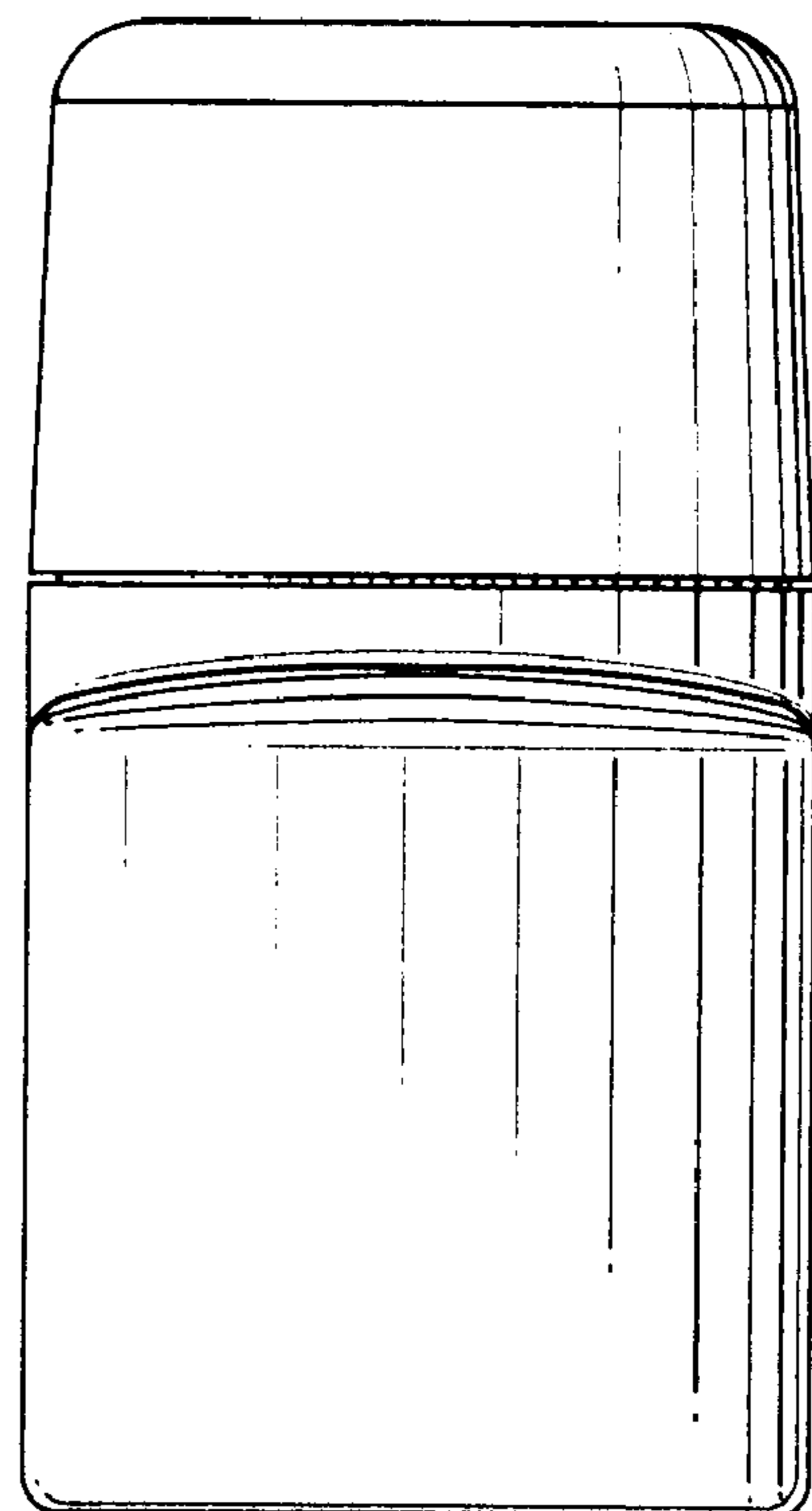
