DESCRIPTION

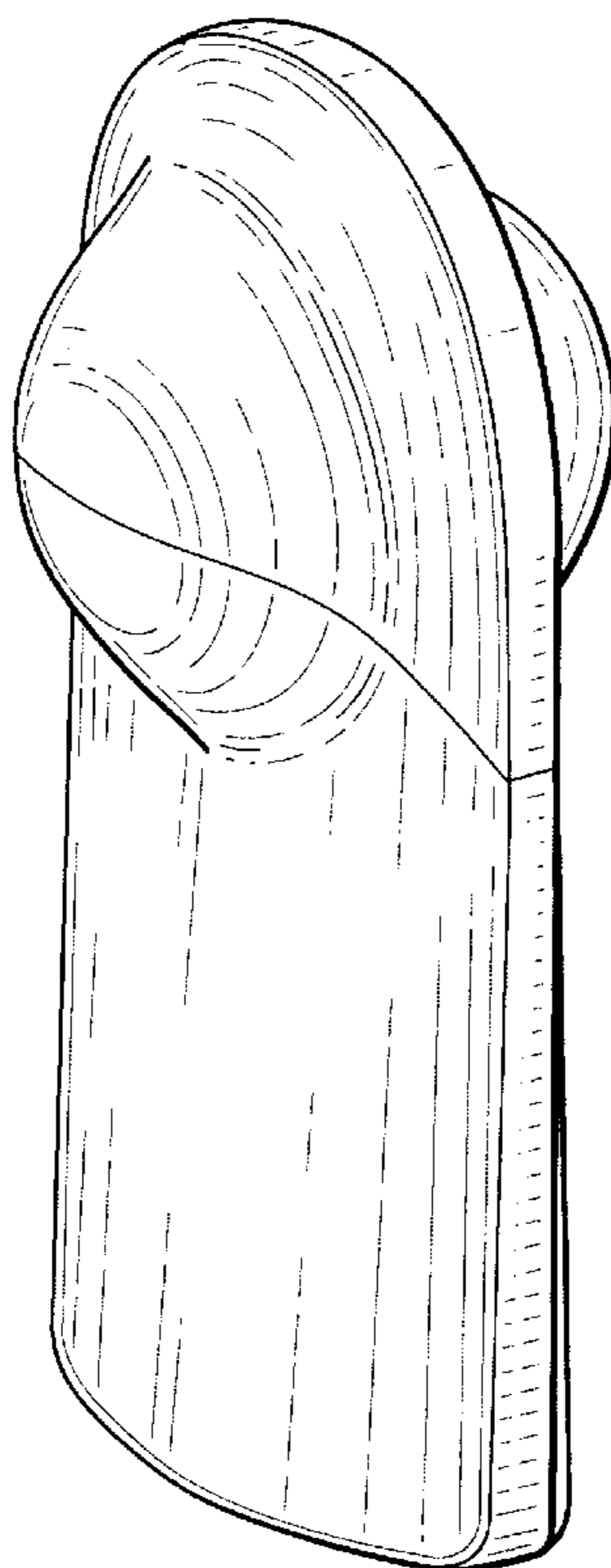
FIG. 1 is a perspective view of the dispenser of our design;

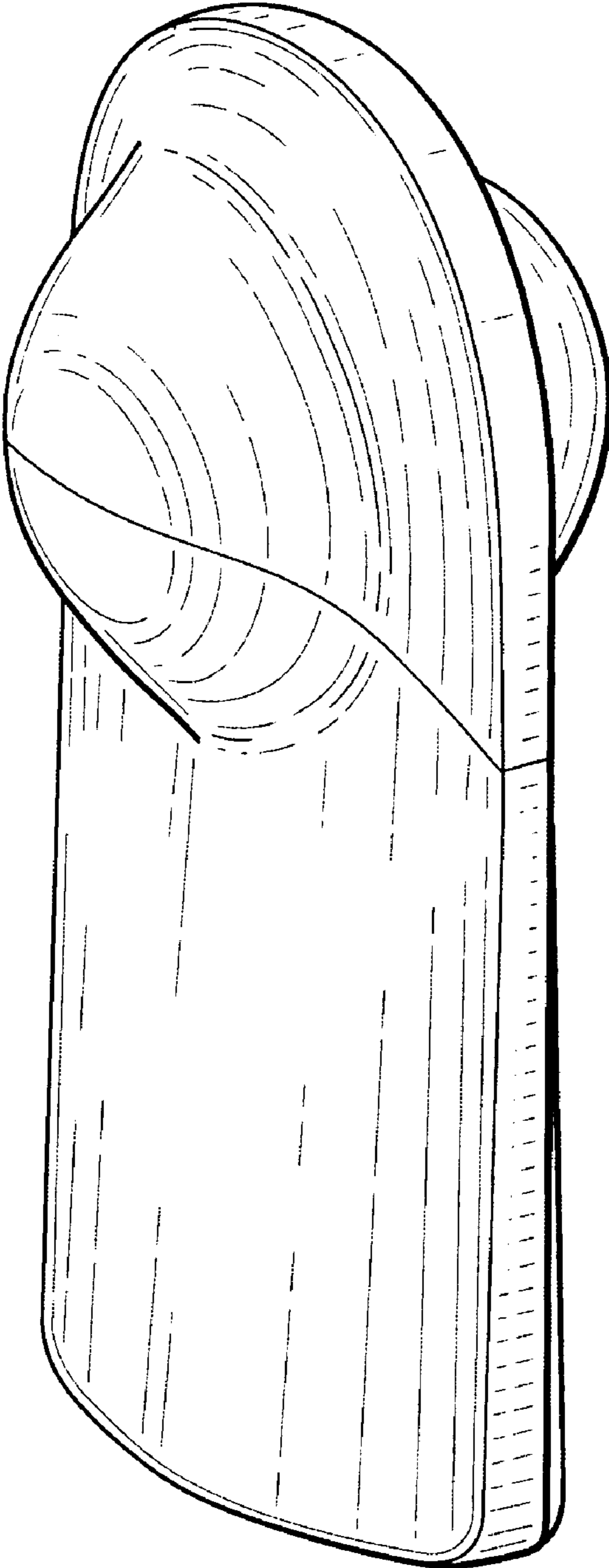

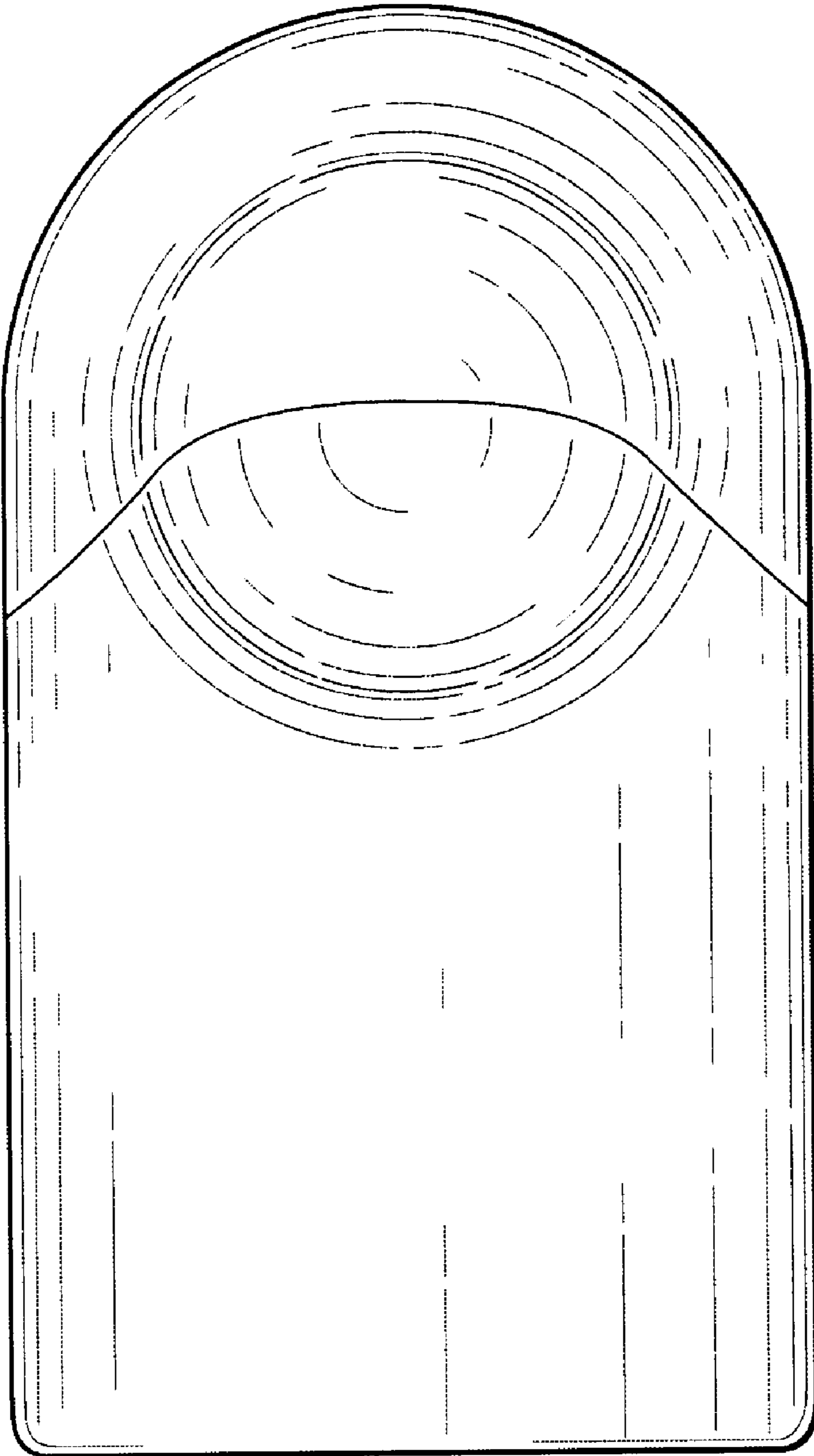

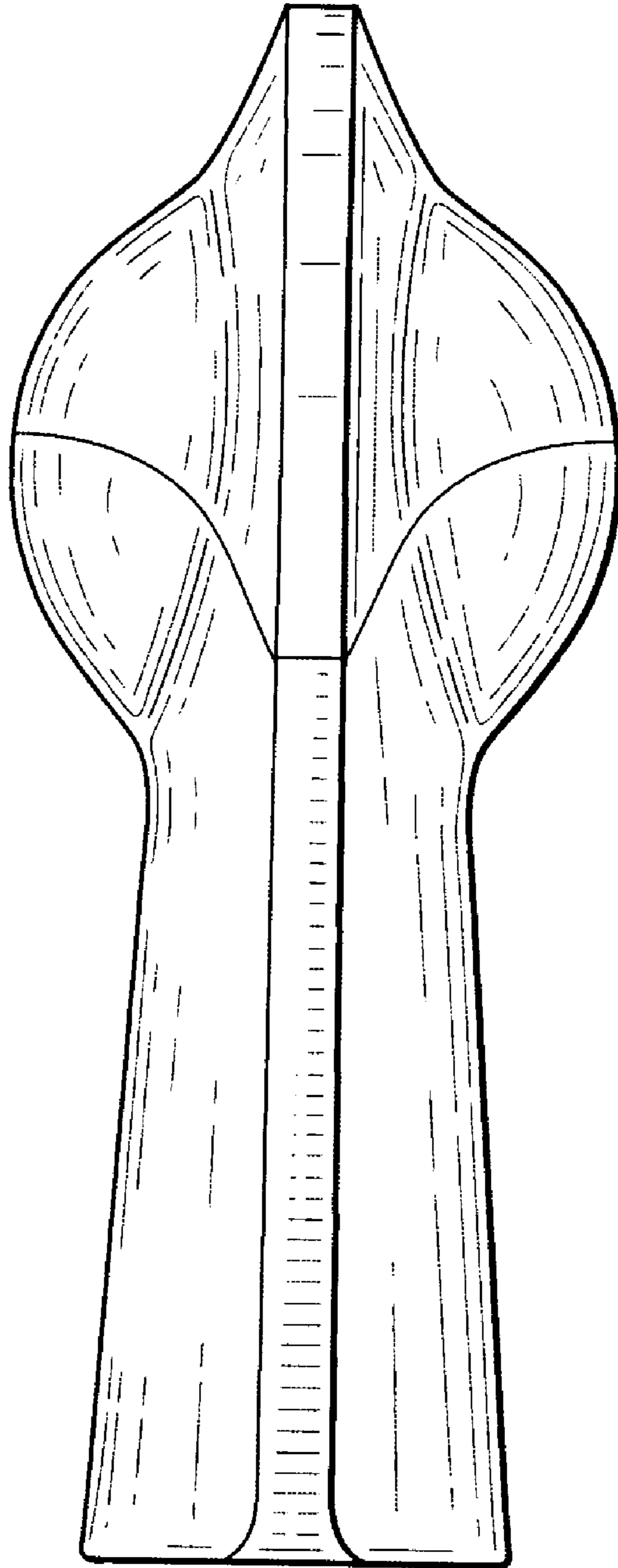

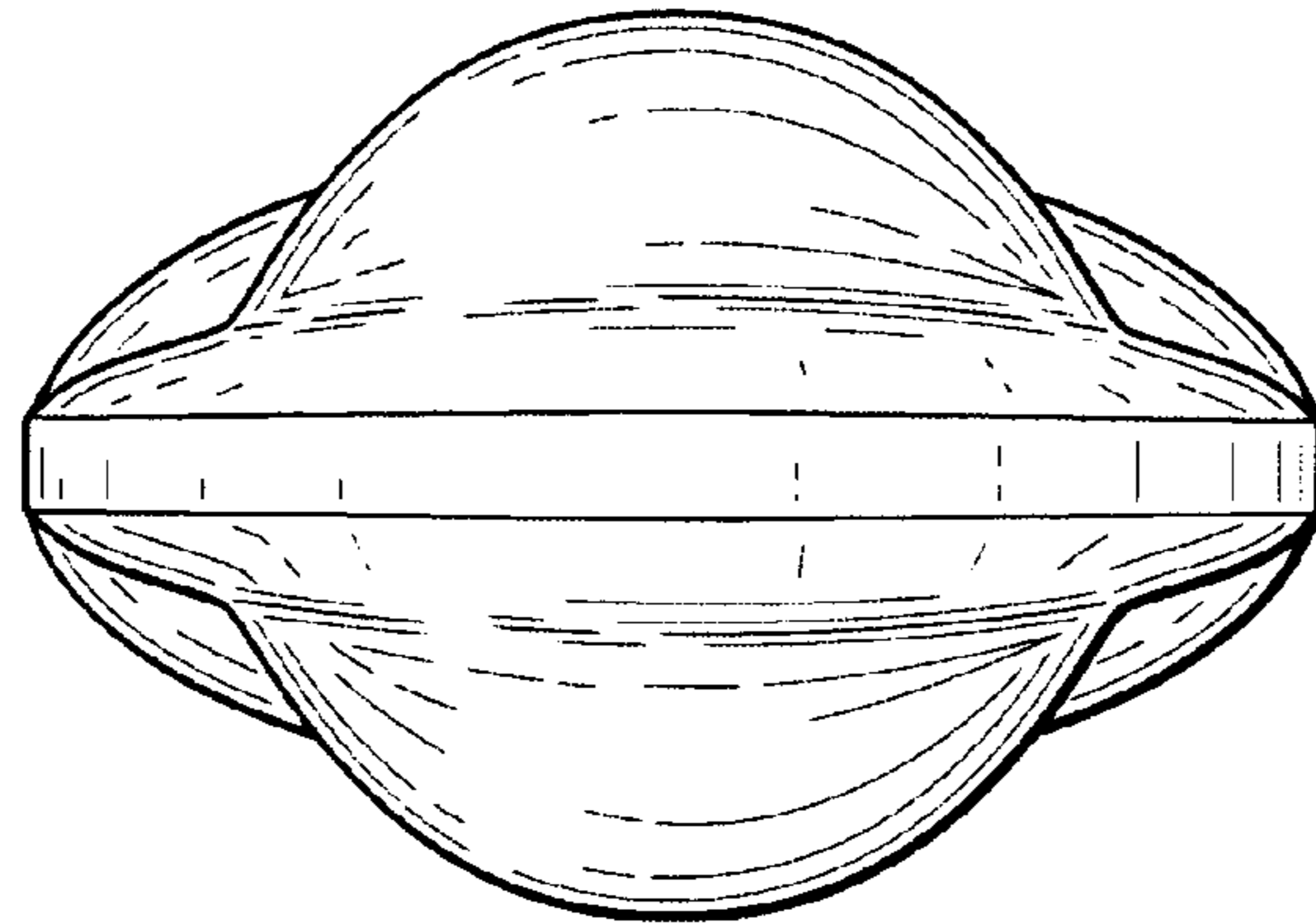

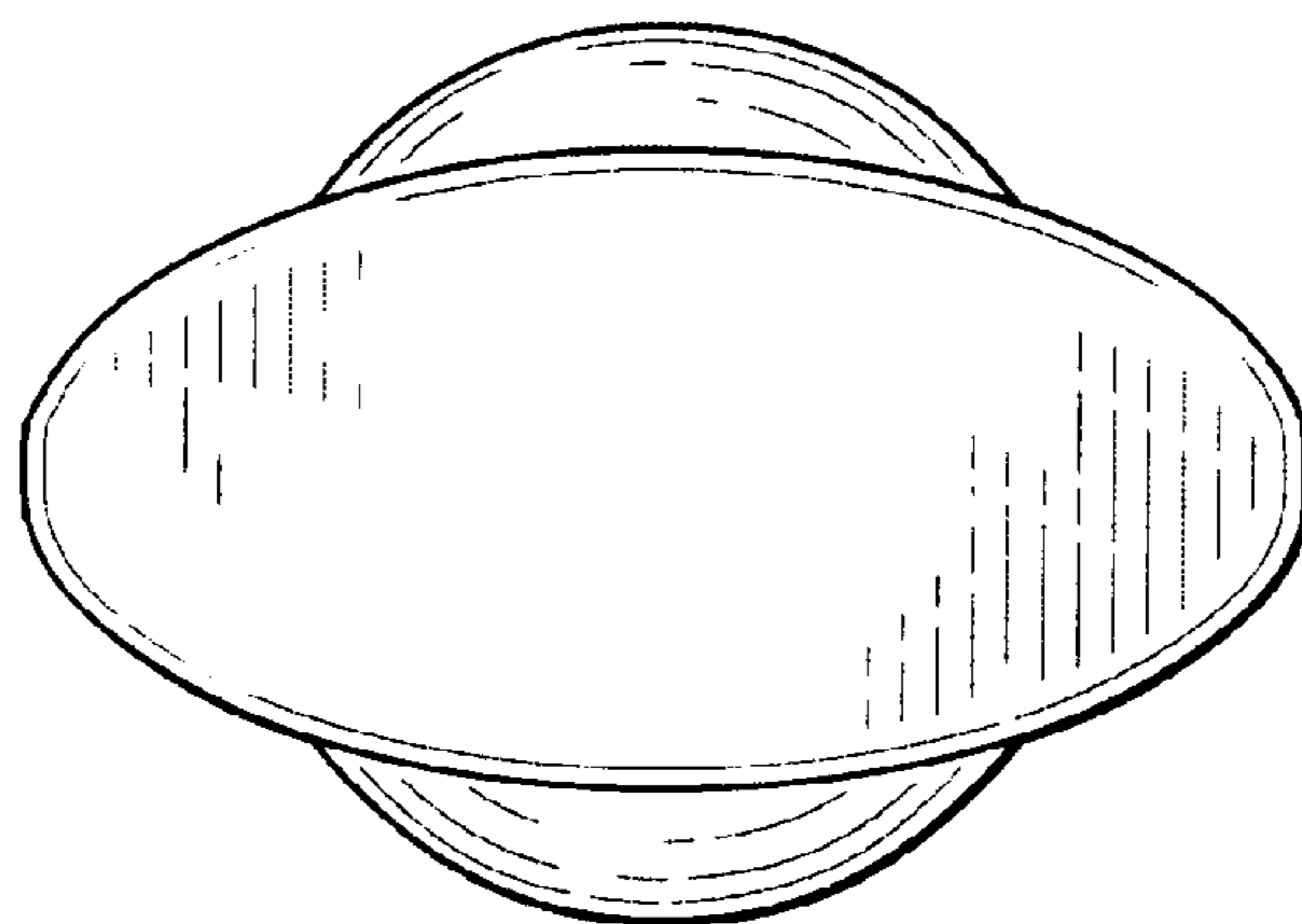
