FIG. 5 shows the rear side view thereof;

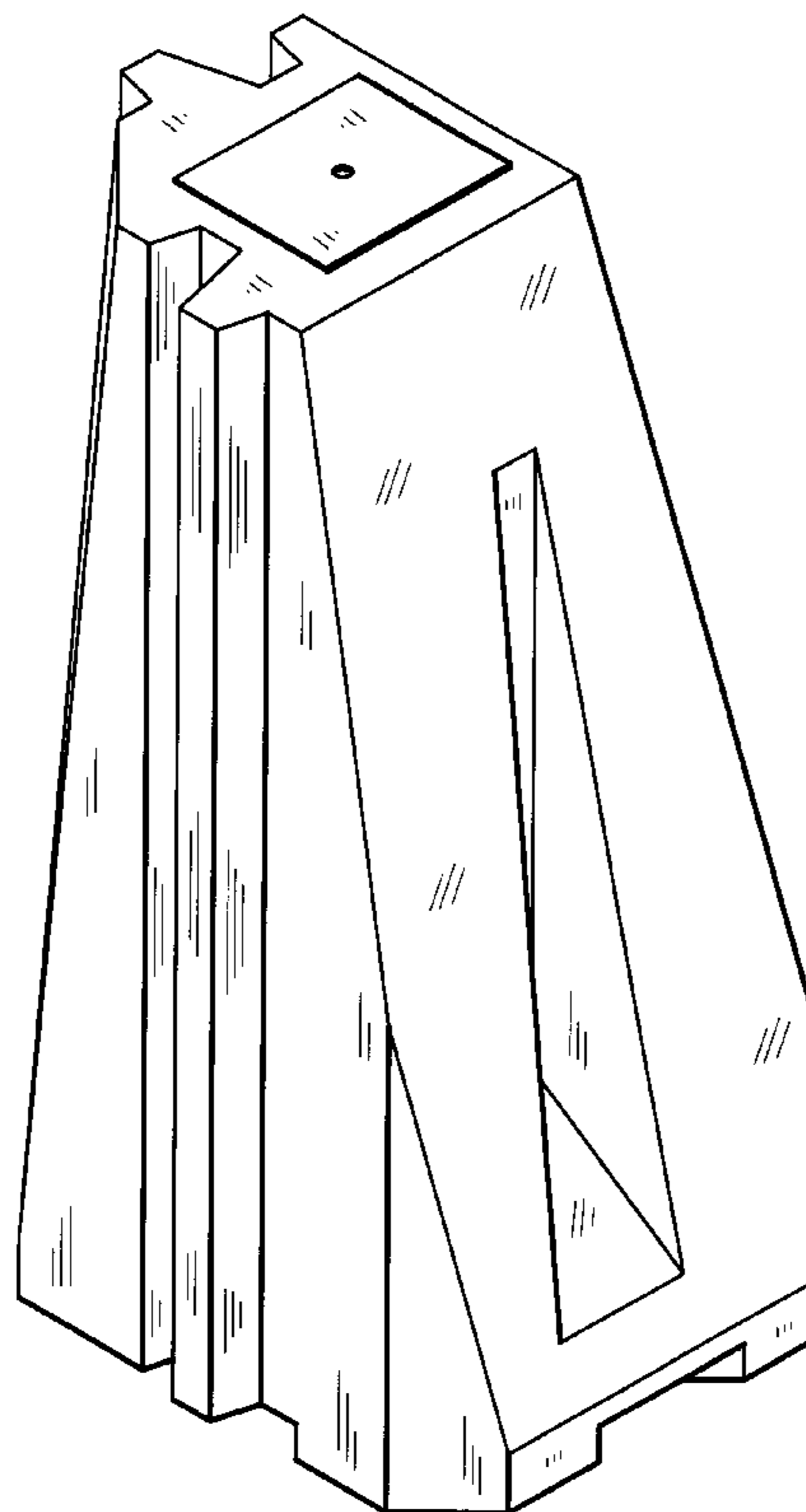
FIG. 6 shows the top view thereof;

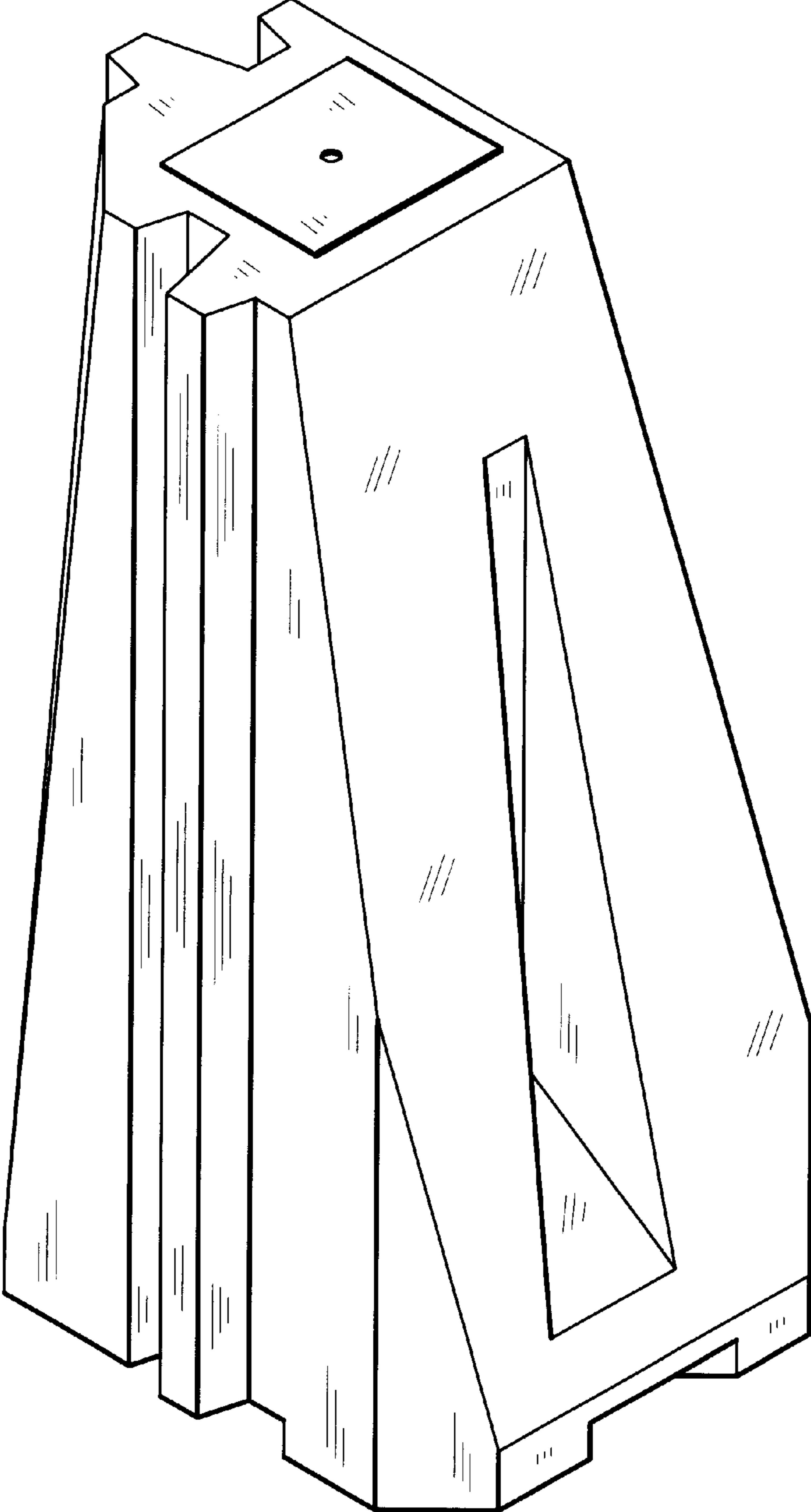

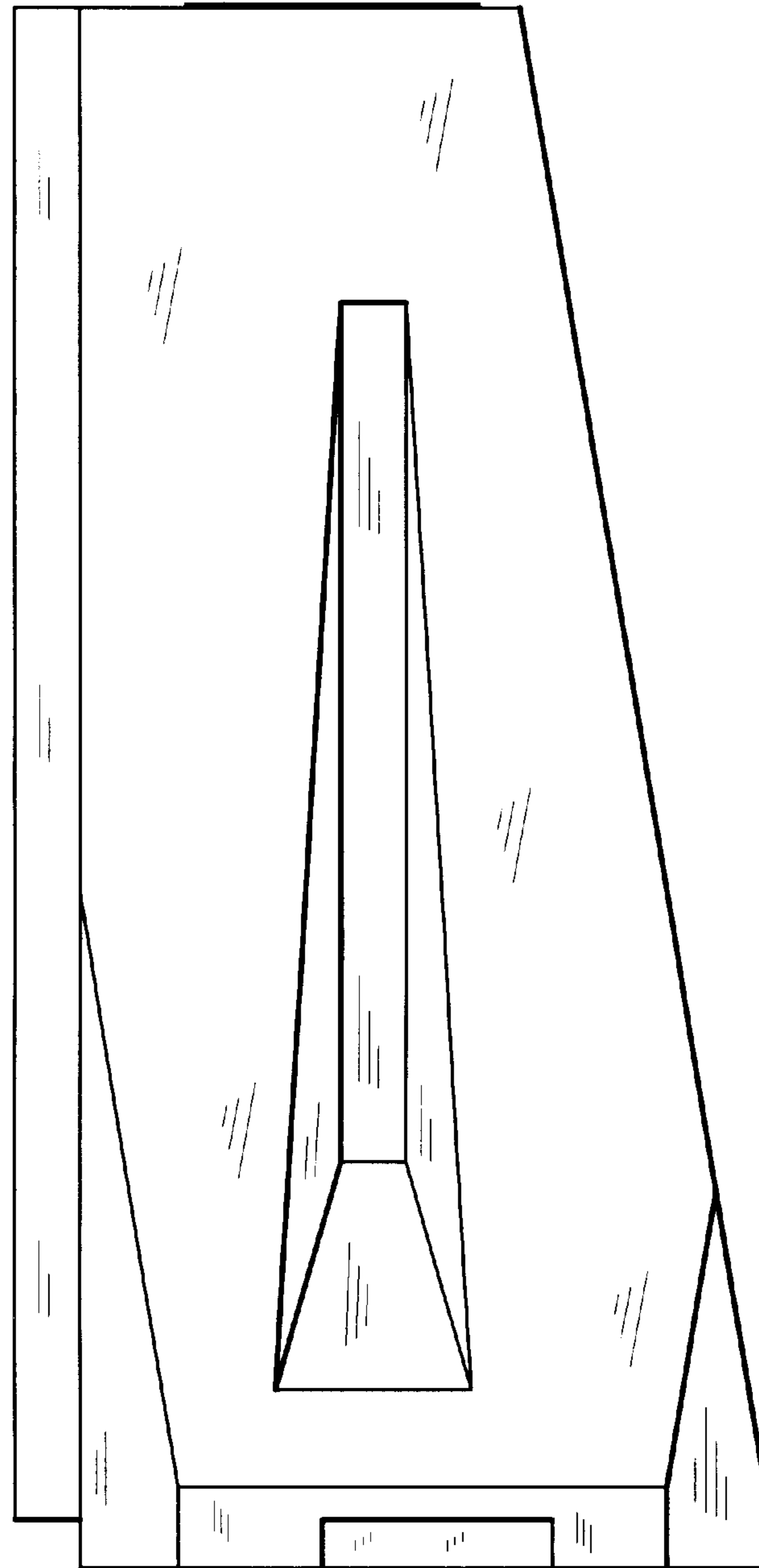

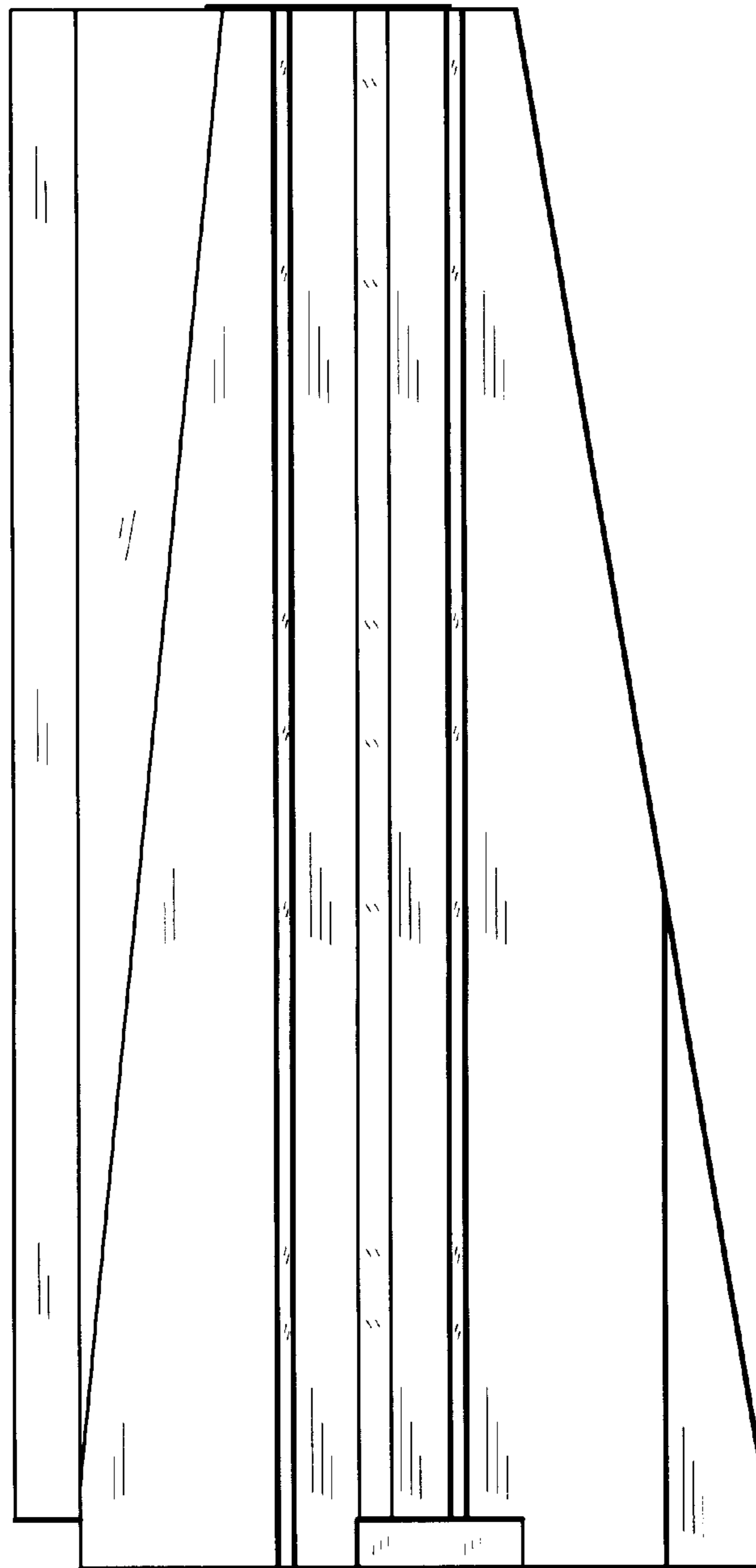

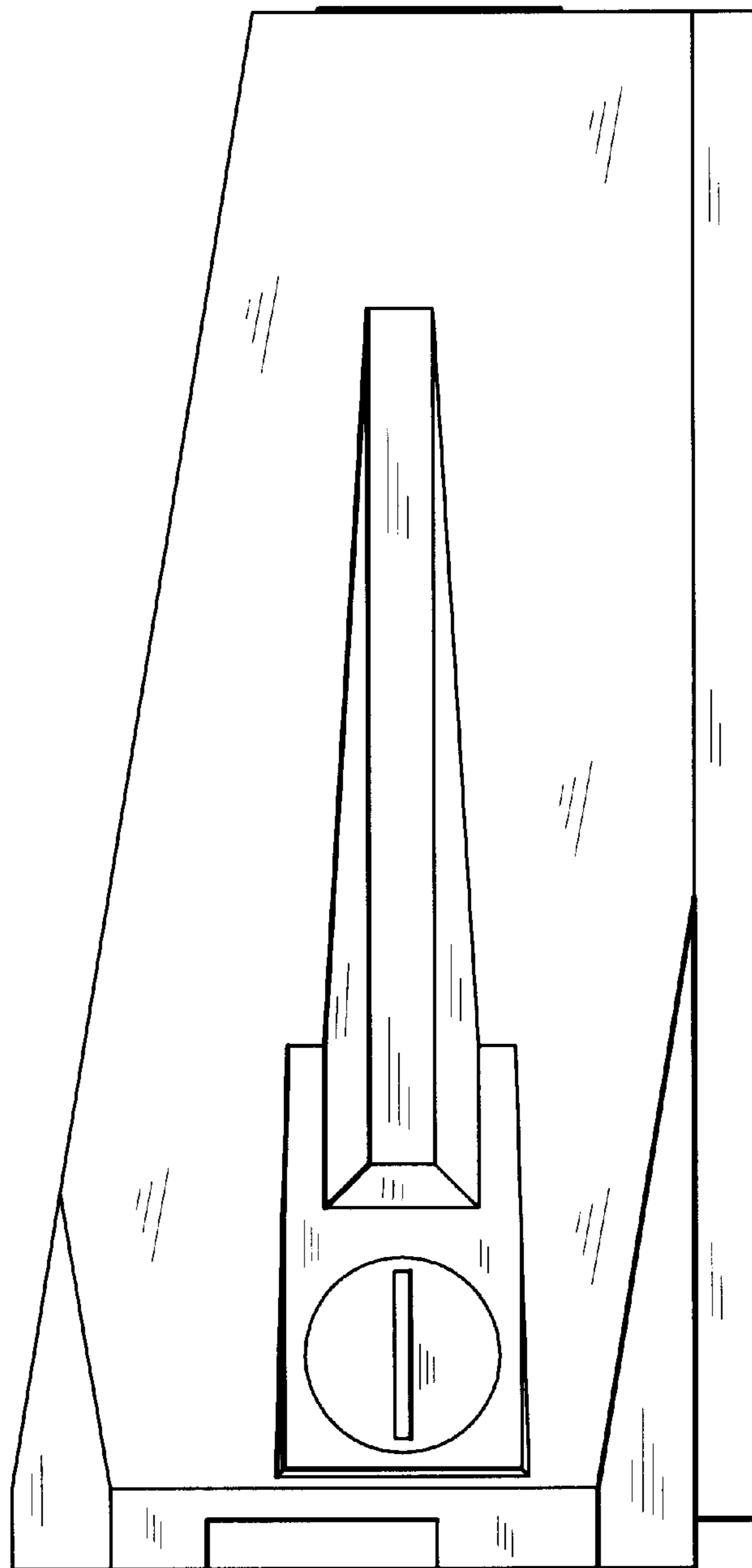

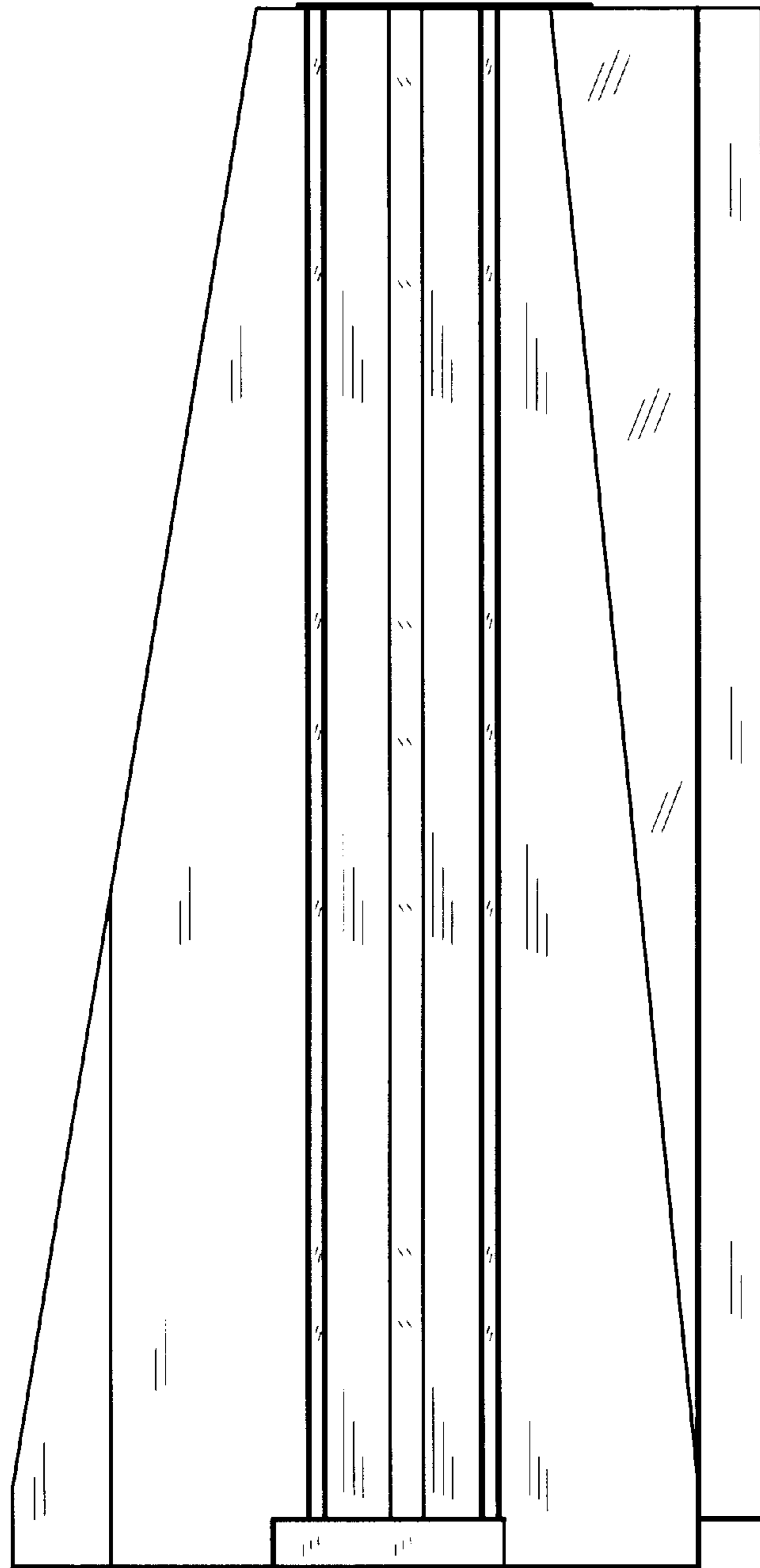

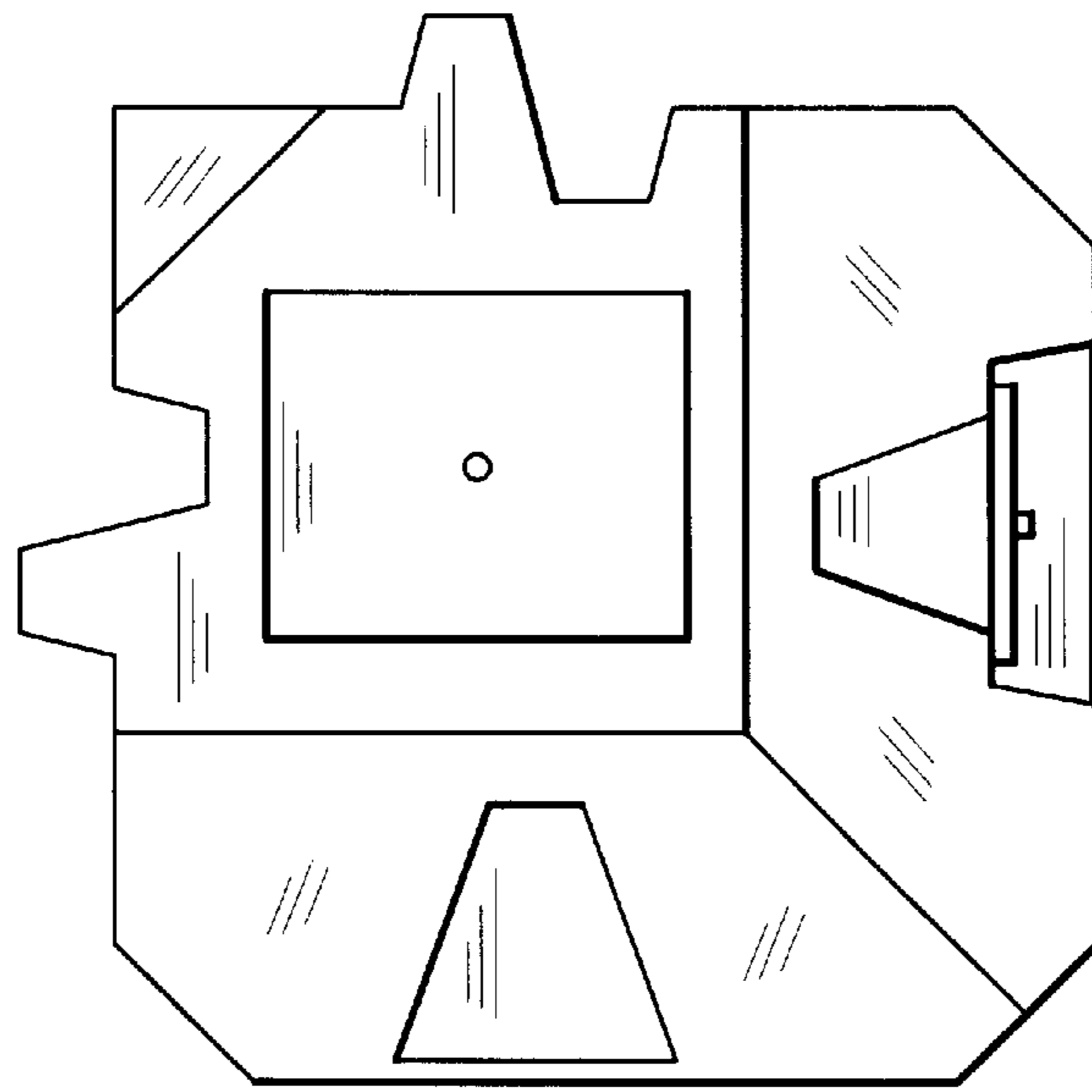

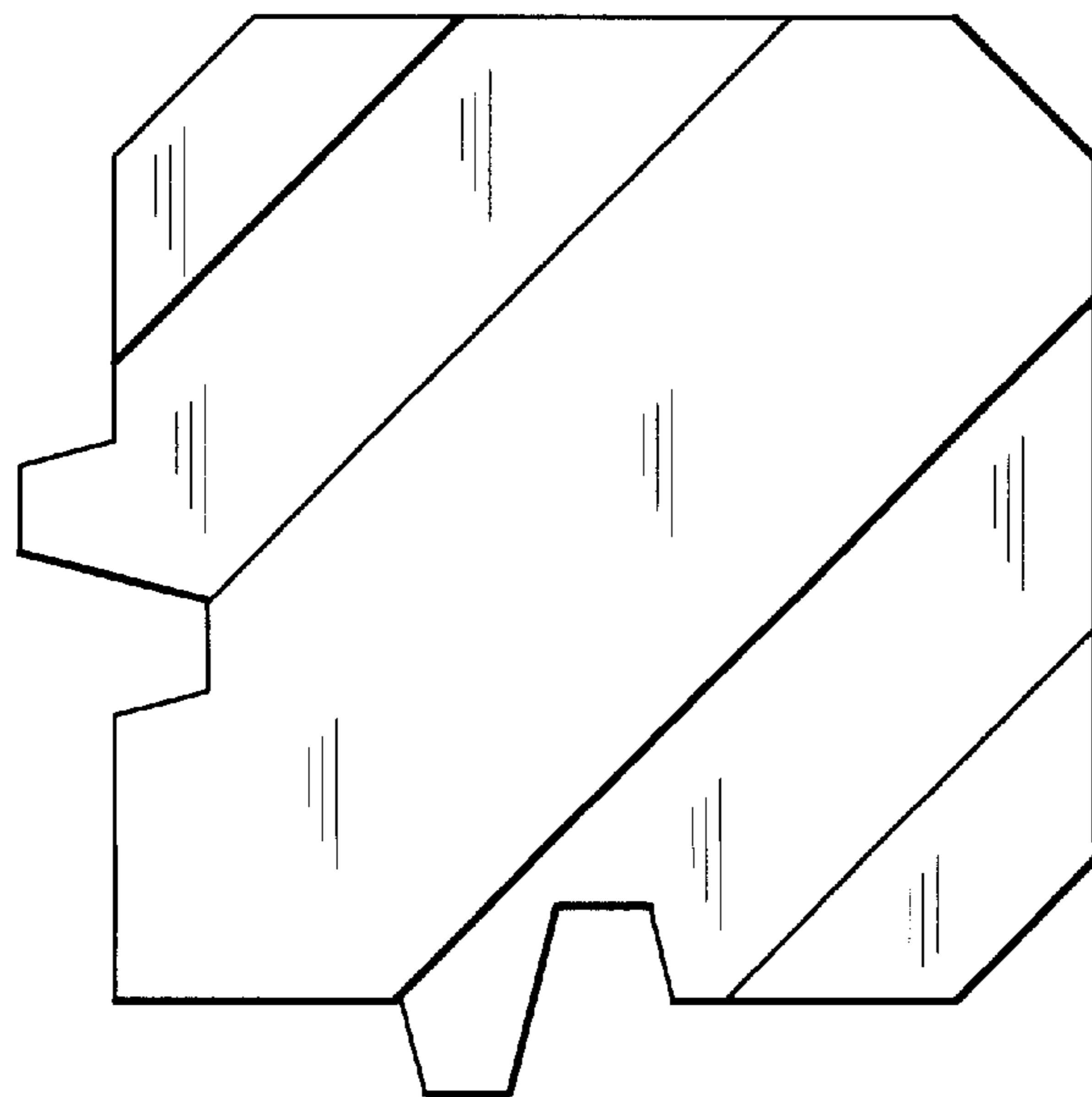

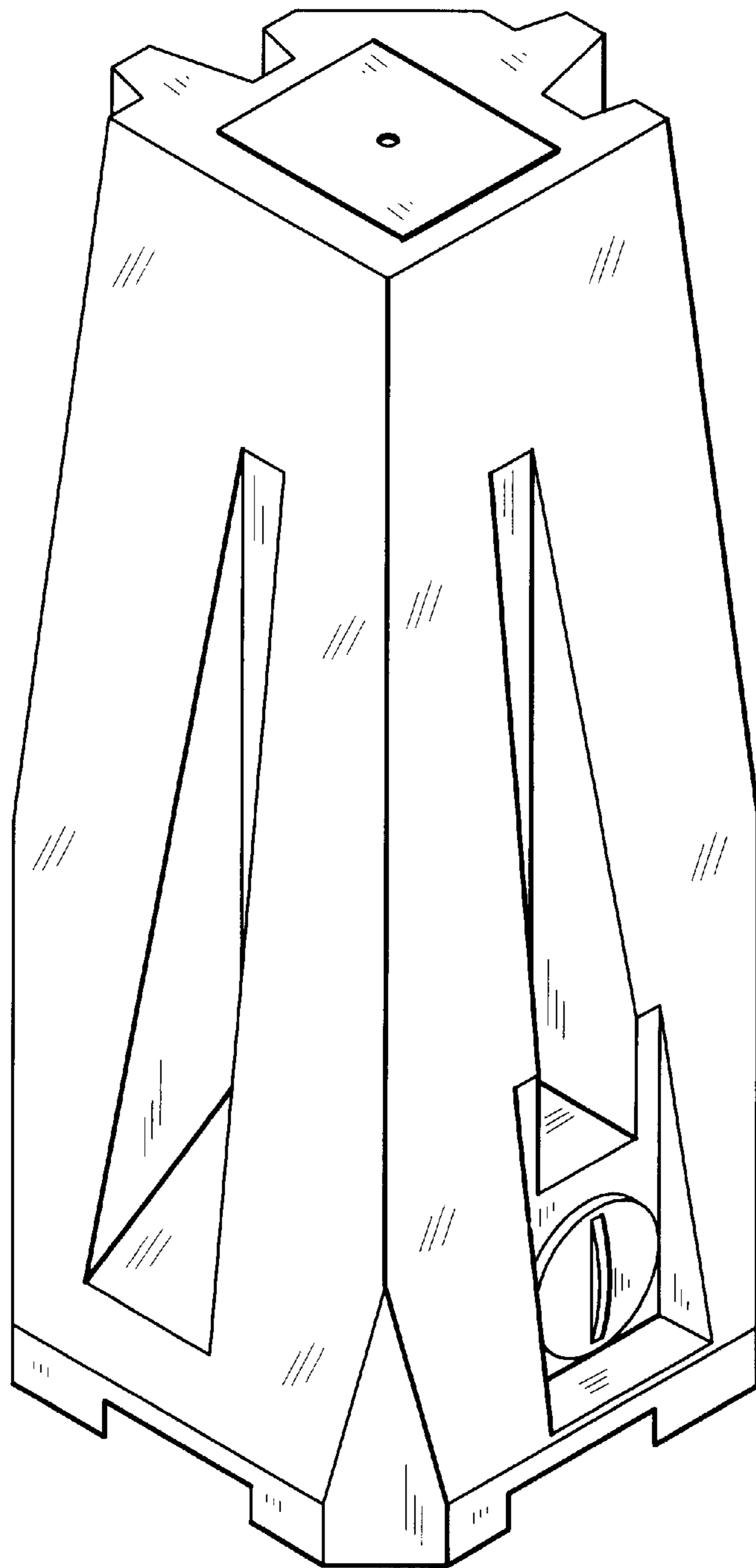

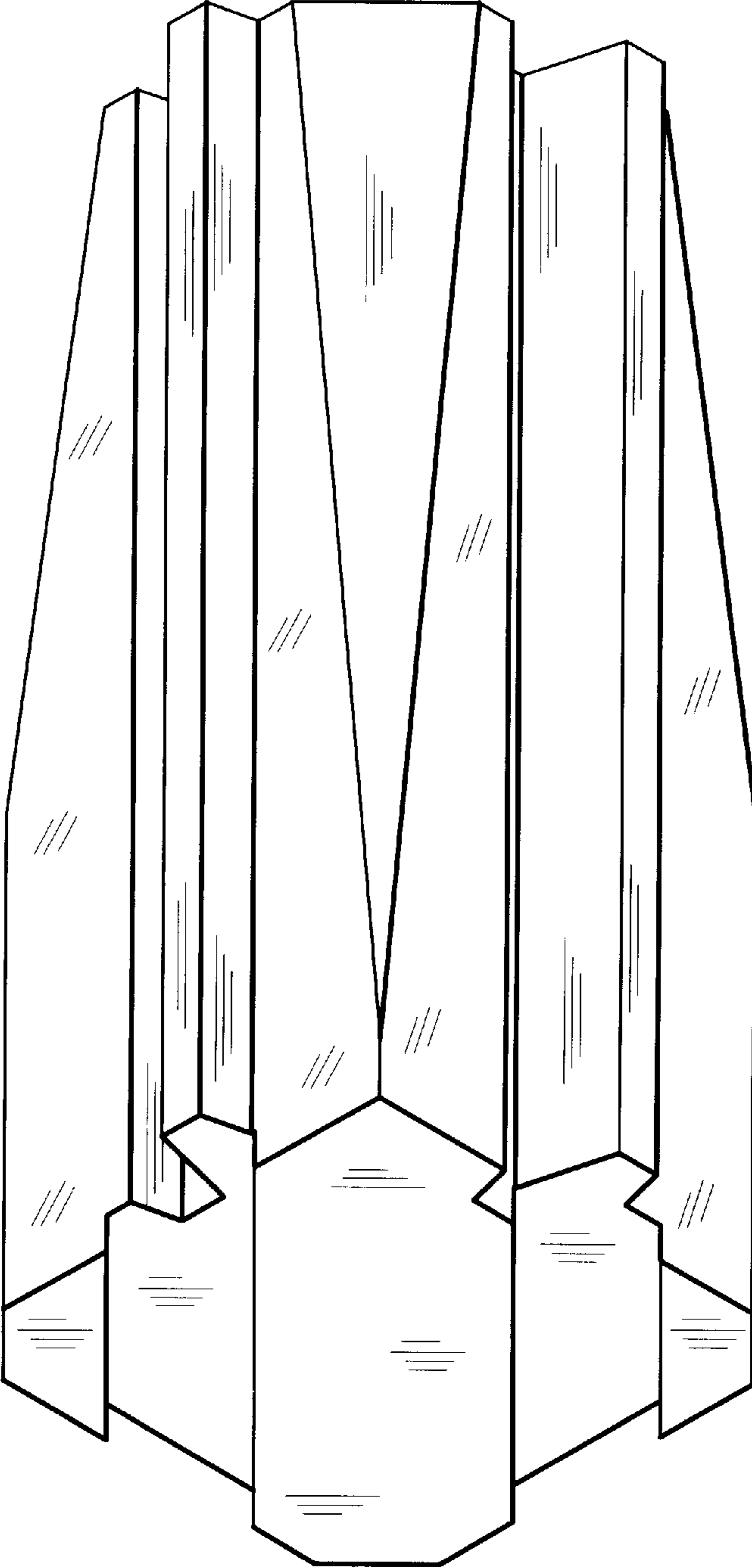
