FIG. 3 is rear elevational view thereof.

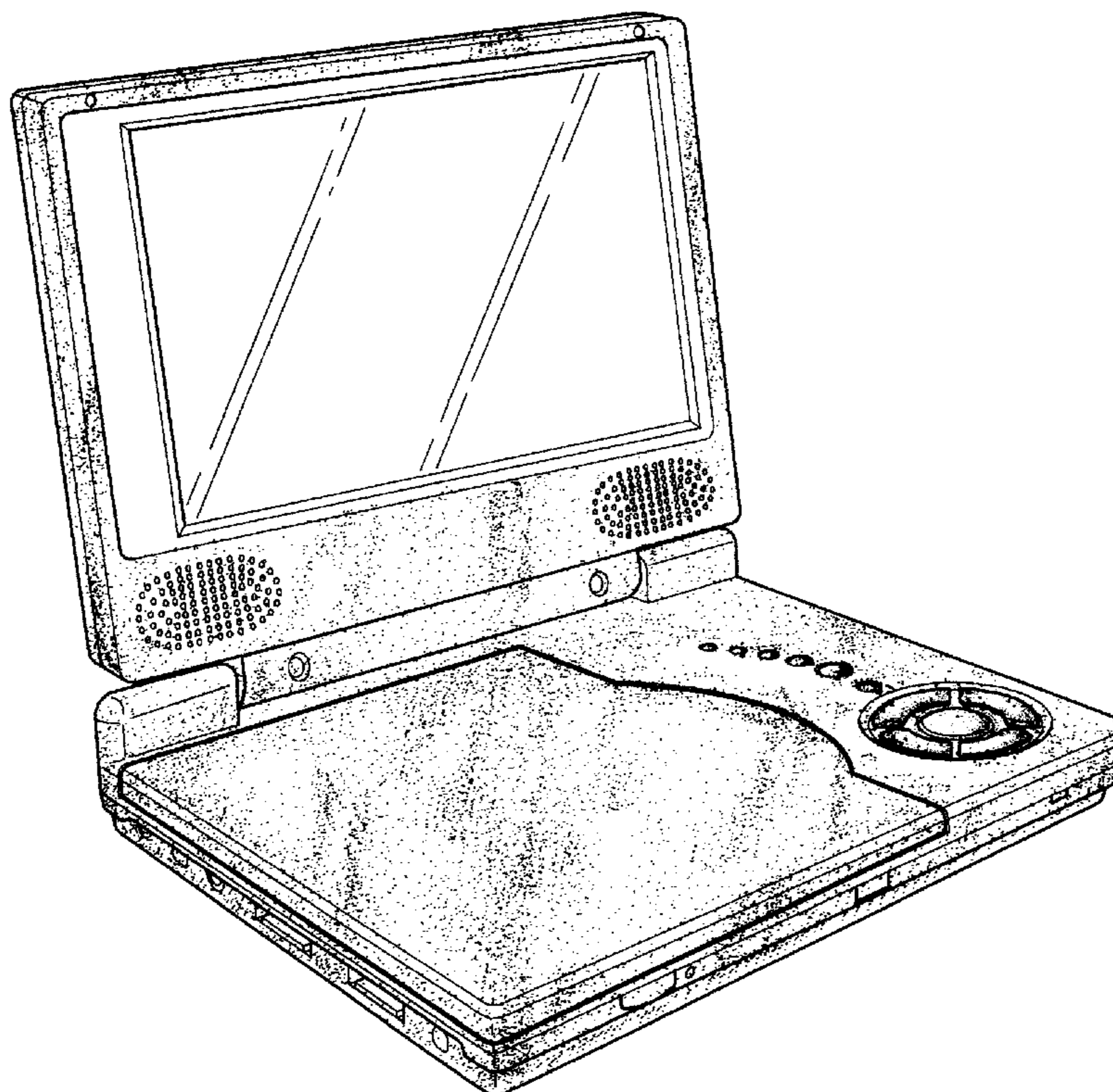
FIG. 4 is left elevational view thereof;

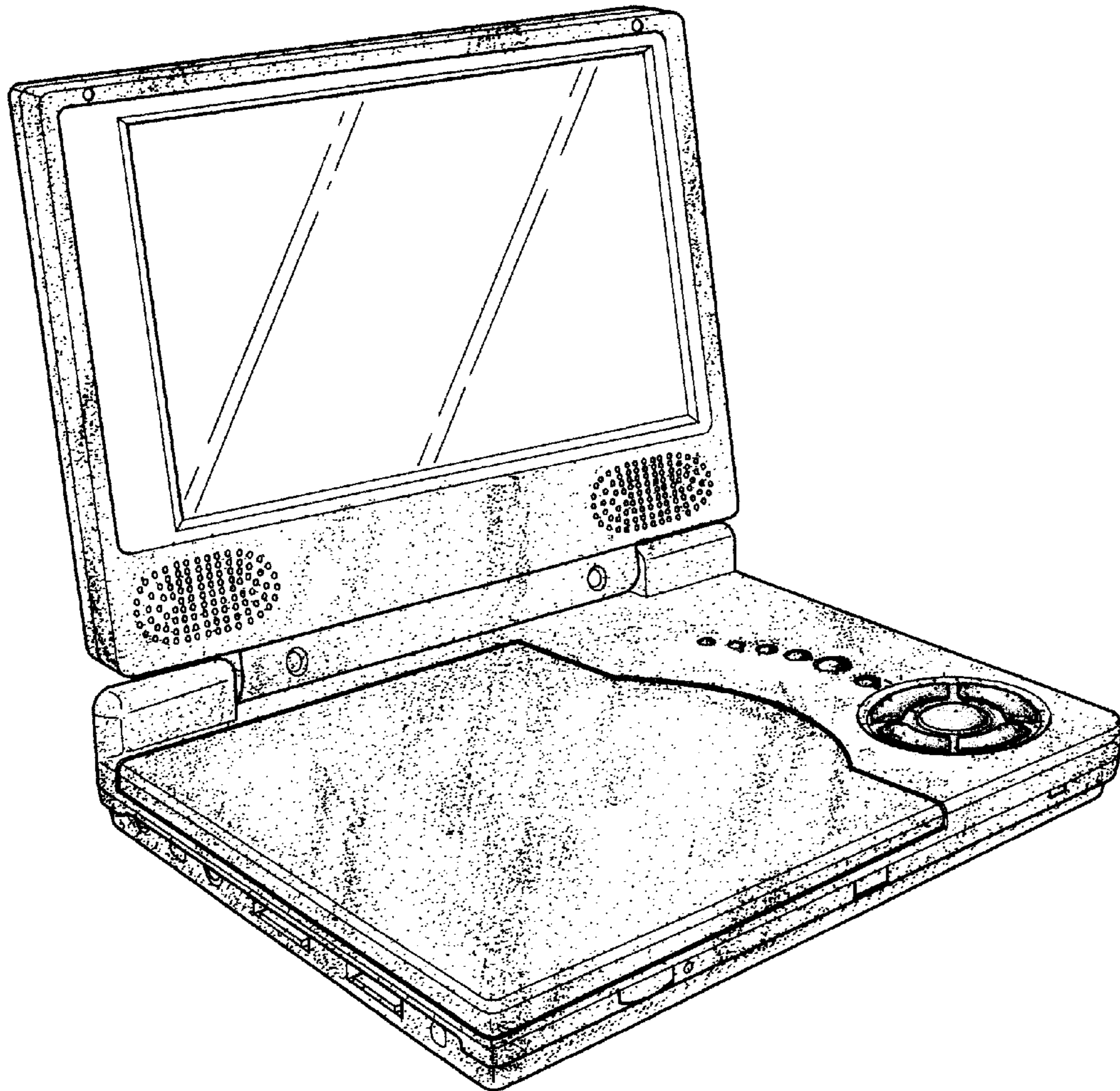

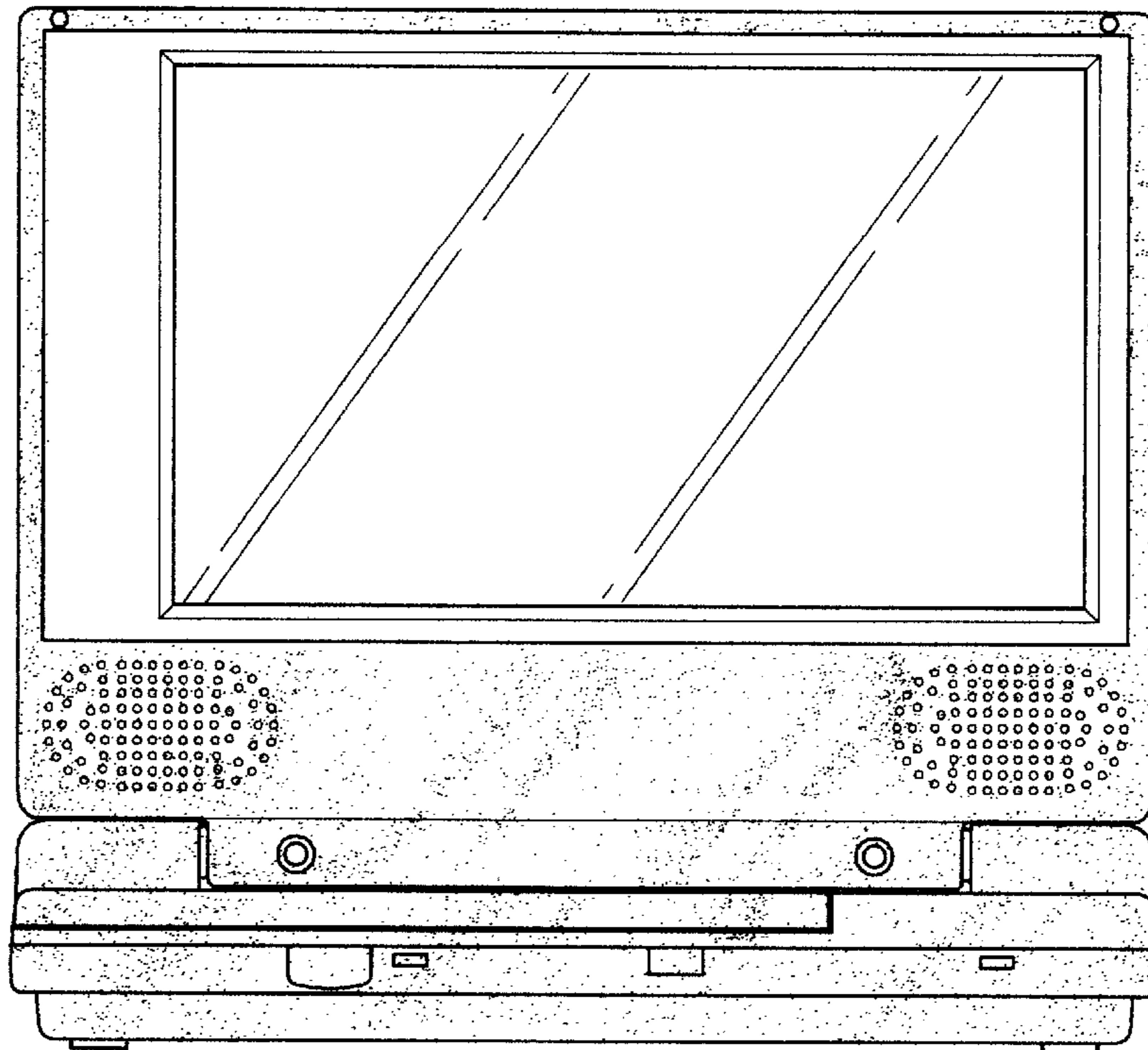

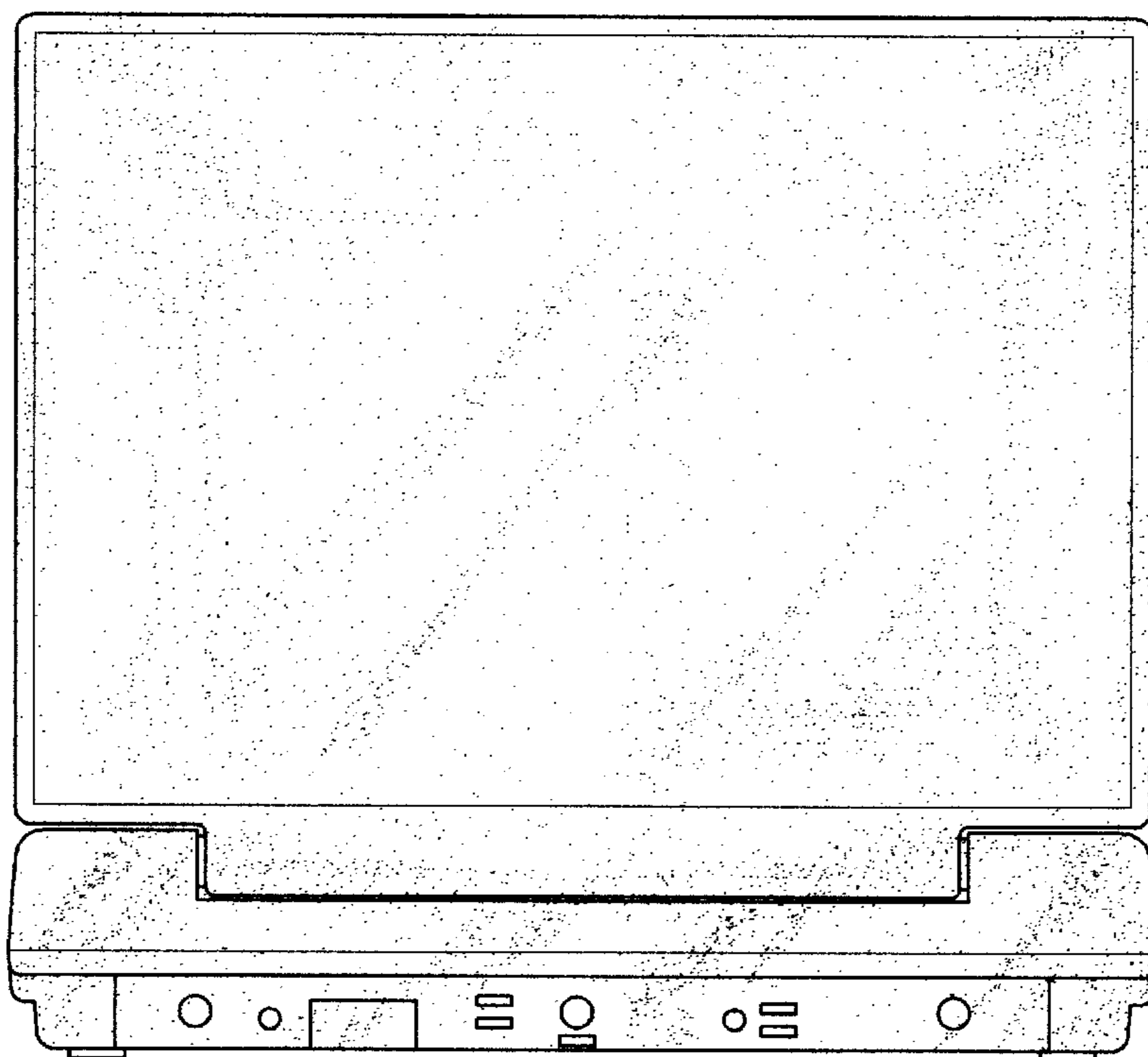

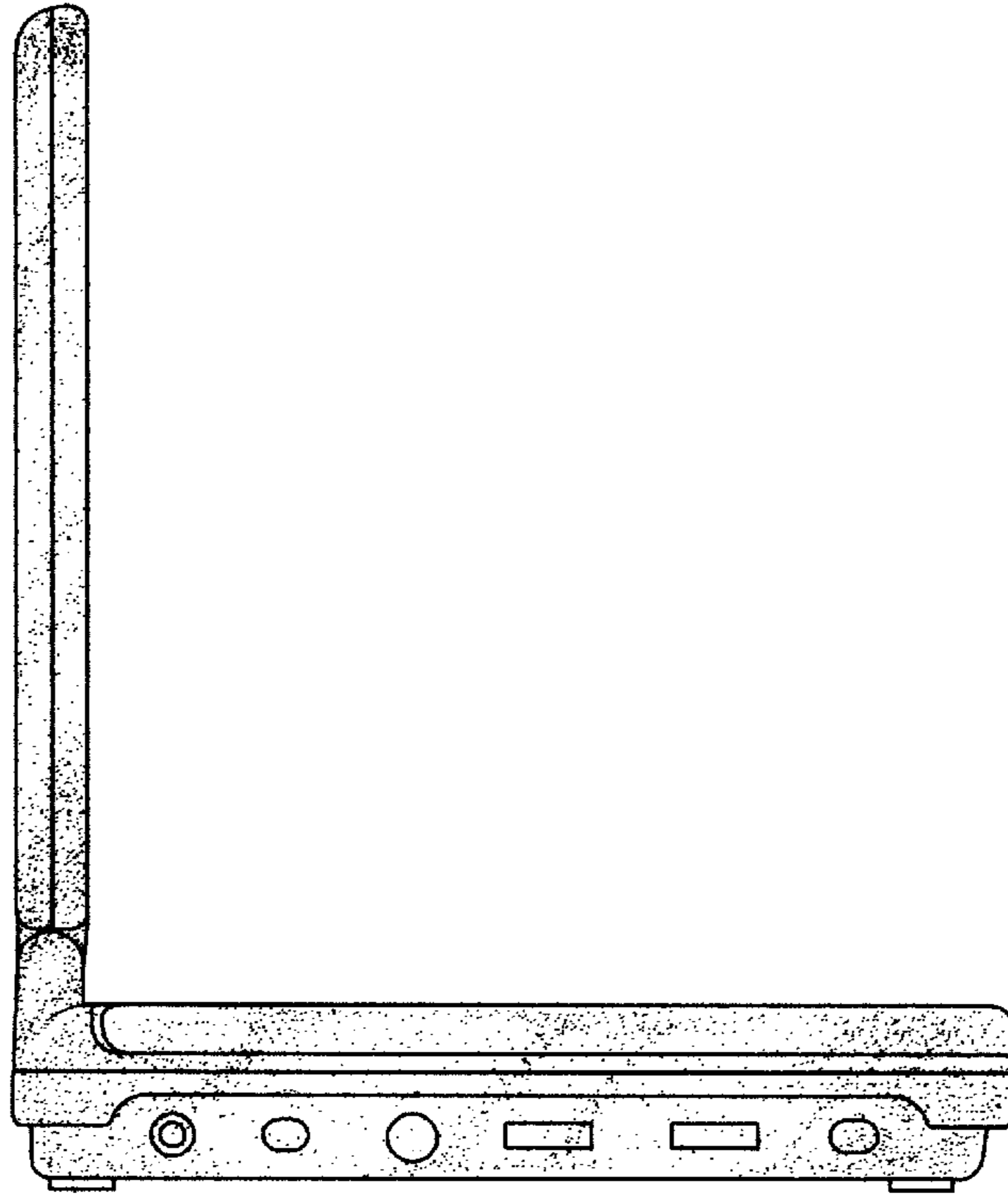

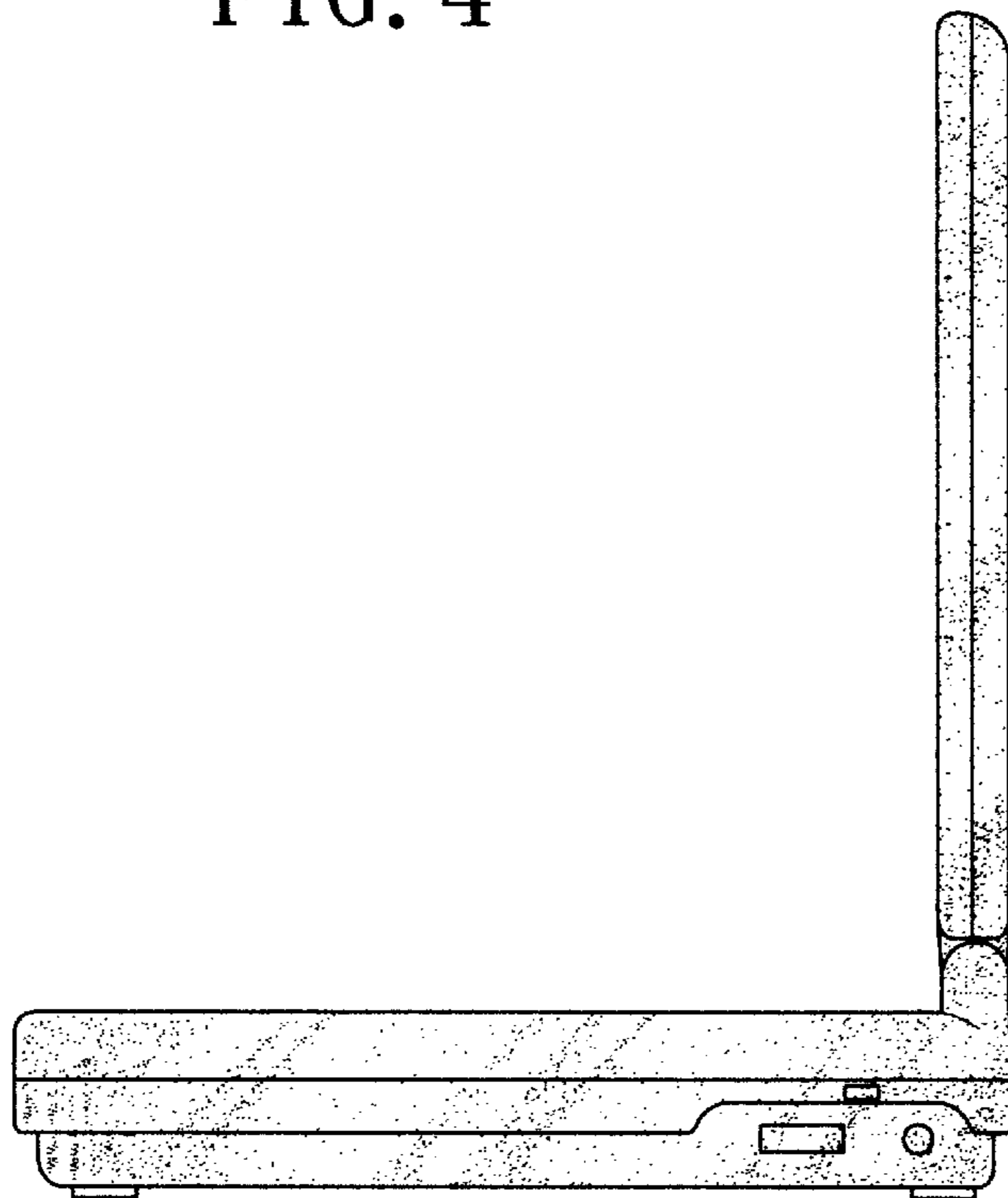

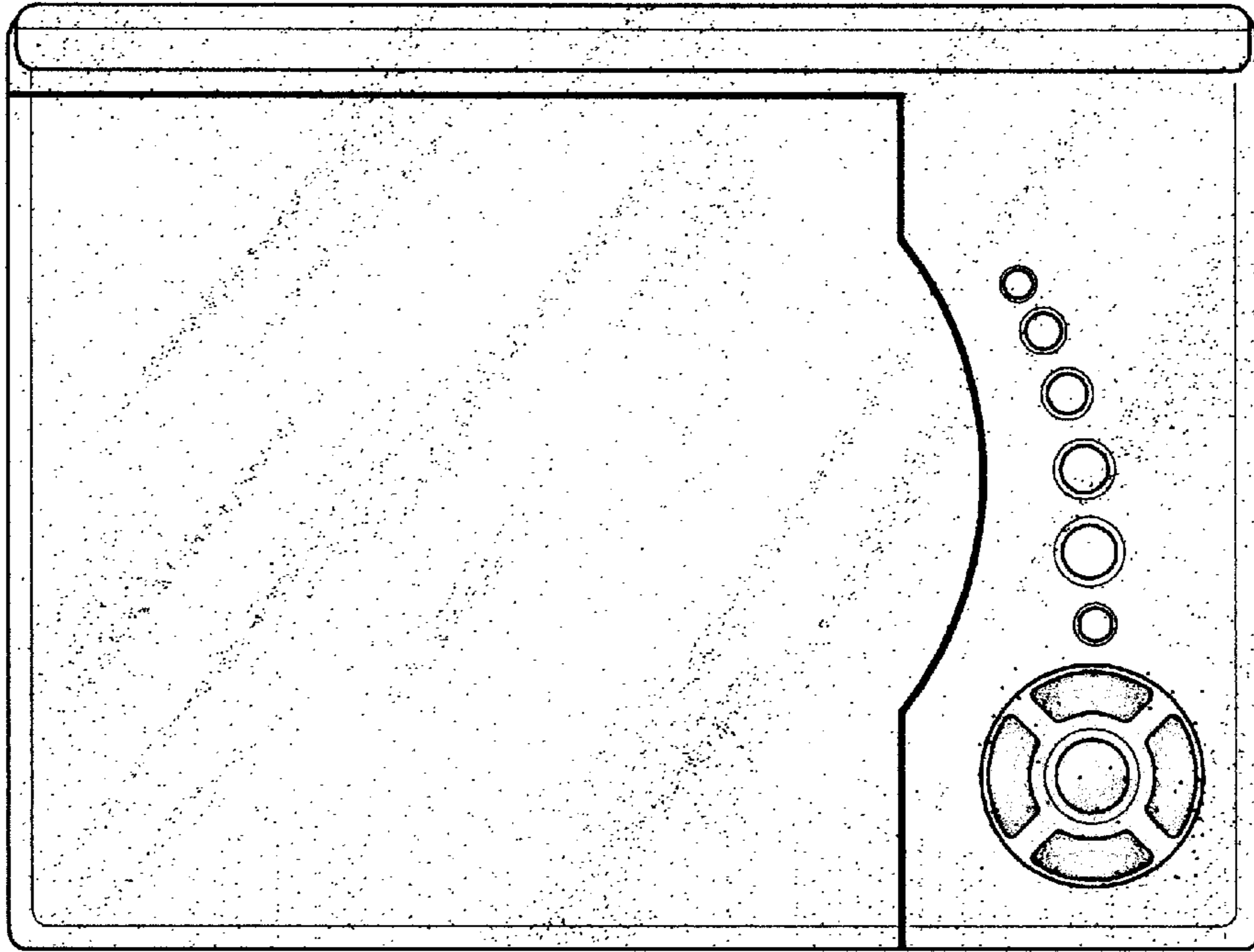

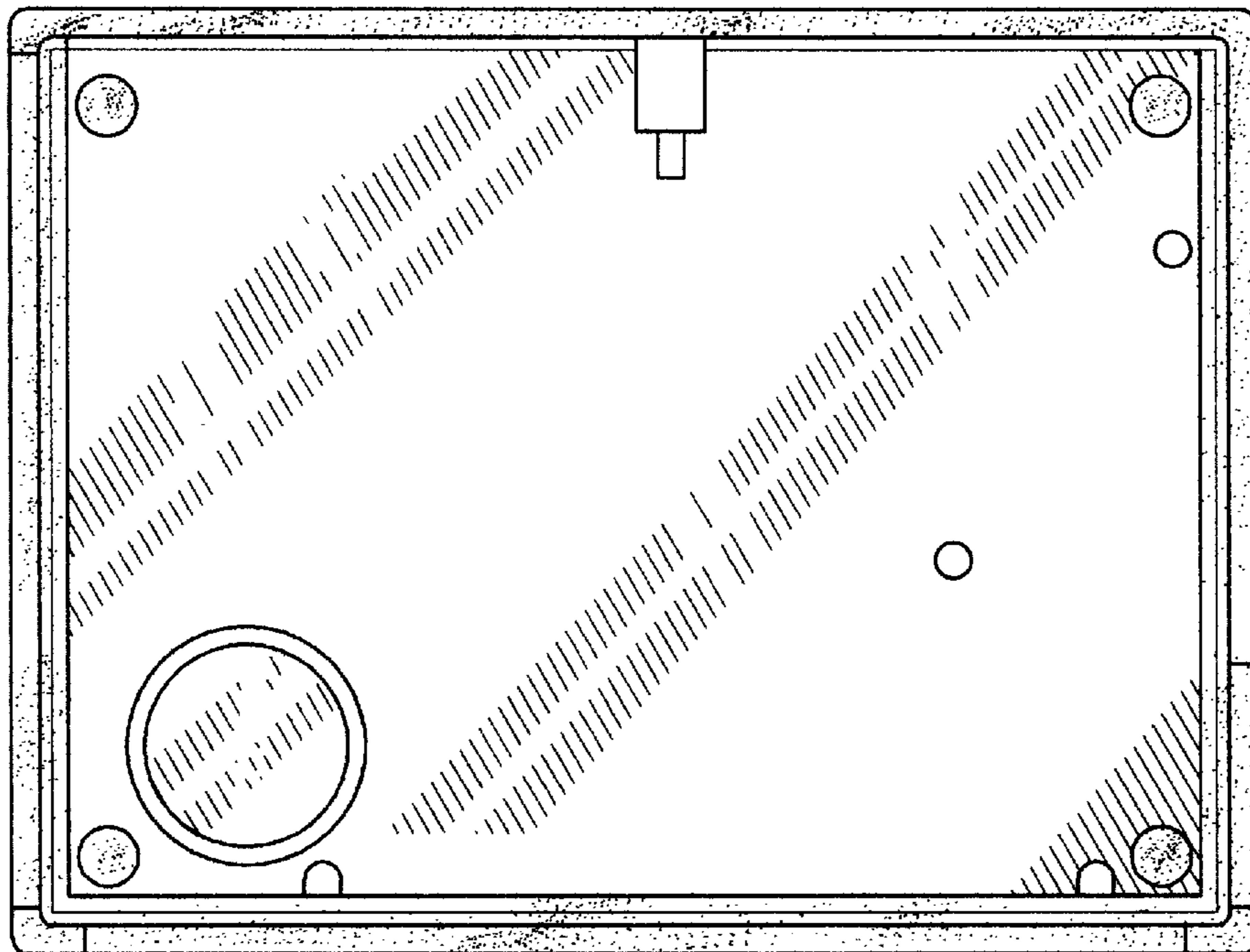
