FIG. 1 is a front perspective view of a telephone set showing our new design;

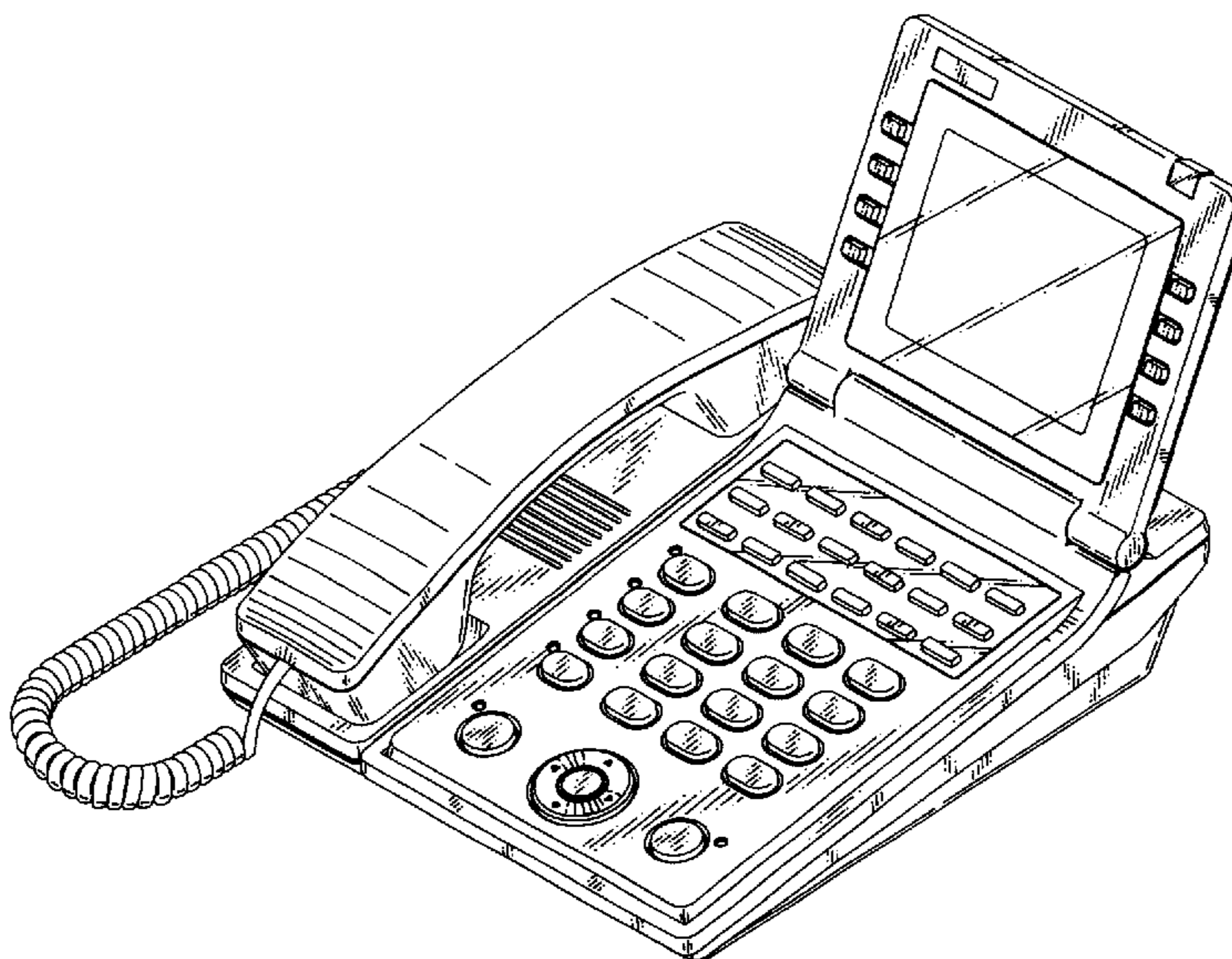

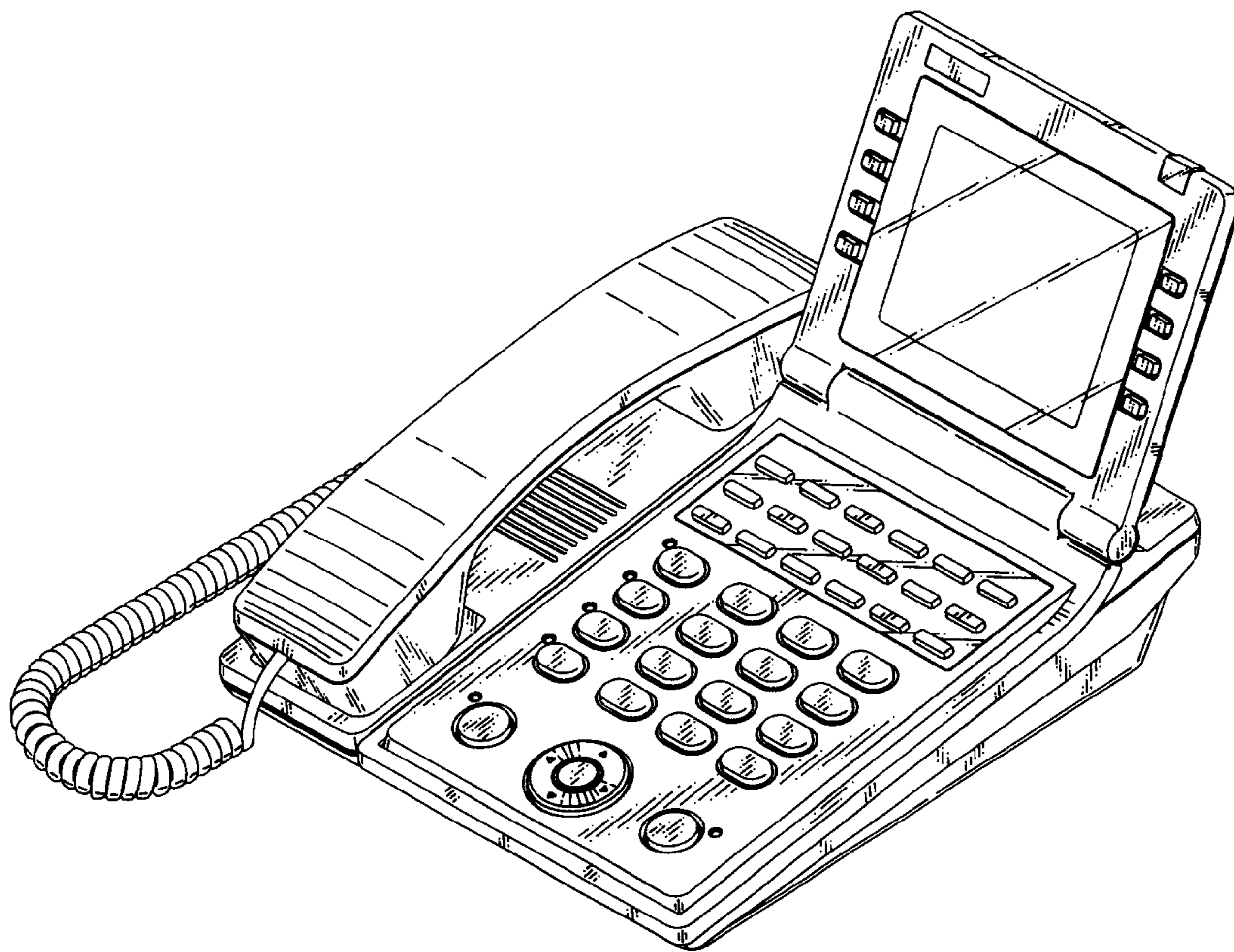

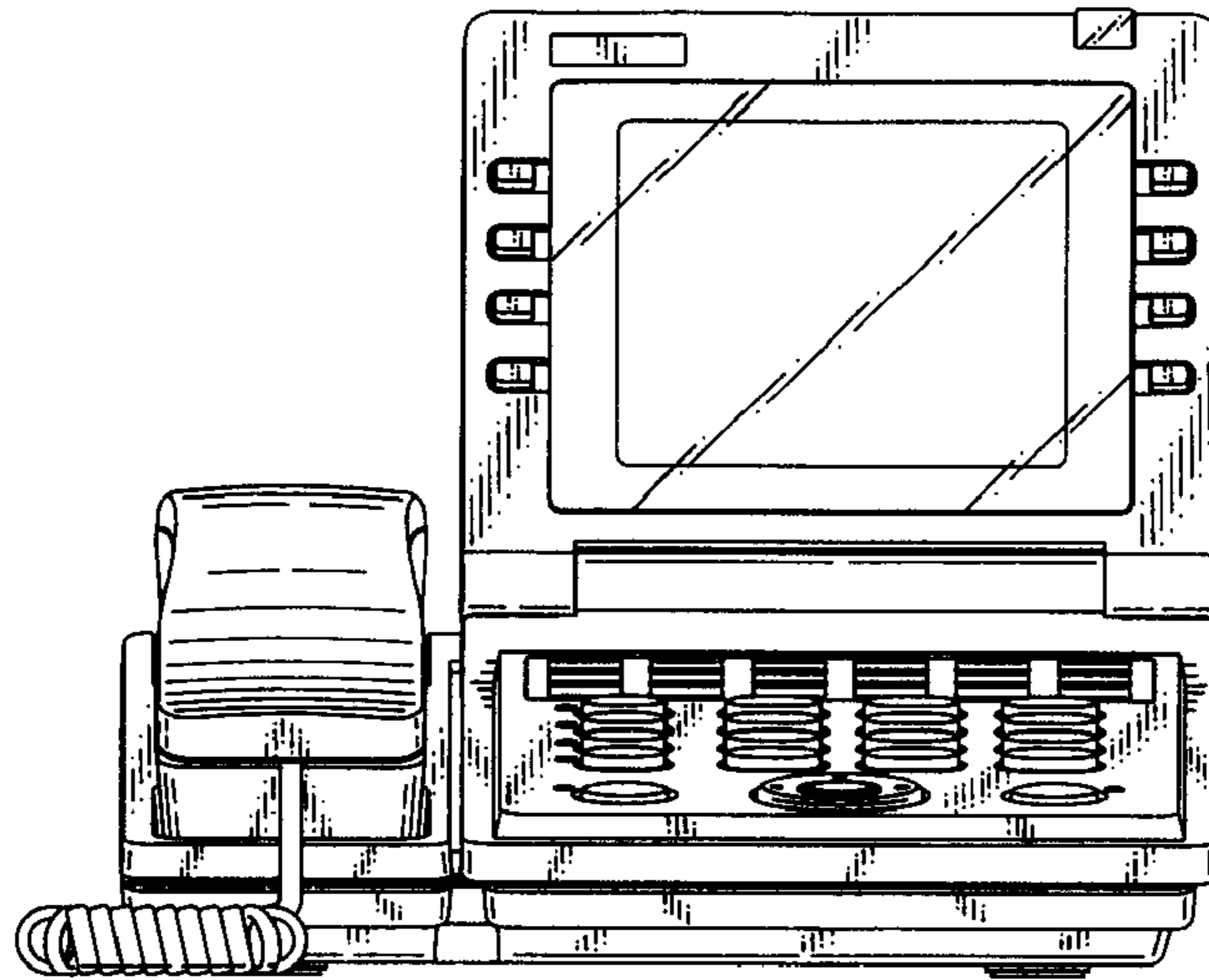

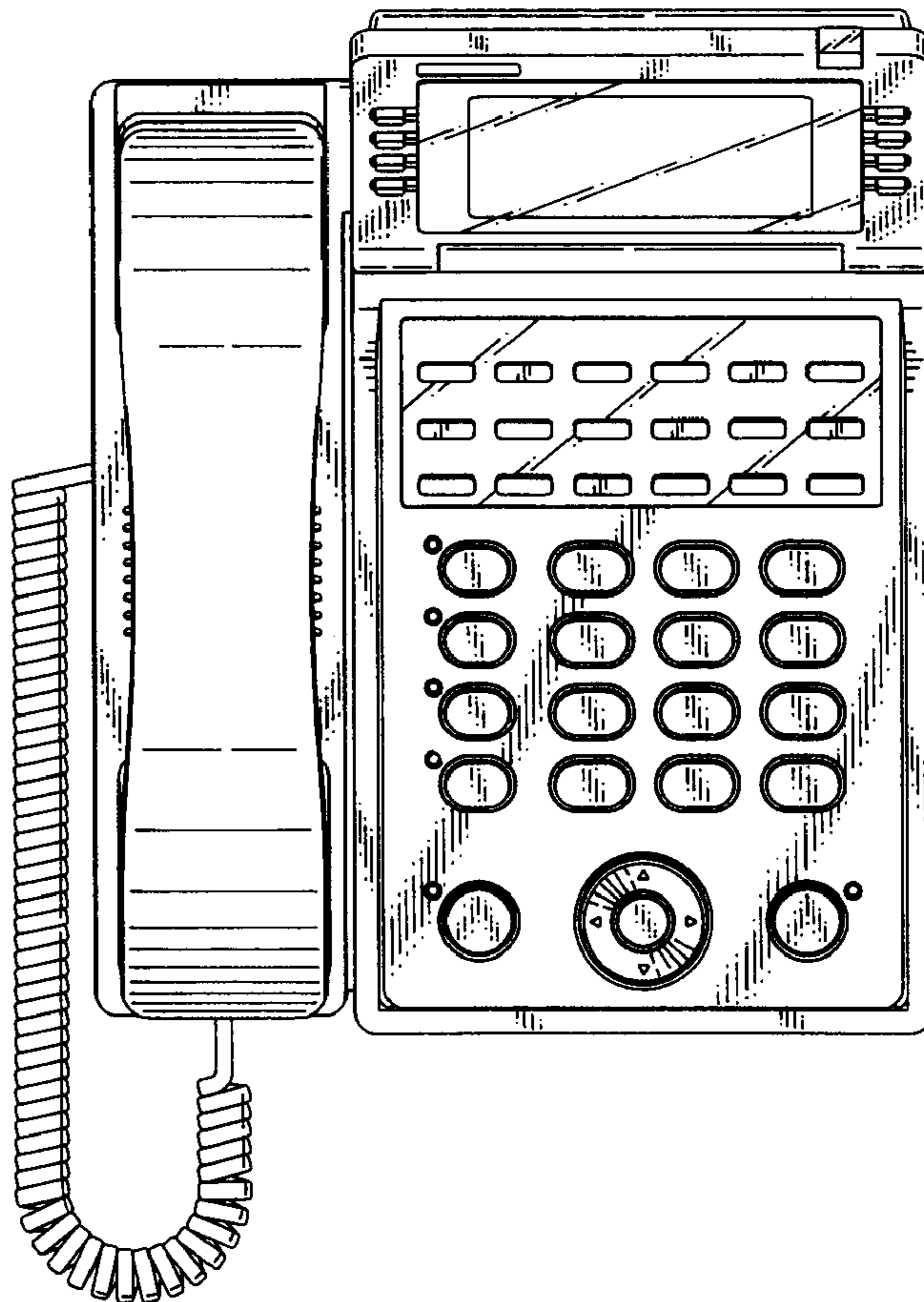

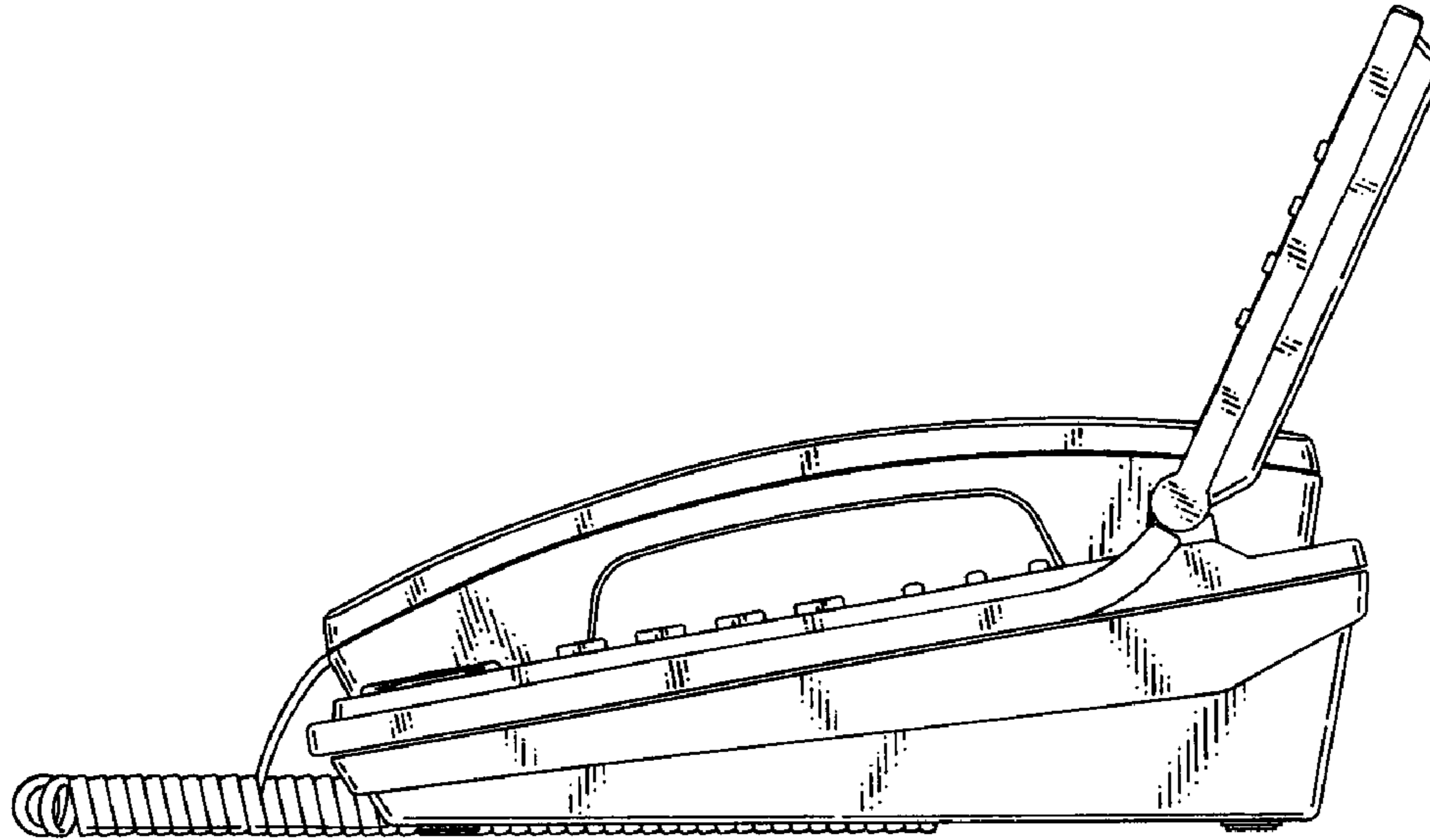

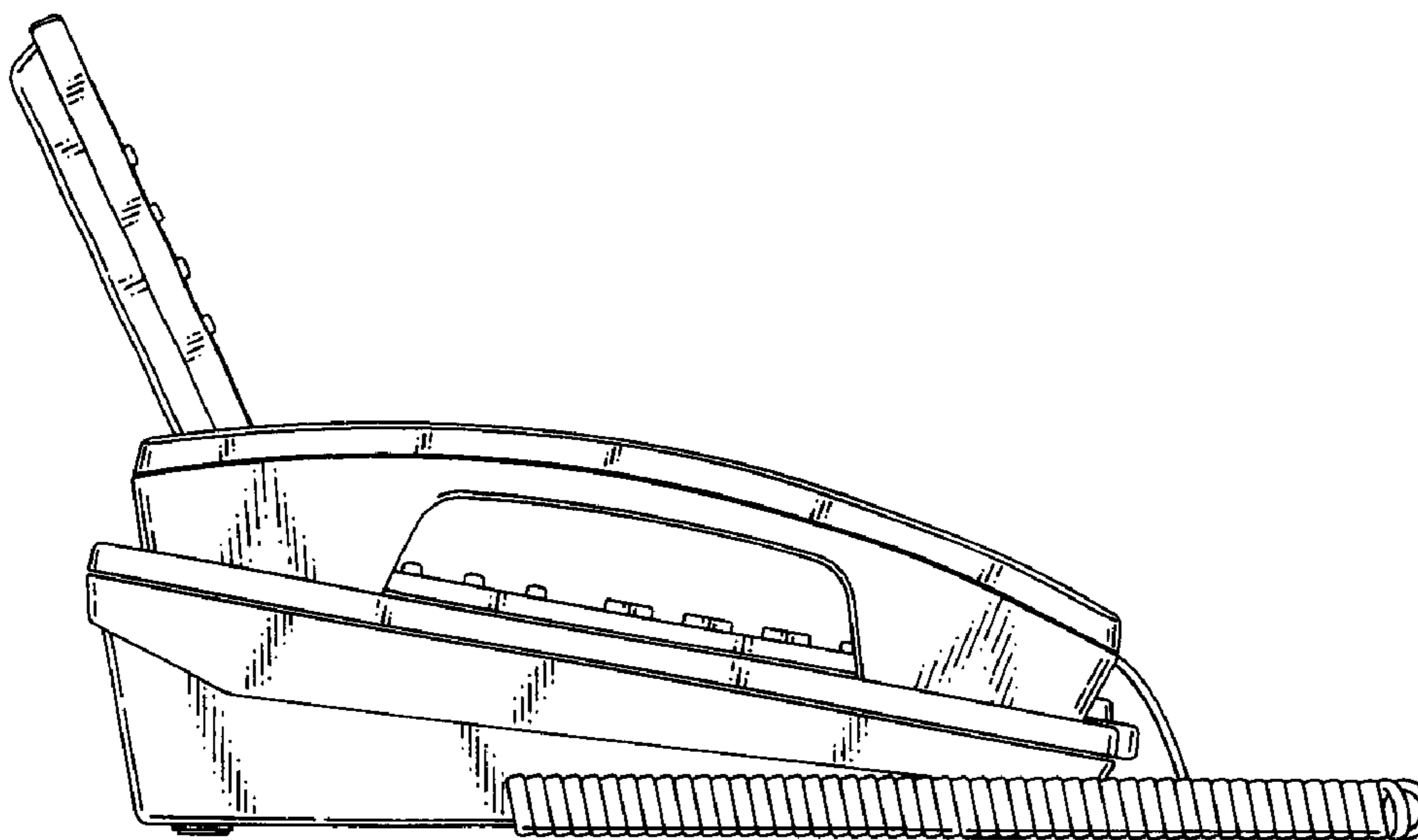

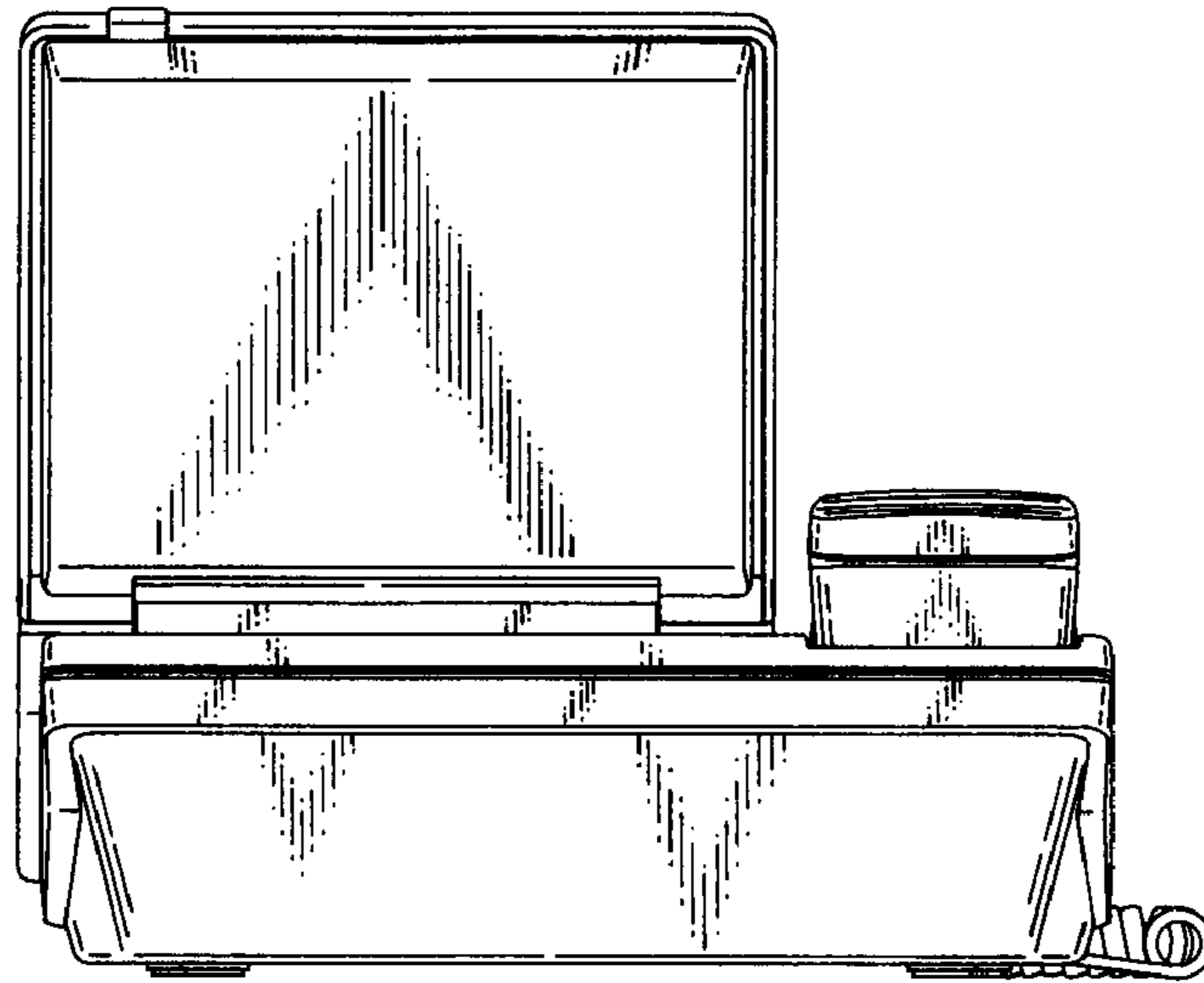
