double stripe and card suit symbol patterns, as shown.

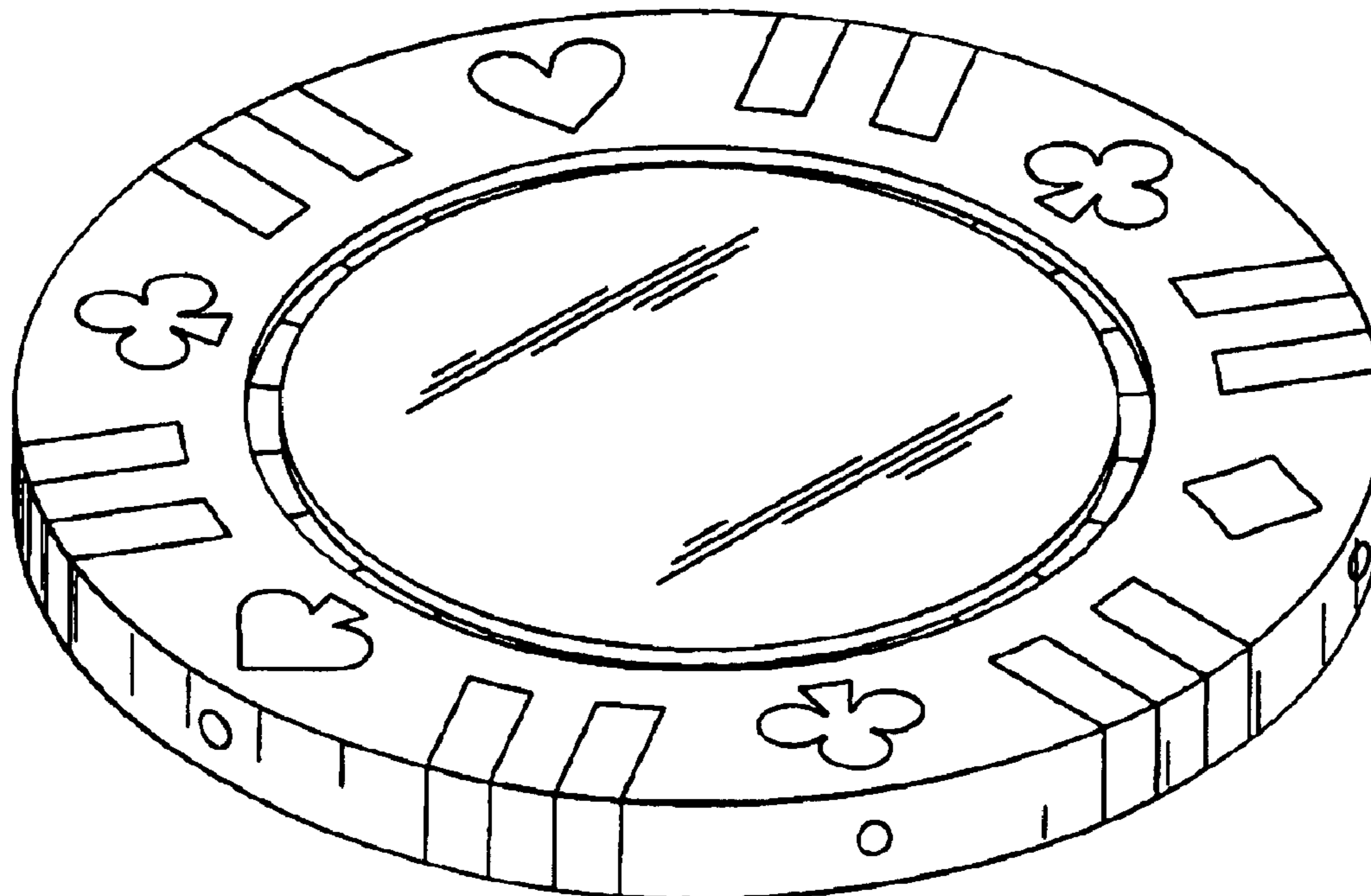
**DESCRIPTION**

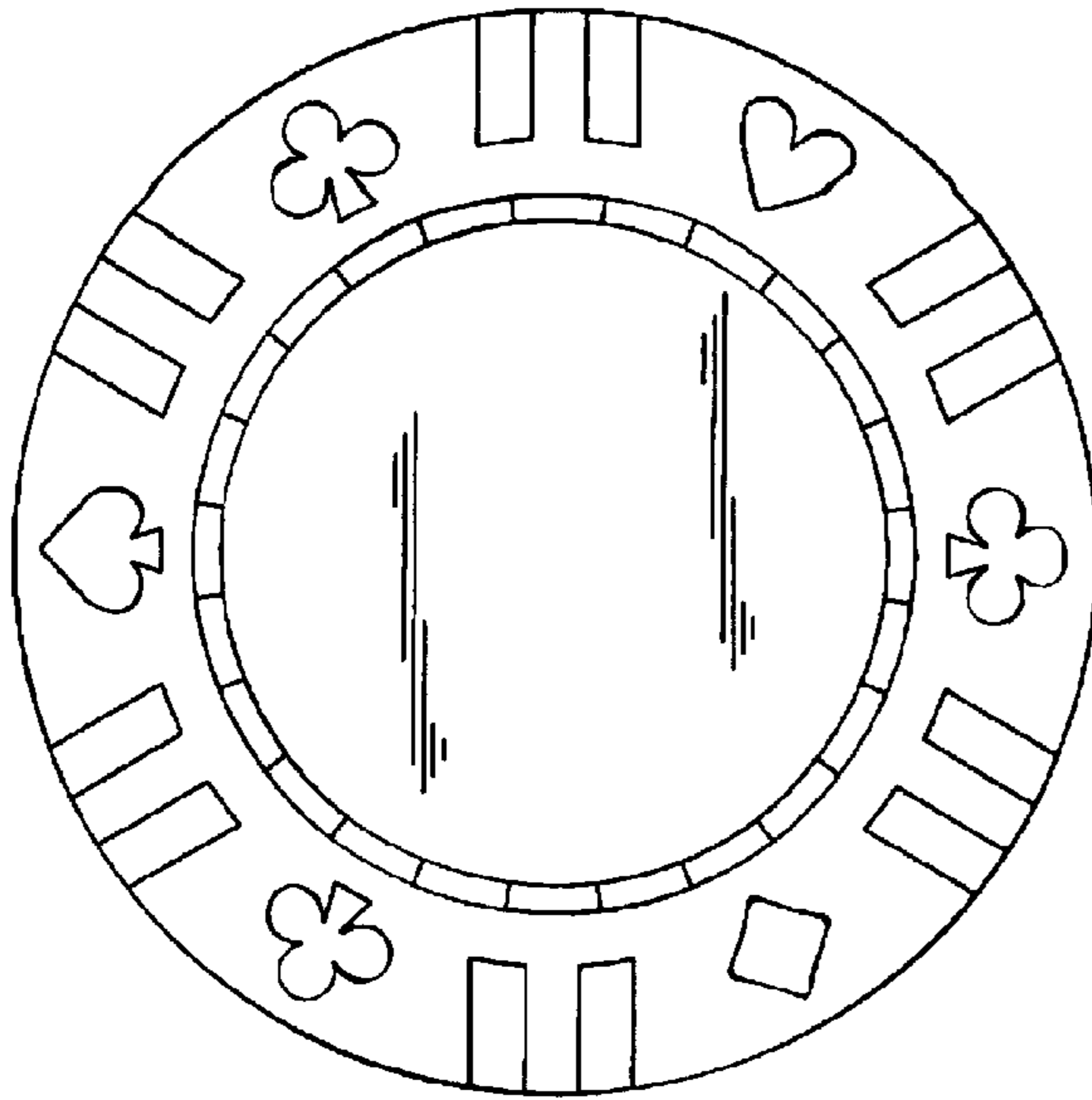
FIG. 1 is a top plan view of the poker chip with alternating

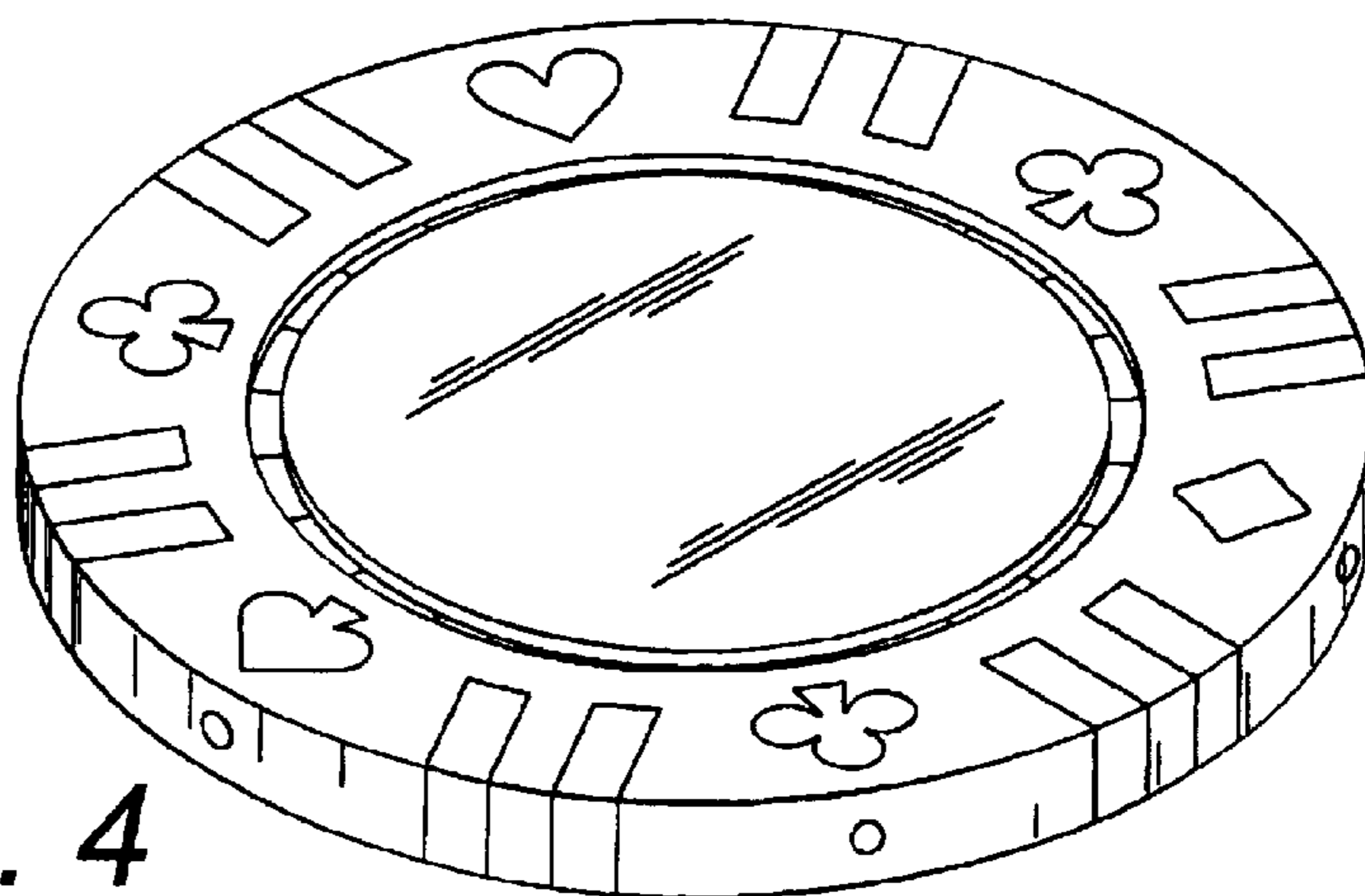
