FIG. 3 is a front photographic view thereof;

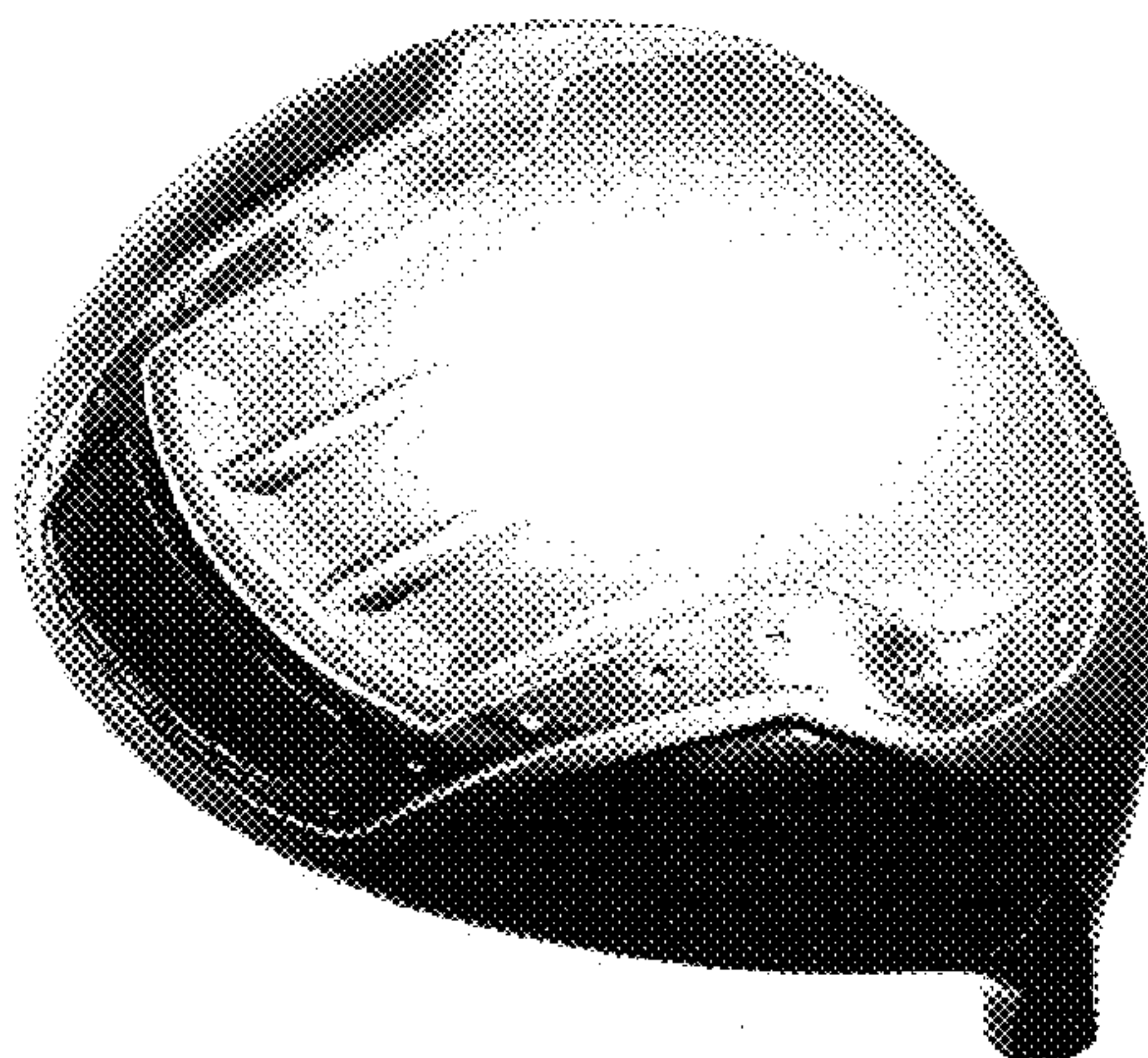
FIG. 4 is a rear photographic view thereof;

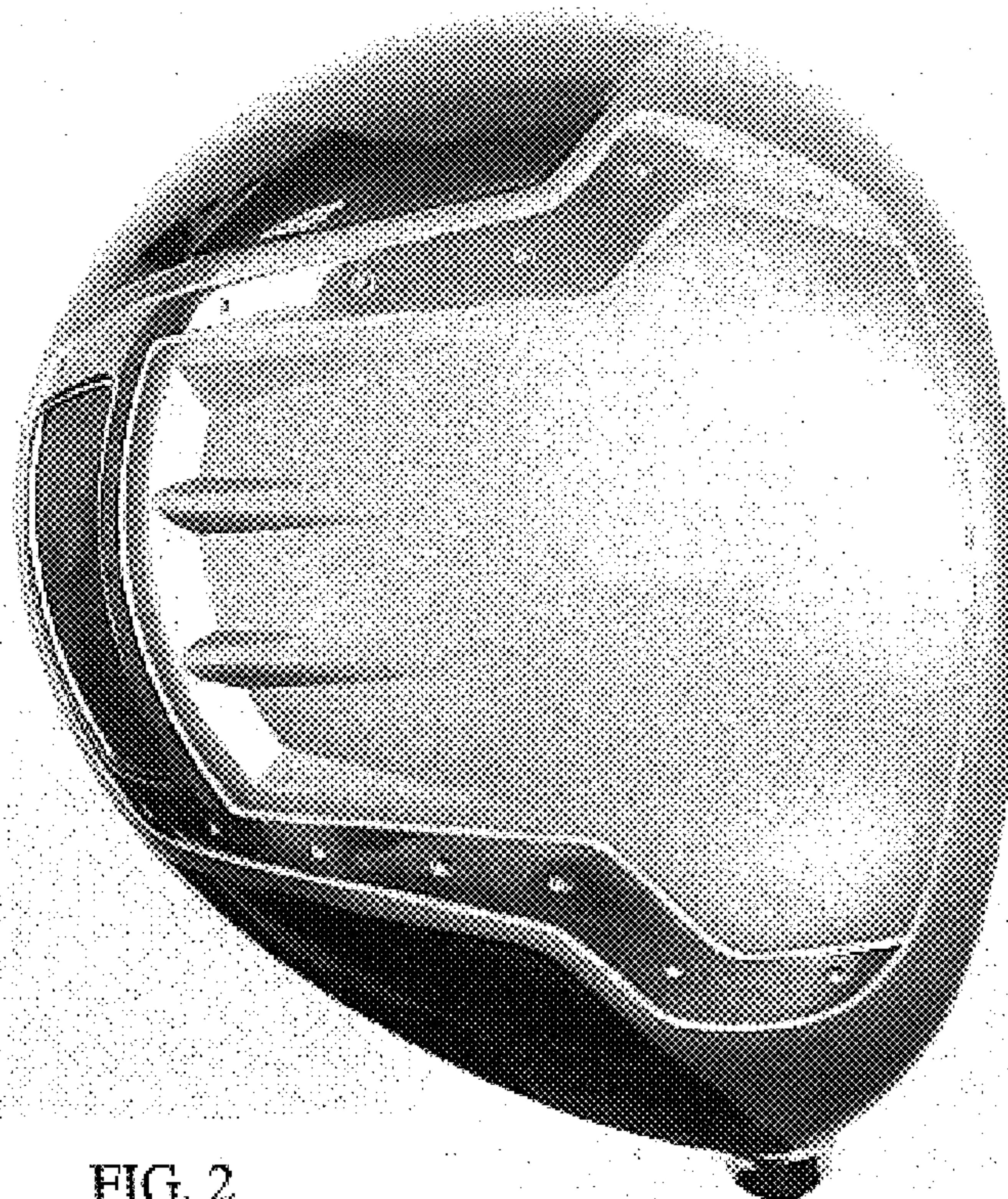

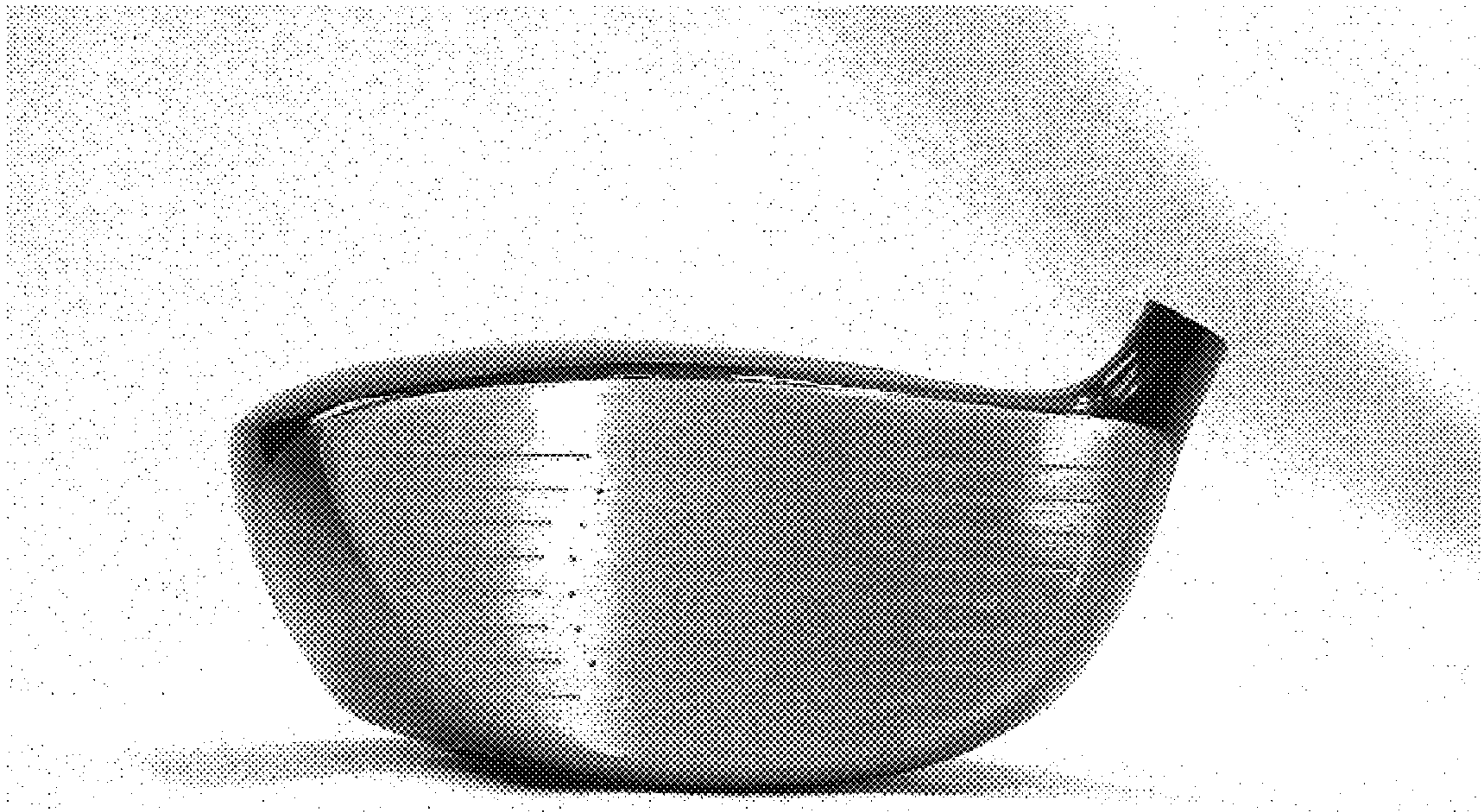

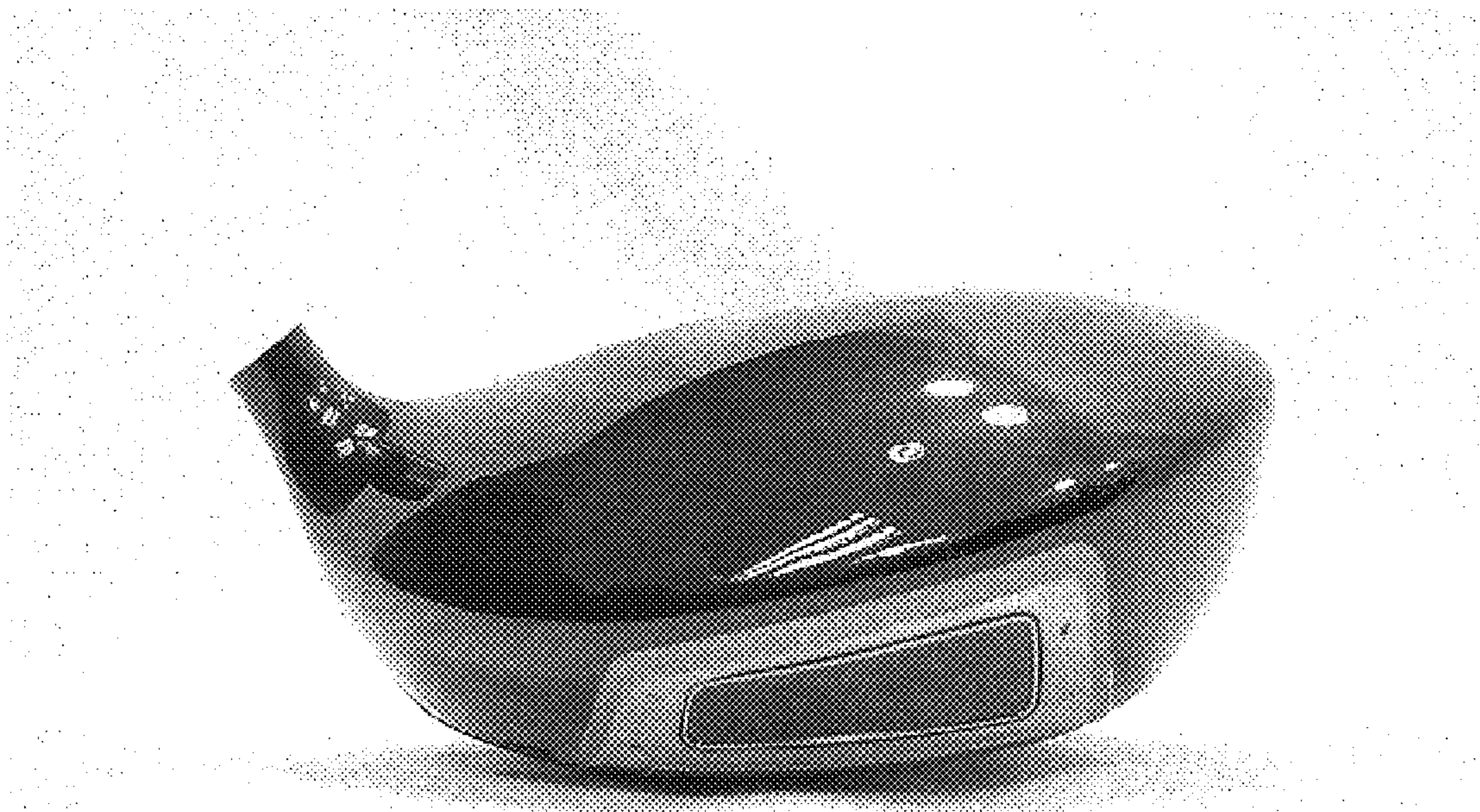

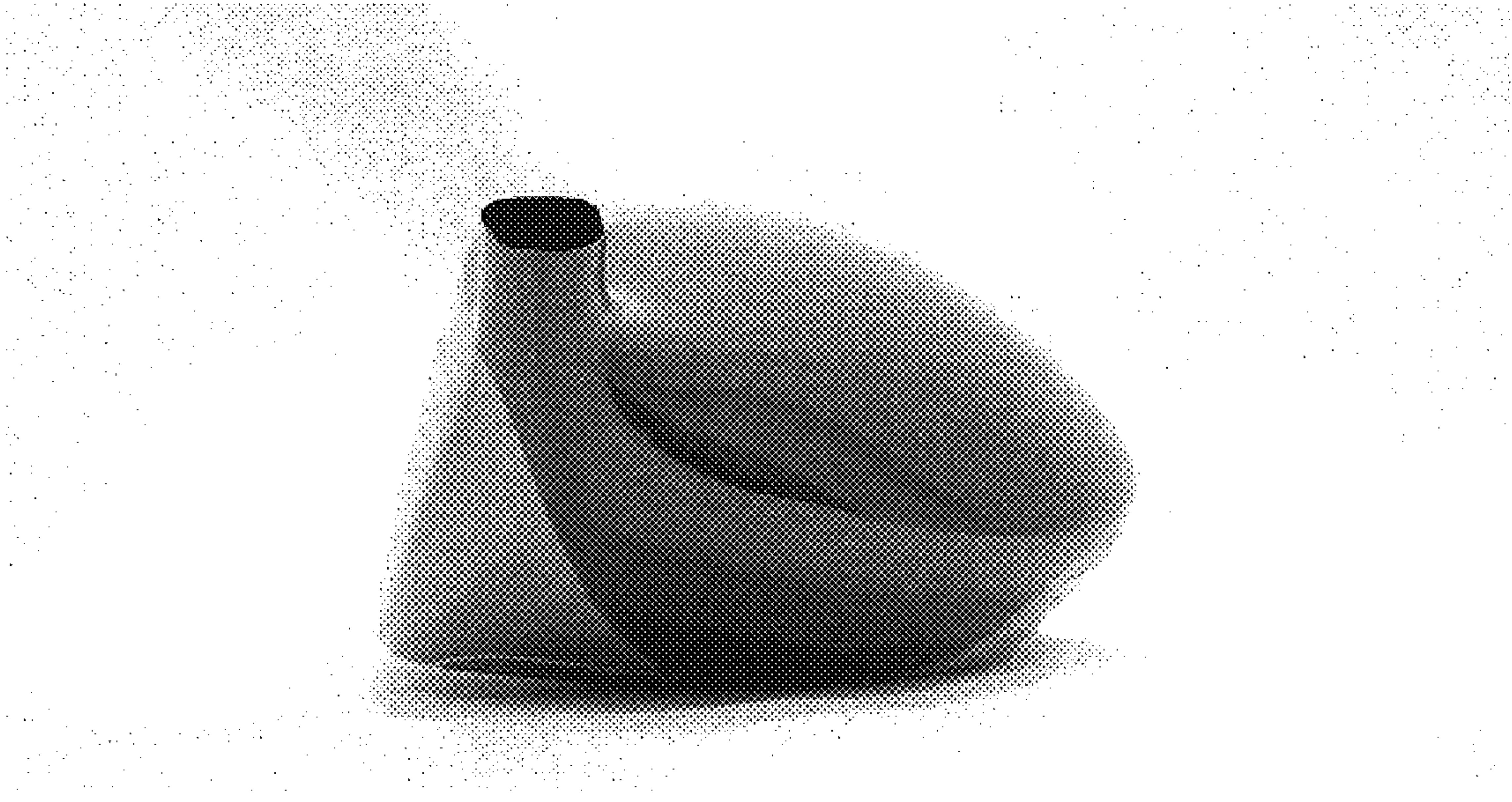

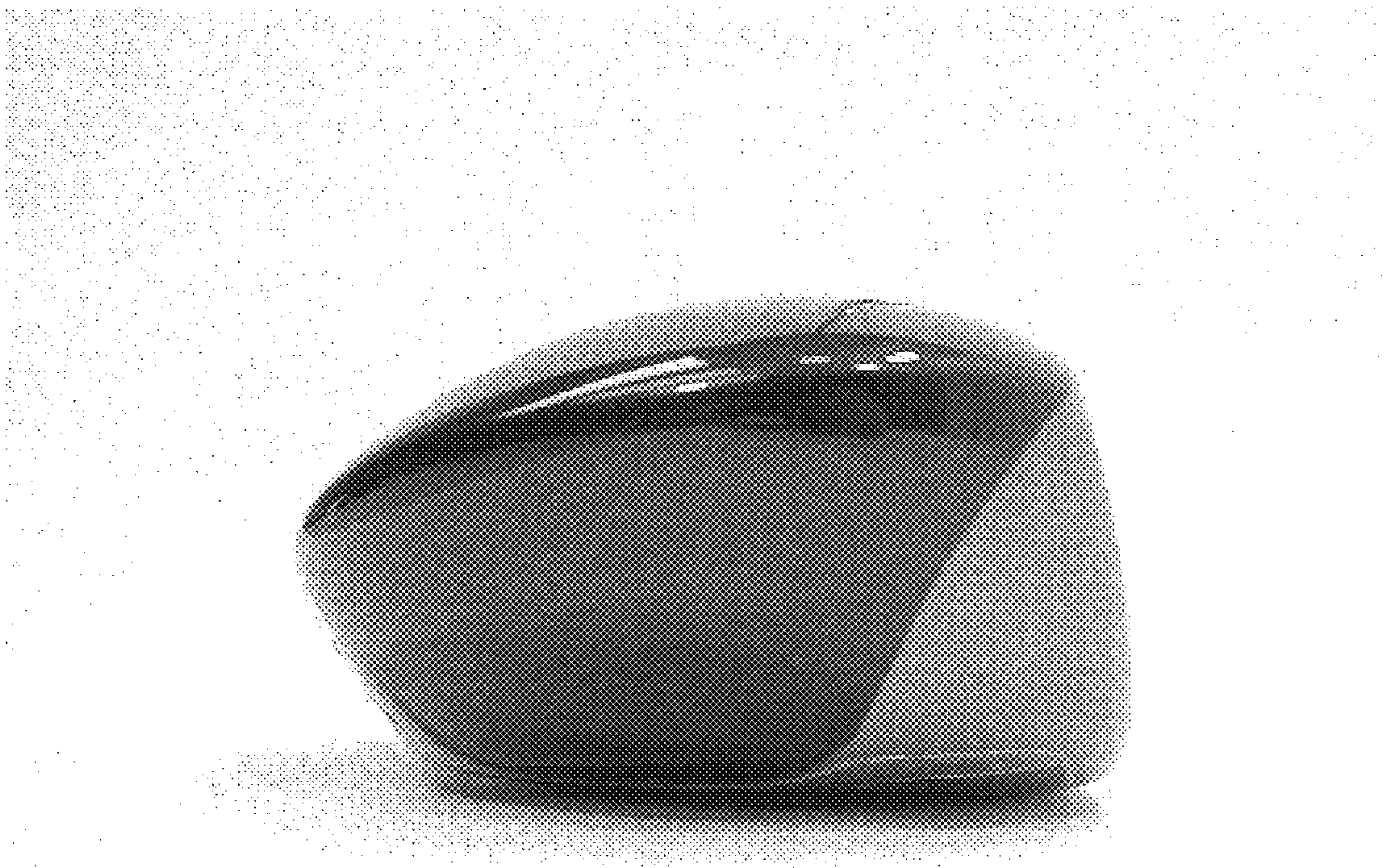
