(57) **CLAIM**

The ornamental design for a thermal therapy pad, as shown and described.

DESCRIPTION

FIG. 1 is a front perspective view of a thermal therapy pad showing our new design, shown applied to a knee. The broken line showing is for illustrative purposes only and forms no part of the claimed design;

FIG. 2 is a top plan view thereof, shown in a non-use condition. The strap is shown broken away to indicate an indeterminate length;

FIG. 3 is a bottom plan view thereof;

FIG. 4 is a front elevational view thereof;

FIG. 5 is a rear elevational view thereof

FIG. 6 is a right side elevational view thereof; and,

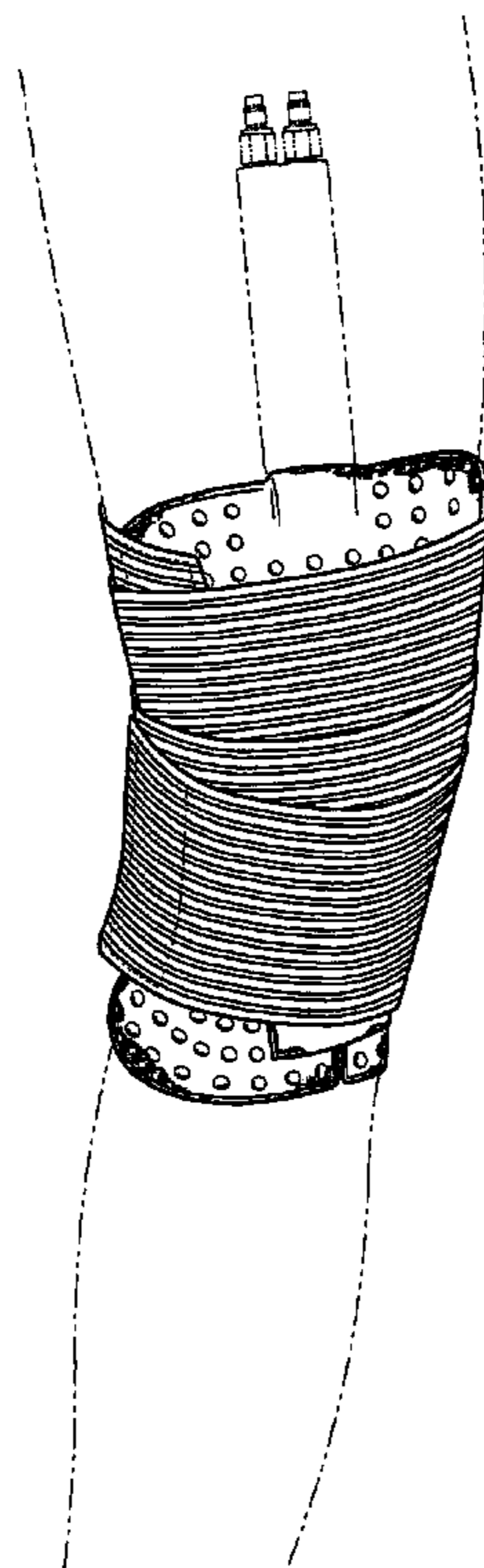
FIG. 7 is a left side elevational view thereof.

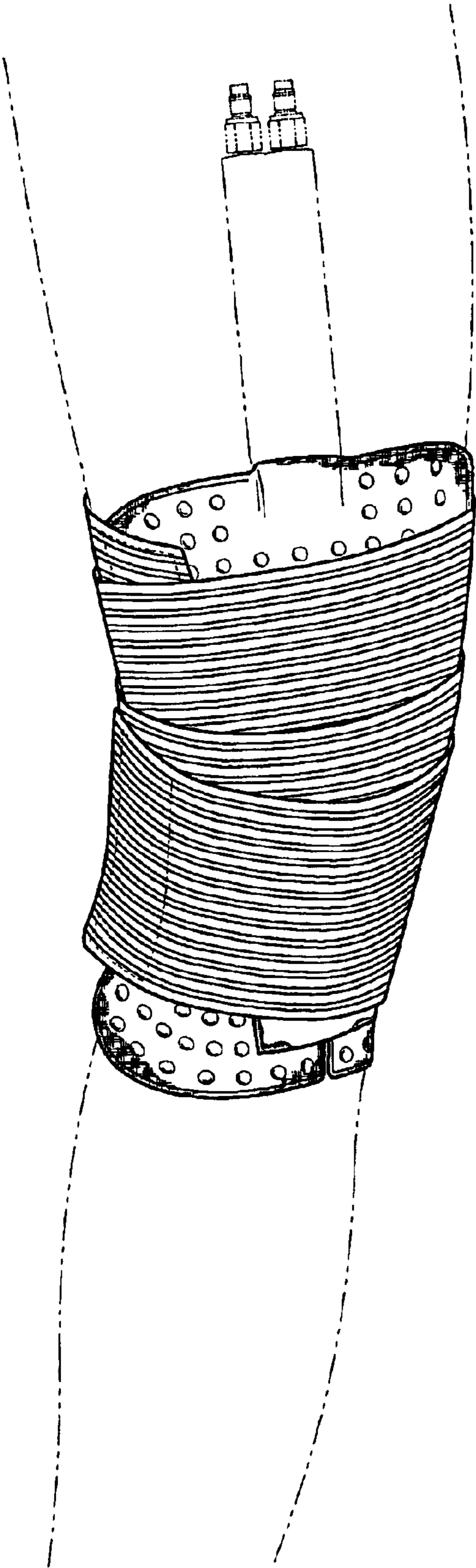

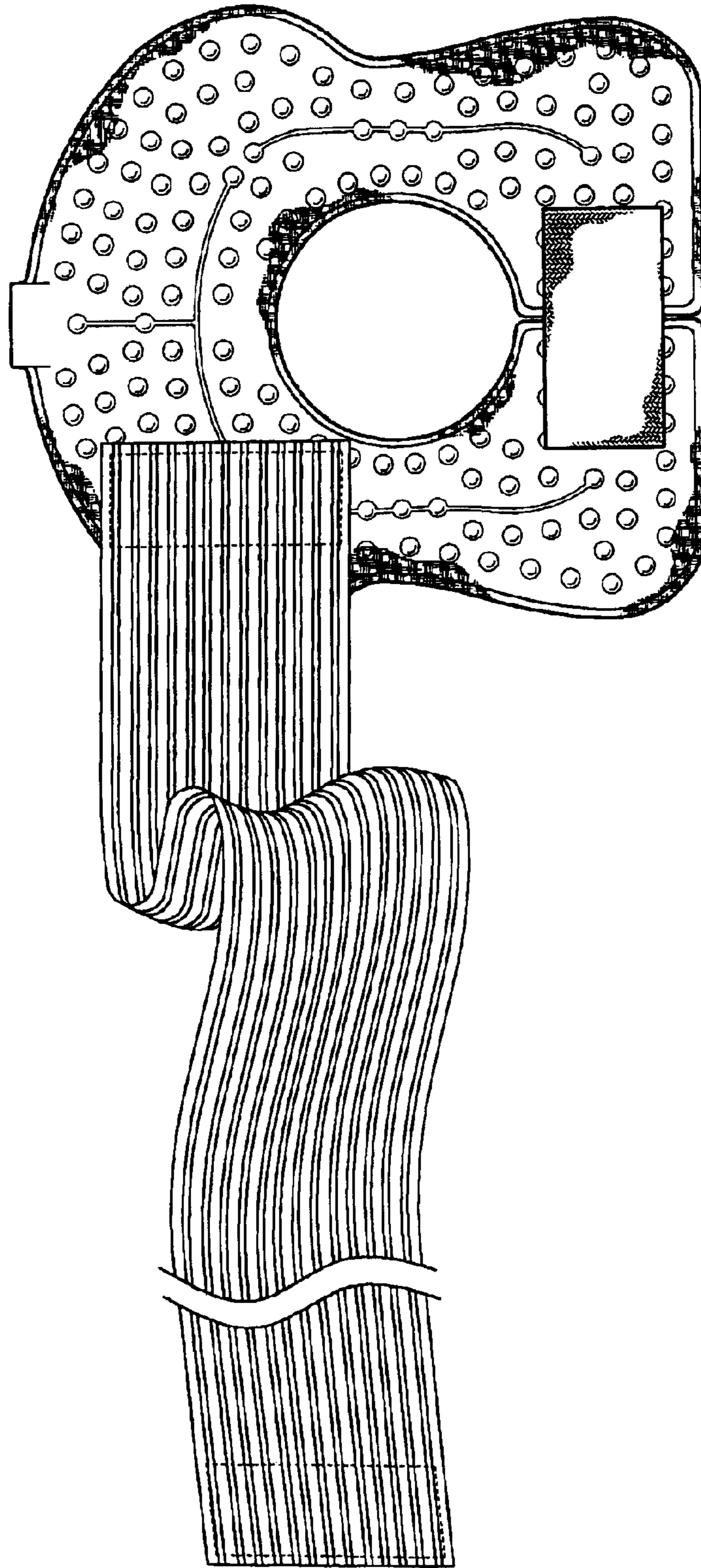

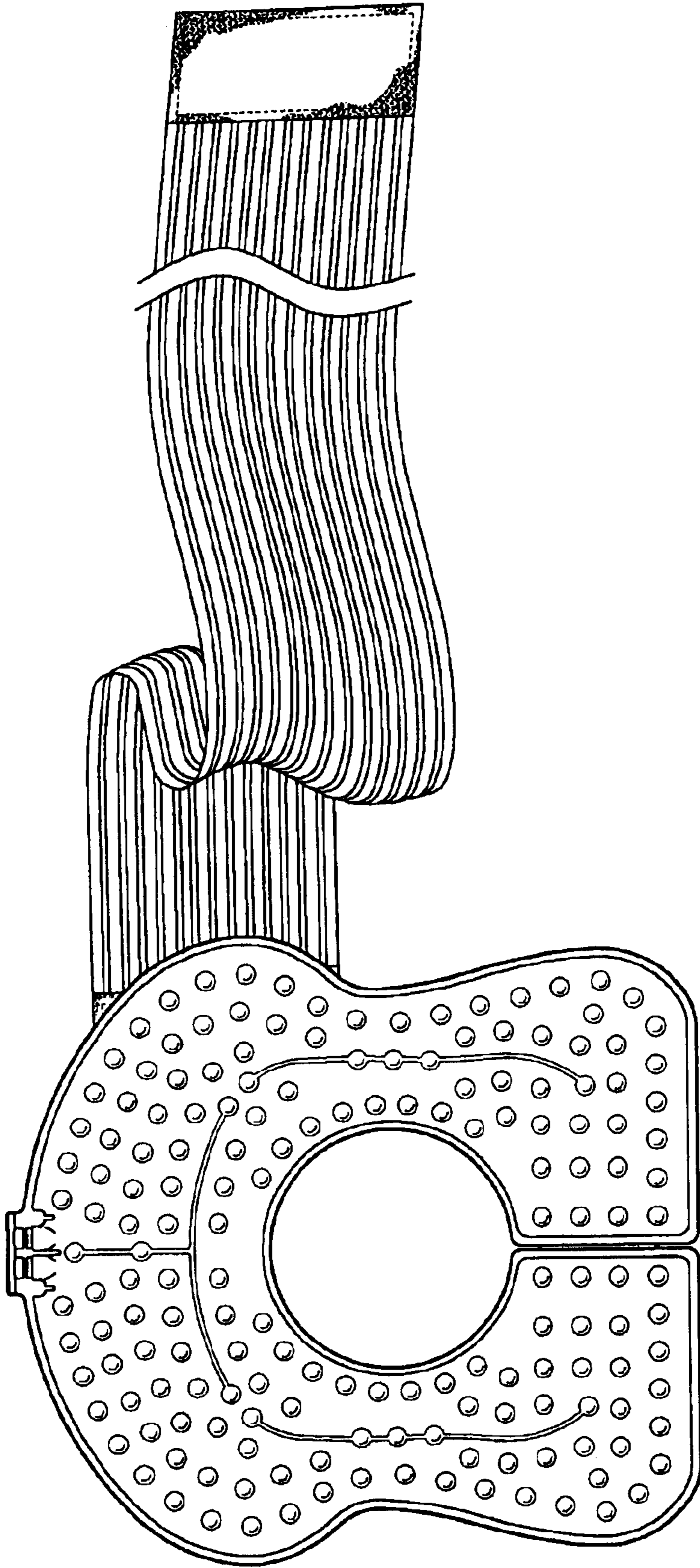

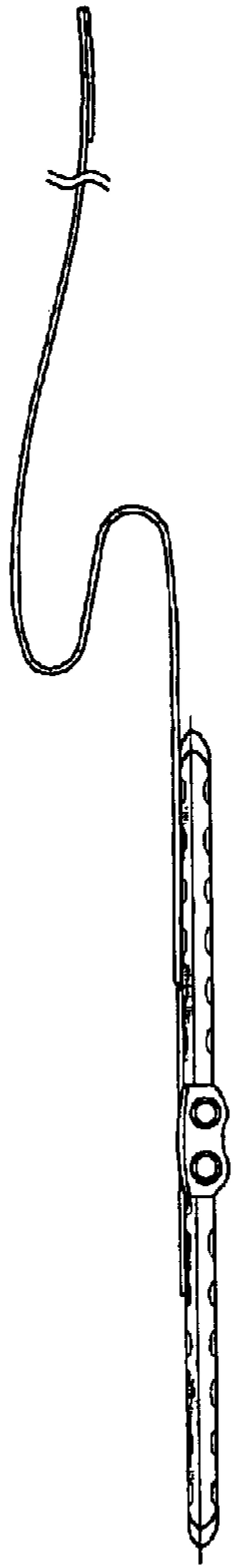

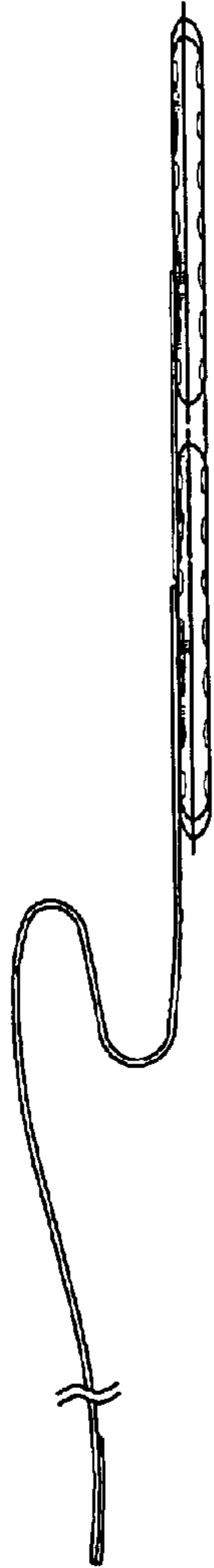

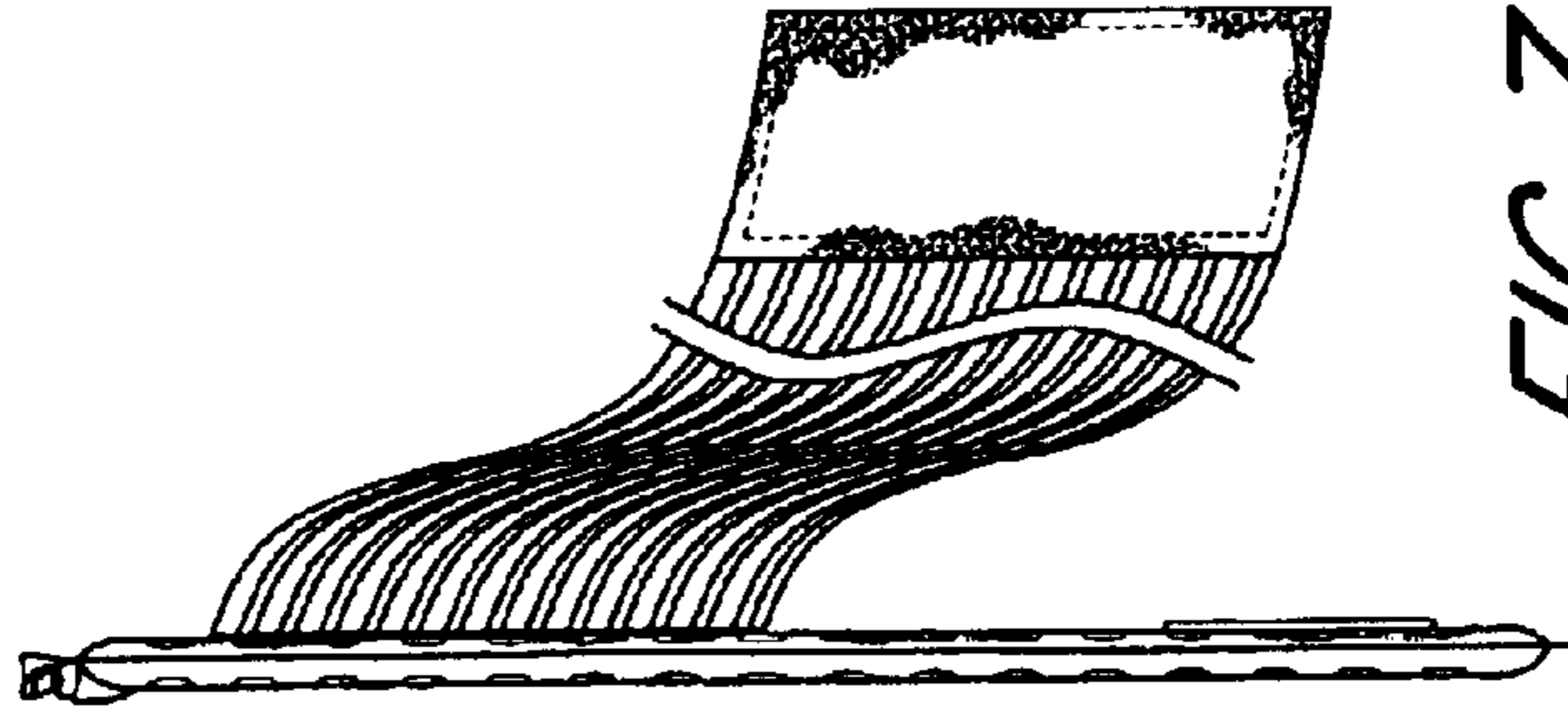

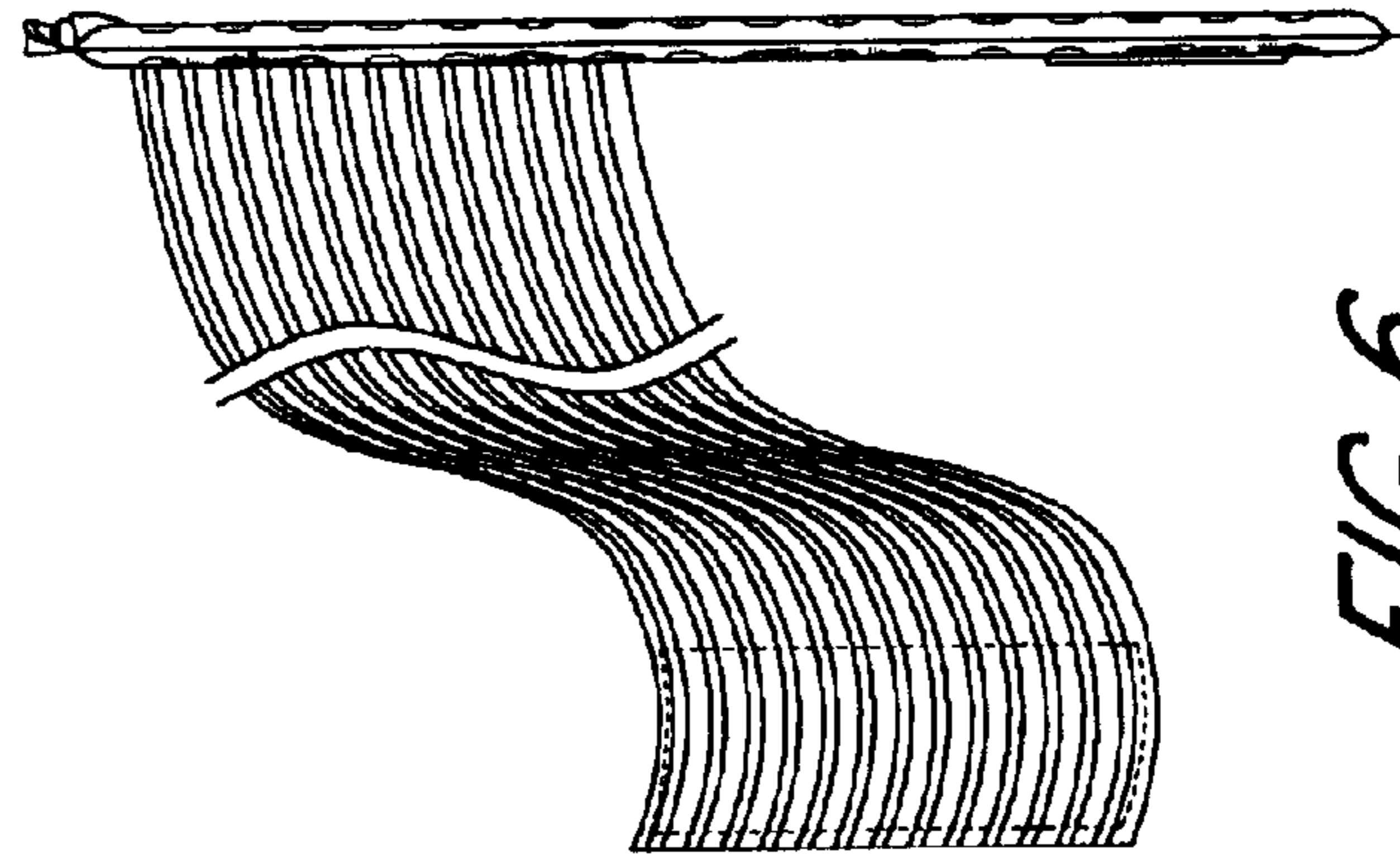
