(57) **CLAIM**

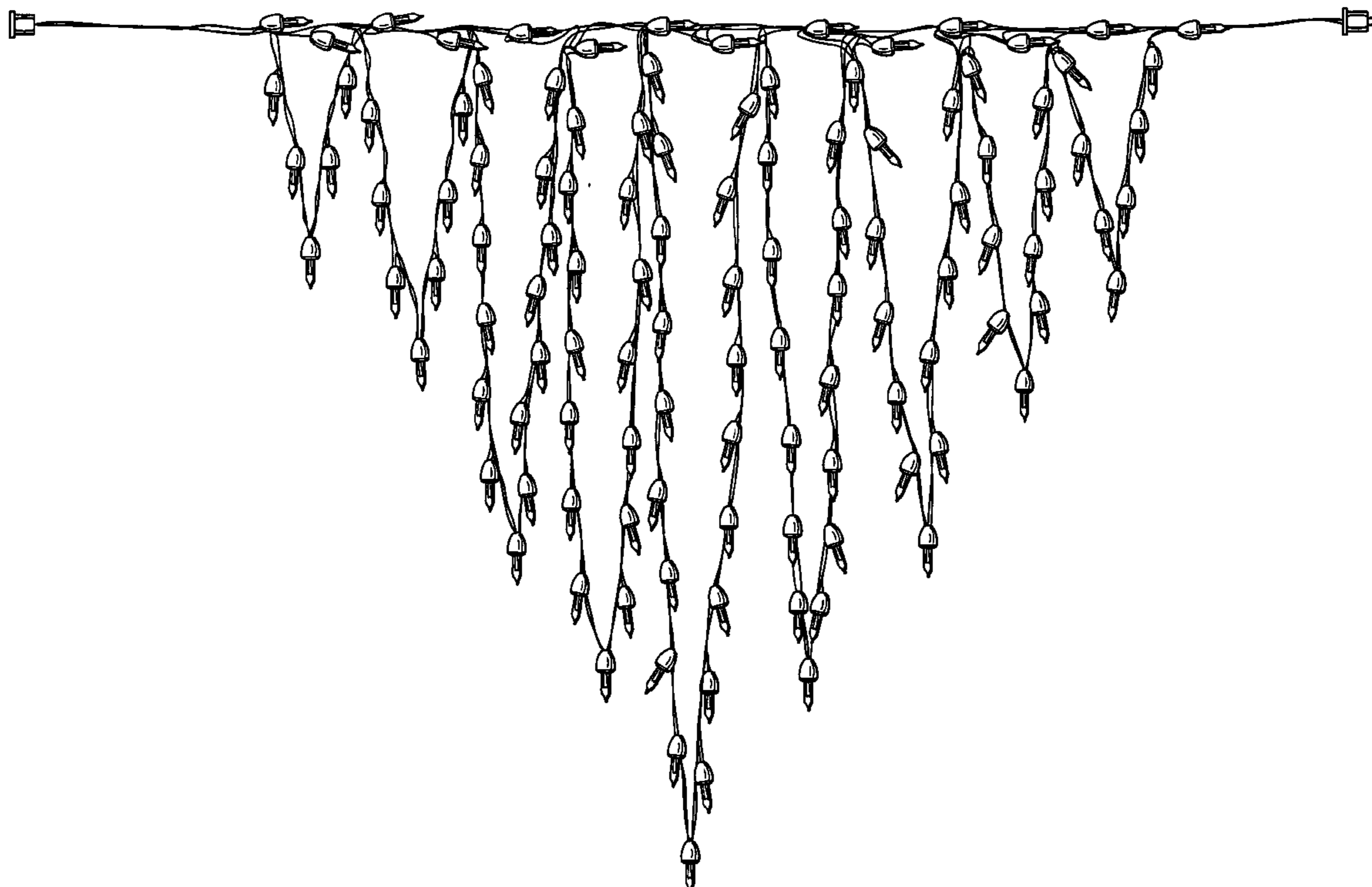
An ornamental design for icicle lights, as shown and described.

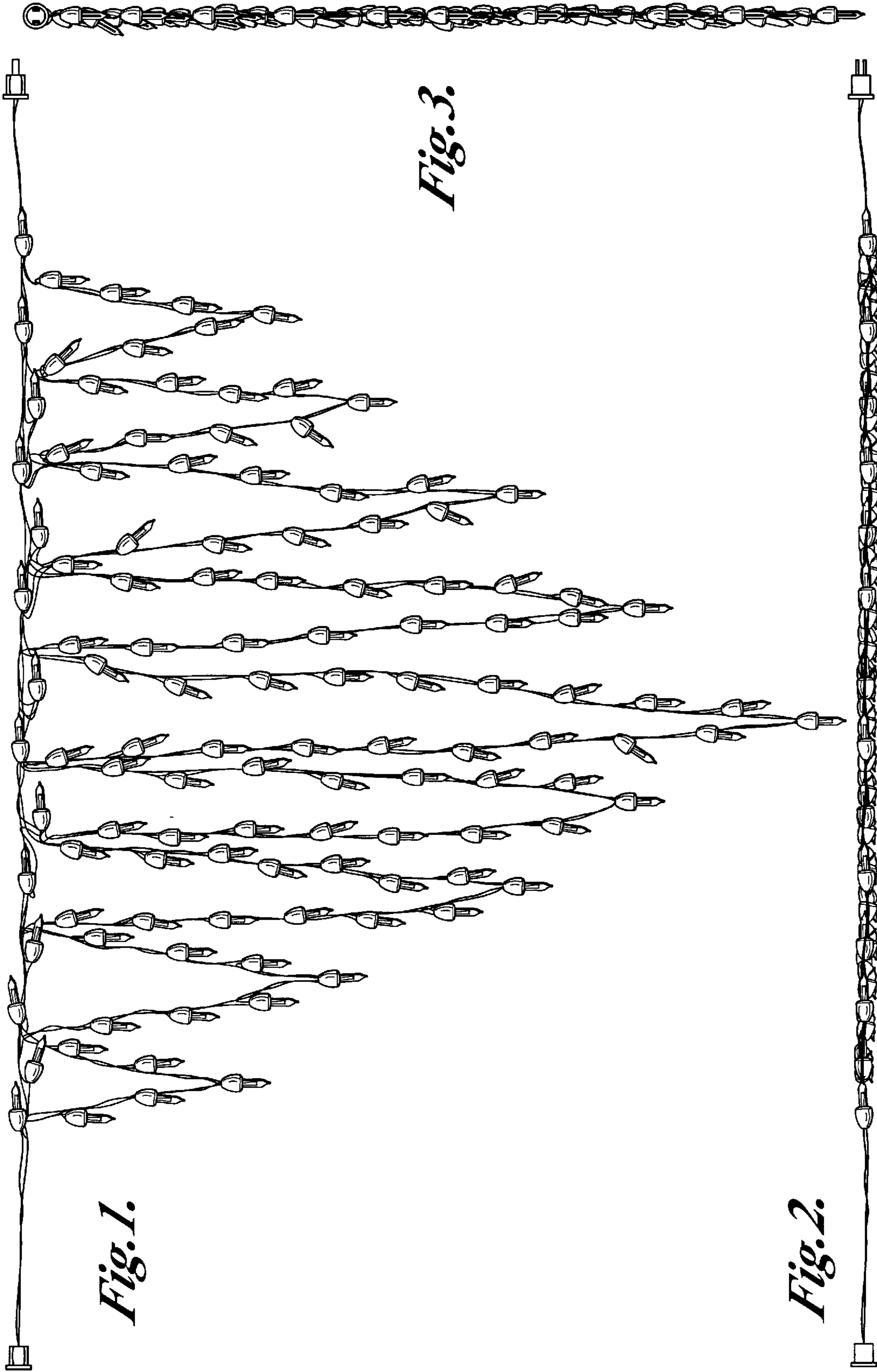
**DESCRIPTION**

FIG. 1 is a front elevation of the icicle lights showing the new design, the rear elevation being identical to the front elevation;

FIG. 2 is a top plan view of the icicle lights of FIG. 1, the bottom plan view being identical to the top plan view; and, FIG. 3 is a side elevation of the icicle lights of FIG. 1, the opposite side elevation being identical.
