The ornamental design for a pair of rally pads, as shown and  
described.

**DESCRIPTION**

FIG. 1 is a perspective view of one of the pair of rally pads  
showing my new design separately for clarity of illustration,  
it being understood the second of the pair is identical;

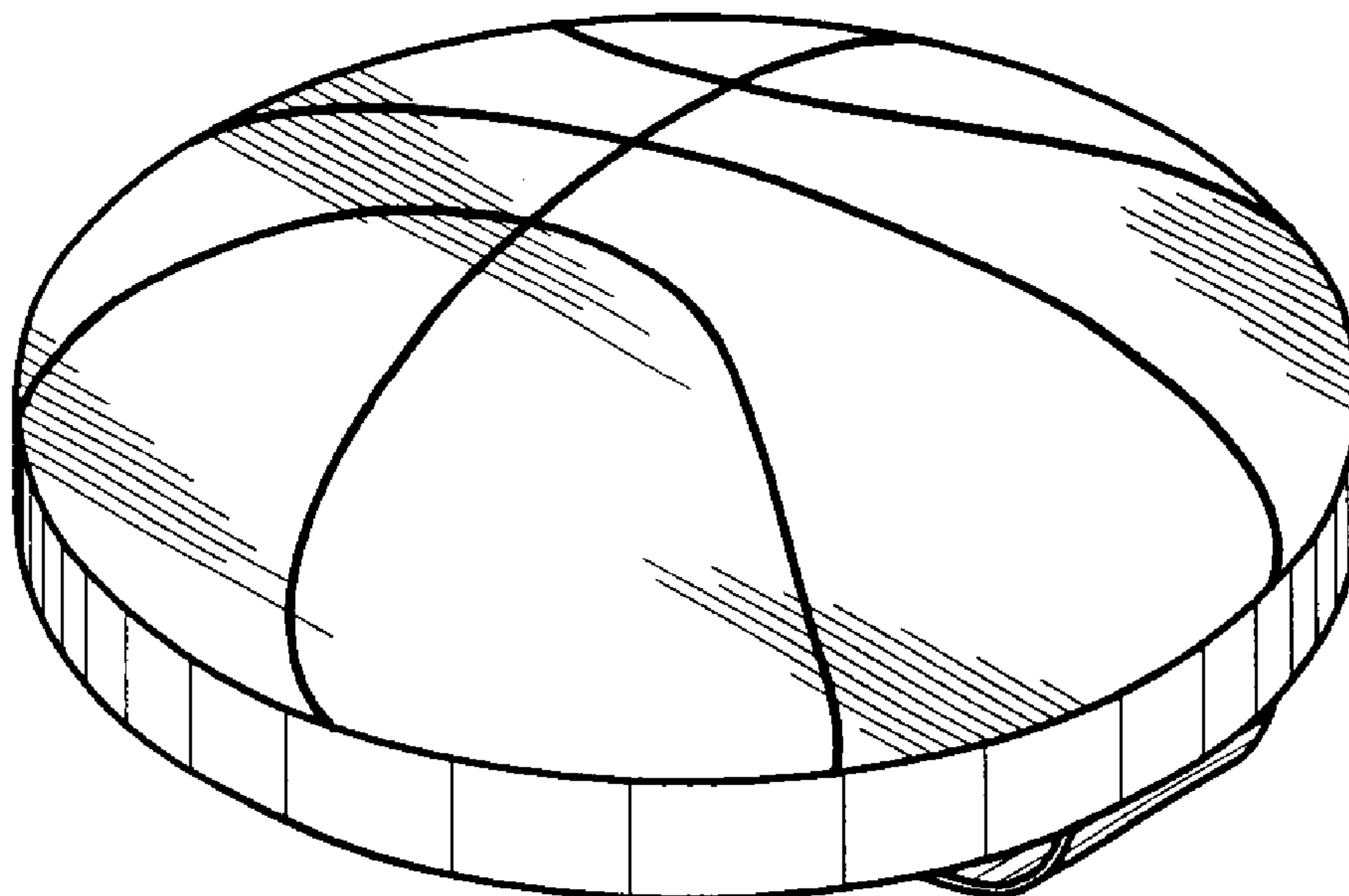
FIG. 2 is a top view of the rally pad shown in FIG. 1.

FIG. 3 is a bottom view of the rally pad shown in FIG. 1.

FIG. 4 is a side view of the rally pad shown in FIG. 1; and,

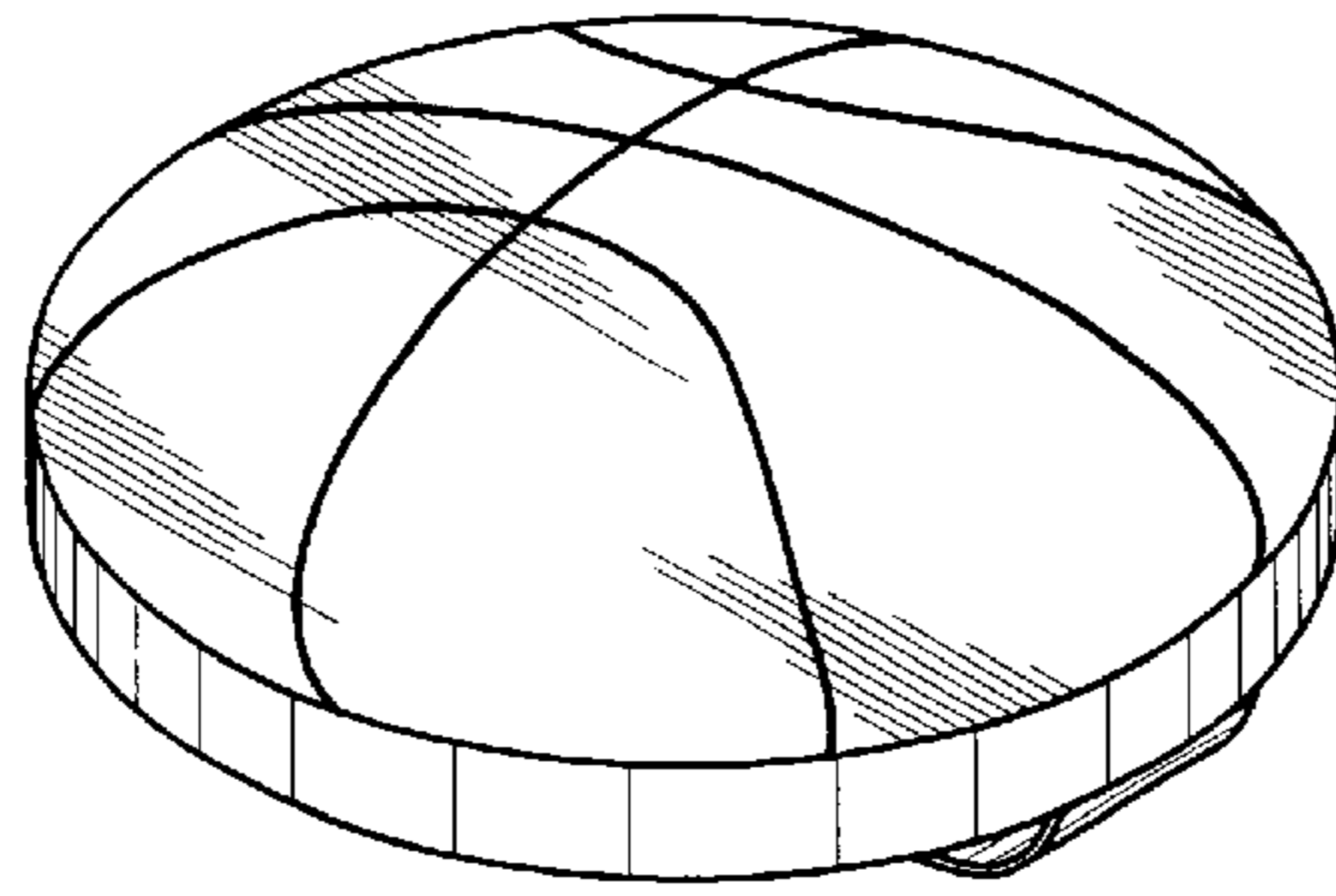

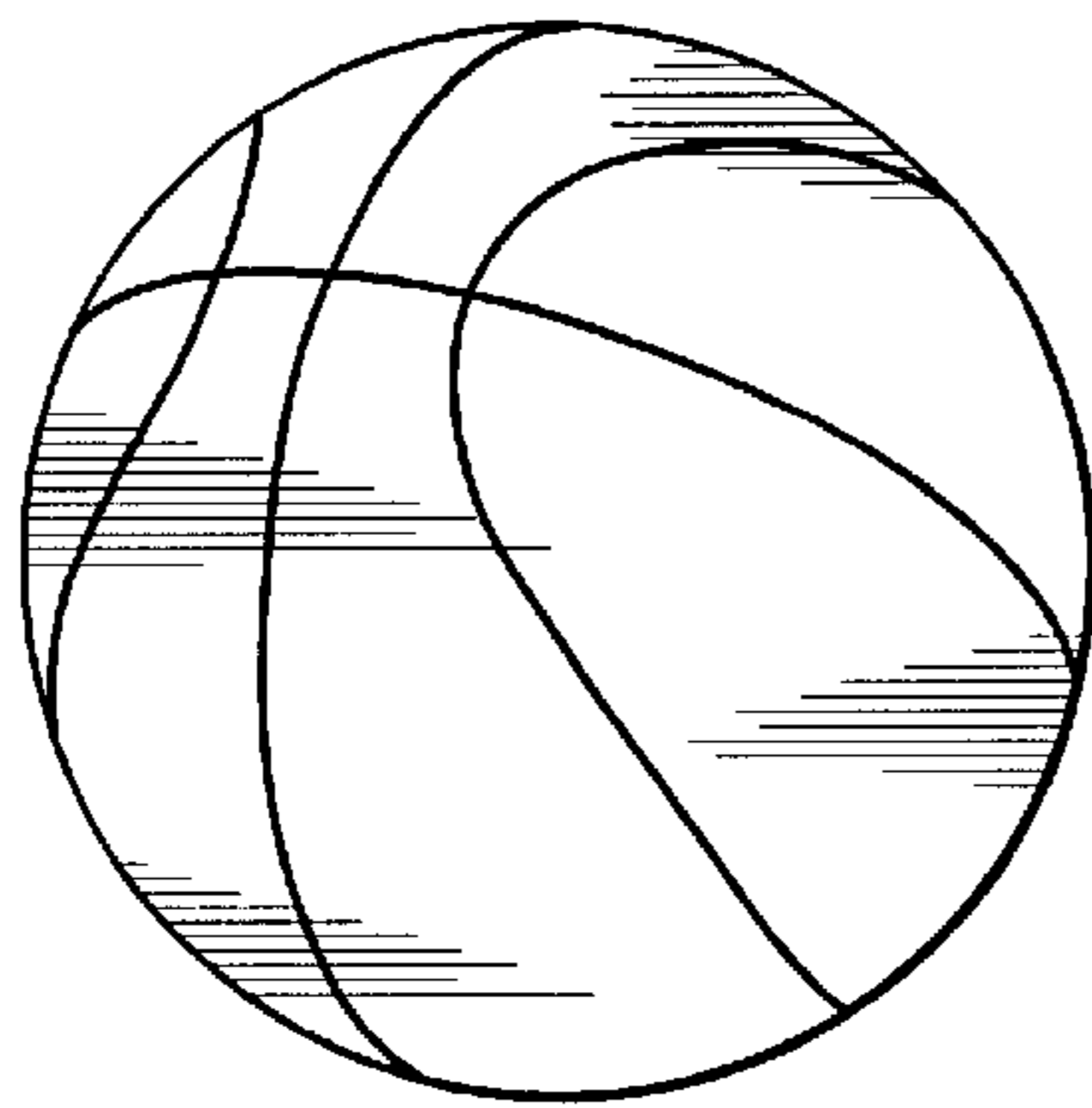

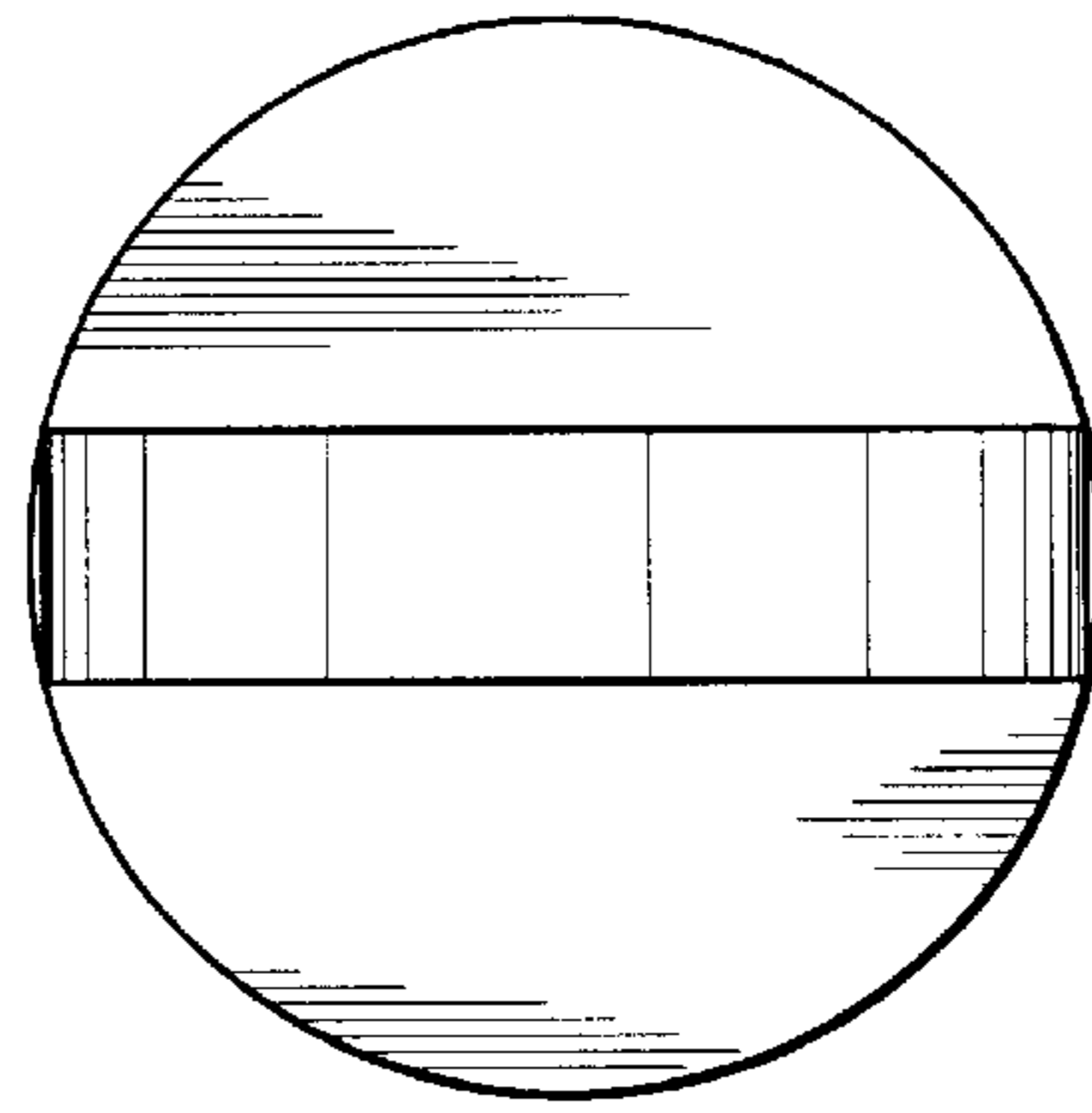

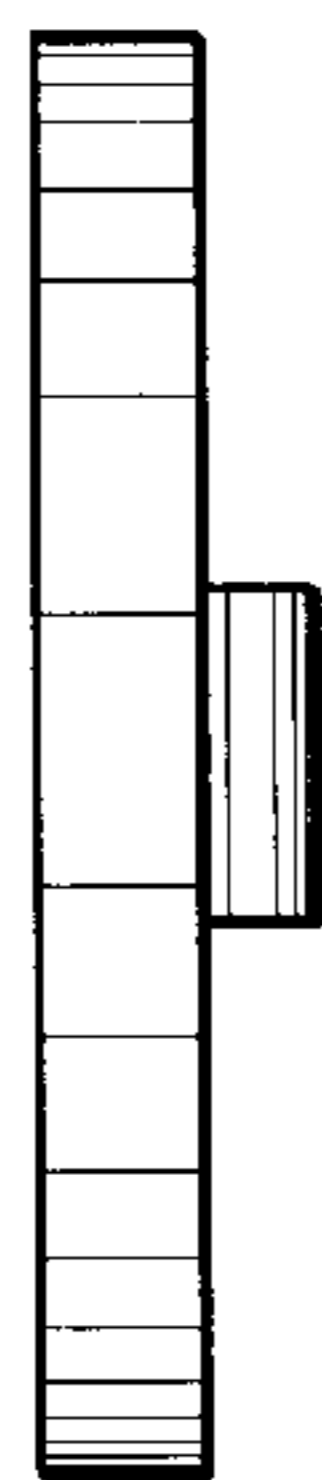

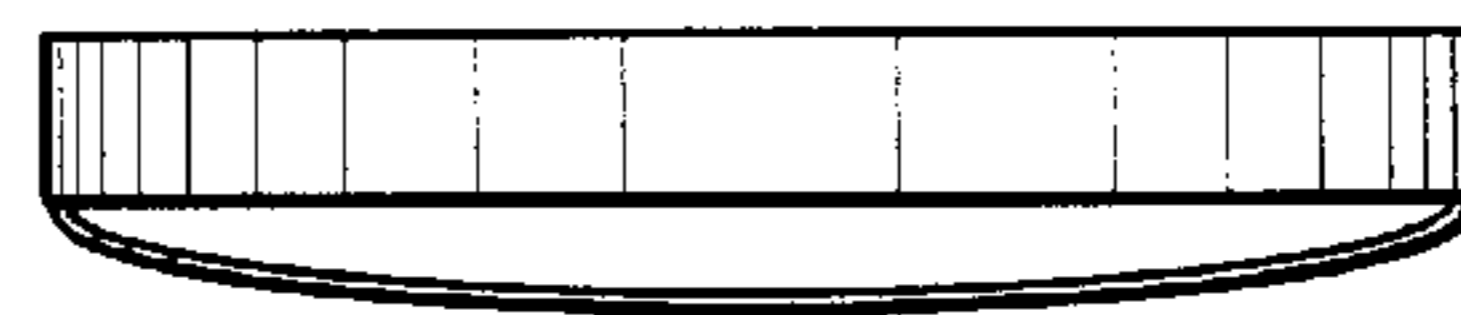
