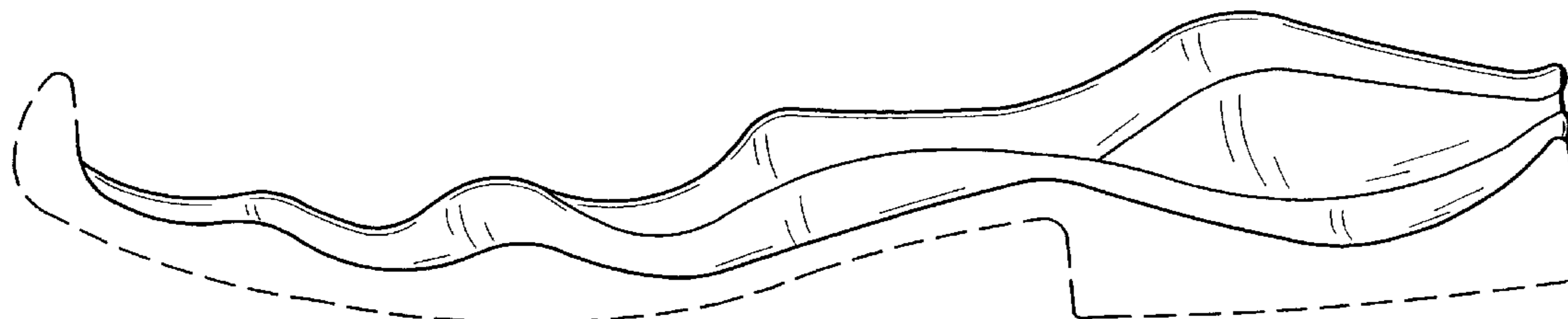
FIG. 1 is a perspective view of the shoe midsole showing a bottom and left sides of the new design;

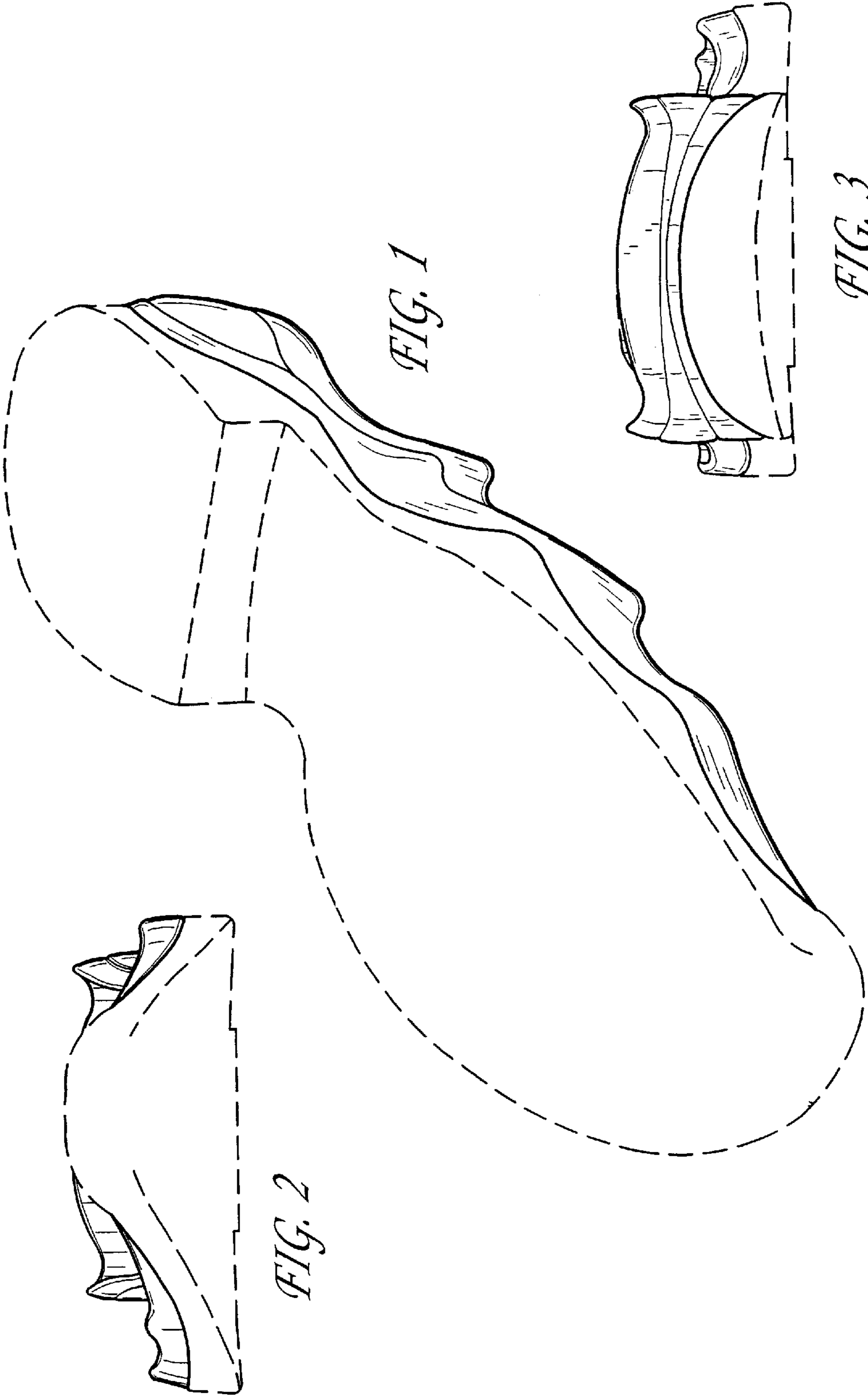

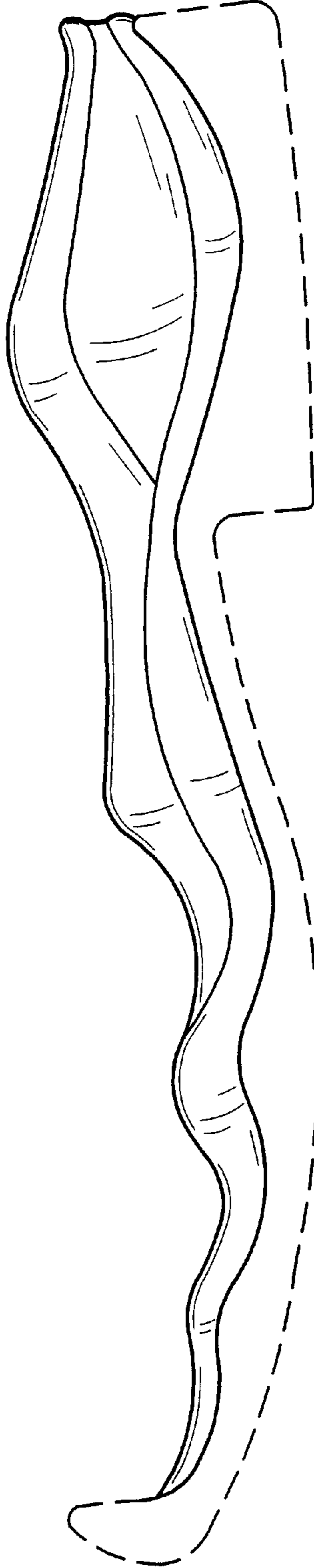

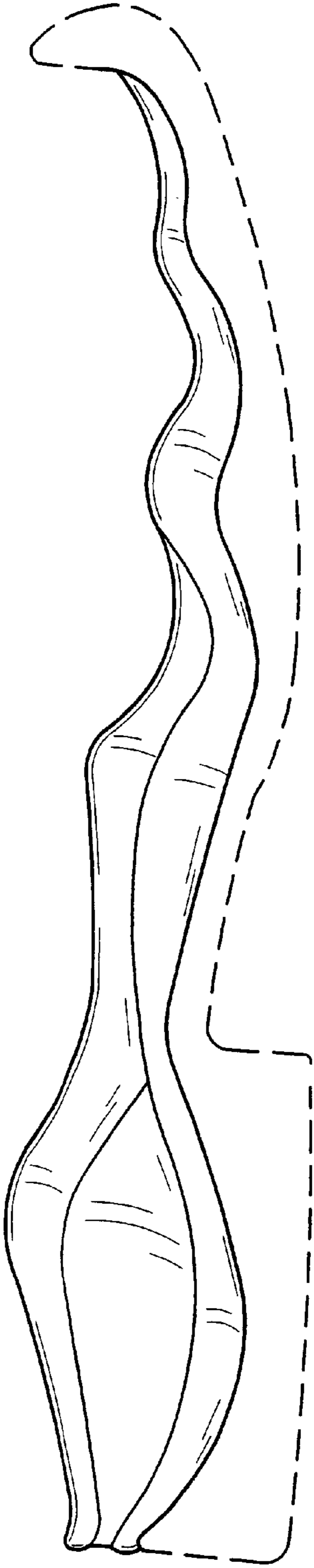

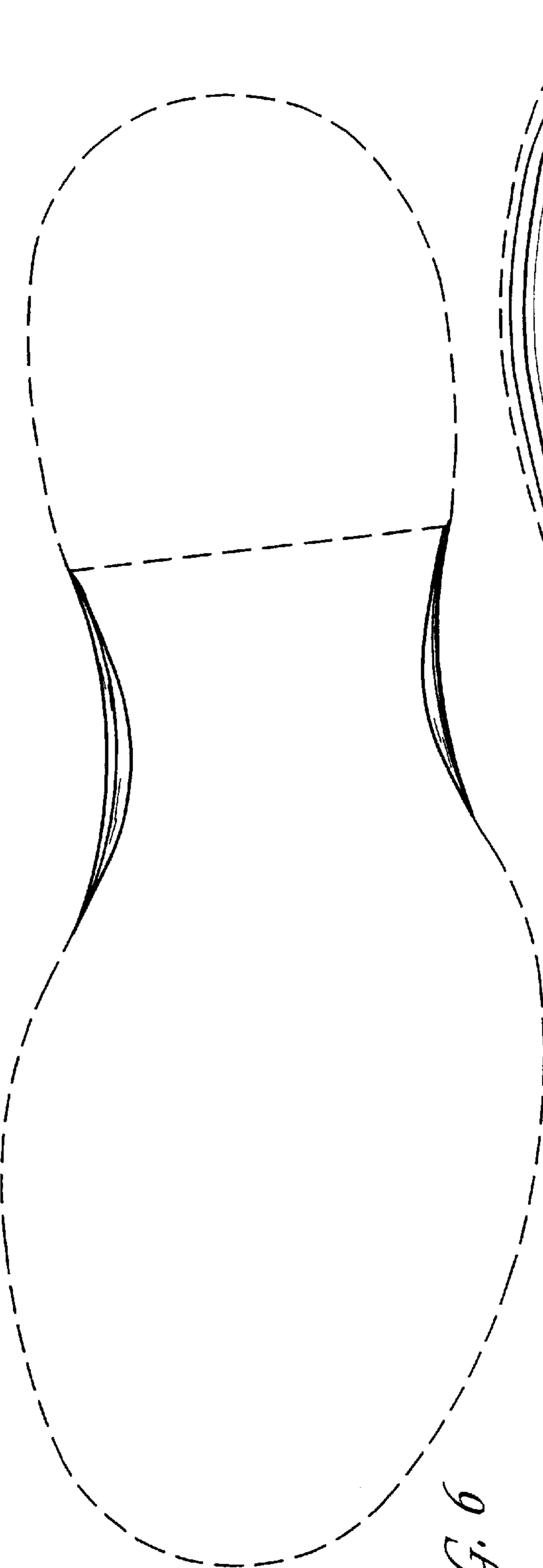

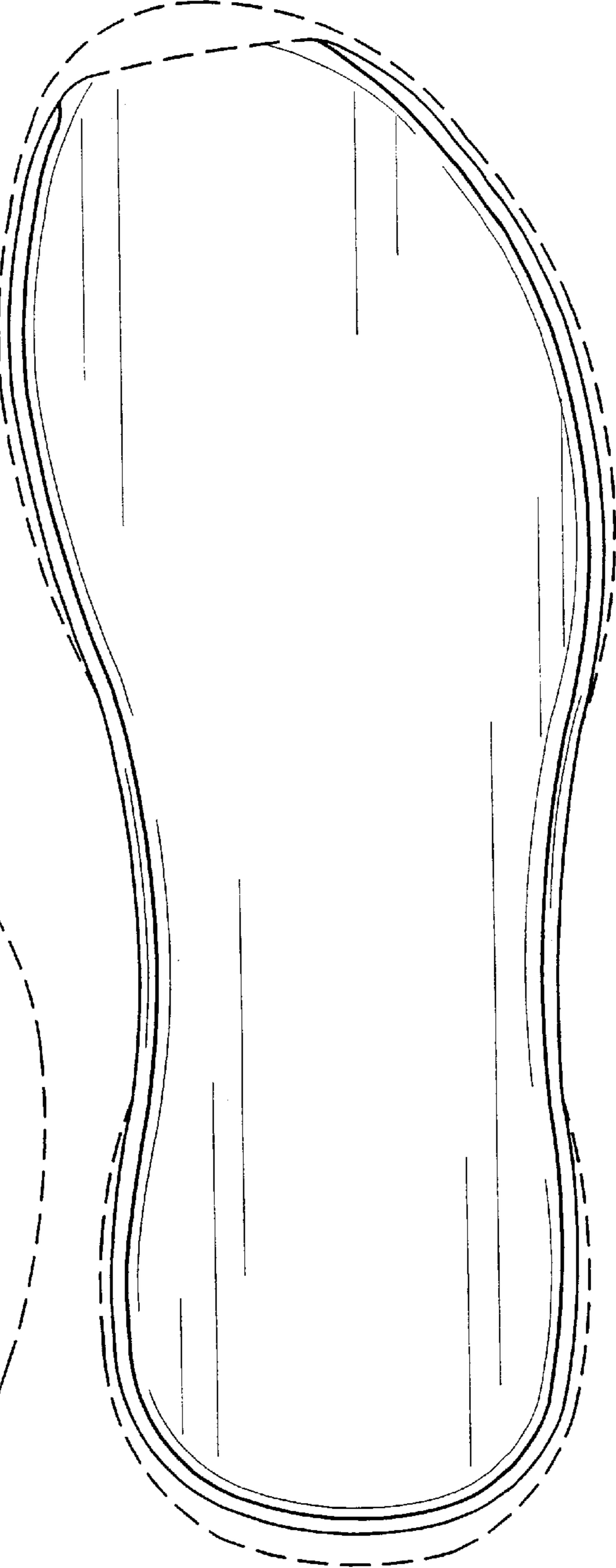

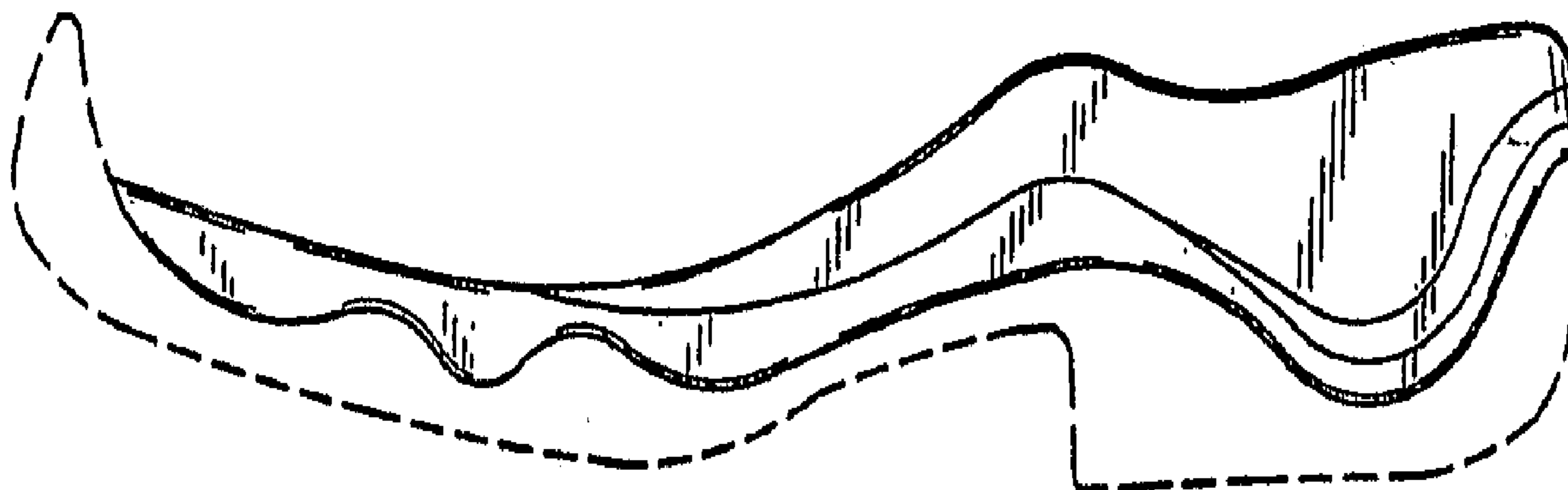

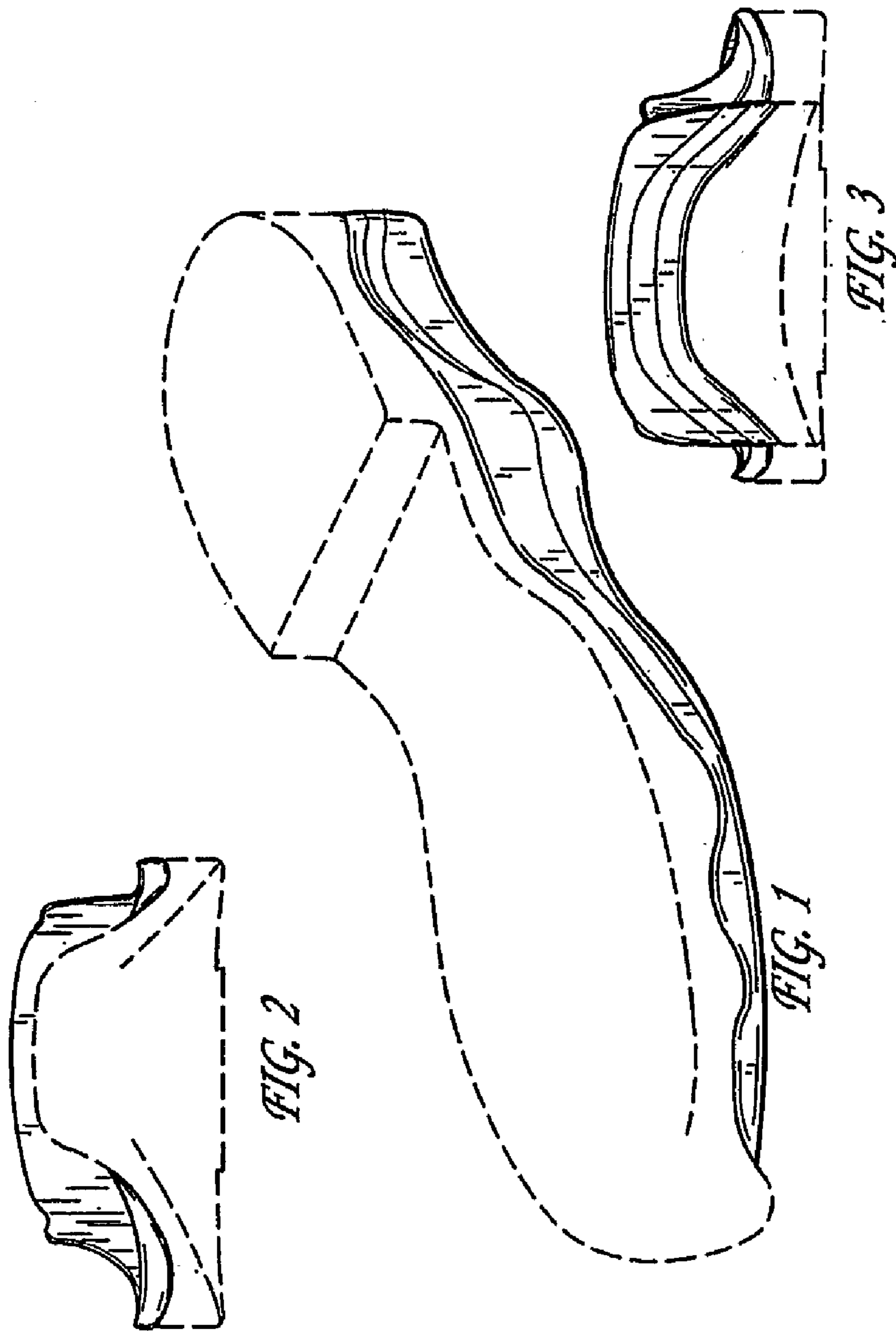

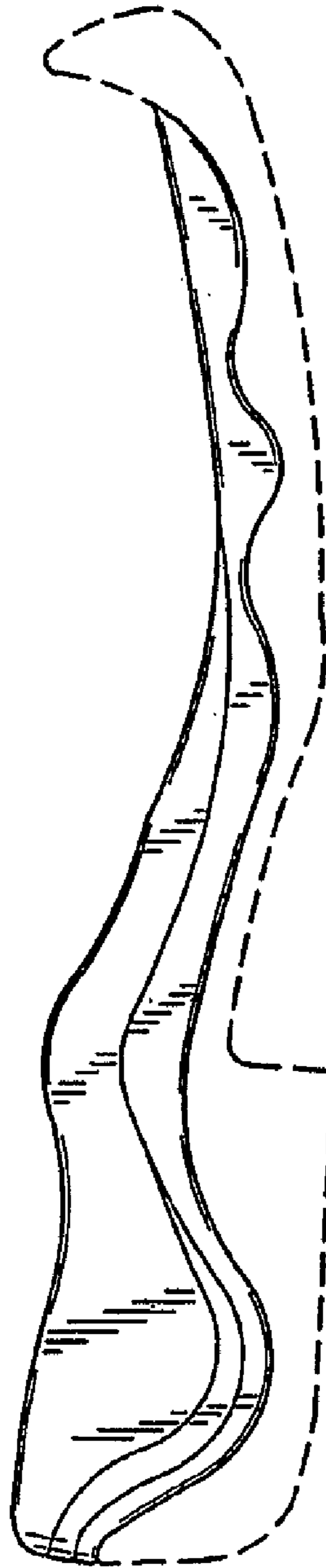

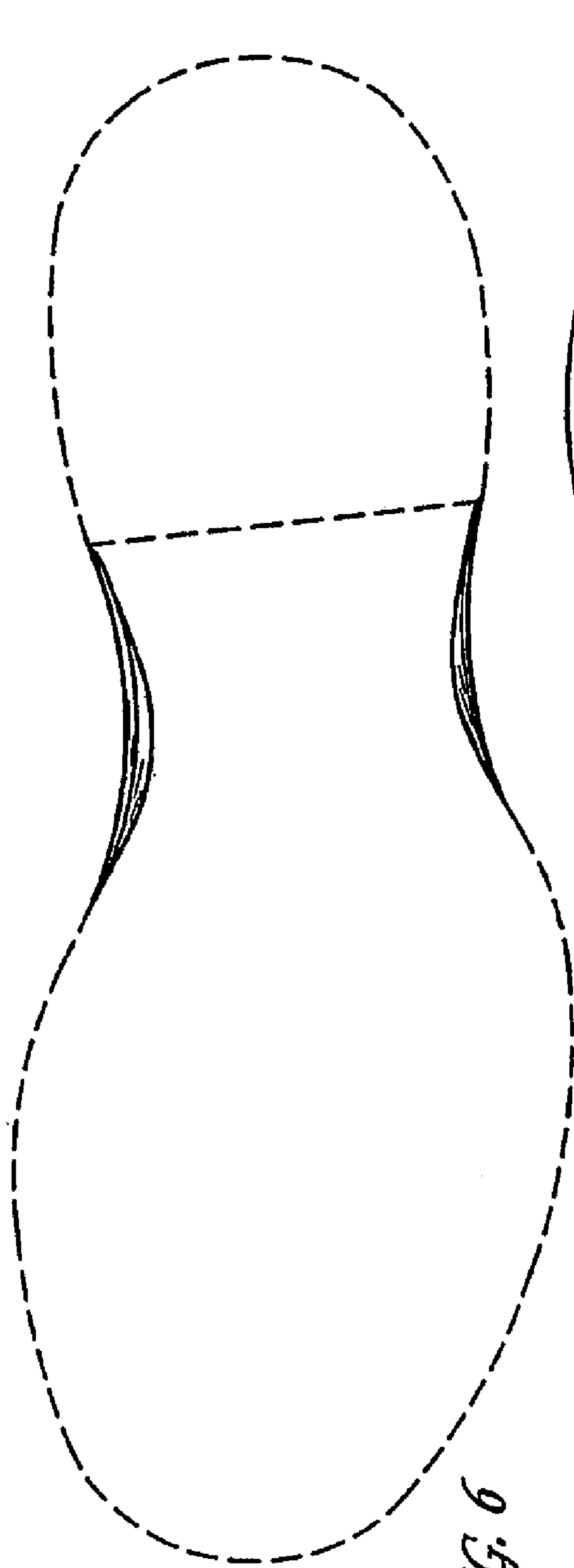
