(57) **CLAIM**

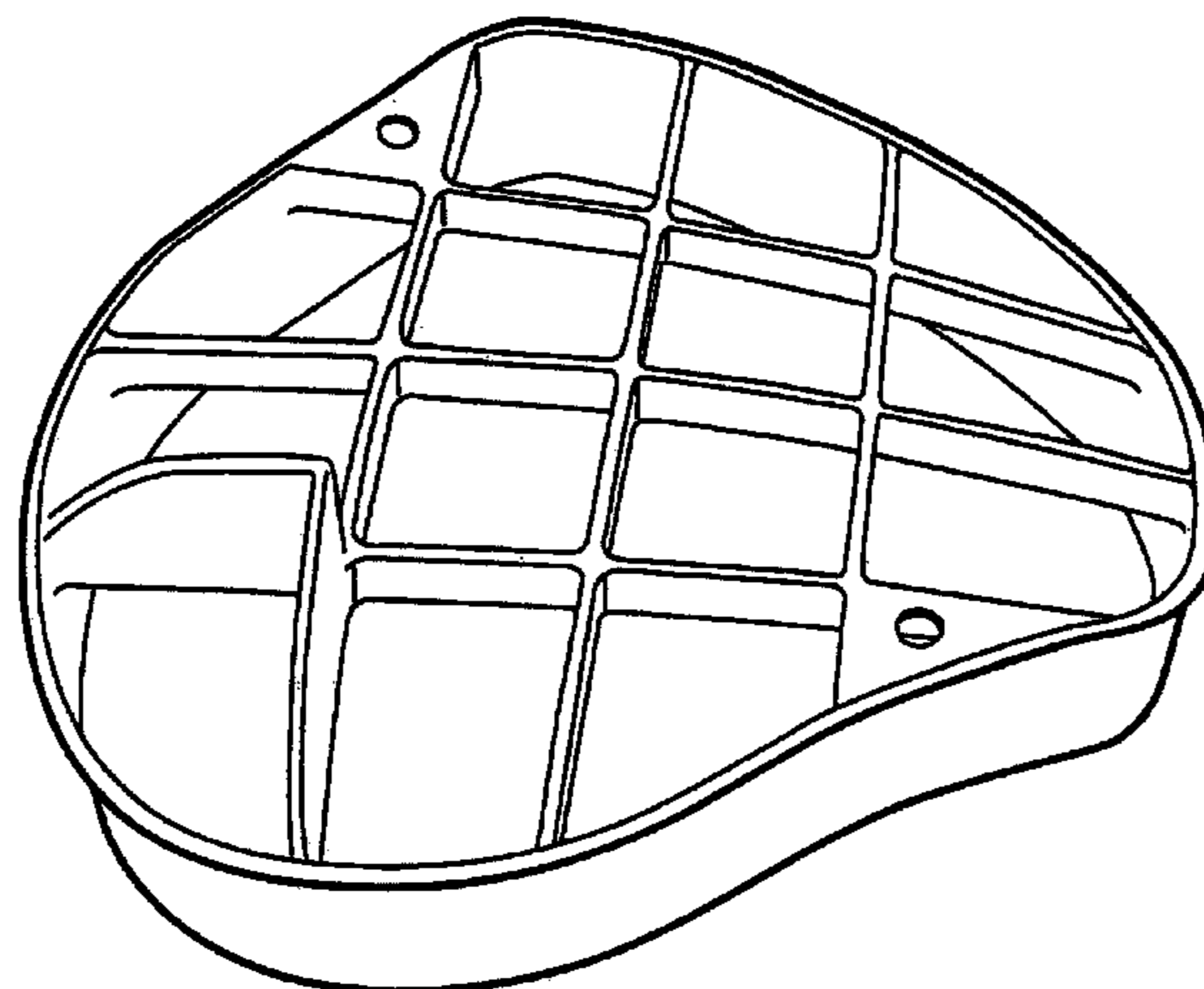
The ornamental design for a golf bag top with diamond shaped club dividers, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of the golf bag top
FIG. 2 is a front perspective view of the golf bag top,
FIG. 3 is a first side view of the golf bag top
FIG. 4 is a second side view of the golf bag top
FIG. 5 is a top view of the golf bag top; and,
FIG. 6 is a rear view of the golf bag top.

My golf bag top is characterized by the diamond shaped club dividers, where the golf club shafts rests on the bottom of the v-shaped troughs.

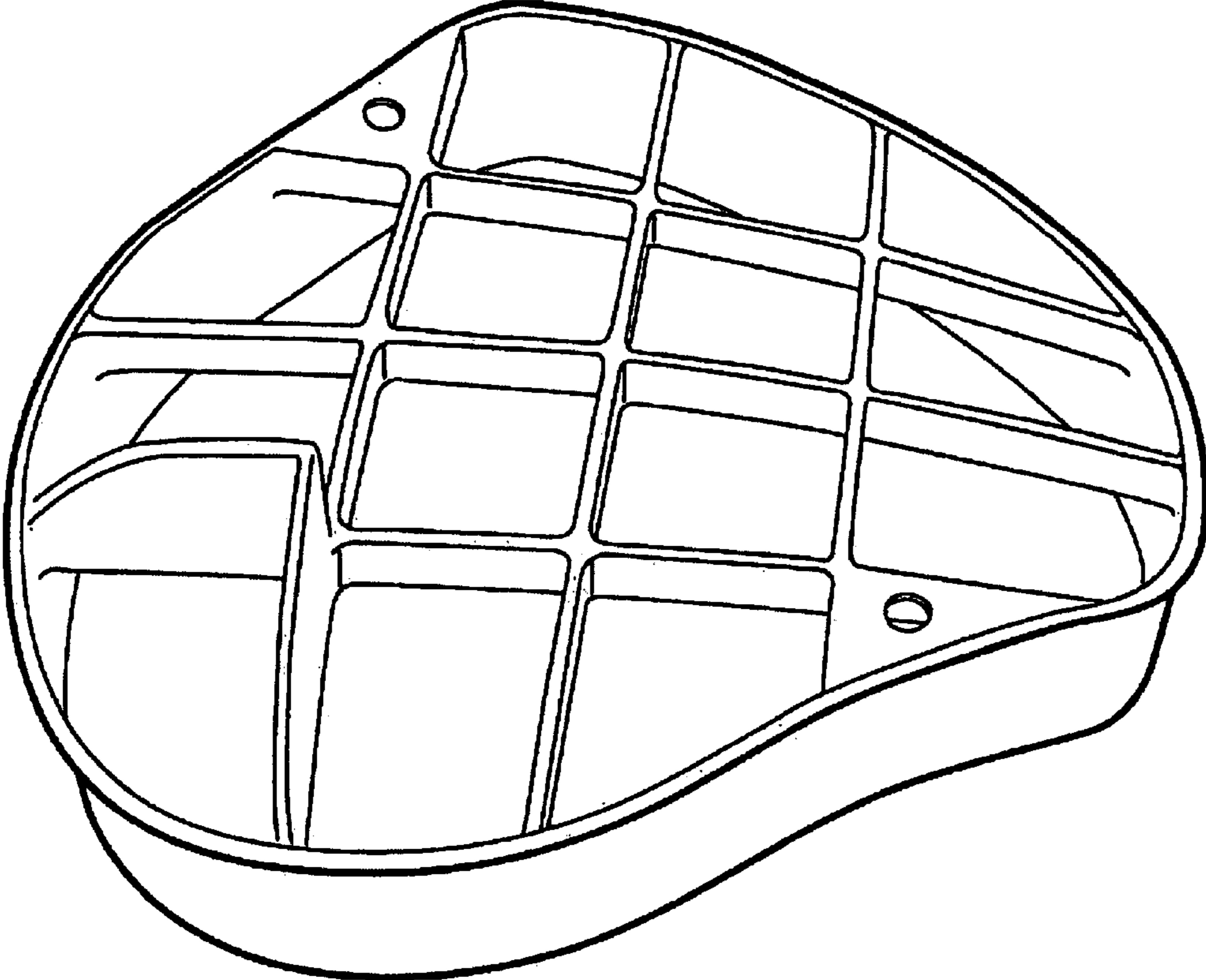

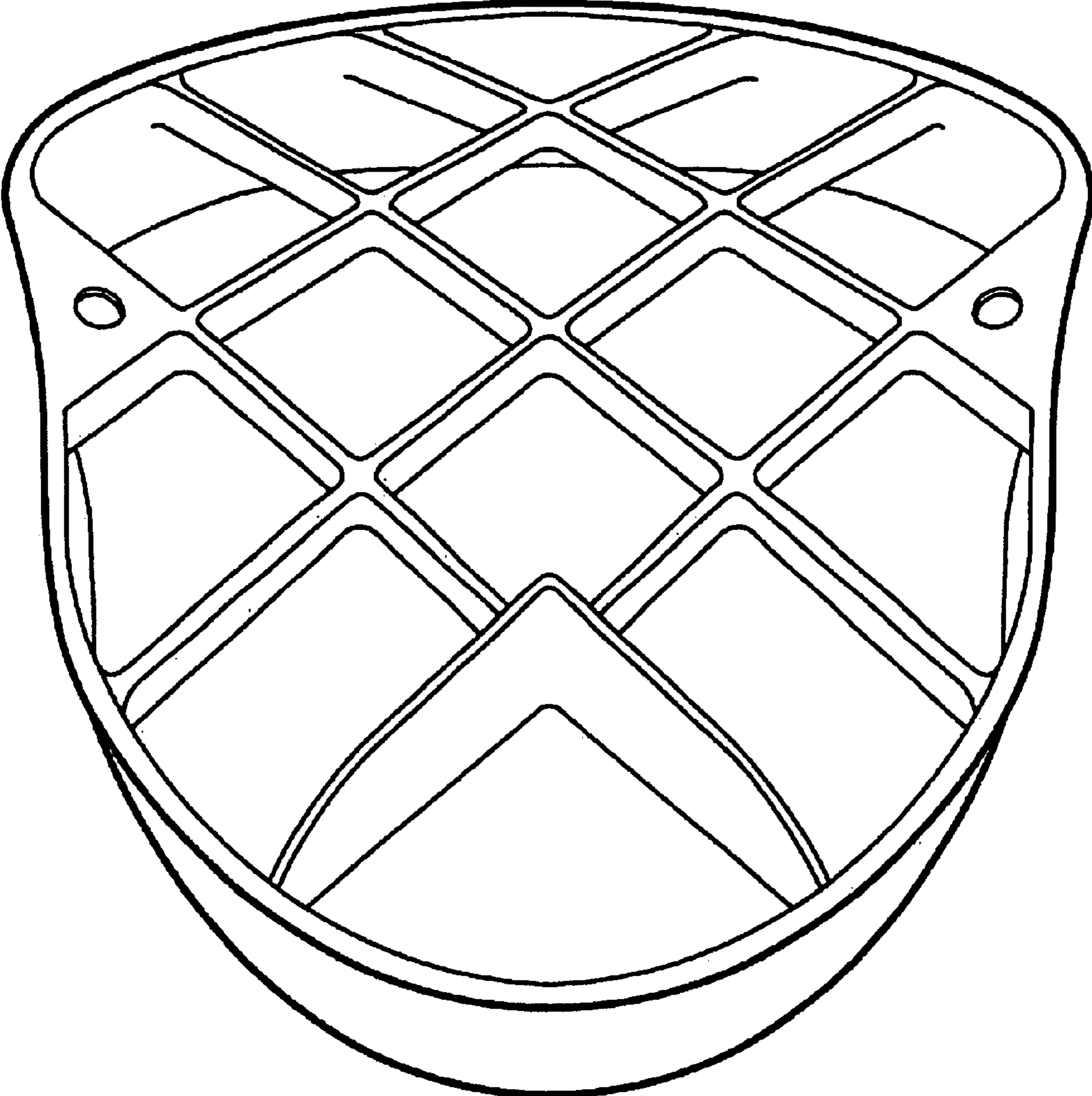

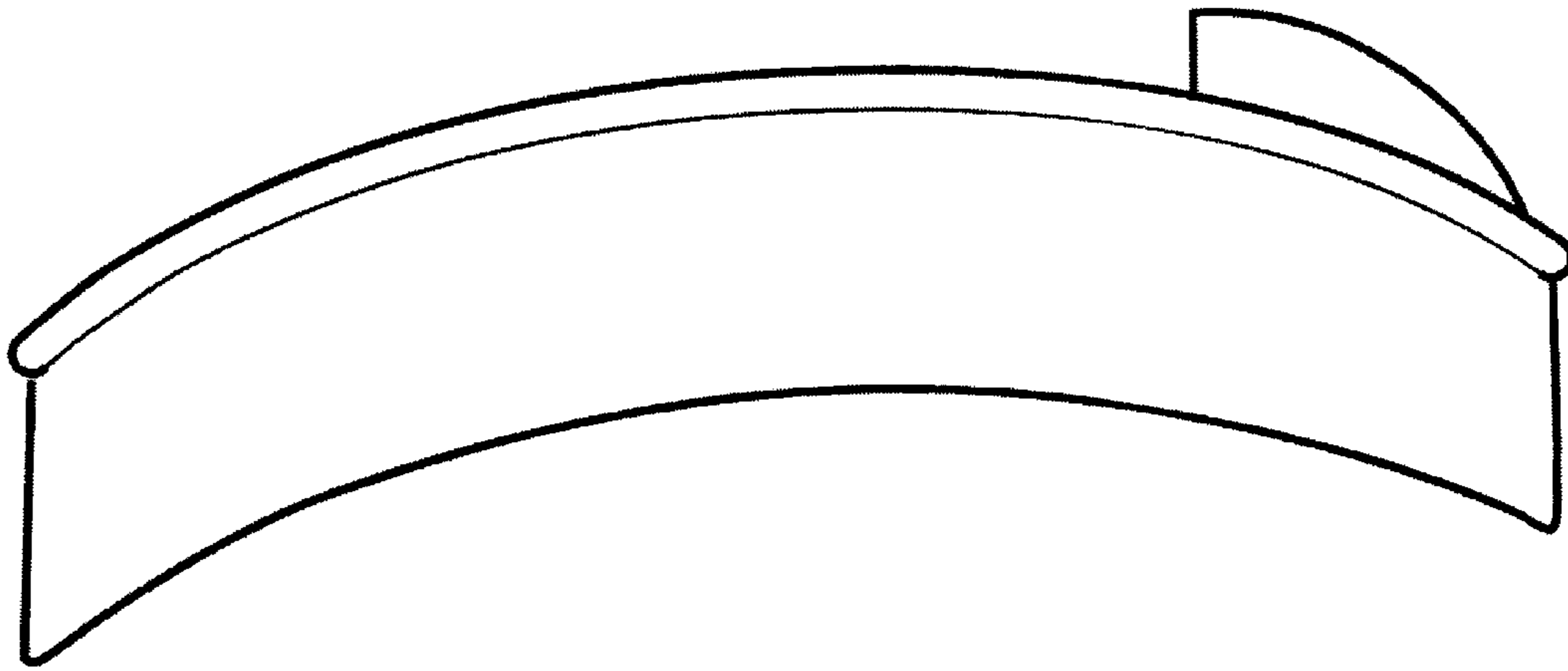

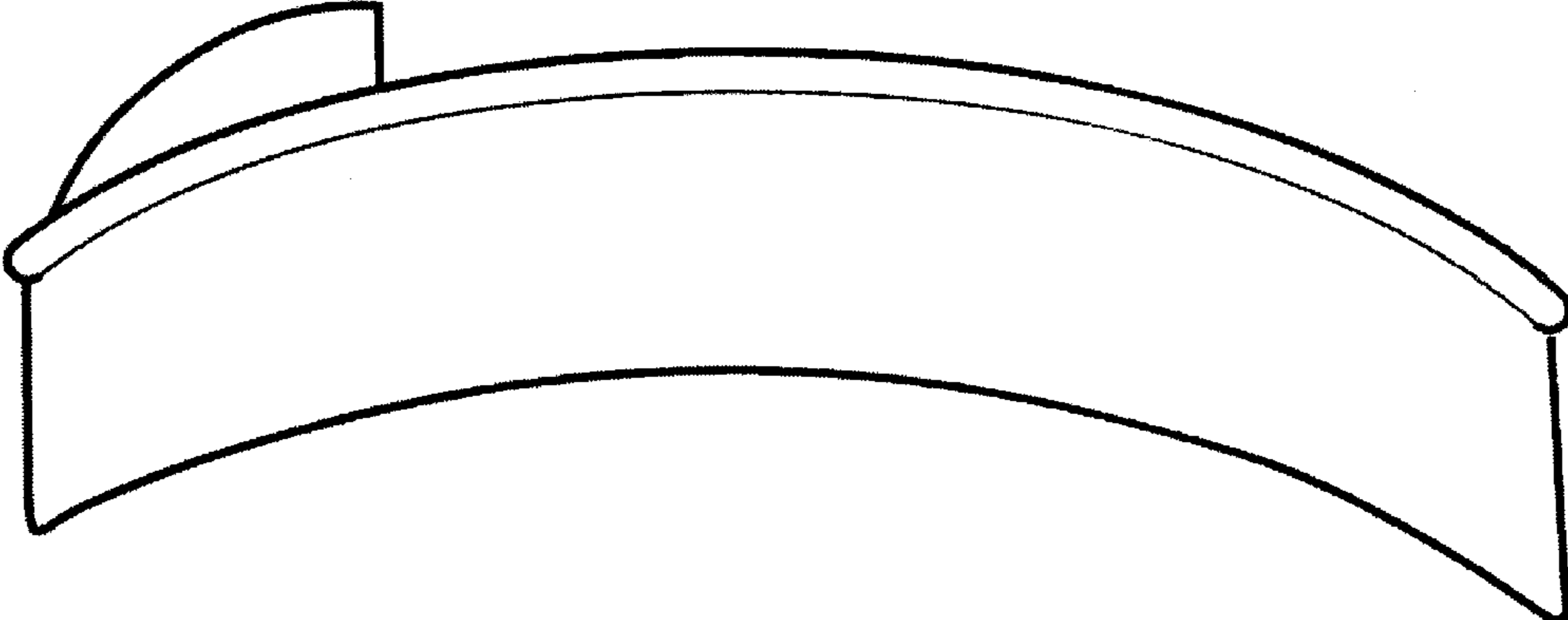

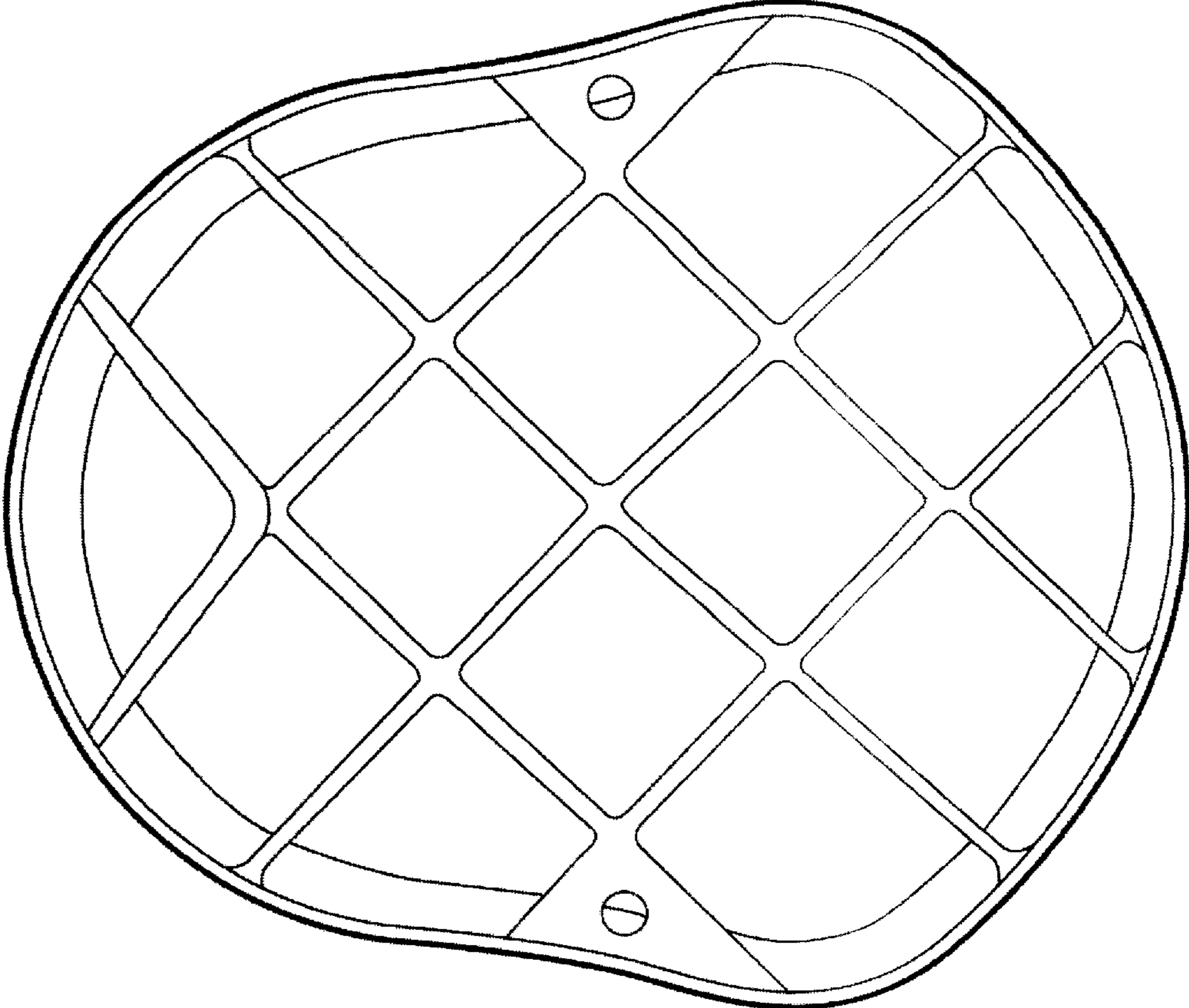

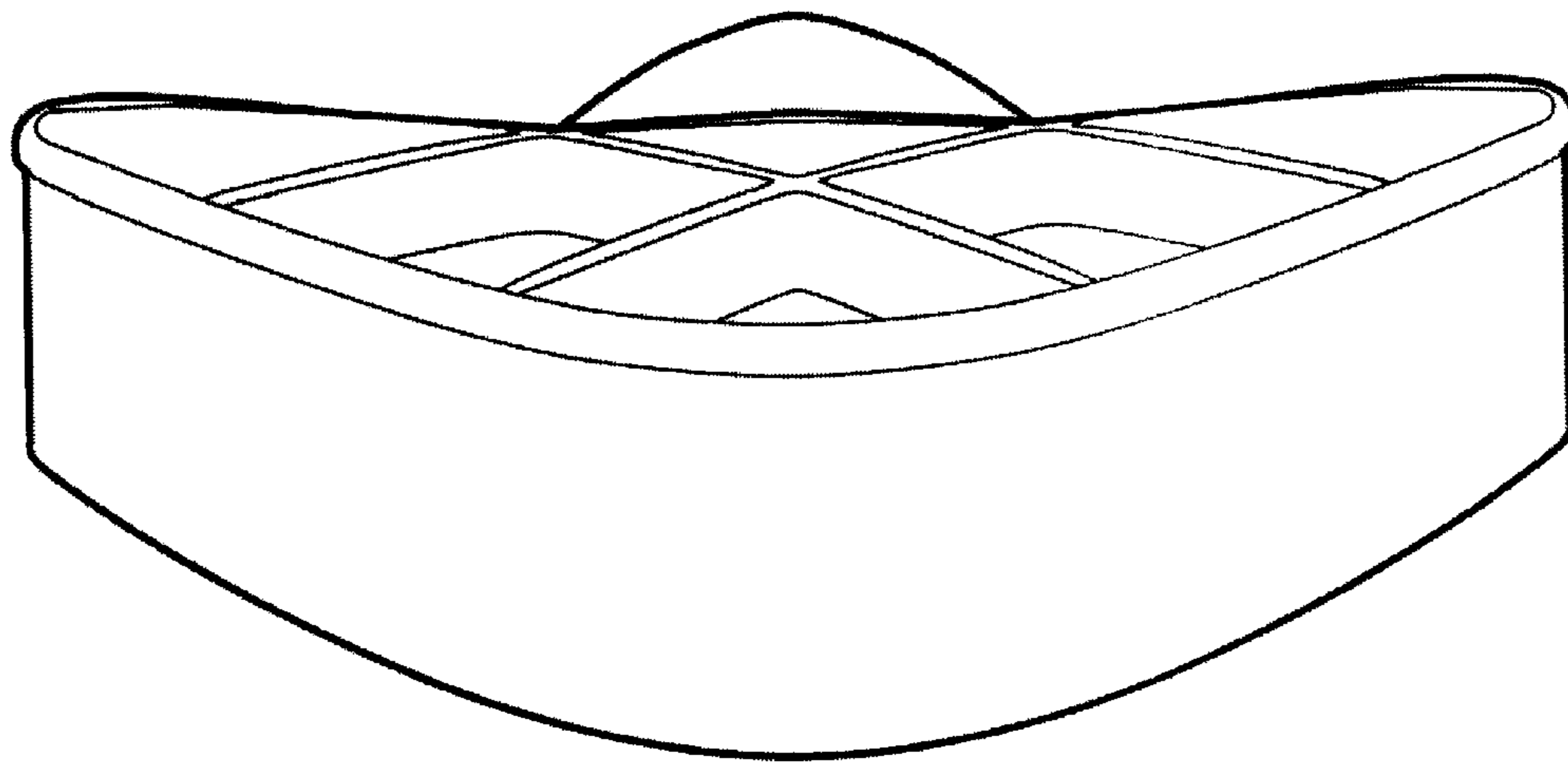
