(57) **CLAIM**

The ornamental design for a steam kettle, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of the steam kettle of the invention;  
 FIG. 2 is a side elevational view of the steam kettle with handle on the right;  
 FIG. 3 is a side elevational view of the steam kettle with handle on the left;  
 FIG. 4 is a top plan view of the steam kettle of the invention;  
 FIG. 5 is a bottom plan view of the steam kettle with centrally positioned generally triangularly shaped indentation;  
 FIG. 6 is a front elevational view of the steam kettle;  
 FIG. 7 is a back elevational view of the steam kettle;  
 FIG. 8 is a perspective view of the steam kettle having the top closure in an open position for filling; and,  
 FIG. 9 is a perspective view of the steam kettle having the top closure in an open position for dispensing.

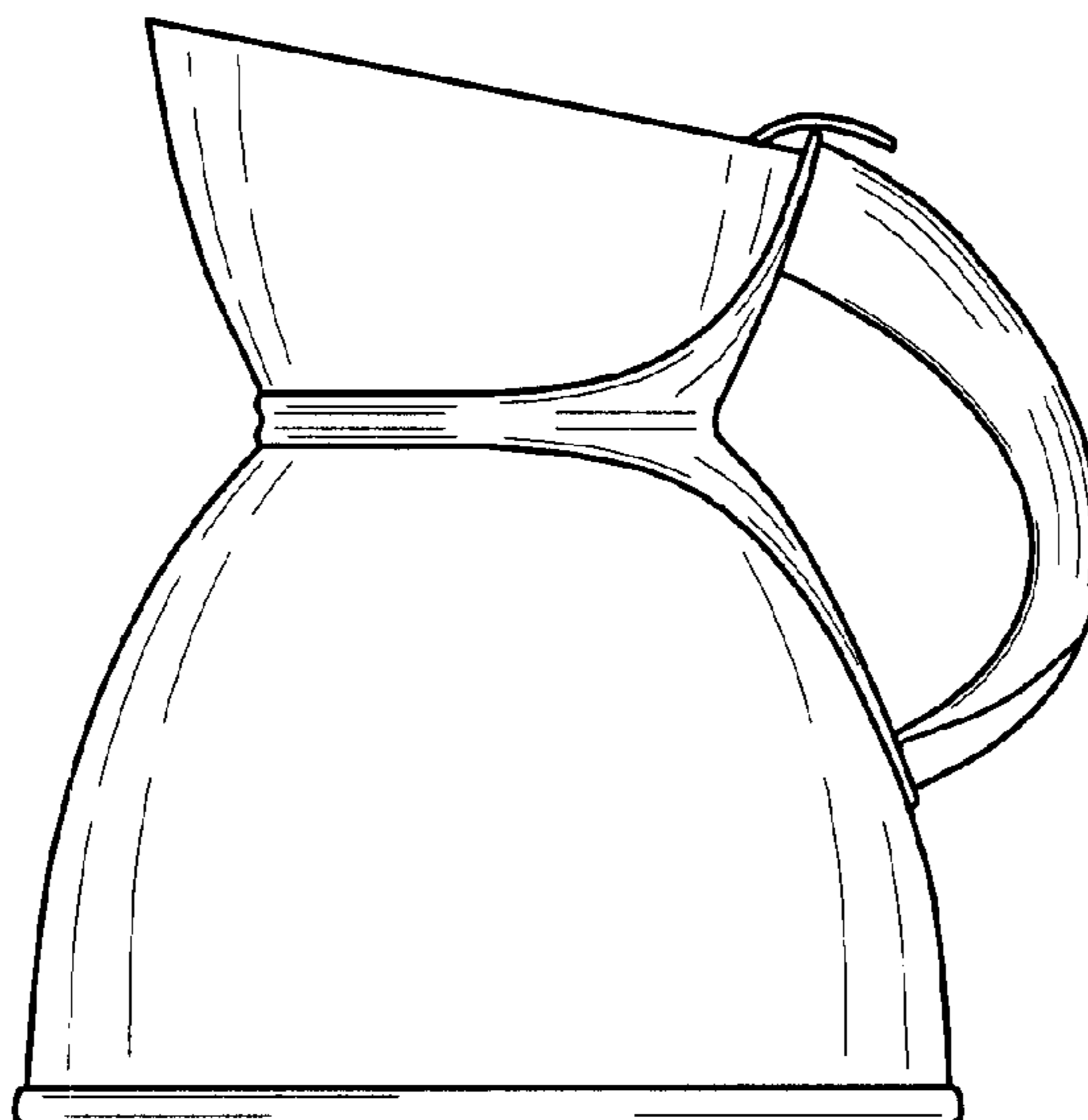

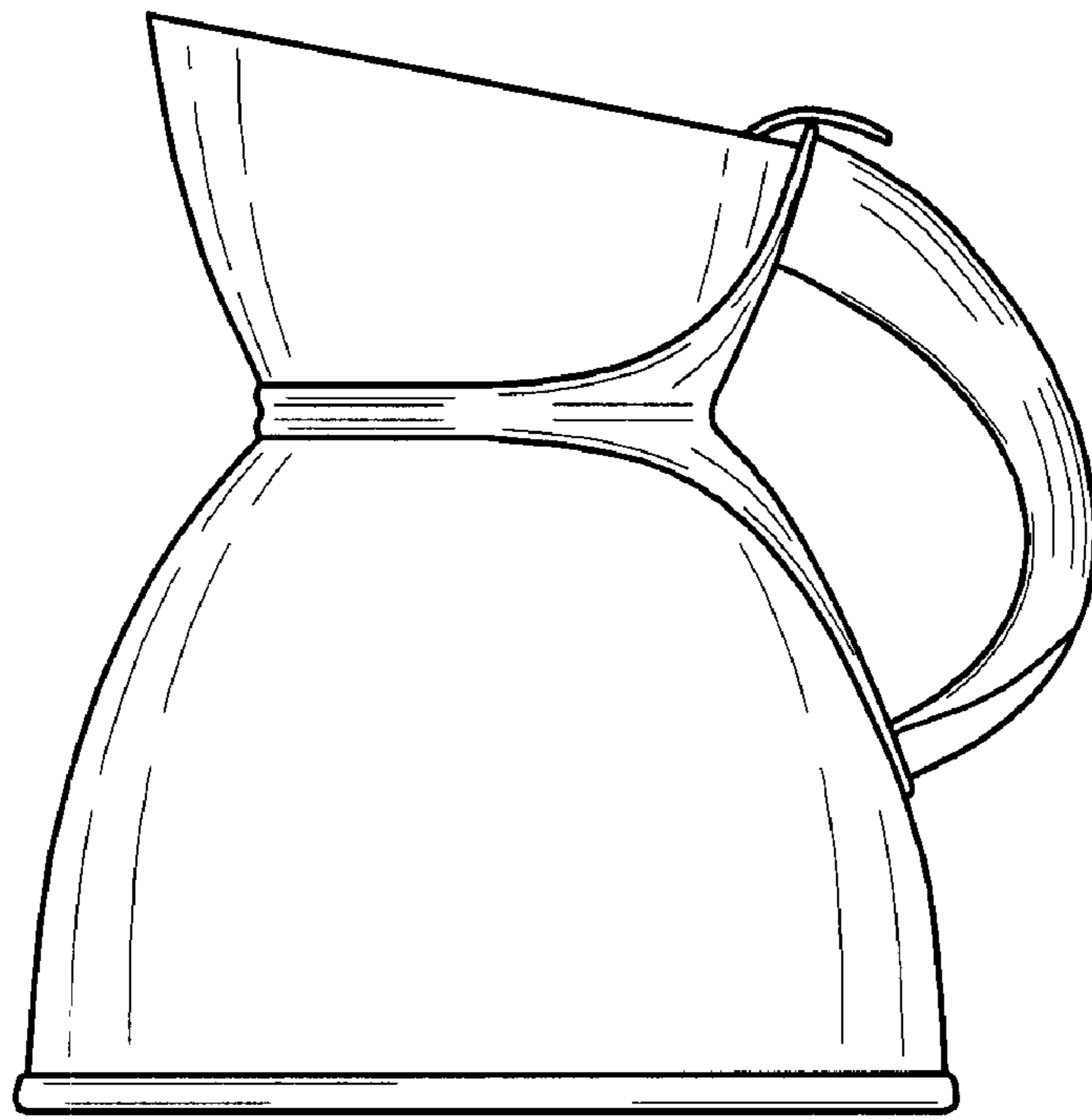

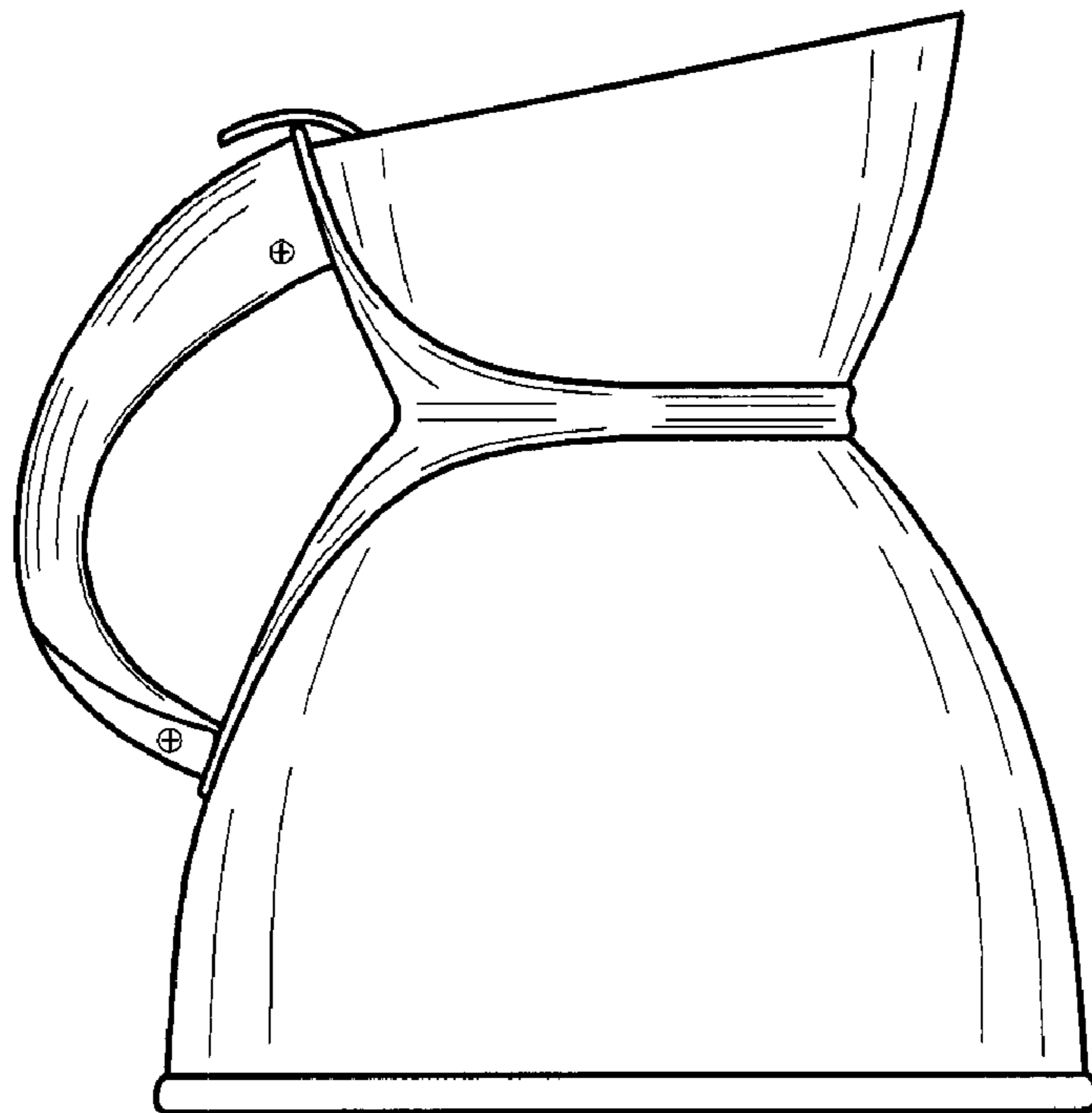

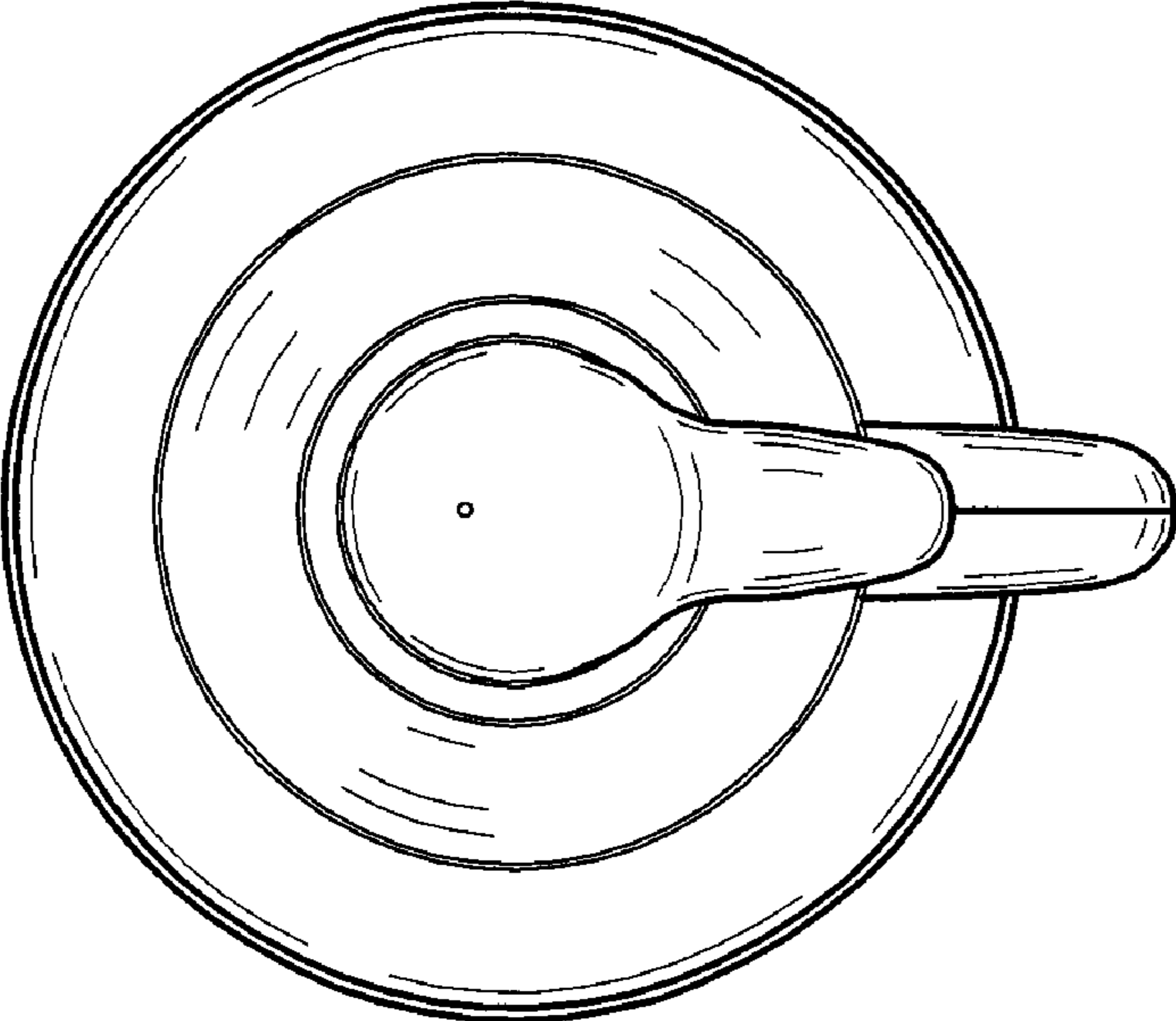

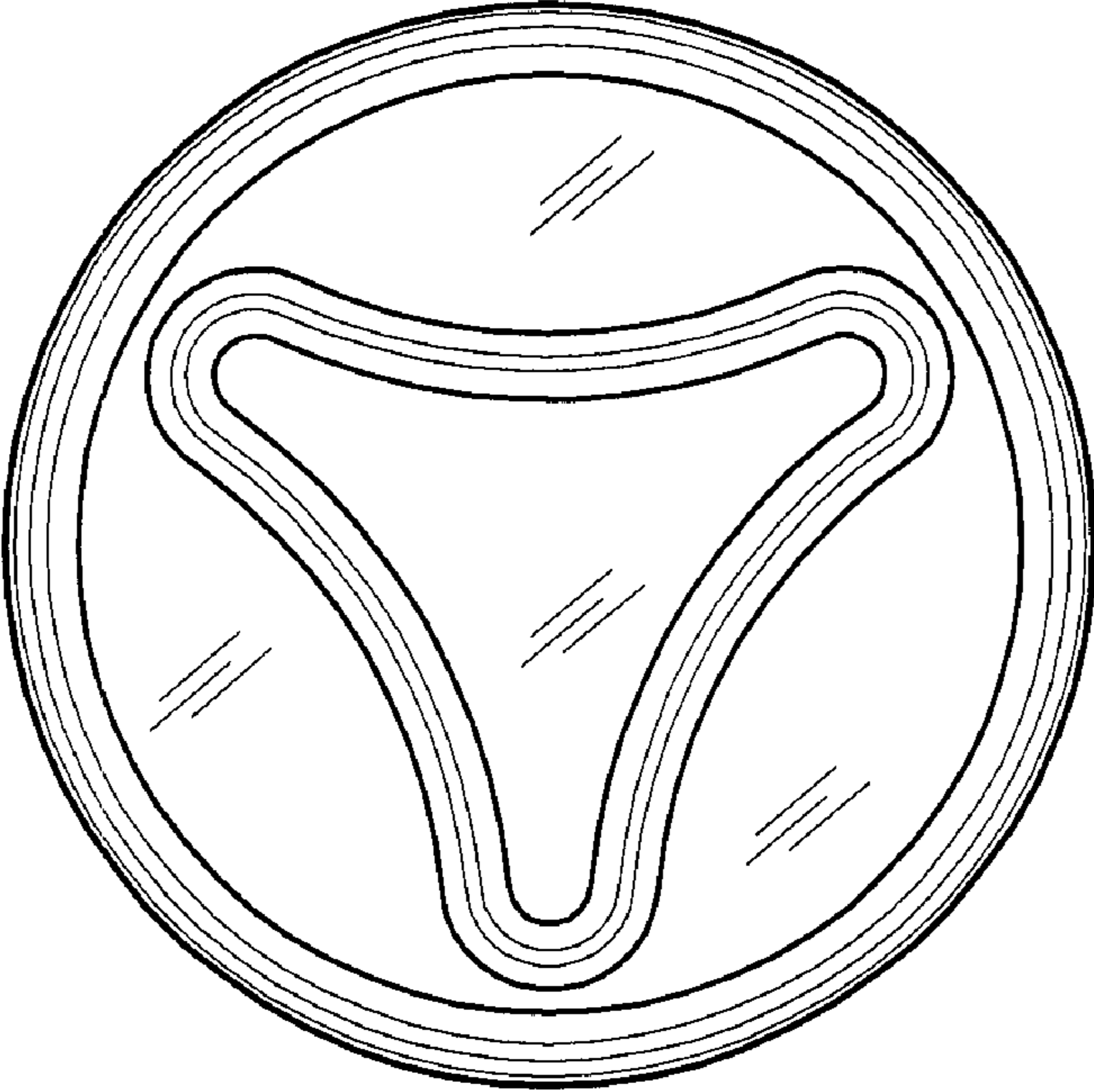

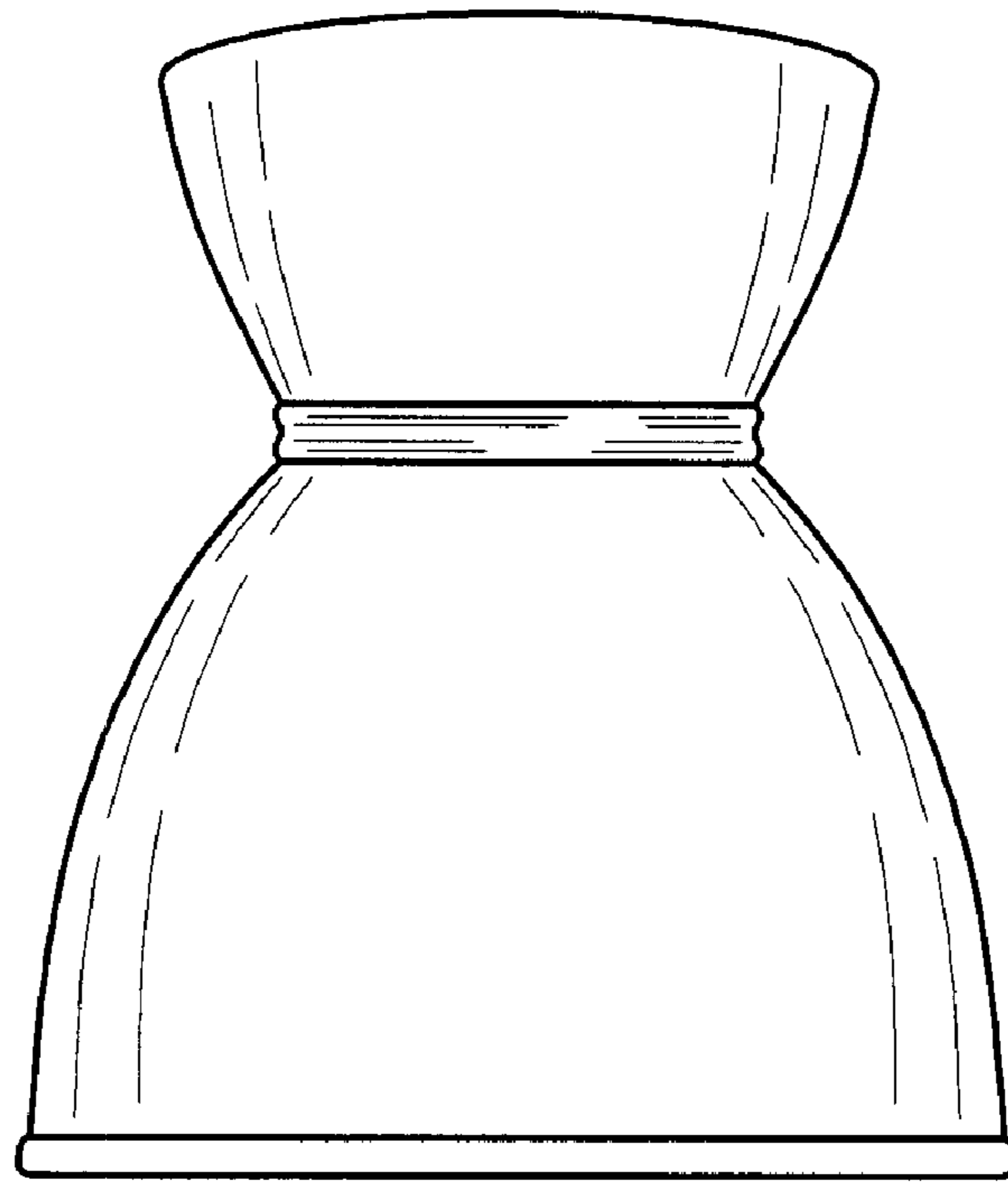

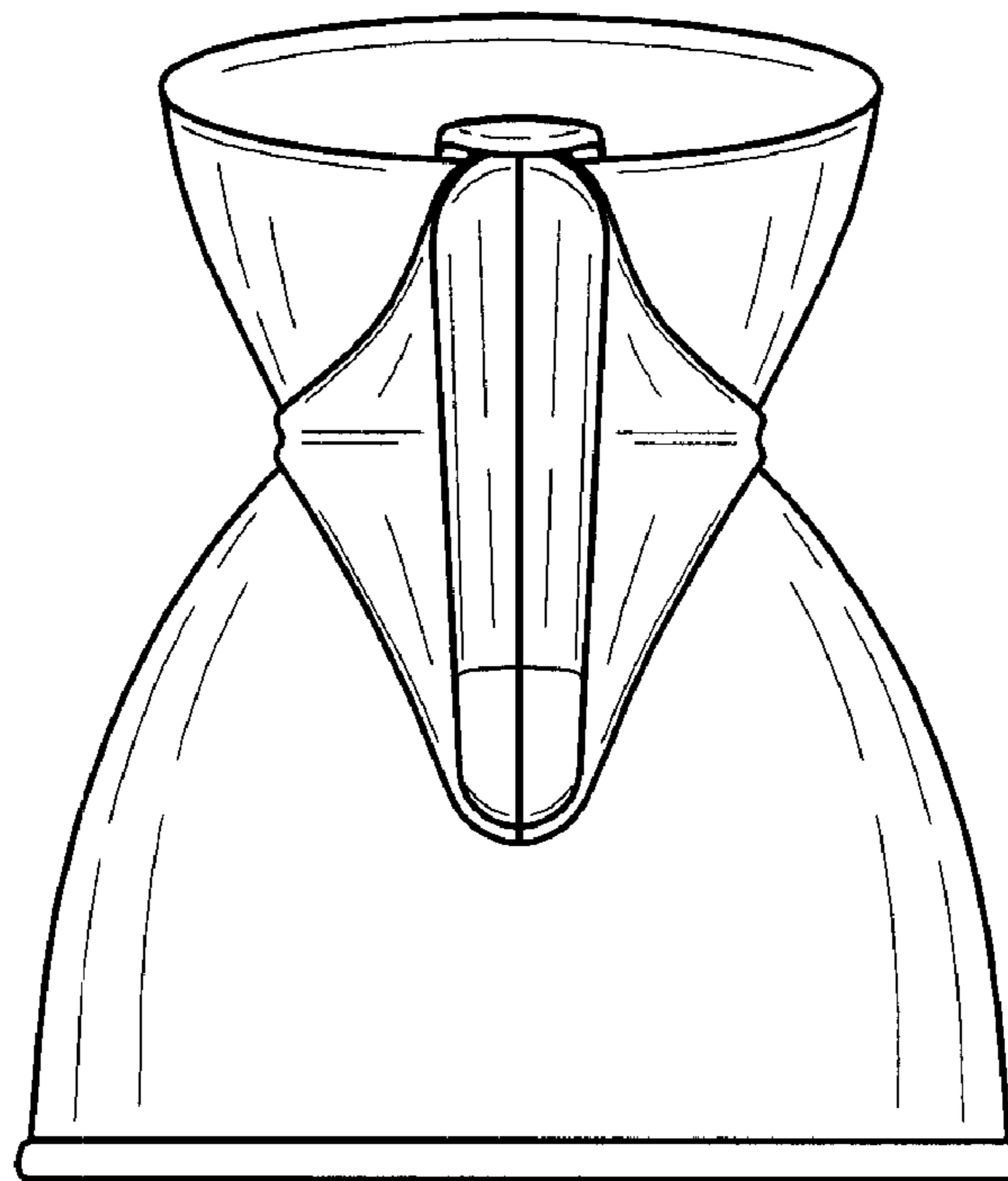

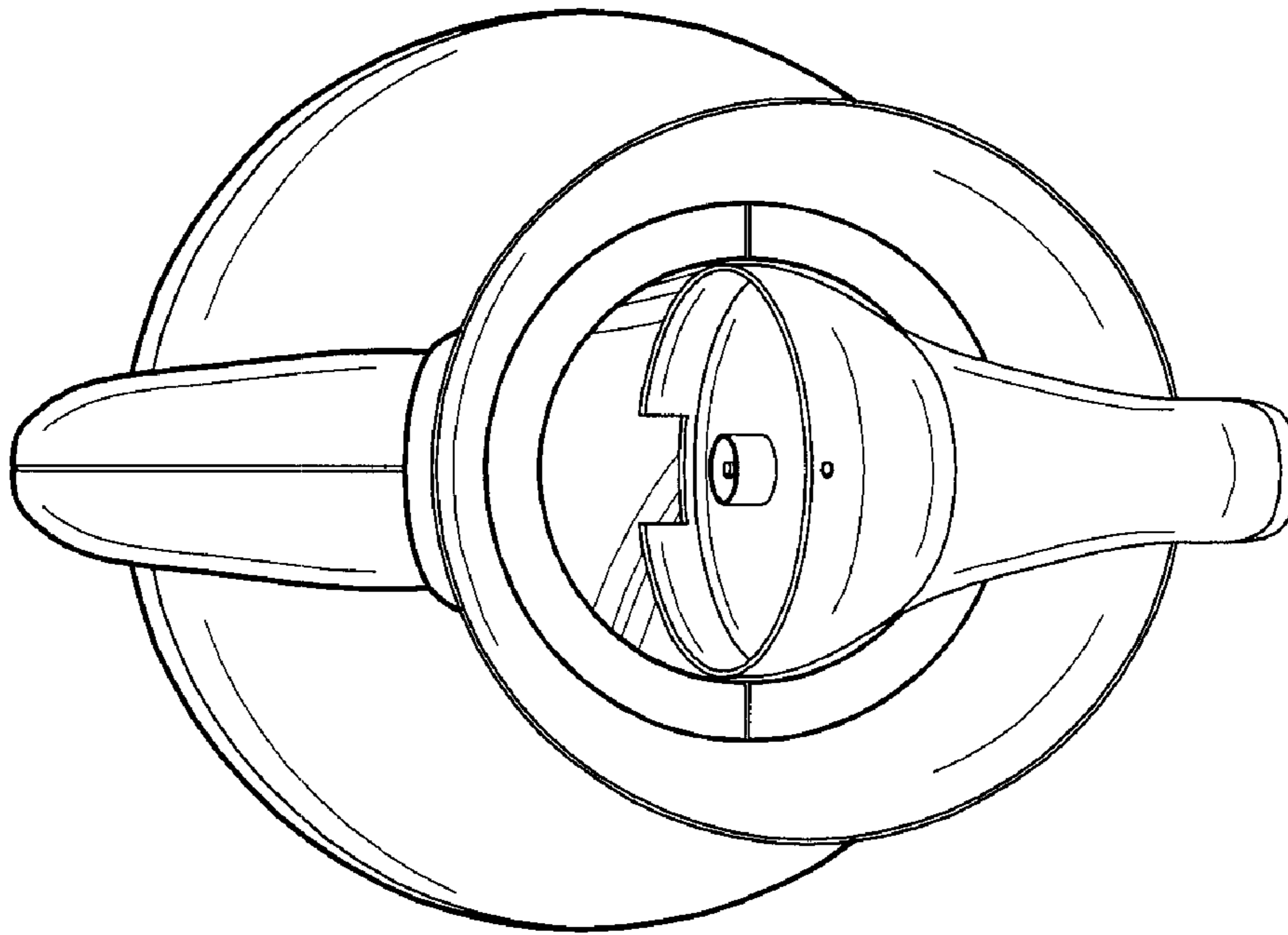

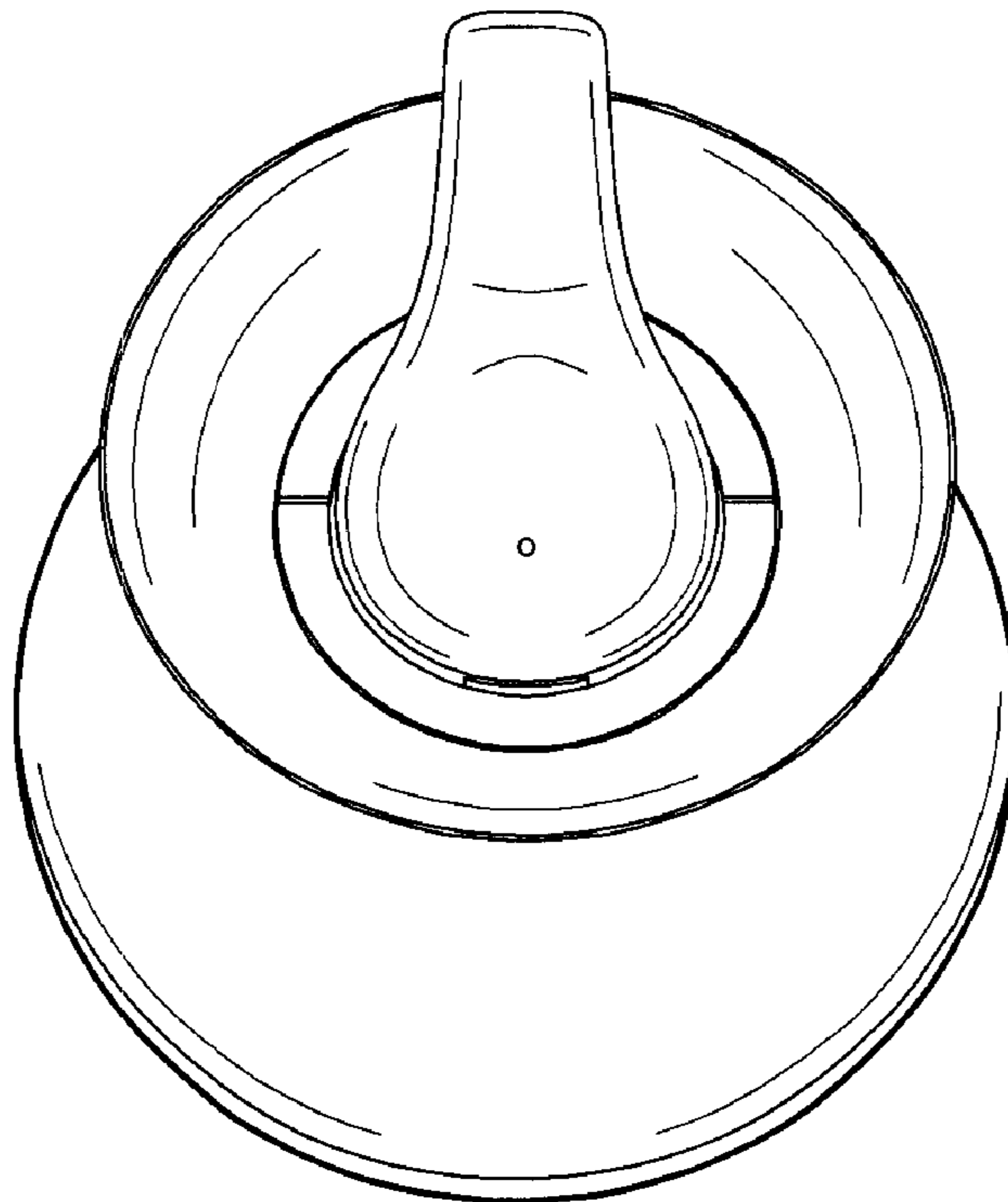
