(57) **CLAIM**

The ornamental design for a screwdriver with a rotatable end cap, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a screwdriver with a rotatable end cap showing my new design.

FIG. 2 is a perspective view of the same screwdriver showing an opening in the end cap.

FIG. 3 is a front-side view of the screwdriver.

FIG. 4 is a right-side view of the screwdriver, i.e., rotated axially 90° to the left relative to FIG. 3.

FIG. 5 is a left-side view of the screwdriver, i.e., rotated axially 90° to the right relative to FIG. 3.

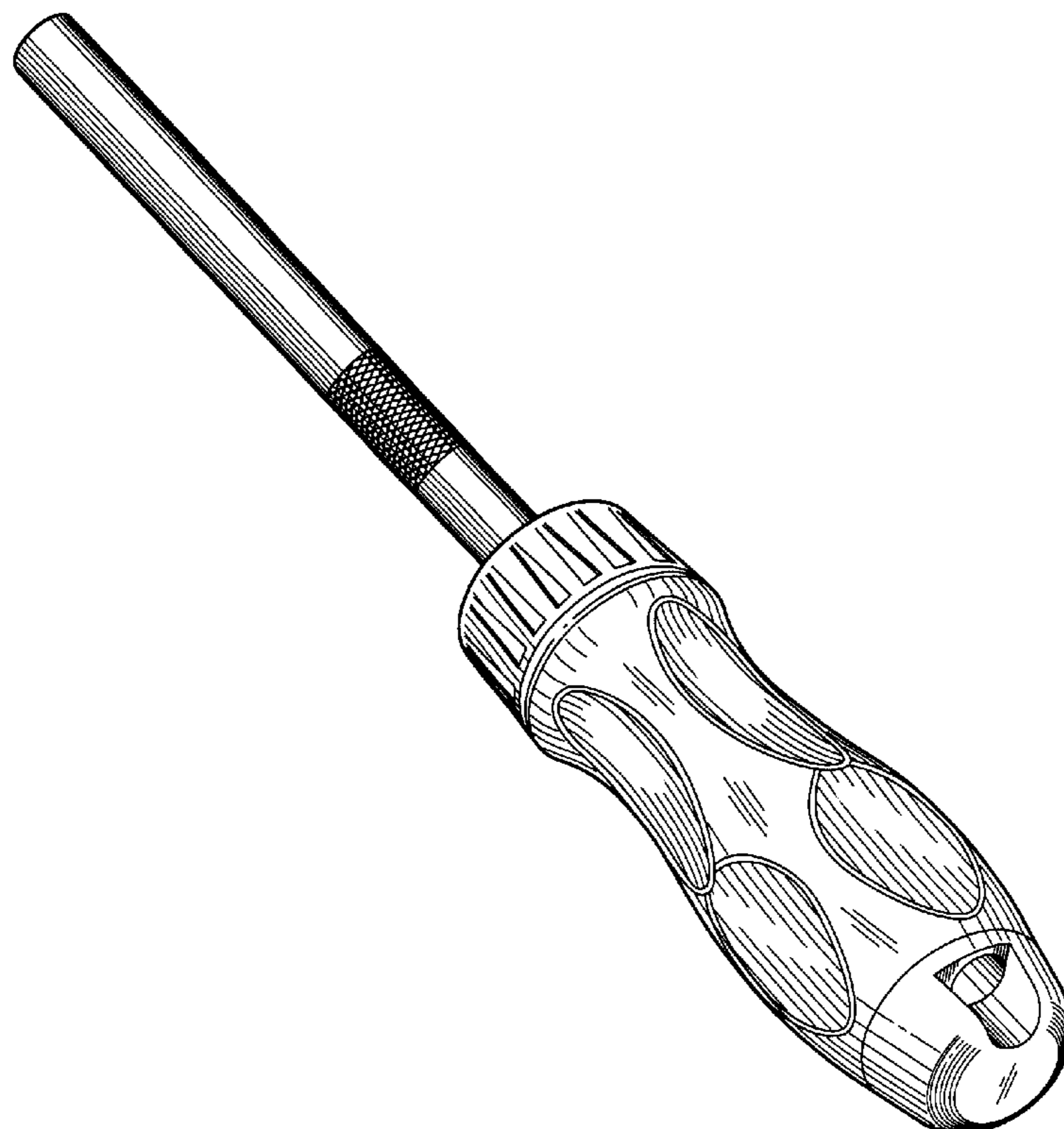
FIG. 6 is a rear-side view of the screwdriver, i.e., rotated axially 180° relative to FIG. 3.

FIG. 7 is a top-end view of the screwdriver; and,

FIG. 8 is a bottom-end view of the screwdriver along the axis formed by the shaft.

The broken line showing of the bit is for illustrative purposes only and forms no part of the claimed design.

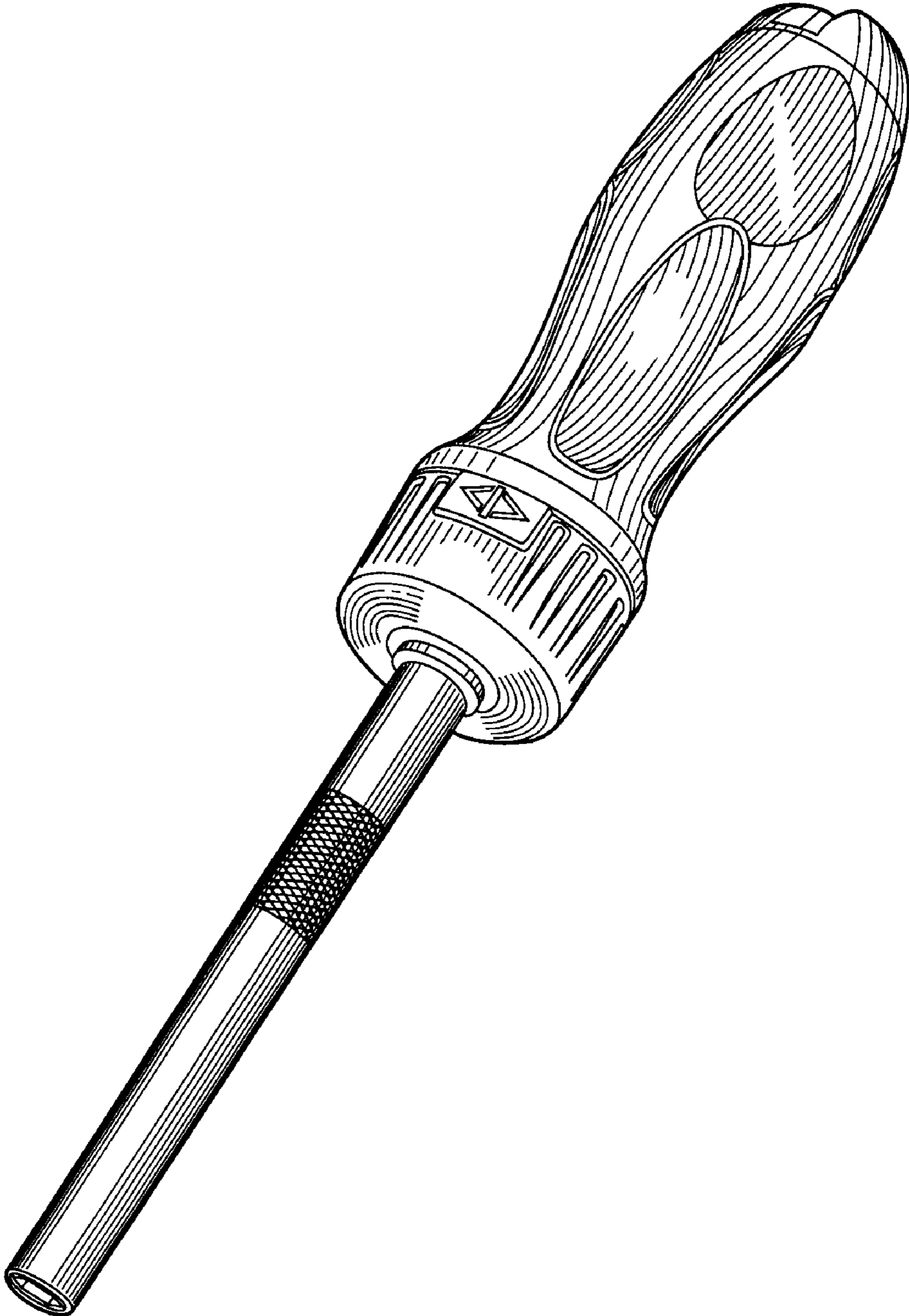

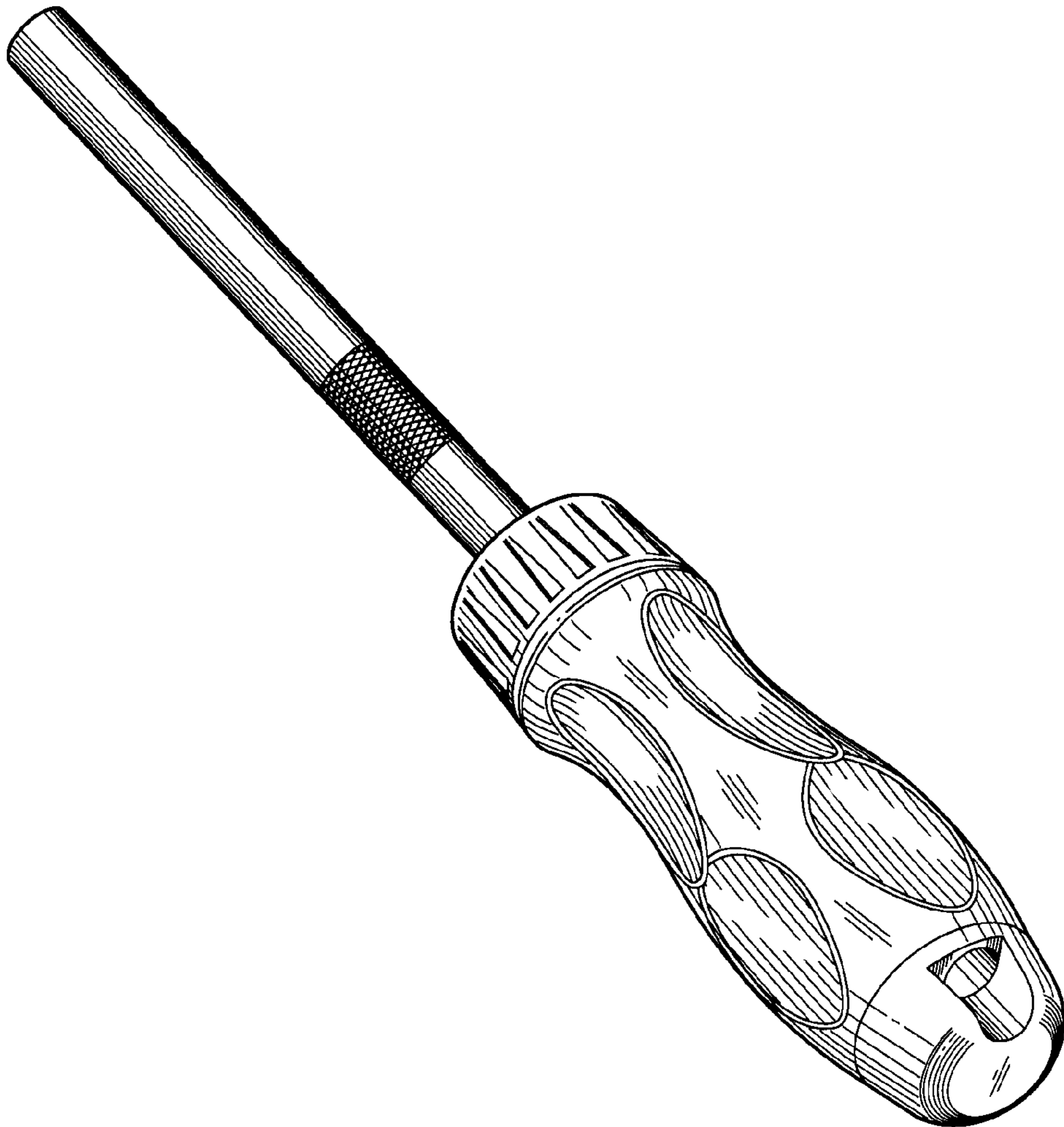

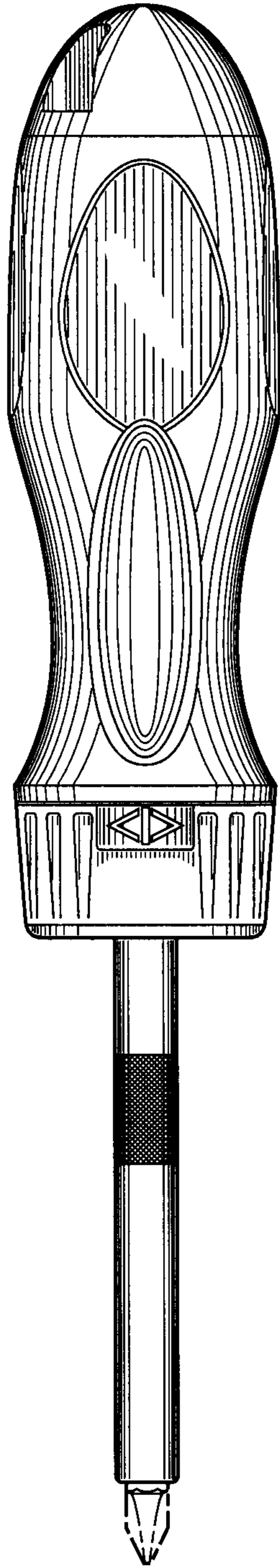

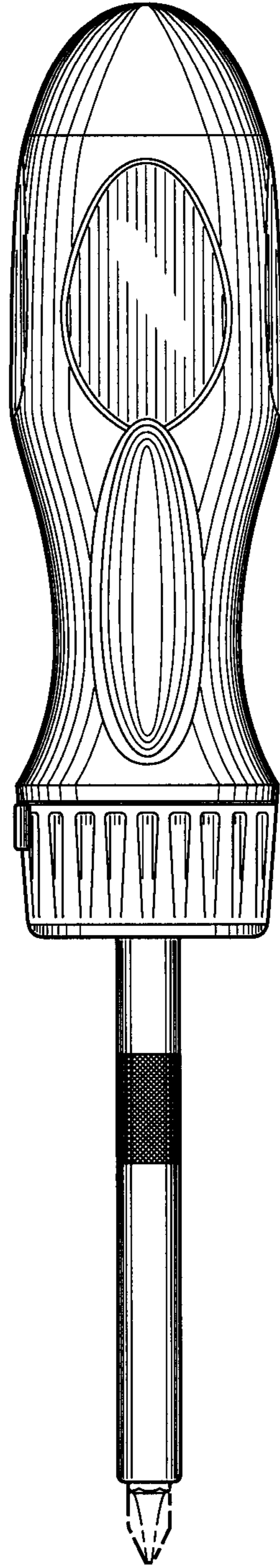

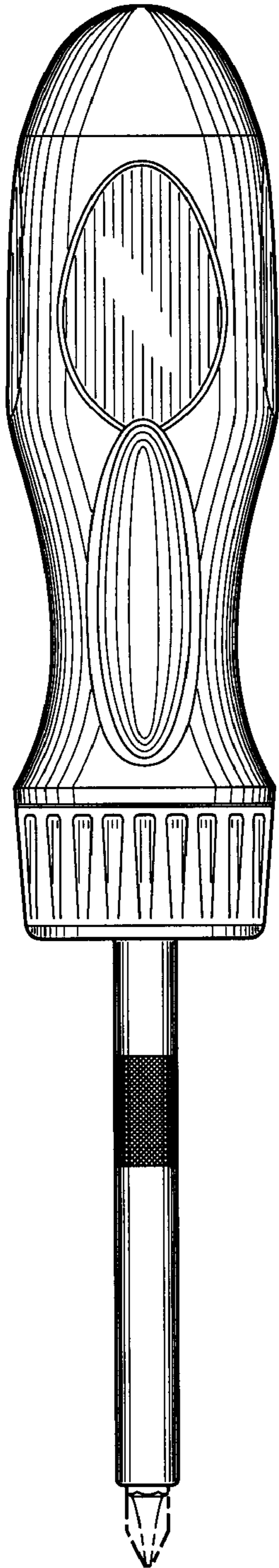

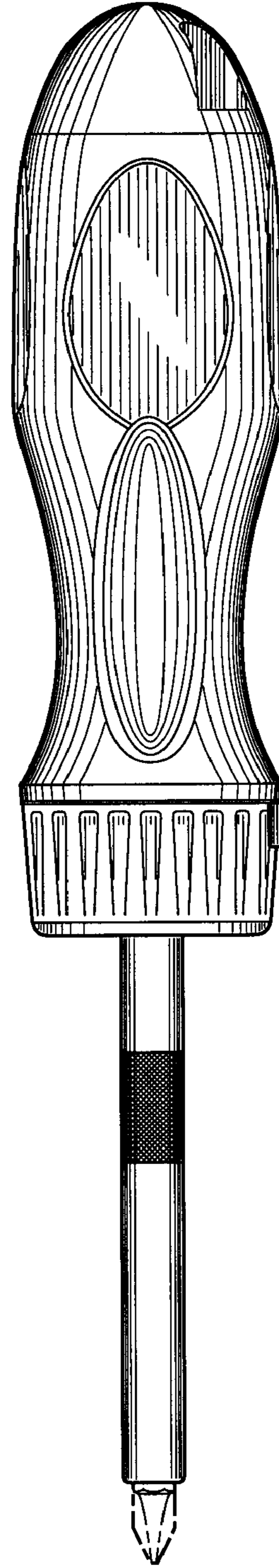

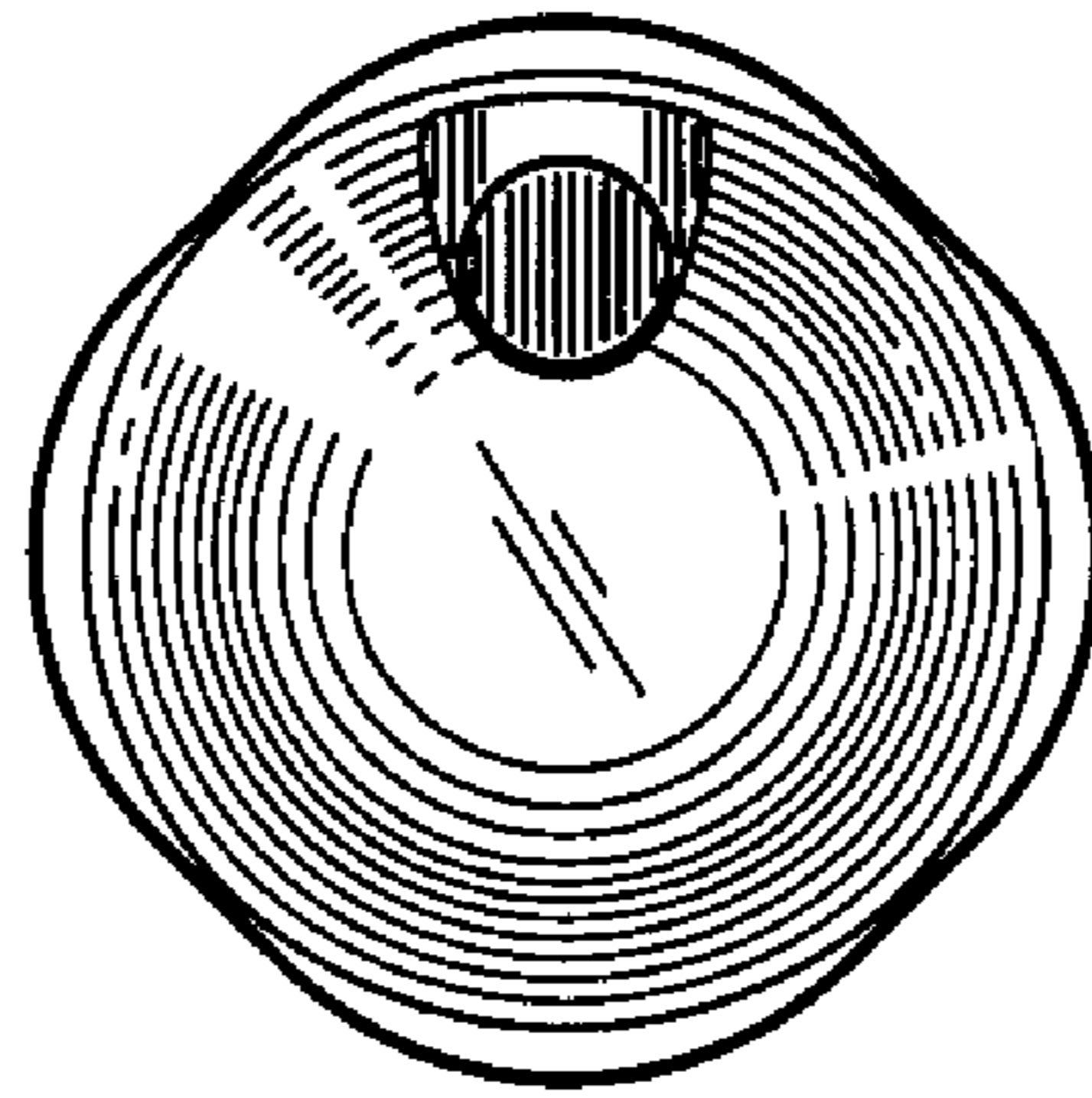

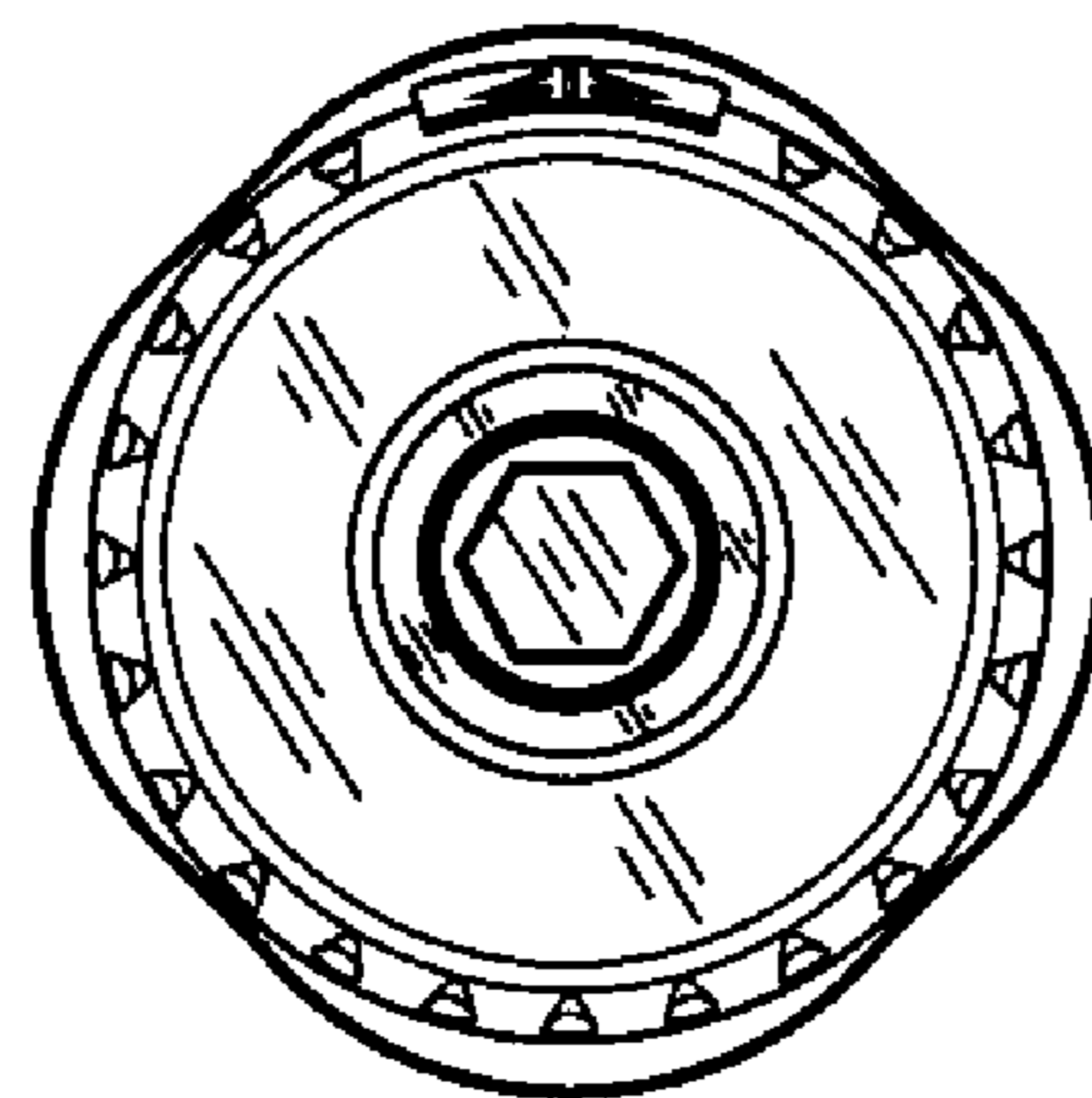
