FIG. 5 is a right end view thereof.

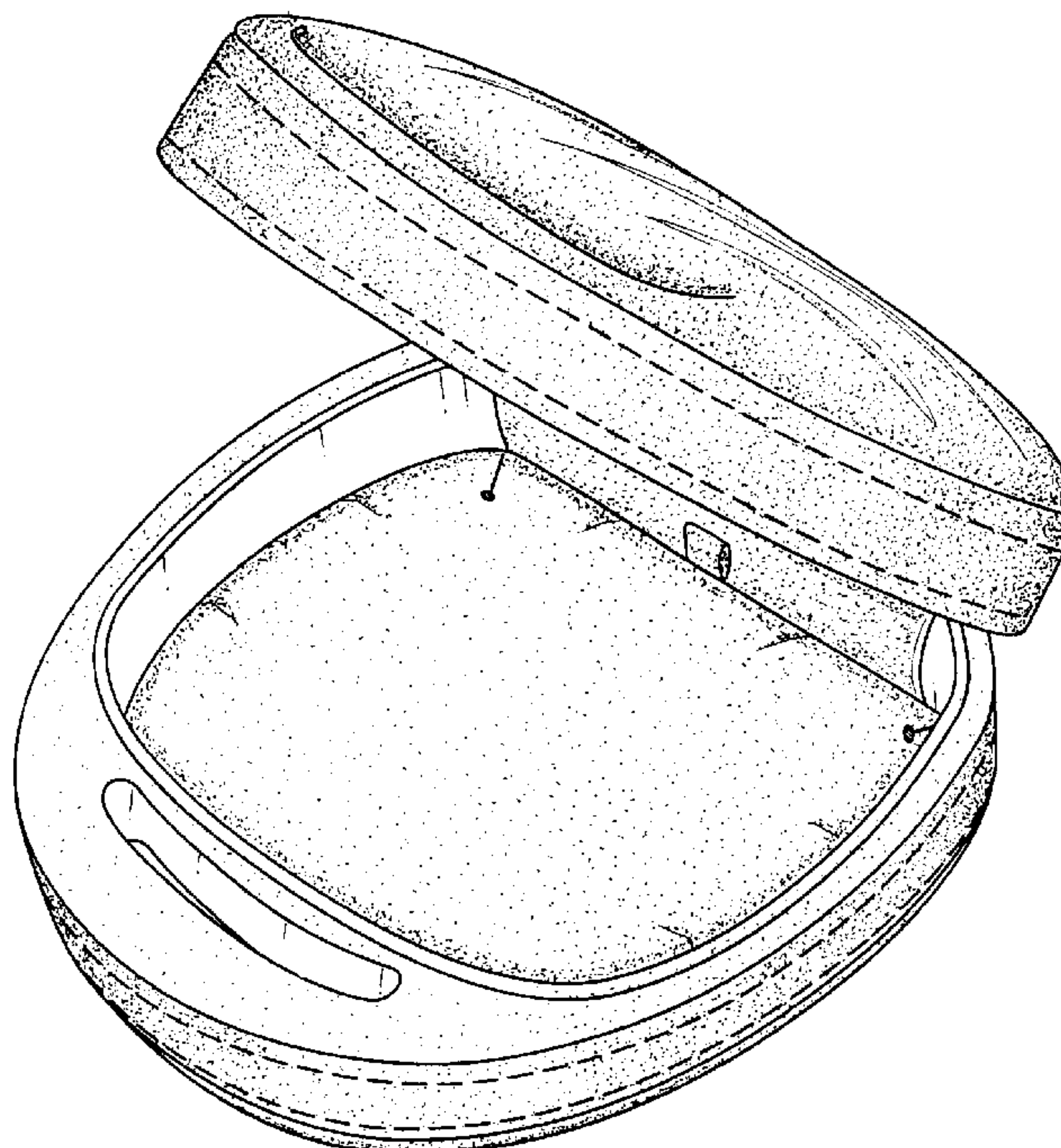
FIG. 6 is a top view thereof.

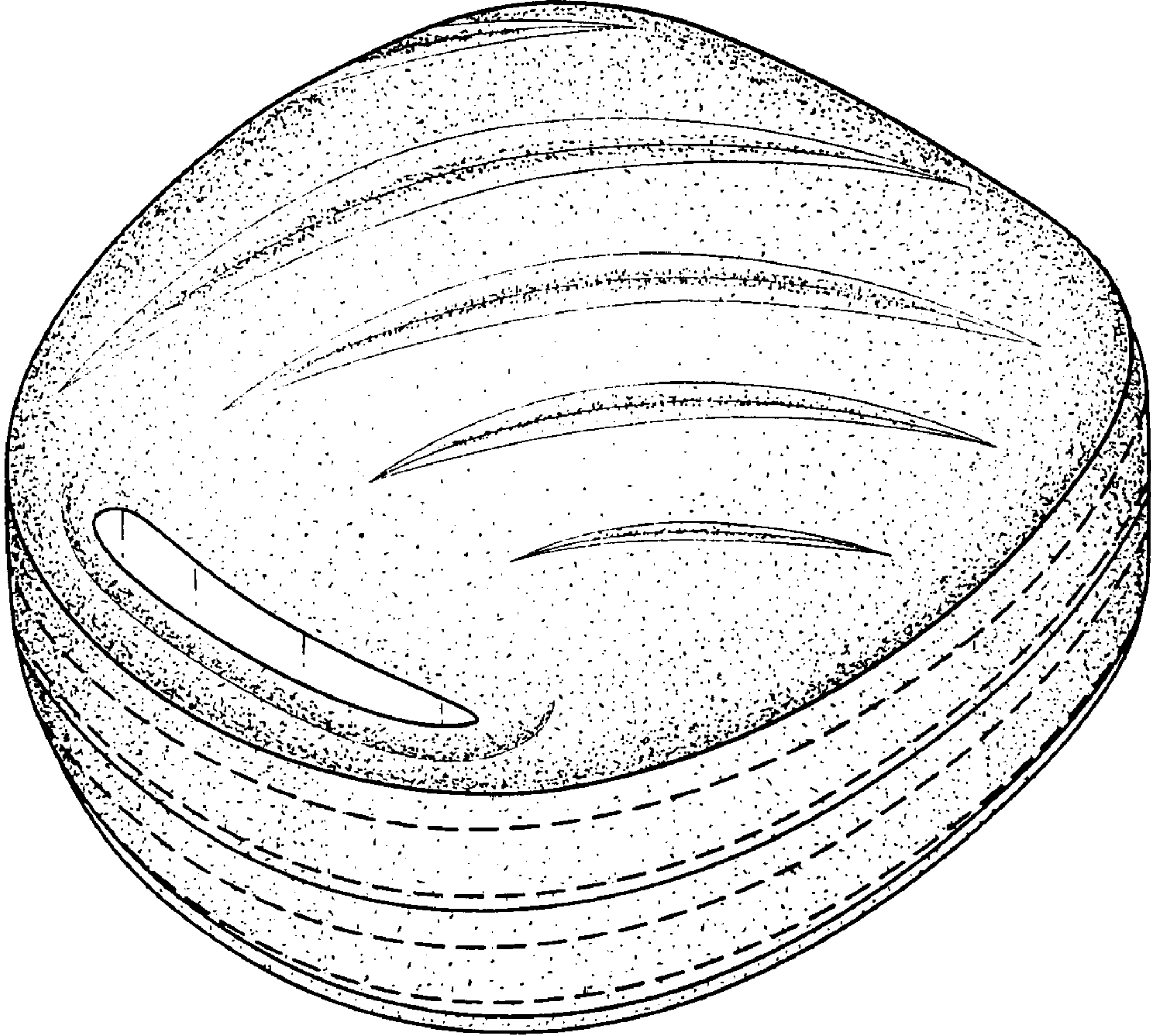

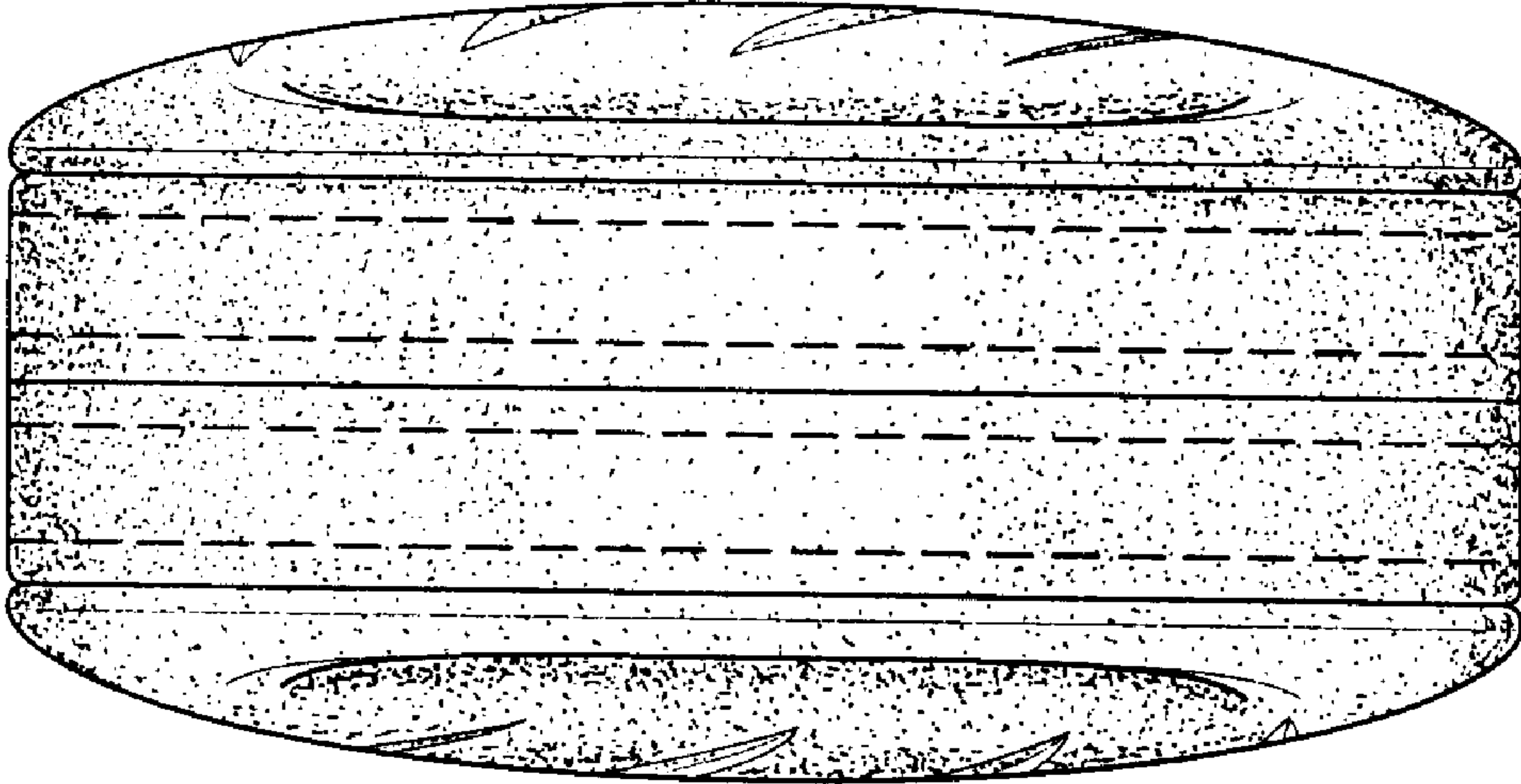

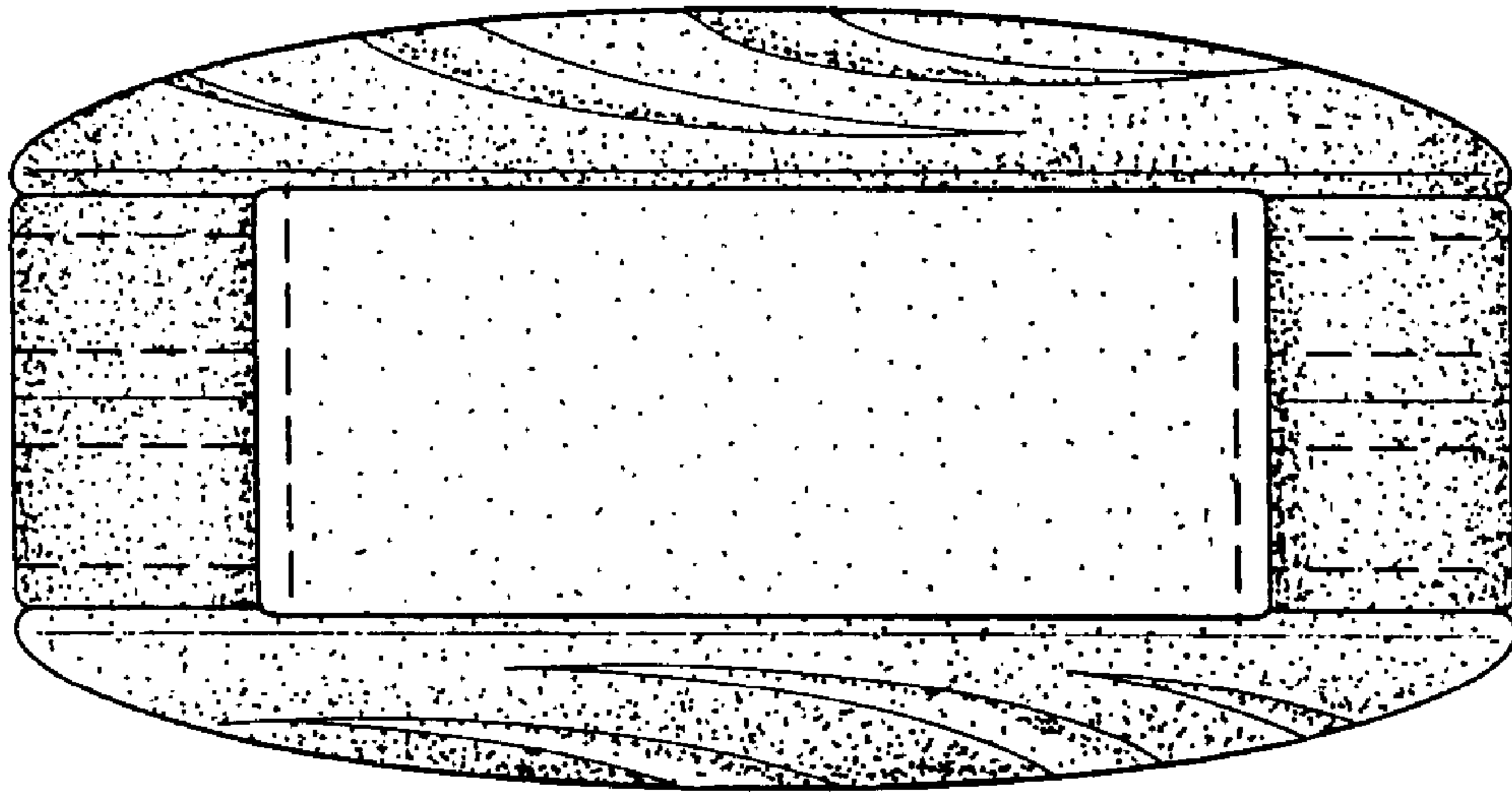

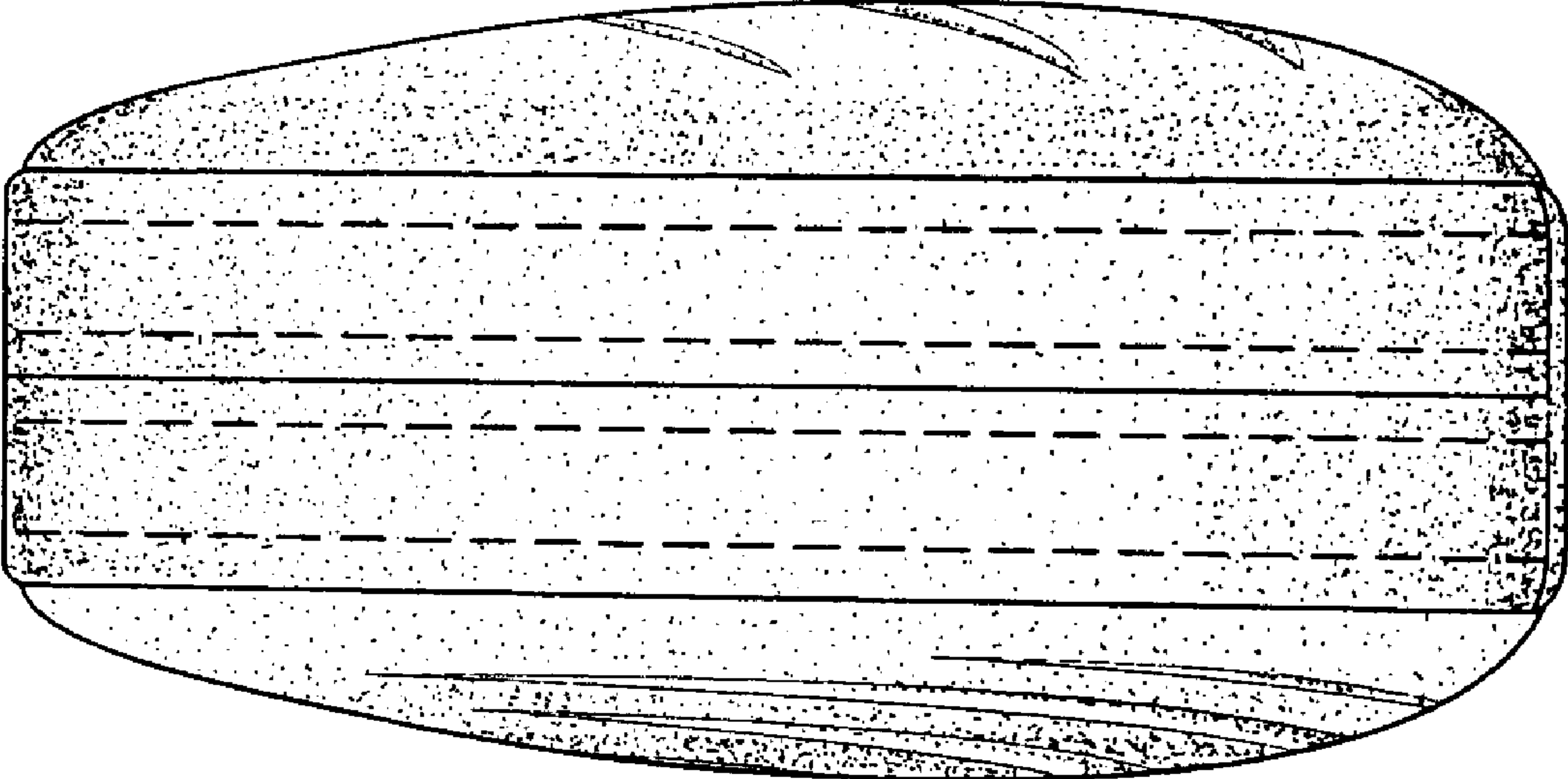

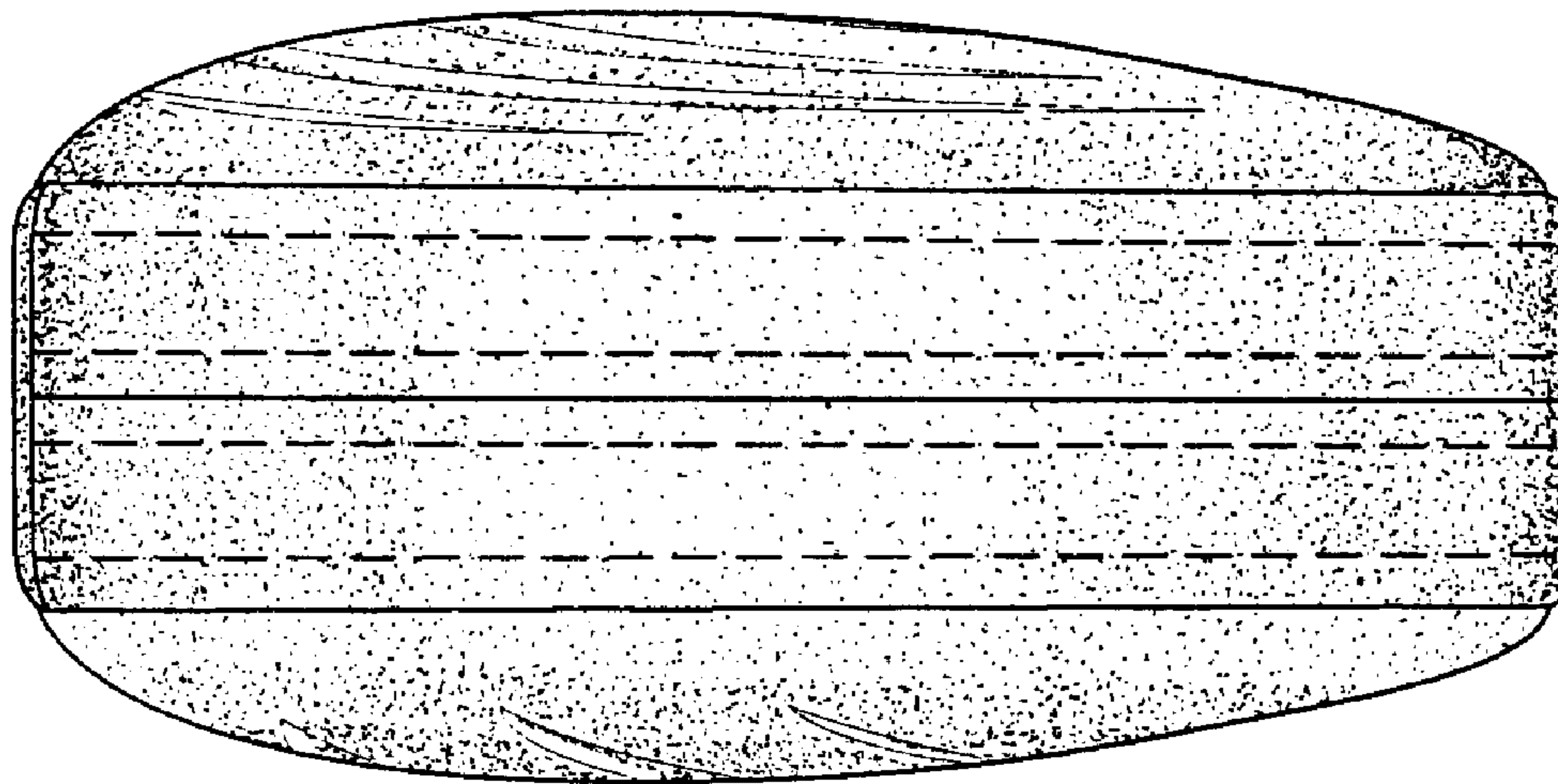

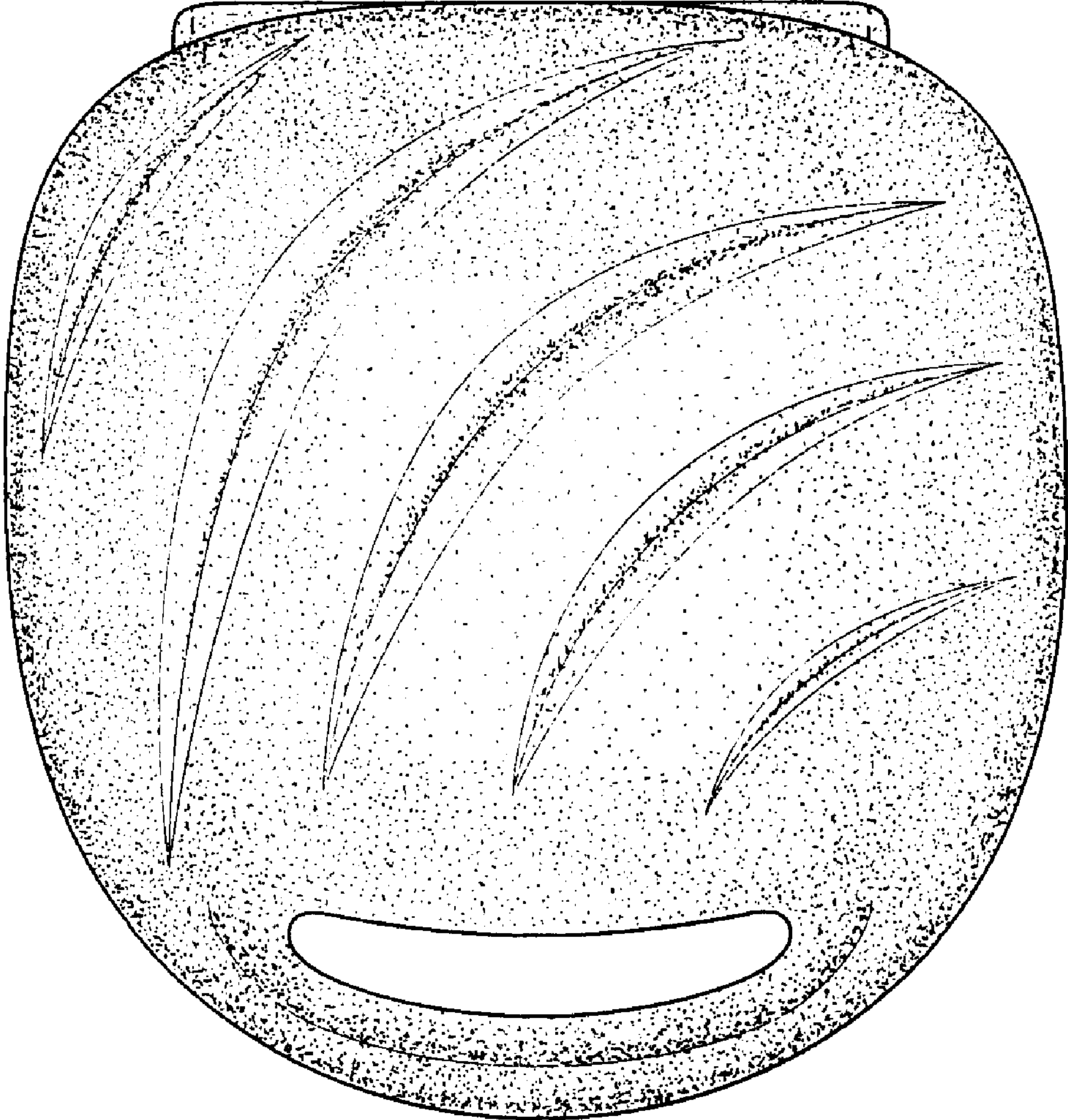

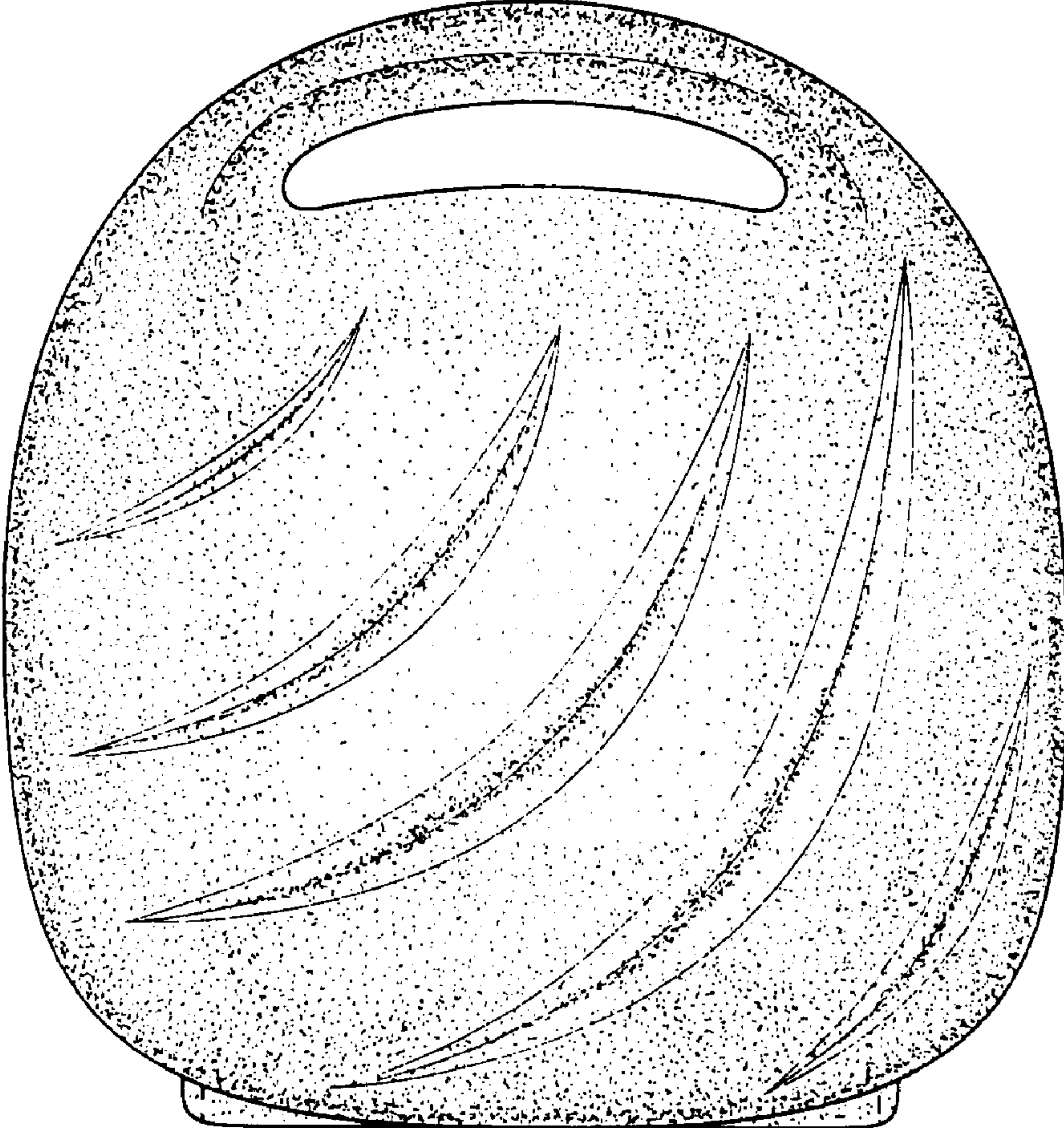

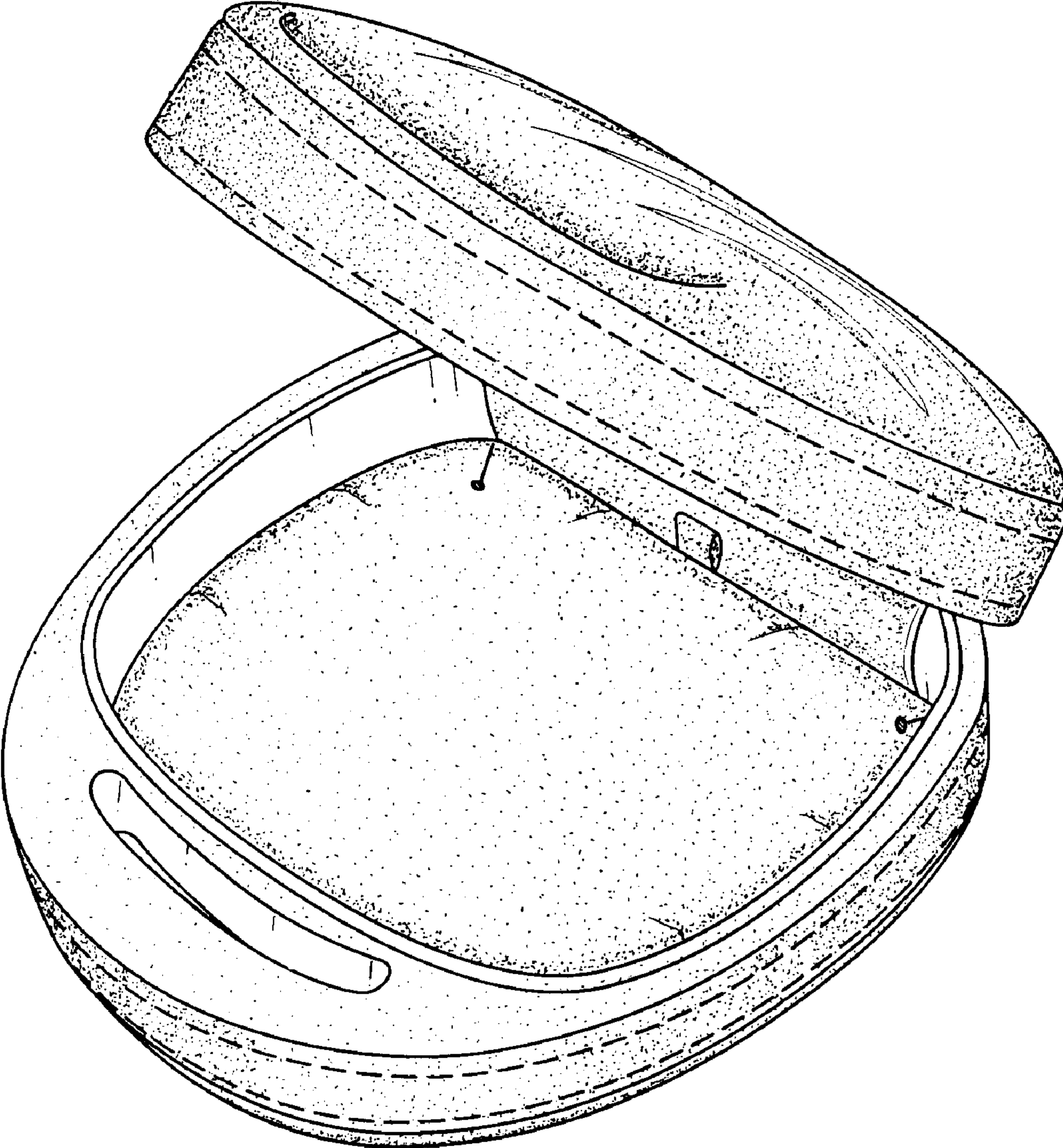
