FIG. 4 is a right side view of the container without cap;

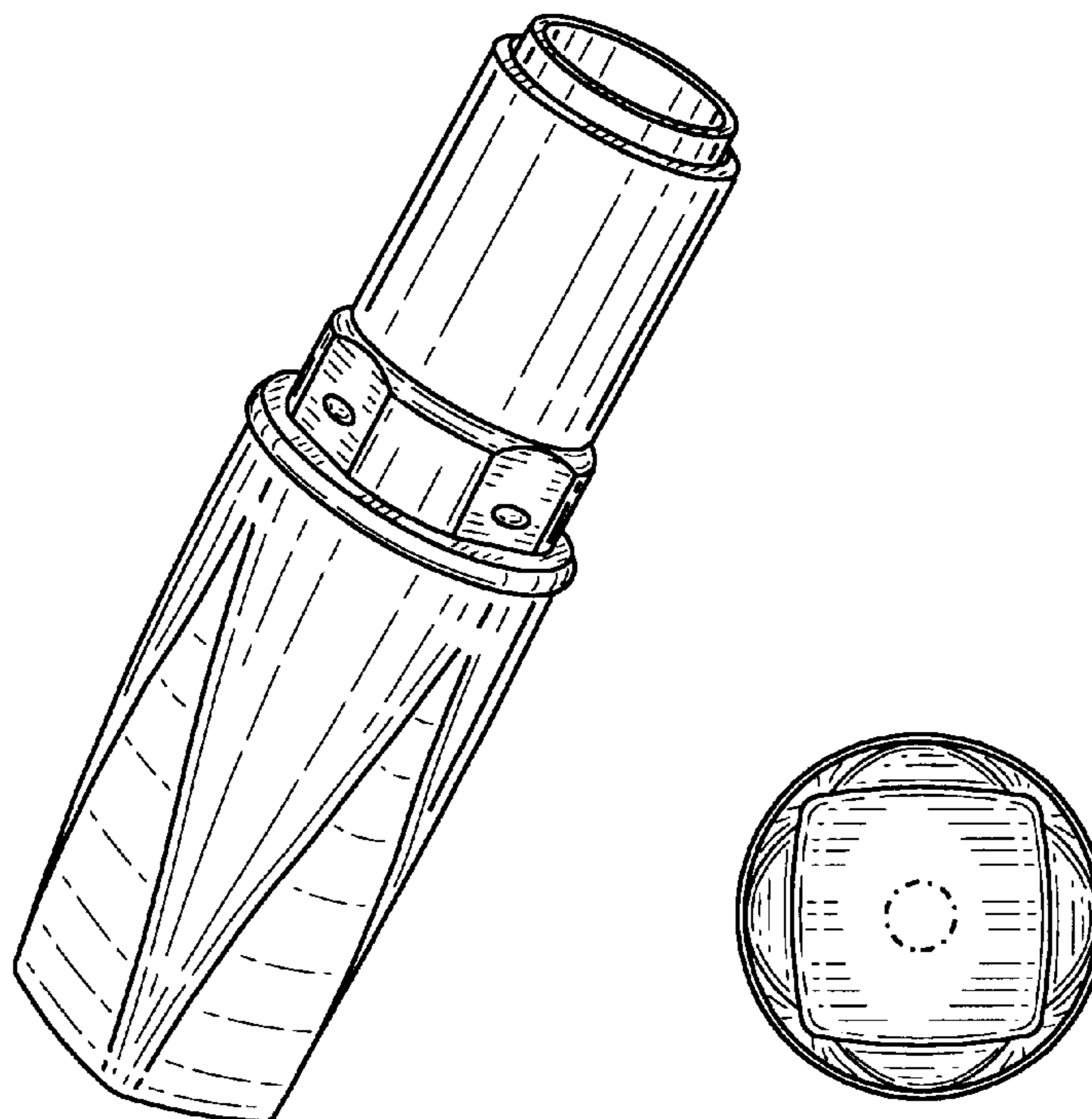
FIG. 5 is a left side view of the container without cap;

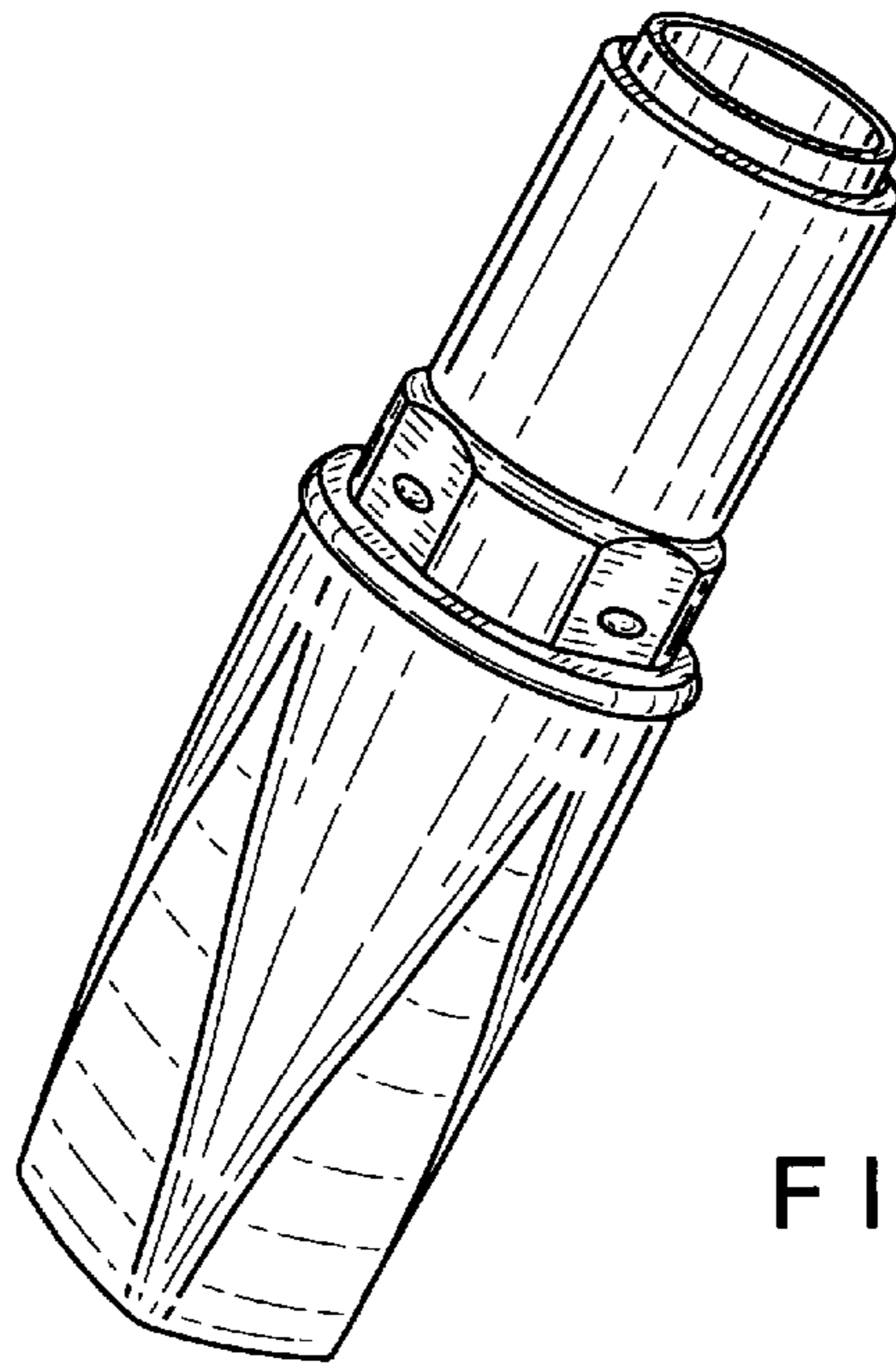

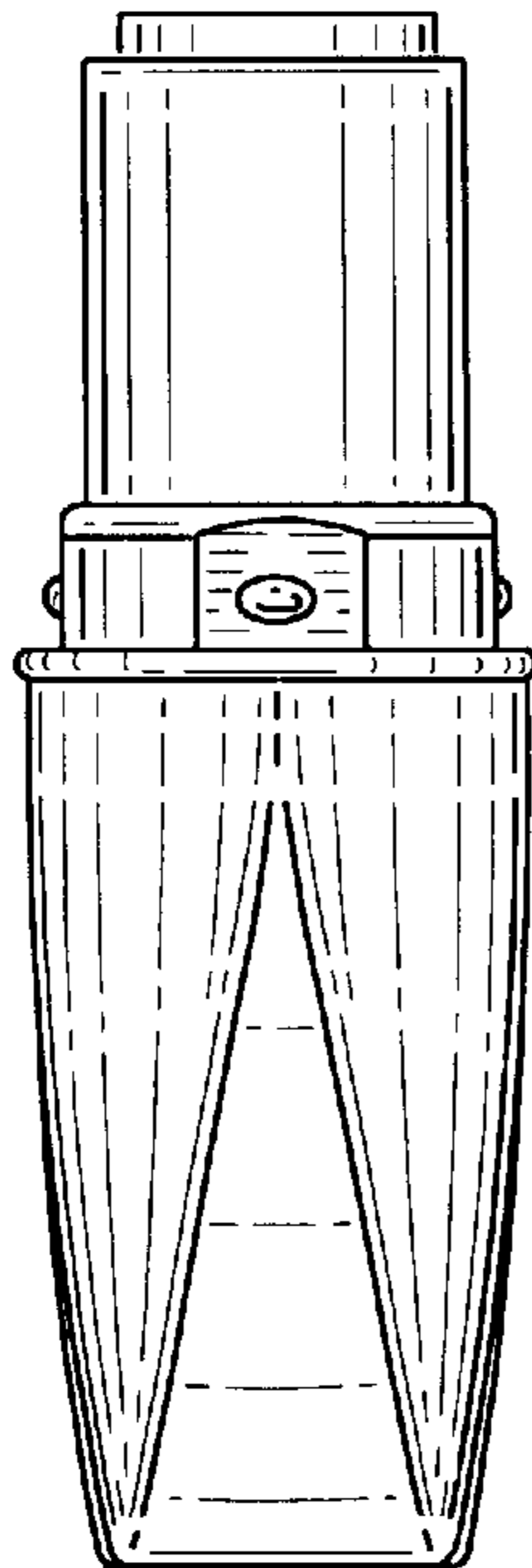

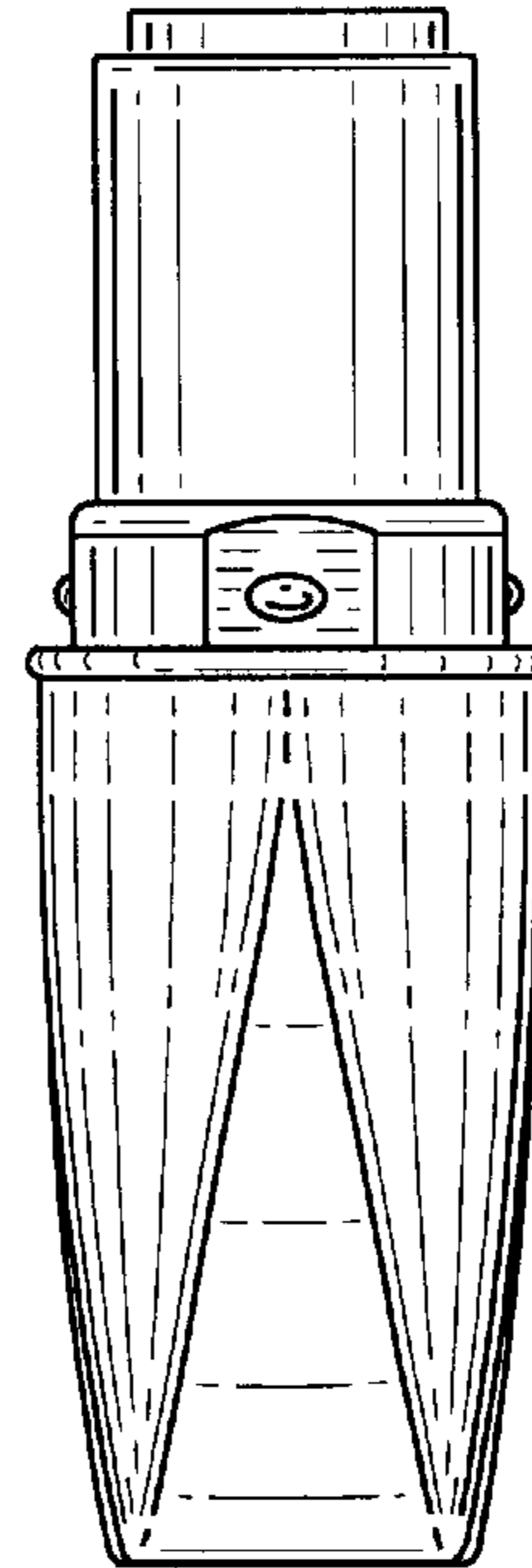

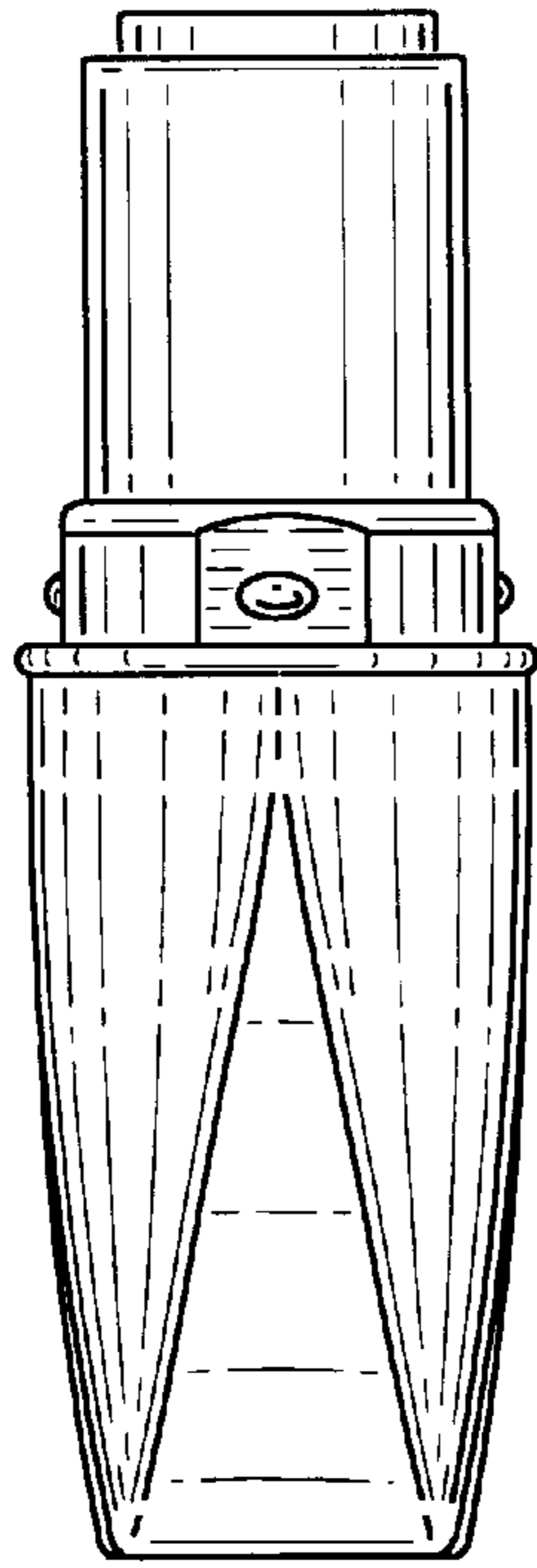

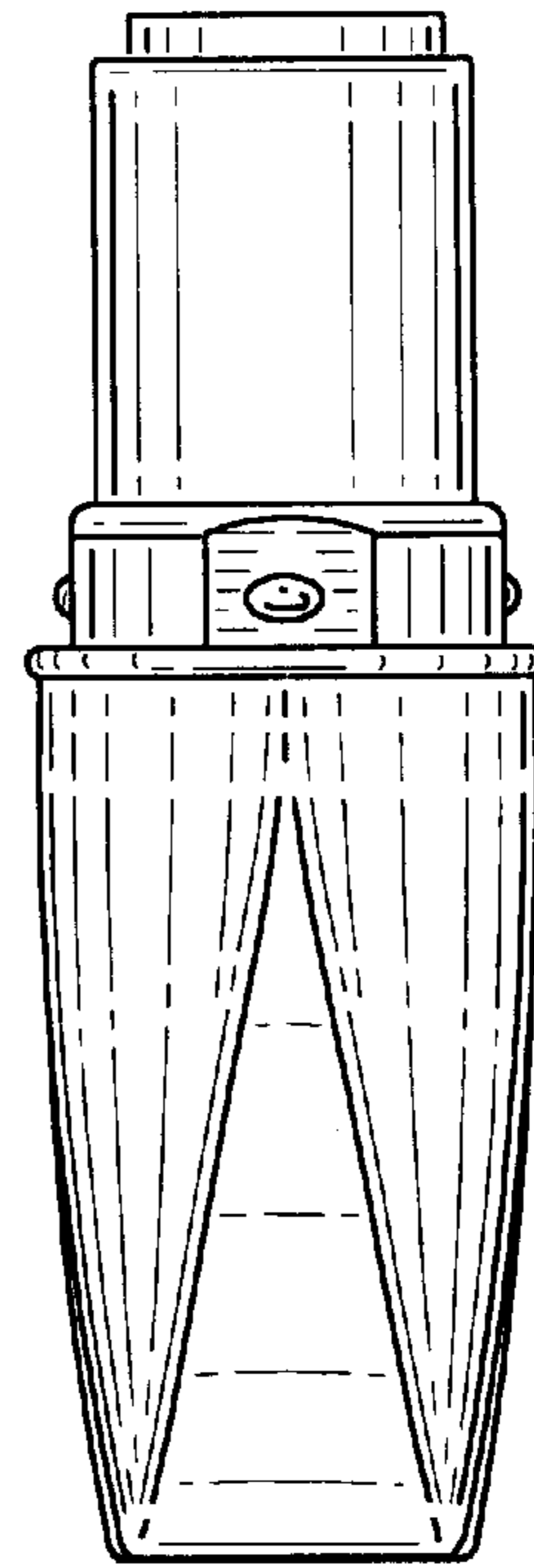

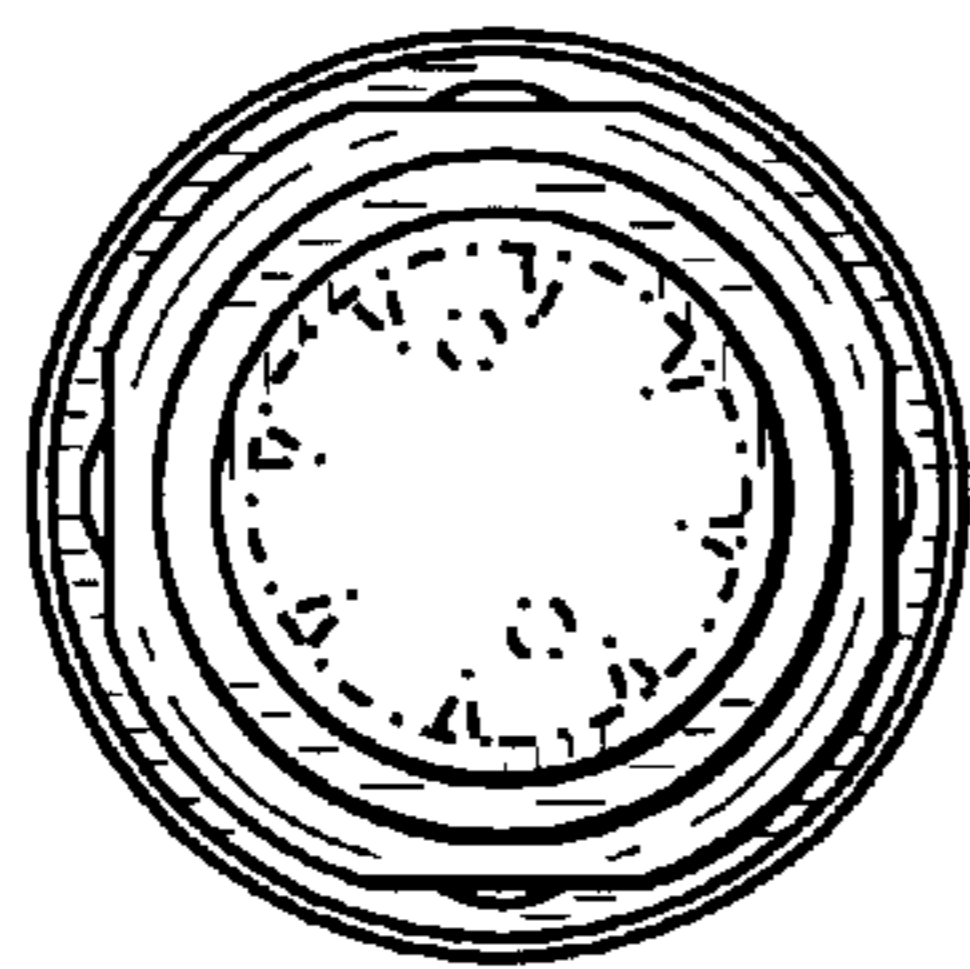

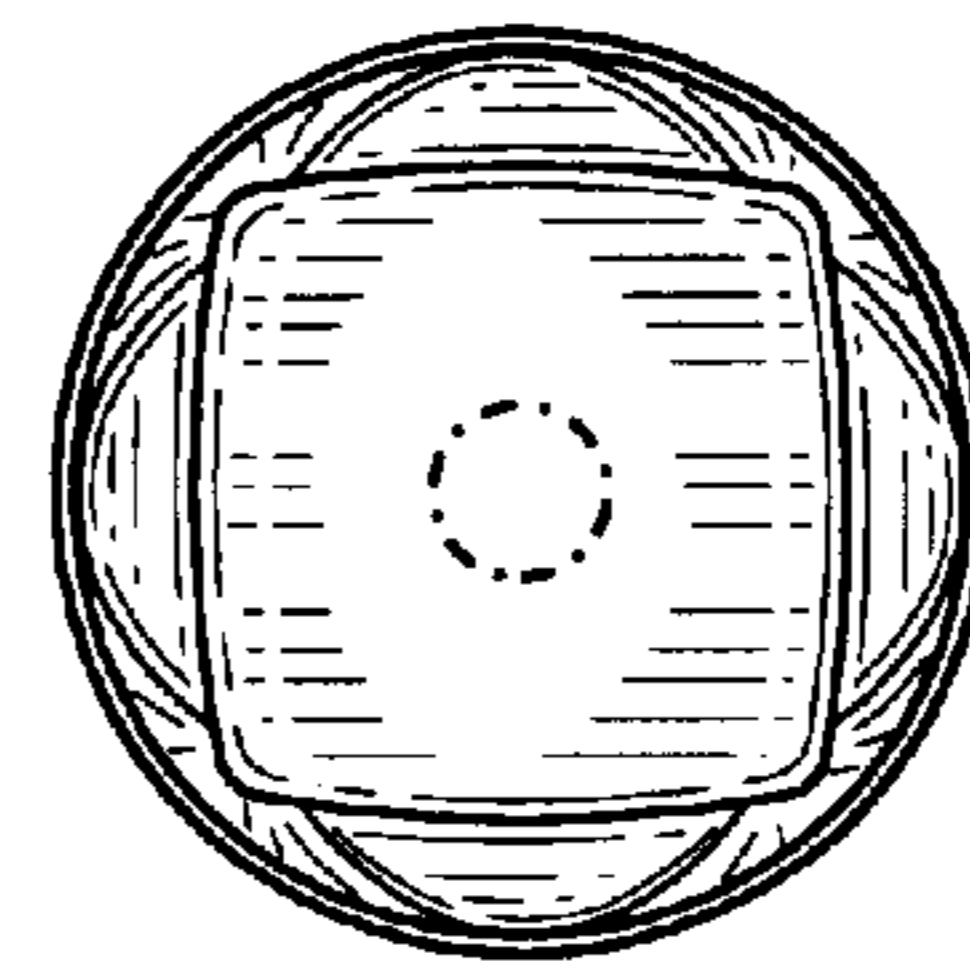
