The ornamental design for a shower timer, as shown and described.

DESCRIPTION

FIG. 1 is a left side elevational view of a shower timer, showing my new design, the right side being a mirror image thereof;

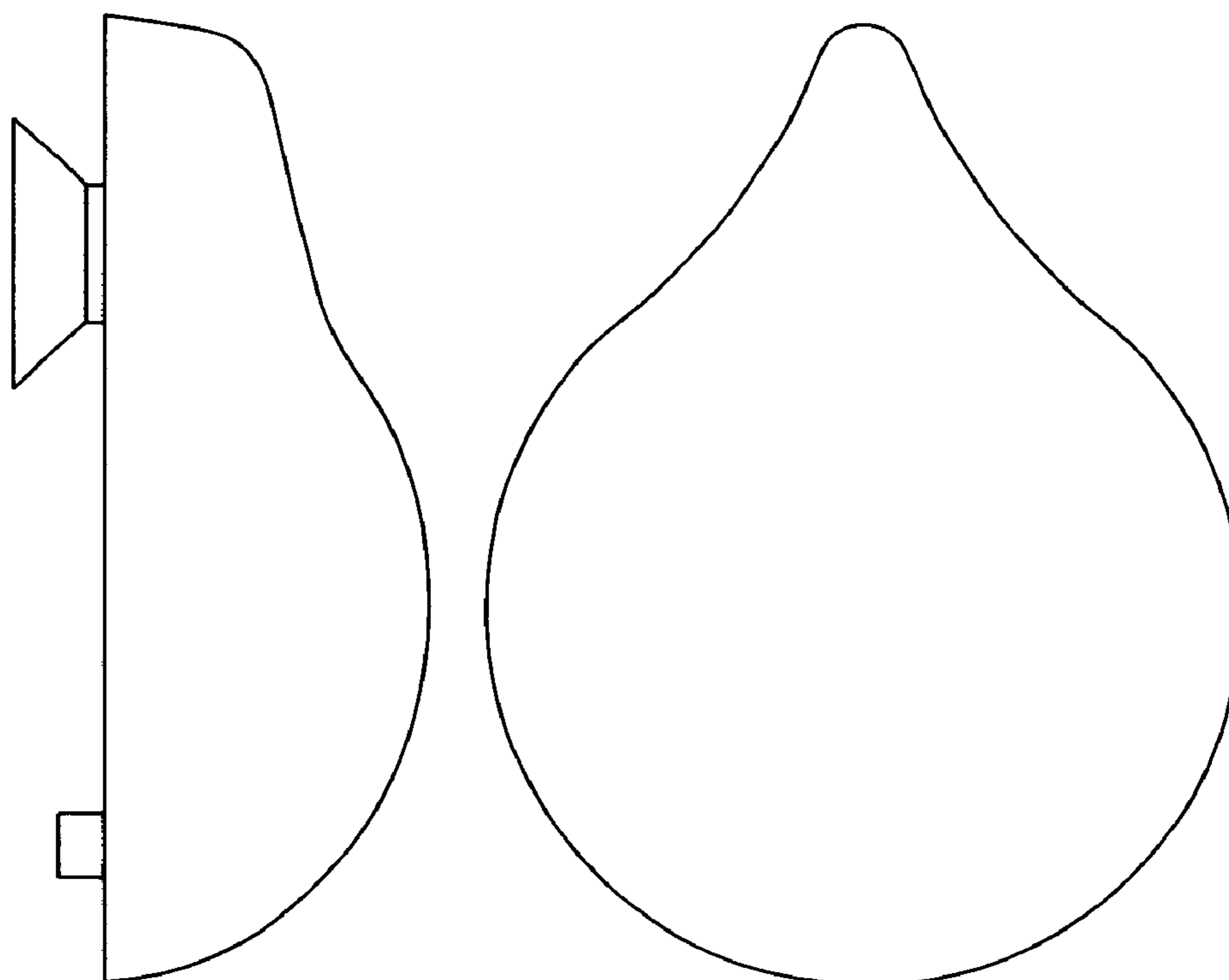

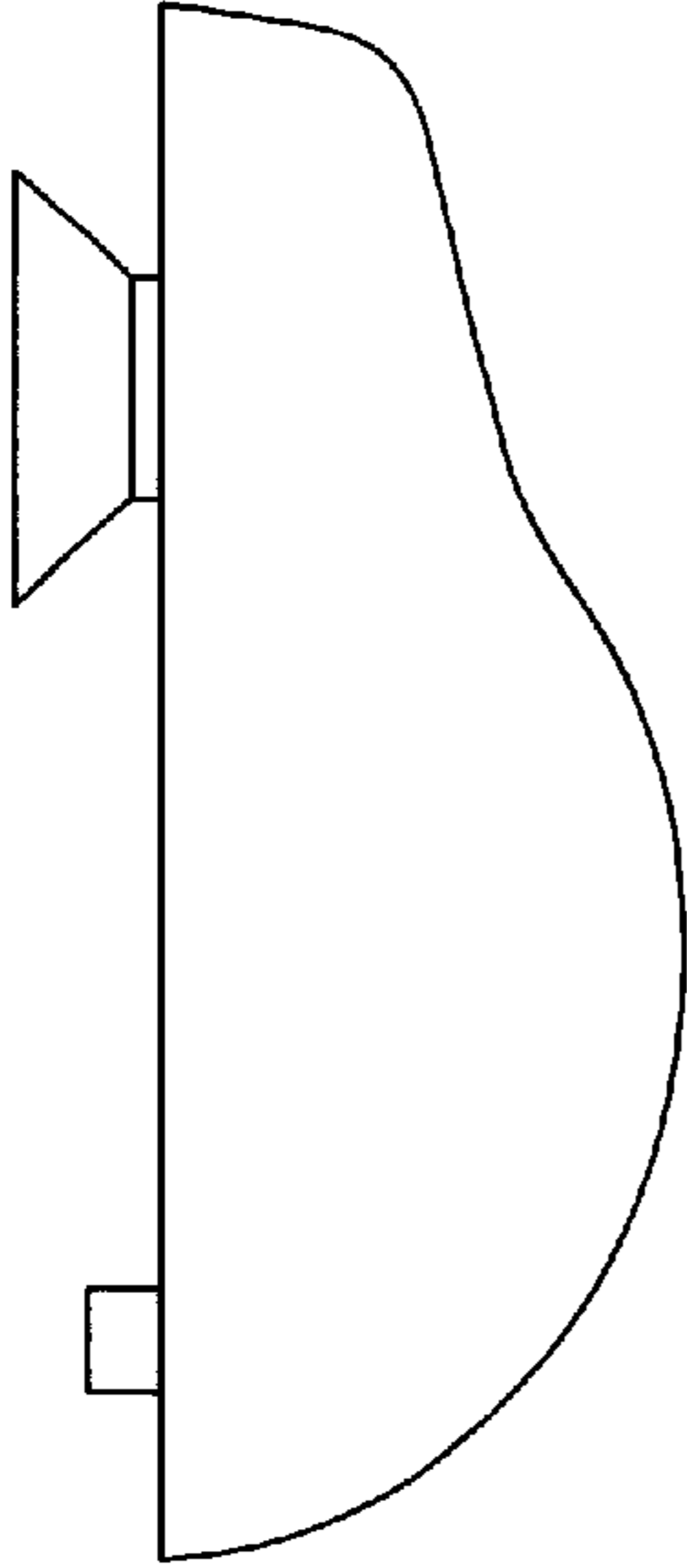

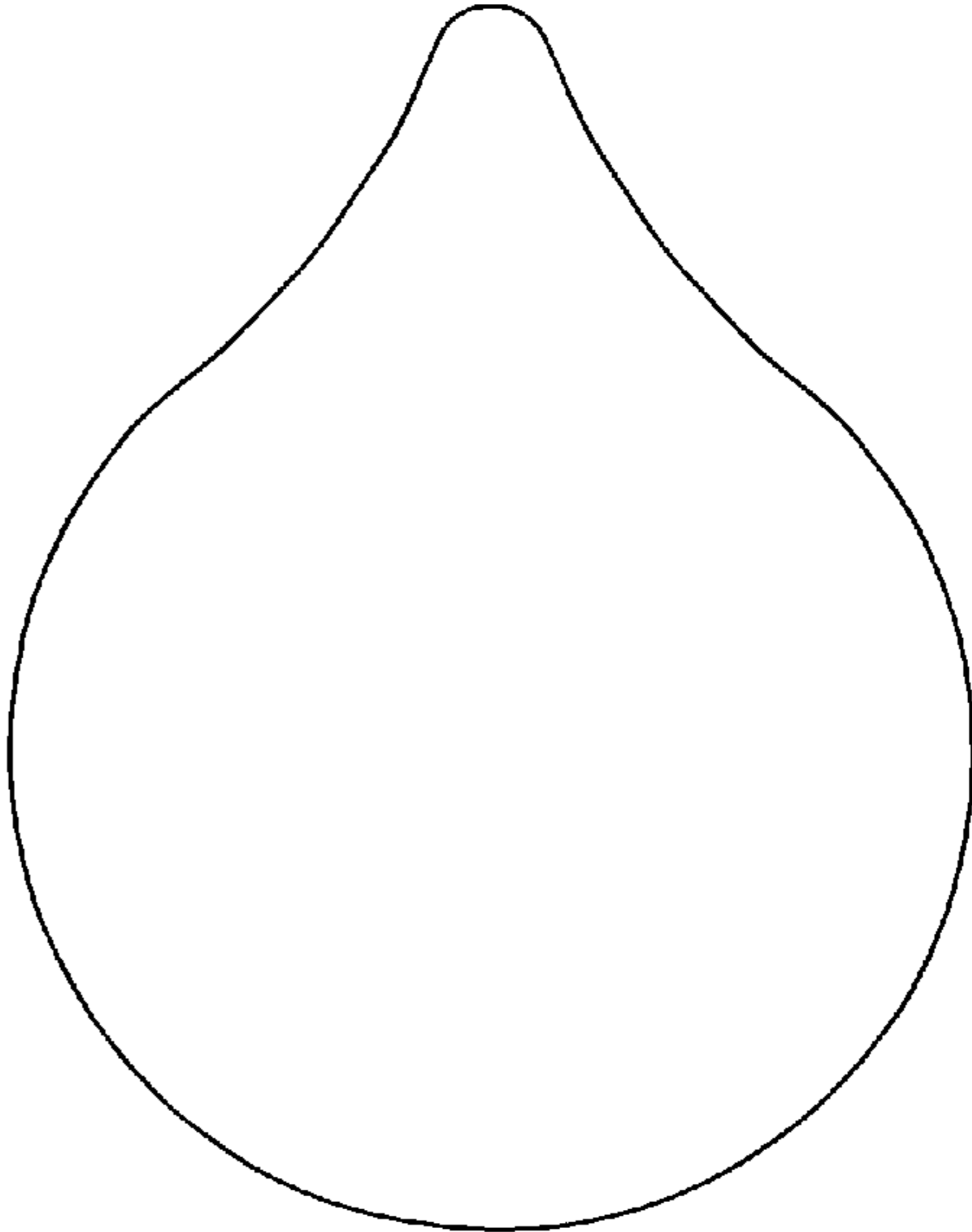

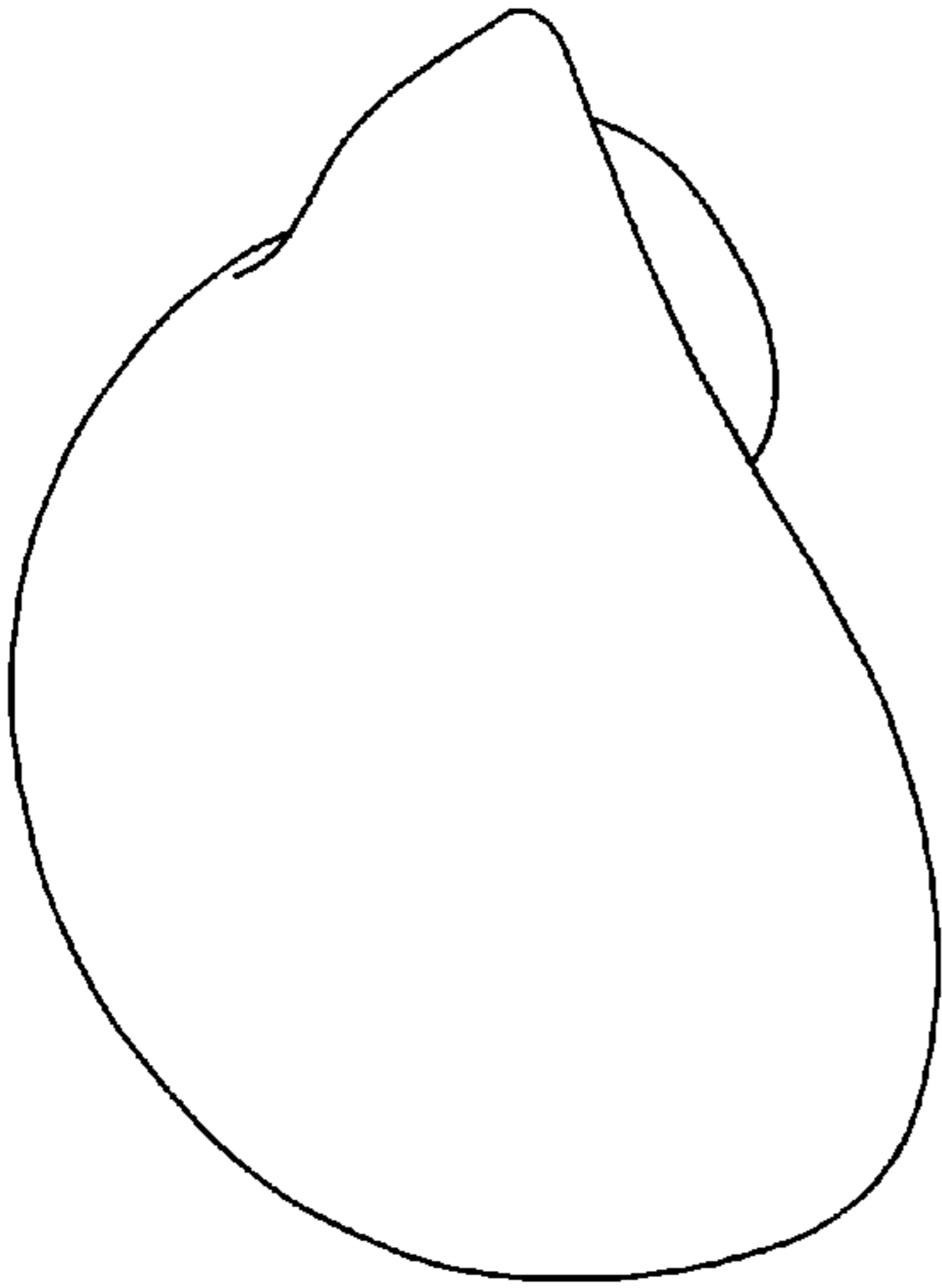

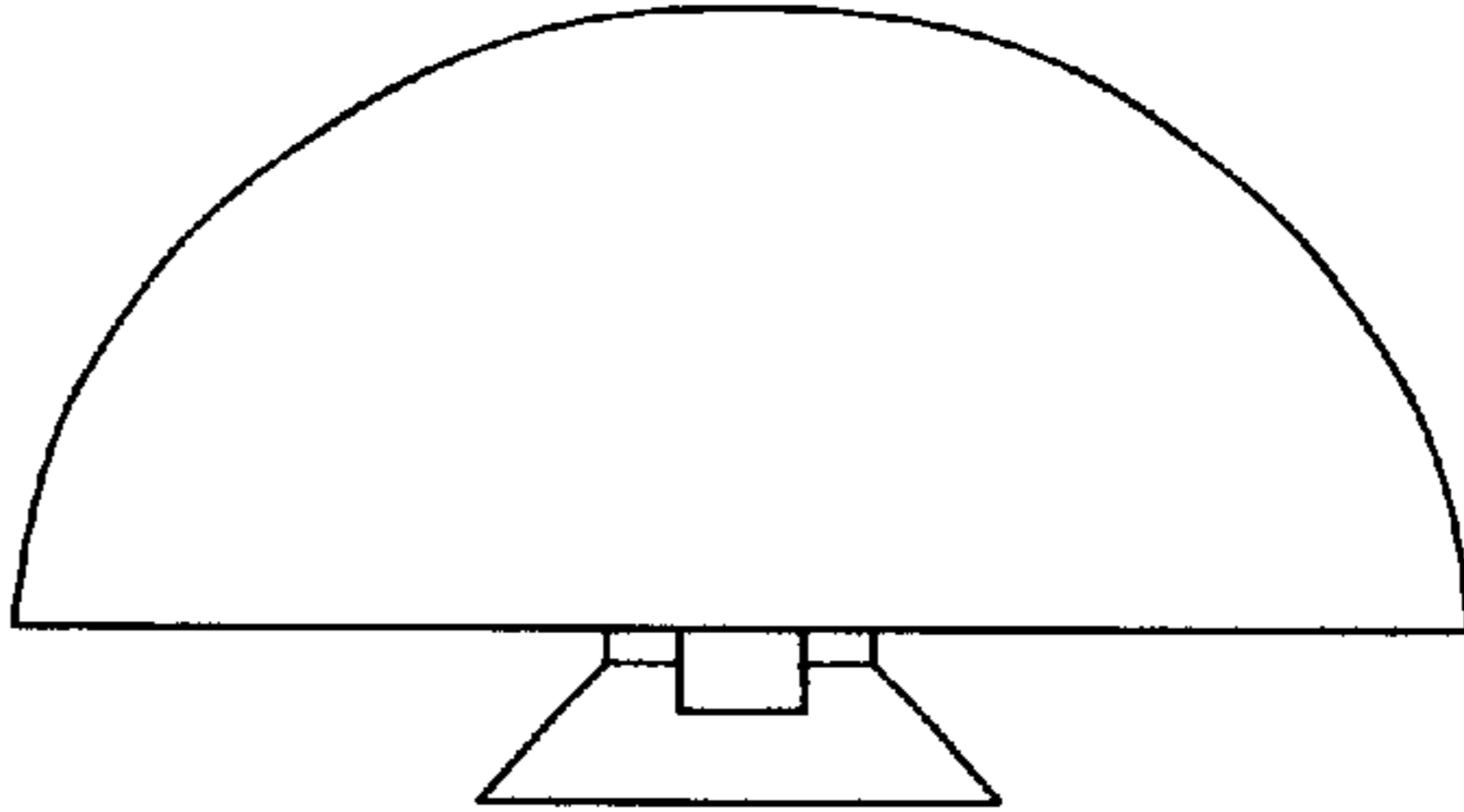

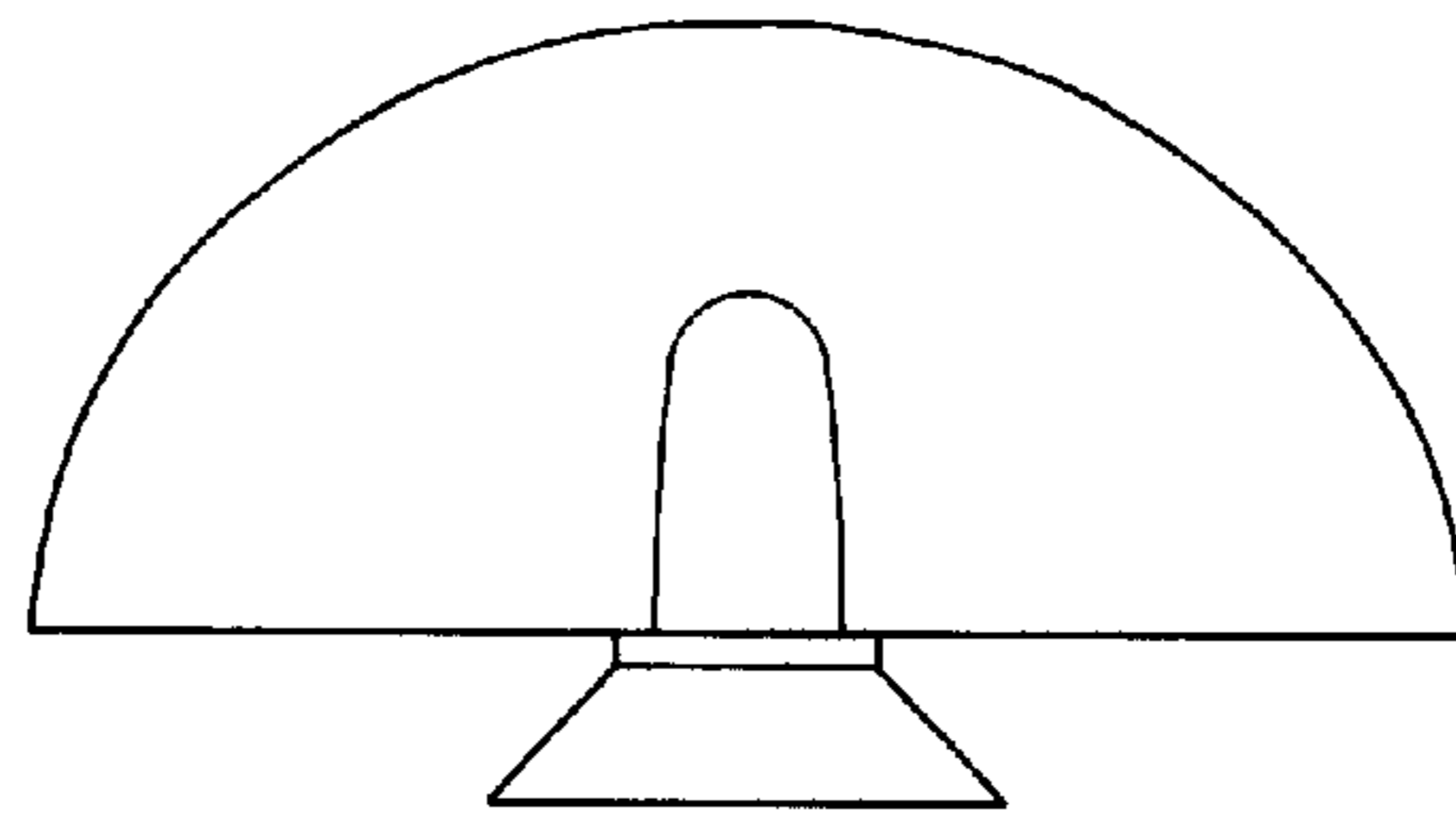
