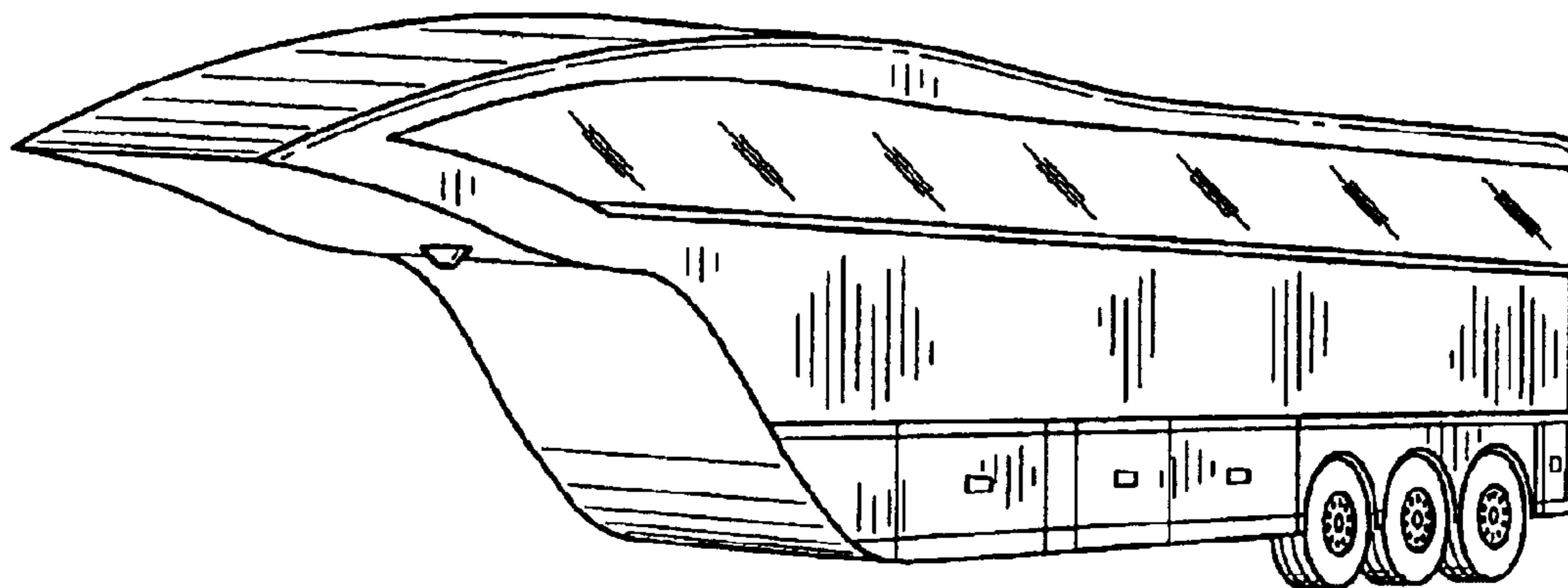

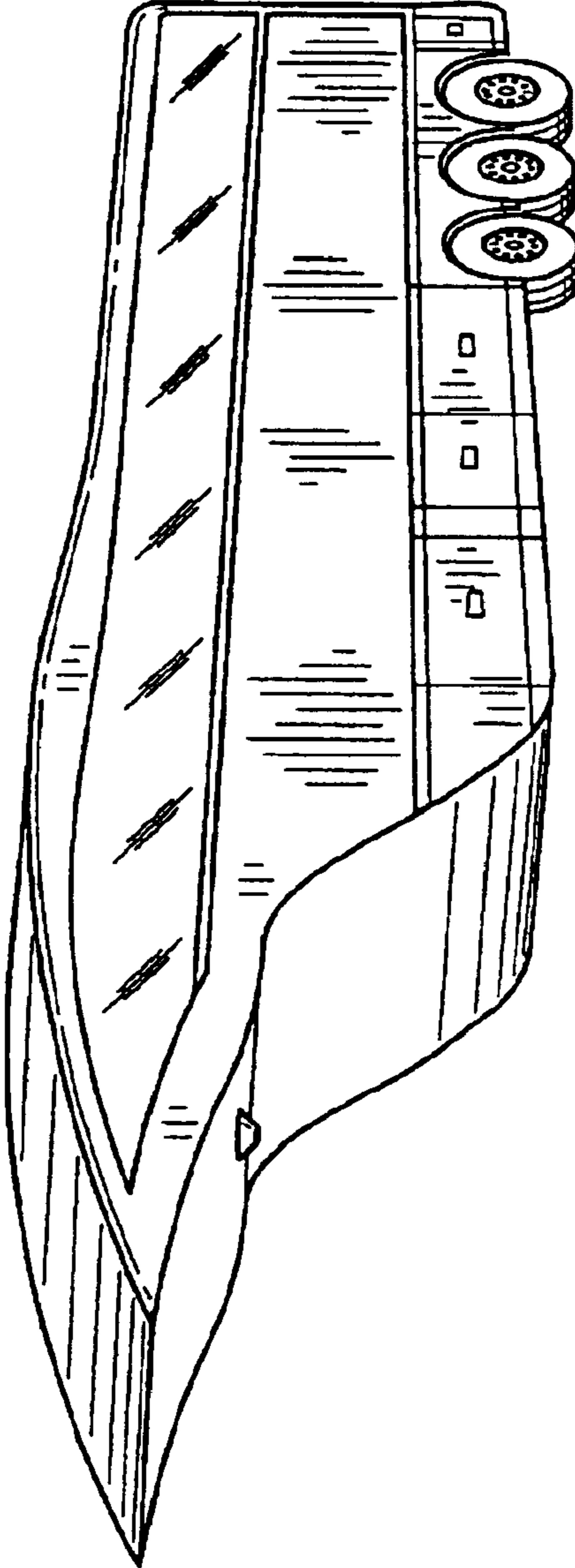
The ornamental design for a trailer, as shown and described.

**DESCRIPTION**

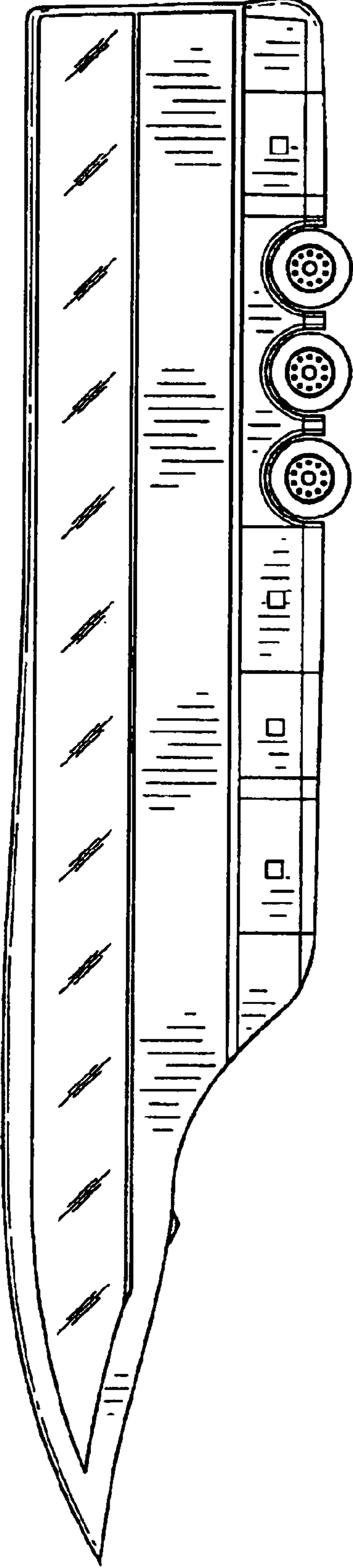
FIG. 1 is a perspective view of the trailer as viewed from the left, front side of the trailer;

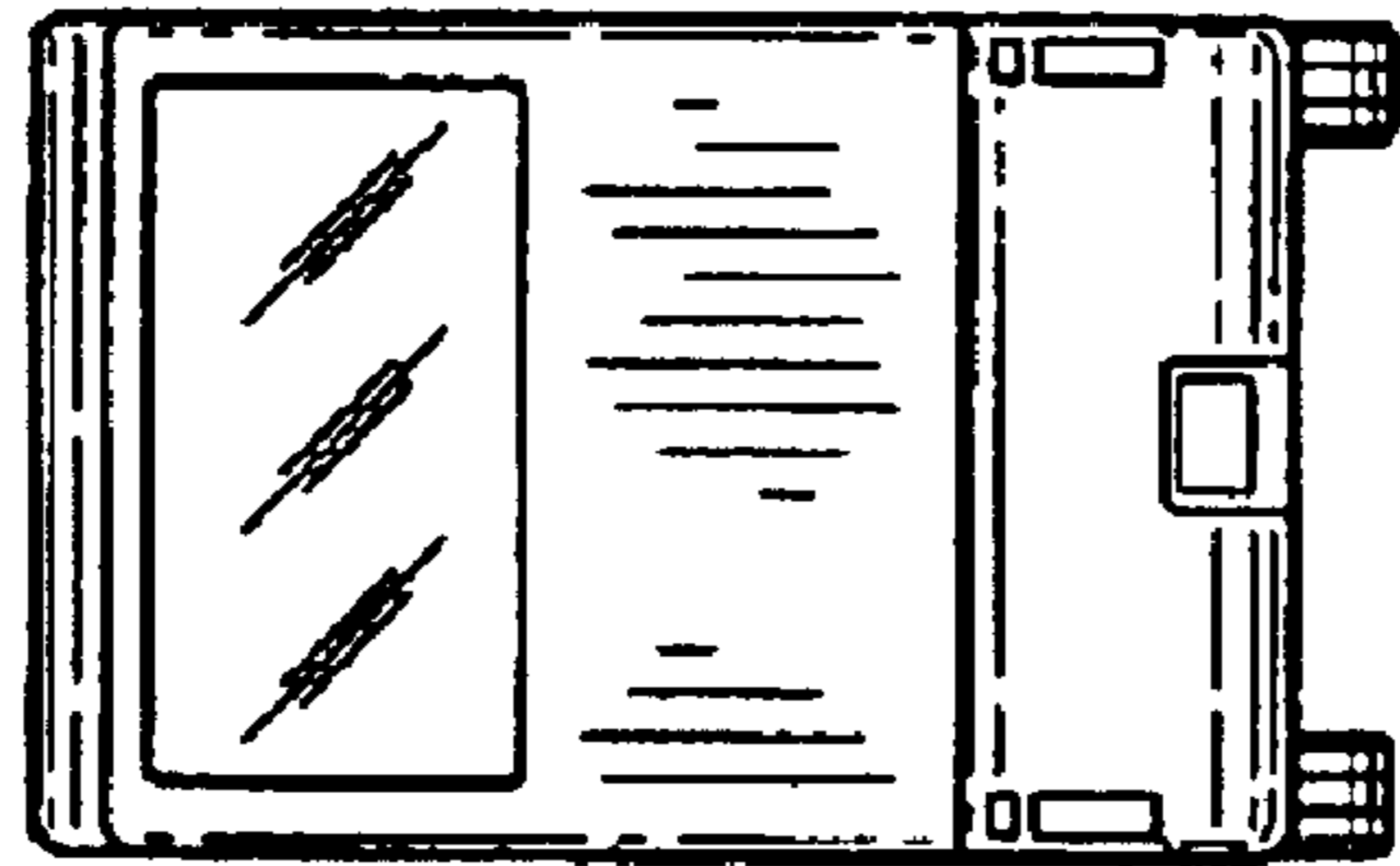

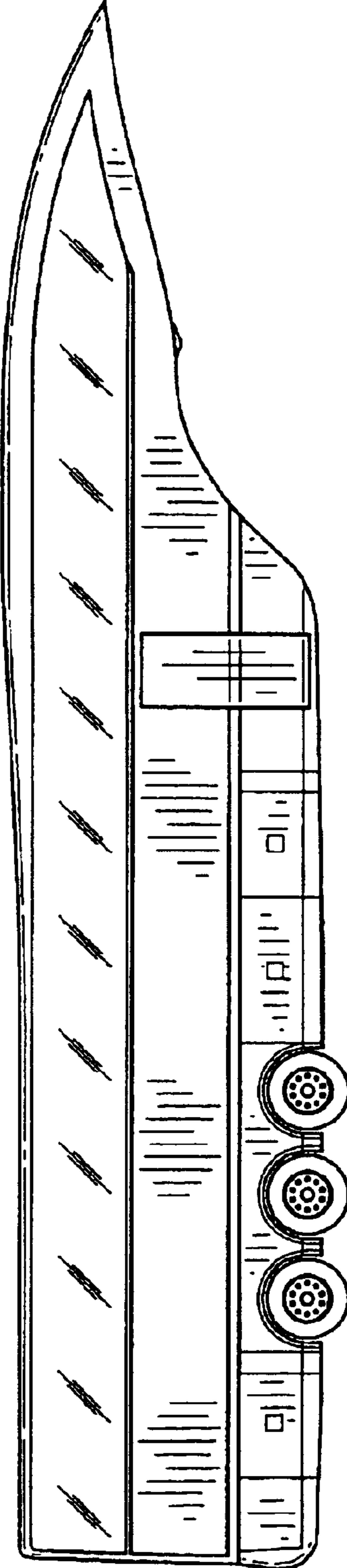

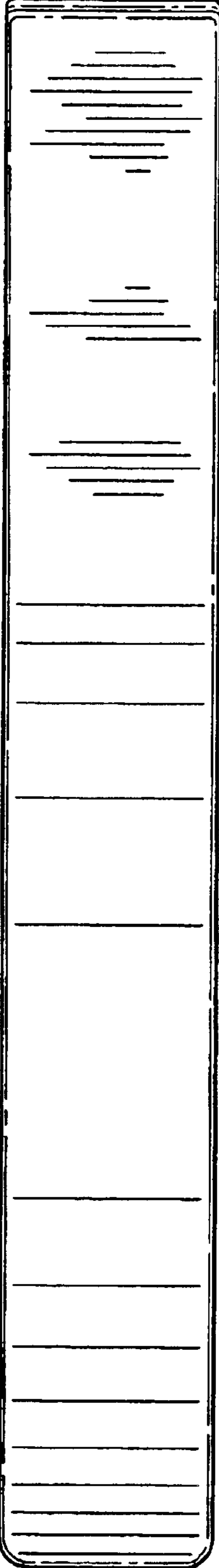

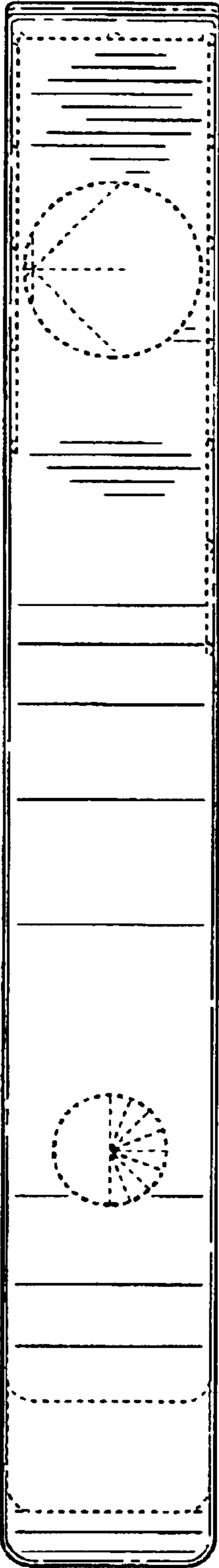
