**DESCRIPTION**

FIG. 4 is a side view of the cordless telephone handset of FIG. 1;

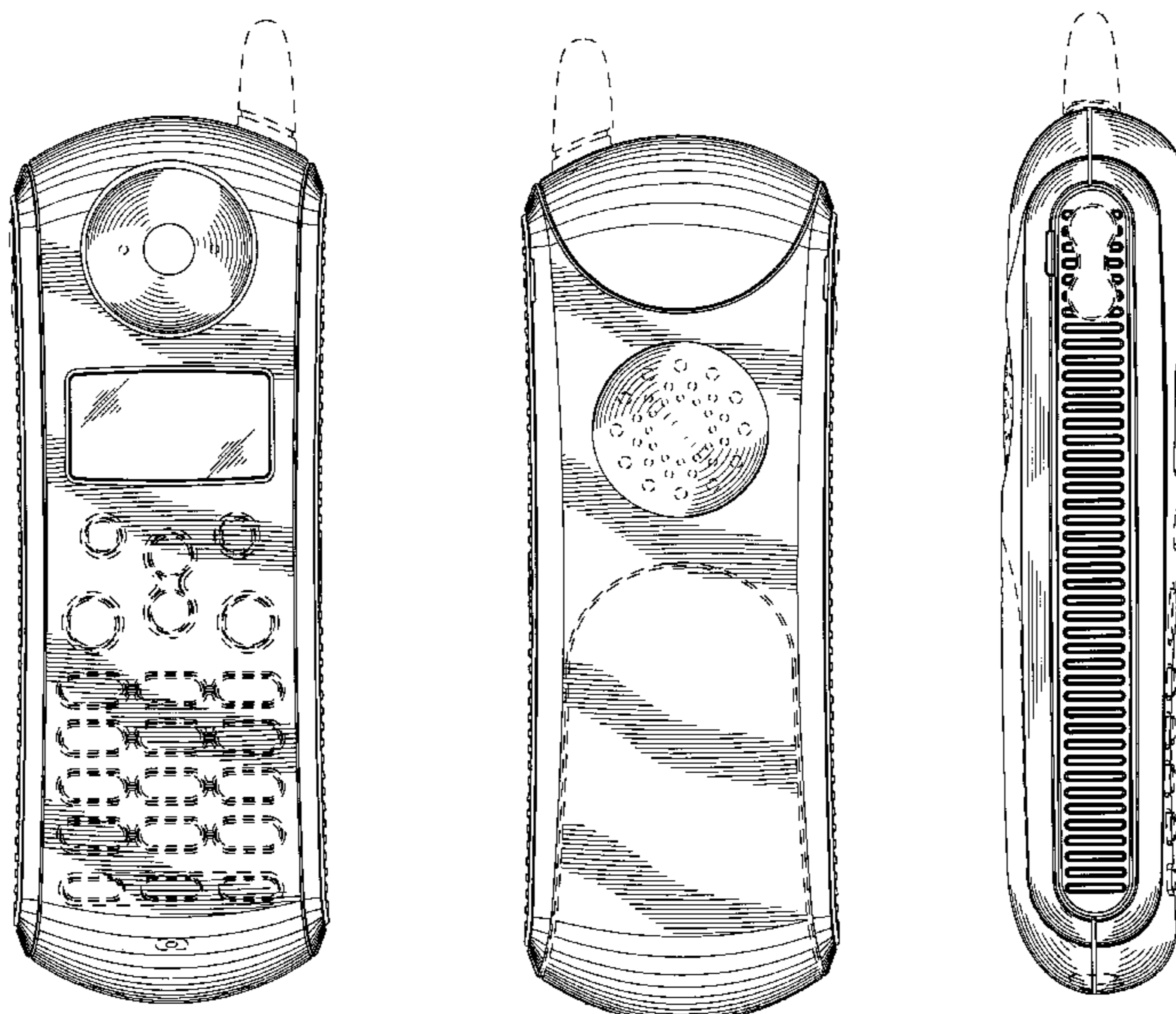
FIG. 5 is an opposite side view of the cordless telephone handset of FIG. 1;

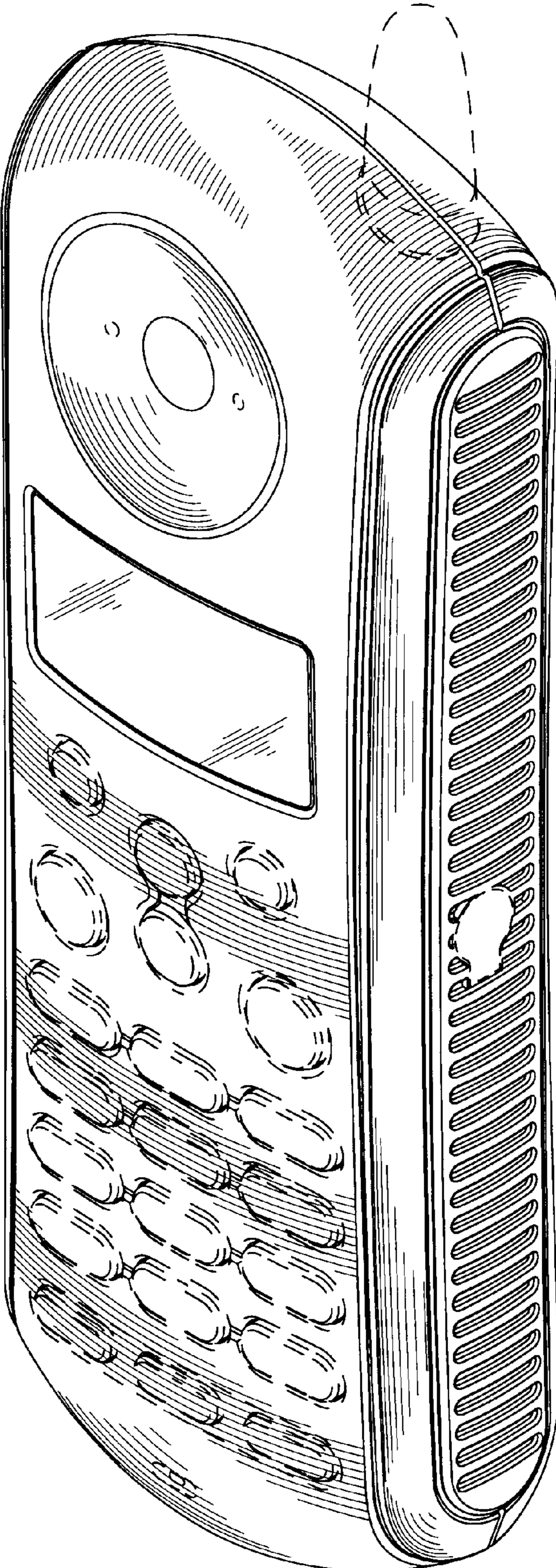
FIG. 6 is a top view of the cordless telephone handset of FIG. 1; and,

FIG. 7 is a bottom view of the cordless telephone handset of FIG. 1.

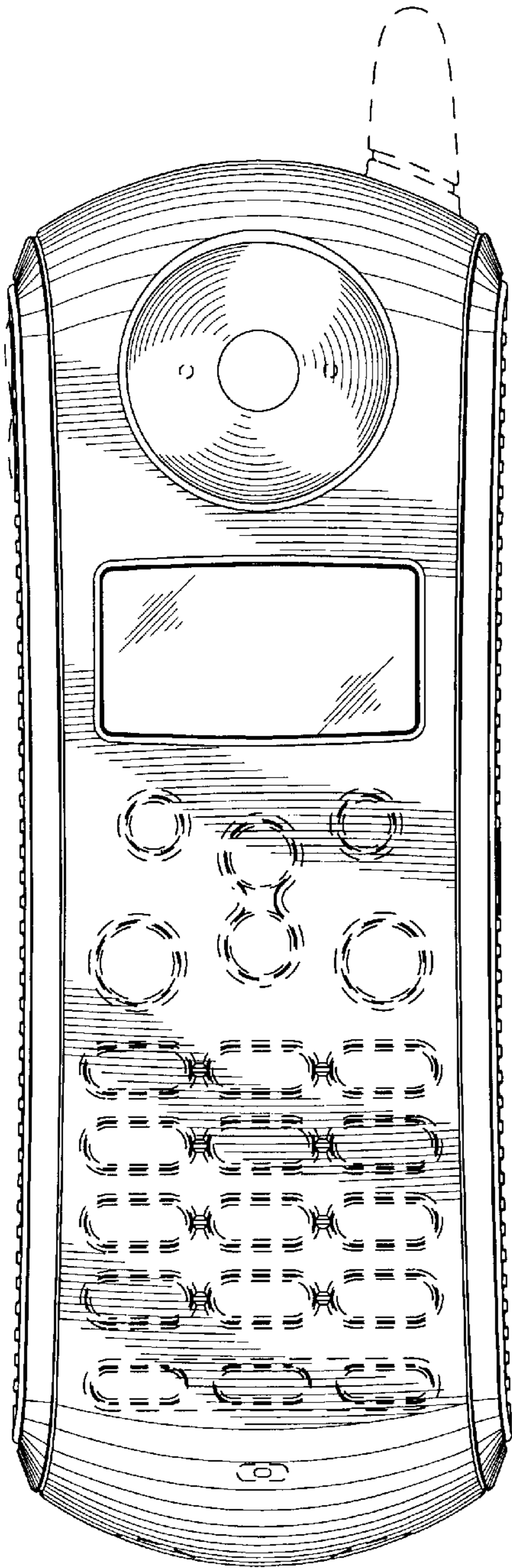

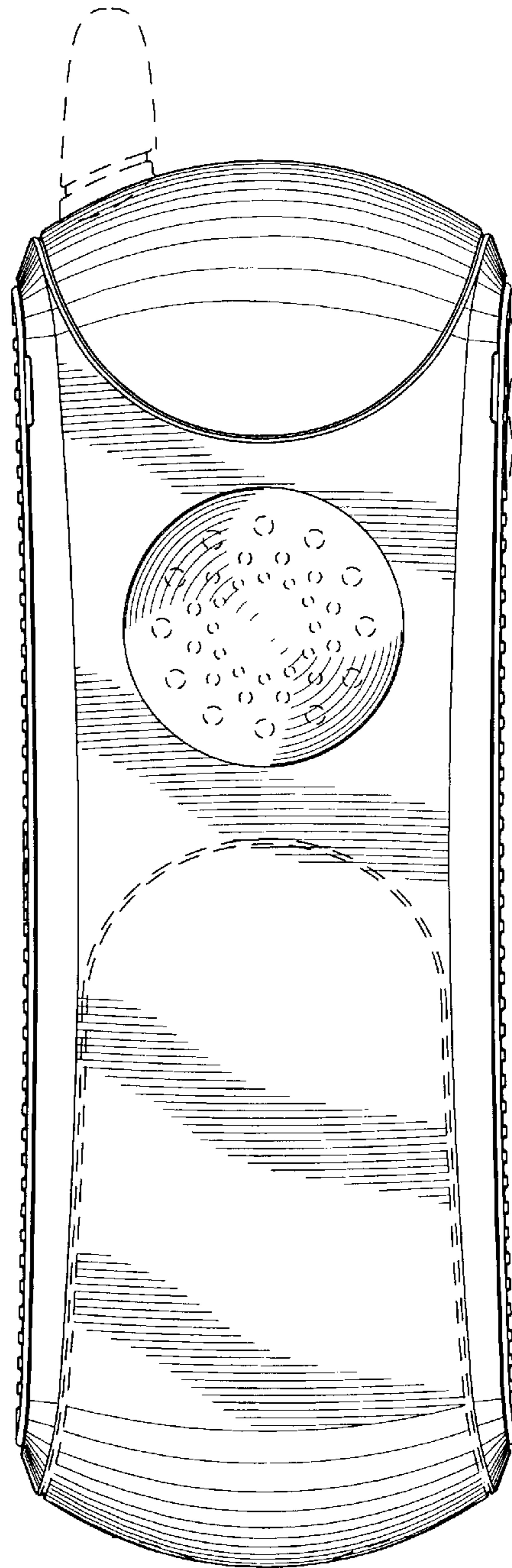




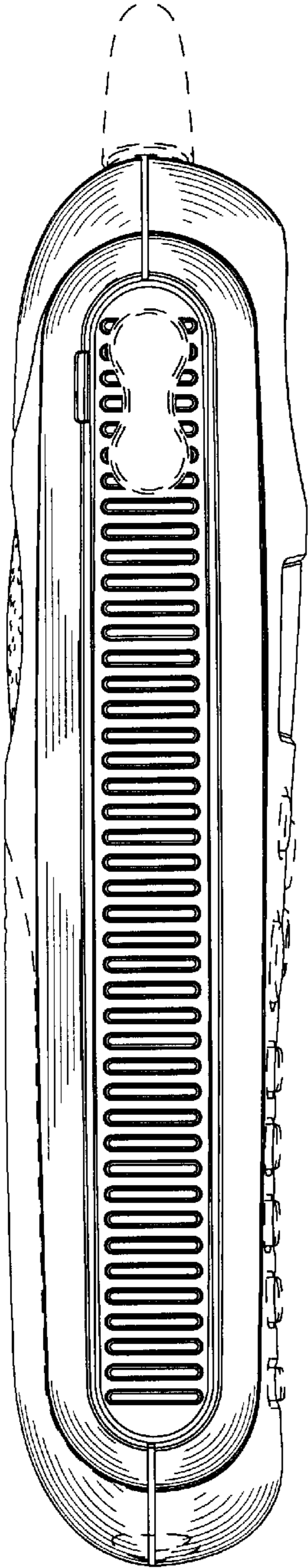

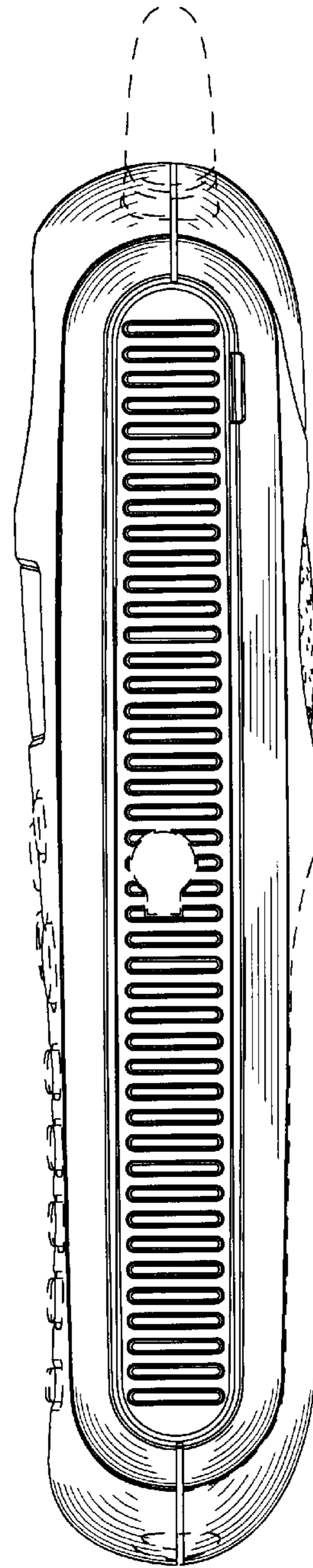

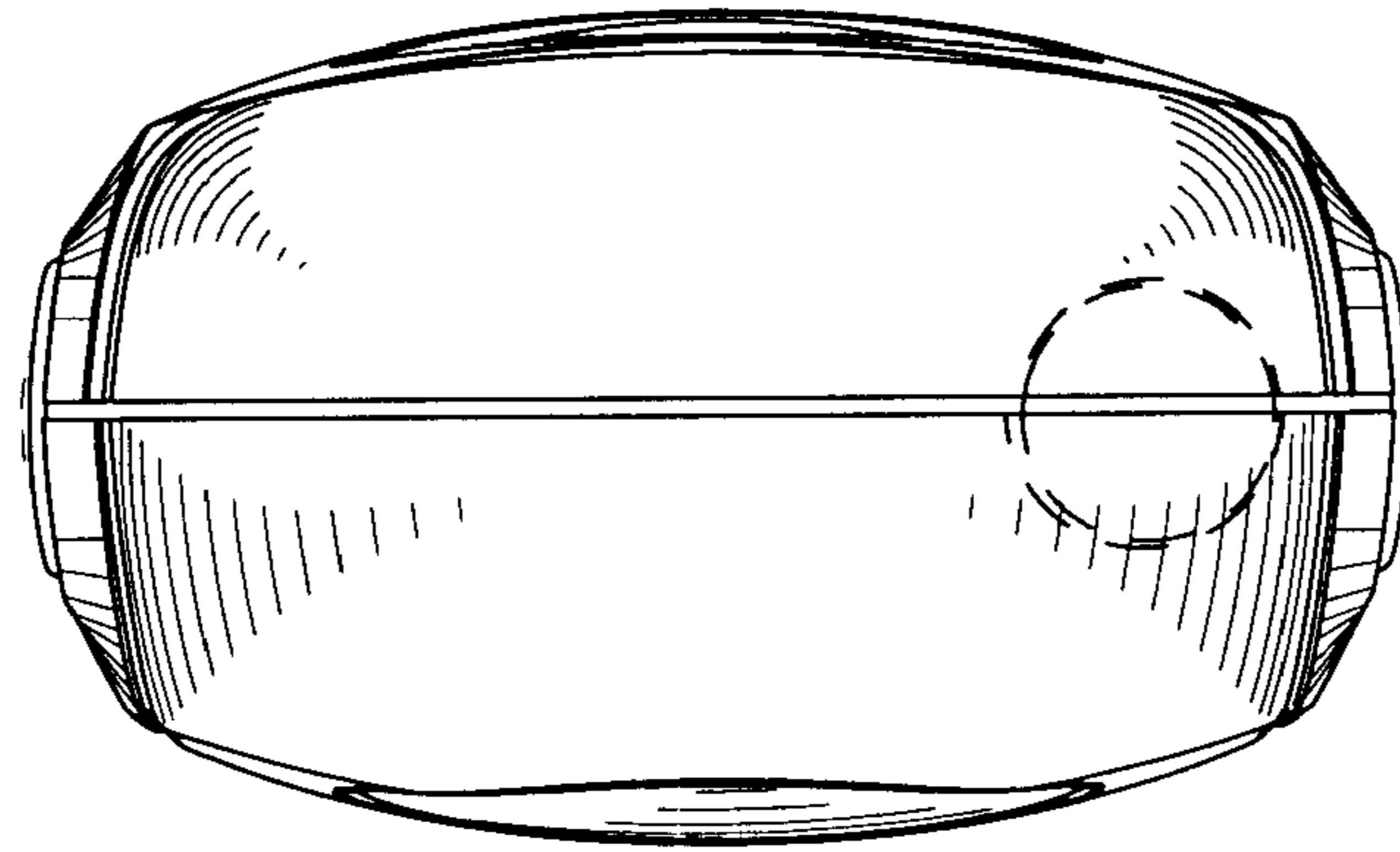

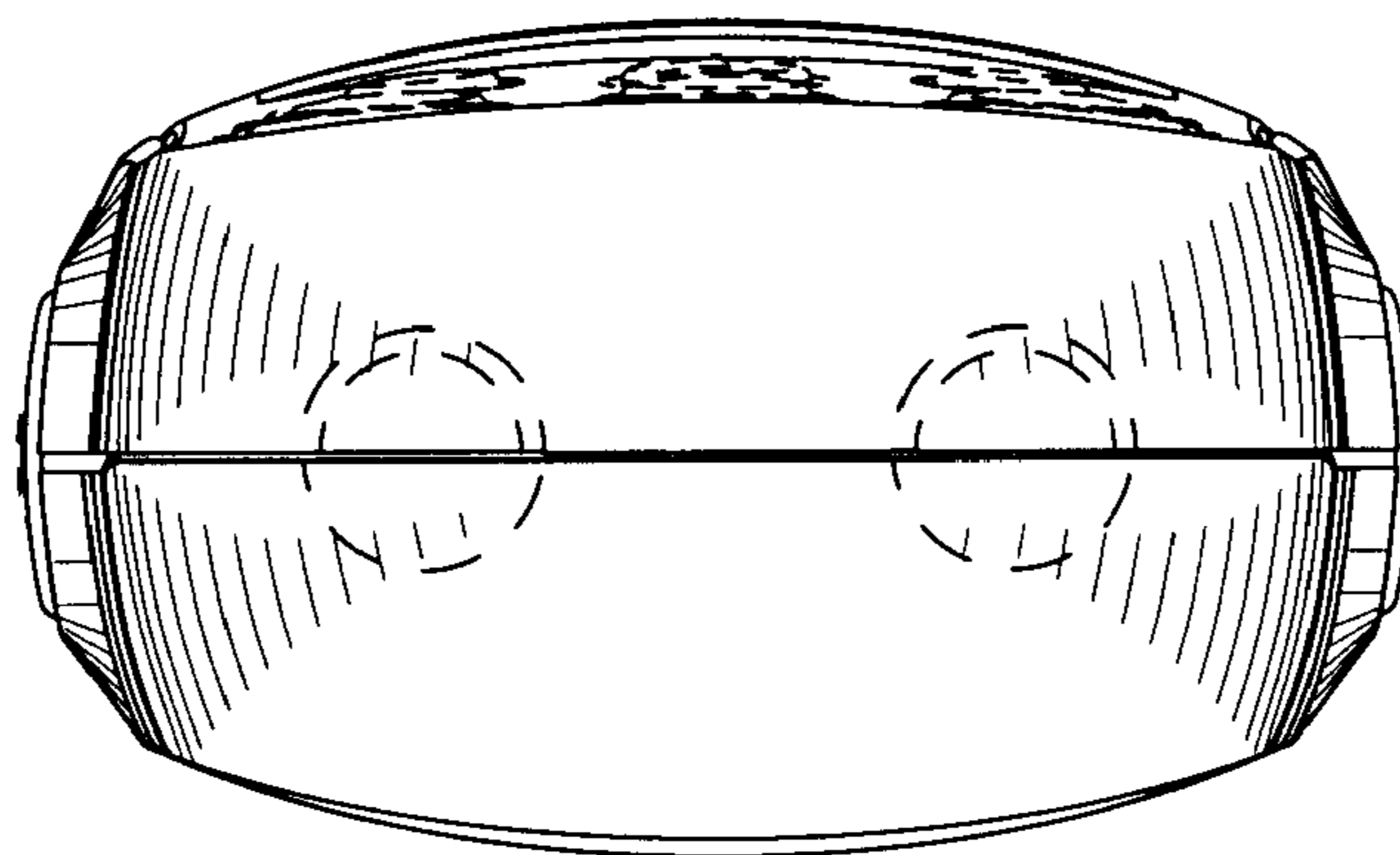
