DESCRIPTION

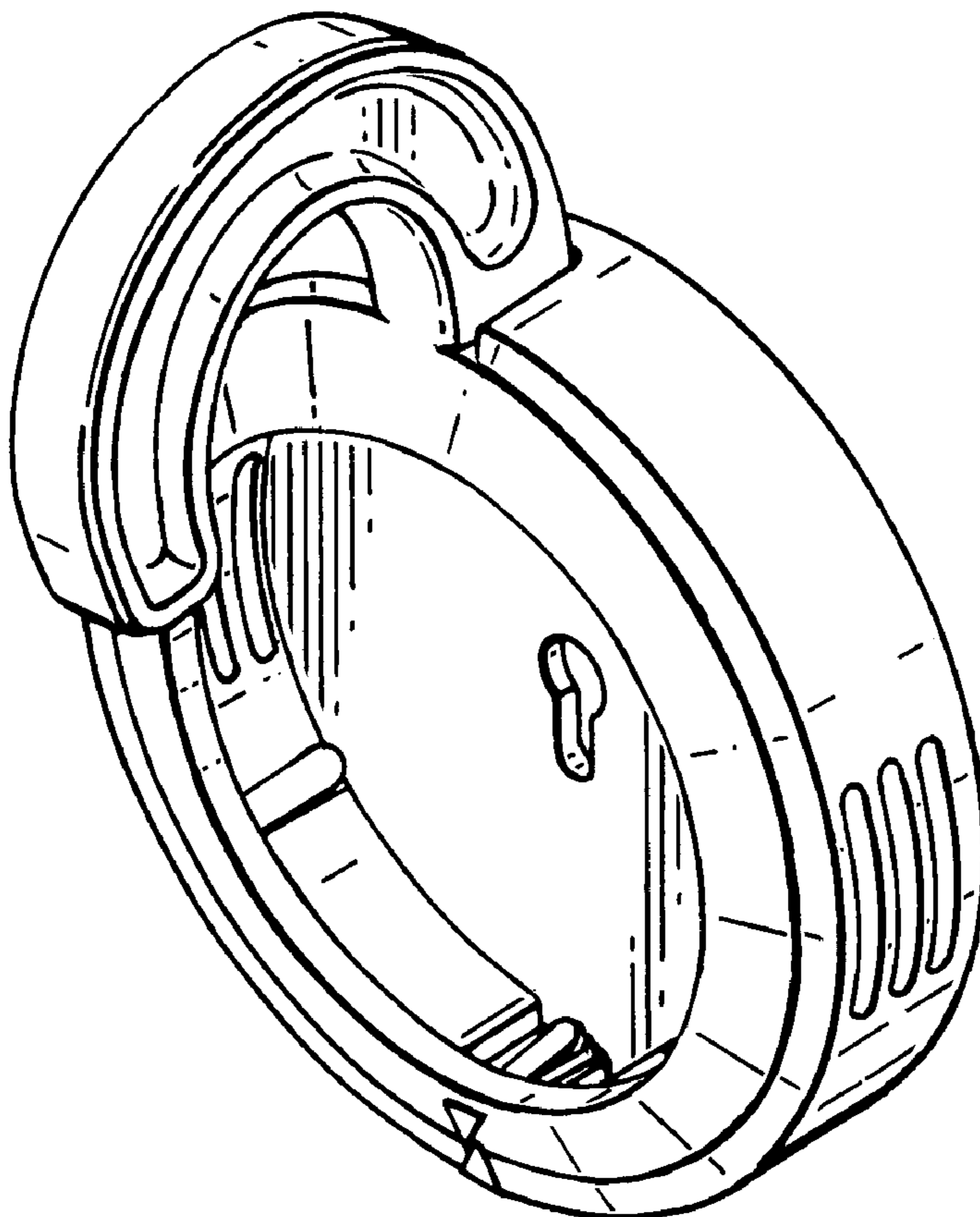
FIG. 1 is a perspective view from the rear looking inward of an air freshener device;

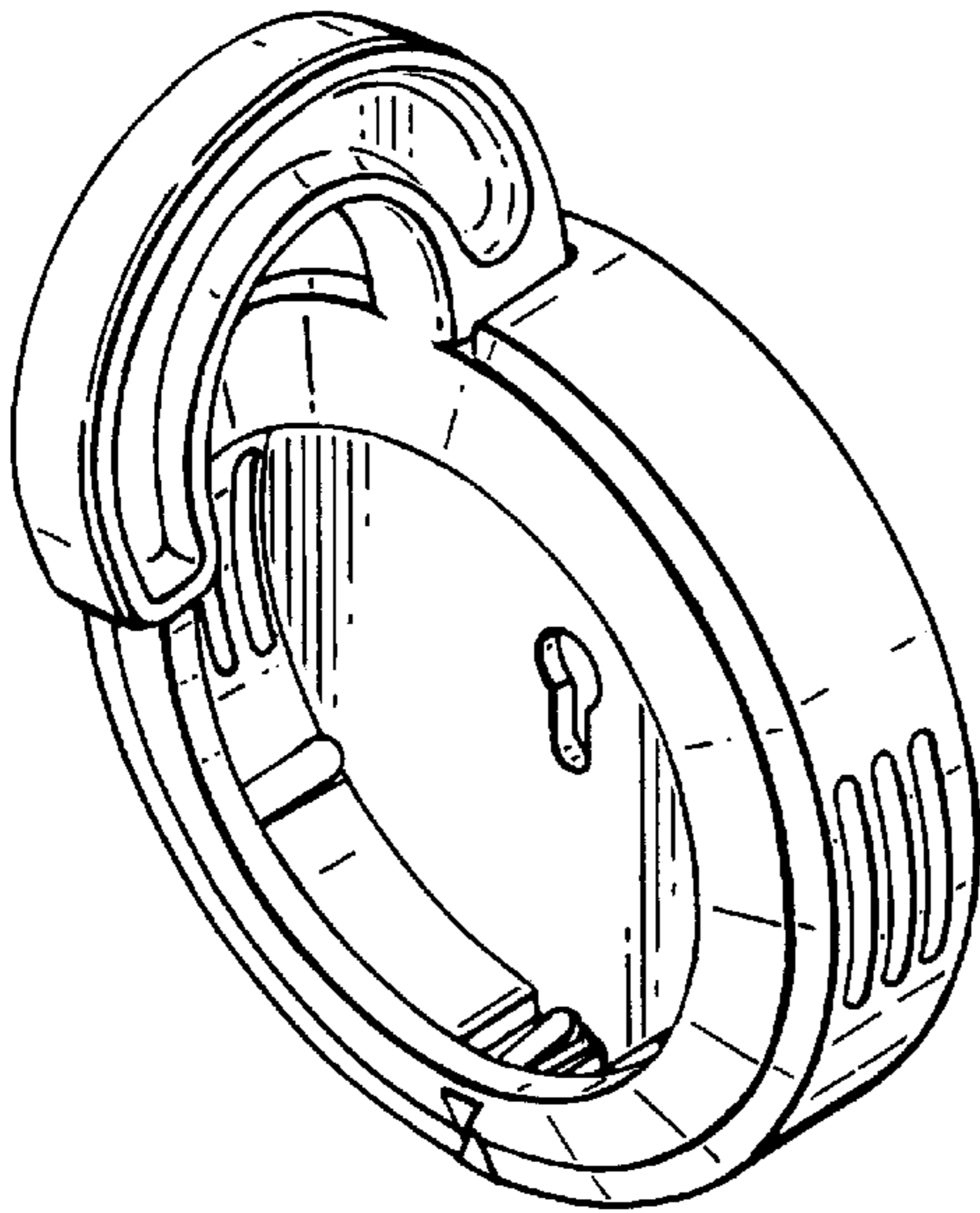

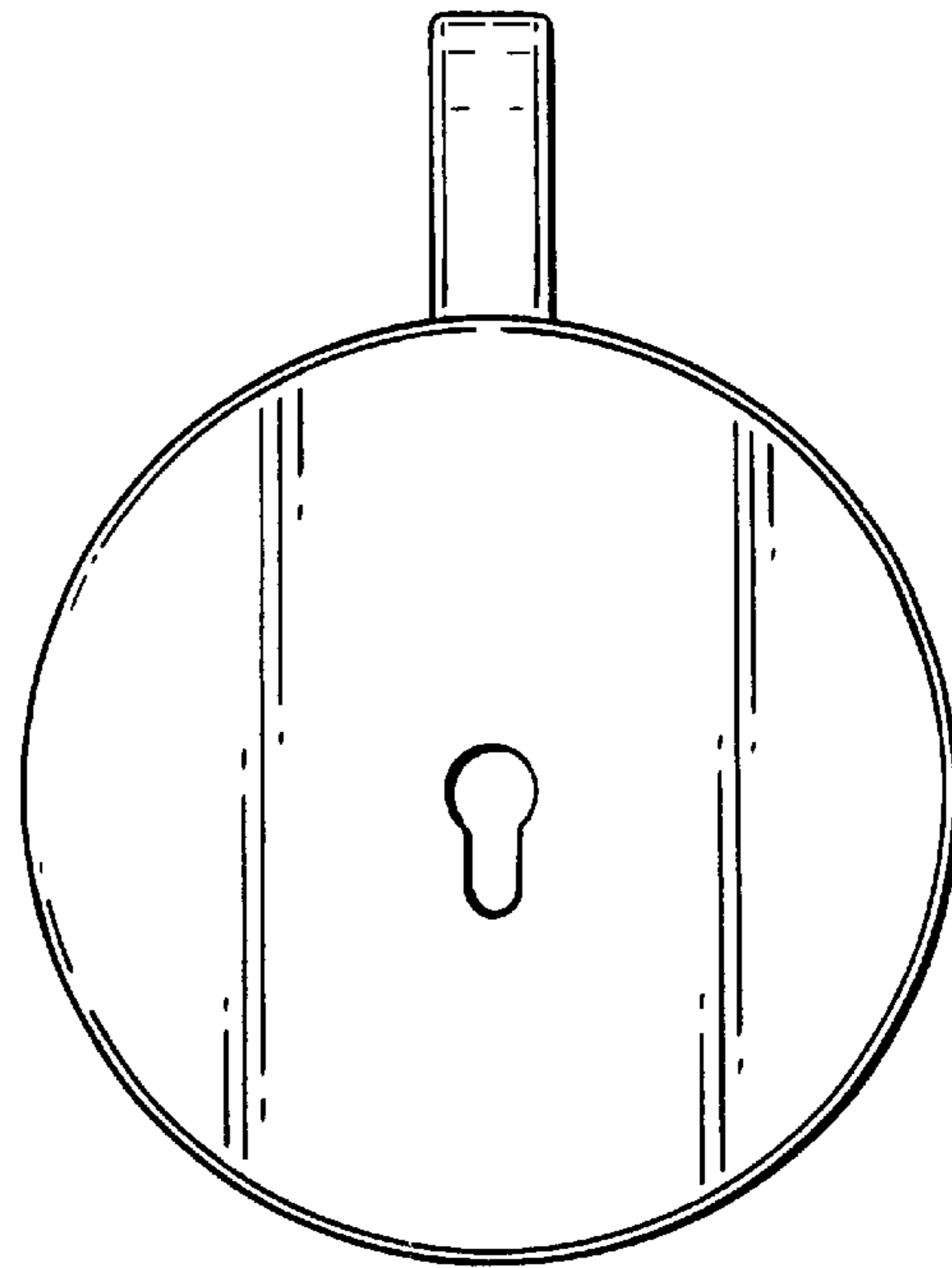

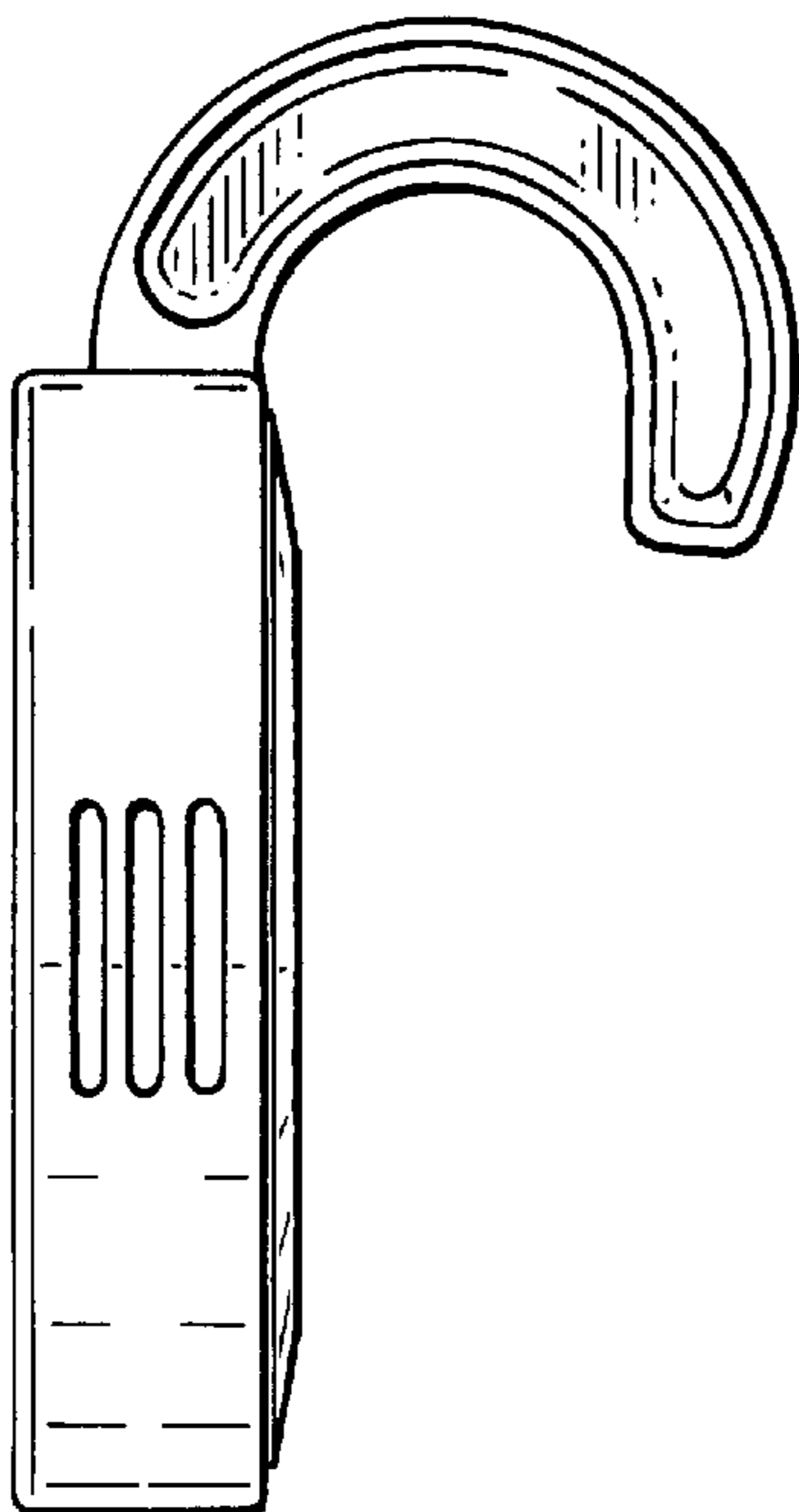

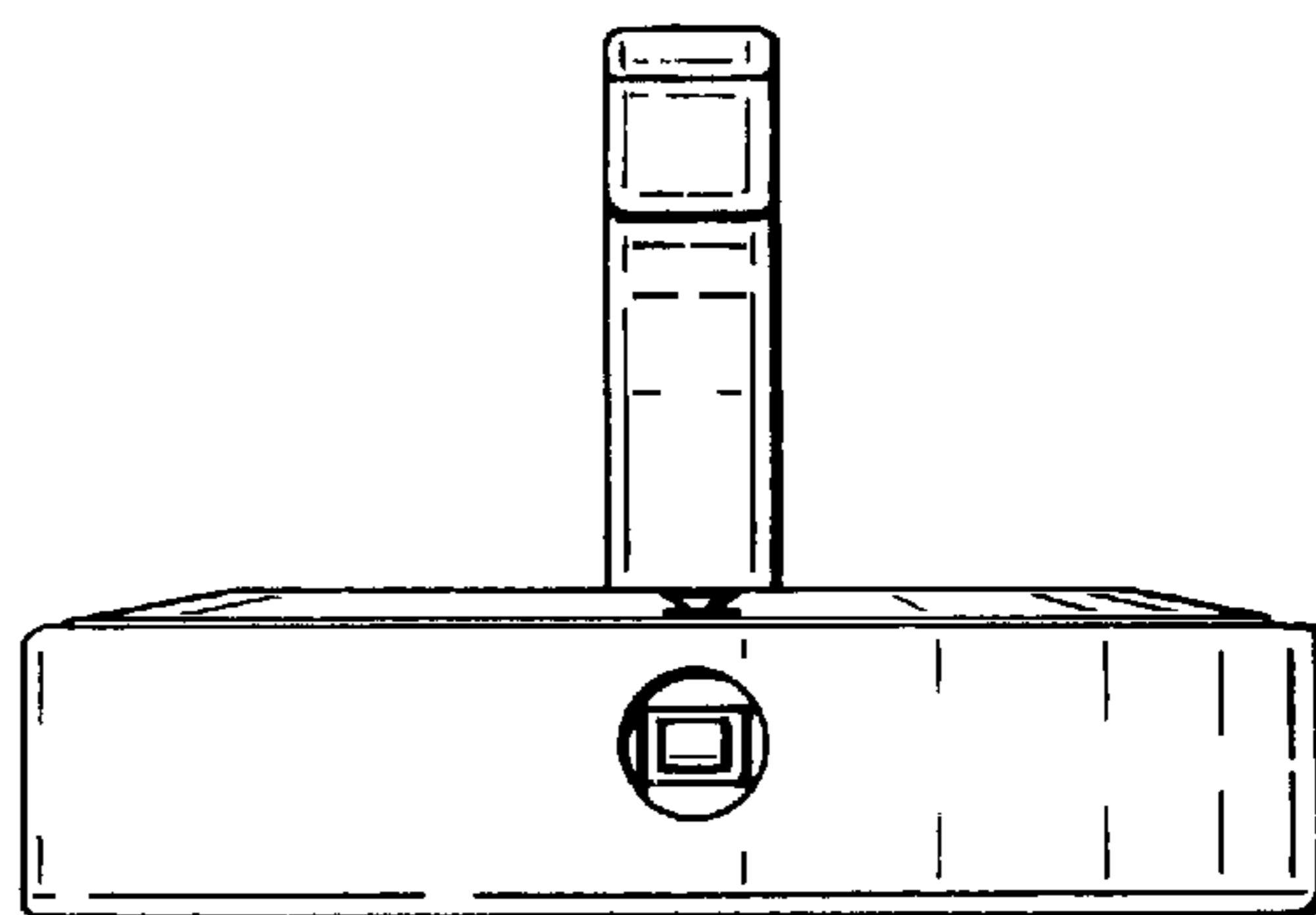
