and described.

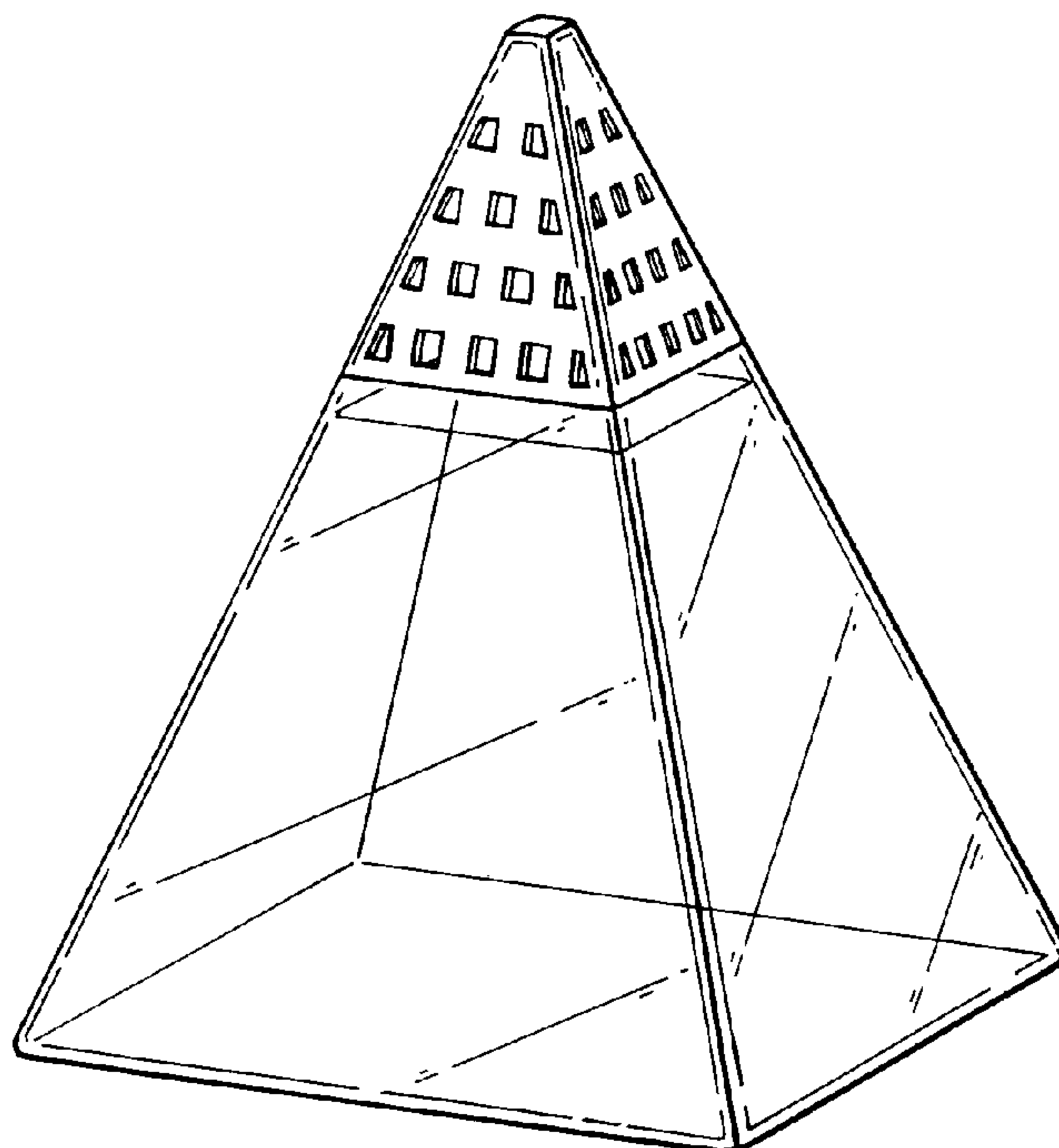
**DESCRIPTION**

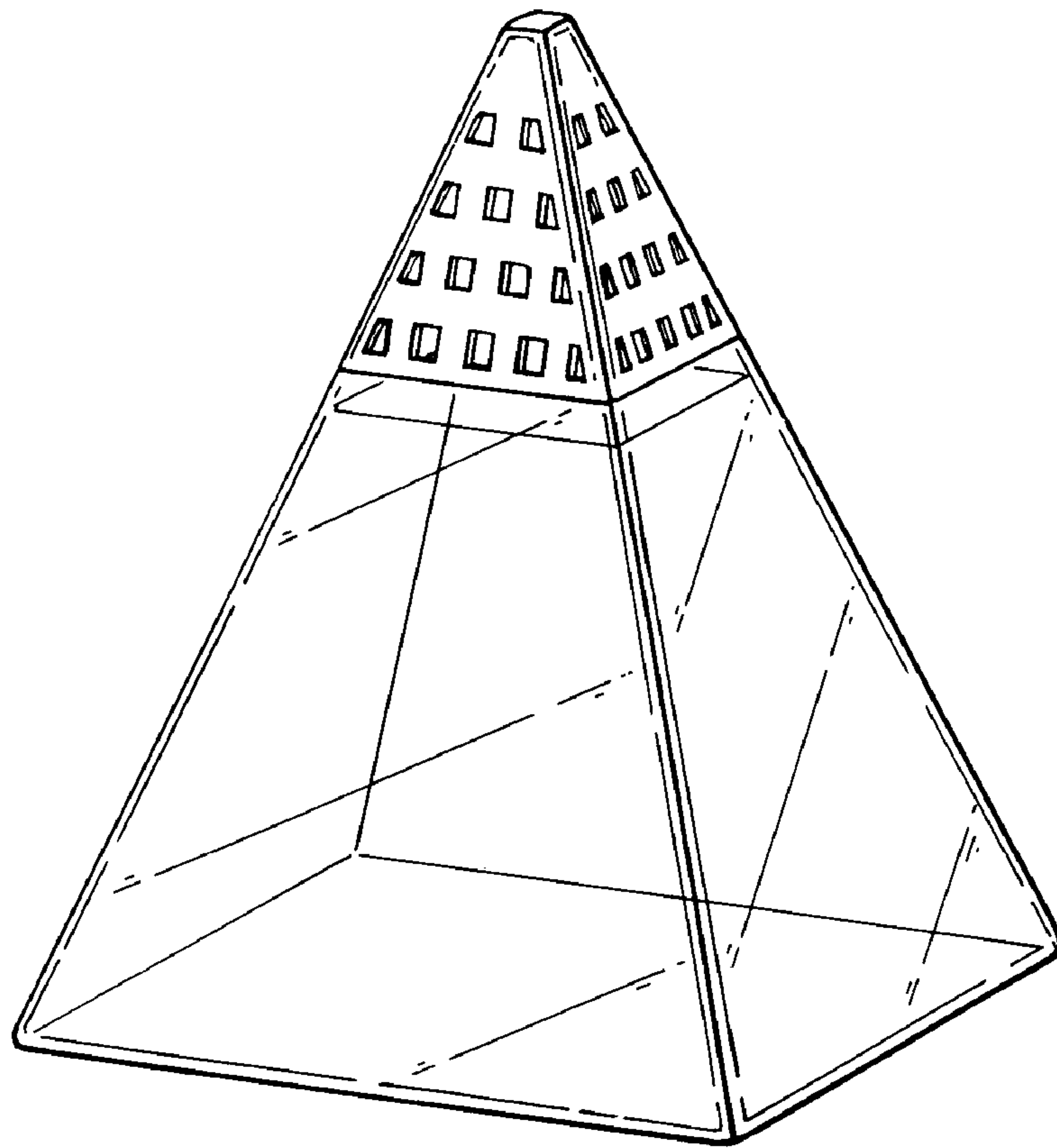

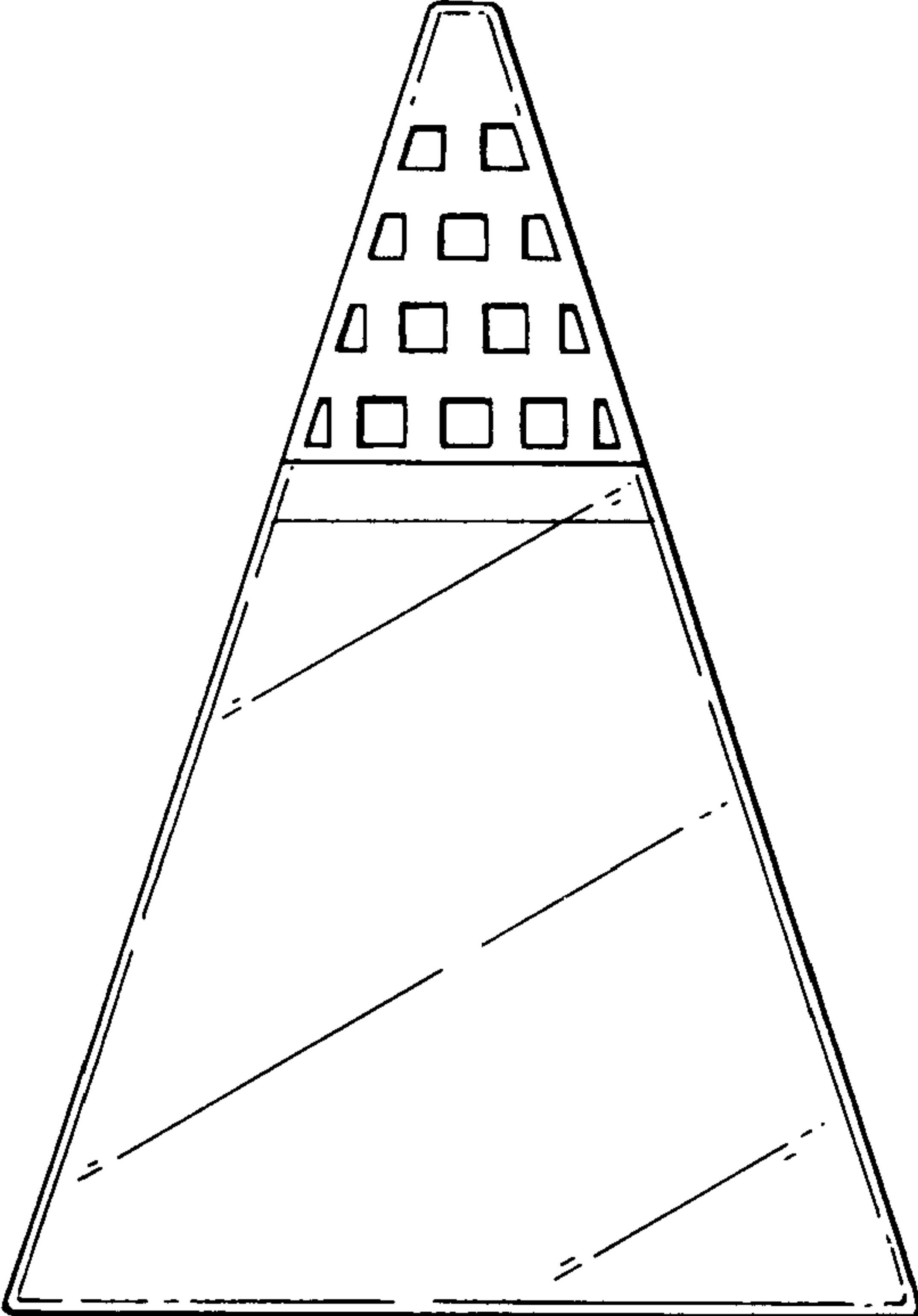

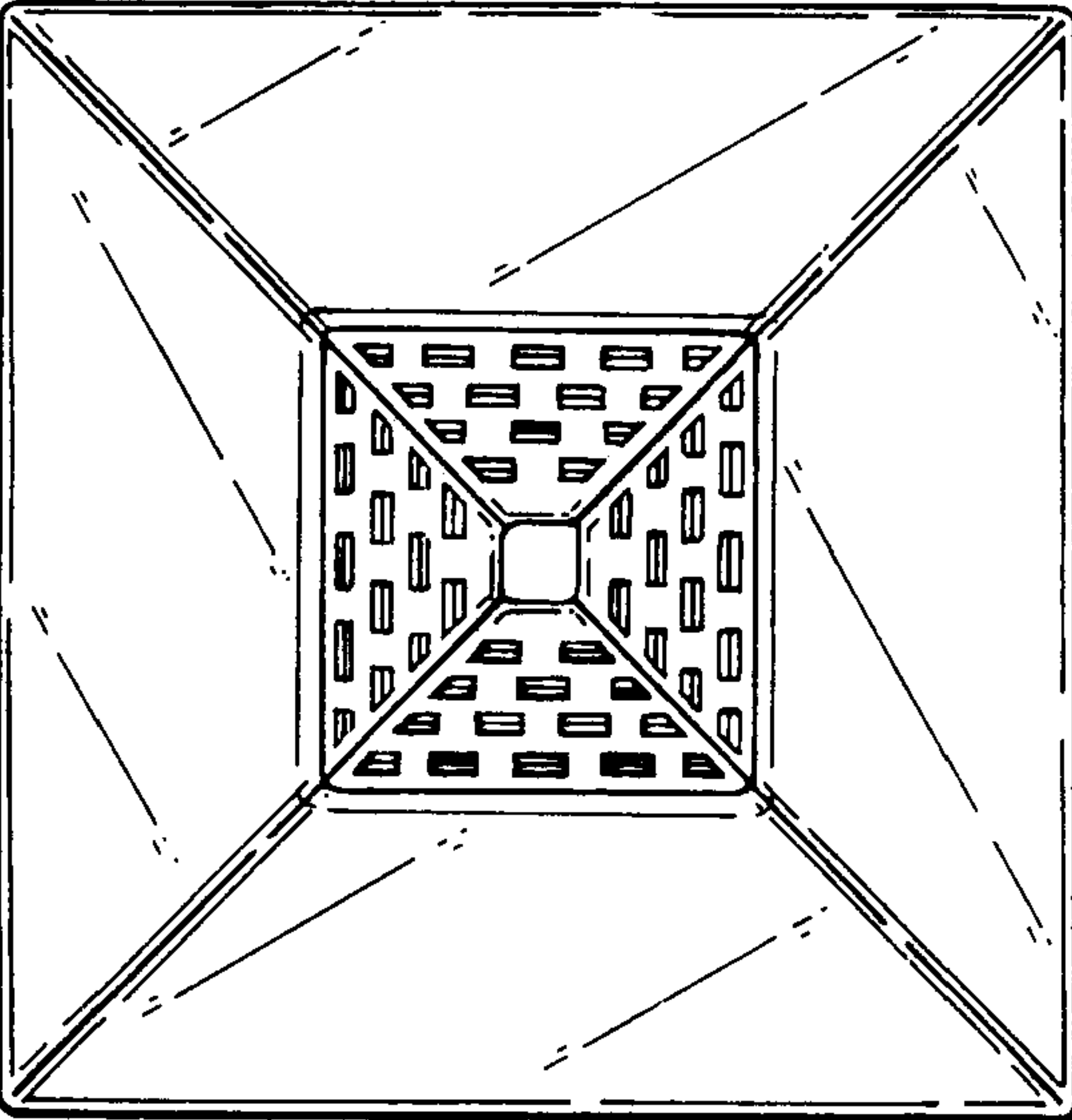
