(57) **CLAIM**

The ornamental design of the door edge with cover strip, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of a first exemplary embodiment of the door edge with cover strip showing our new design;

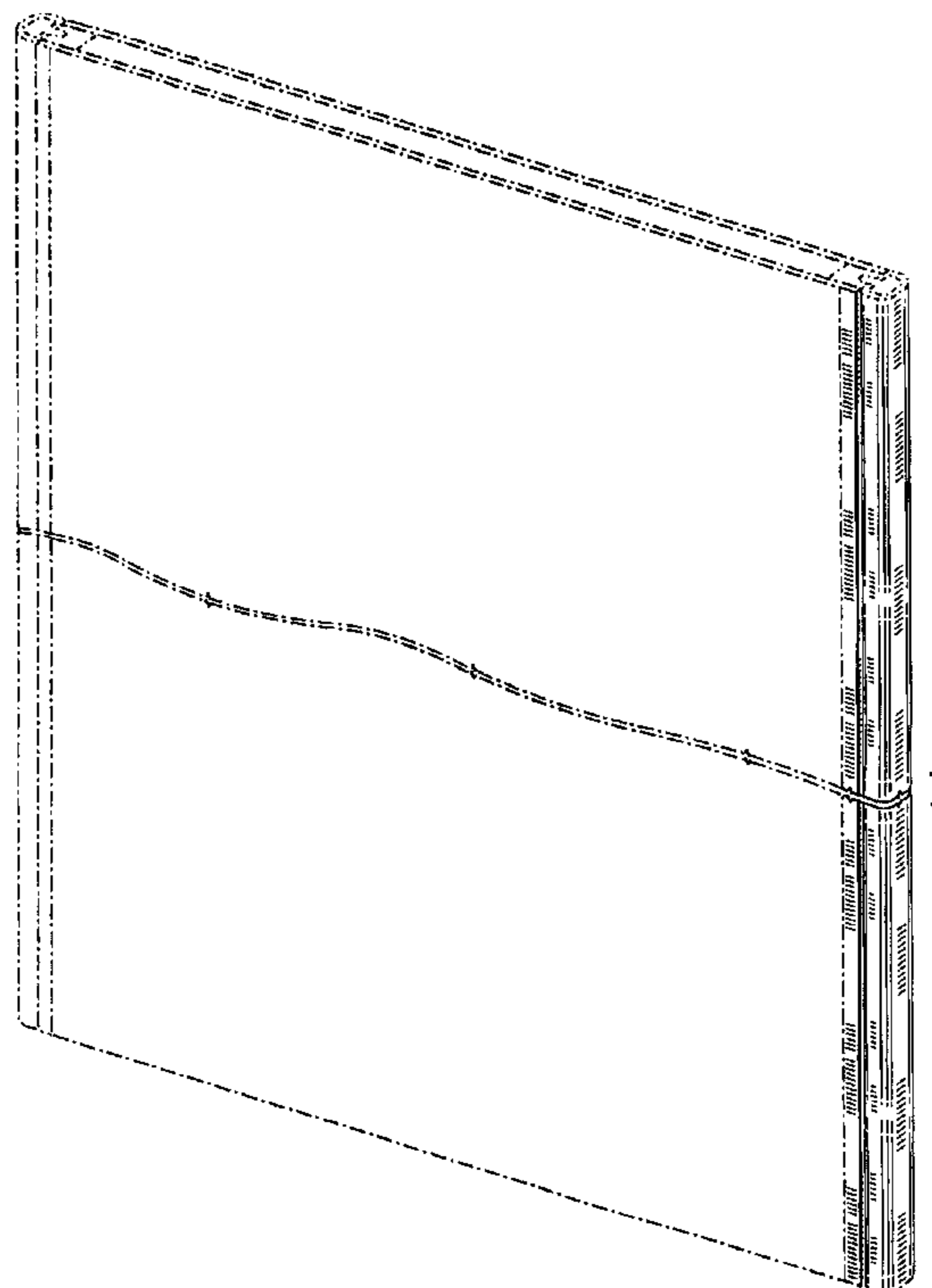
FIG. 2 is a front view of the door edge with cover strip of FIG. 1;

FIG. 3 is a perspective view of a second exemplary embodiment of the door edge with cover strip showing our new design; and,

FIG. 4 is a front view of the door edge with cover strip of FIG. 3.

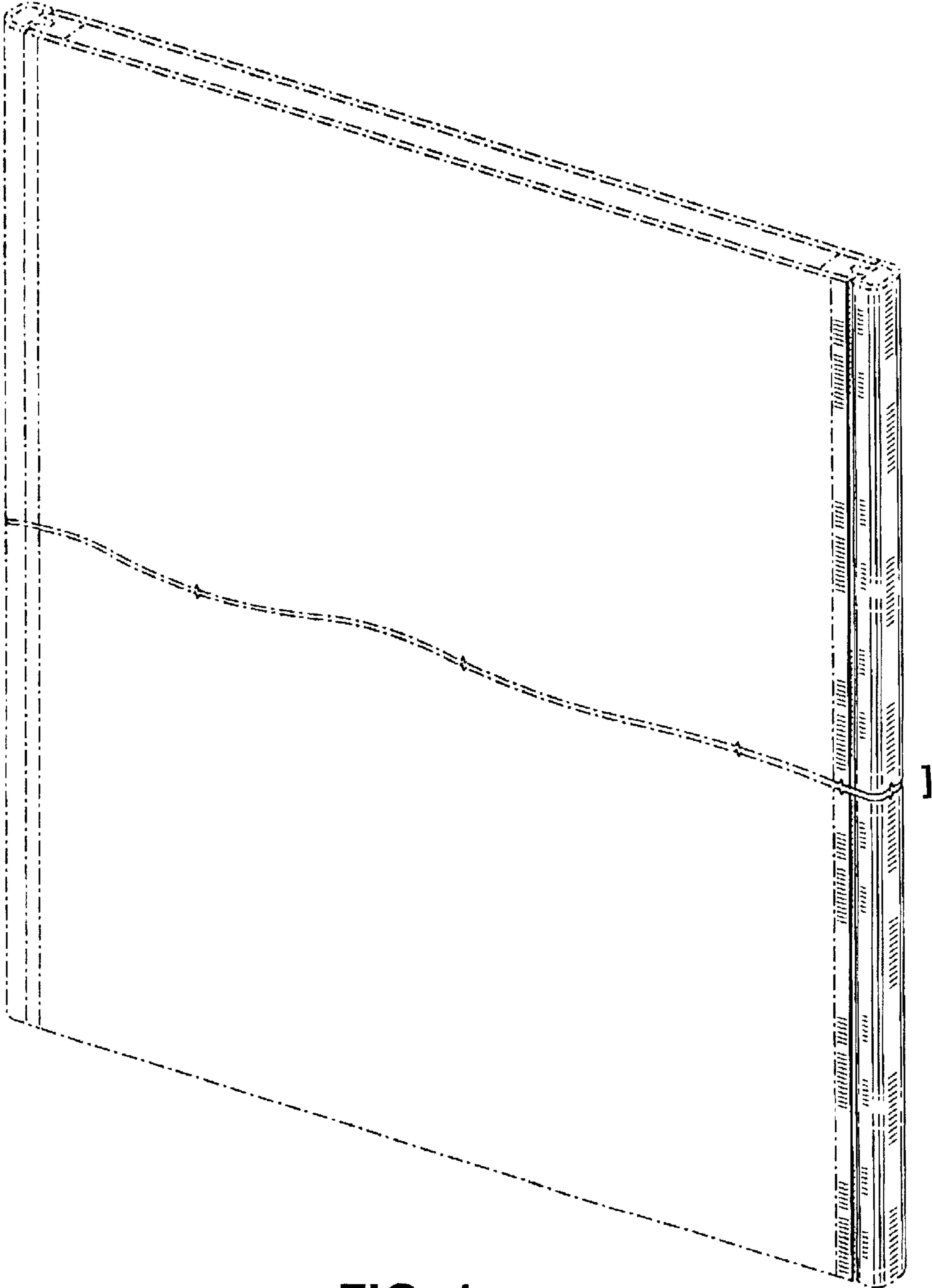

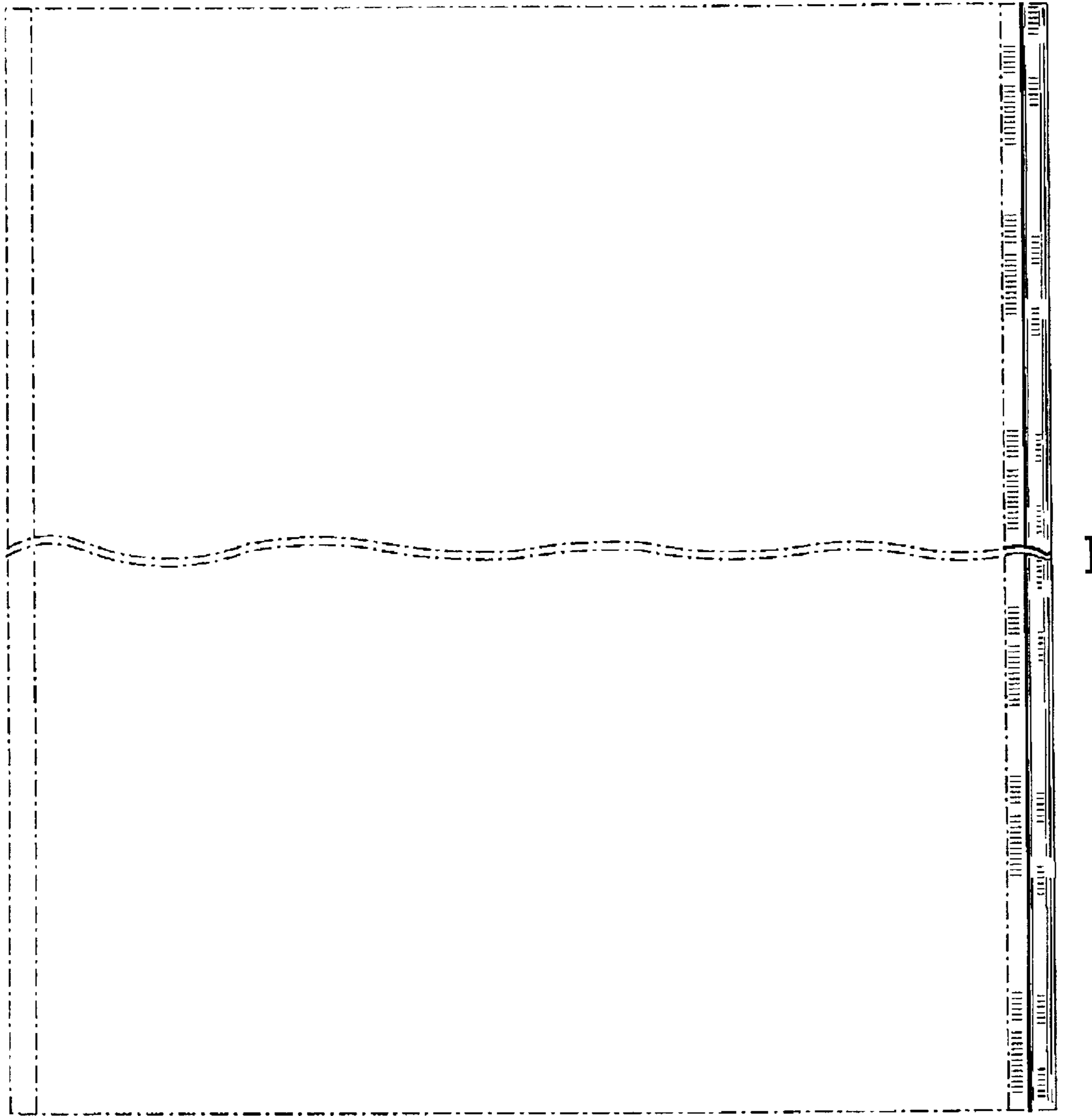

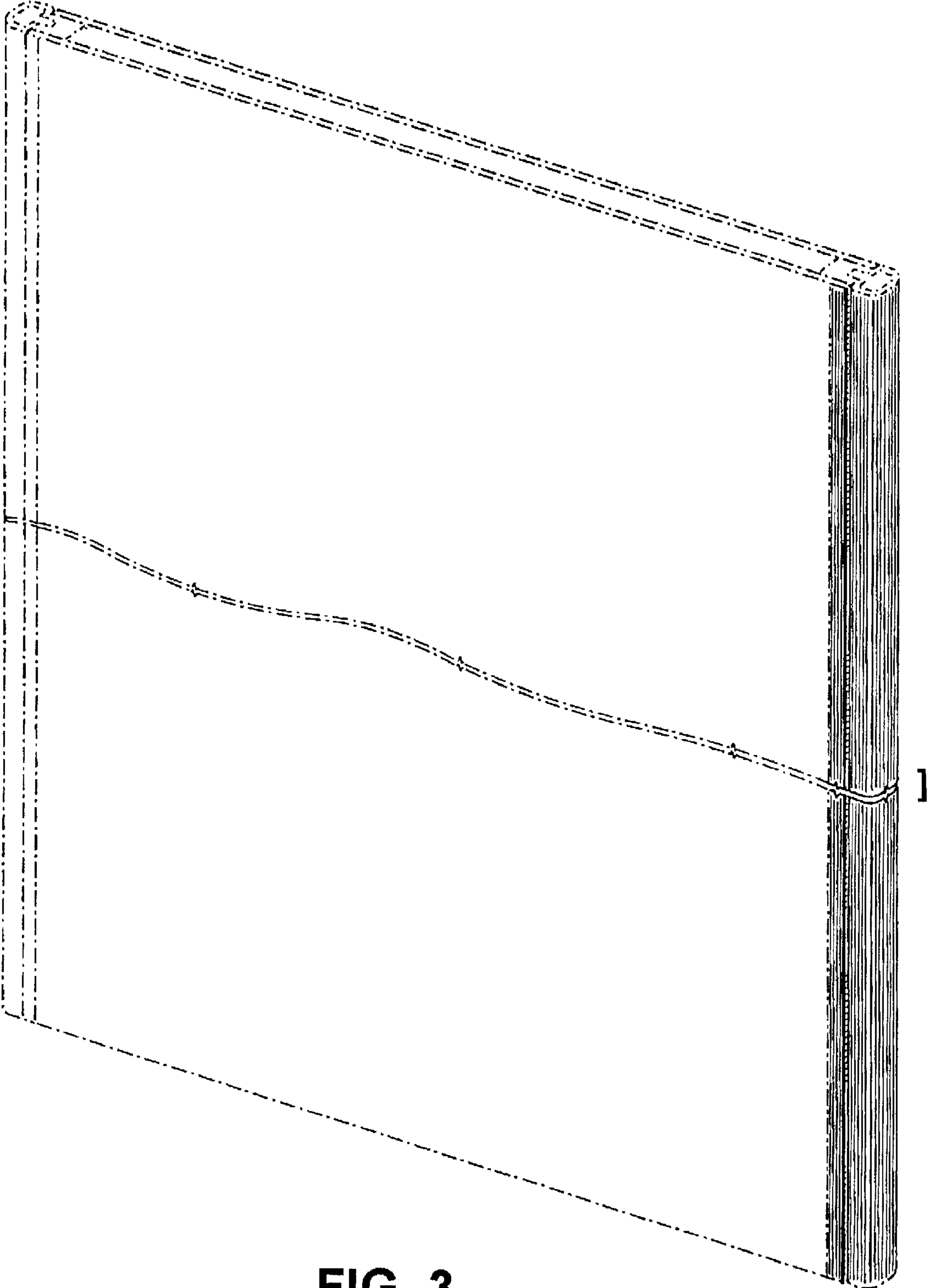

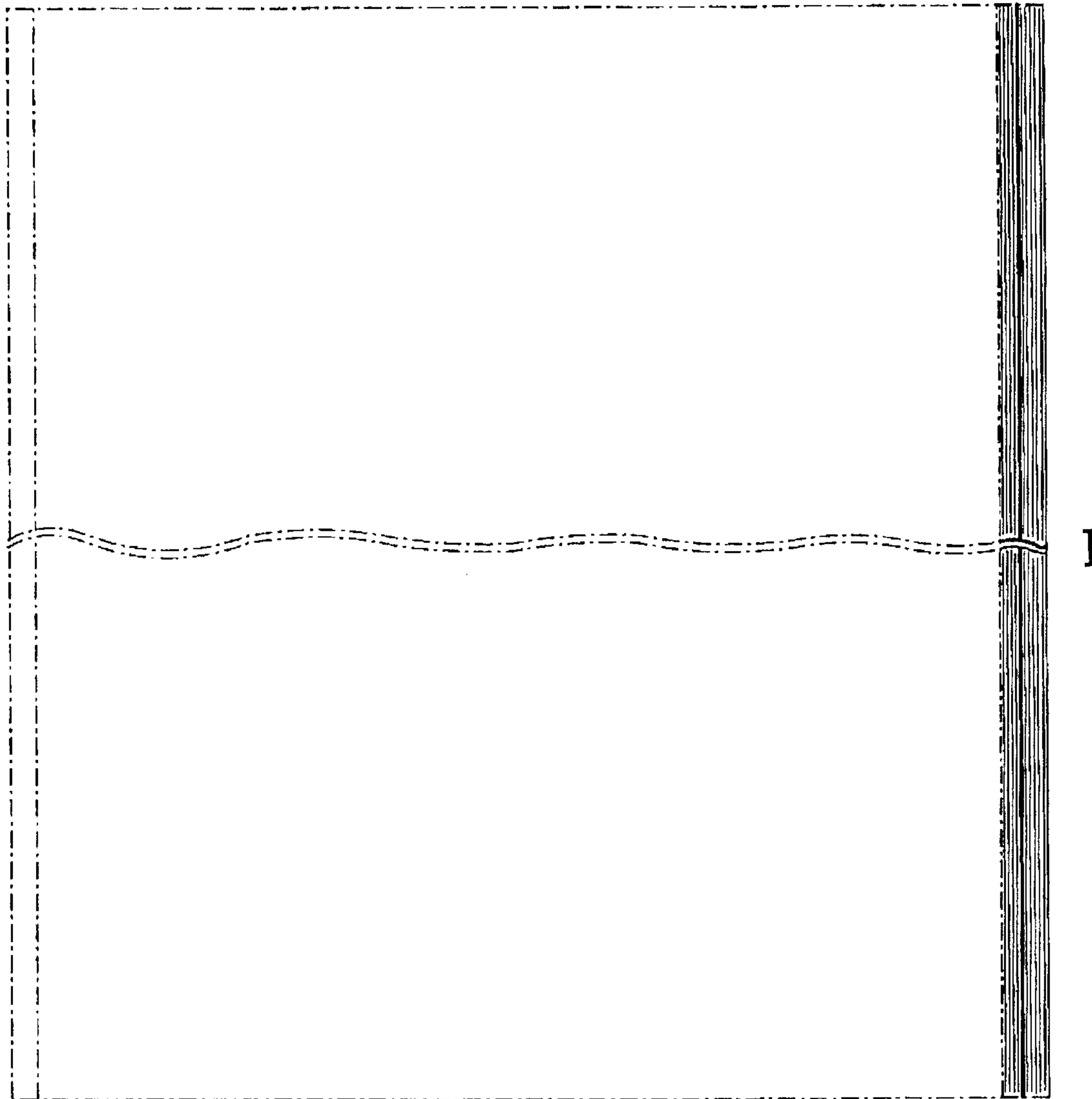
