(57) **CLAIM**

The ornamental design for a combined razor handle and cradle, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of my new design for a “combined razor handle and cradle”;

FIG. 2 is a bottom view of the razor handle and cradle of FIG. 1;

FIG. 3 is a side elevation view of the razor handle and cradle of FIG. 1, the opposite side elevation view being a mirror image of the side shown;

FIG. 4 is a top plan view of the razor handle and cradle of FIG. 1;

FIG. 5 is a front elevation view of the razor handle and cradle of FIG. 1; and,

FIG. 6 is a rear elevation view of the razor handle and cradle of FIG. 1.

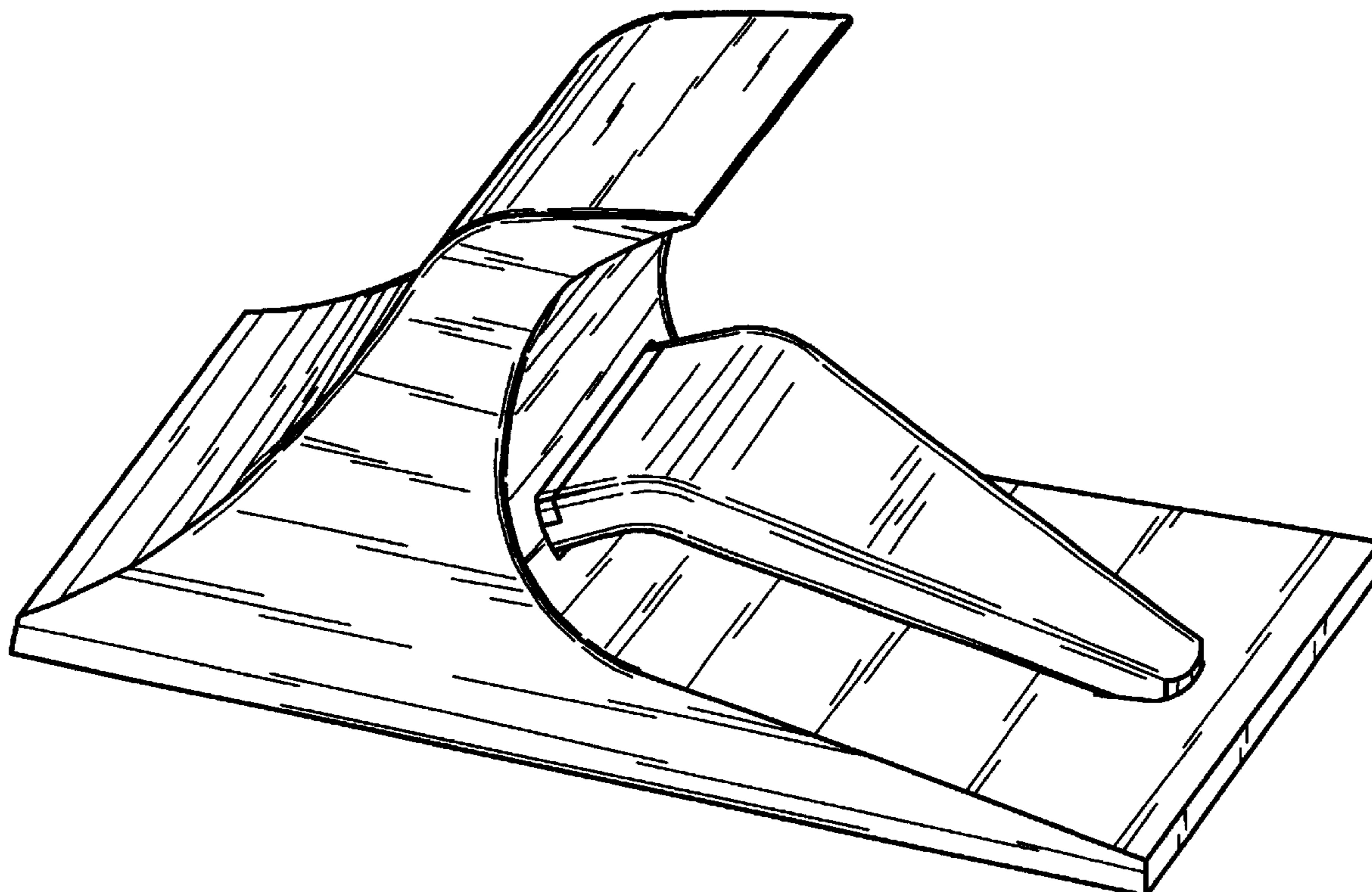

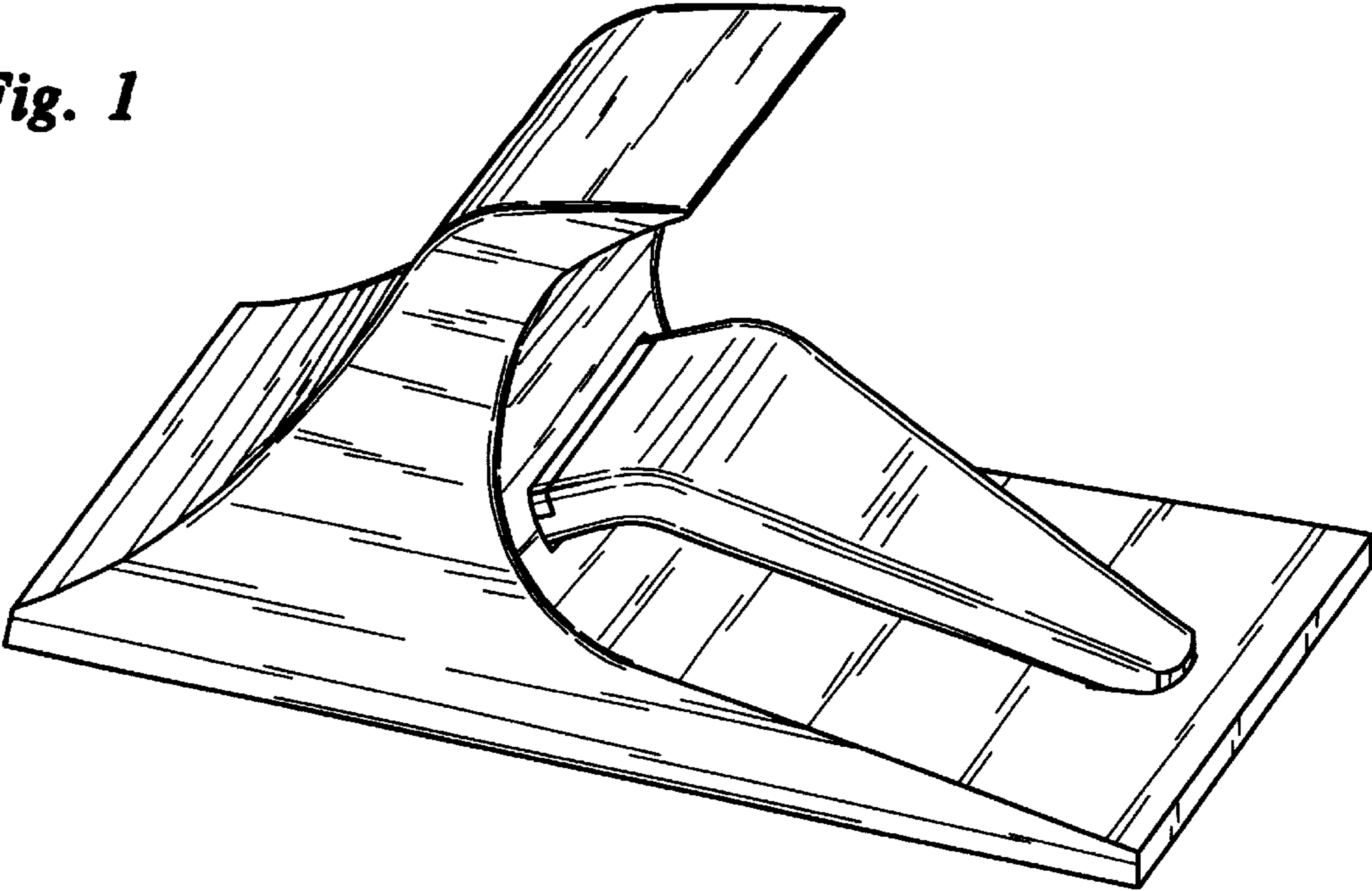

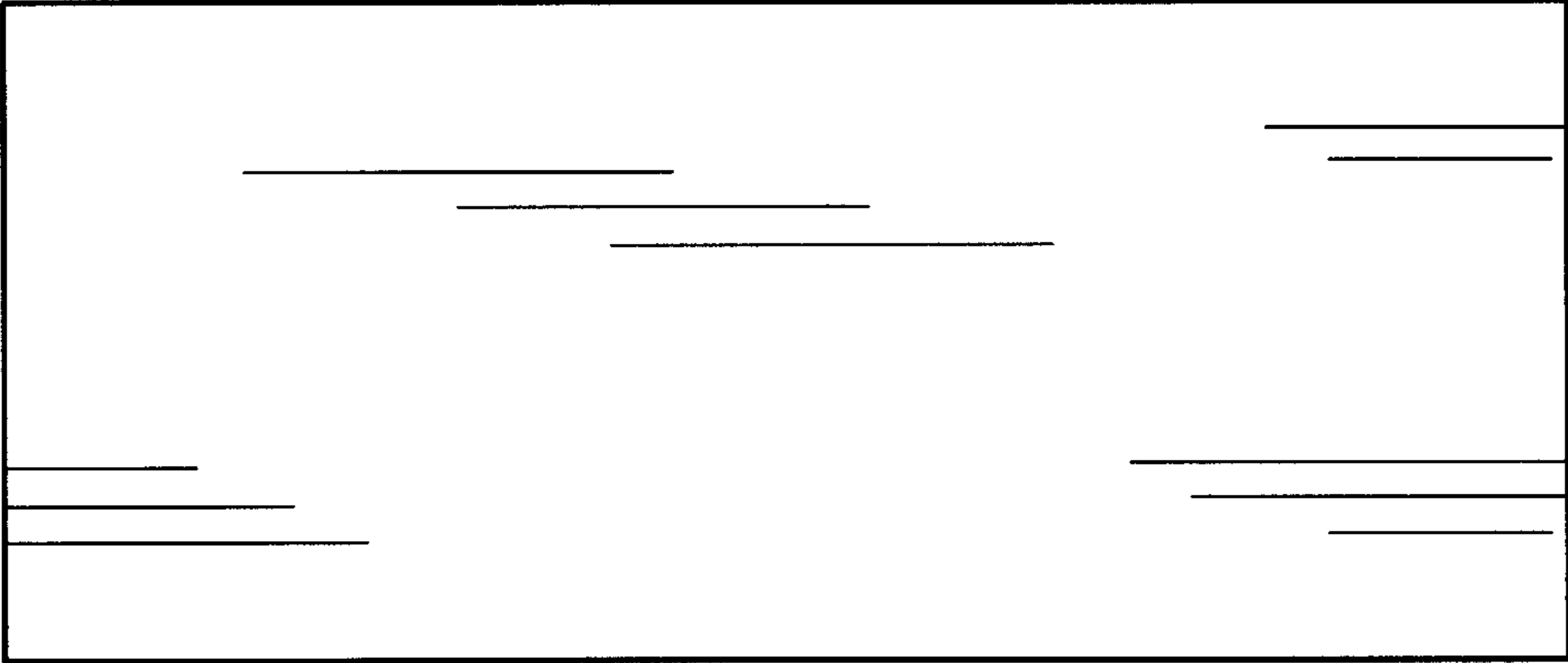

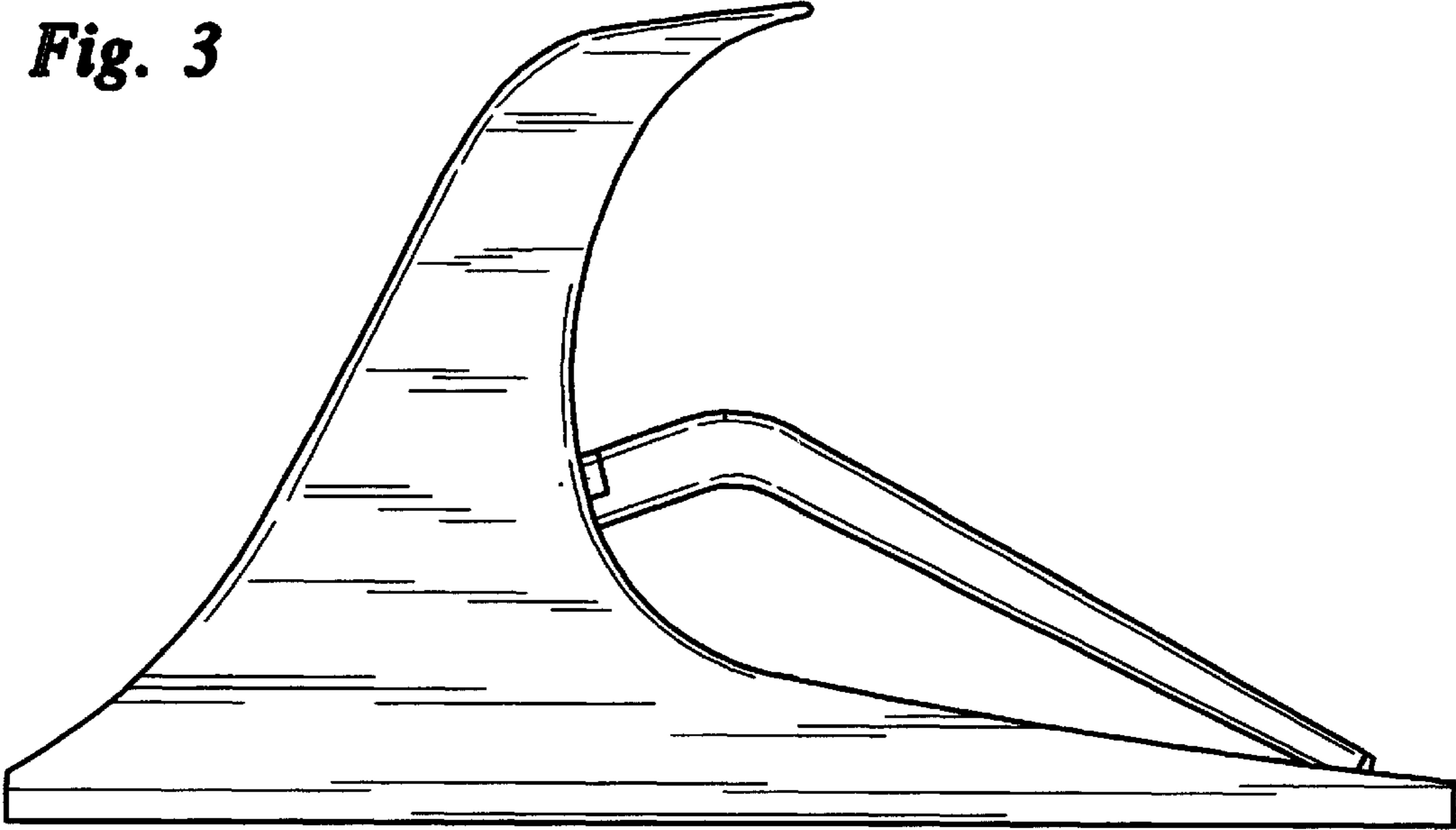

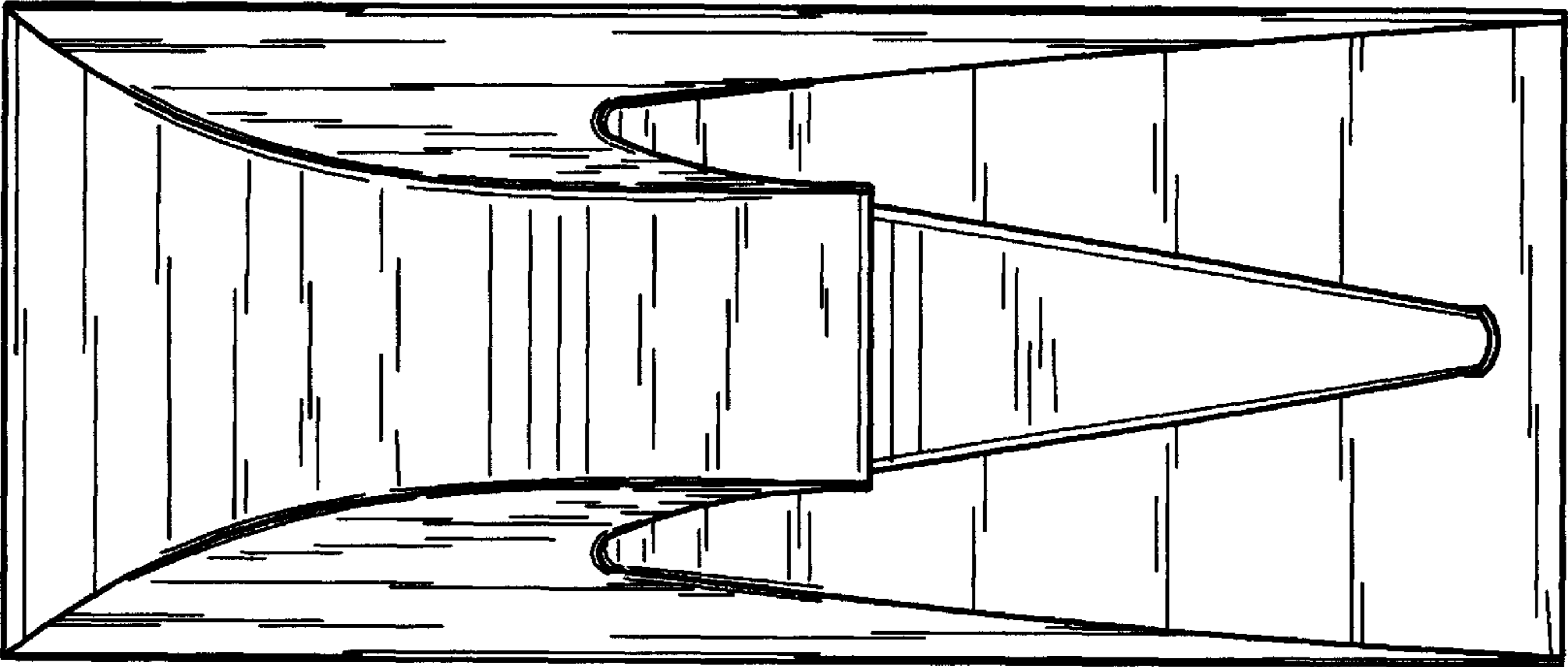

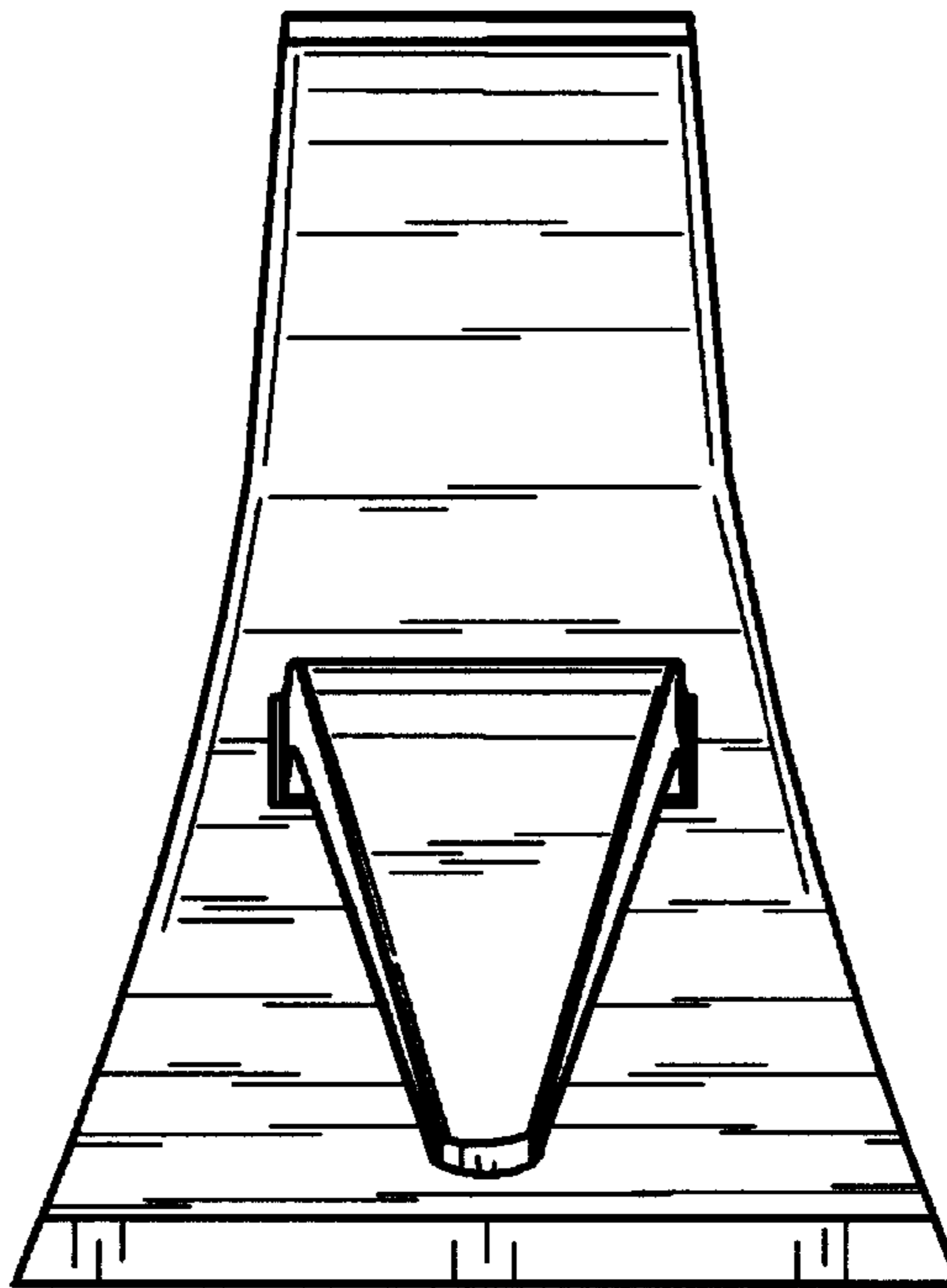
