(57) **CLAIM**

The ornamental design for a chair, substantially as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of the chair as seen from a slightly elevated point to the front and left side.

FIG. 2 is a front view of the chair.

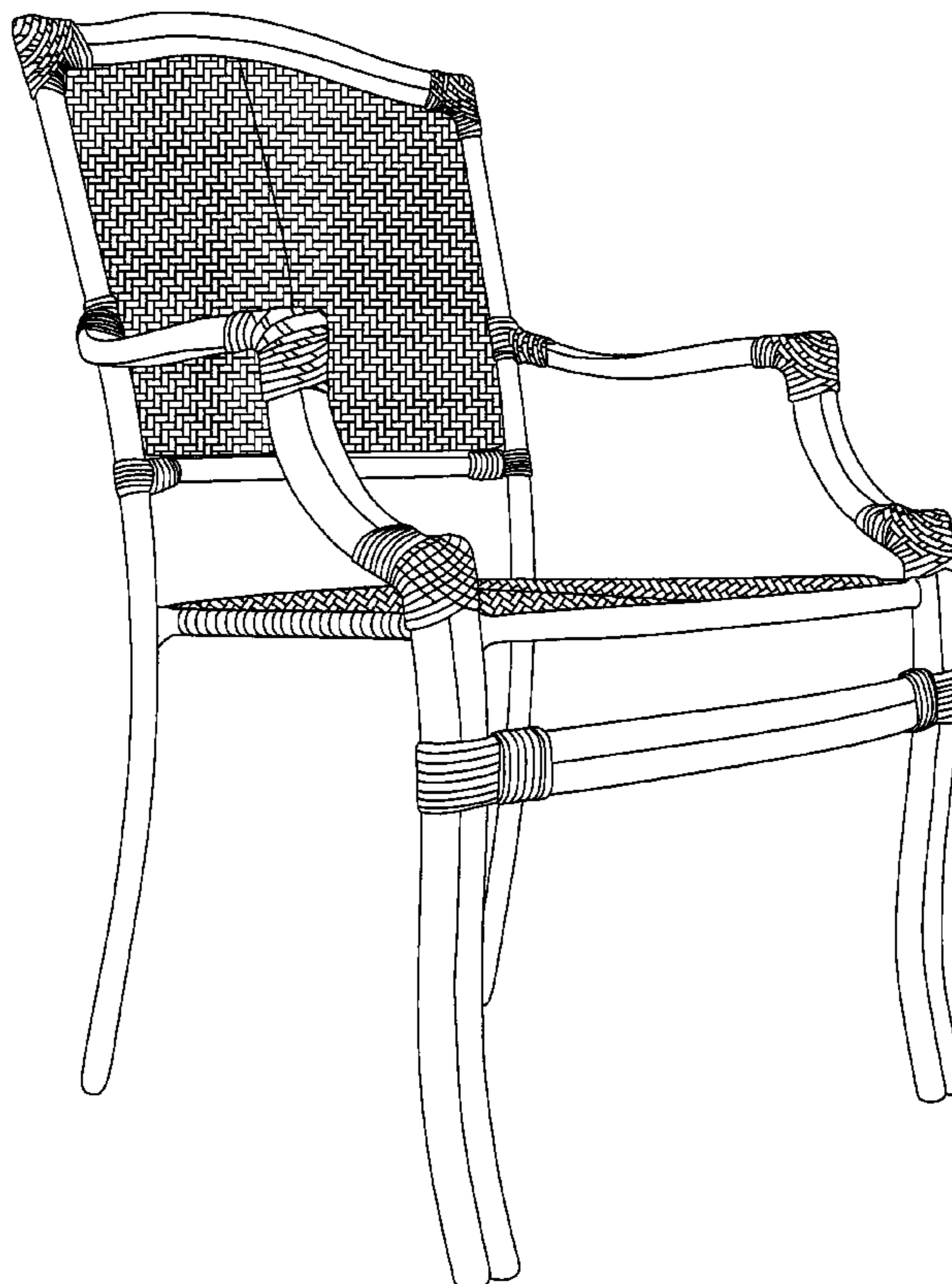
FIG. 3 is a rear view of the chair.

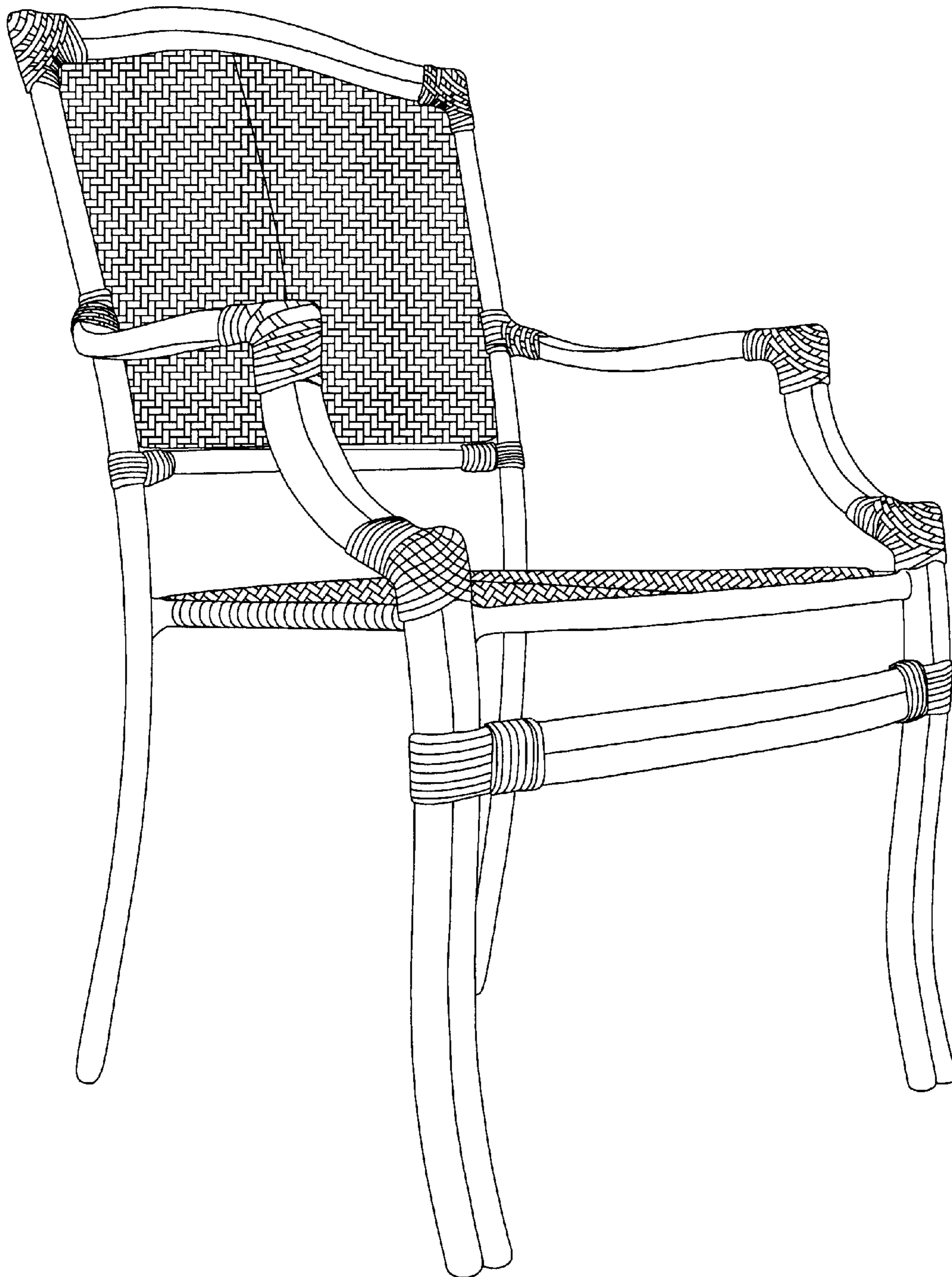

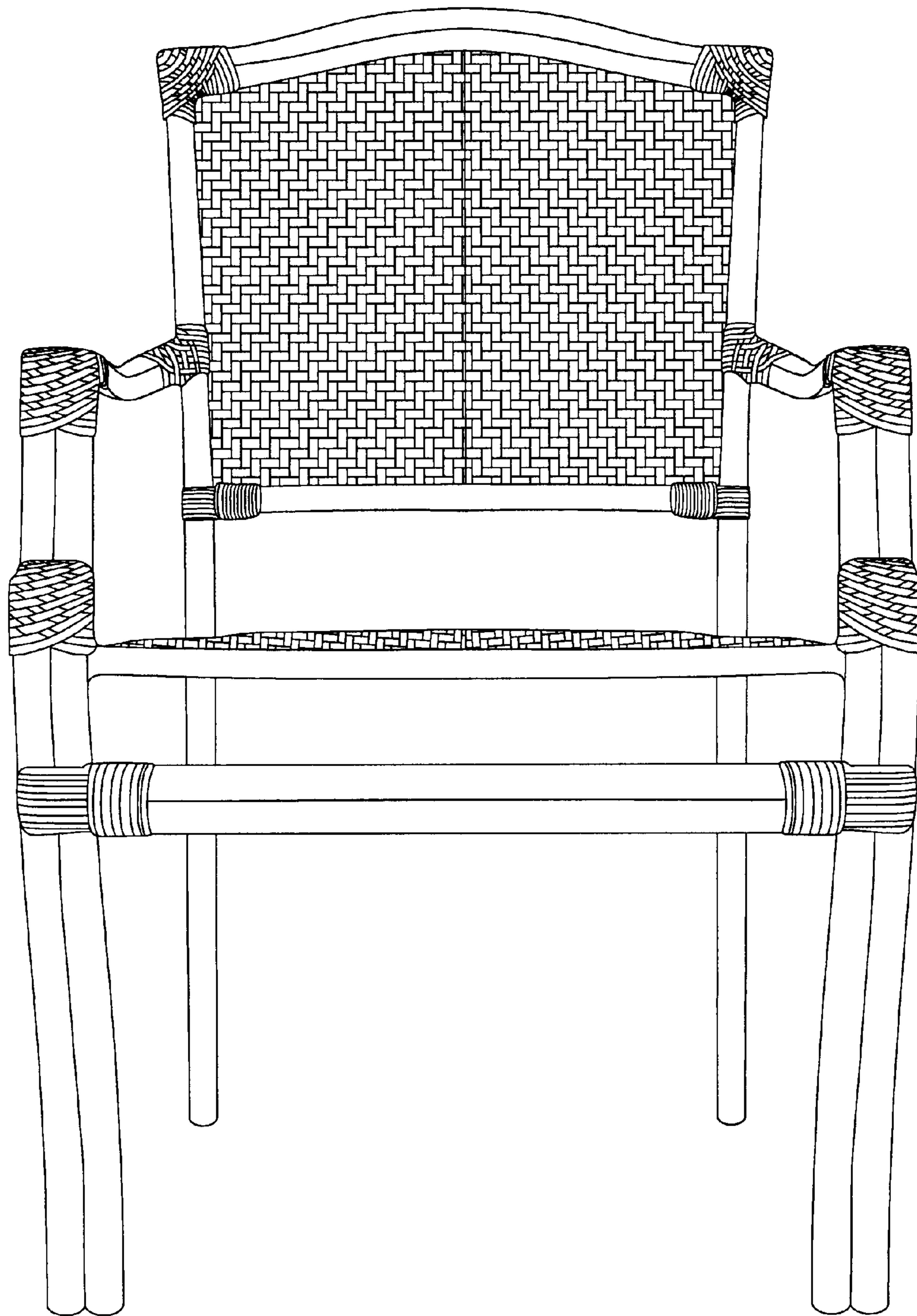

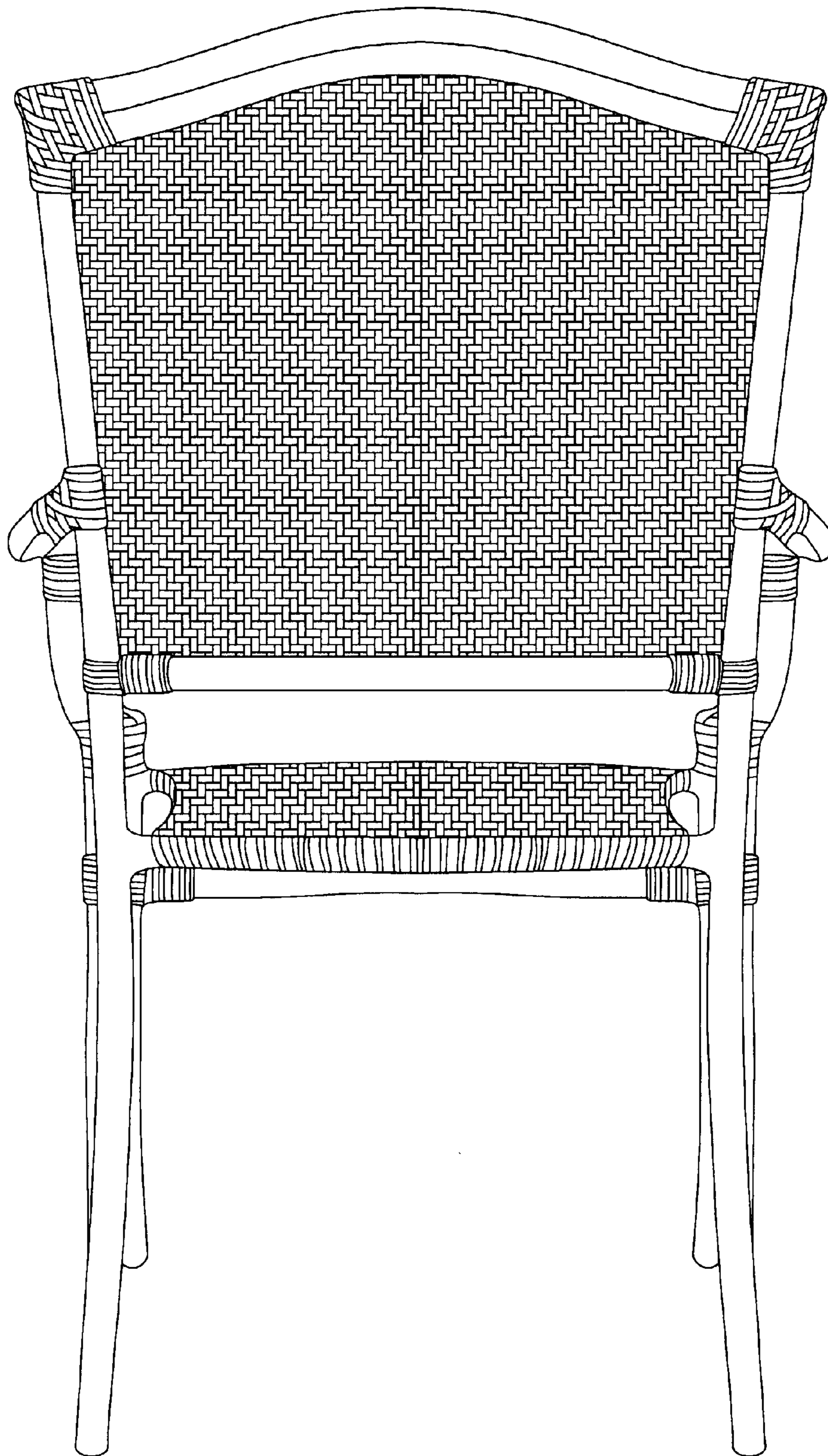

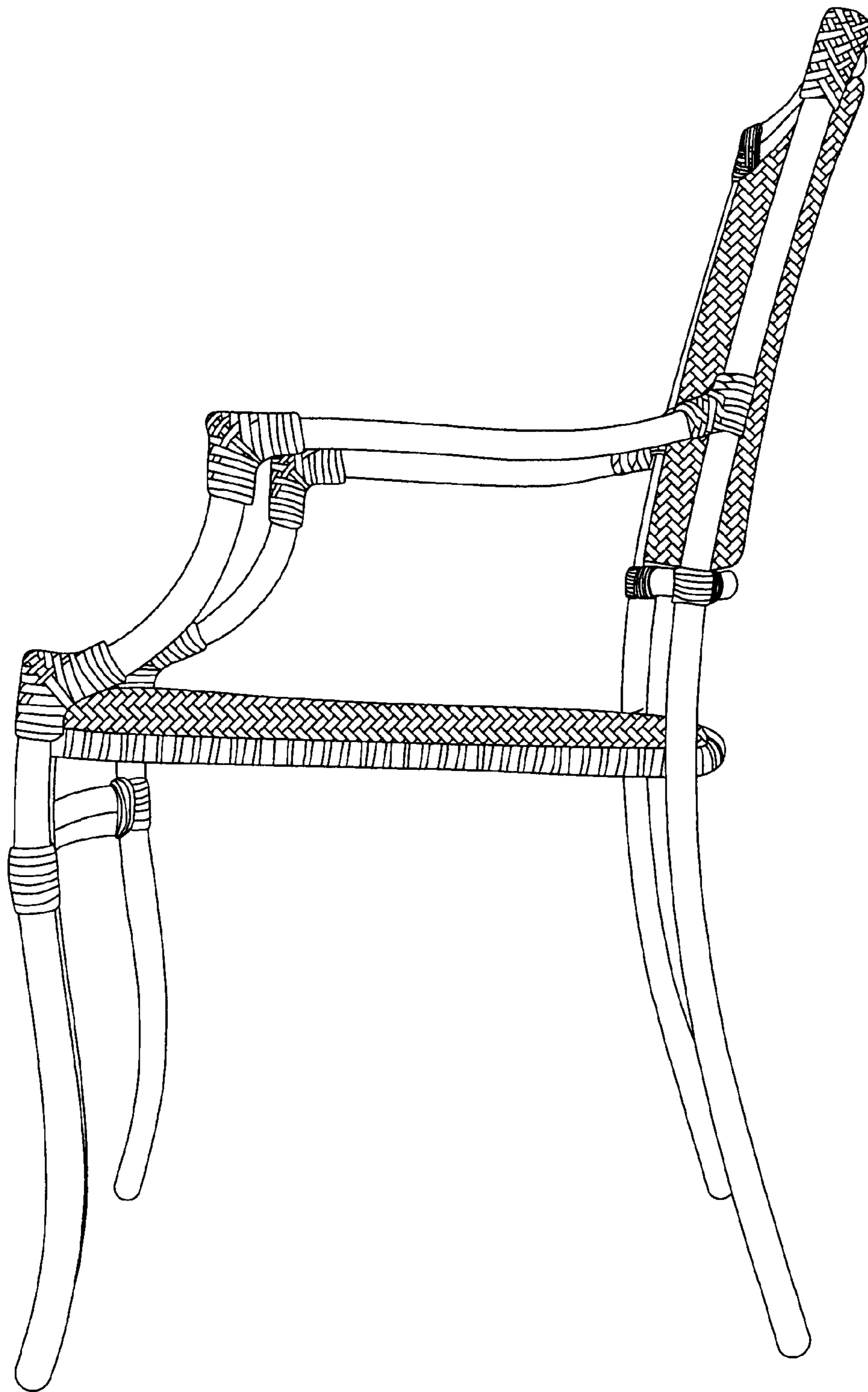

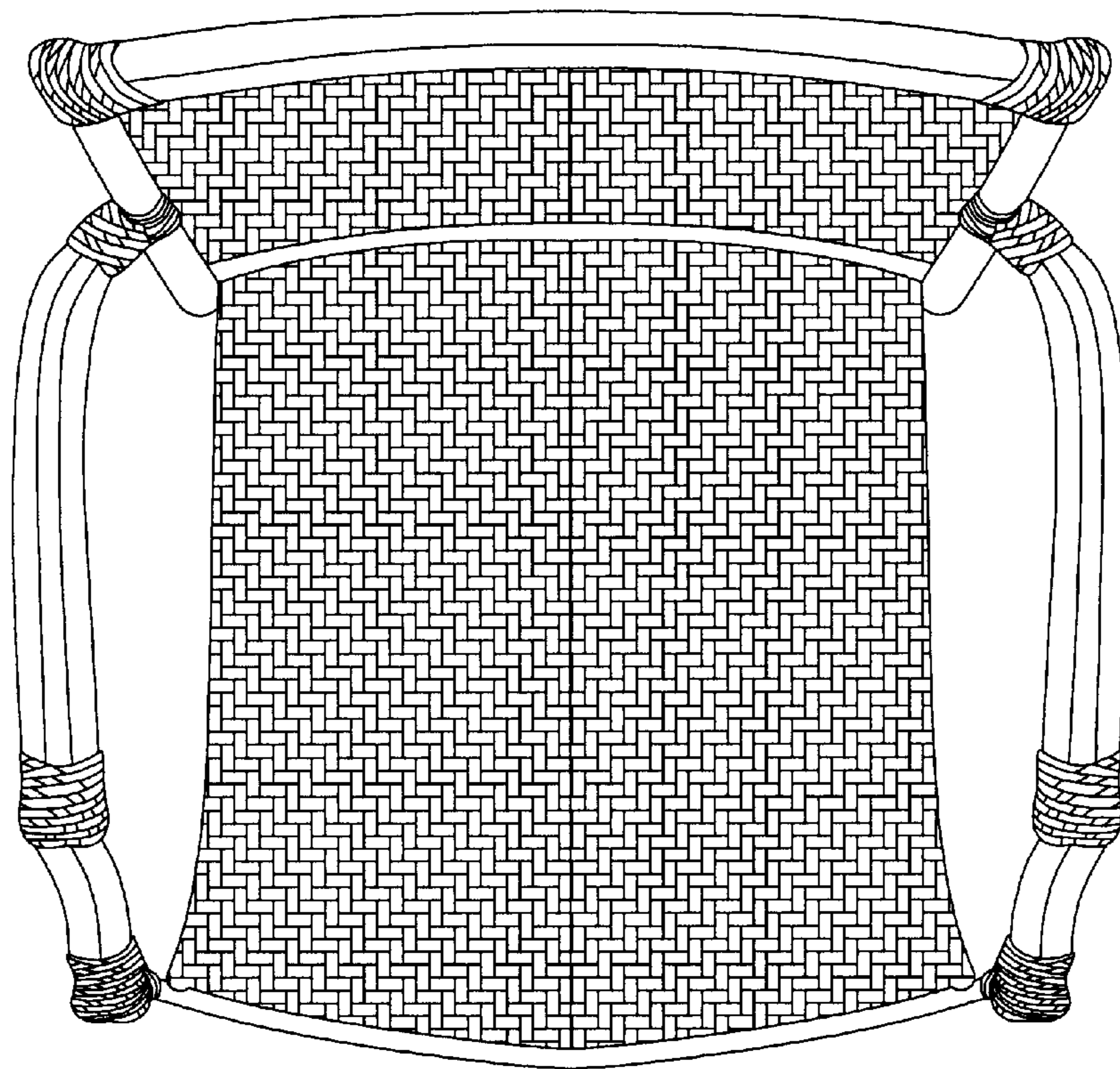
