DESCRIPTION

FIG. 1 is a perspective view of a container holder showing my new design supporting a flower pot shown in broken lines.

FIG. 2 is a front elevational view thereof.

FIG. 3 is a rear elevational view thereof.

FIG. 4 is a side elevational view thereof.

FIG. 5 is a side elevational view a side opposite that shown in FIG. 4.

FIG. 6 is a top plan view thereof.

FIG. 8 is a perspective view of another embodiment of a container holder showing my new design supporting a flower pot shown in broken lines.

FIG. 9 is a front elevational view thereof.

FIG. 11 is a side elevational view thereof.

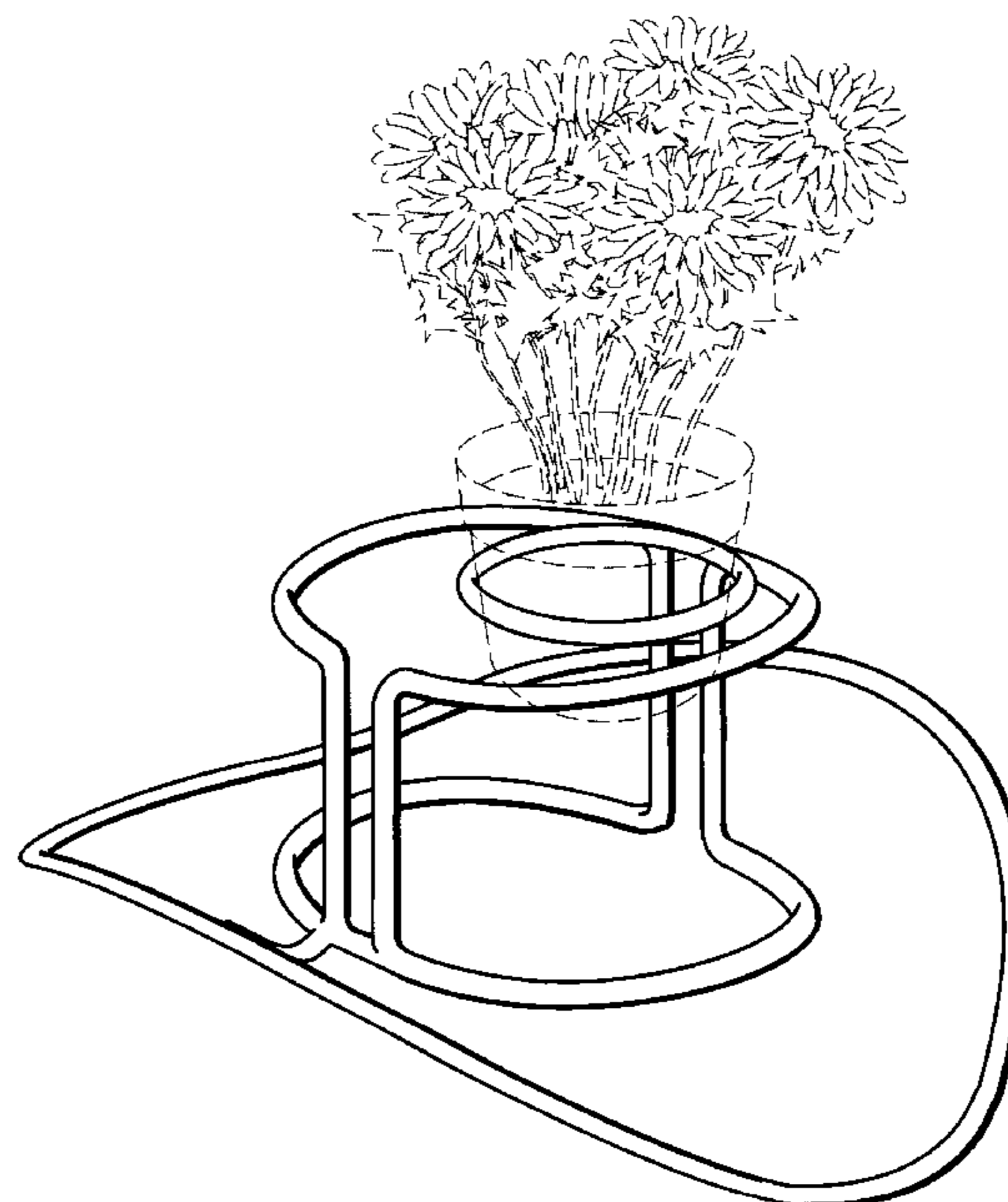
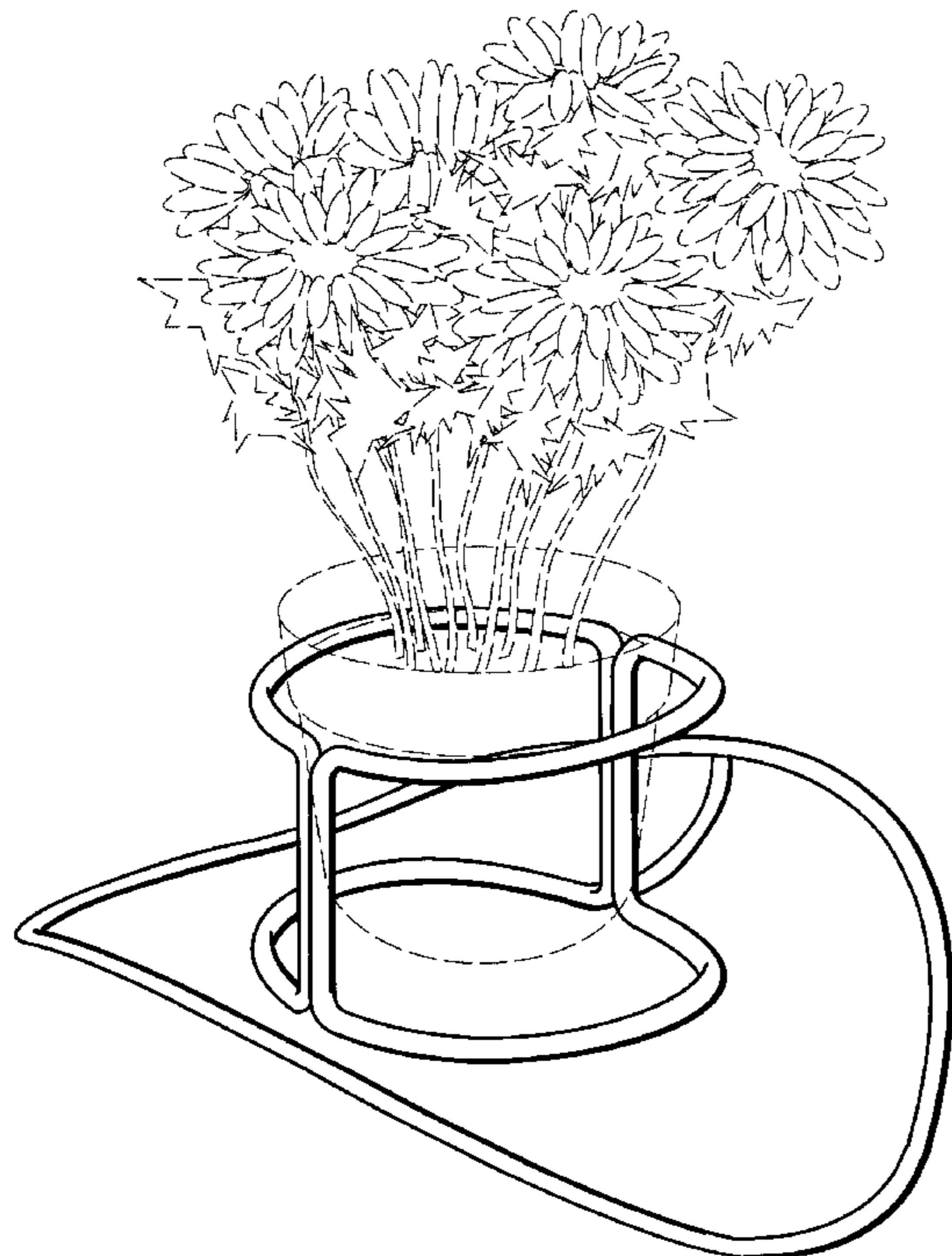
FIG. 12 is a side elevational view of a side opposite that shown in FIG. 11.

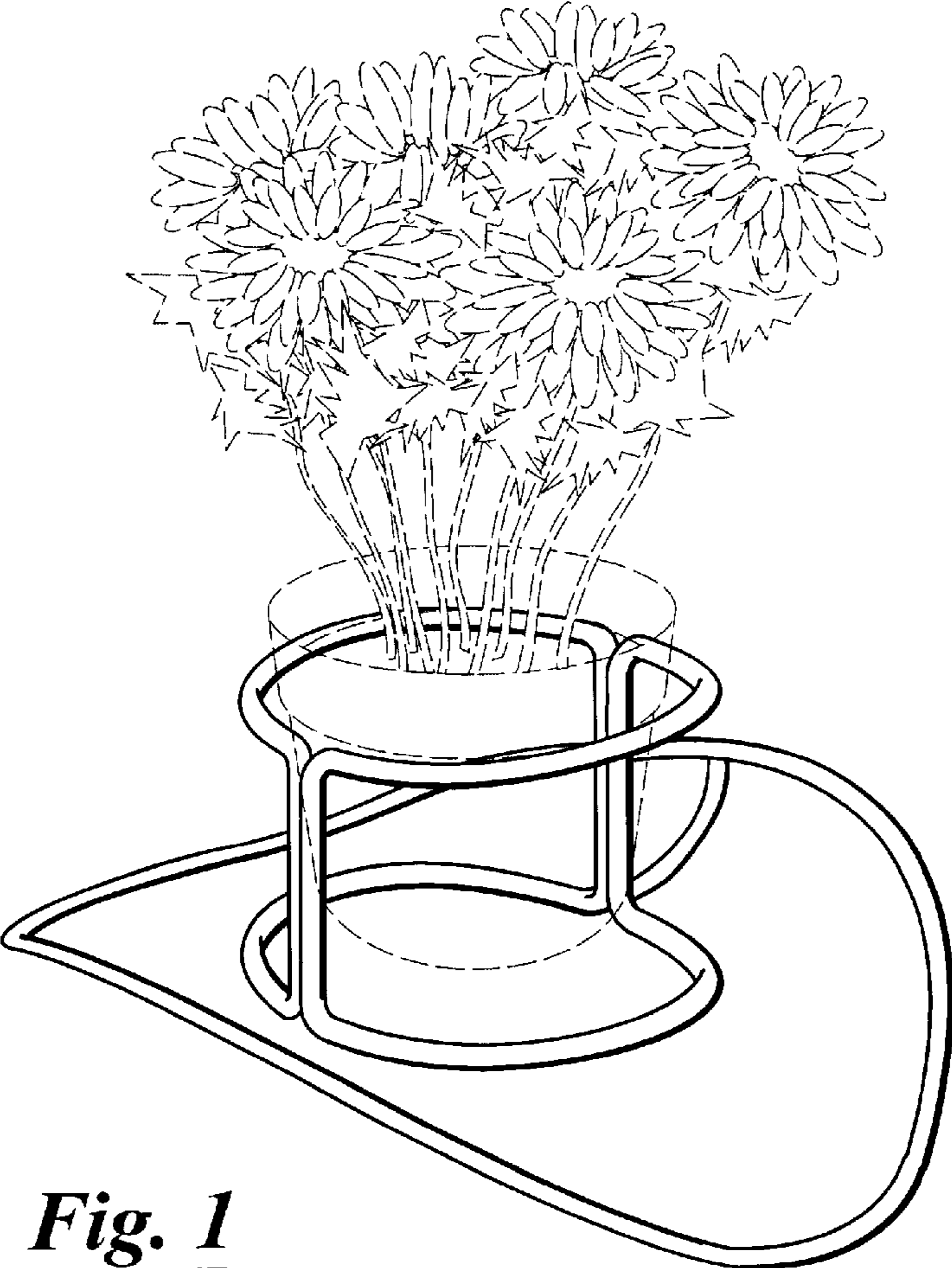

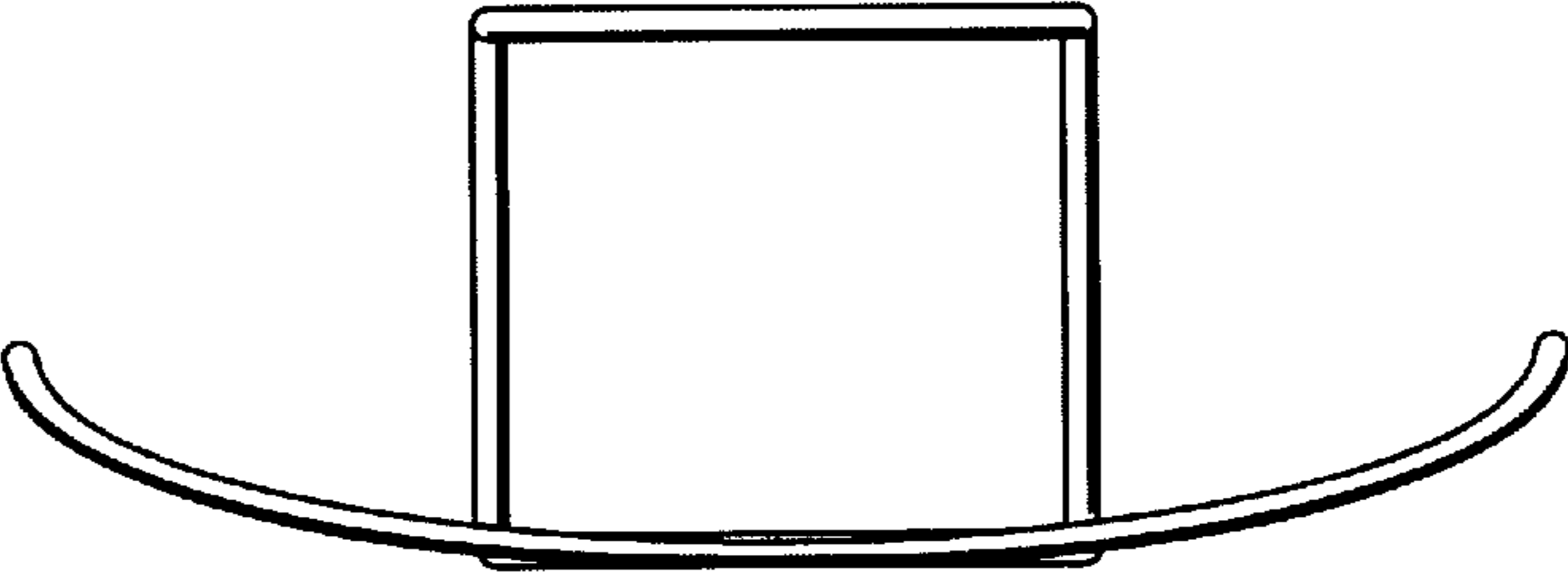

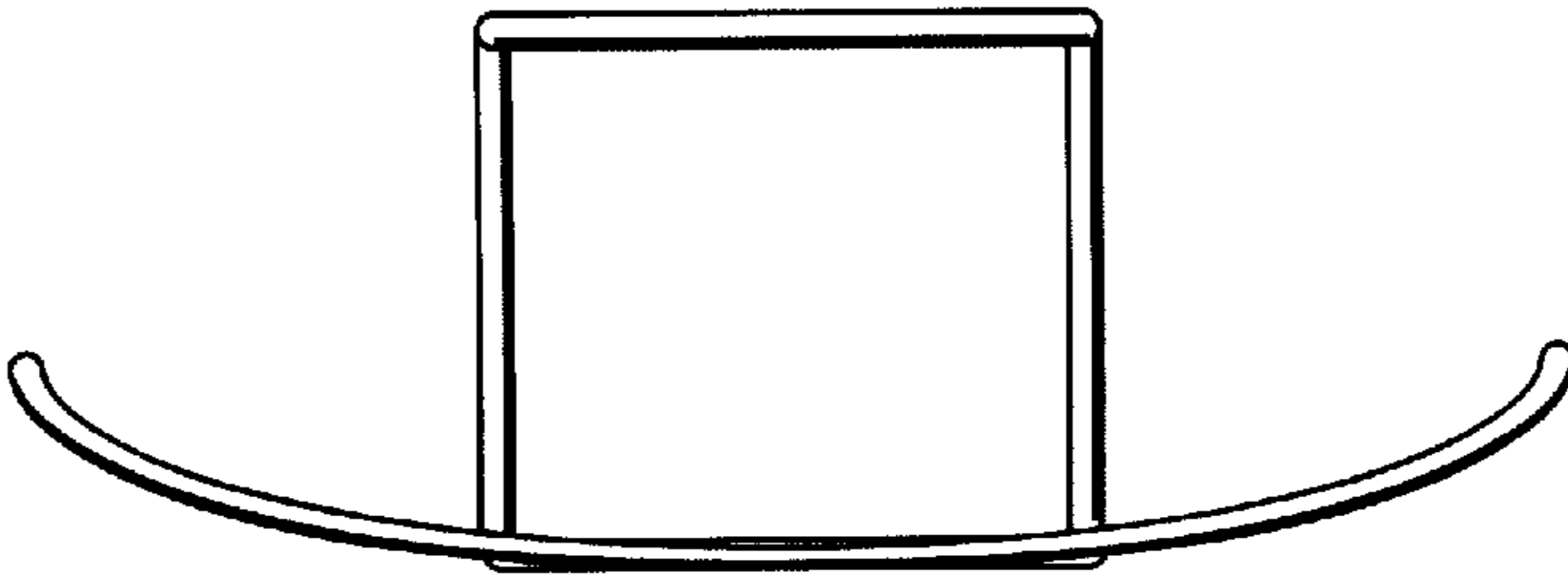

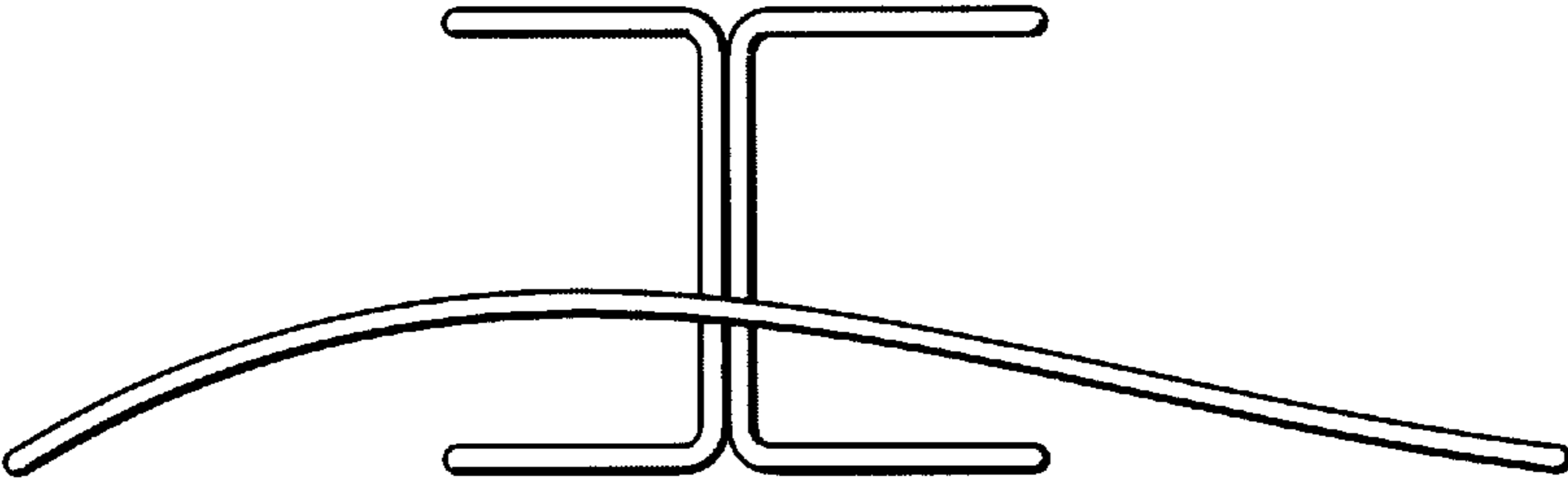

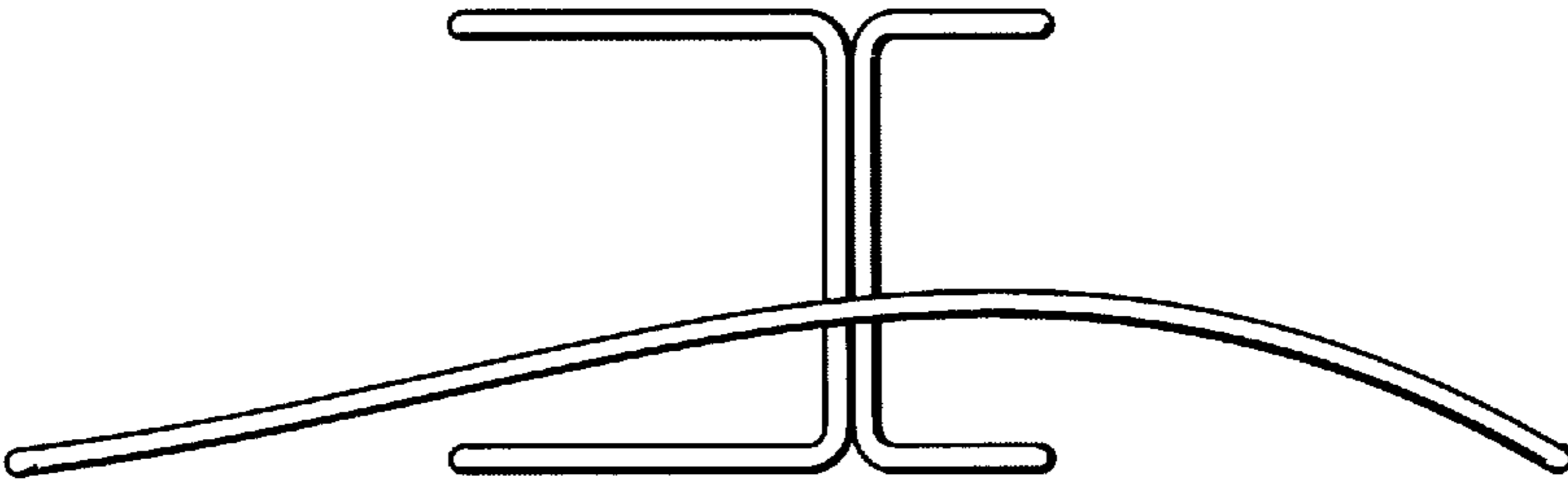

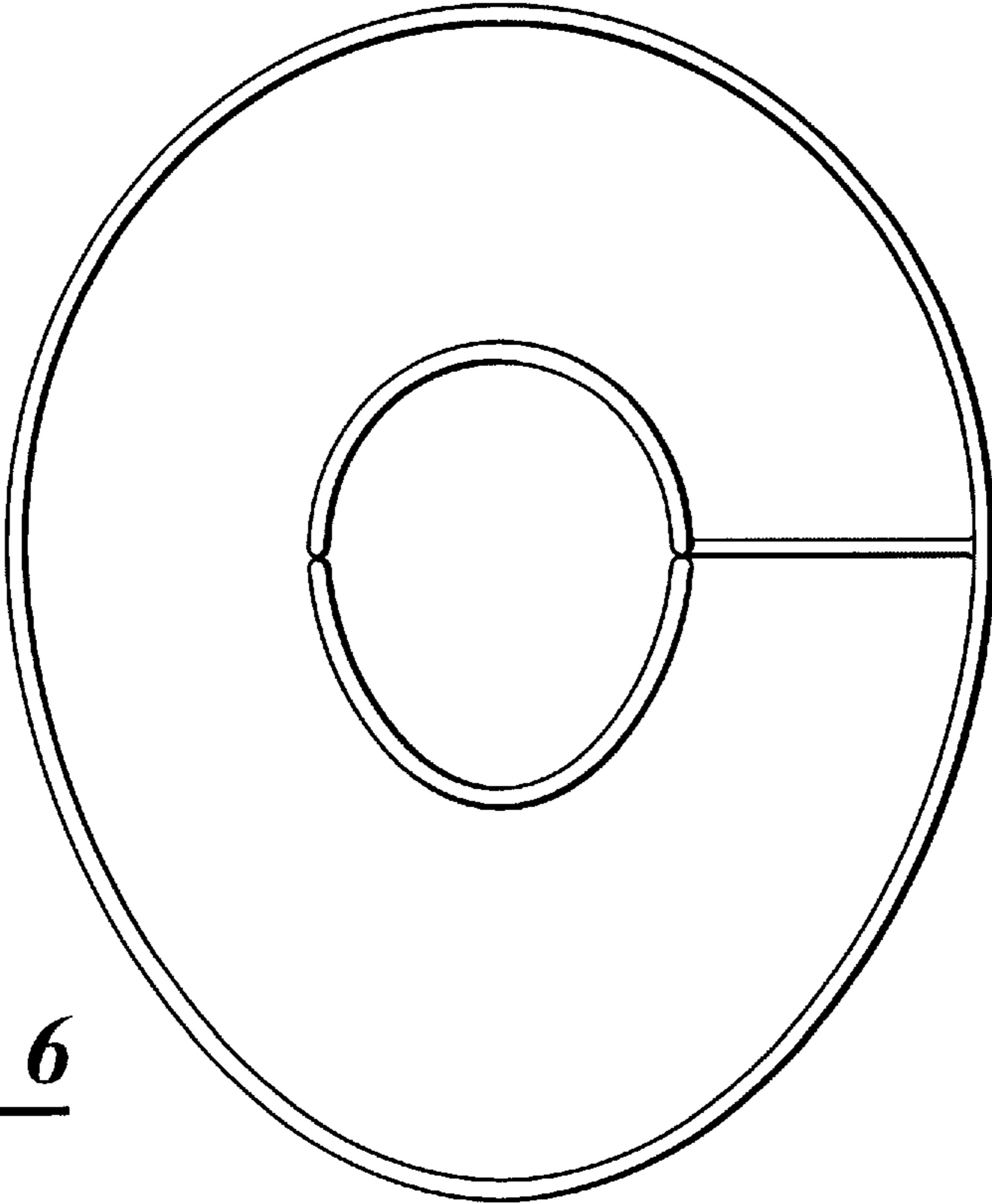

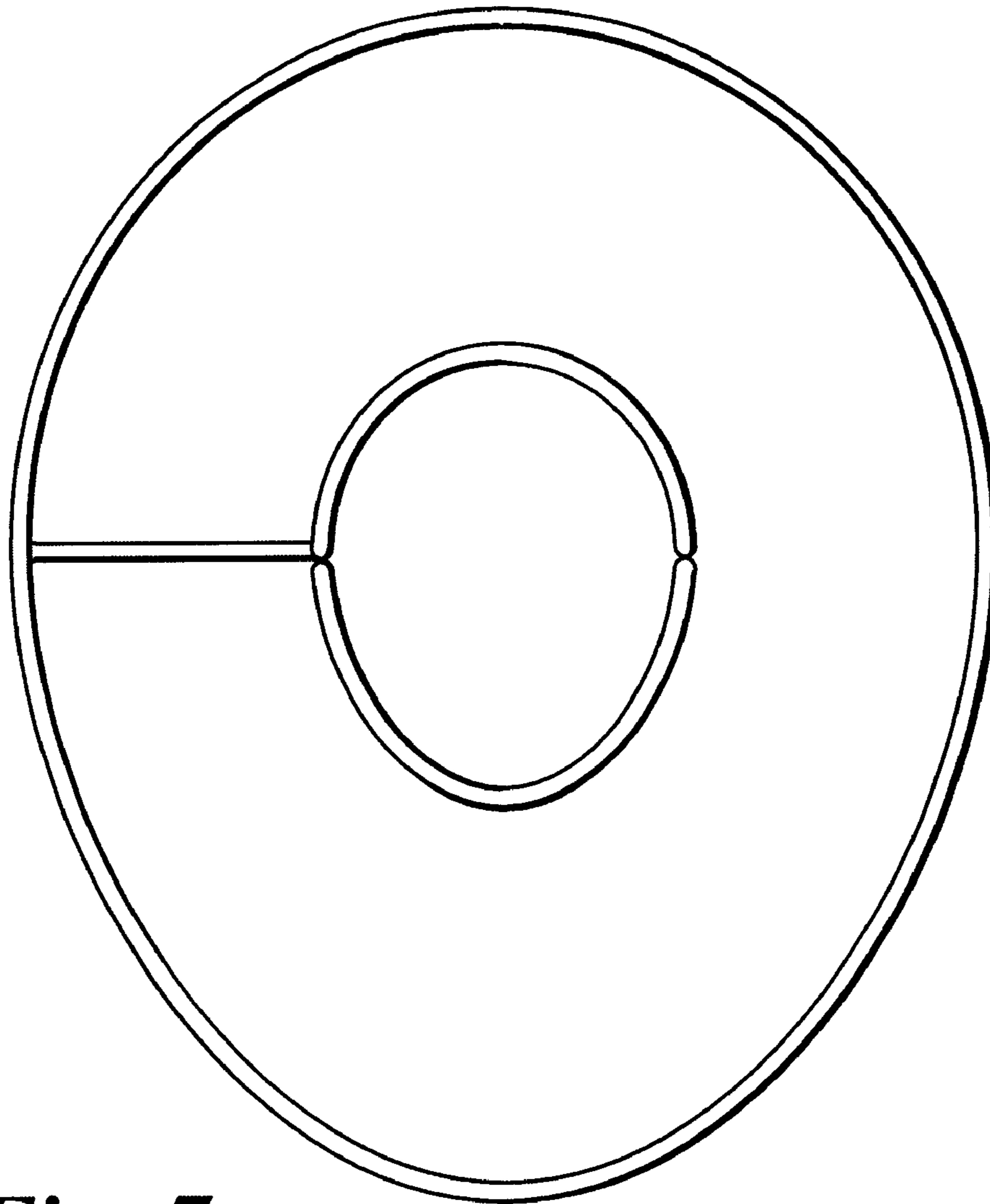

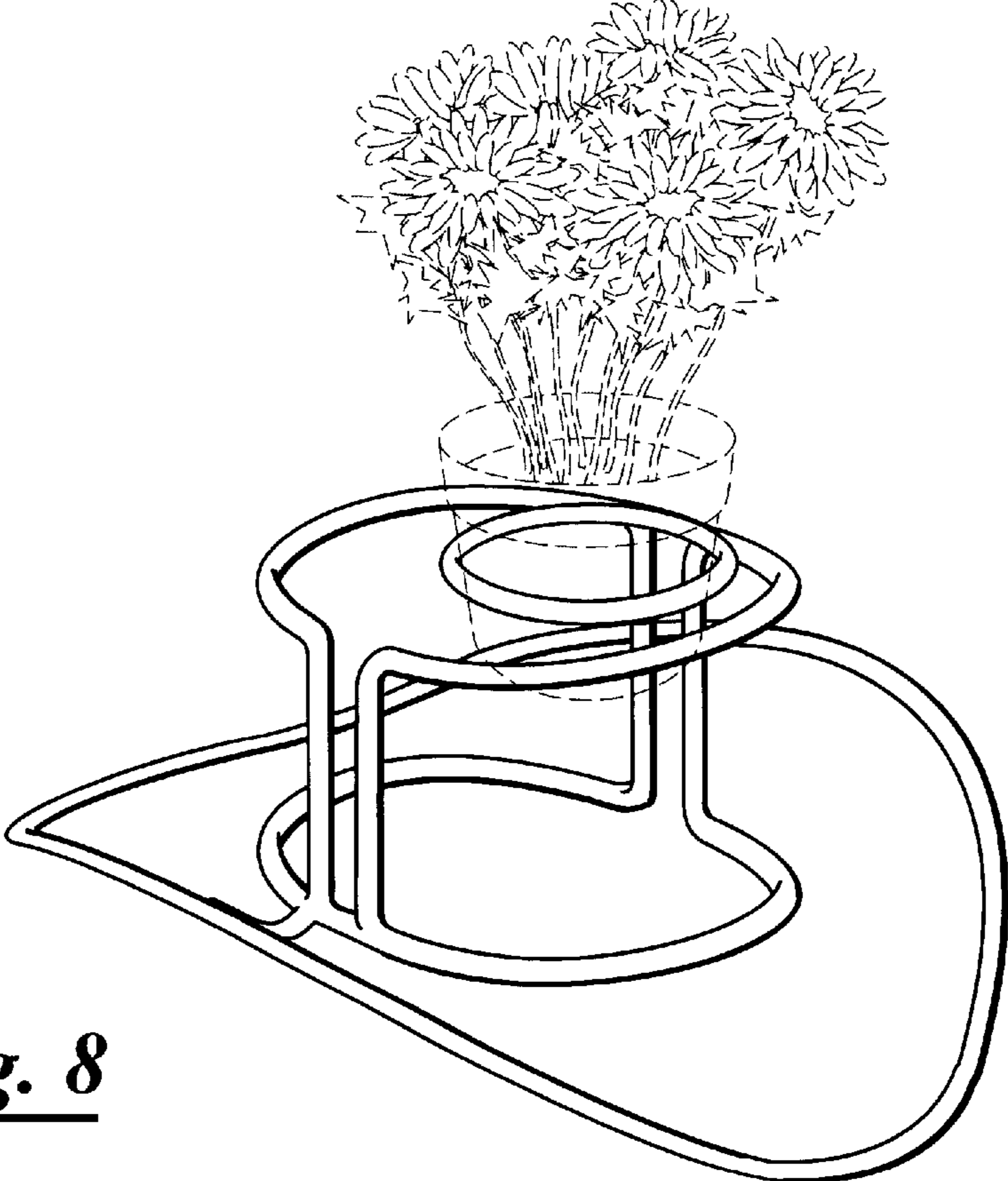

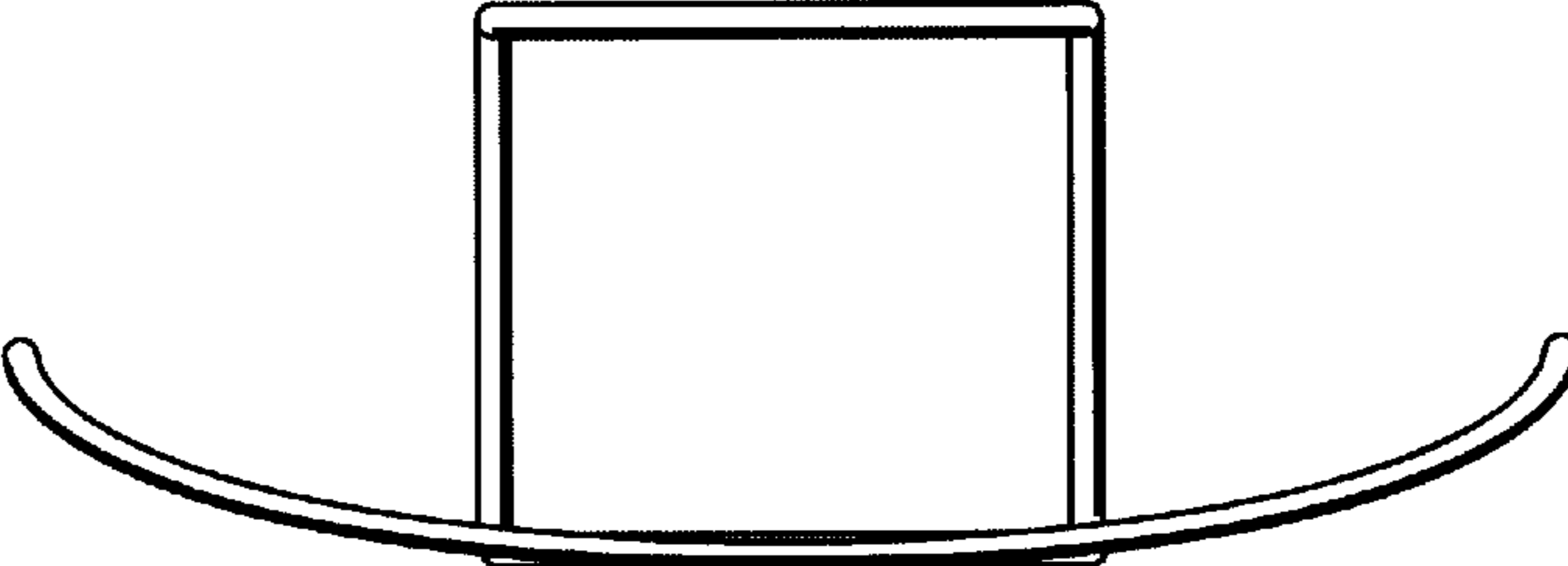

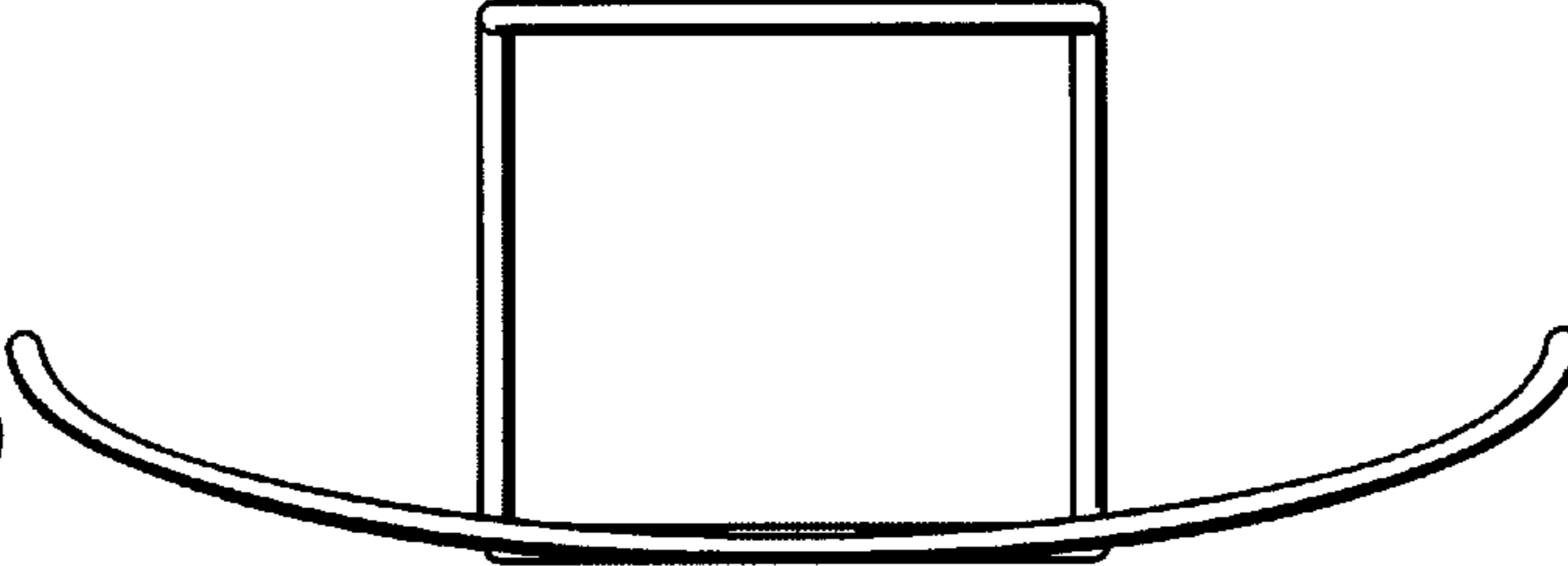

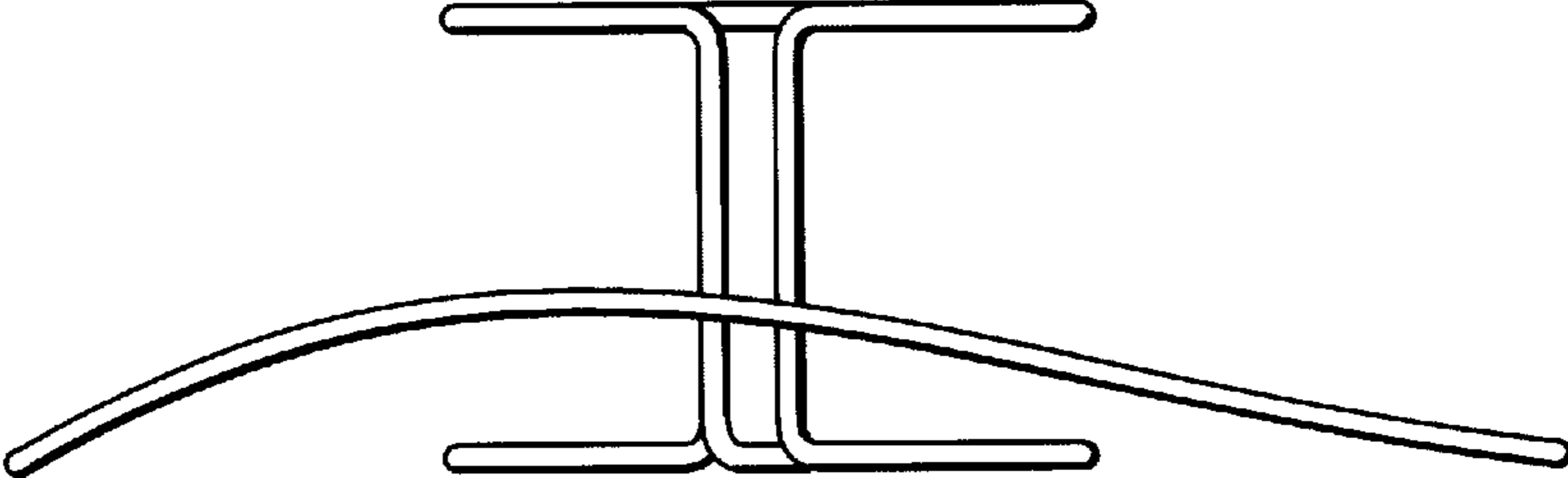

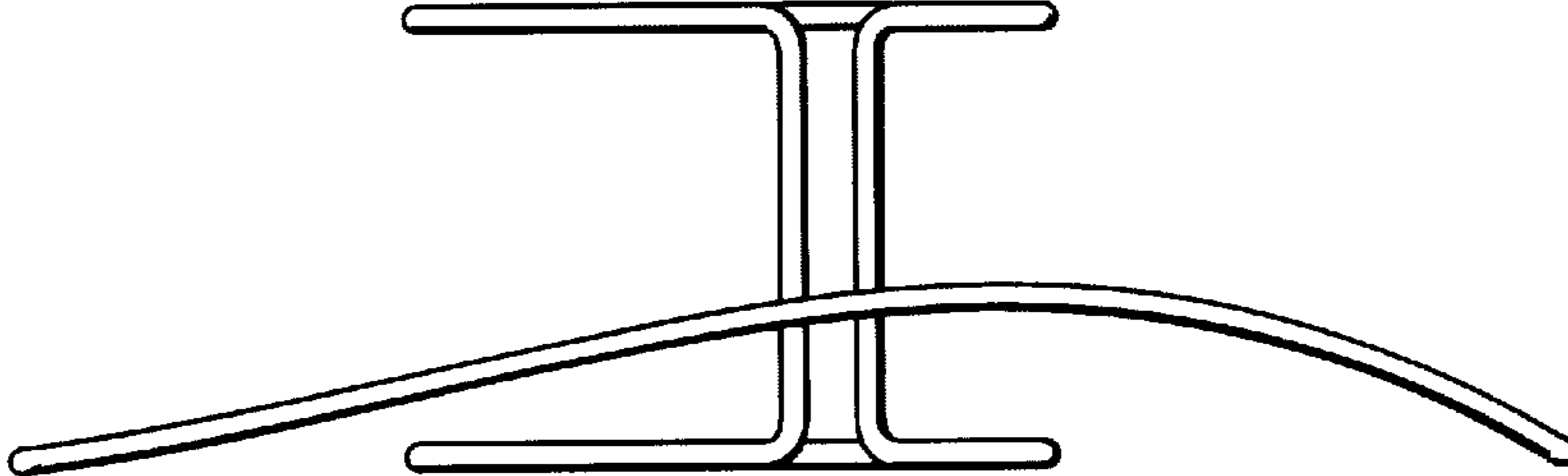

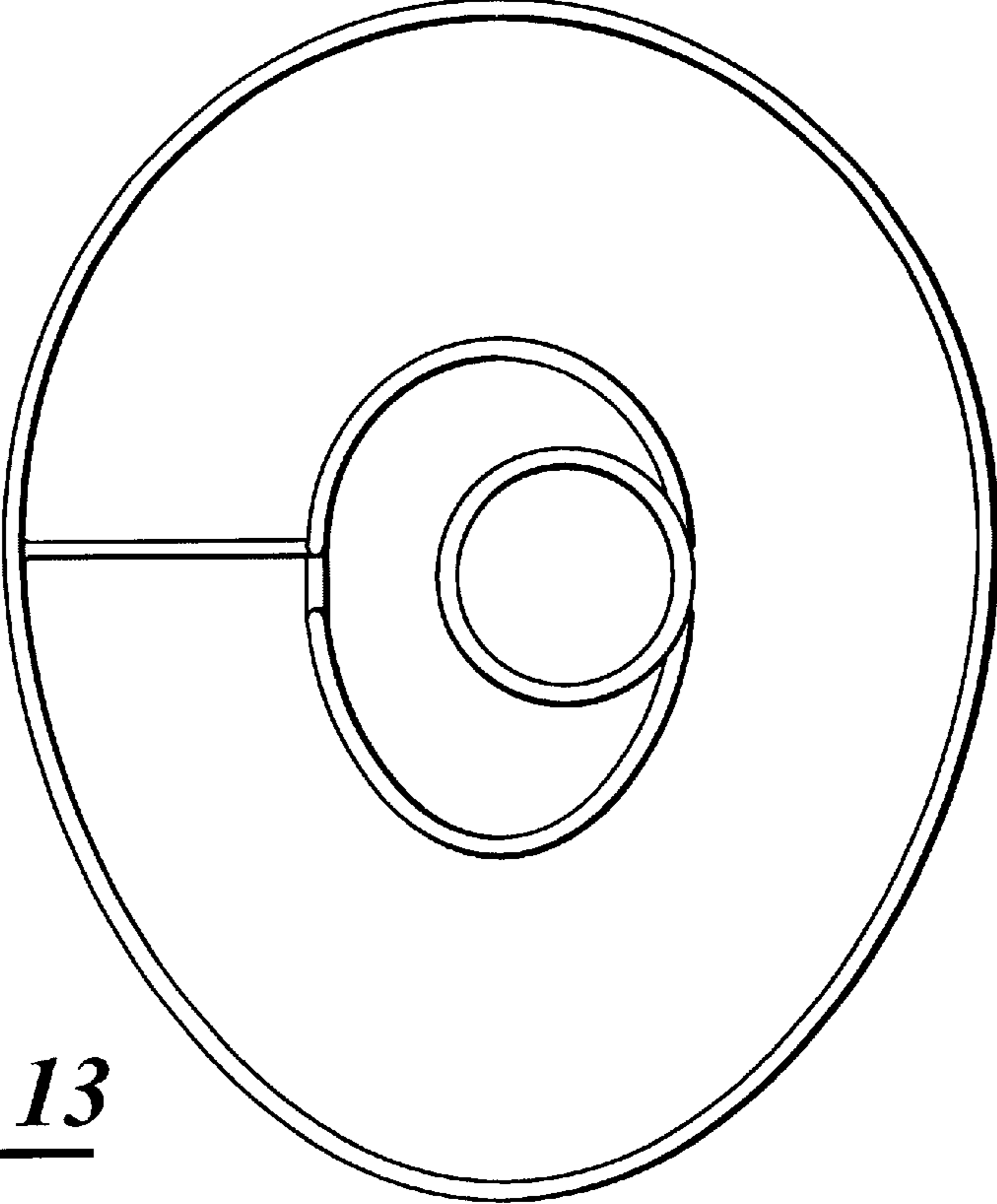

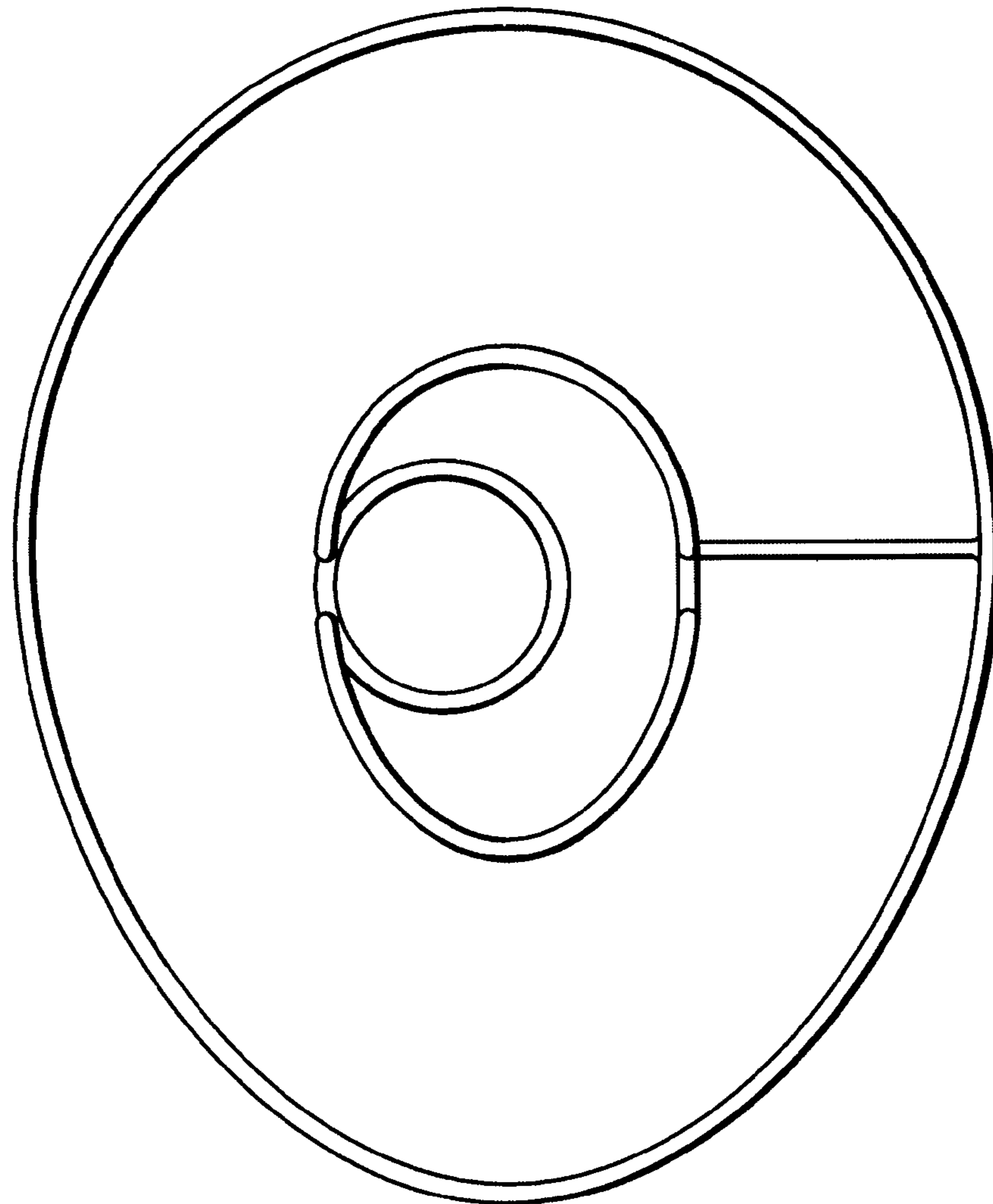
