DESCRIPTION

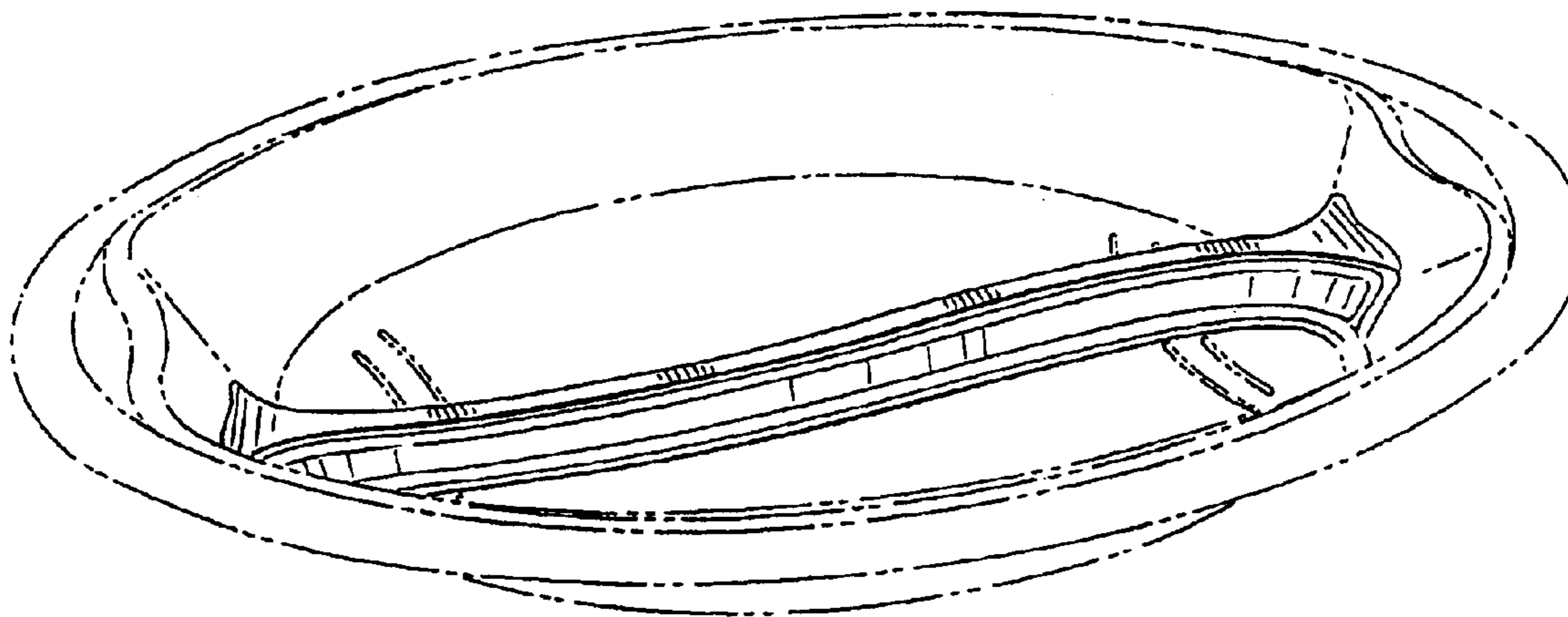
FIG. 1 is a top perspective view of a disposable plate showing our new design;
 FIG. 2 is a top pan view thereof;
 FIG. 3 is a left side elevation thereof;
 FIG. 4 is a right side elevation thereof;

 FIG. 6 is a top plan view of modified embodiment of the design shown in FIGS. 1 through 5, the other views thereof being mirror images of FIGS. 1 through 5.

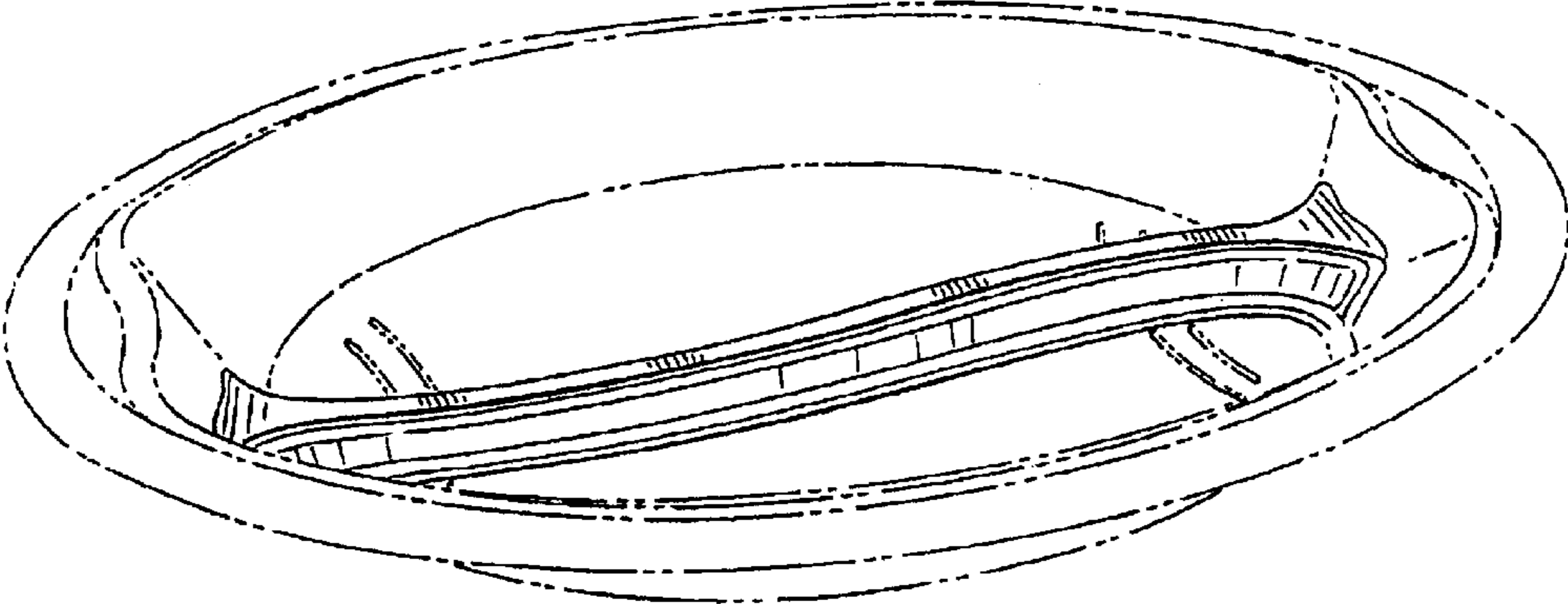

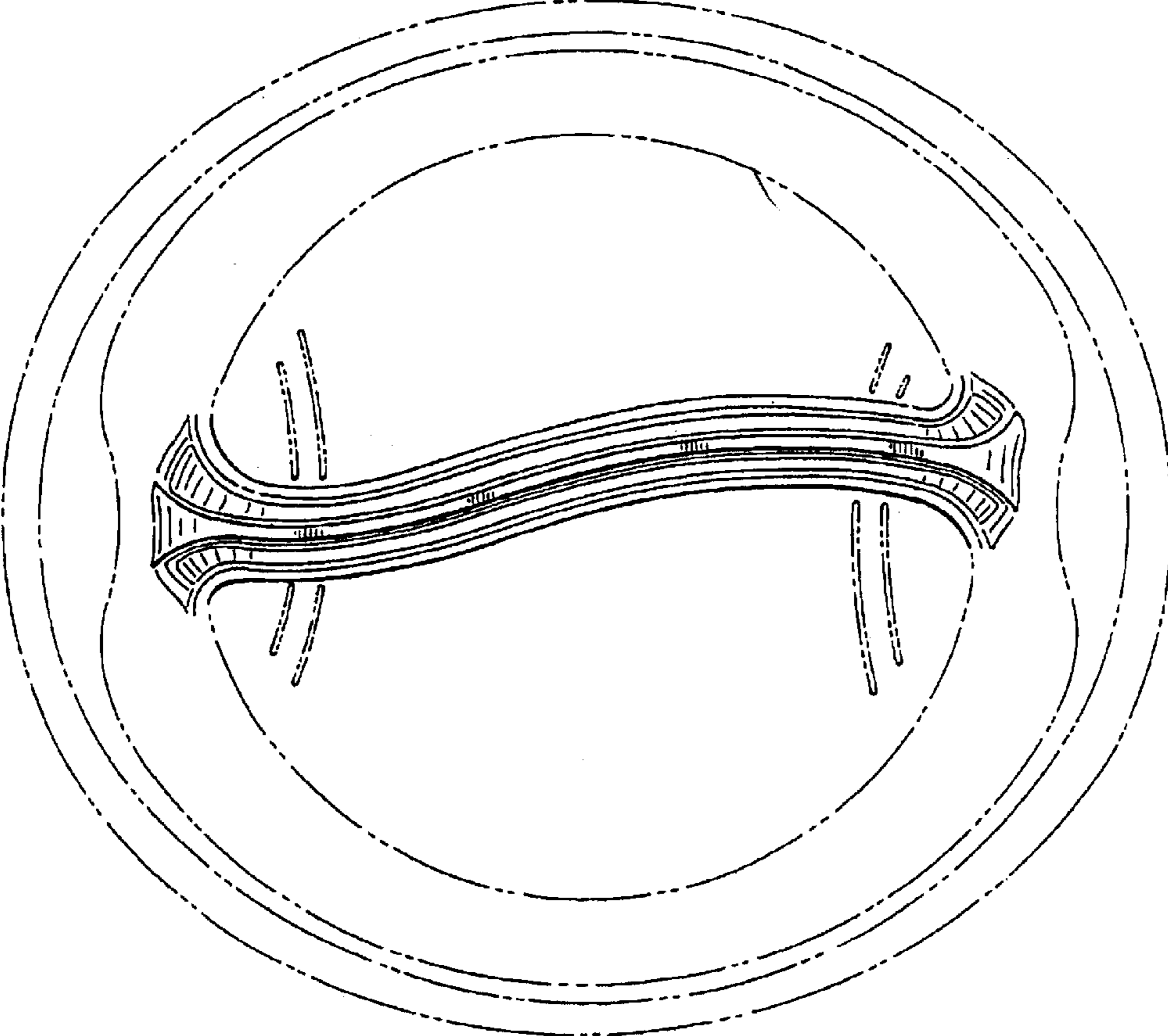

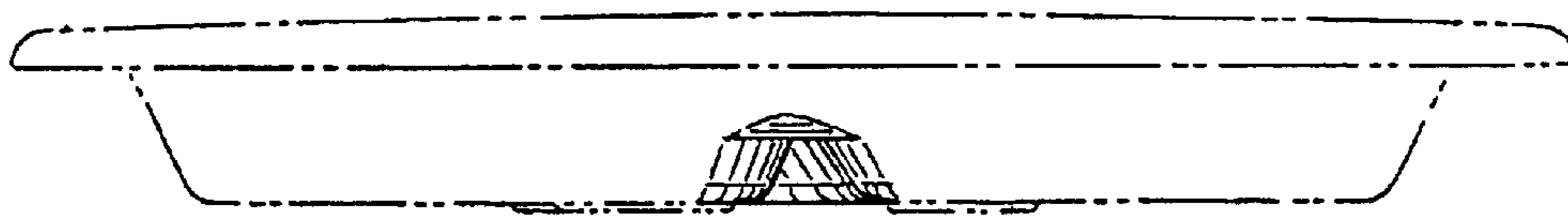

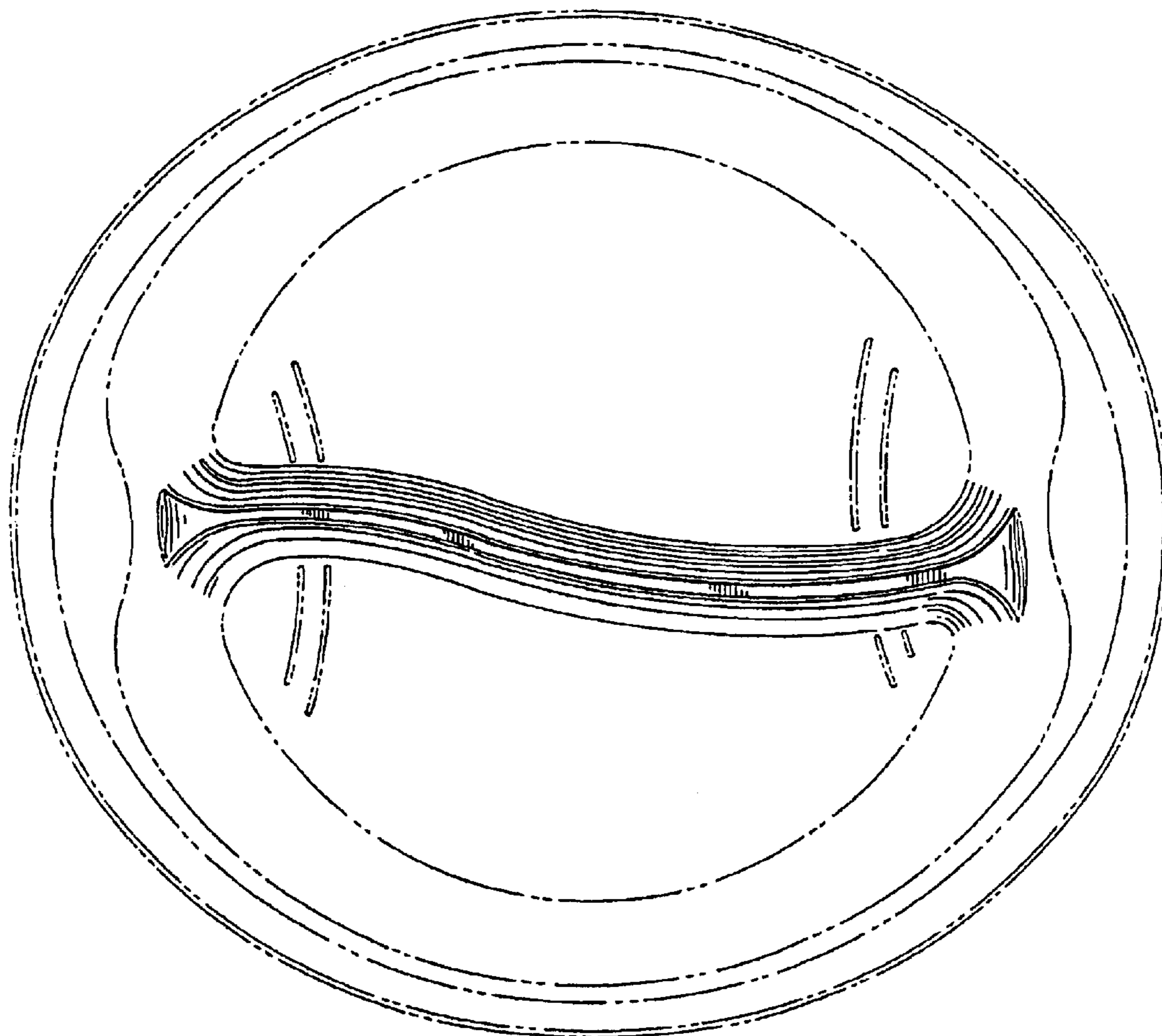
