 FIG. 13 is a top view of the chopping device, as shown in FIG. 8; and,
 FIG. 14 is a bottom view of the chopping device, as shown in FIG. 8.

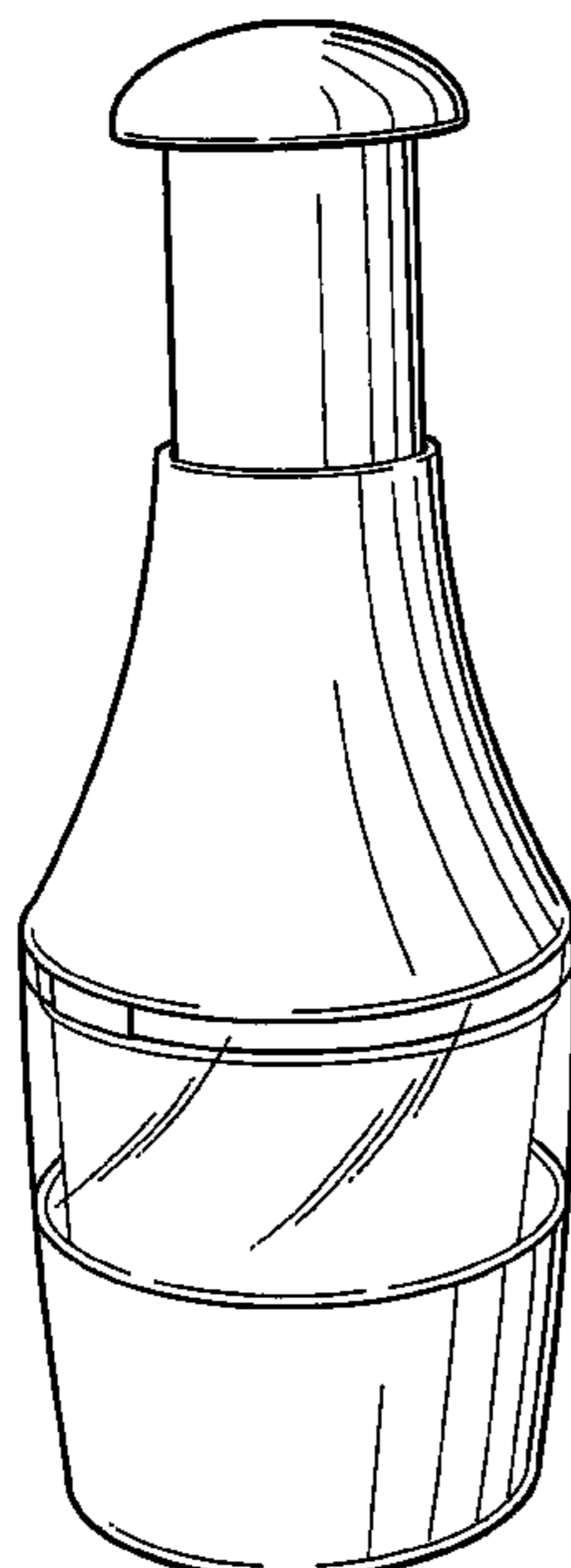

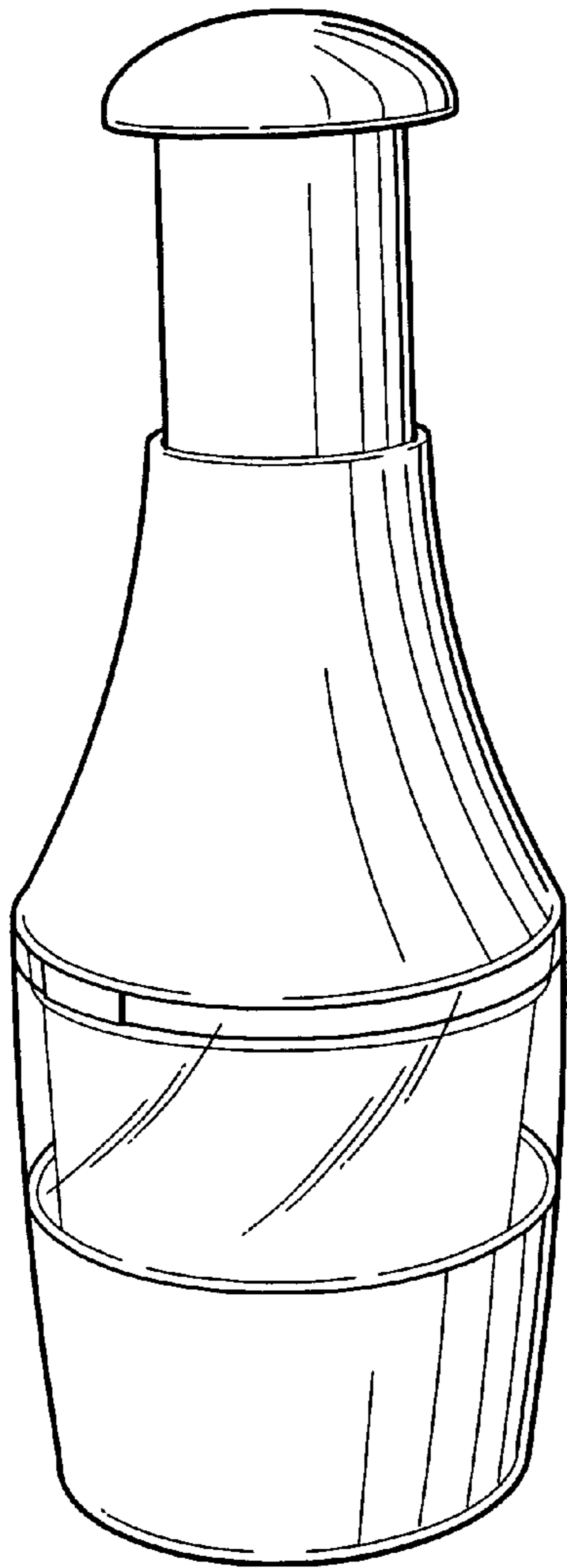

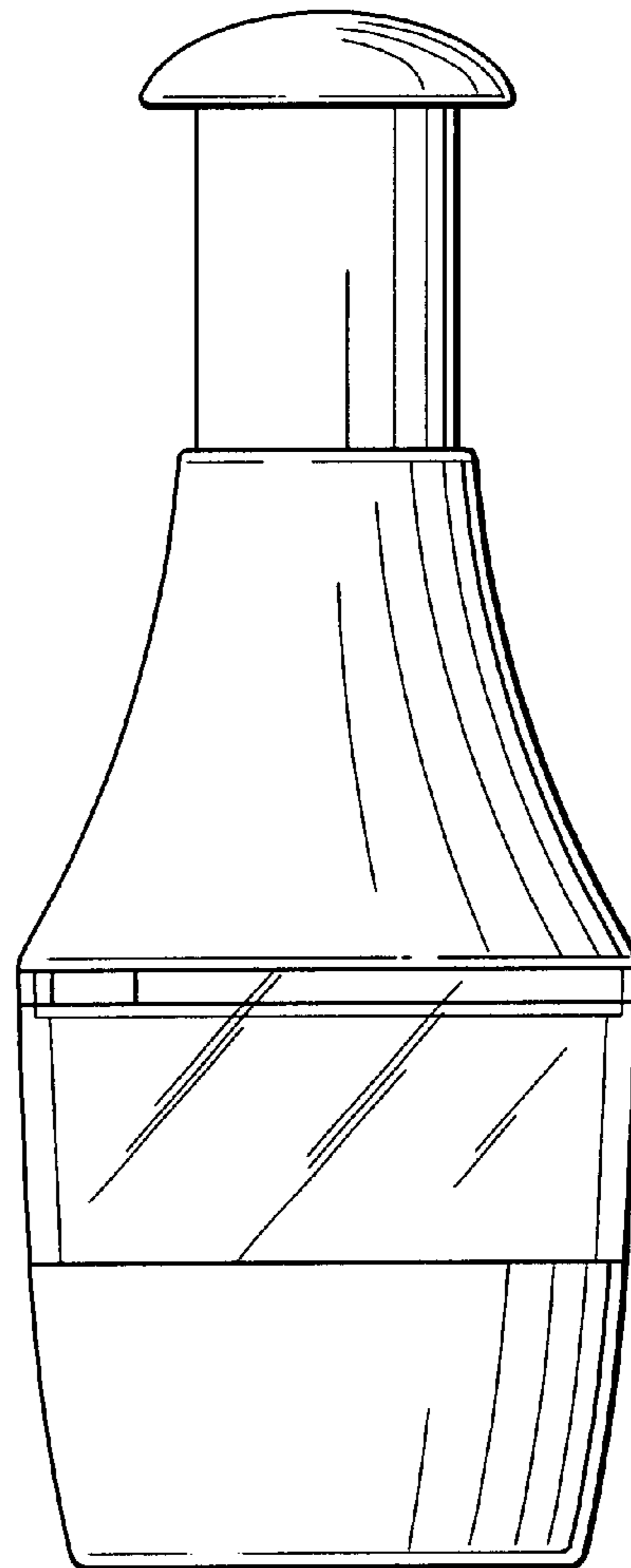

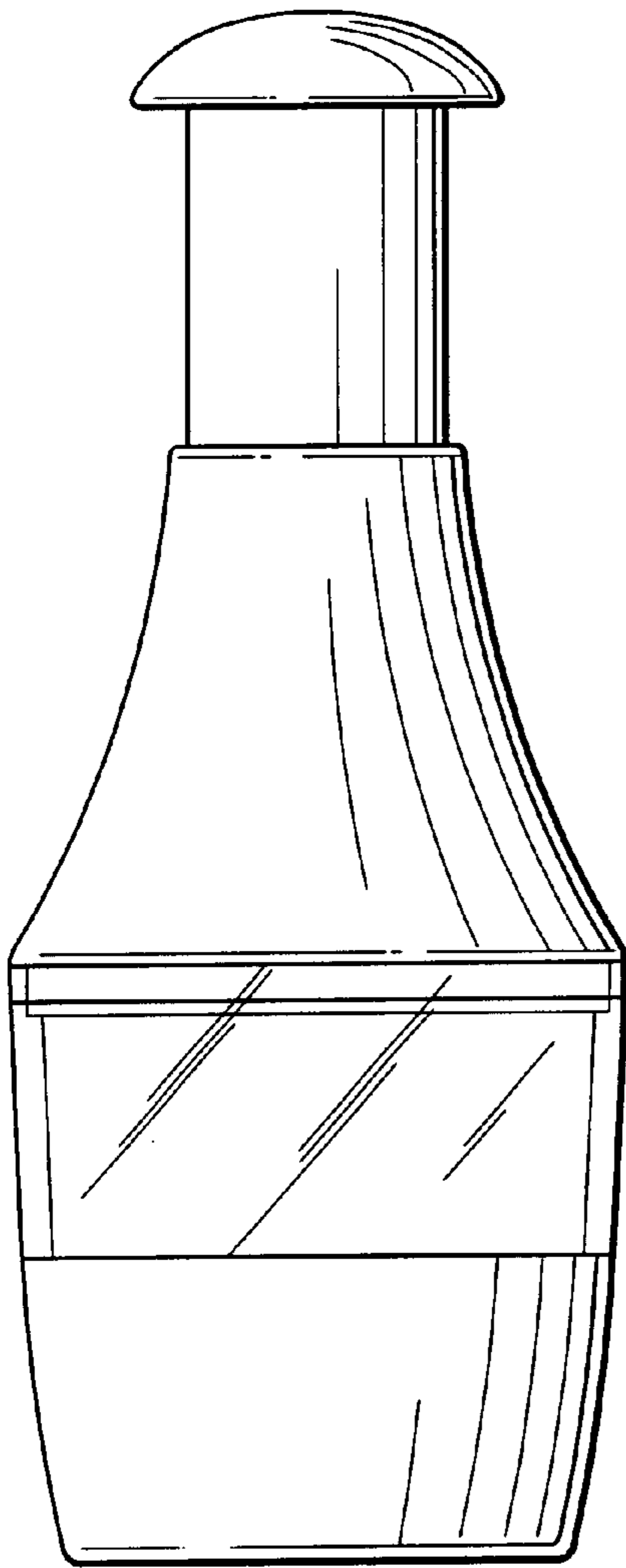

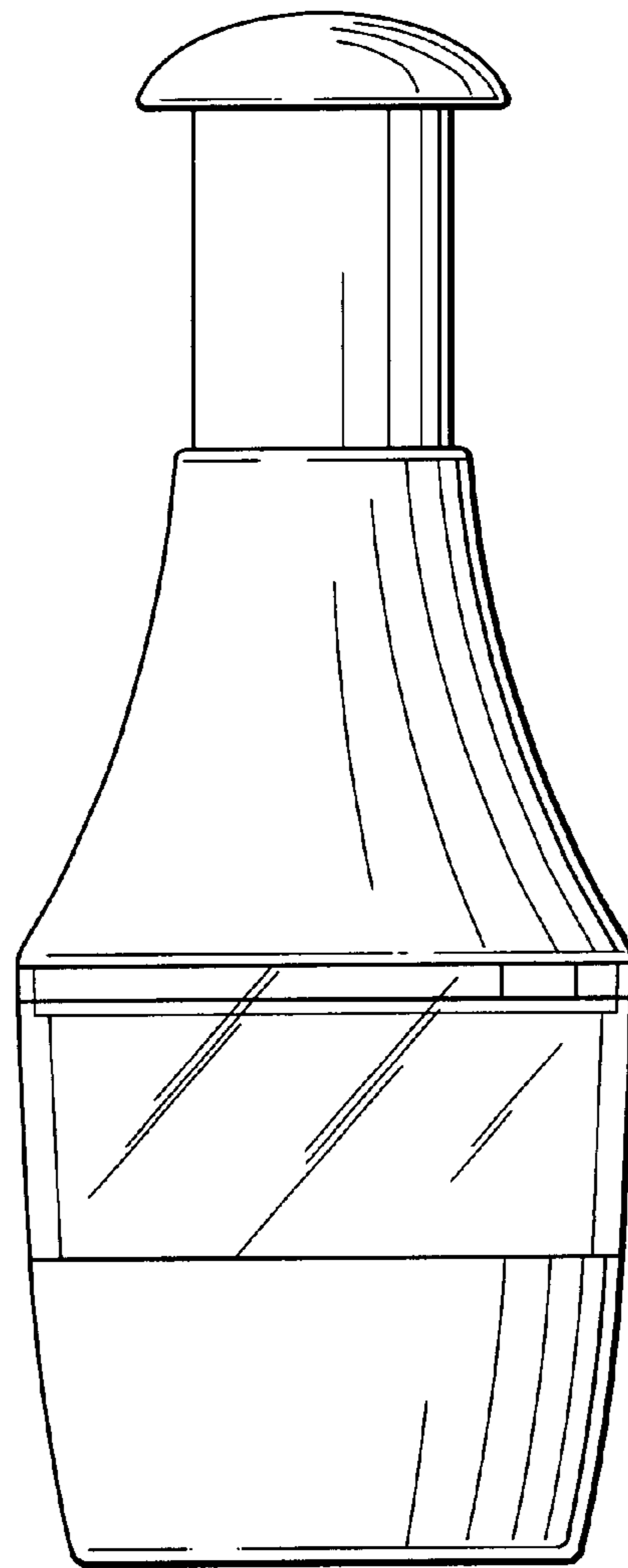

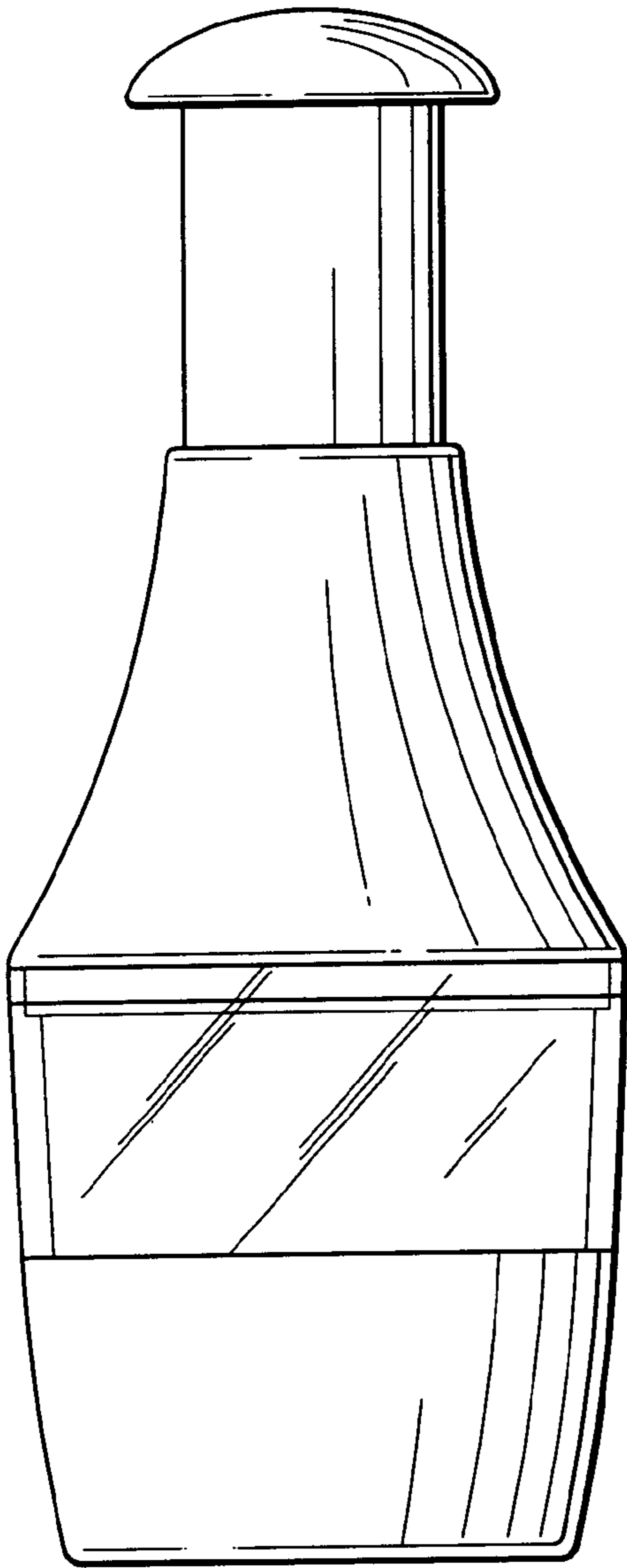

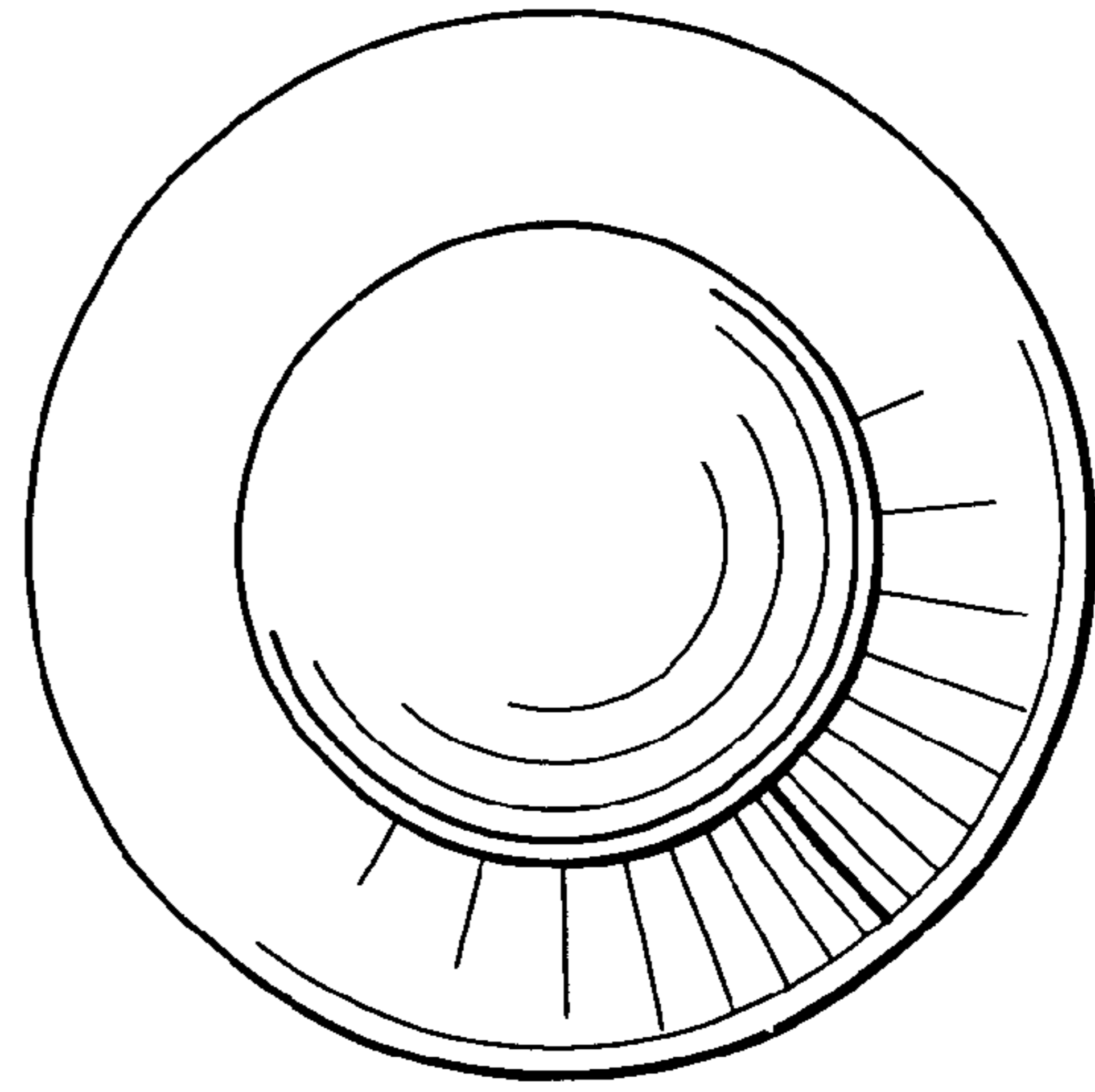

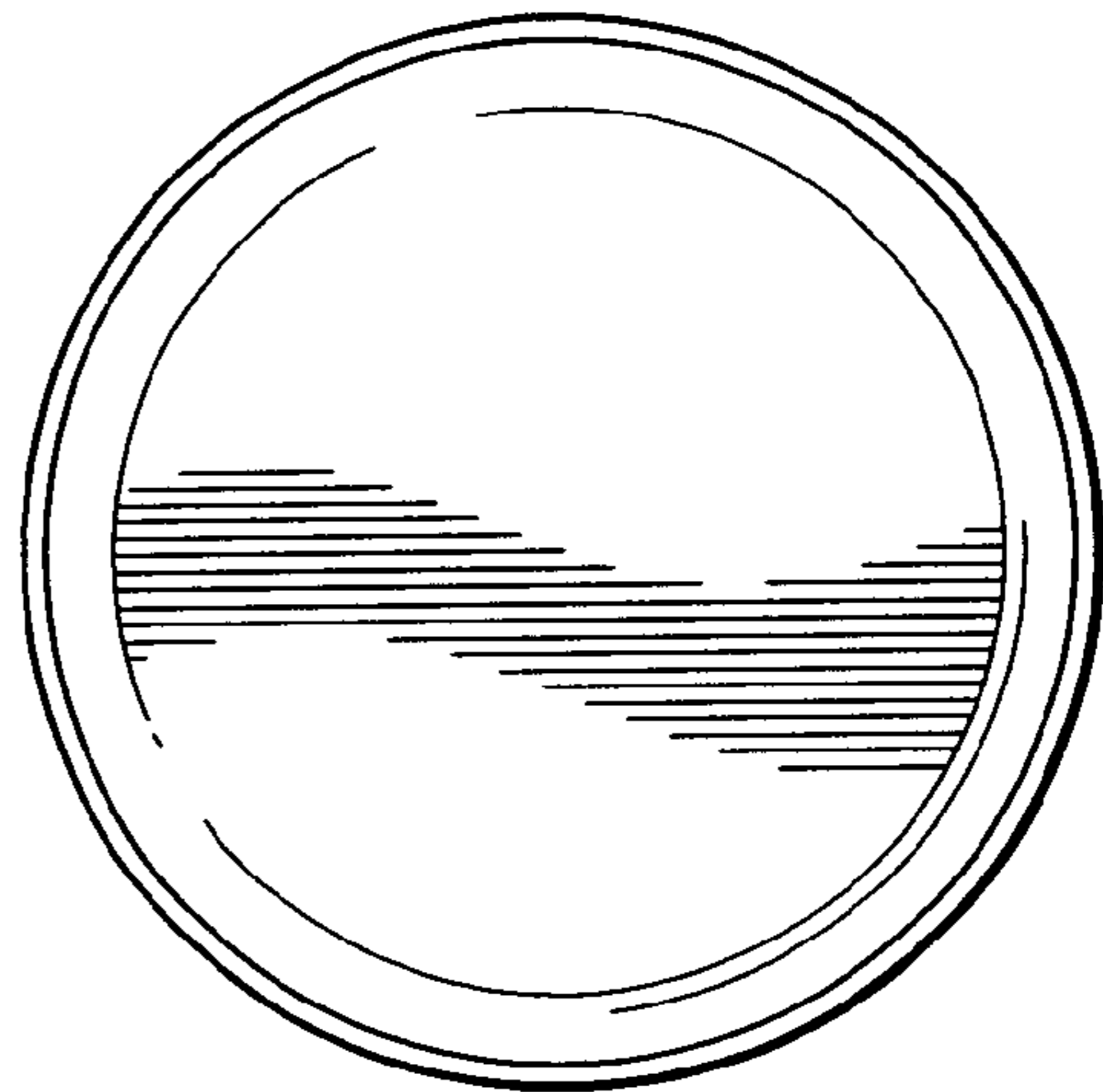

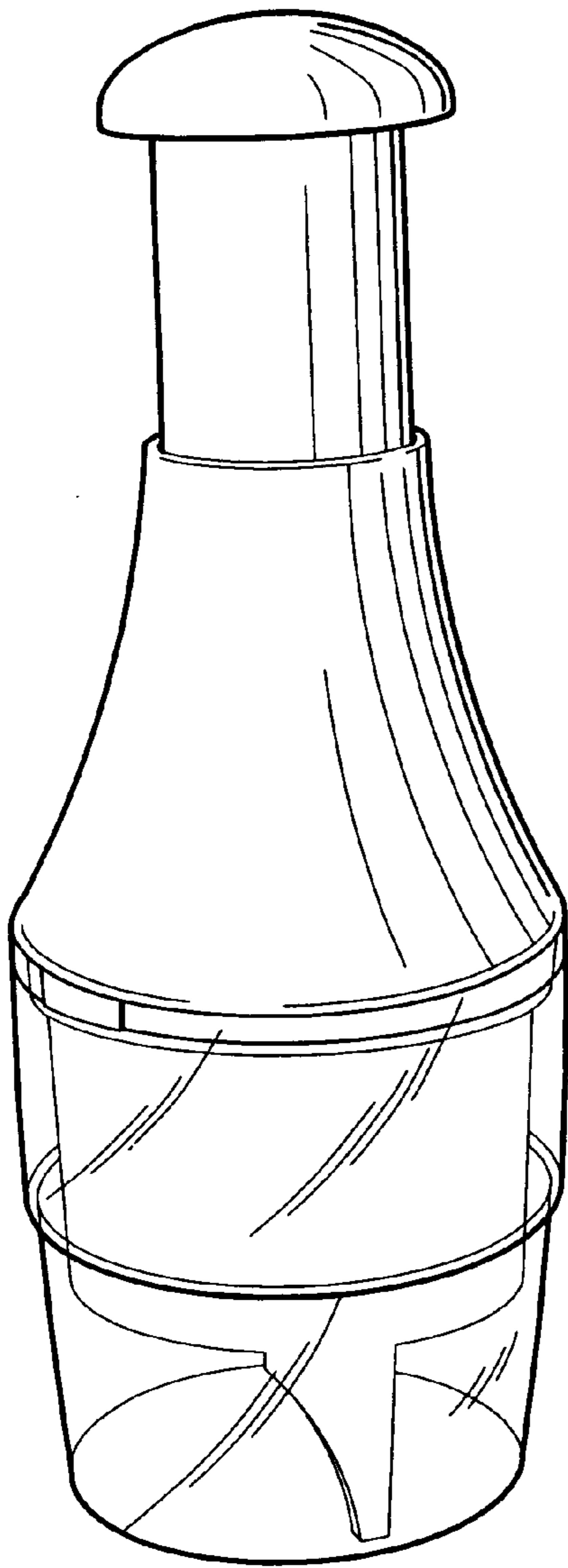

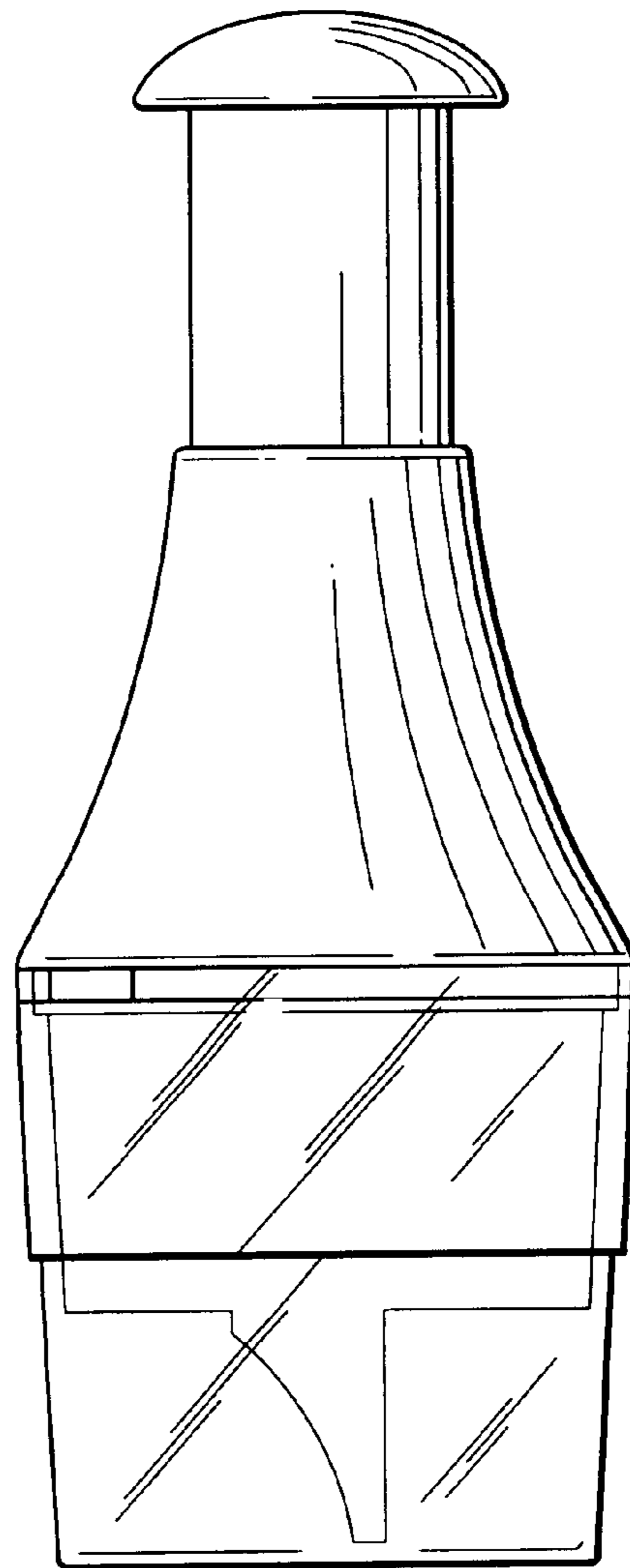

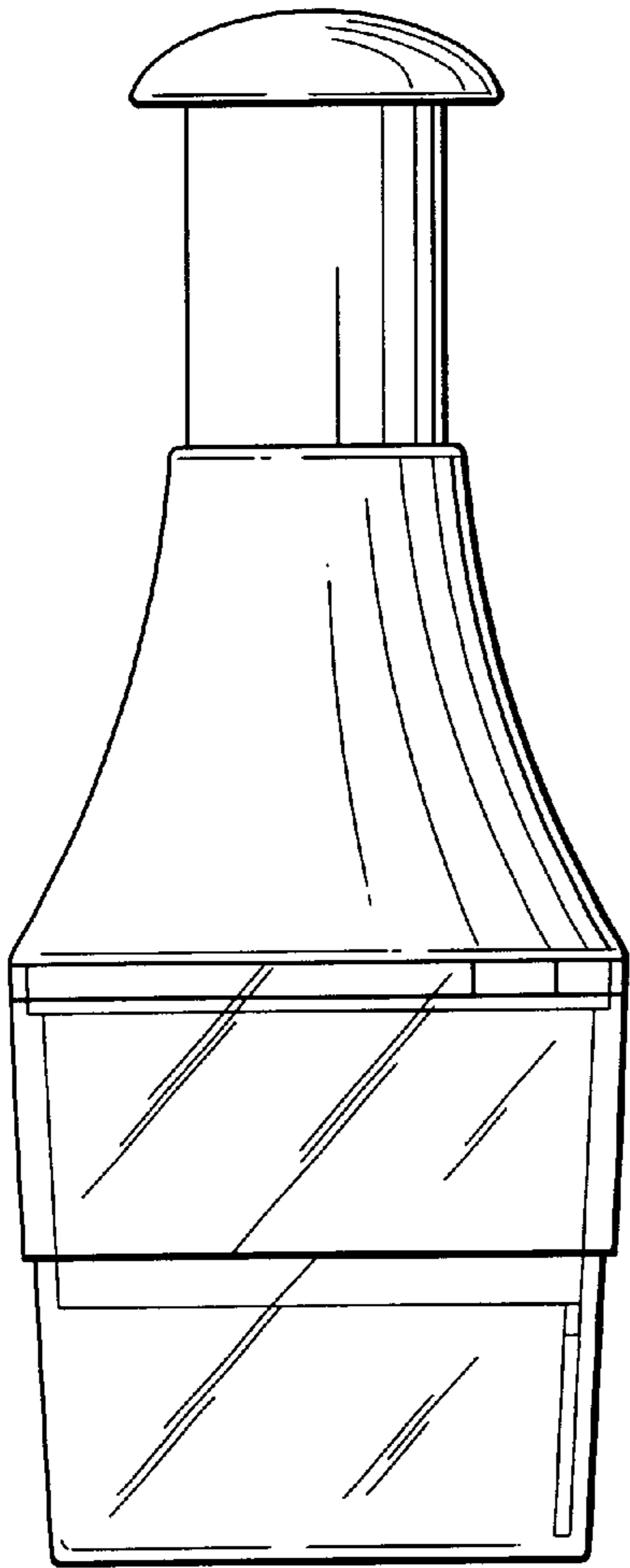

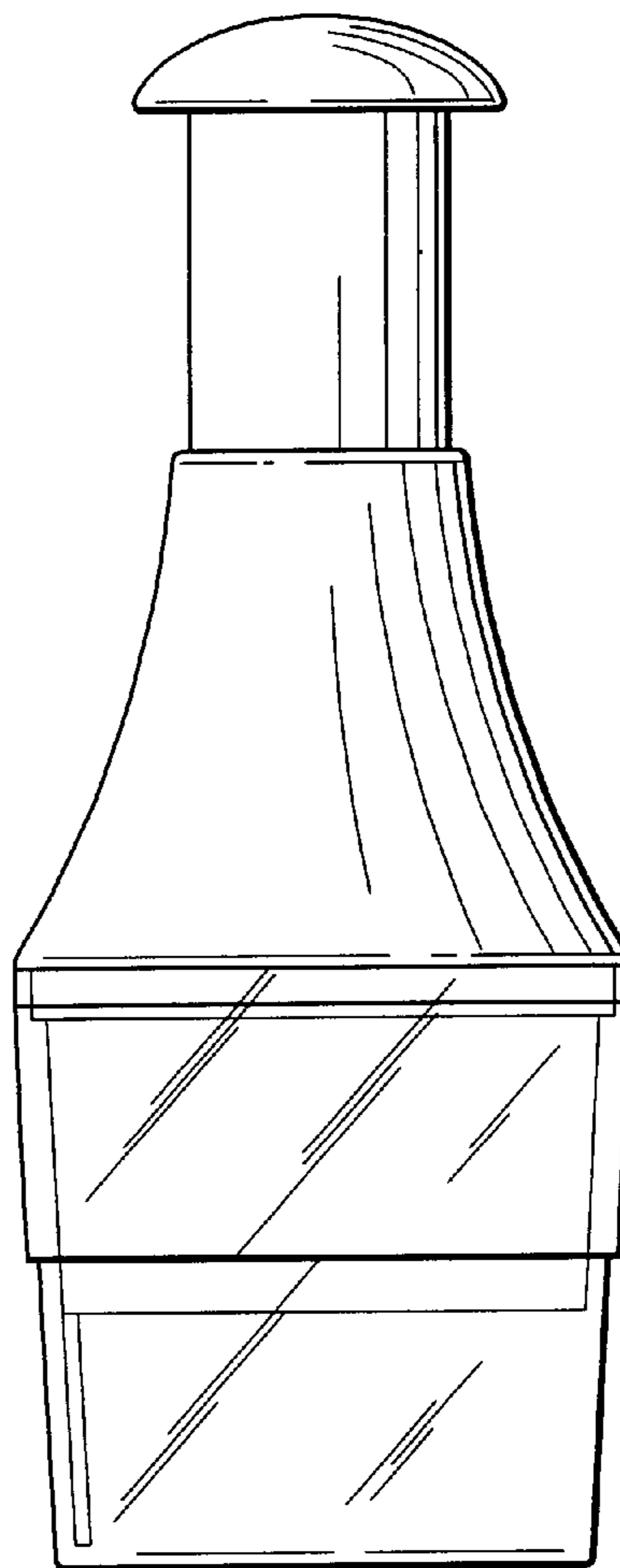

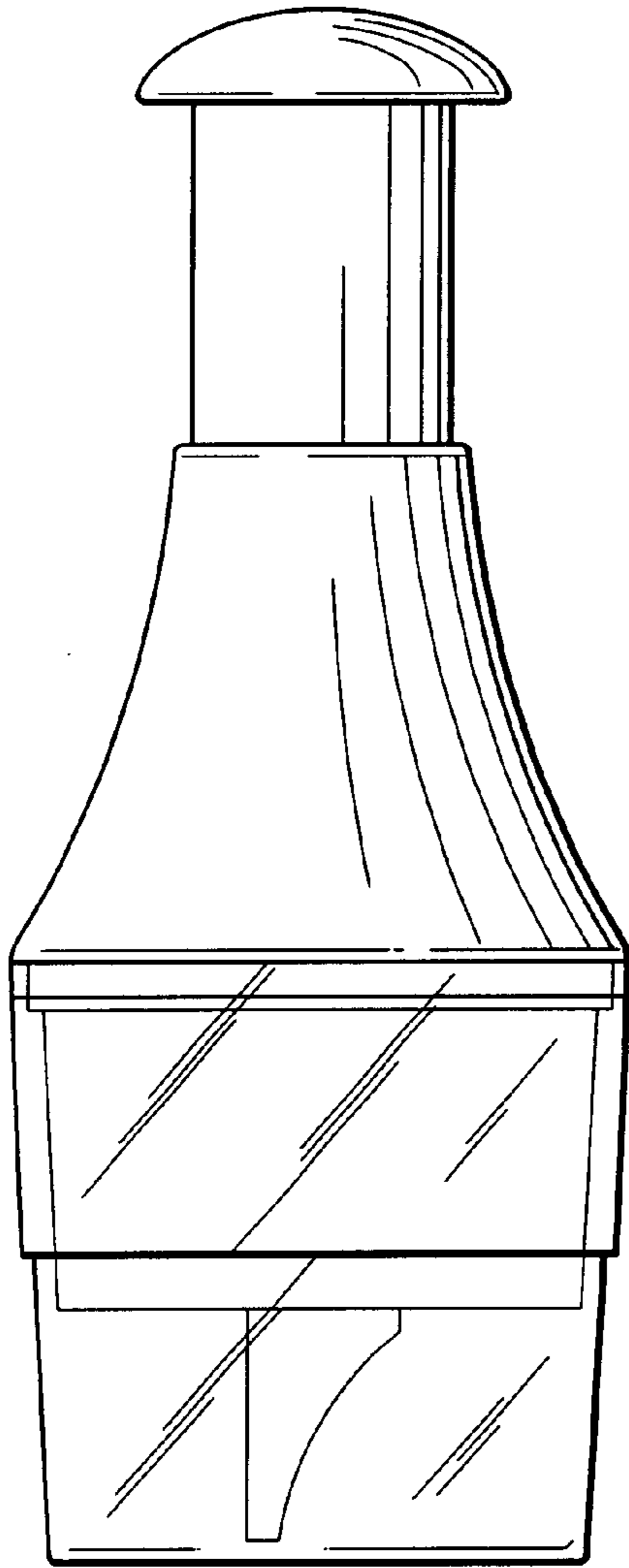

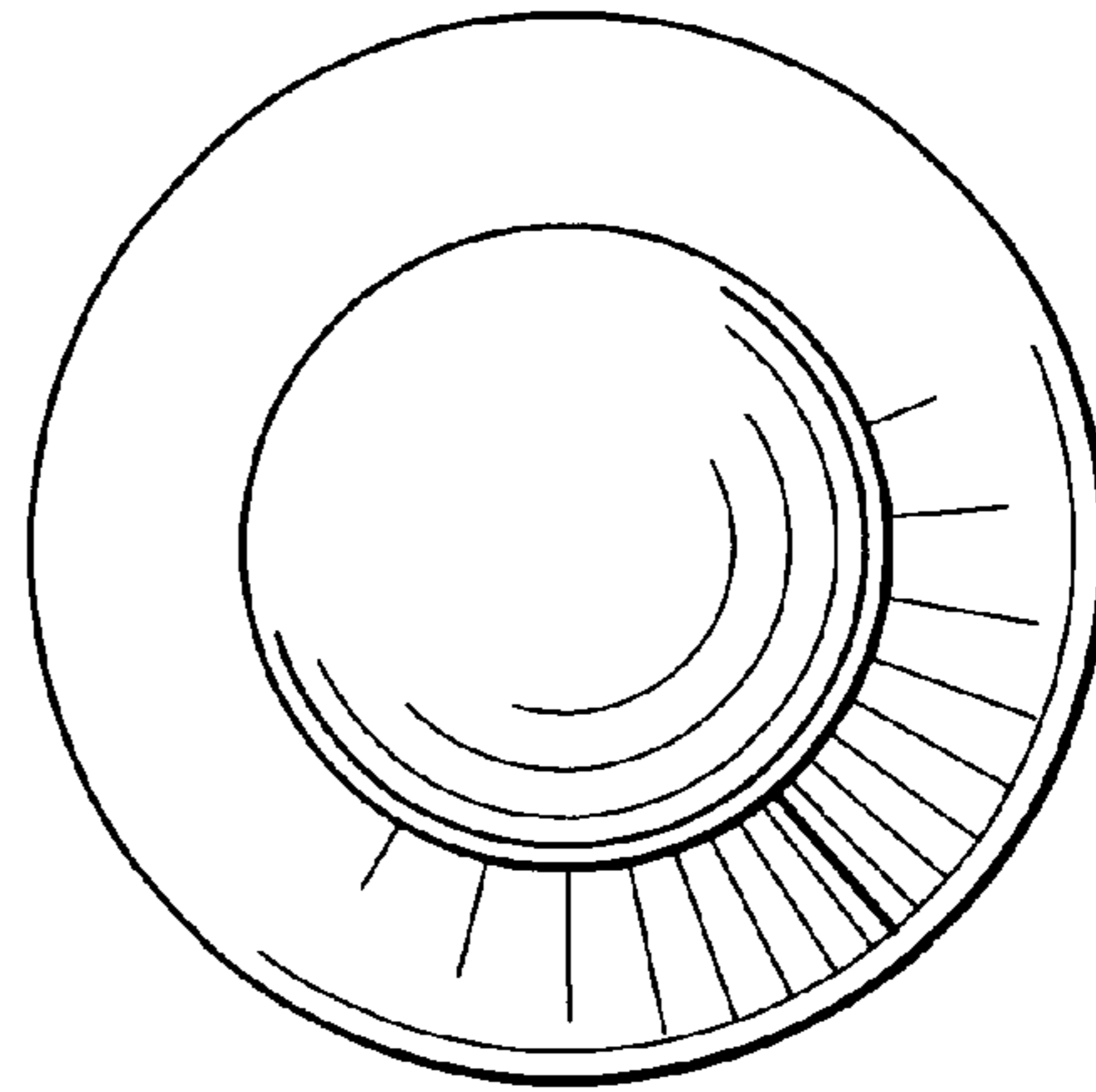

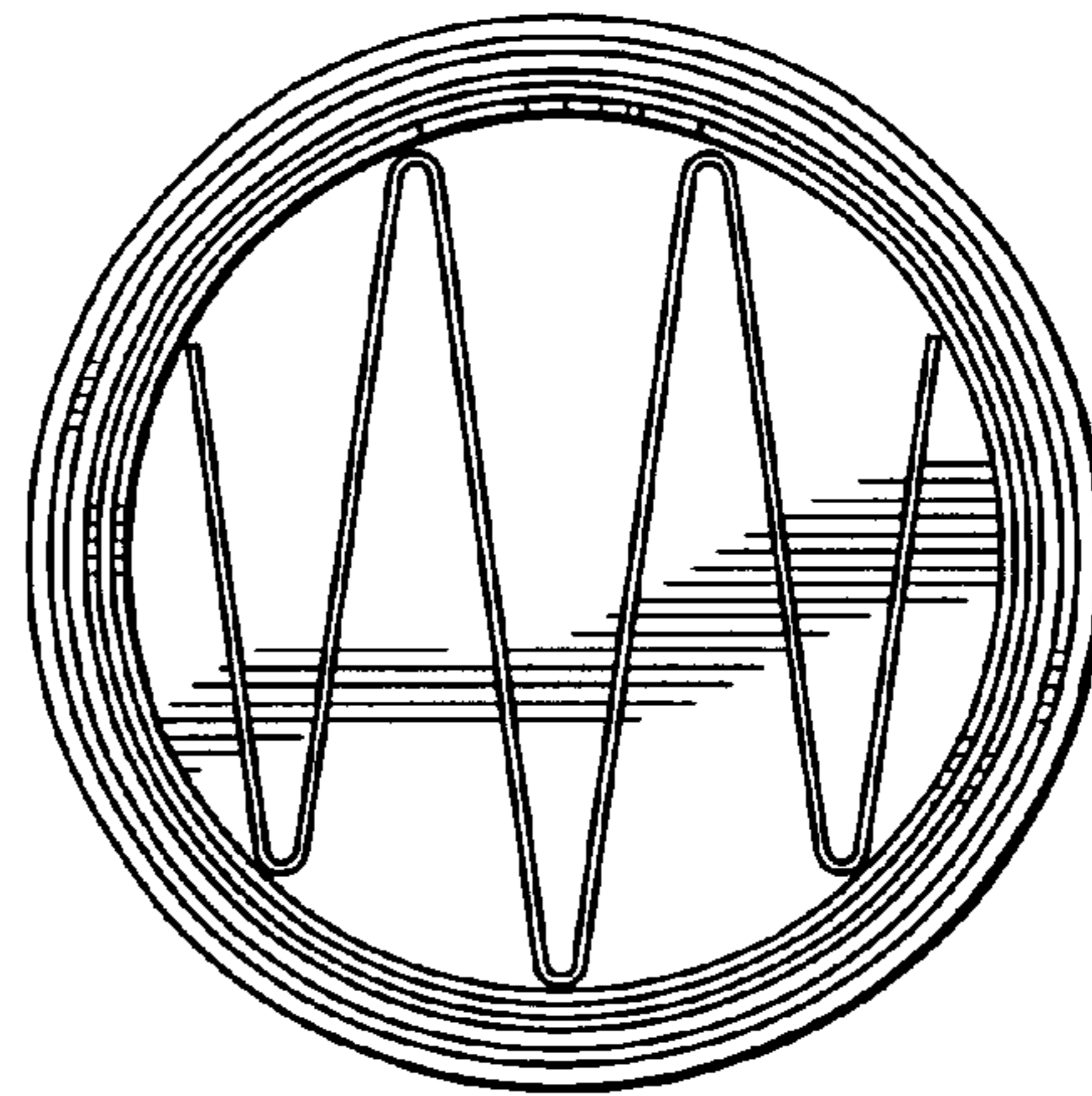
