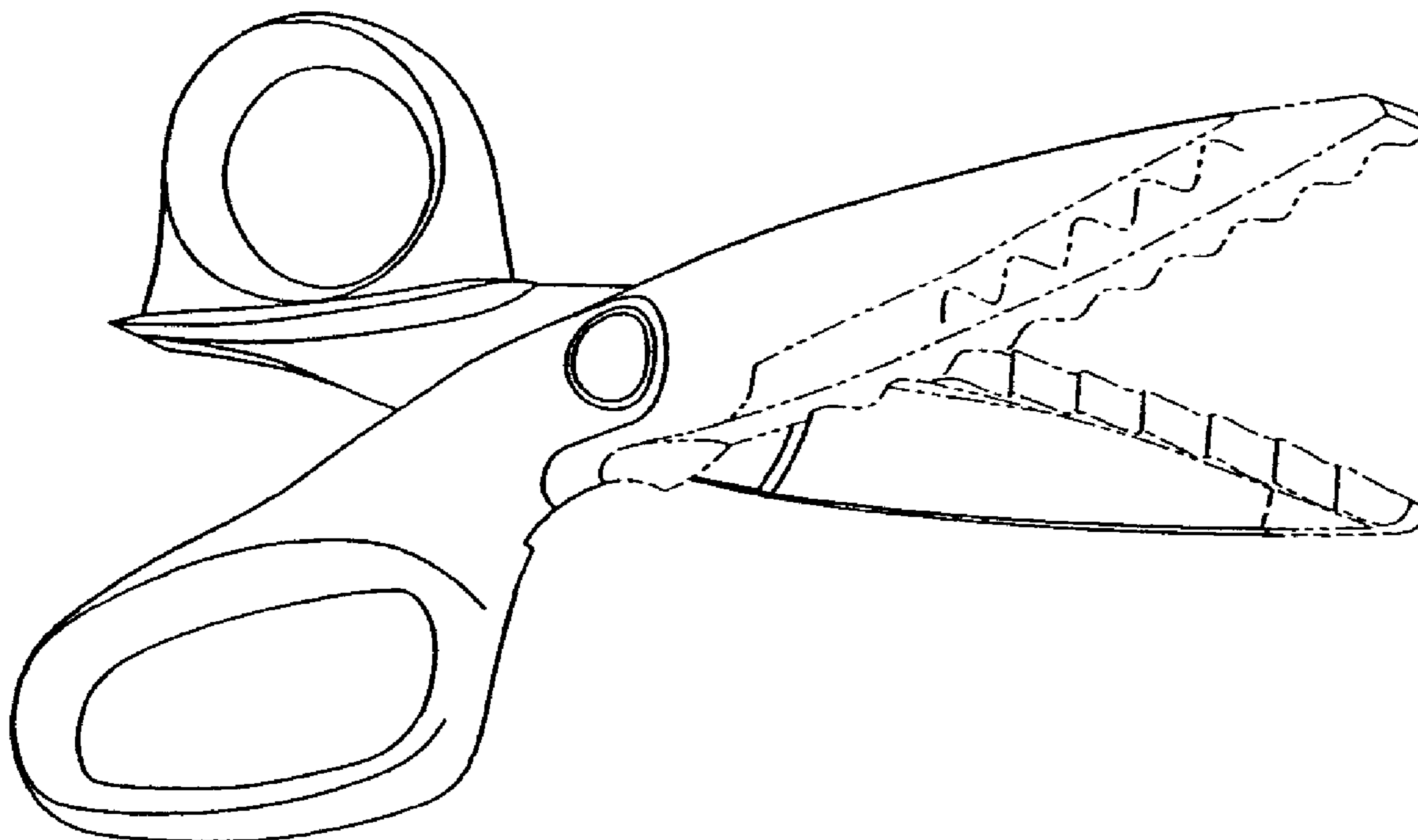
The removable cutting blade portions of the scissors, shown

purposes only and form no part of the claimed design.

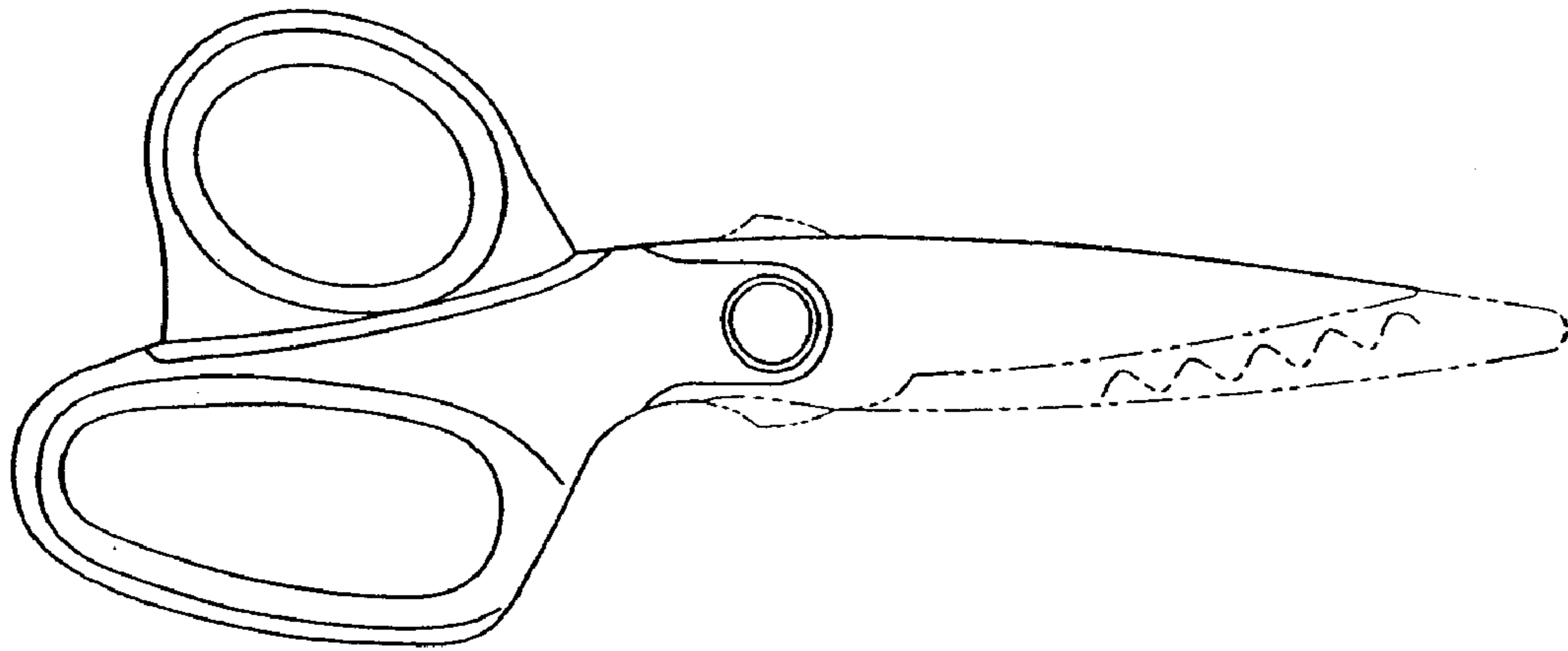

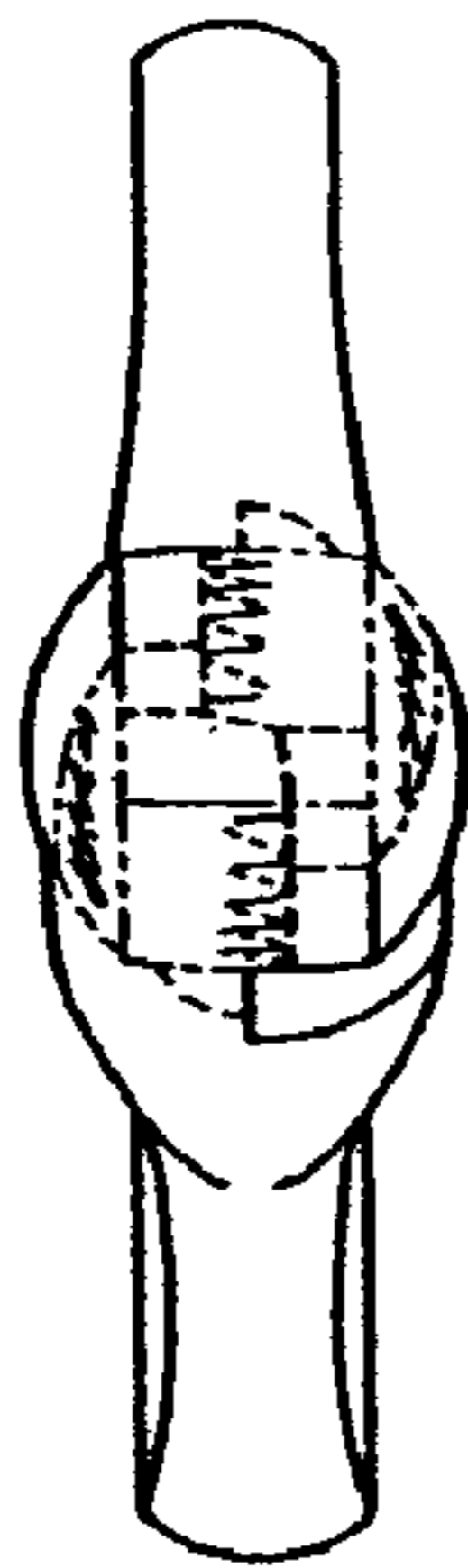

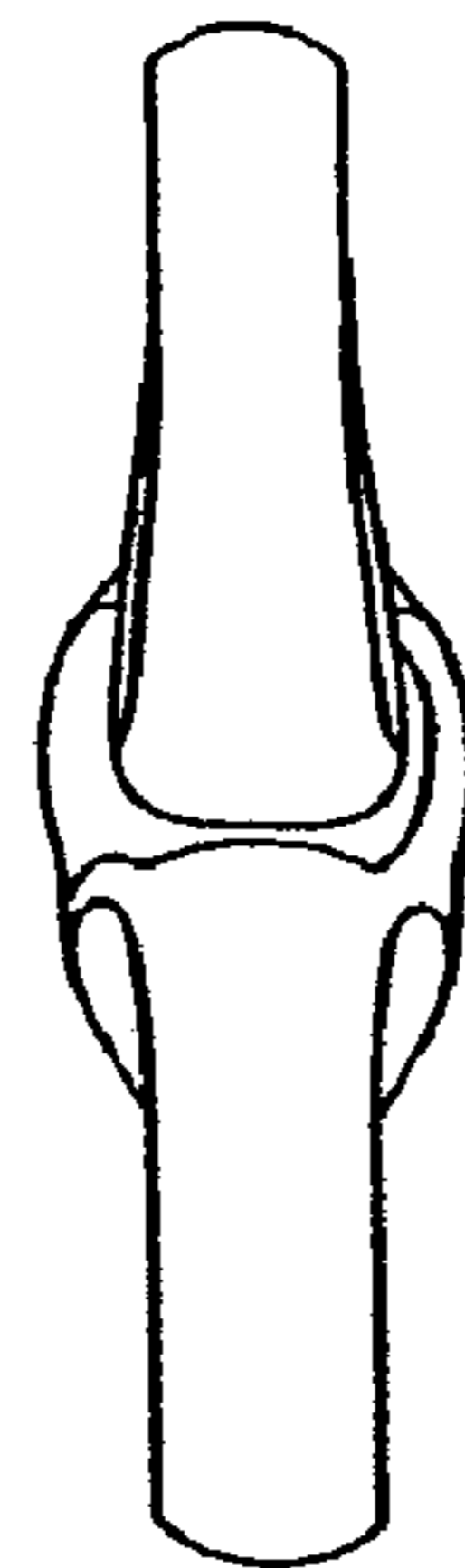




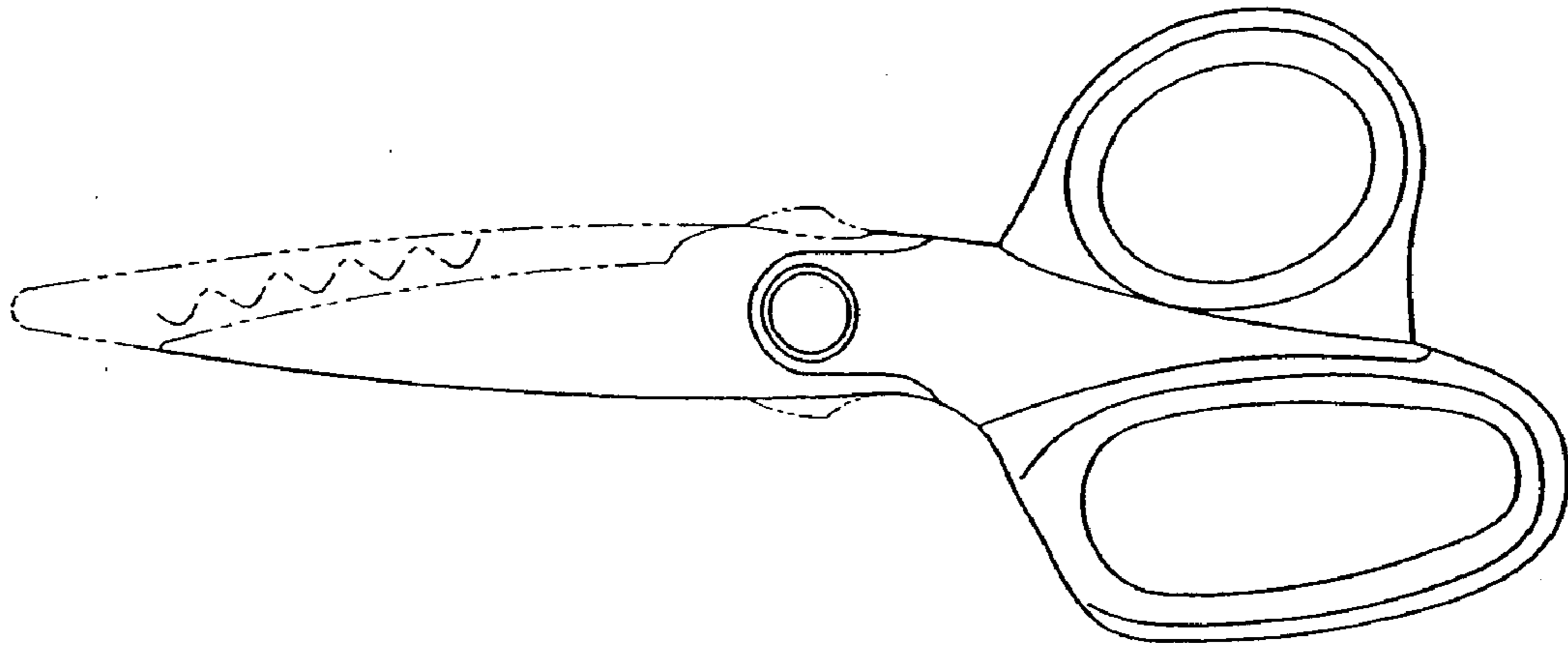

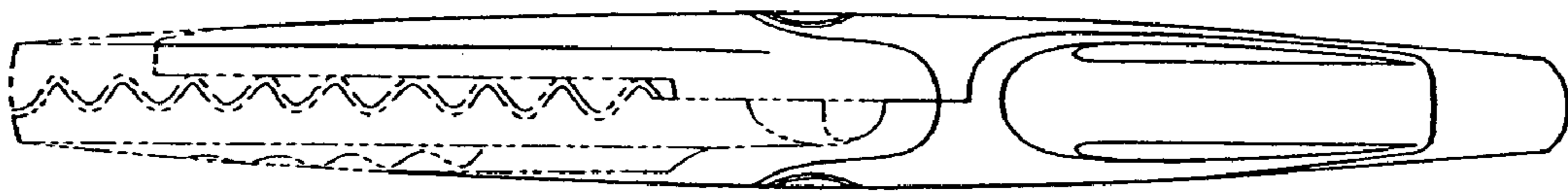

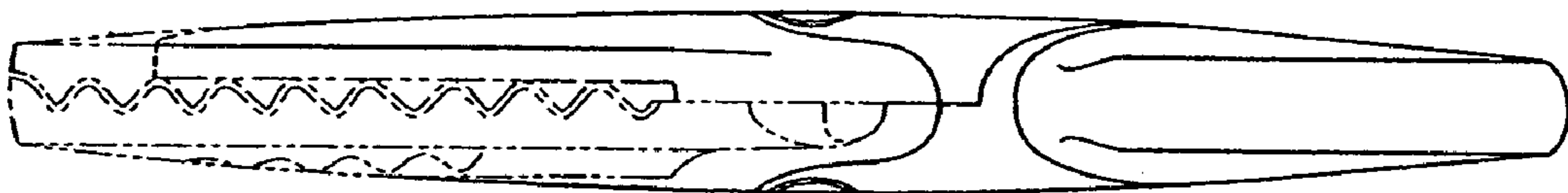

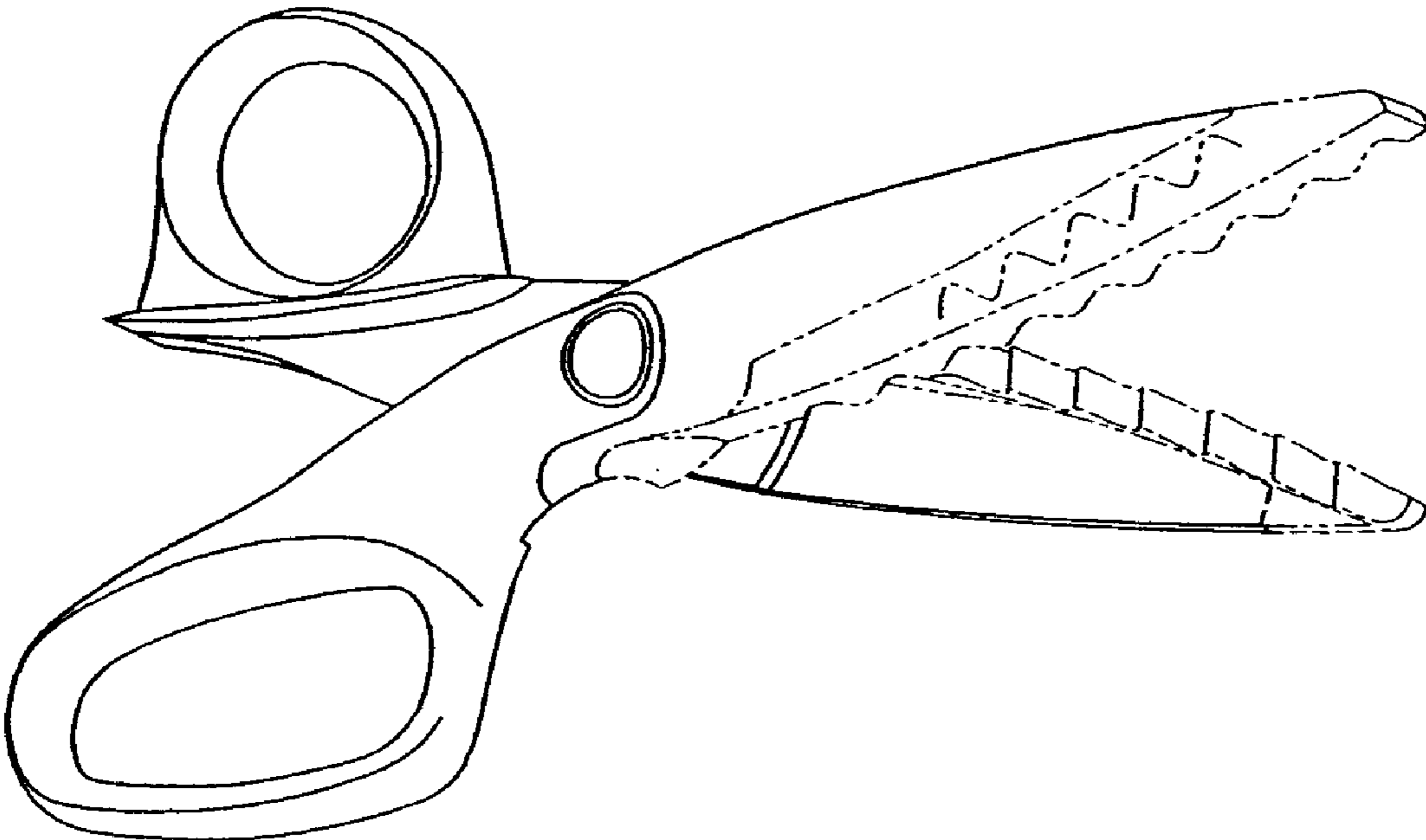
