(57) **CLAIM**

The ornamental design for a clock display, as shown and described.

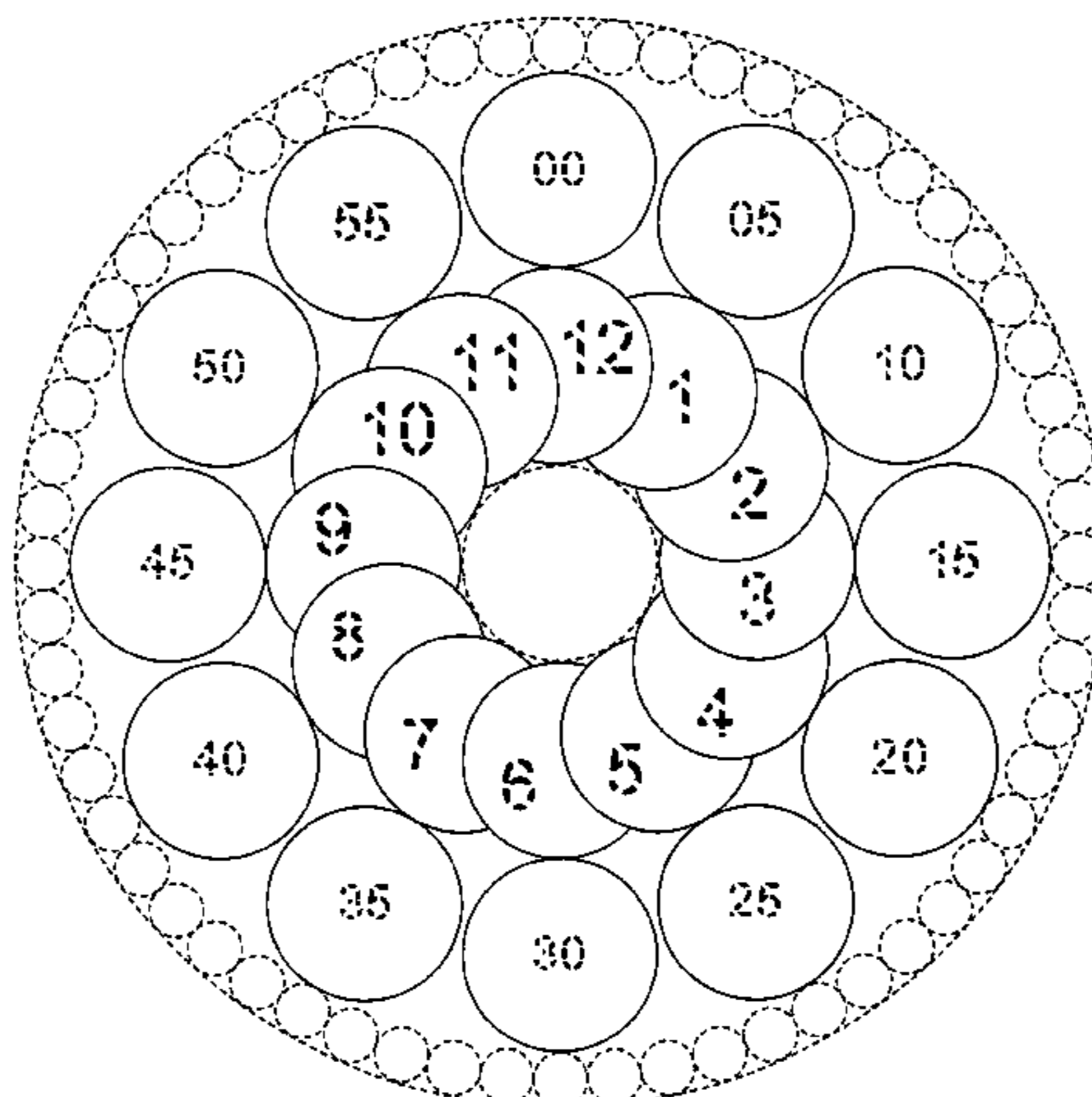
DESCRIPTION

FIG. 1 is a top plan view of a clock display, showing the new design; and,

FIG. 2 is a top plan view of the clock display, showing the new design in an environment of use.

The broken lines showing portions of a clock face in FIG. 2 represent environmental structure only and form no part of the claimed design. FIG. 1 is shown without the environment of the clock face for clarity of illustration. FIG. 2 is shown on an enlarged scale.

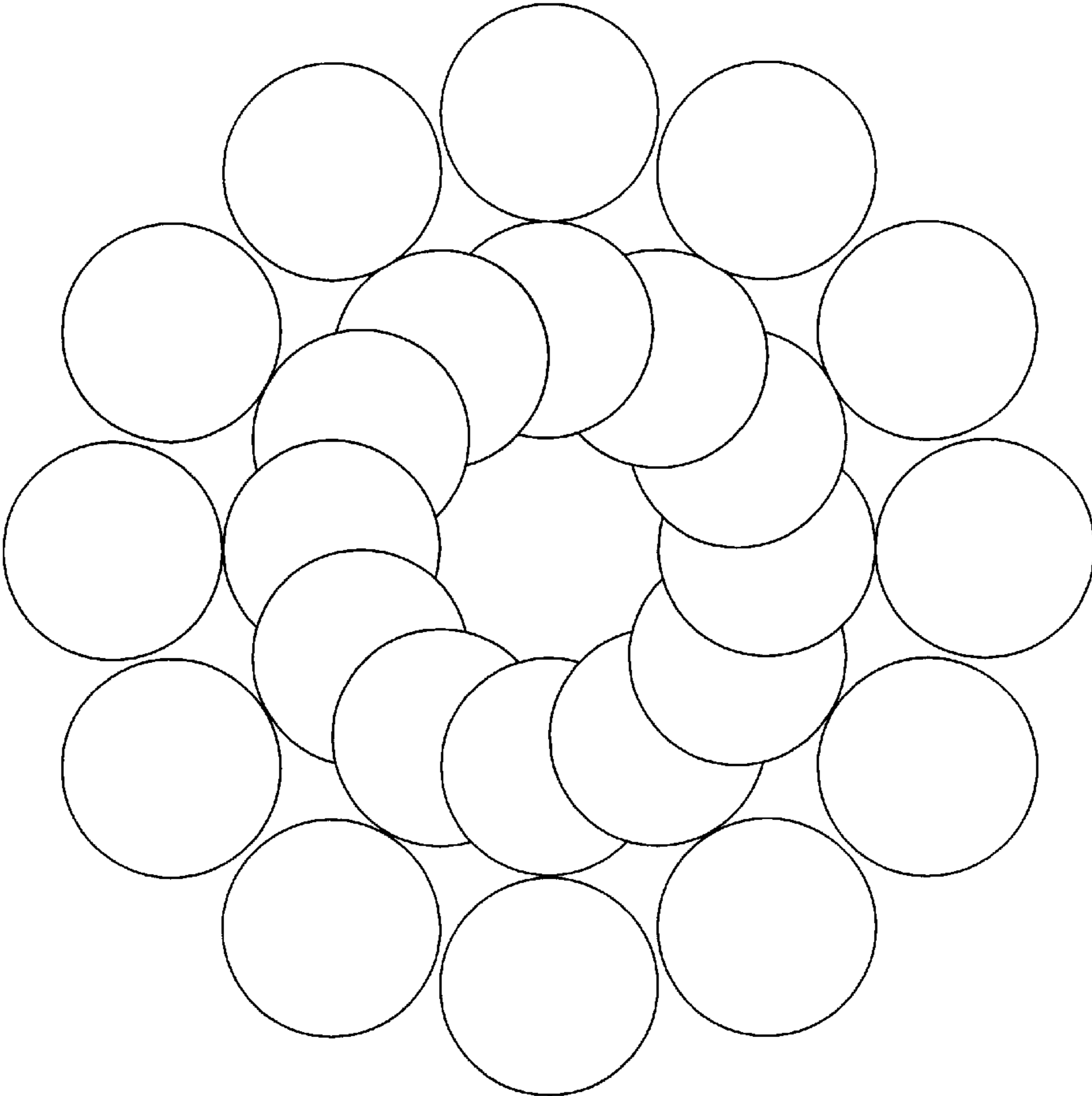

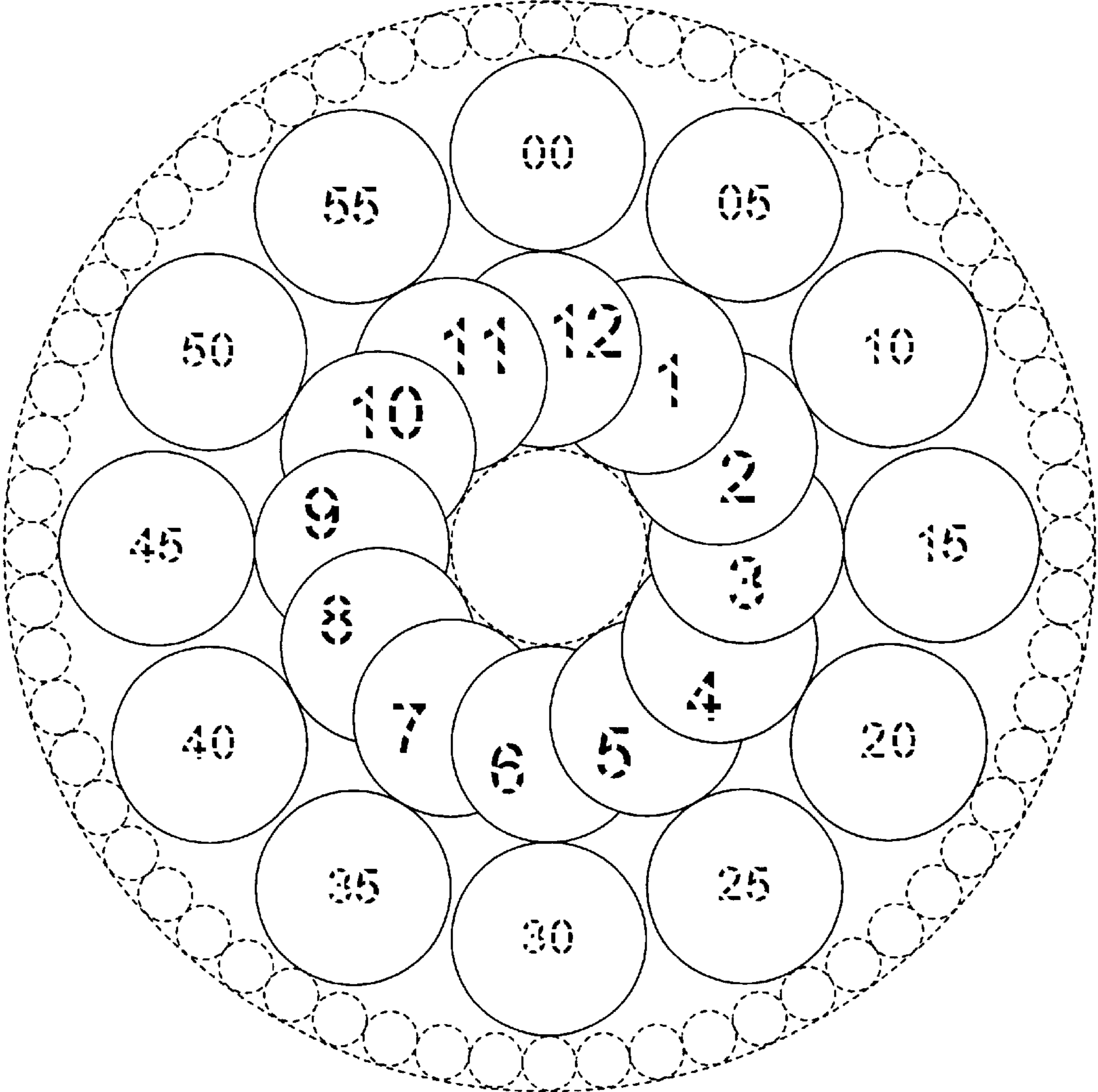
