(57) **CLAIM**

The ornamental design for a rechargeable battery for digital camera, as shown and described.

DESCRIPTION

FIG. 1 is a front, left side, top perspective view of a rechargeable battery for digital camera showing our new design;

FIG. 2 is a front elevational view thereof;

FIG. 3 is a rear elevational view thereof;

FIG. 4 is a left side view thereof;

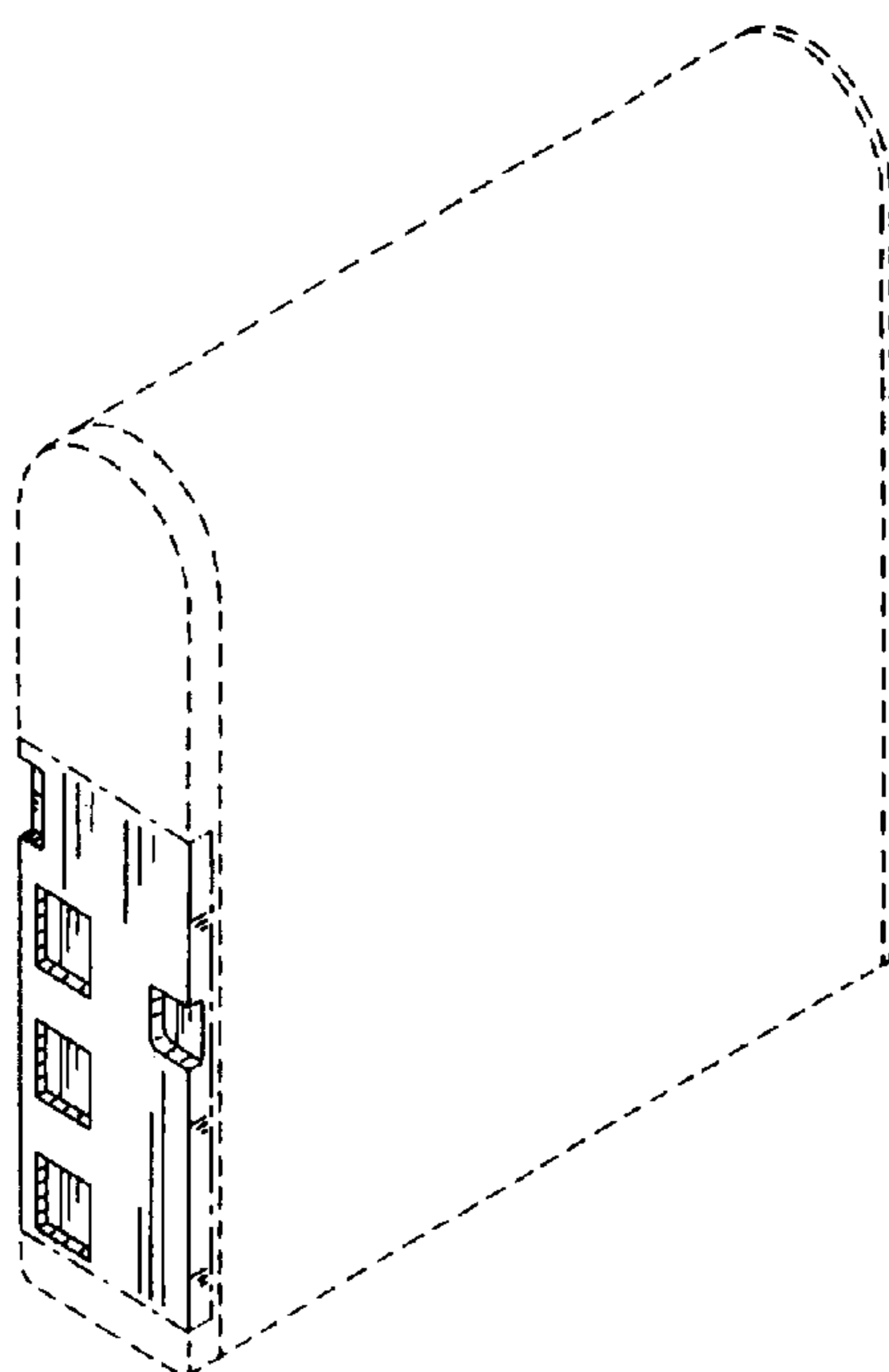
FIG. 5 is a right side view thereof;

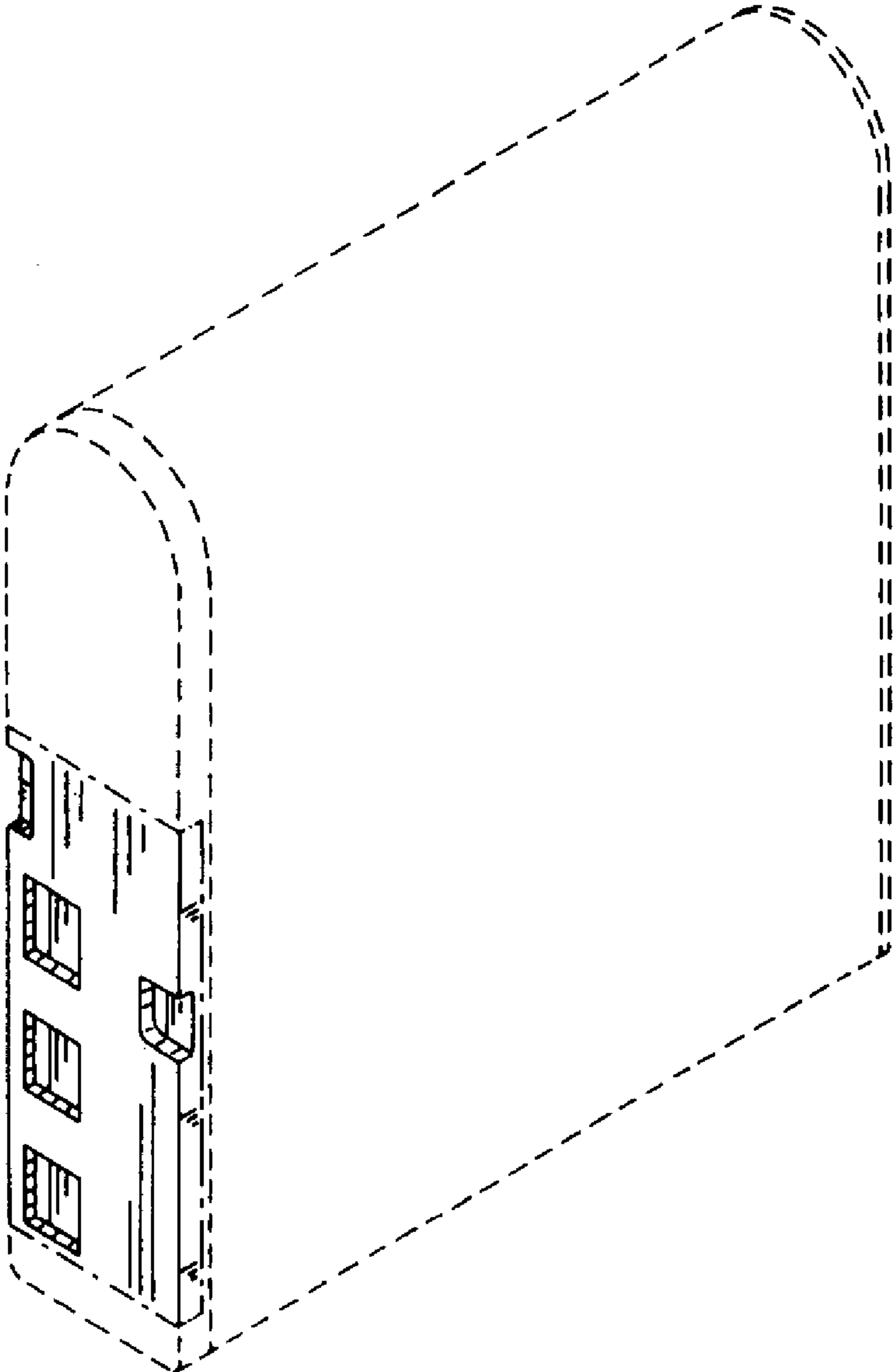

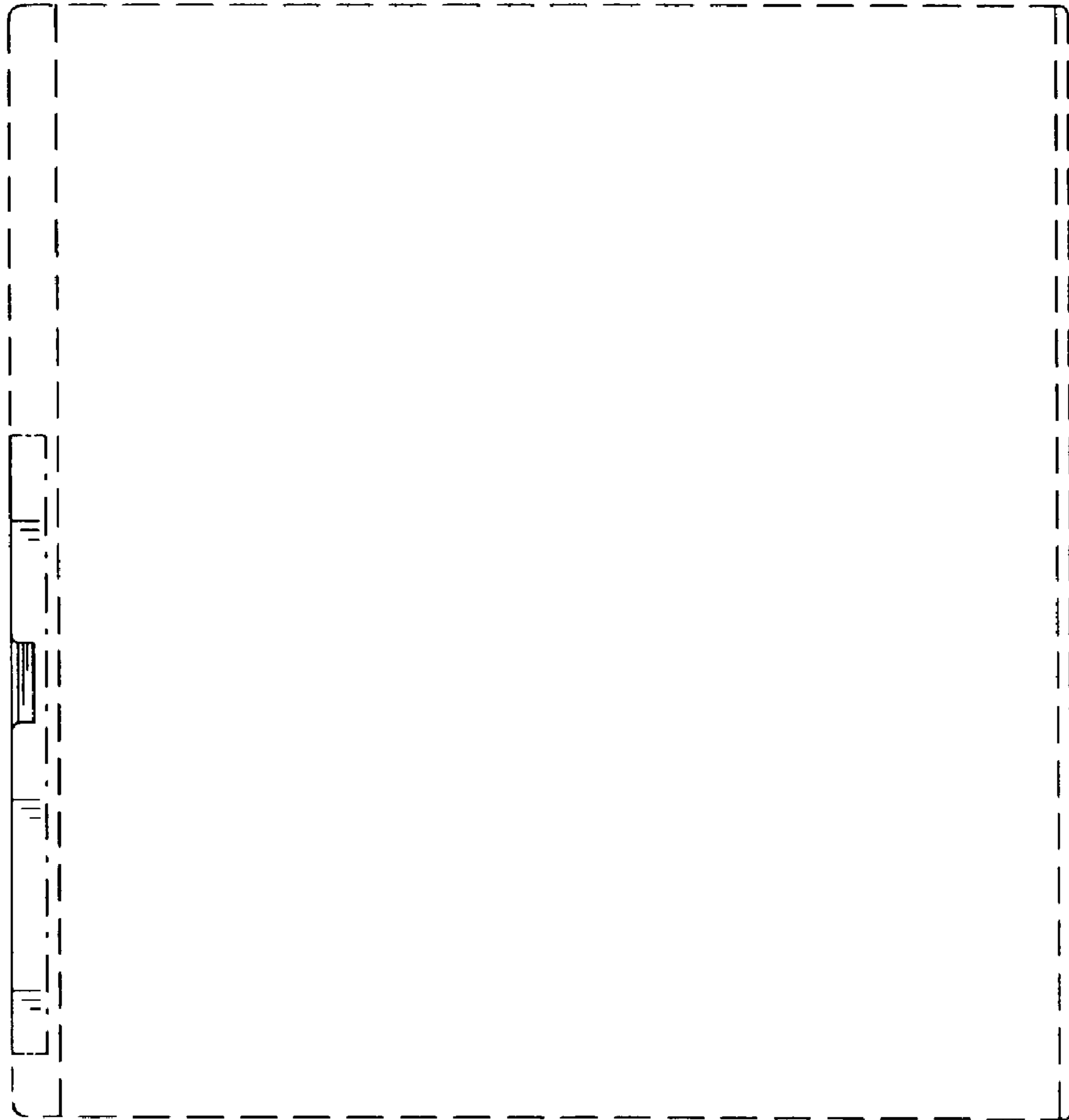

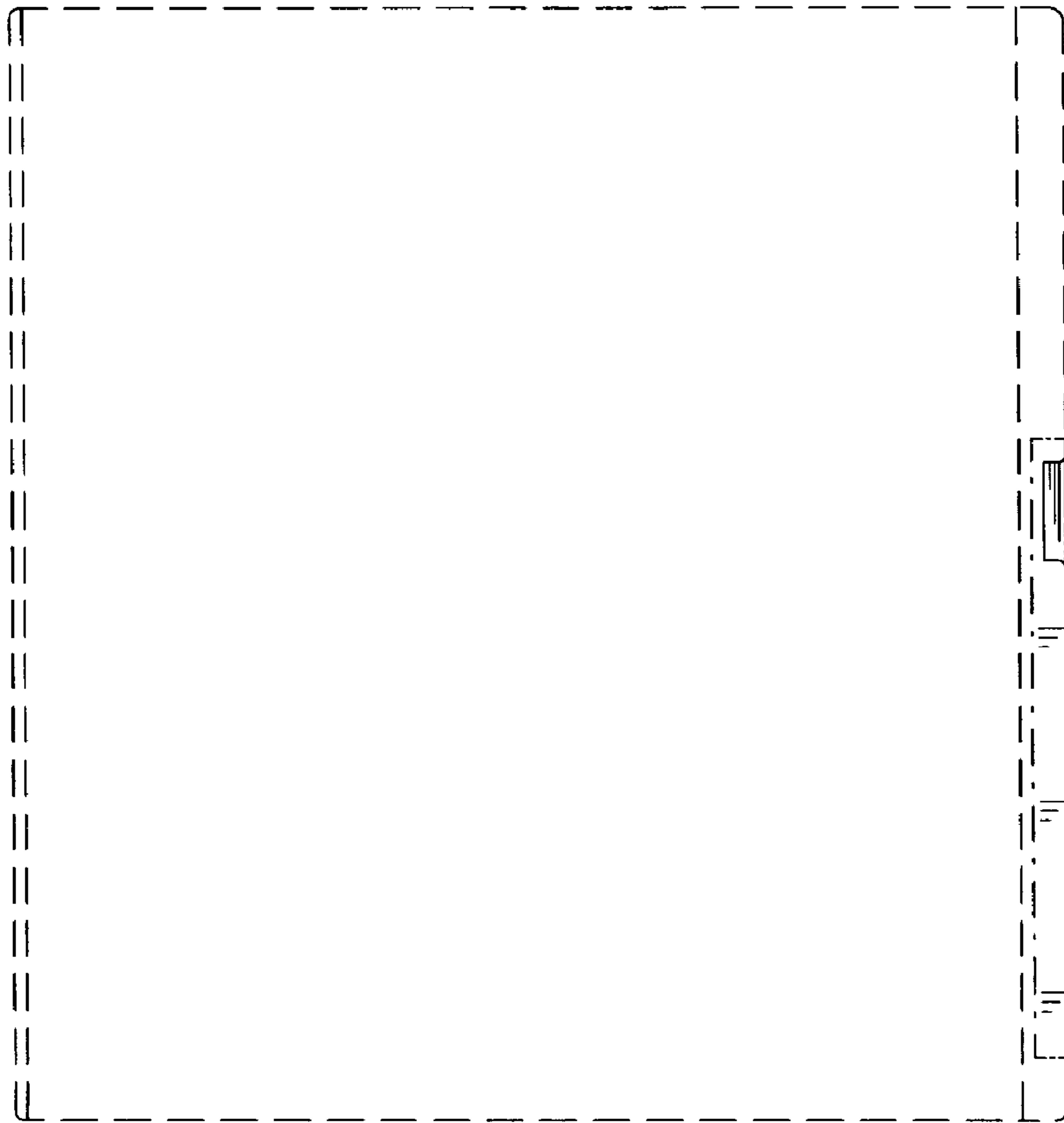

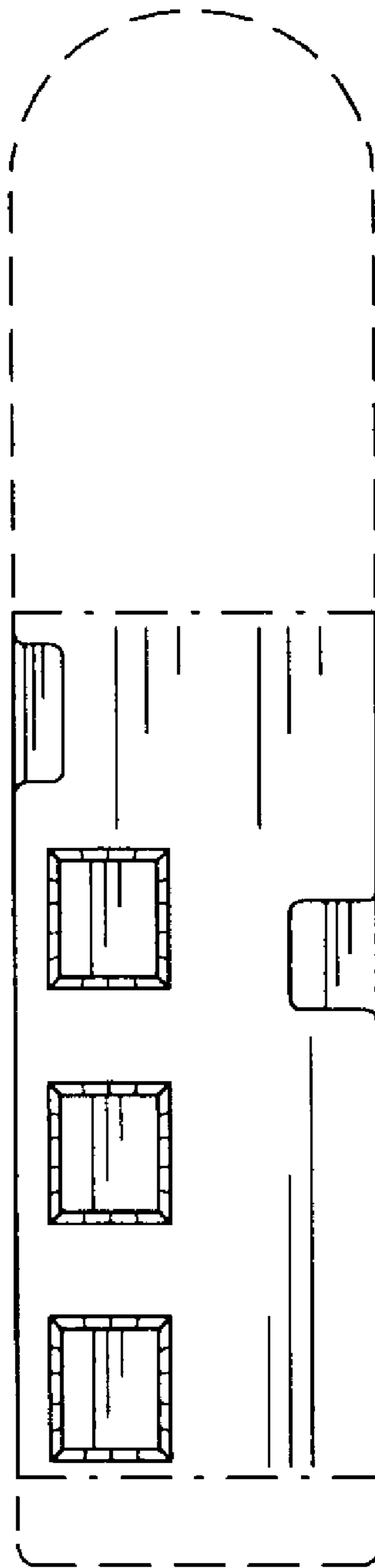

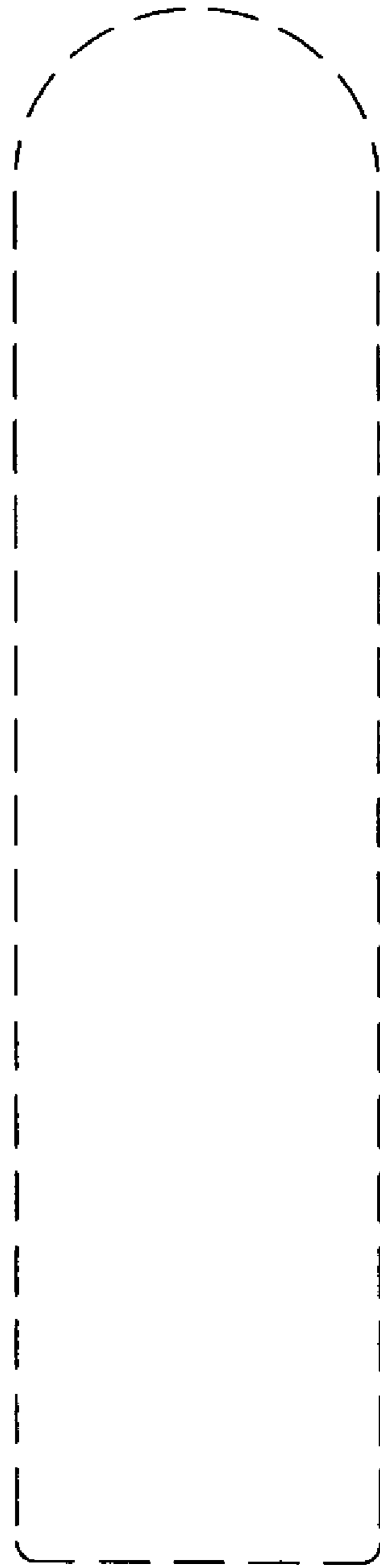
