The ornamental design for the media center extender, as shown and described.

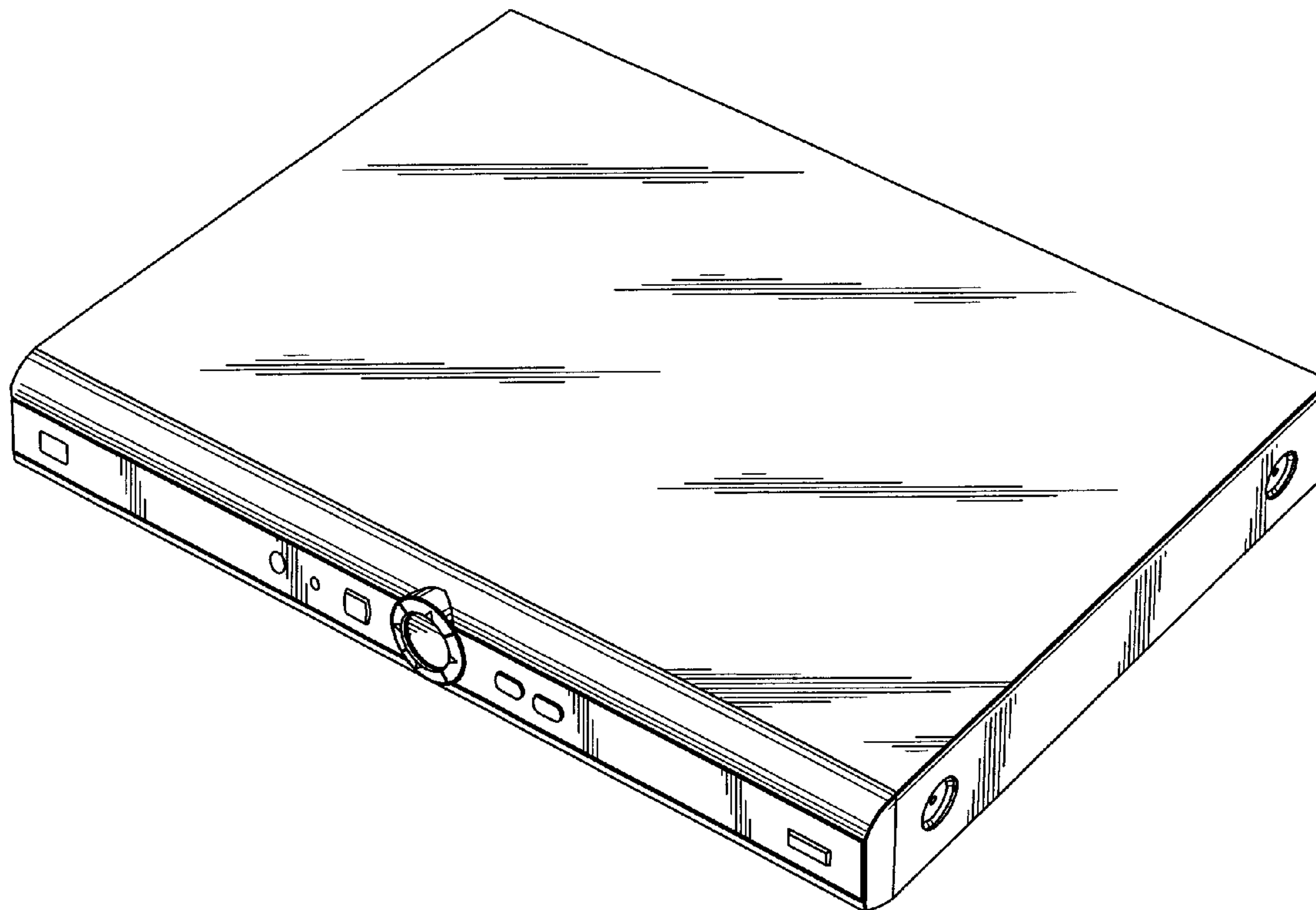
**DESCRIPTION**

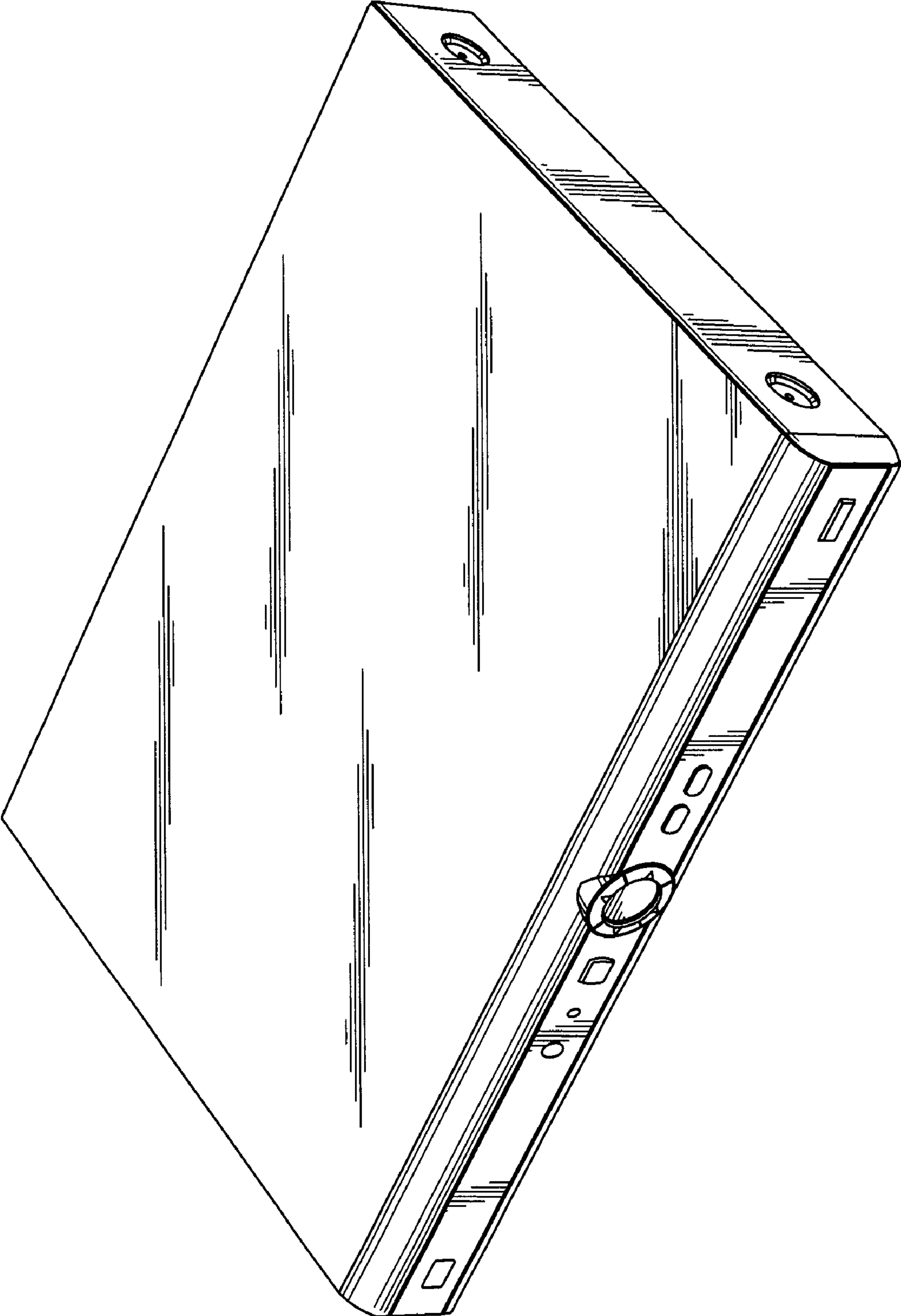

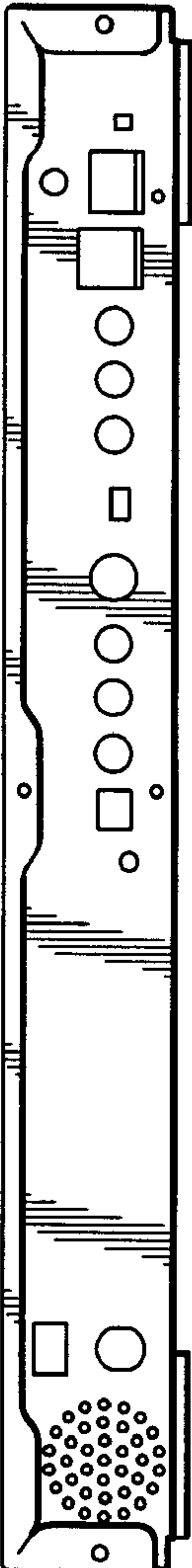

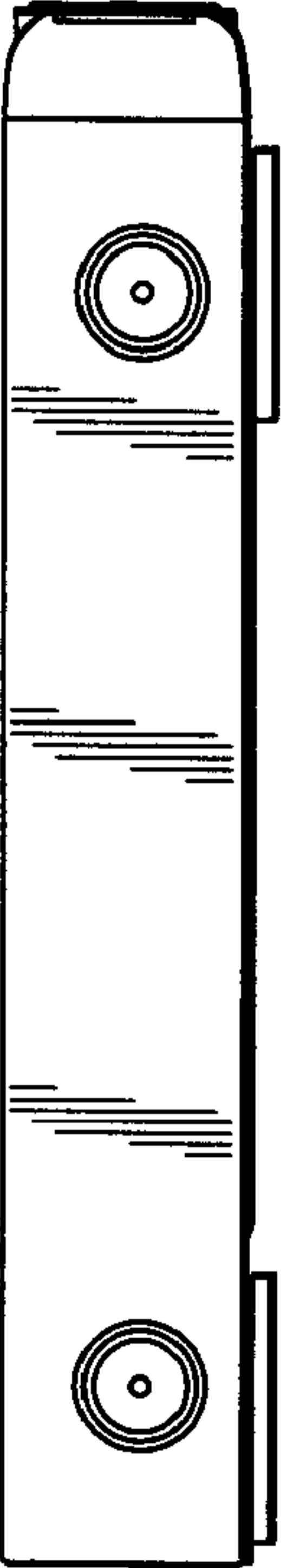

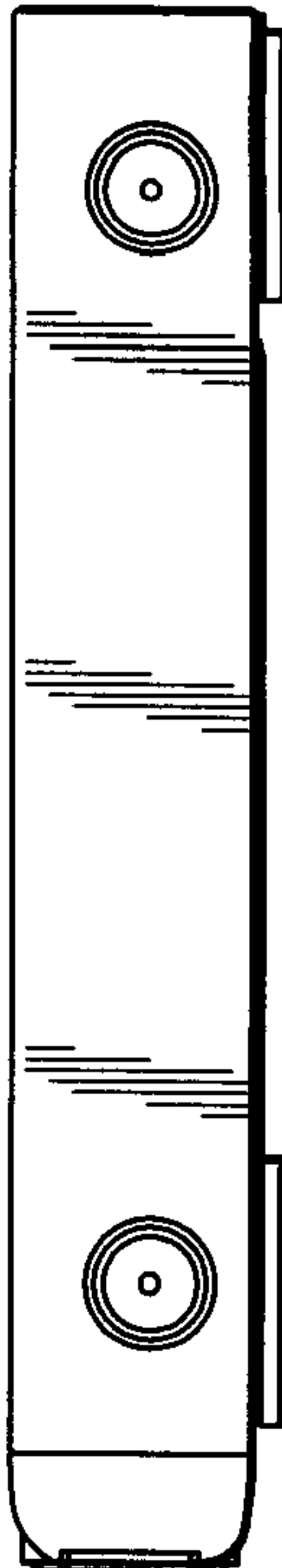

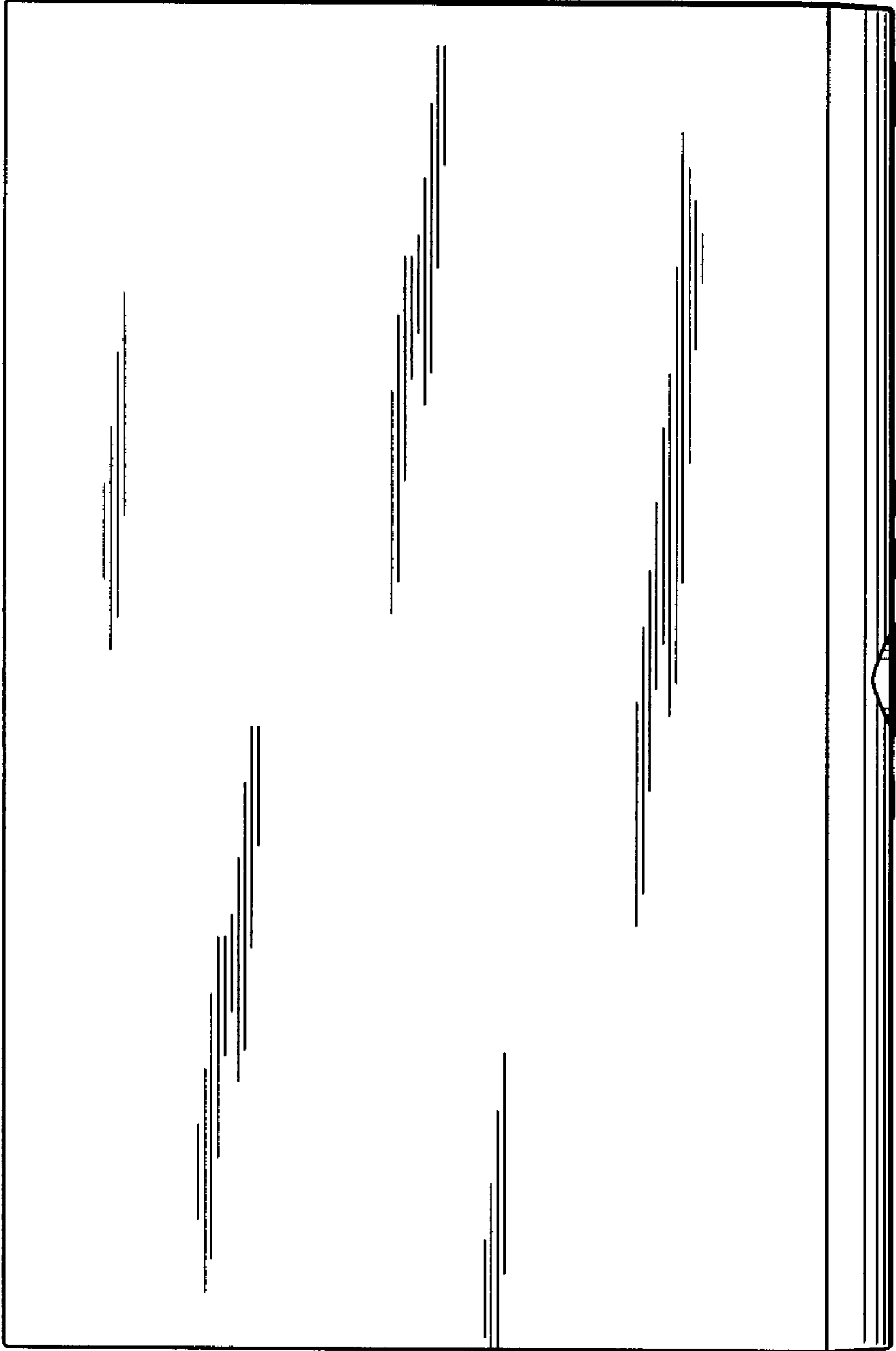

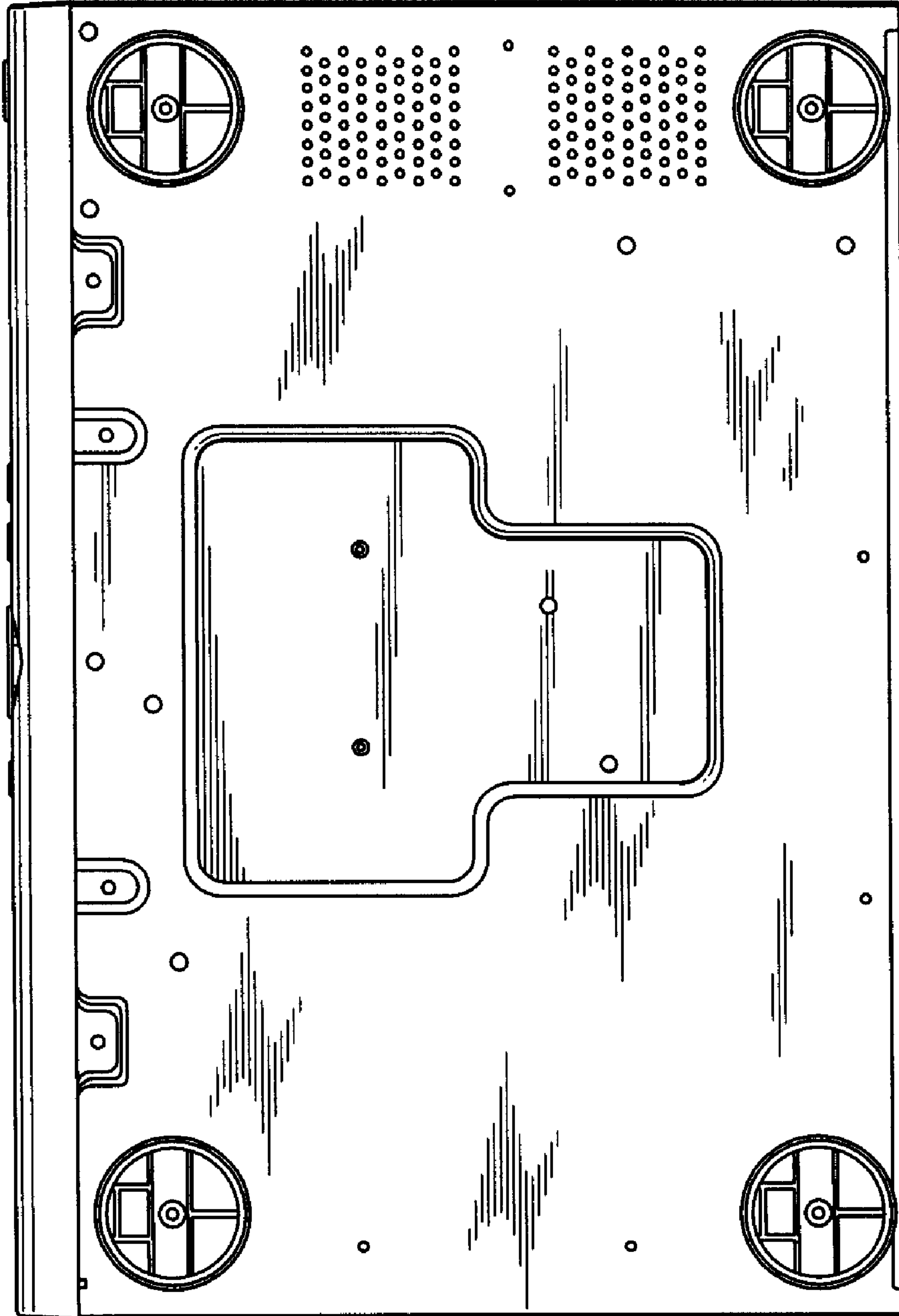
