I claim the ornamental design for a music system, as shown and described.

DESCRIPTION

FIG. 1 is a top, front, and right side perspective view of the new music system of the present invention, with the doors closed;

FIG. 20 is a top, rear, and left side perspective view thereof;

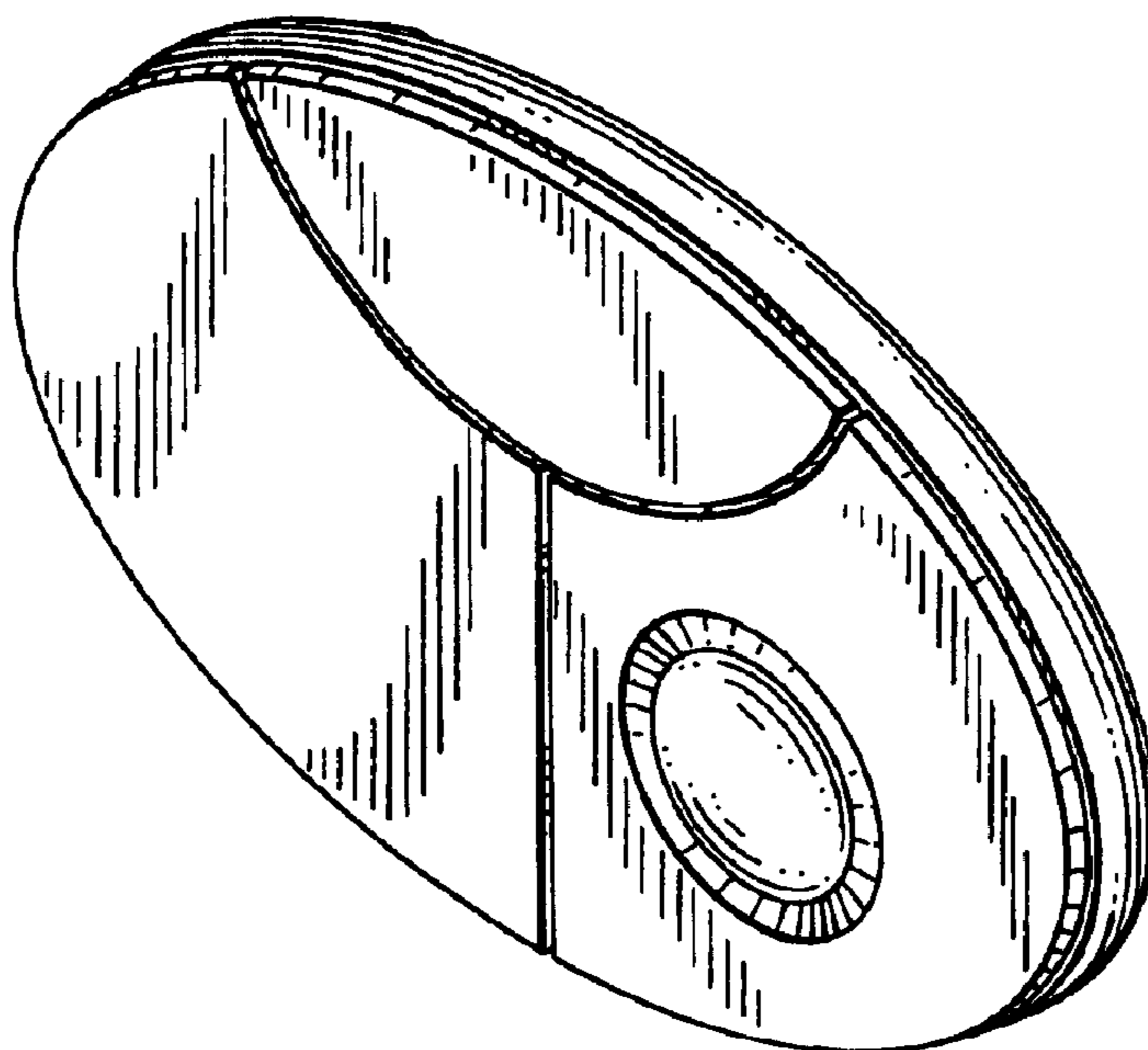
FIG. 21 is a rear view thereof;

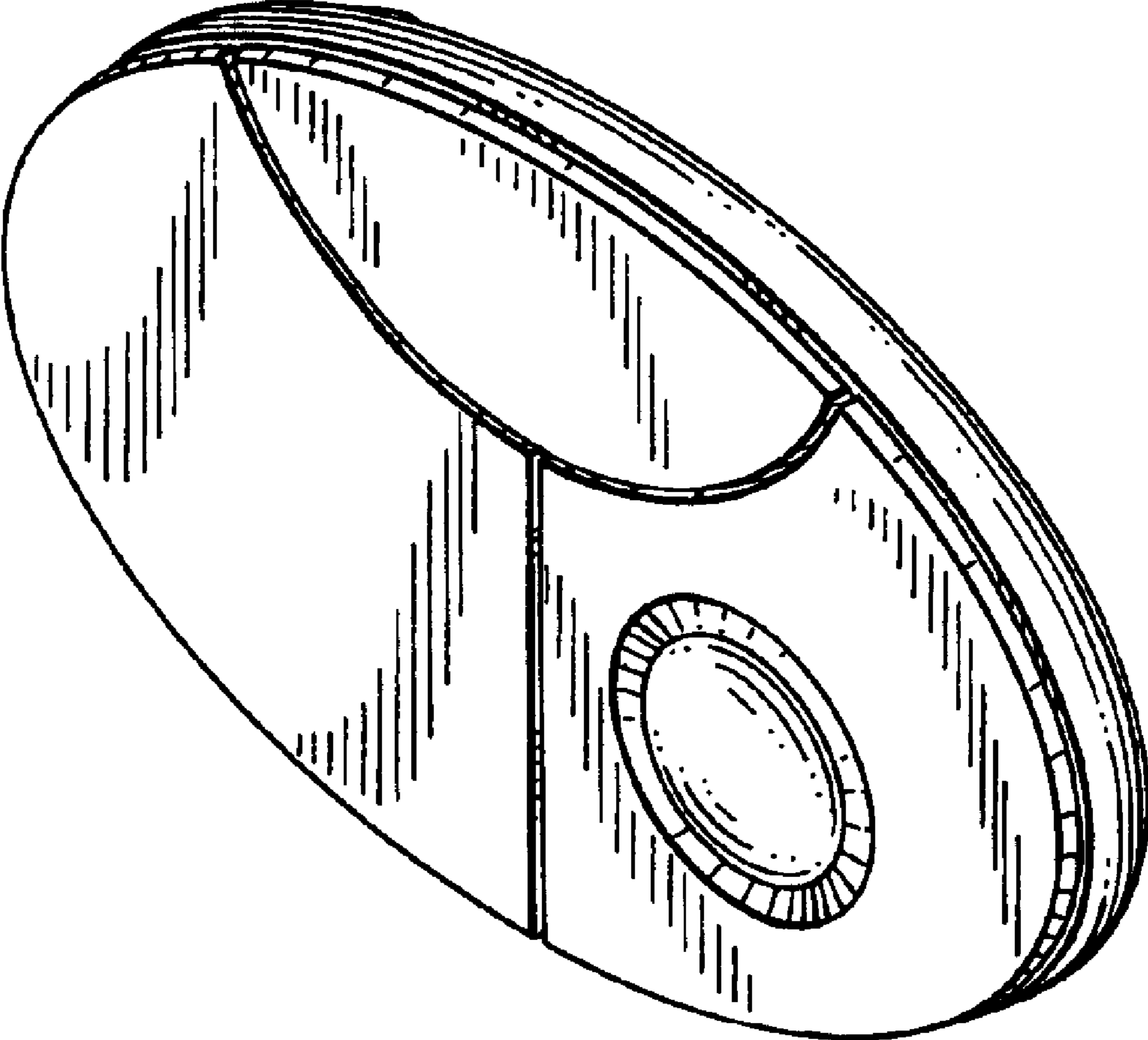

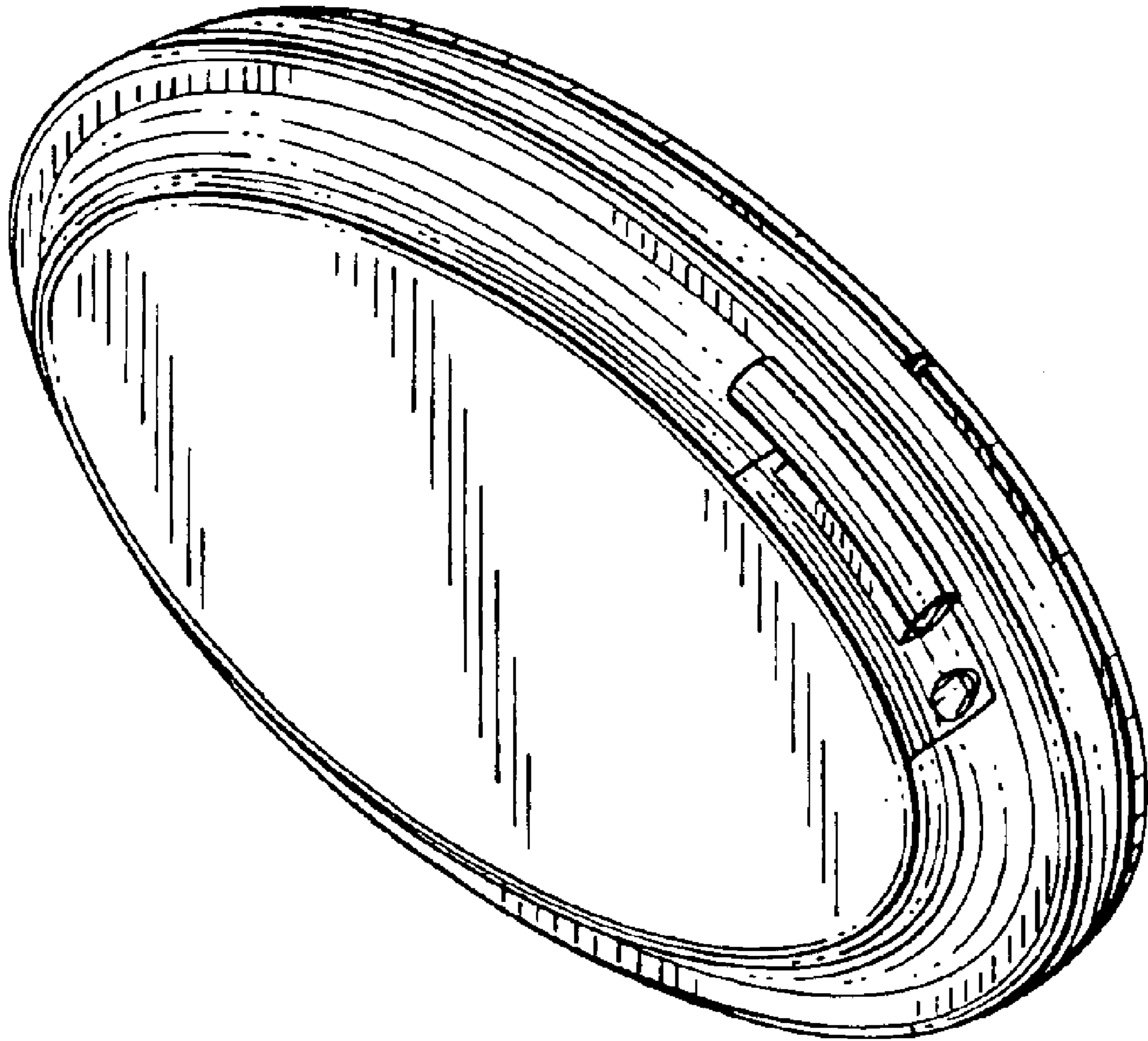

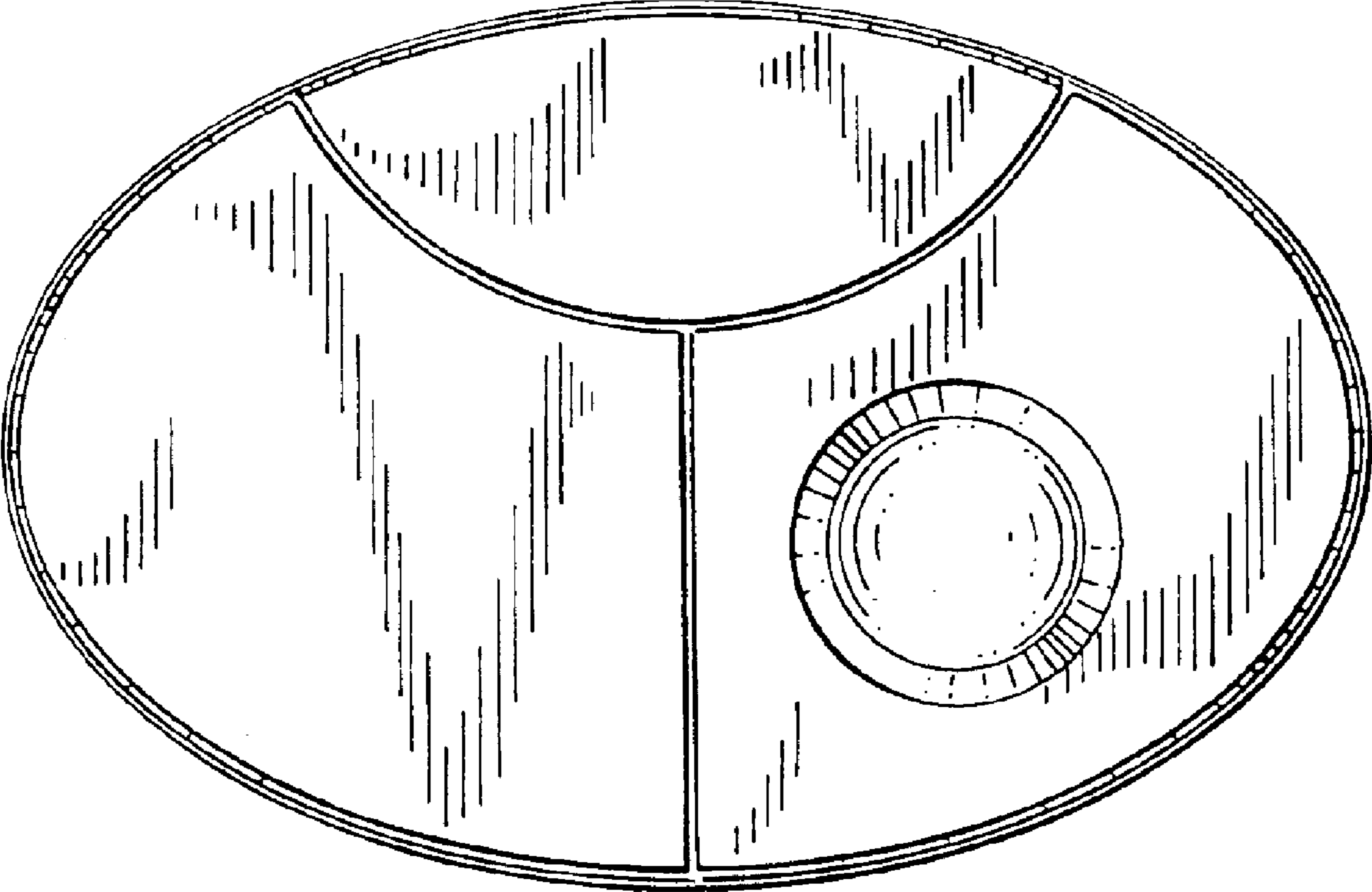

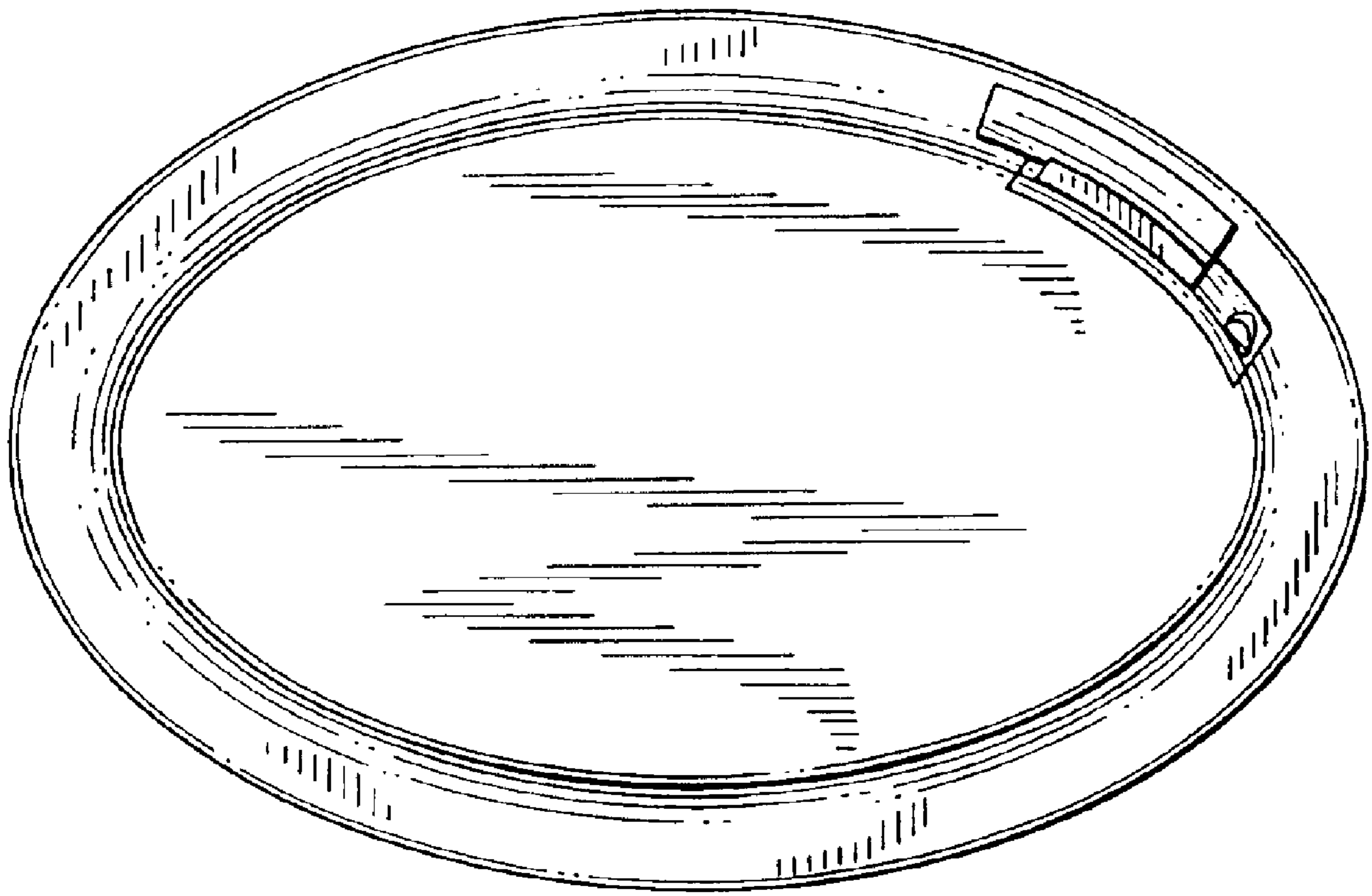

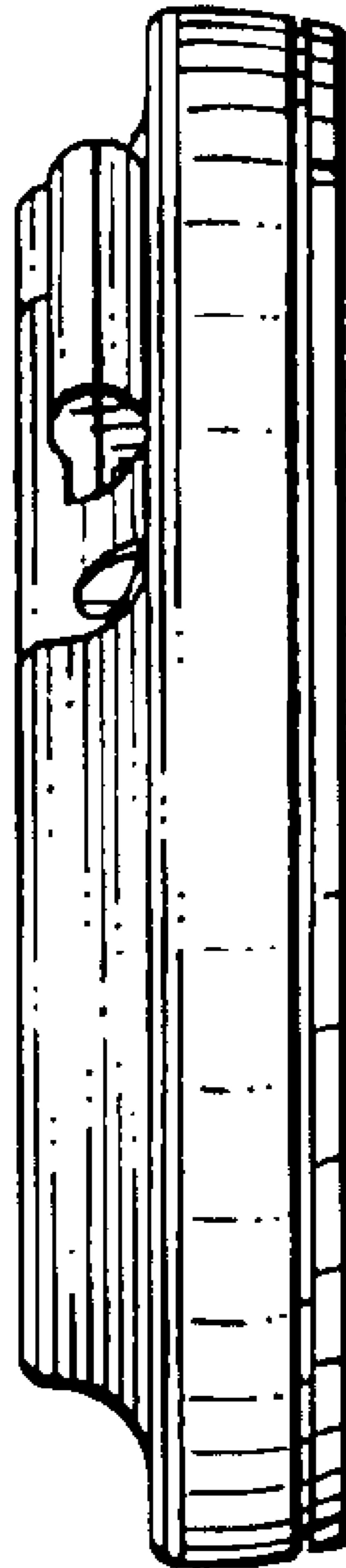

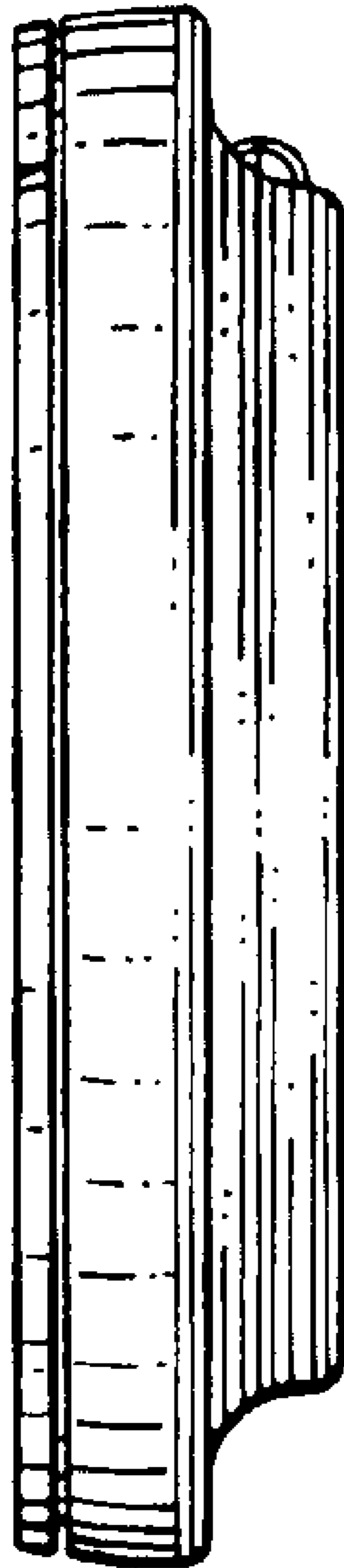

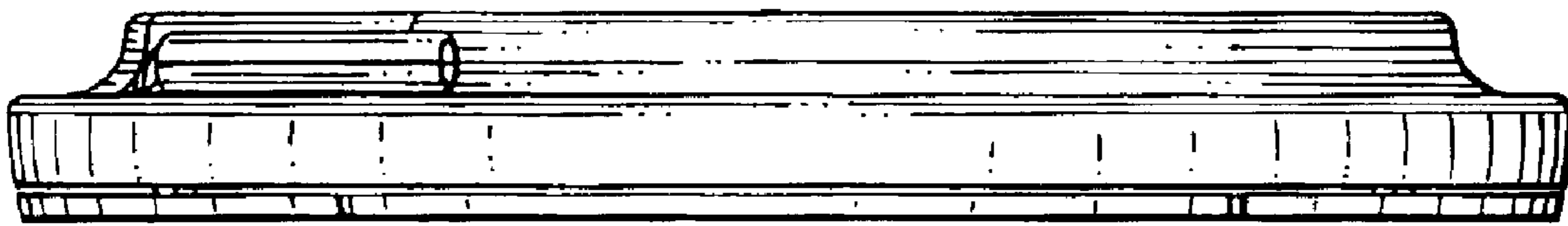

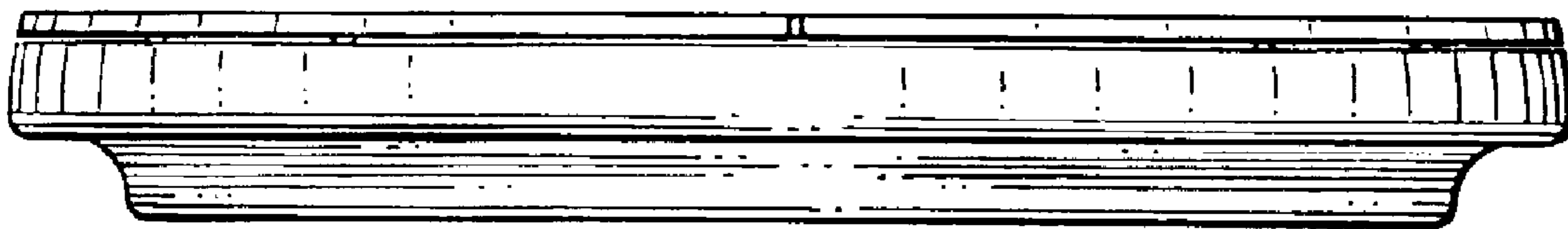

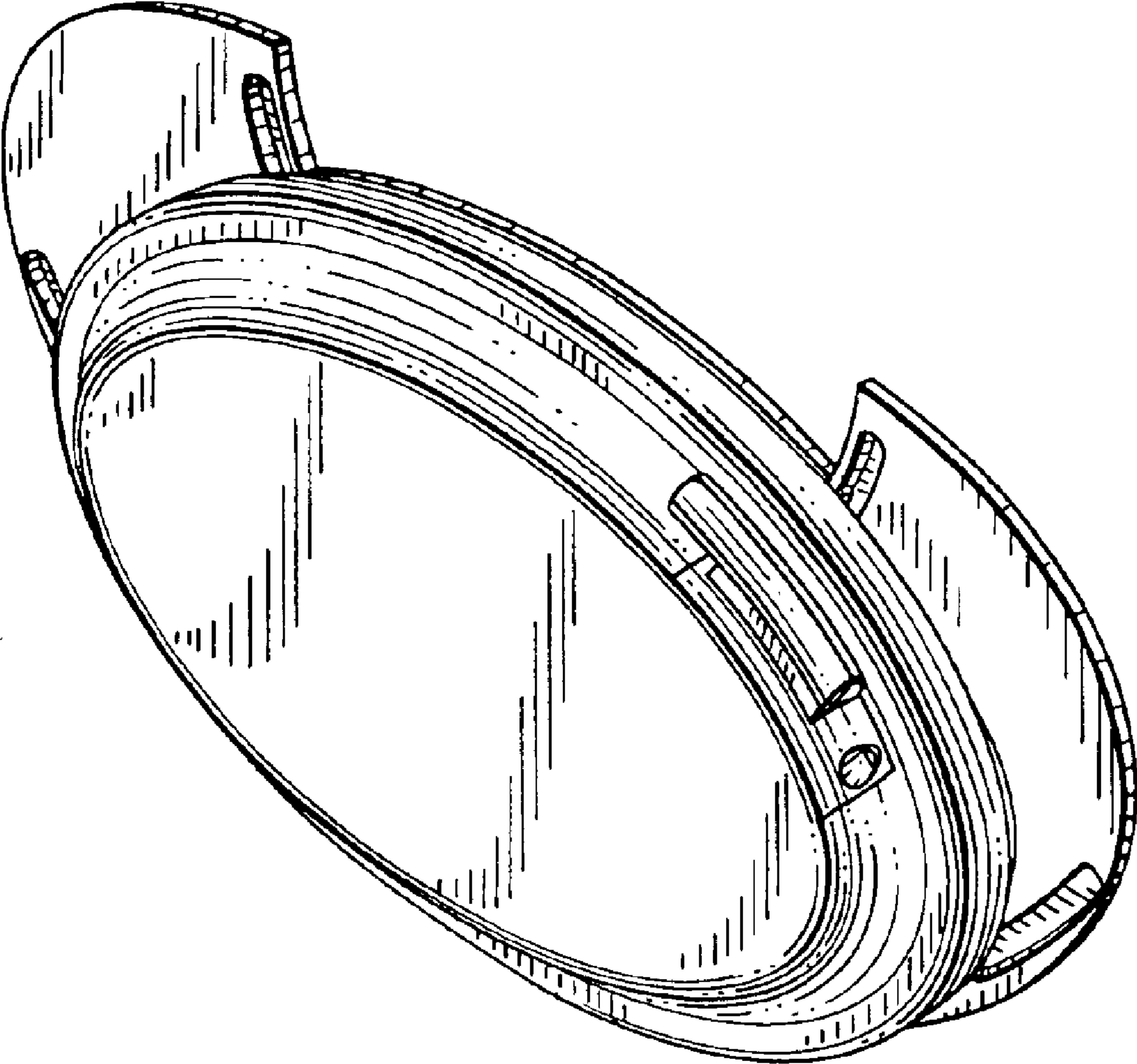

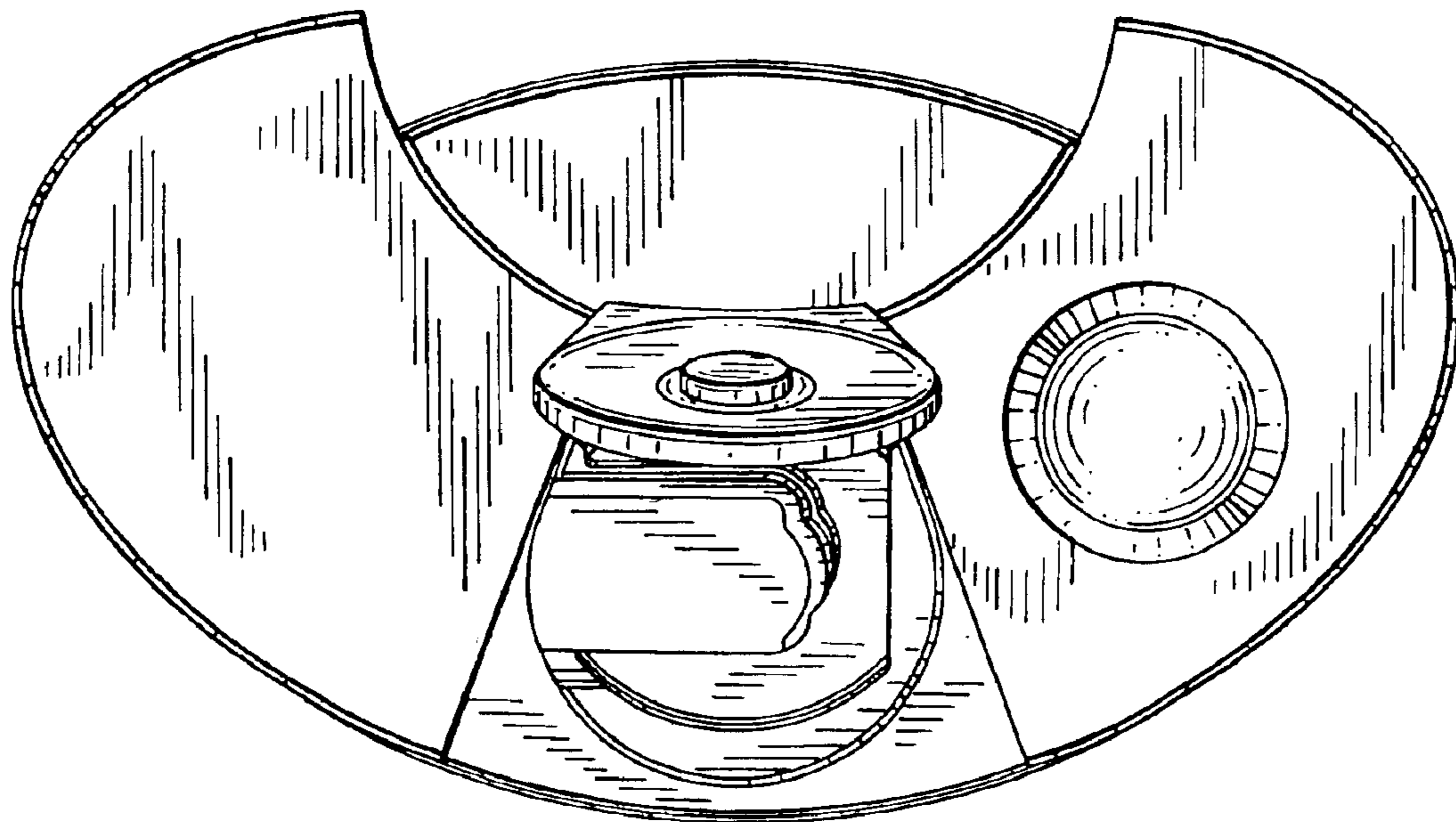

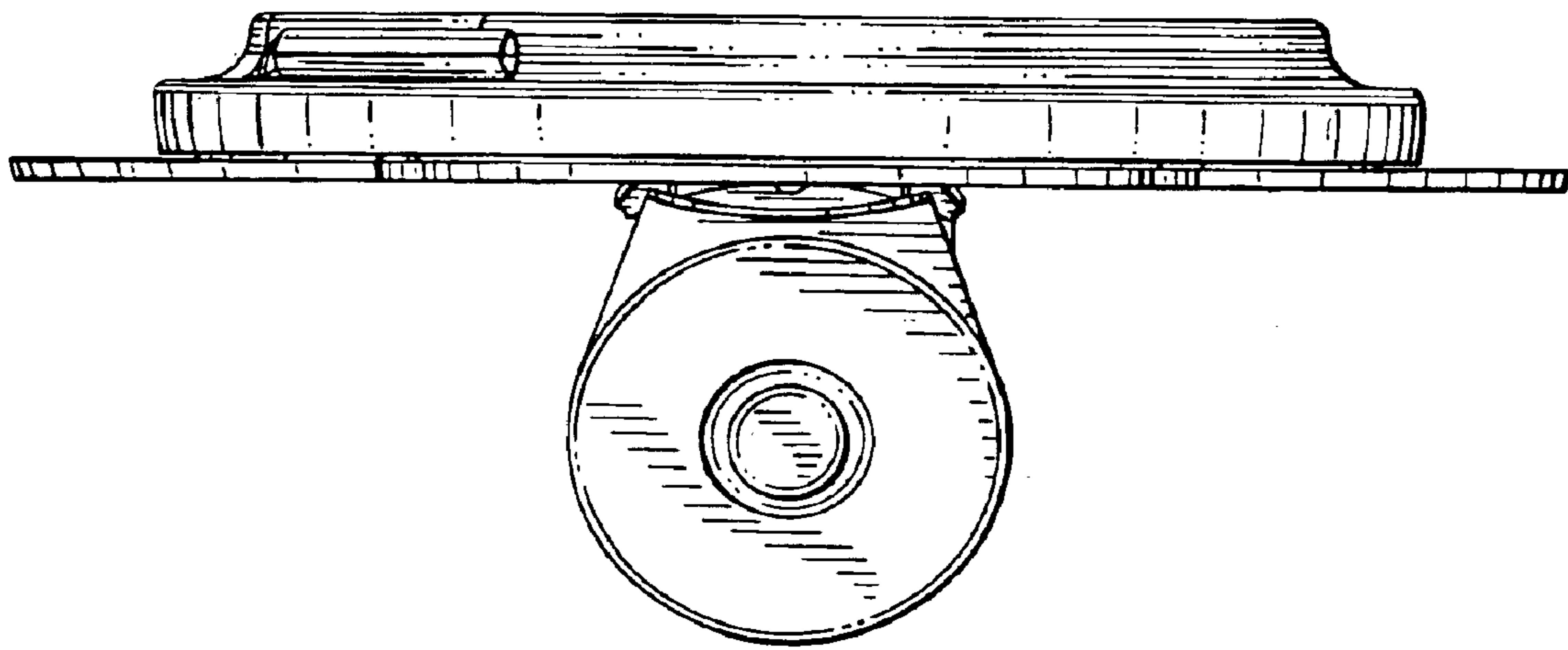

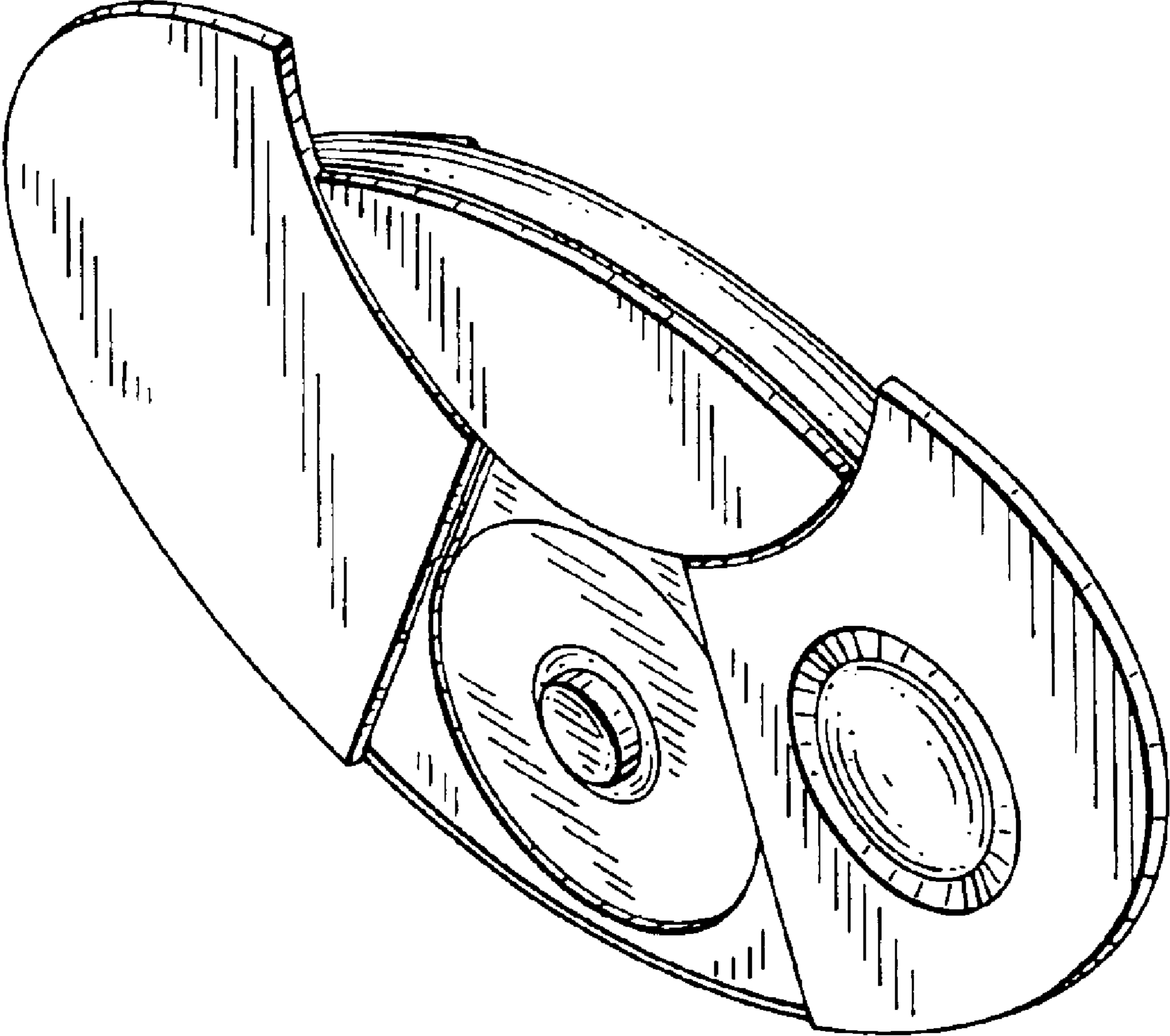

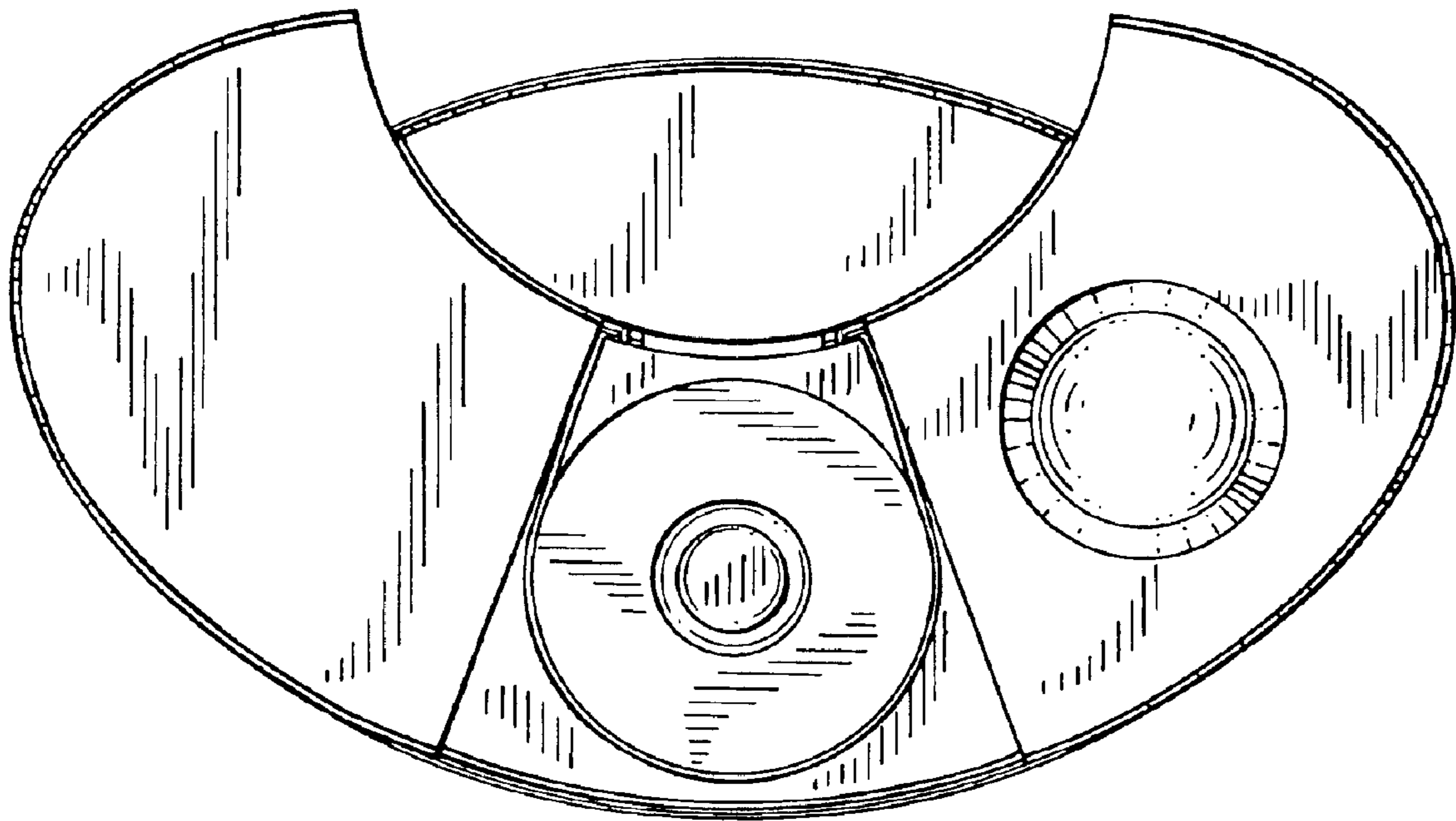

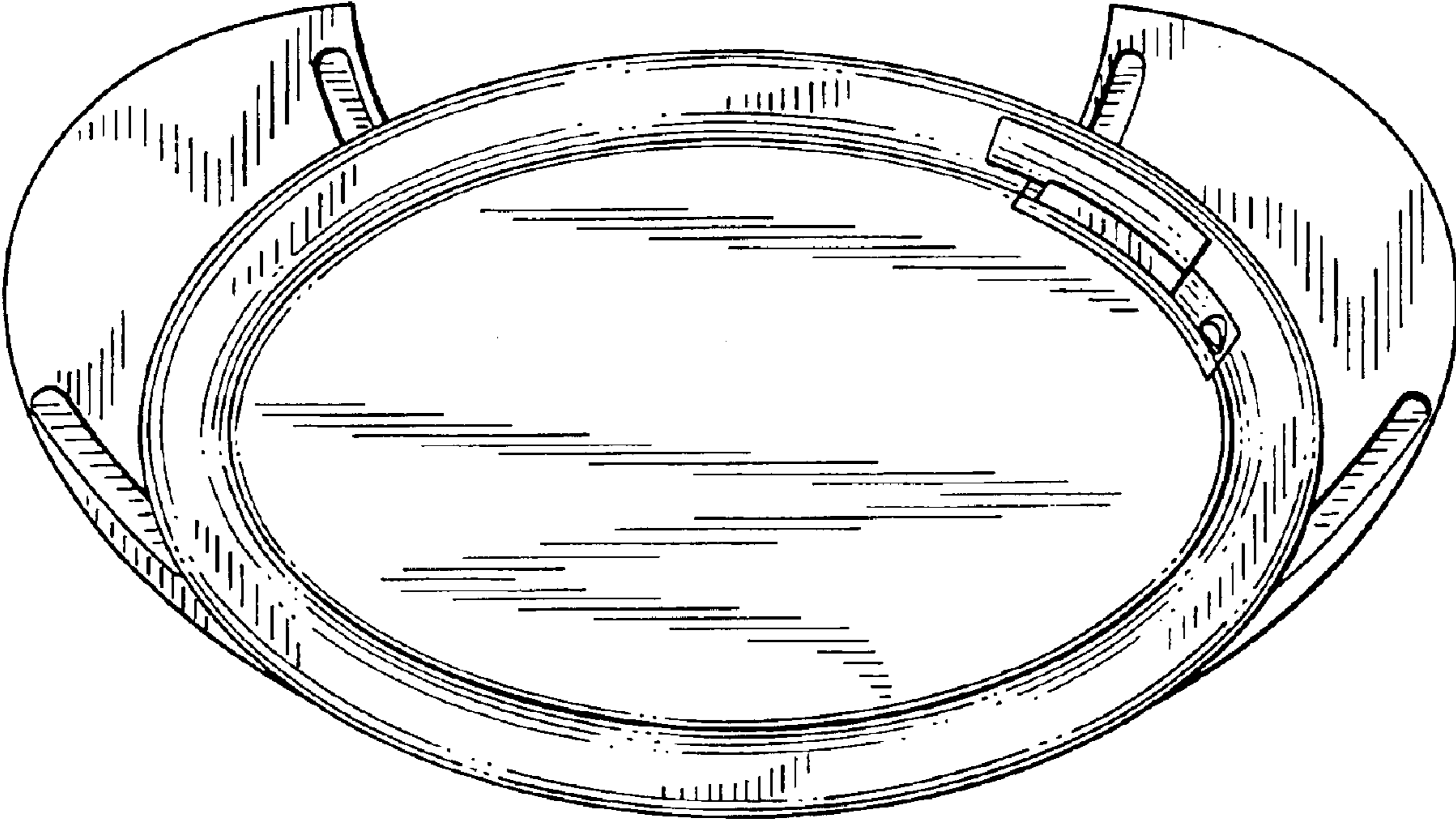

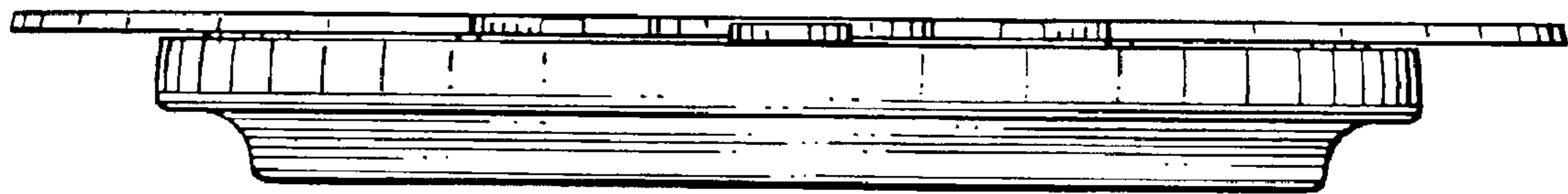

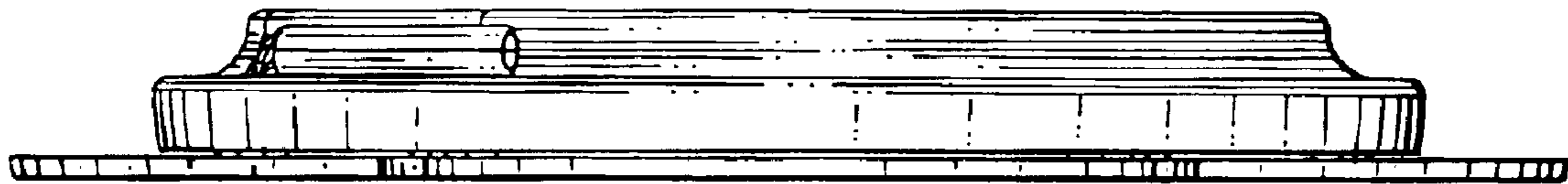

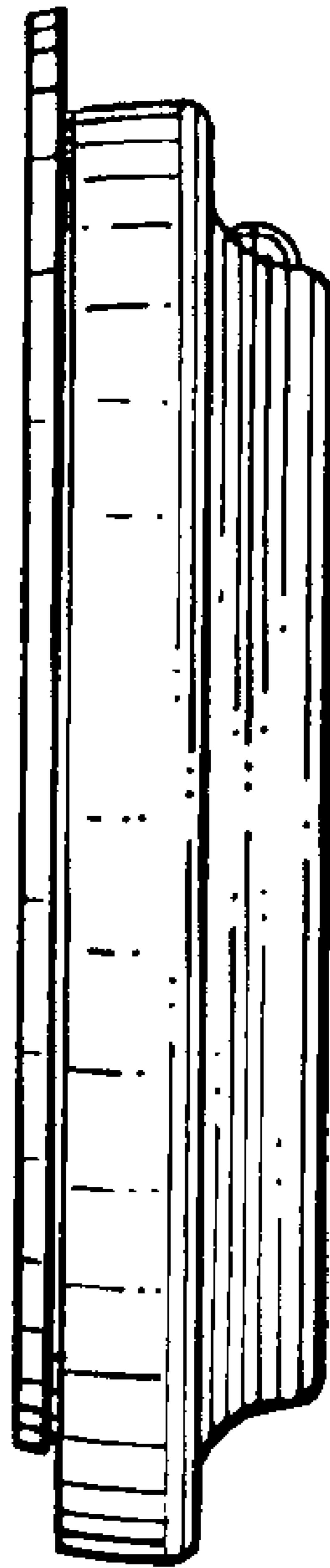

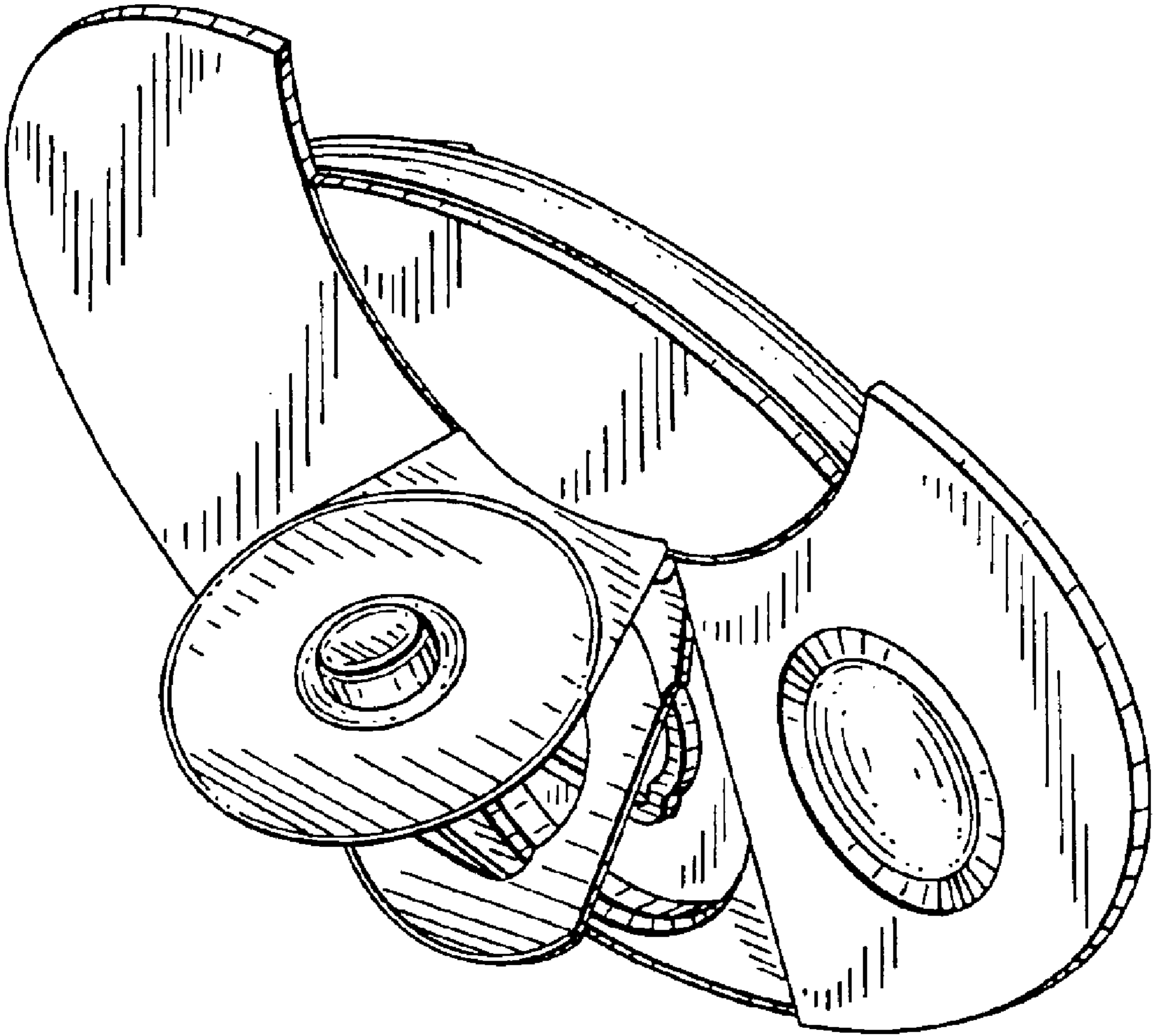

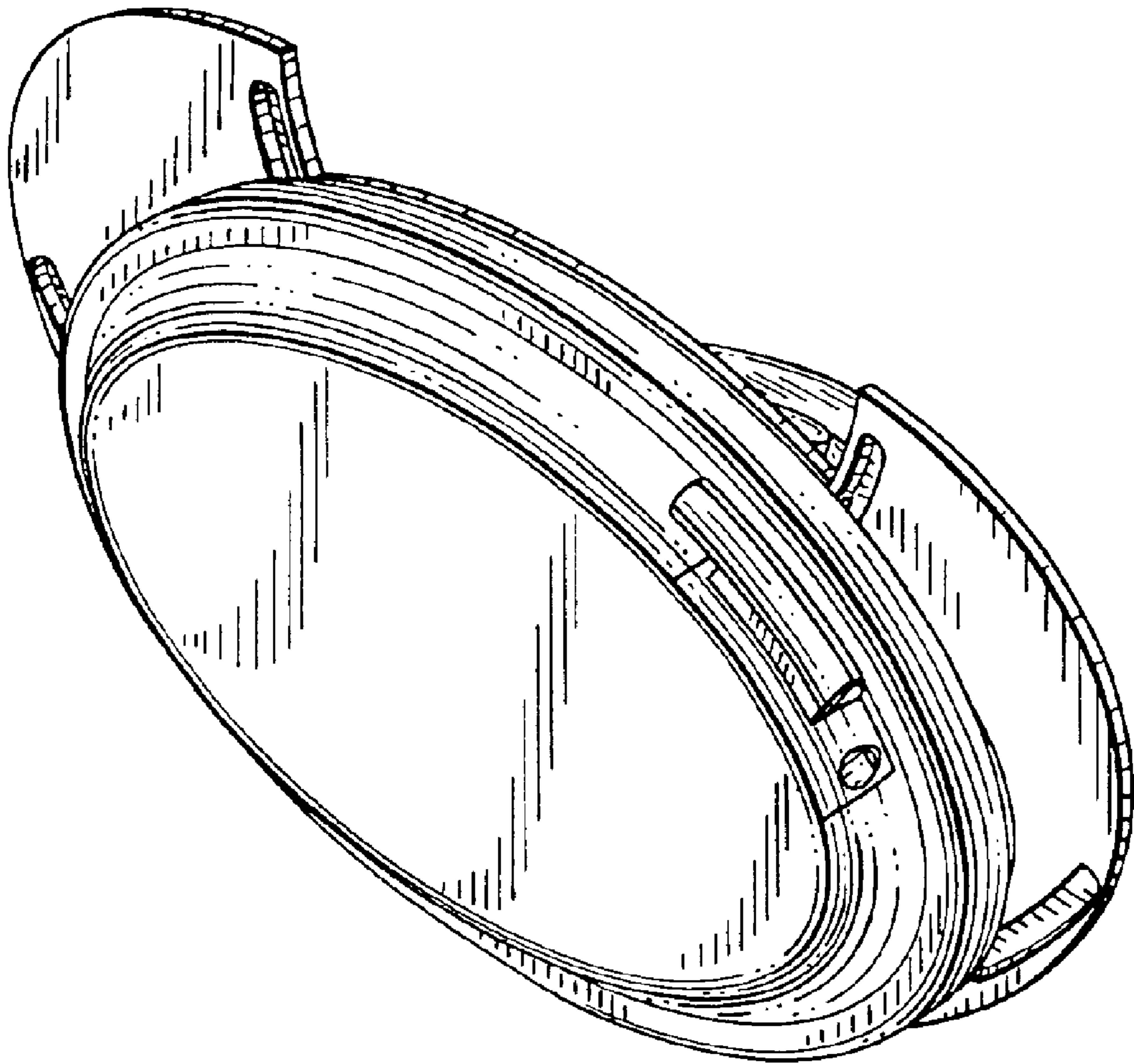

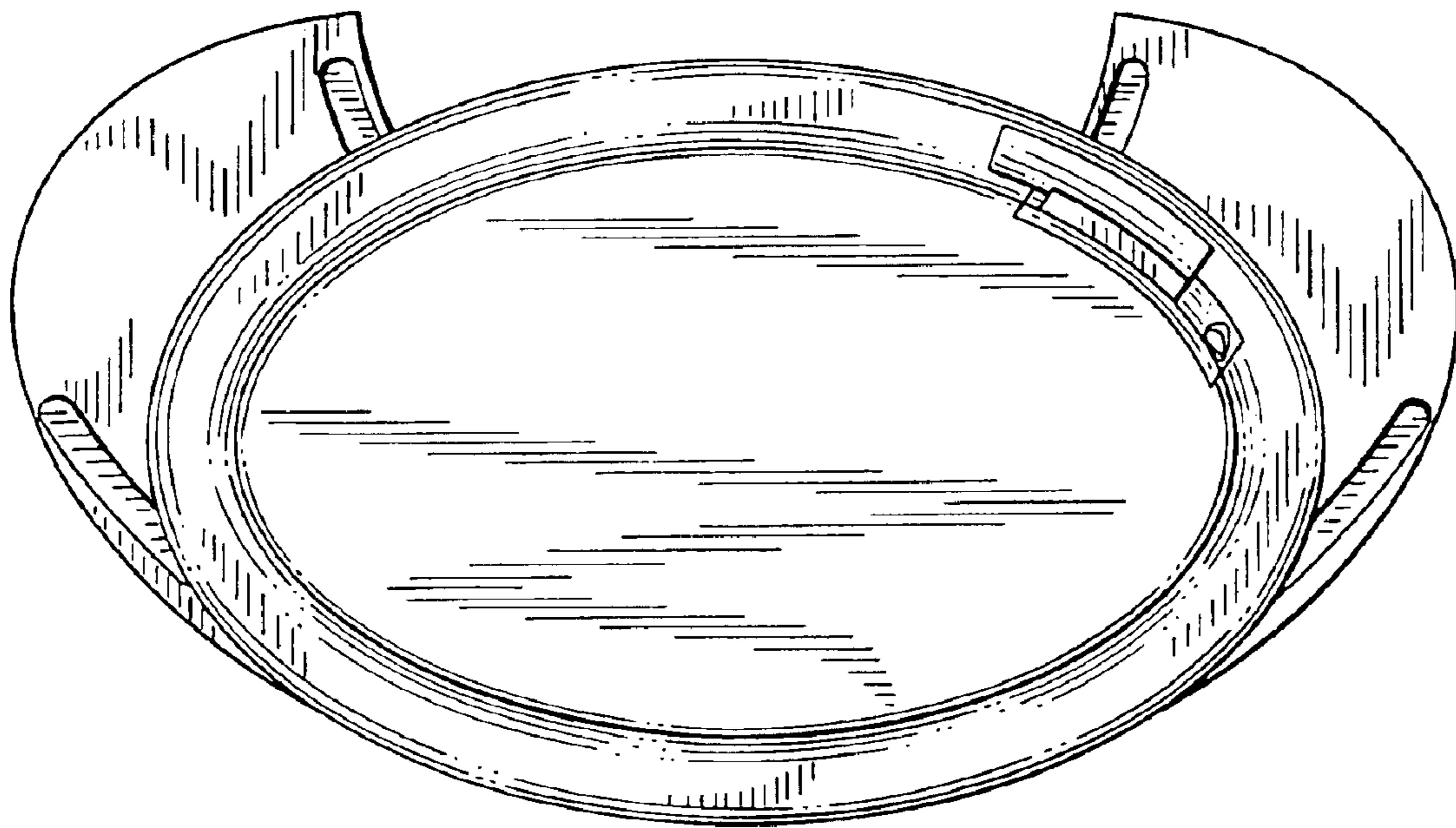

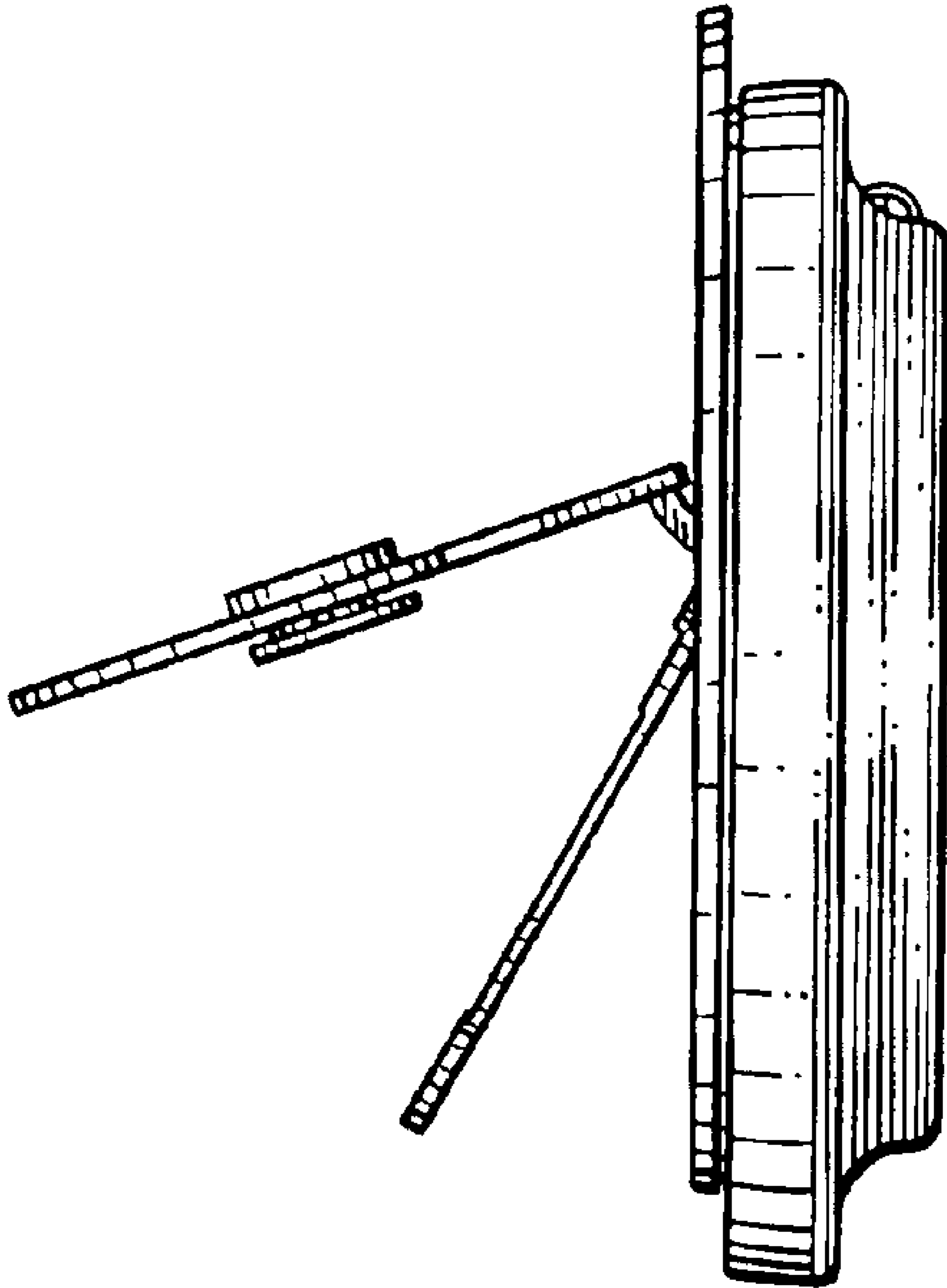

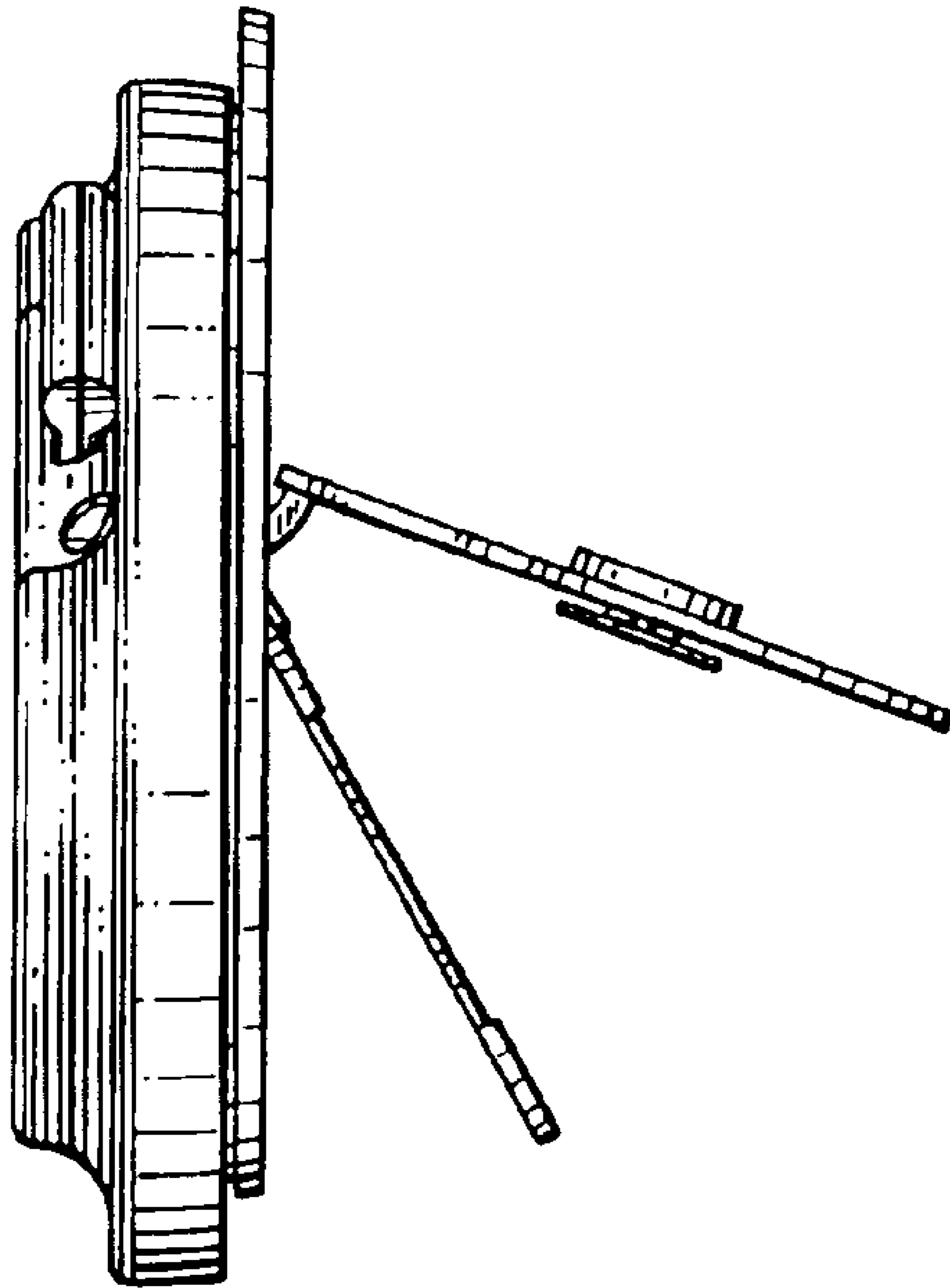

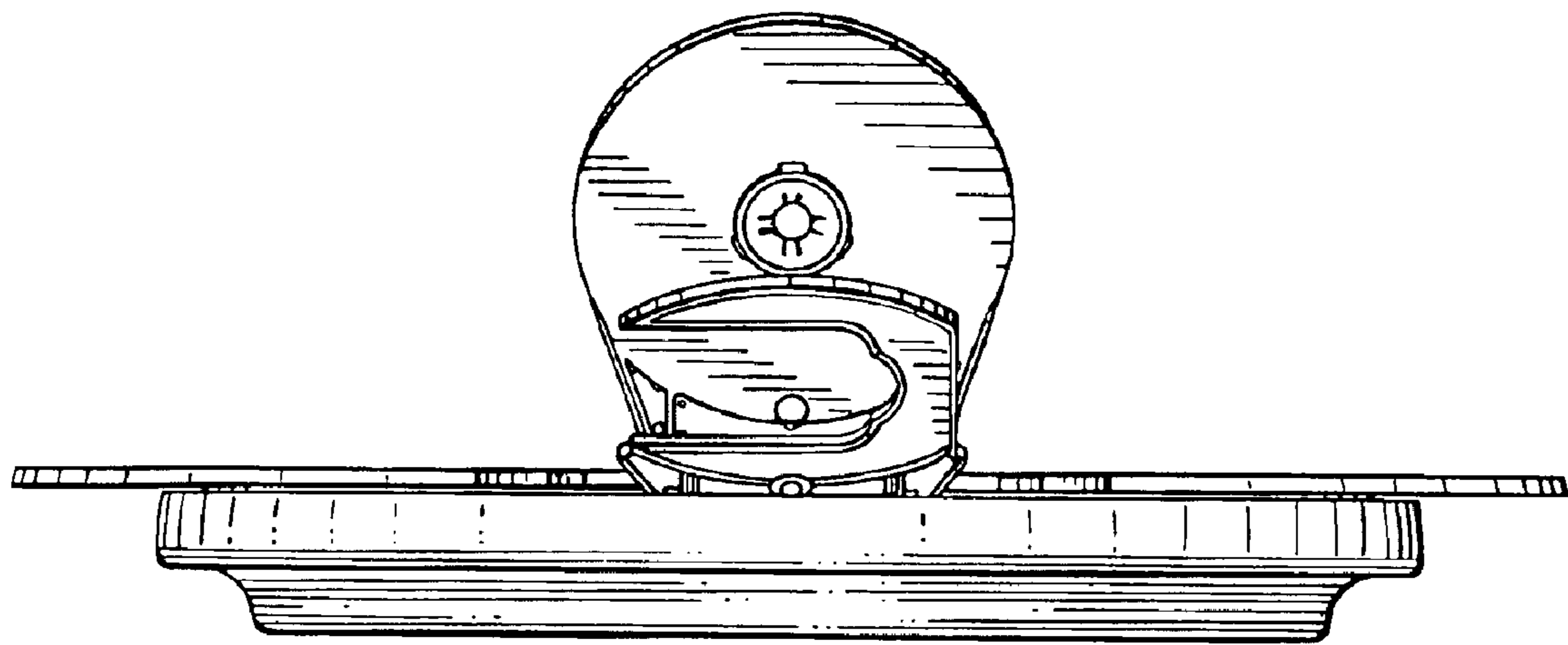
