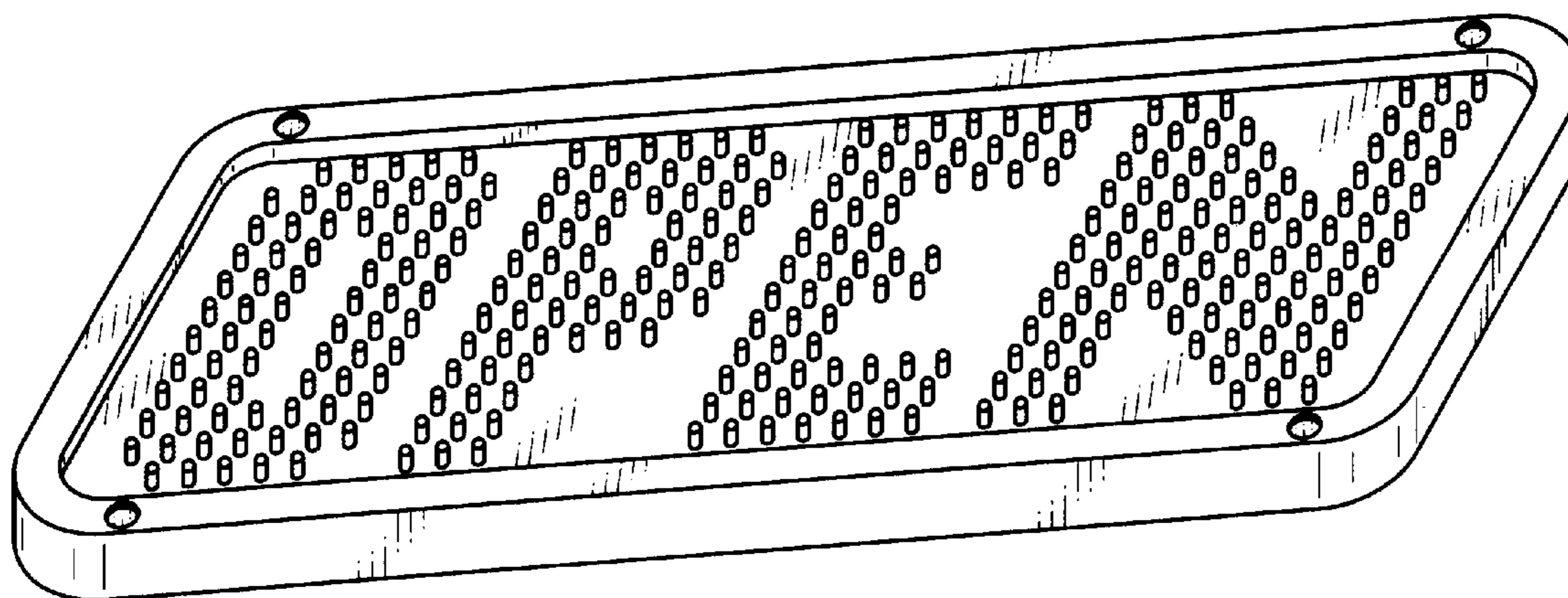
(57) **CLAIM**

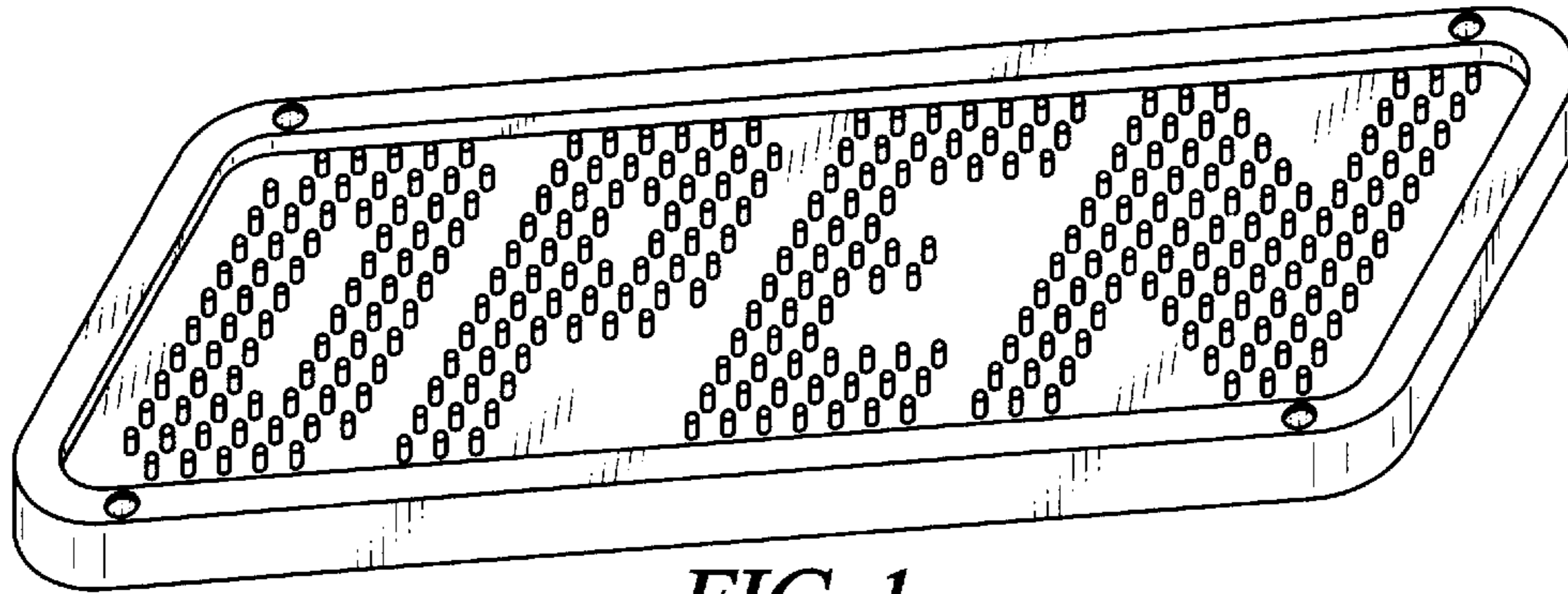
The ornamental design for a for a thin-mount slanted raised light sign, as shown and described.

**DESCRIPTION**

FIG. 1 is an isometric top view of a thin-mount slanted raised light sign showing my new design;

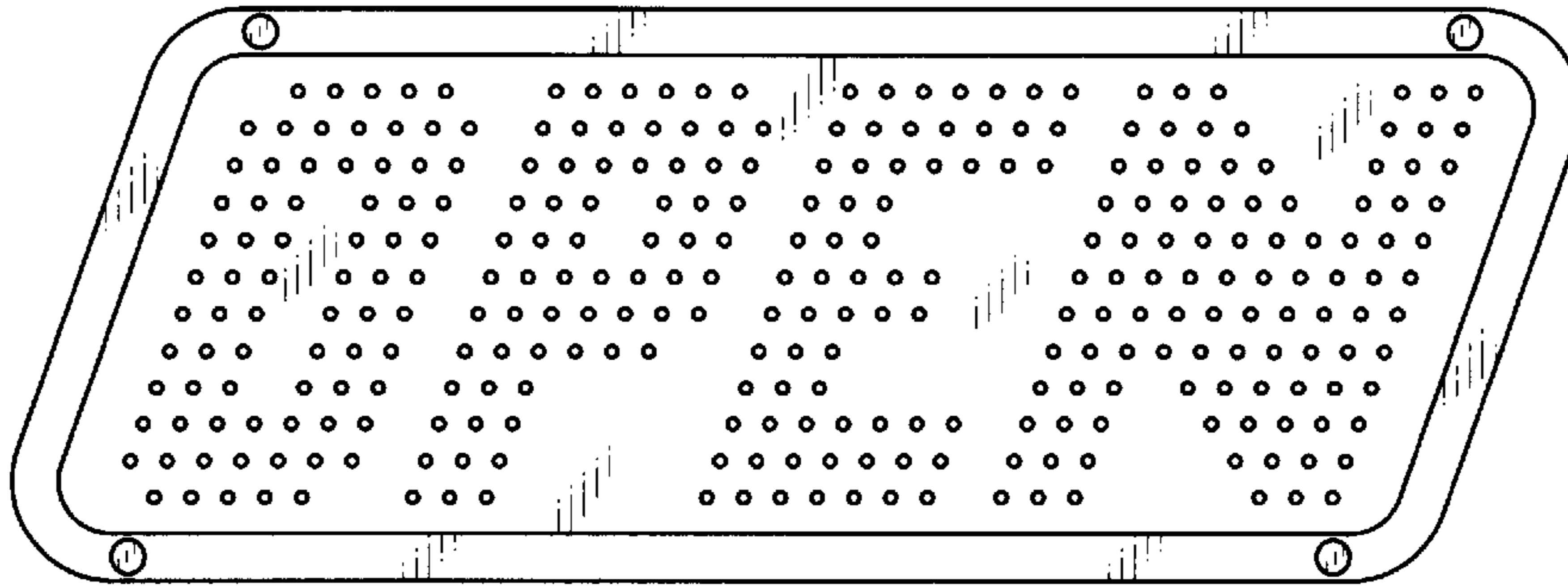

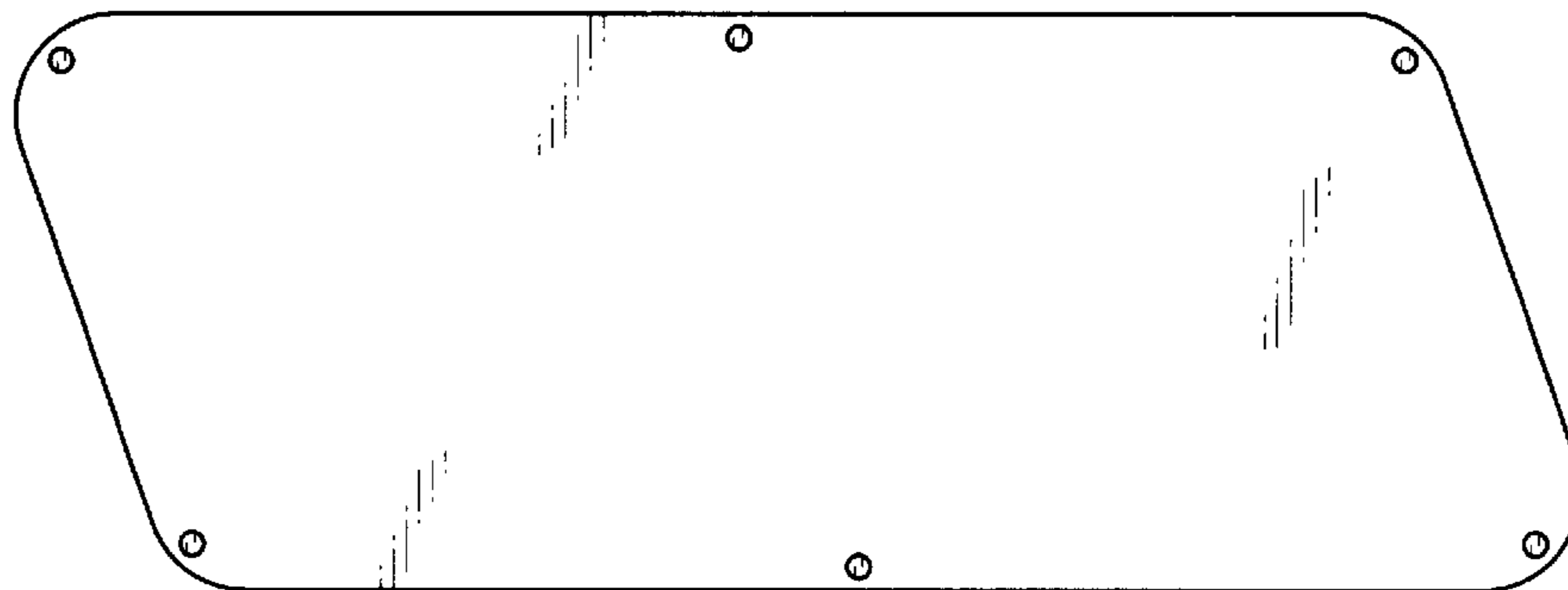
