(57) **CLAIM**

The ornamental design for a golf club head, as shown.

DESCRIPTION

FIG. 1 is a perspective view of a first embodiment of a golf club head in accordance with my new design.

FIG. 2 is a front view of the first embodiment of the golf club head shown in FIG. 1.

FIG. 3 is a rear view of the first embodiment of the golf club head shown in FIG. 1.

FIG. 4 is a top view of the first embodiment of the golf club head shown in FIG. 1.

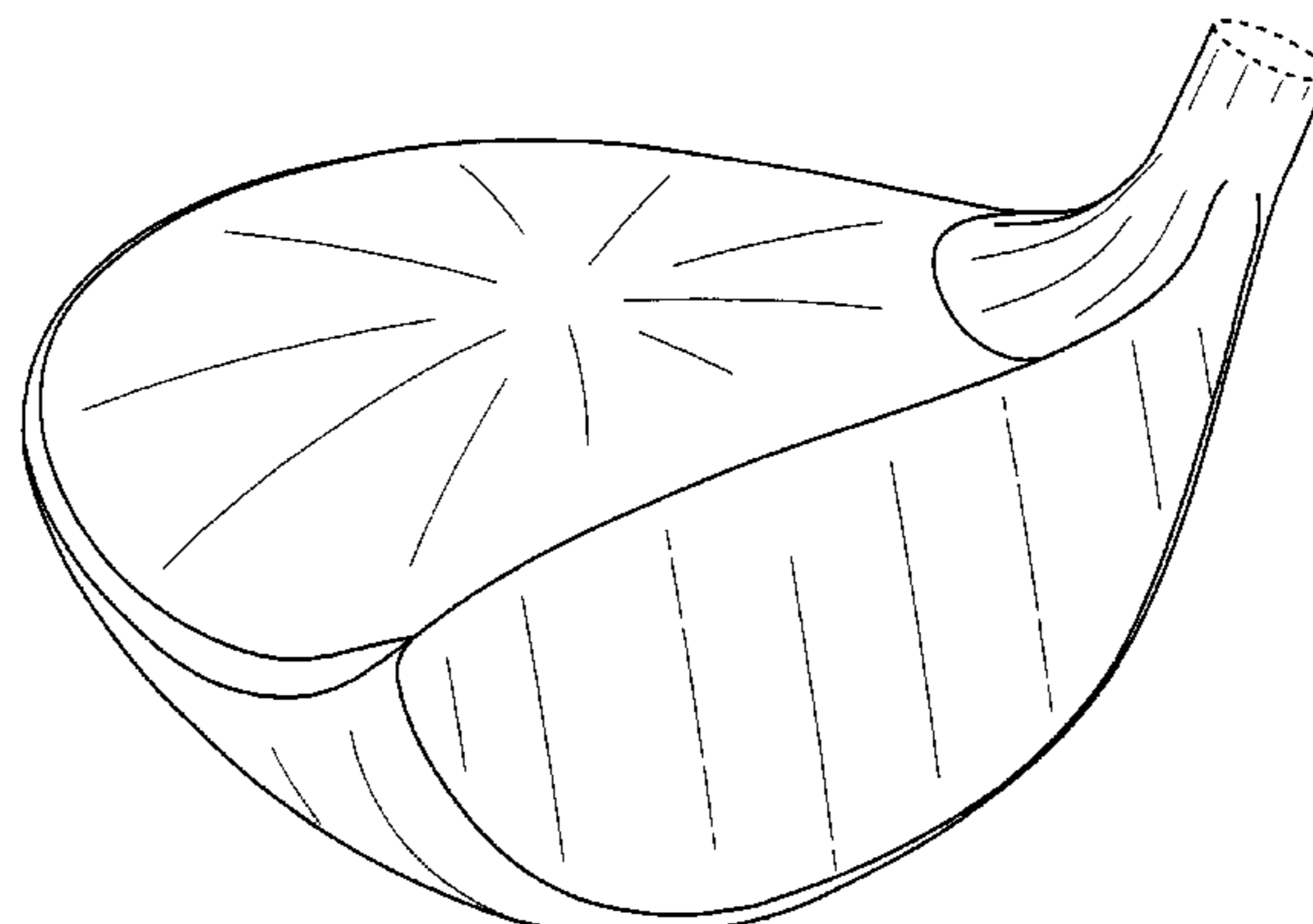

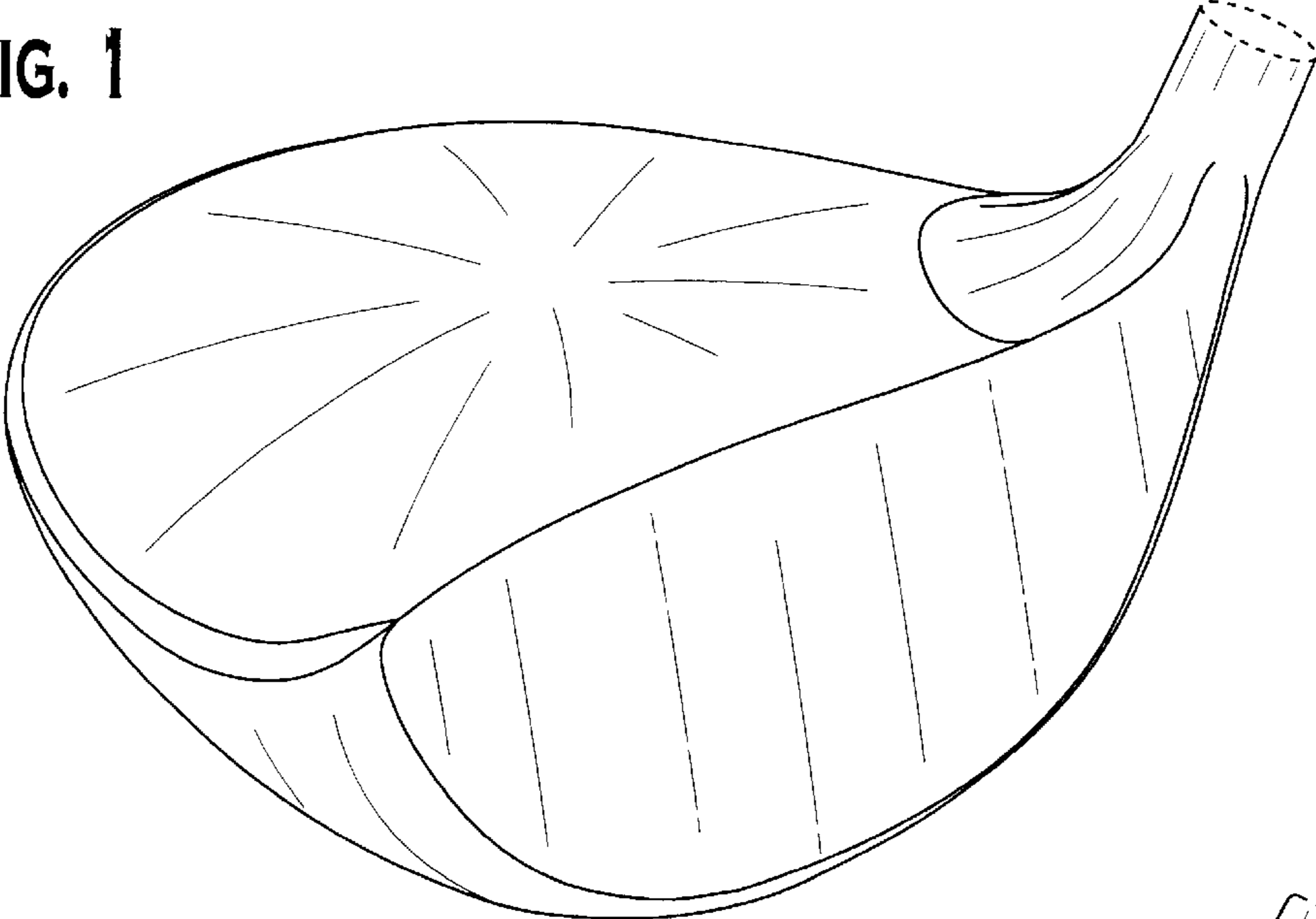

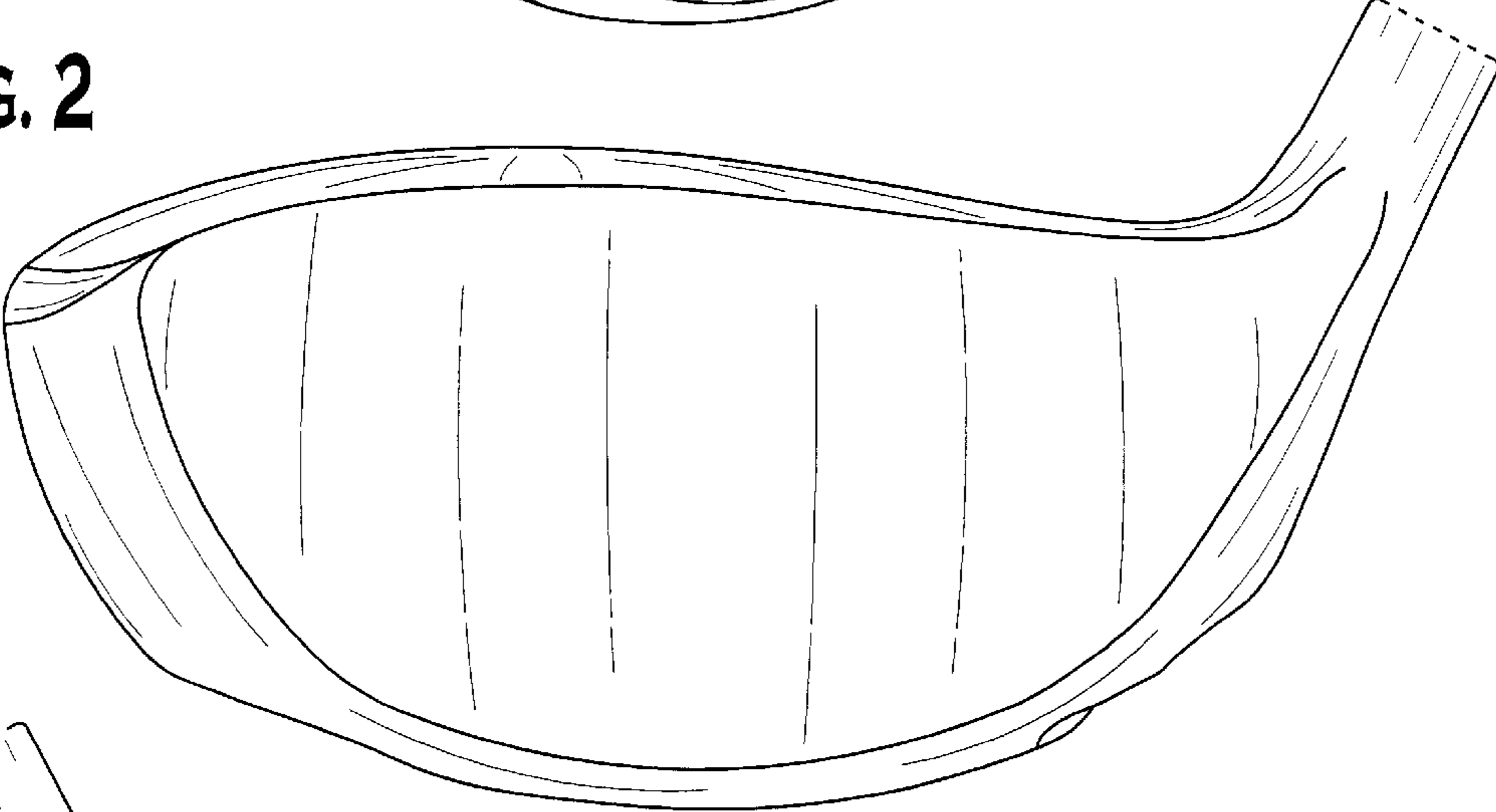

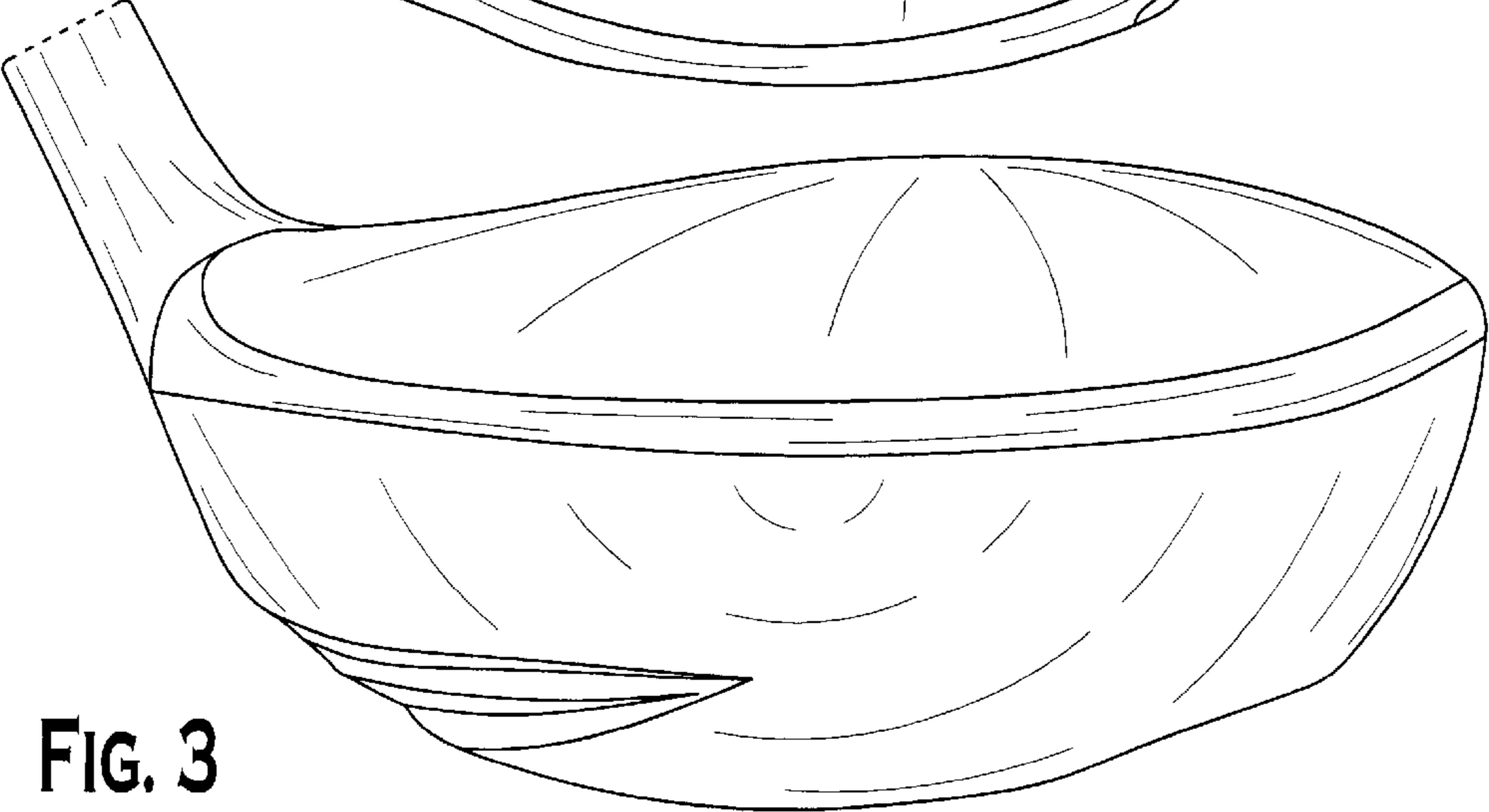

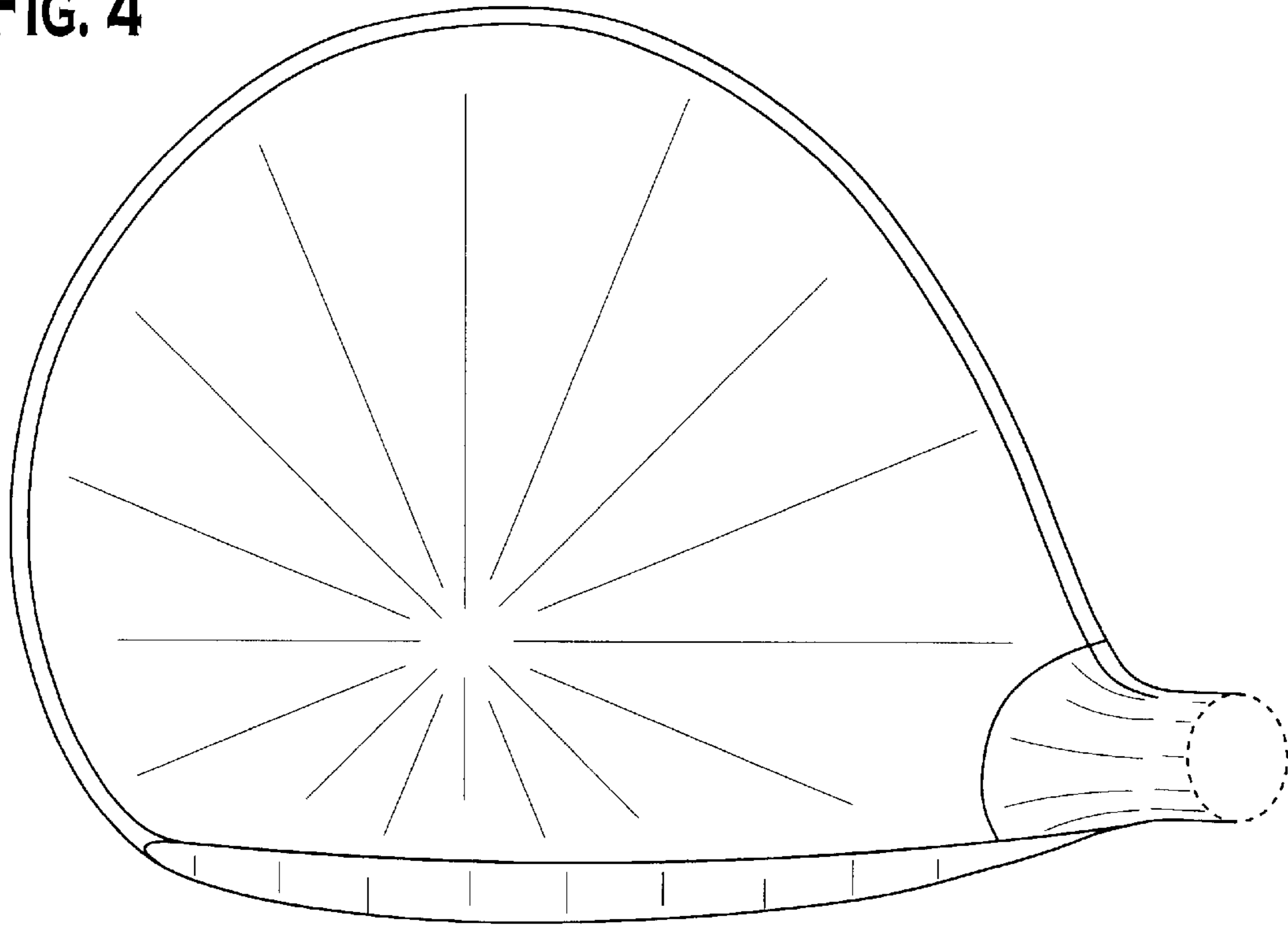

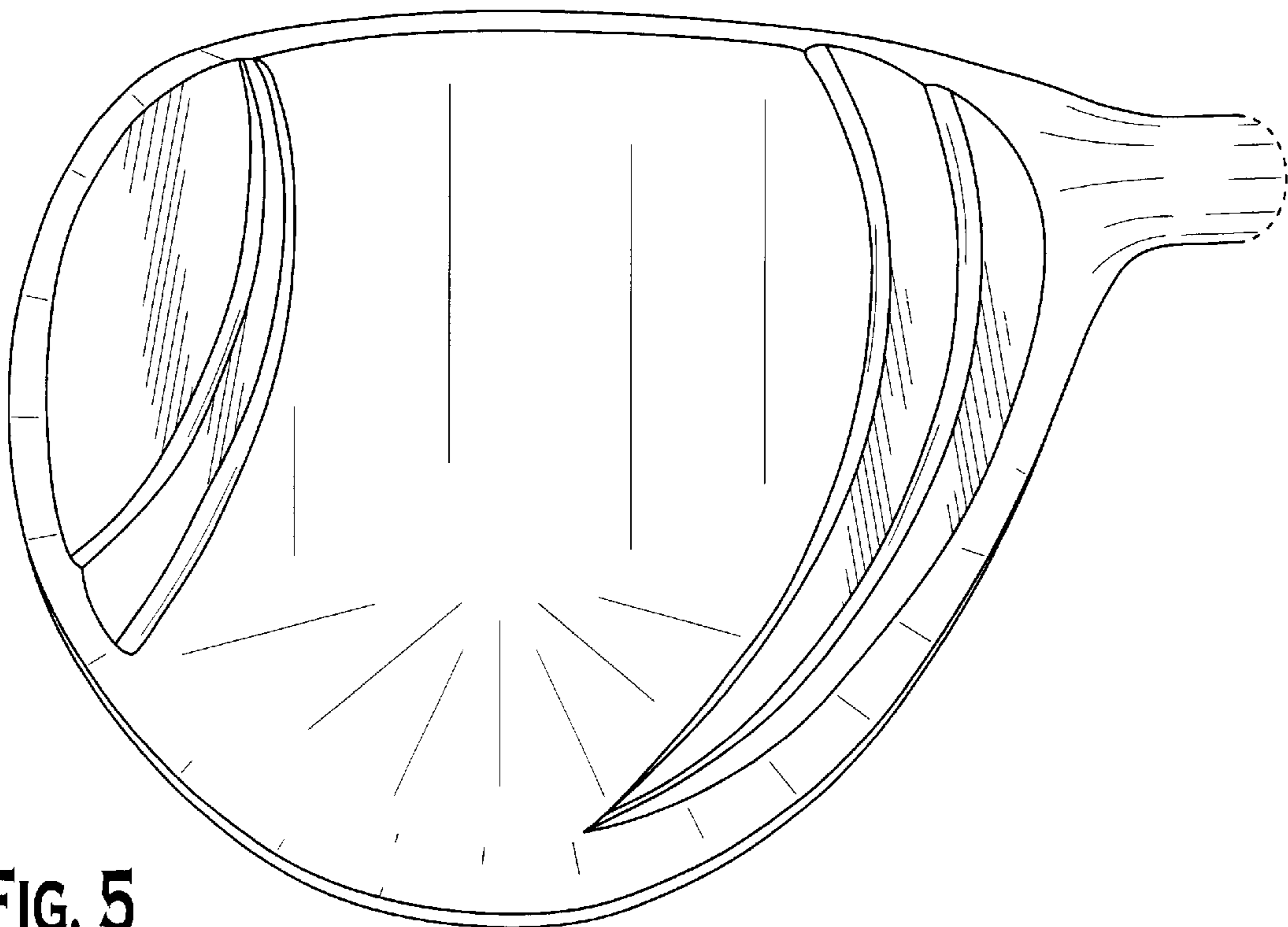

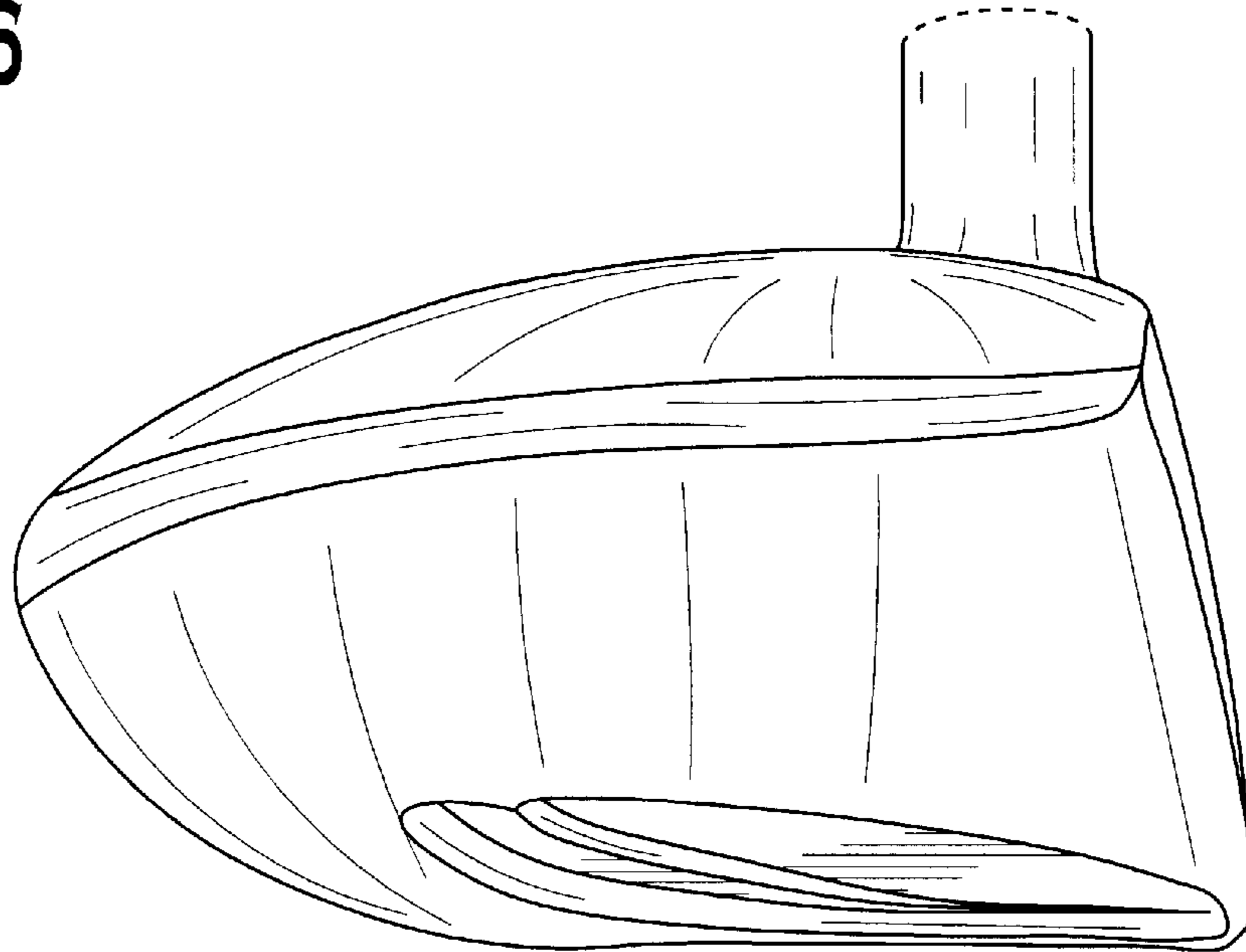

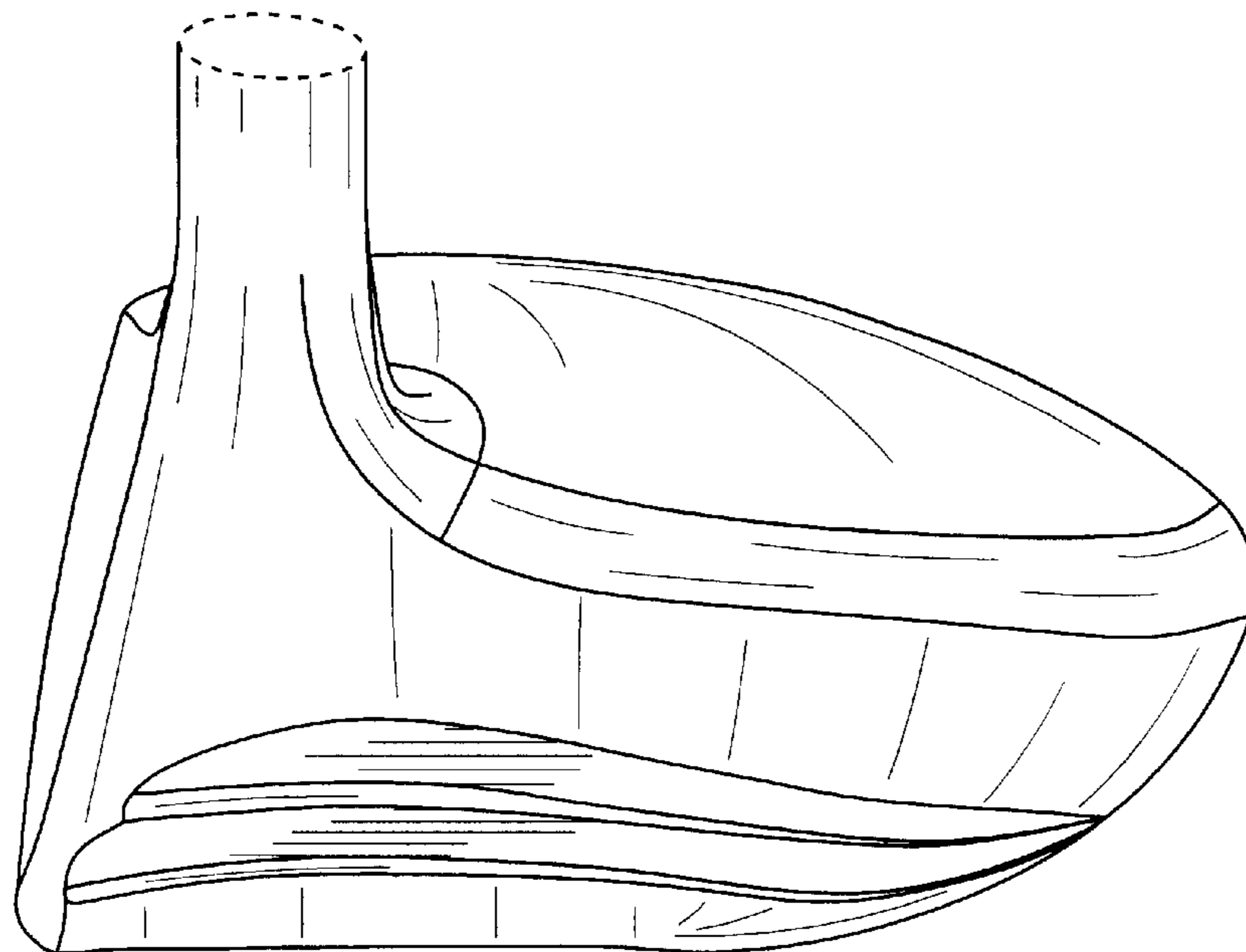

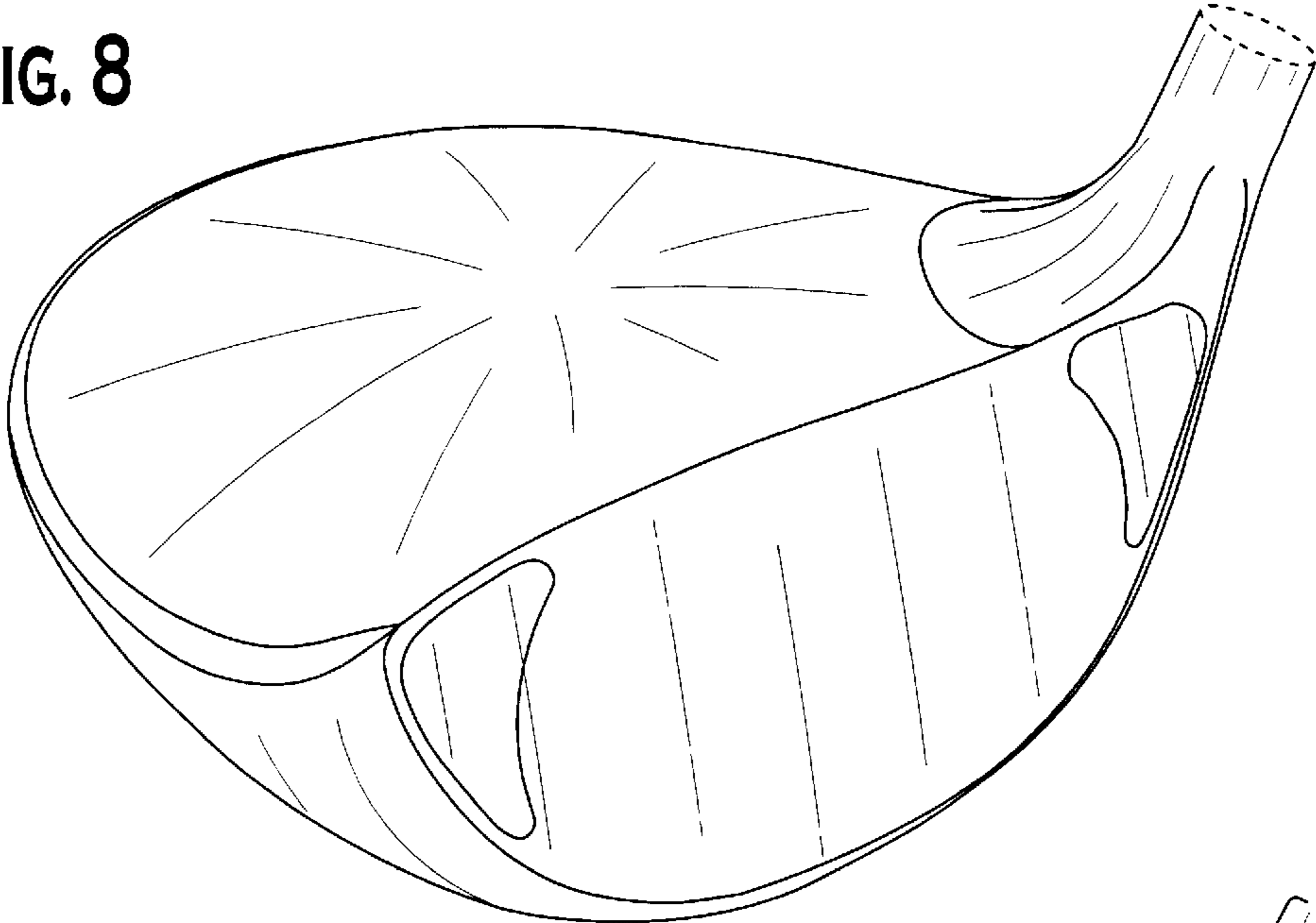

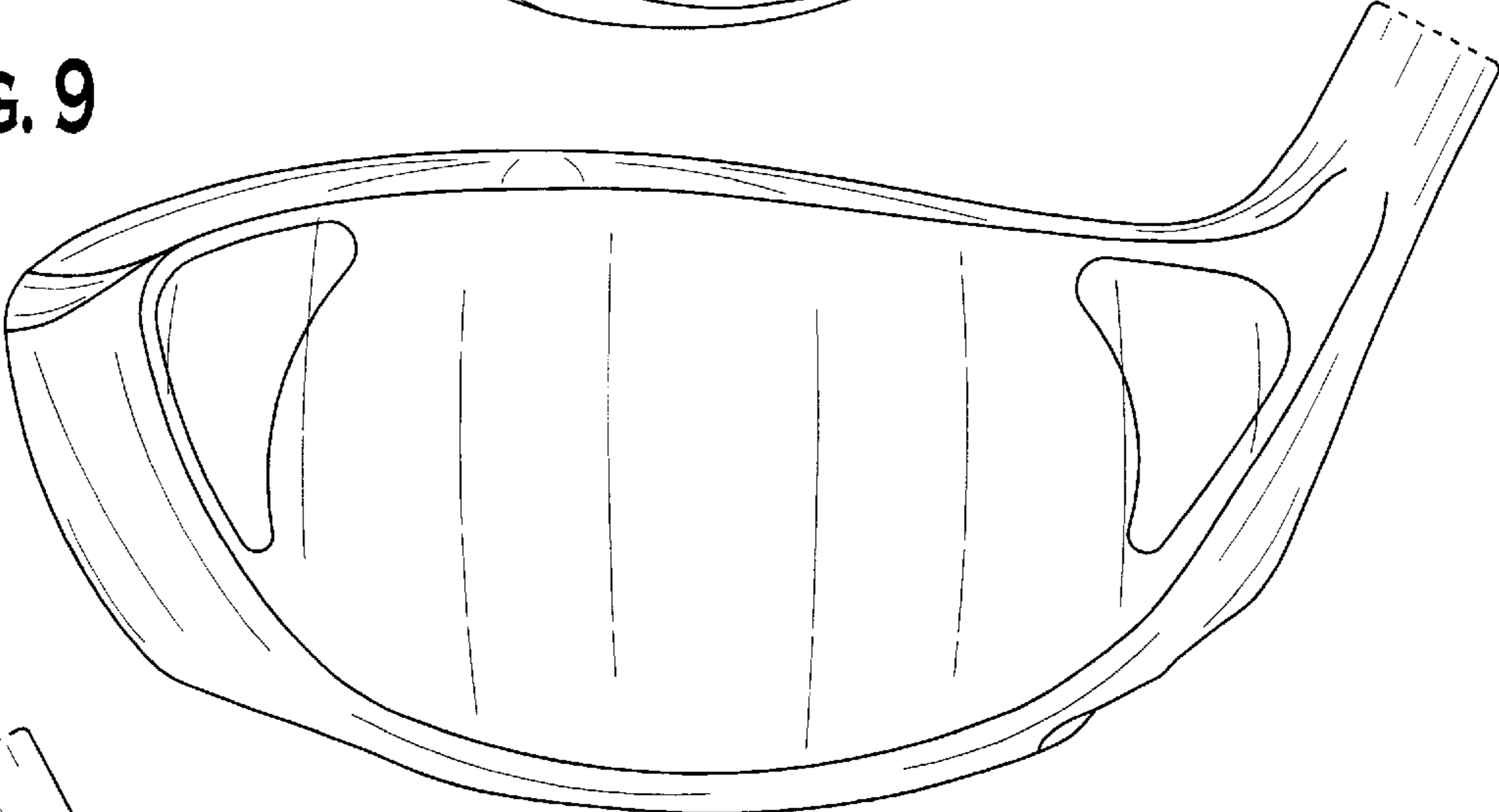

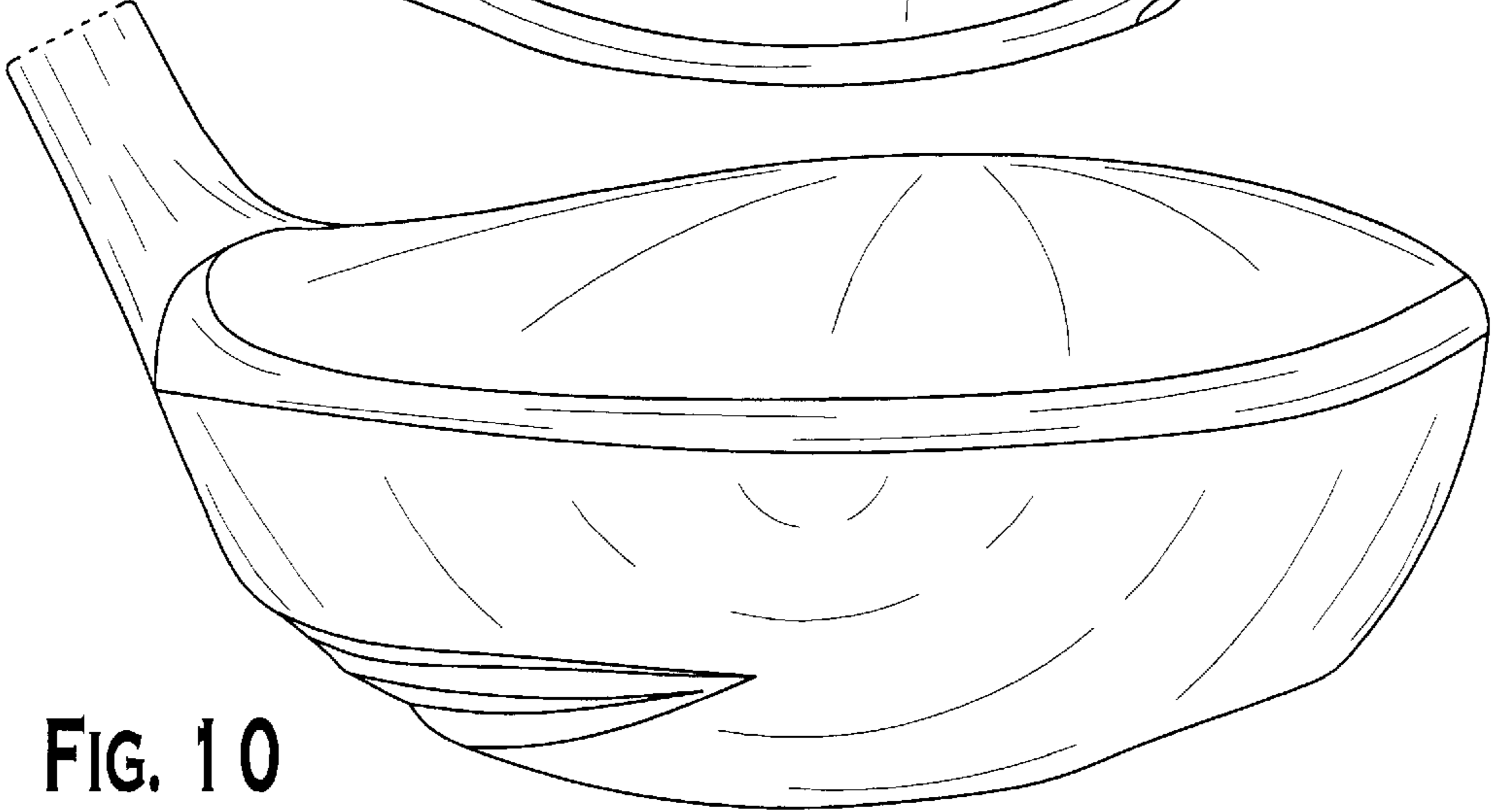

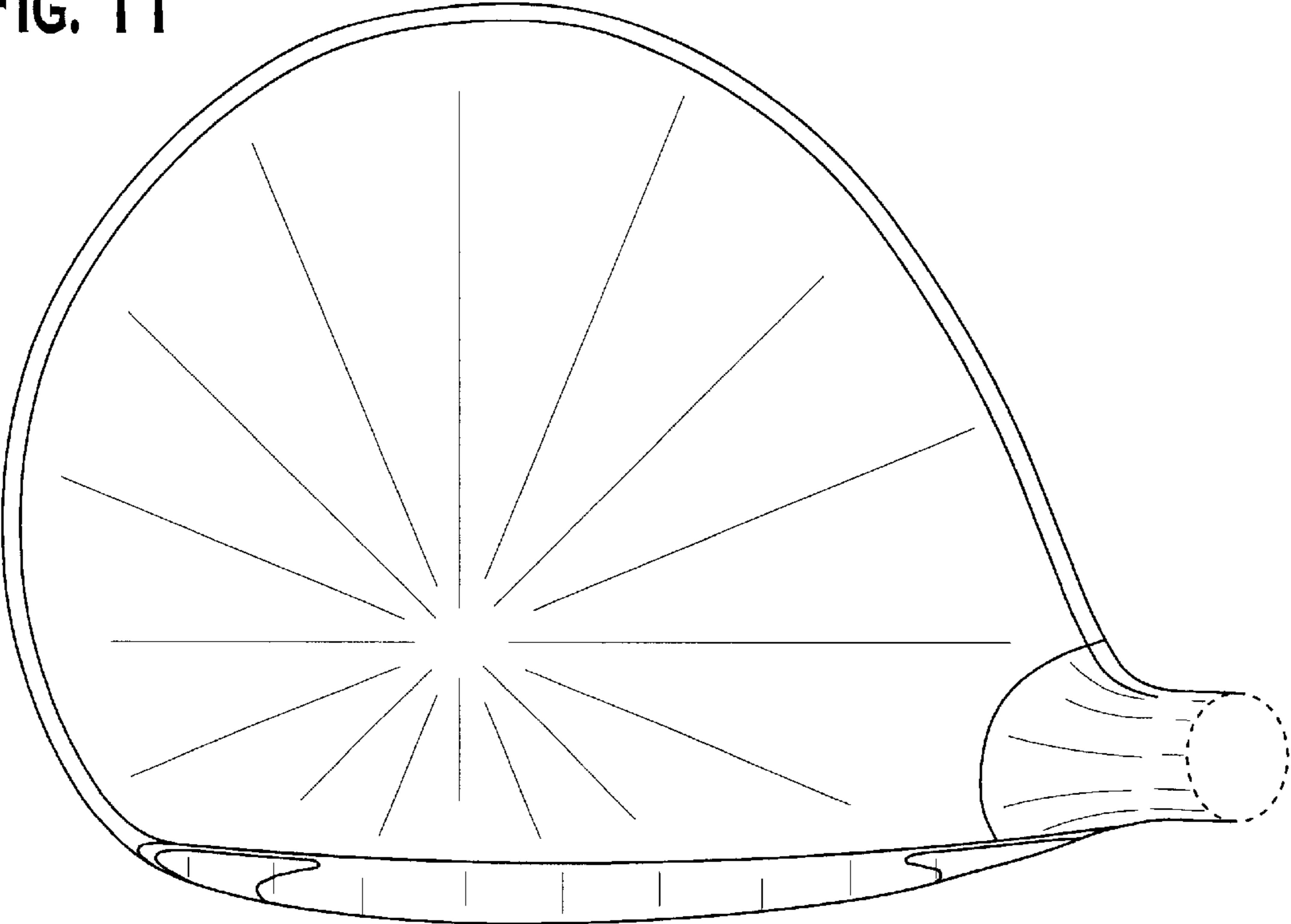

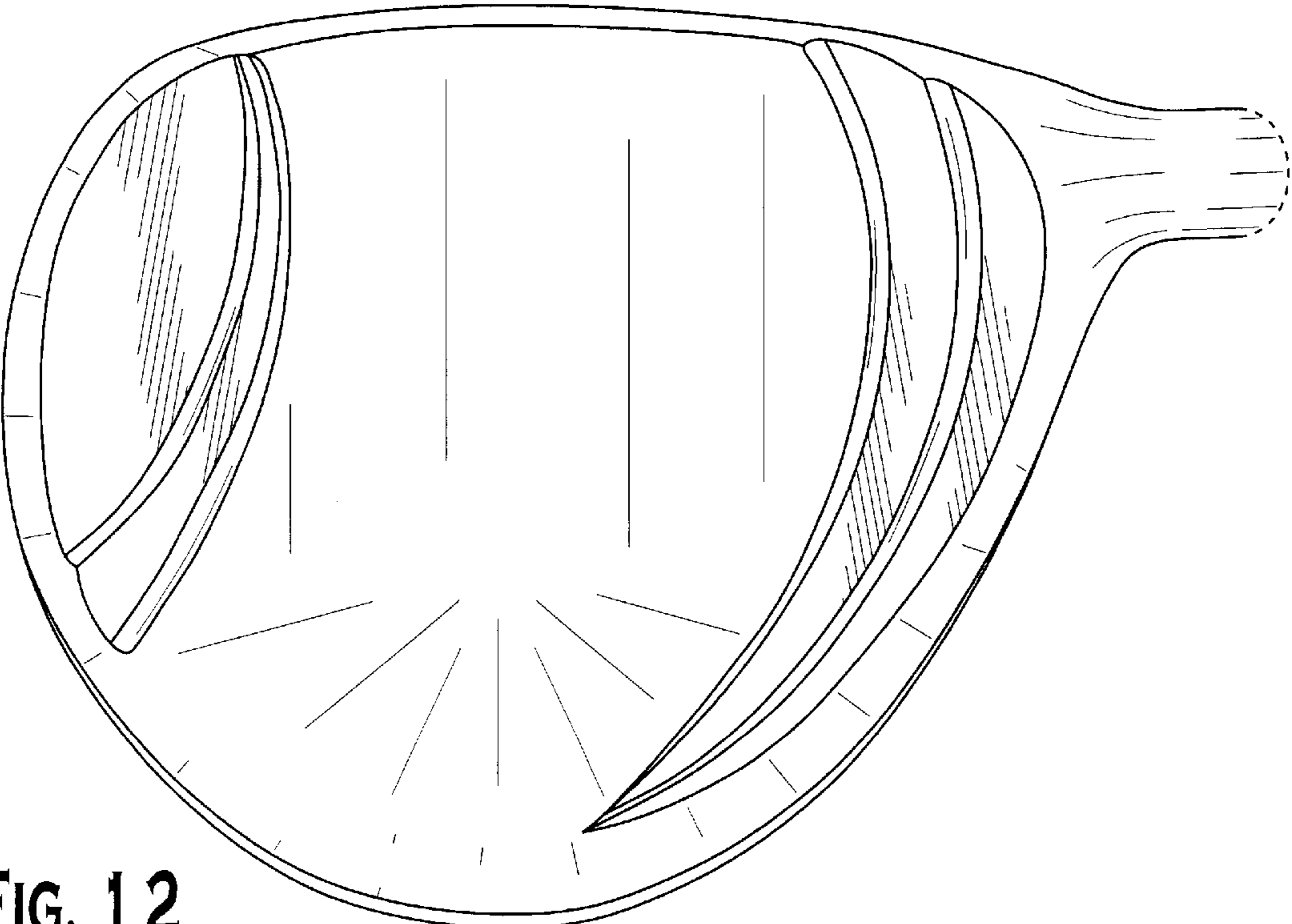

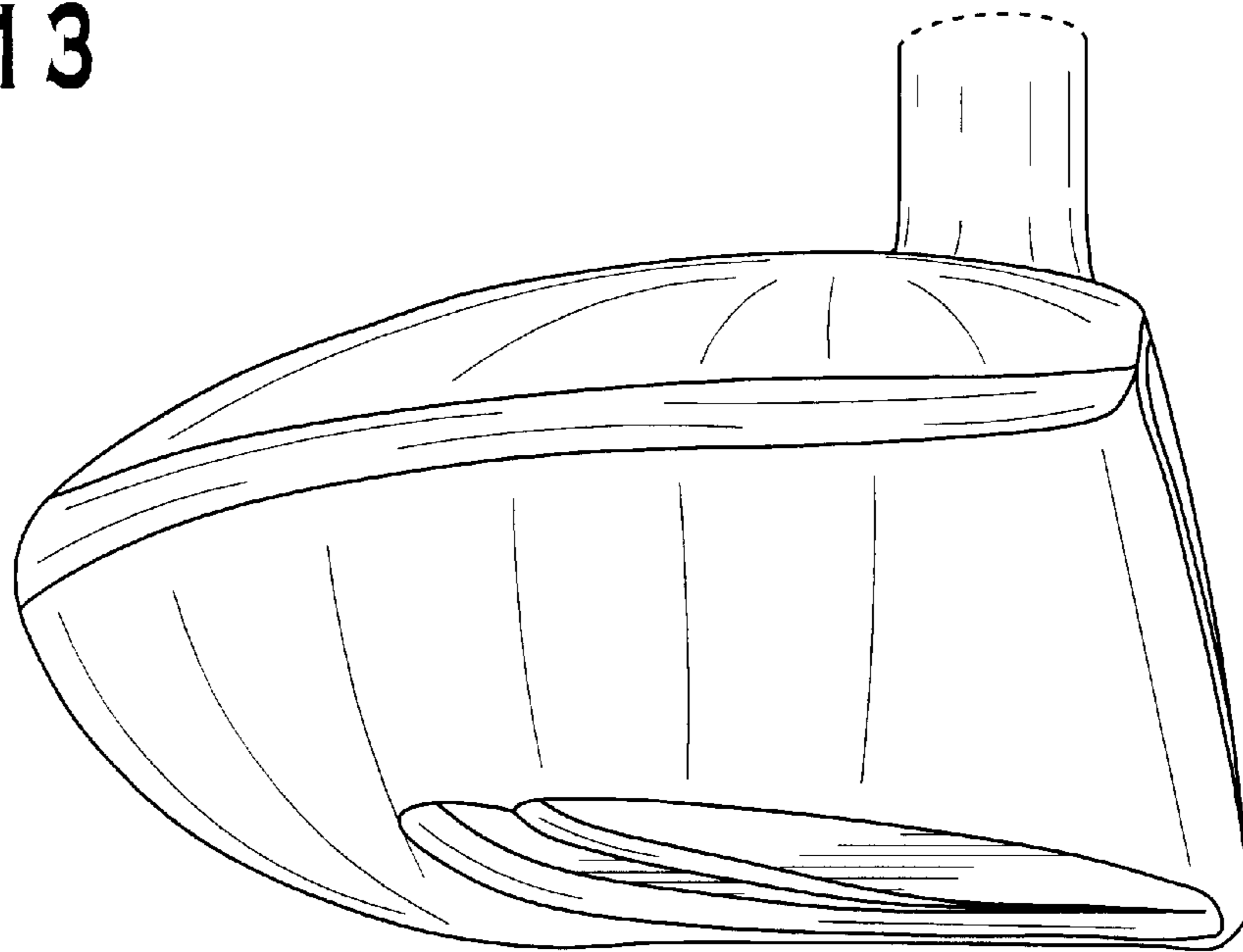

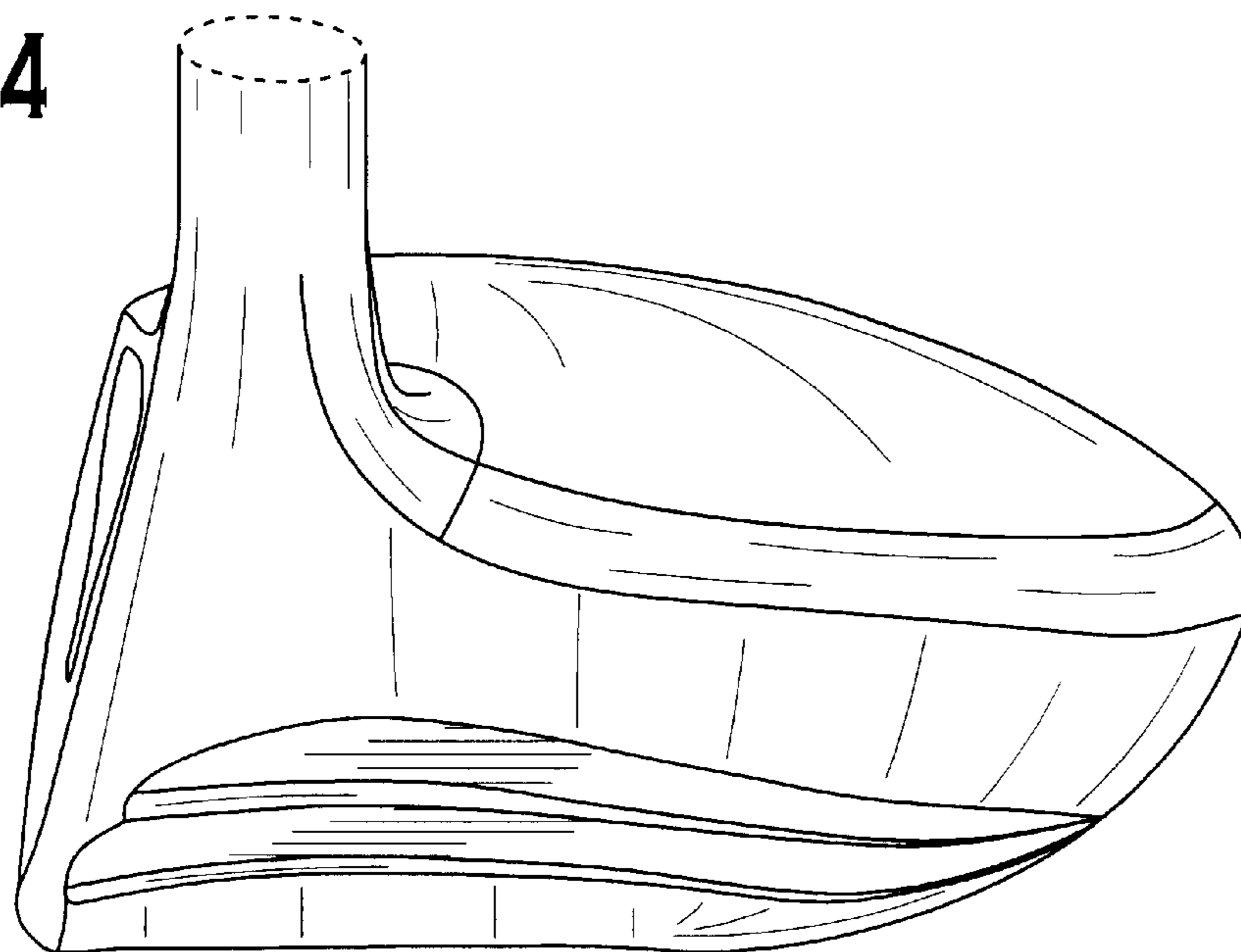

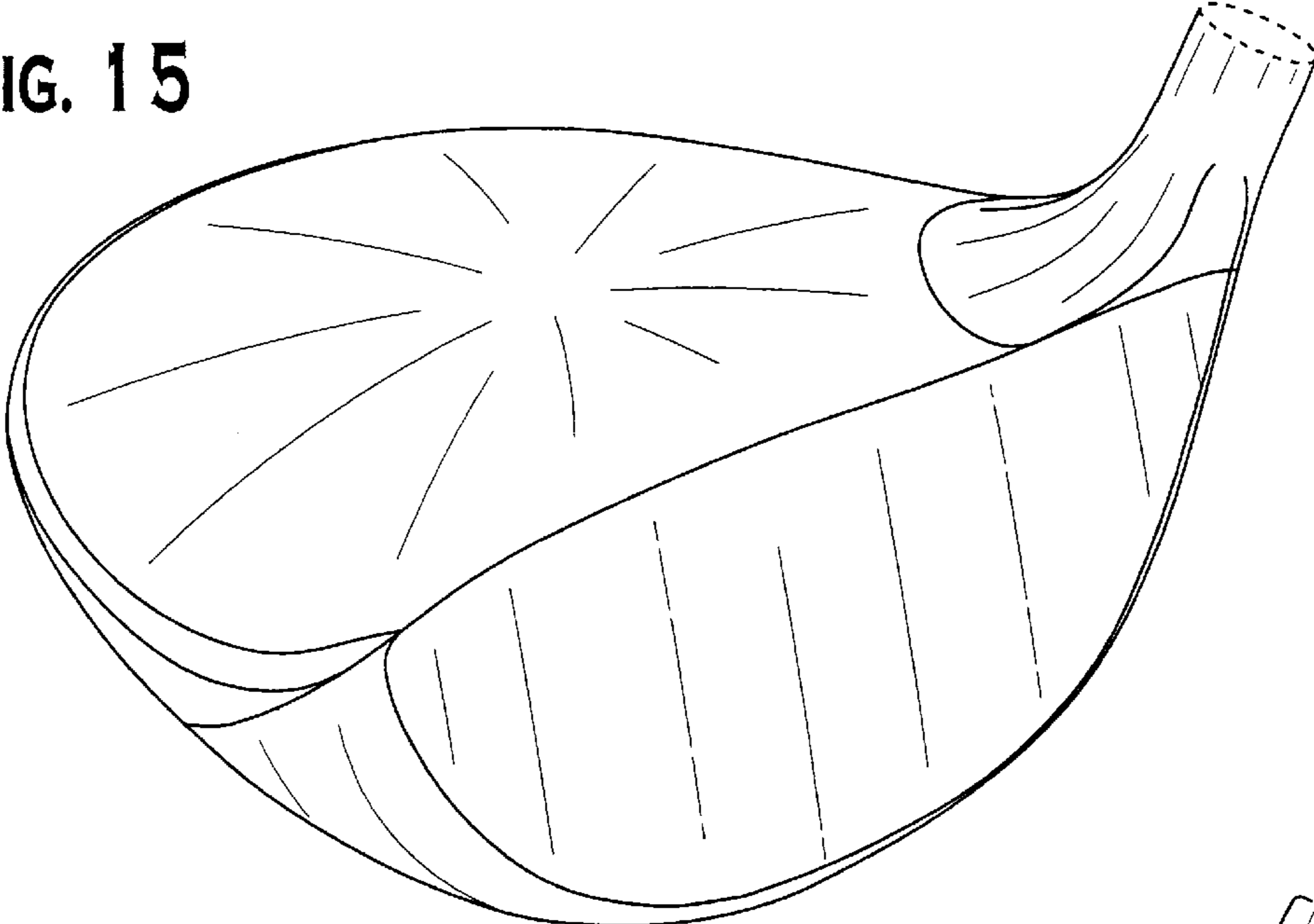

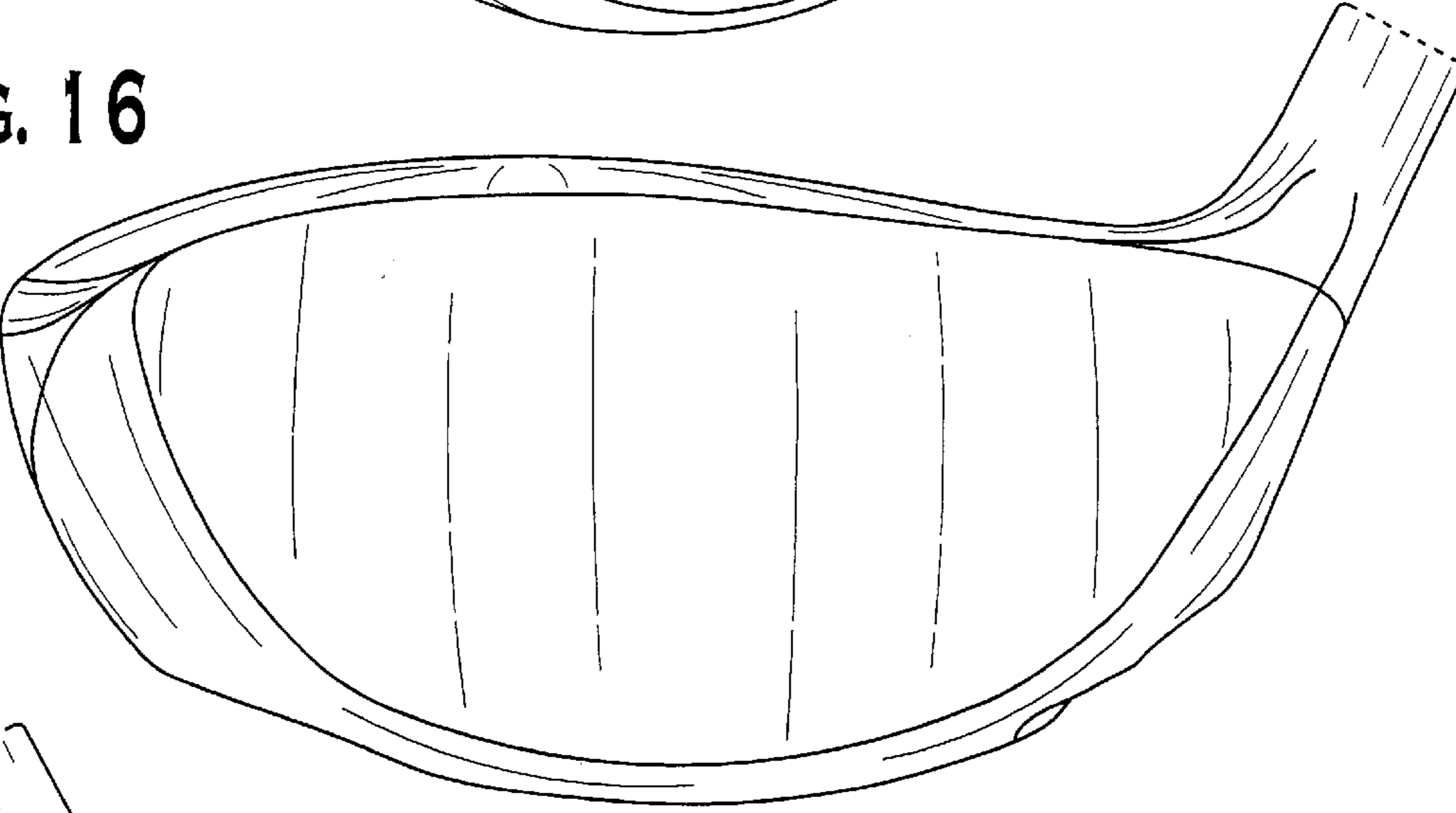

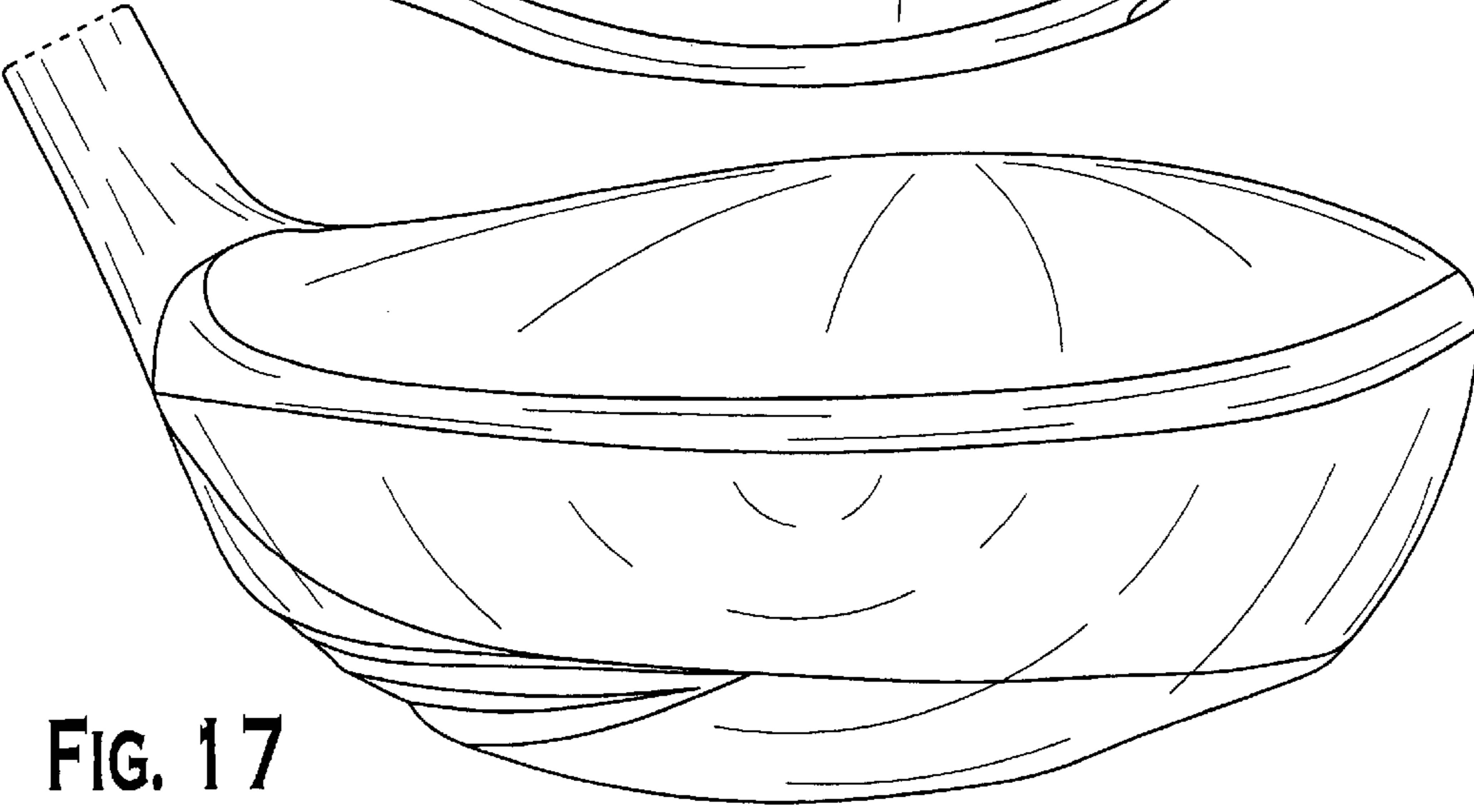

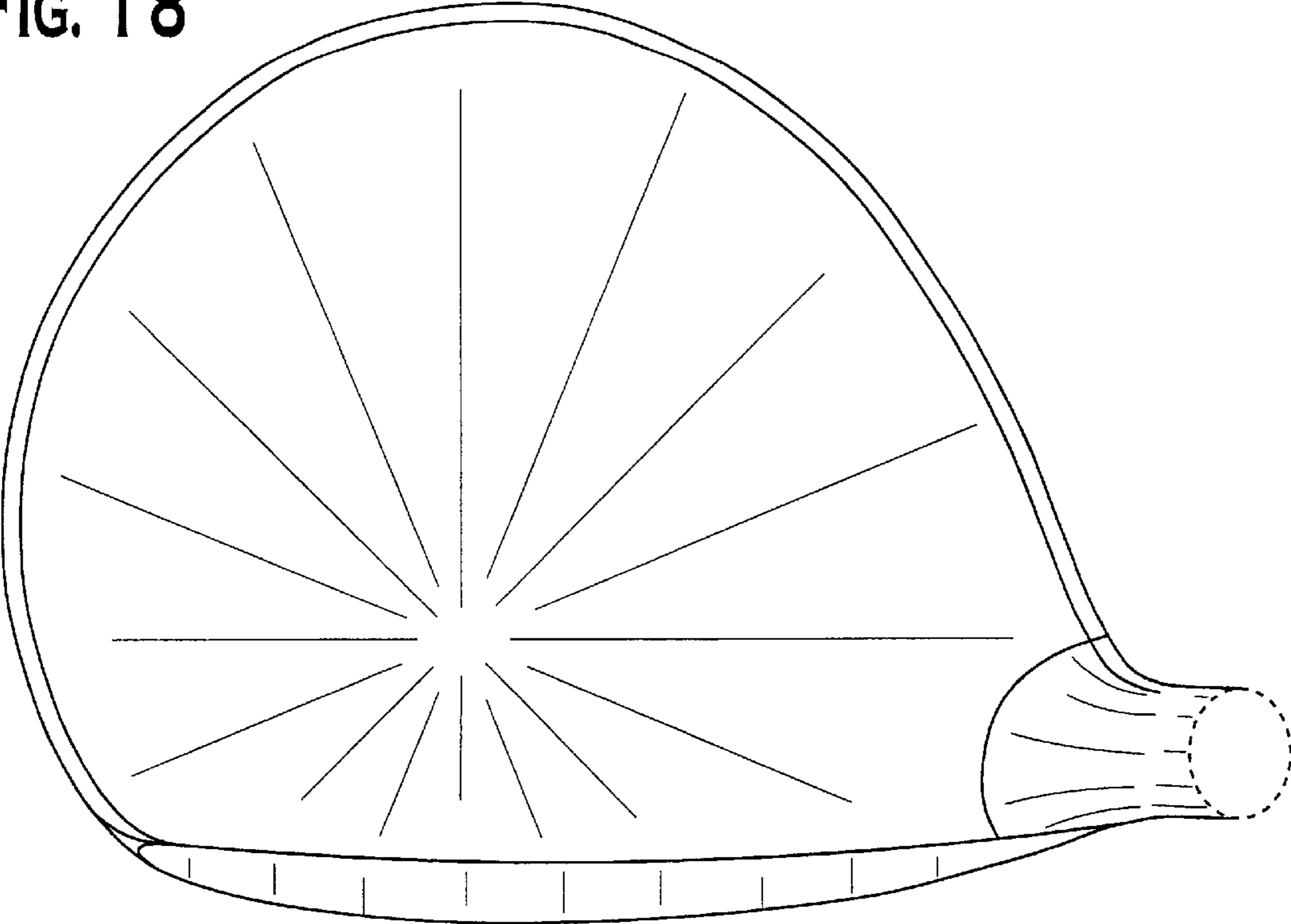

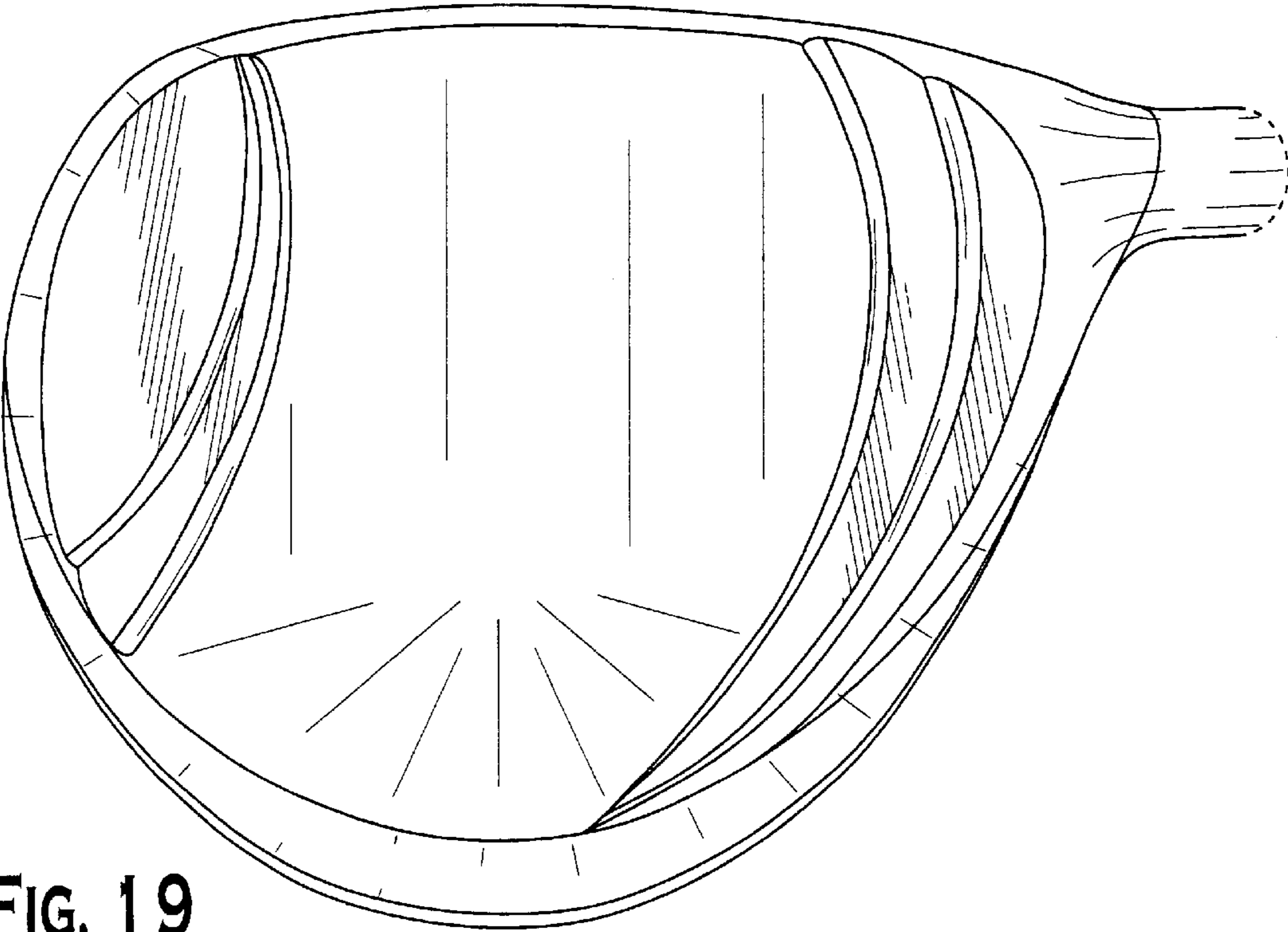

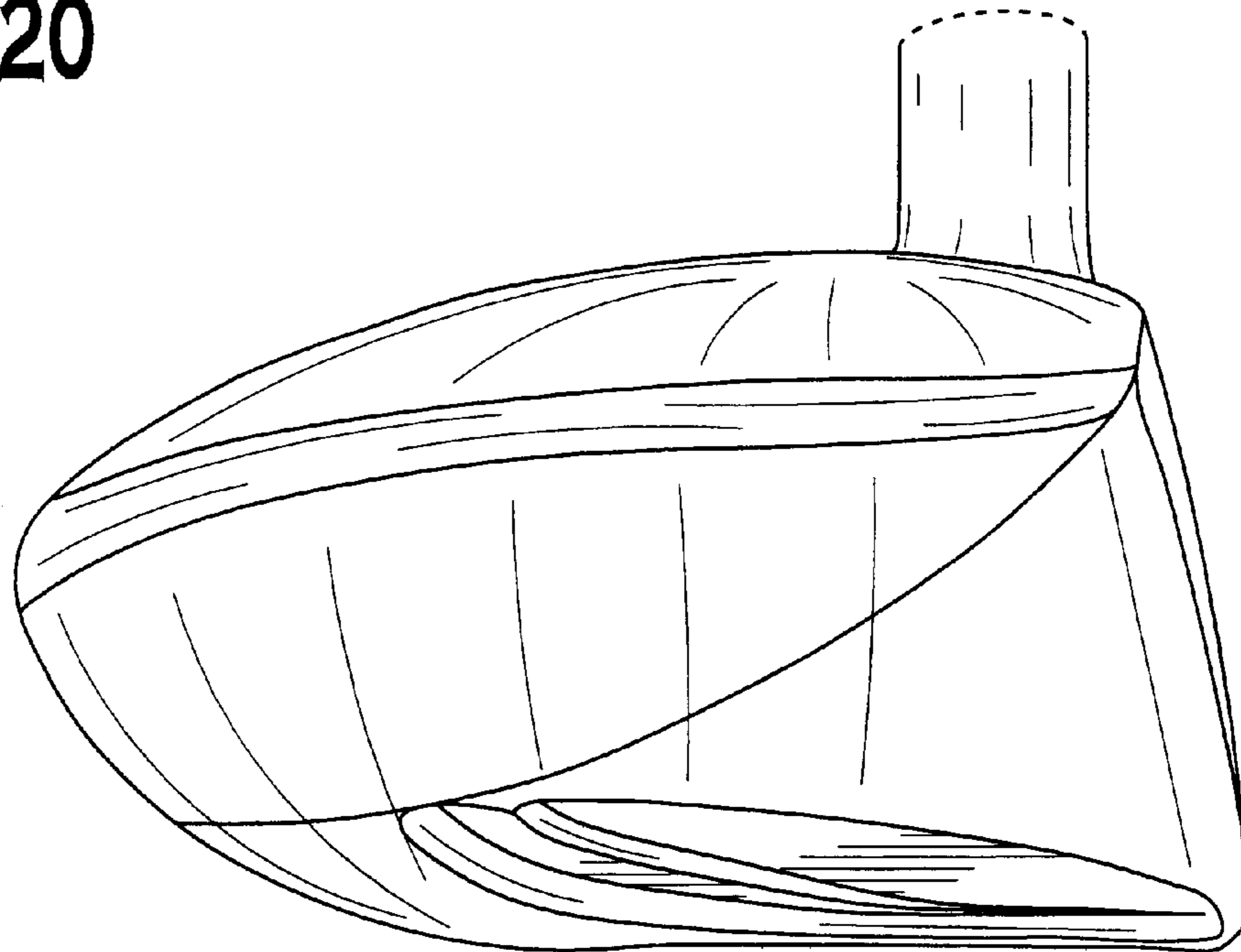
