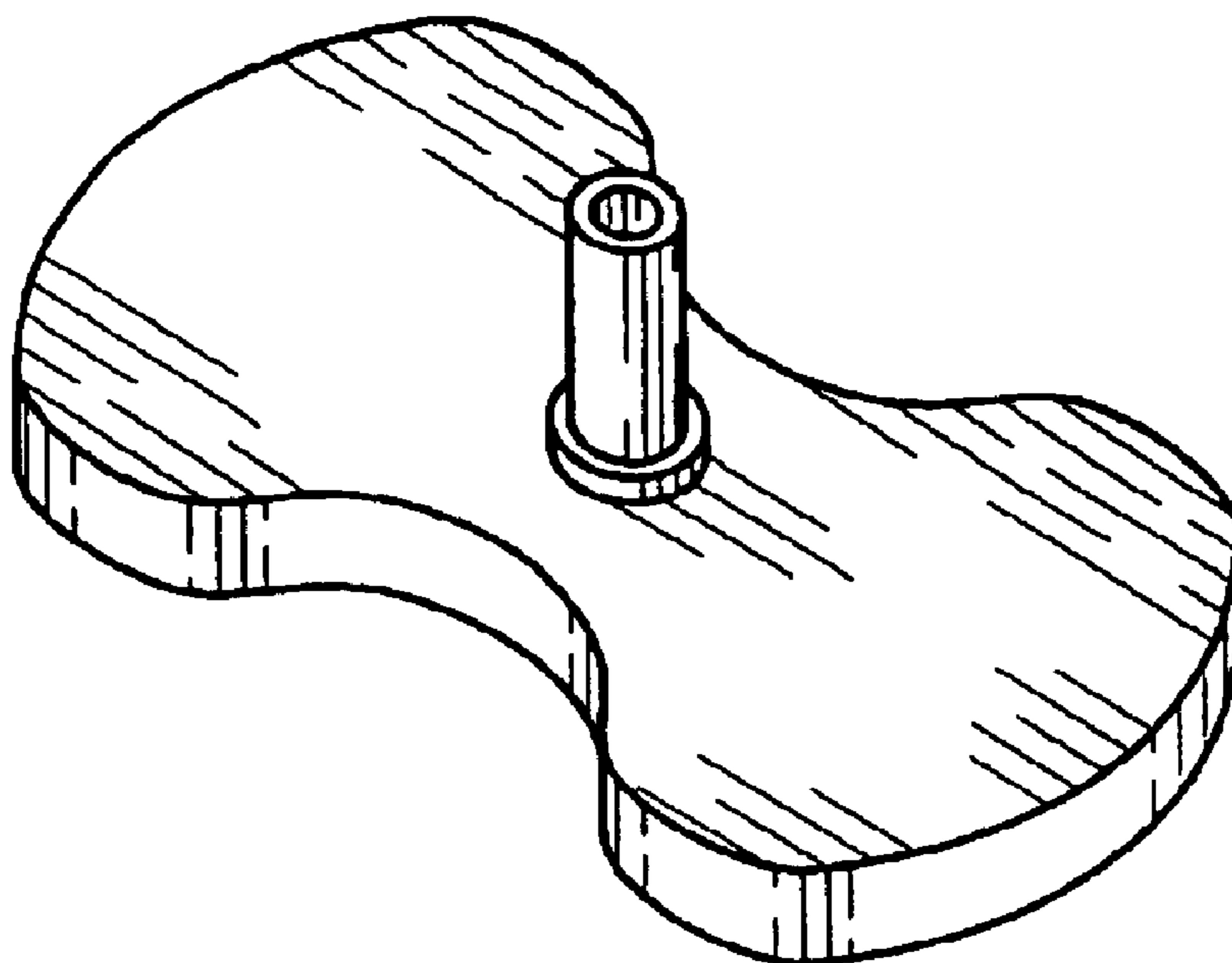

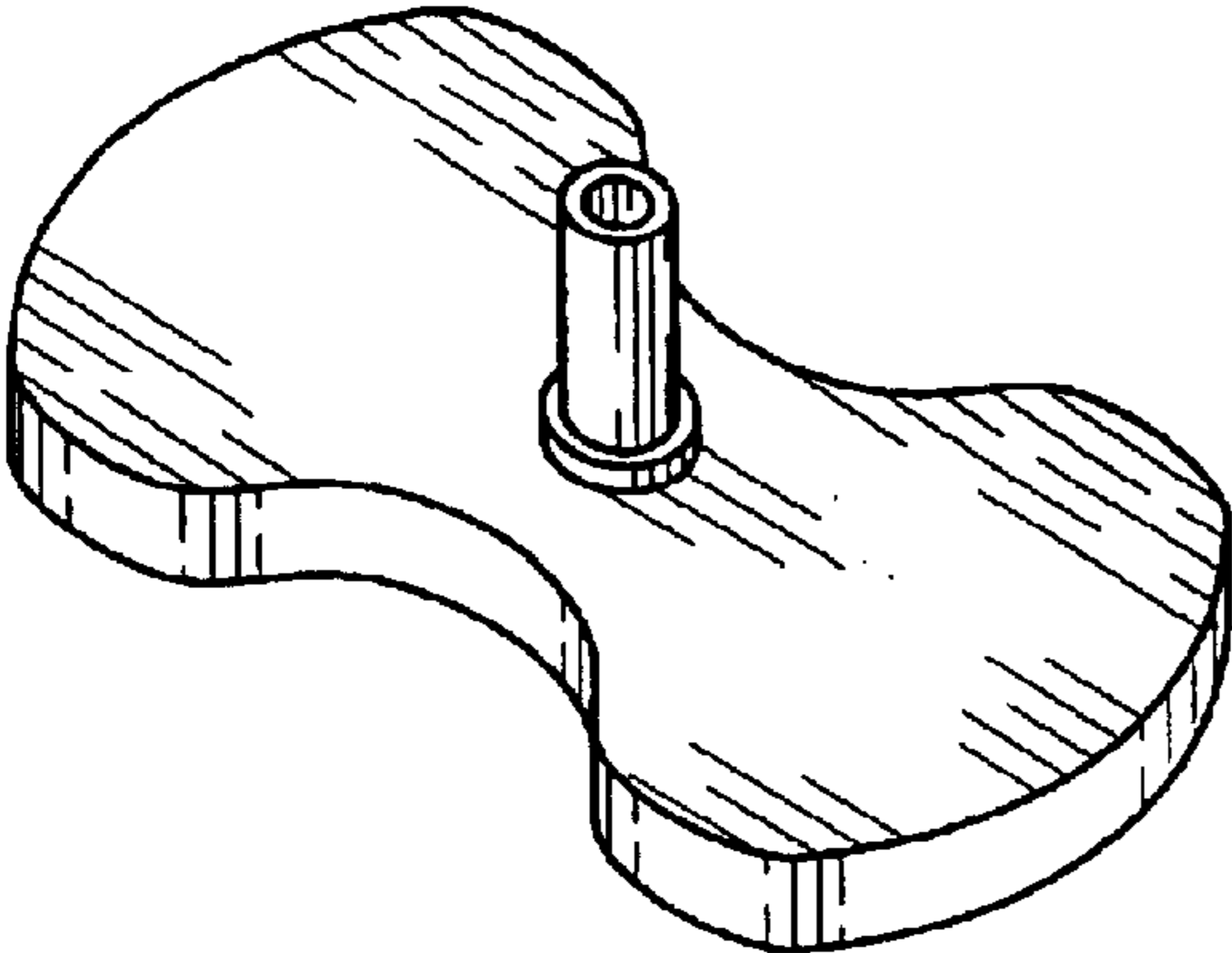
The ornamental design for a surgical template for dental implant, as shown and described.

**DESCRIPTION**

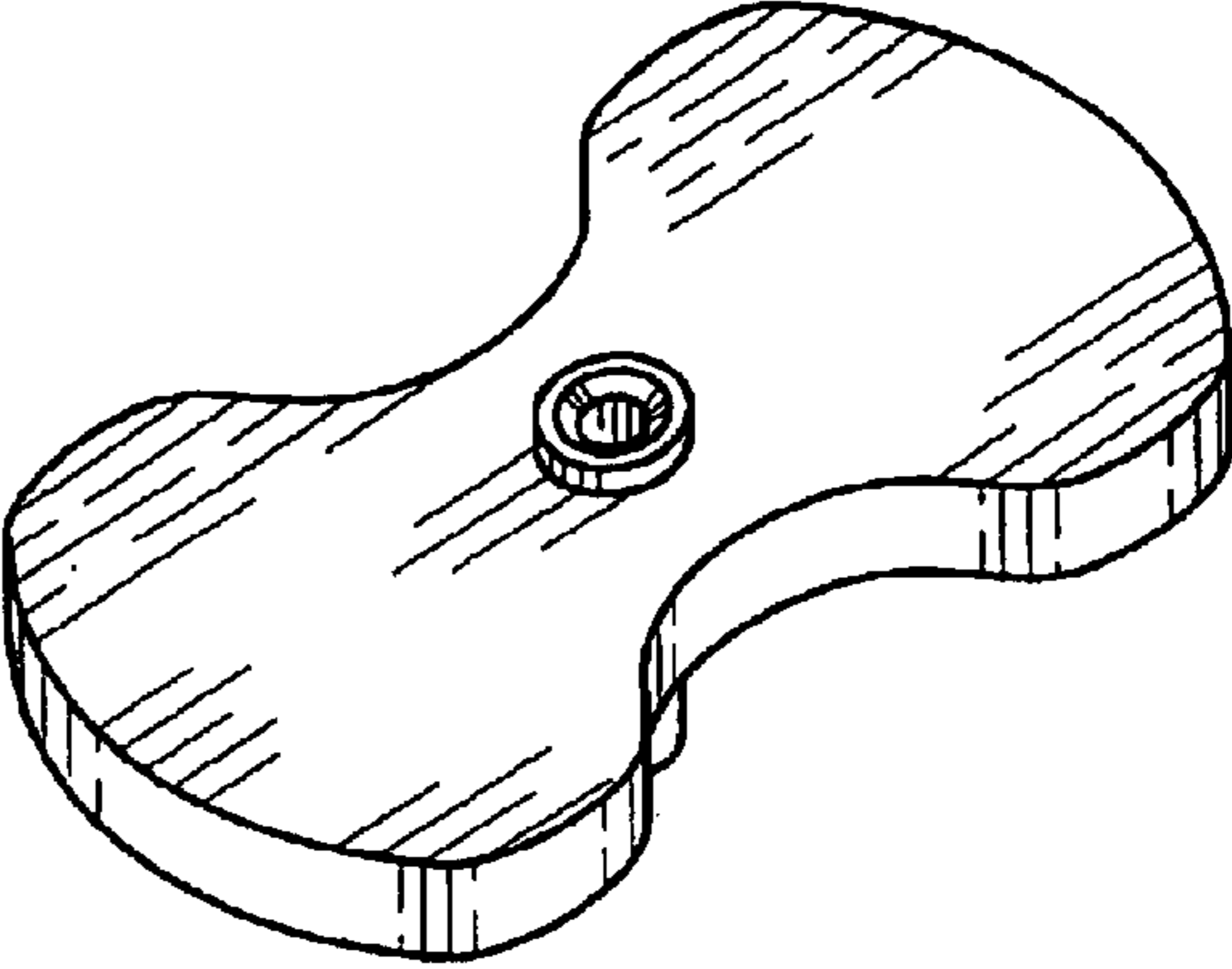
FIG. 1 is a bottom perspective view of a surgical template for dental implant embodying my design; FIG. 2 is a top perspective view thereof; FIG. 3 is a top plan view thereof; FIG. 4 is a right side elevational view thereof, the left side elevational view being a mirror image of the right side elevational view; and, FIG. 5 is a front elevational view thereof, the rear elevational view being a mirror image of the front elevational view.

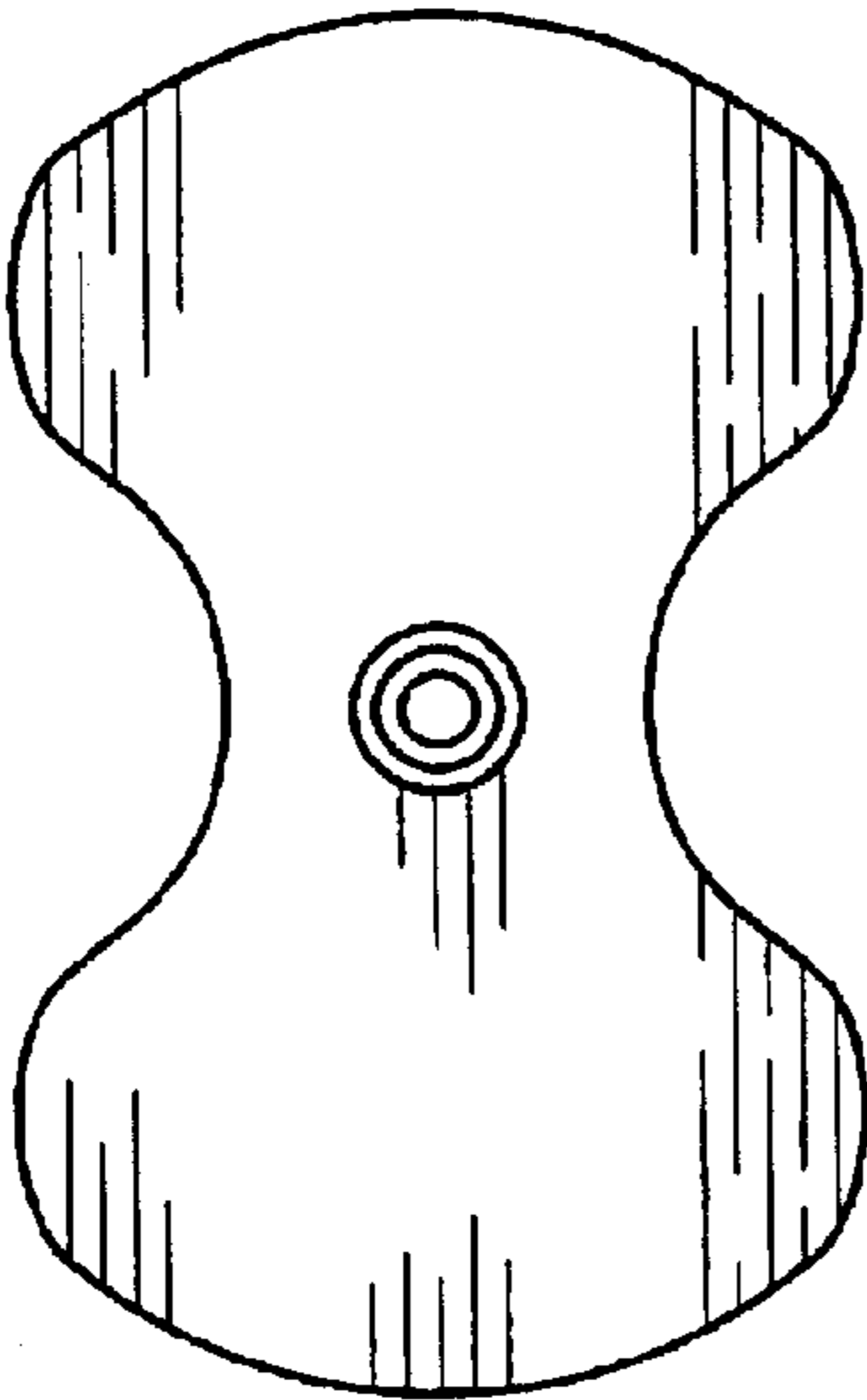




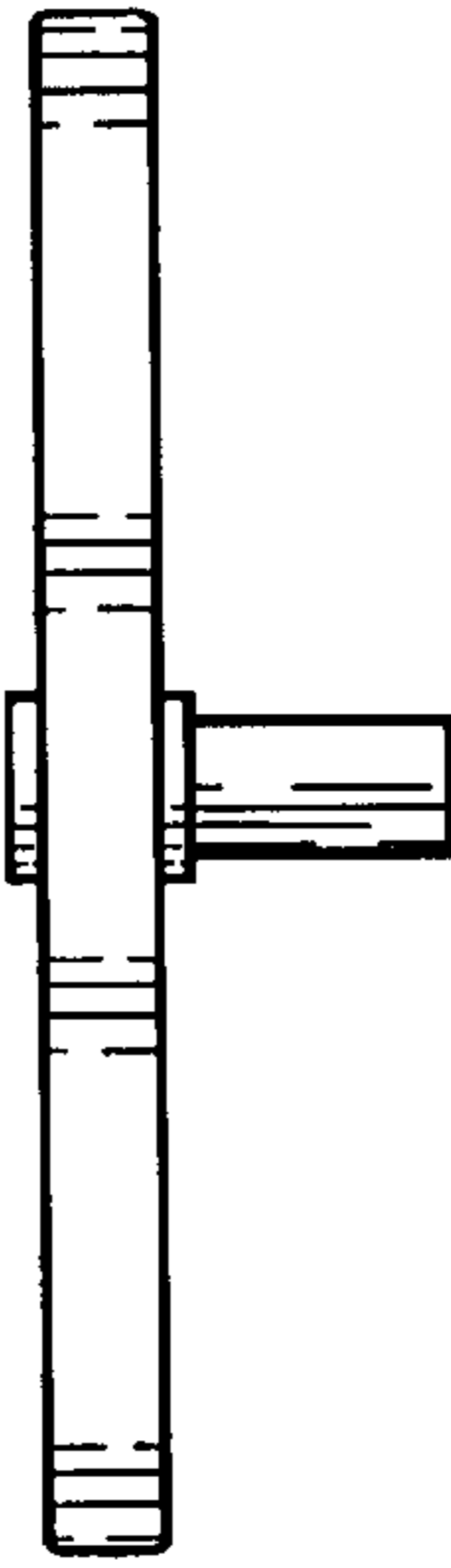

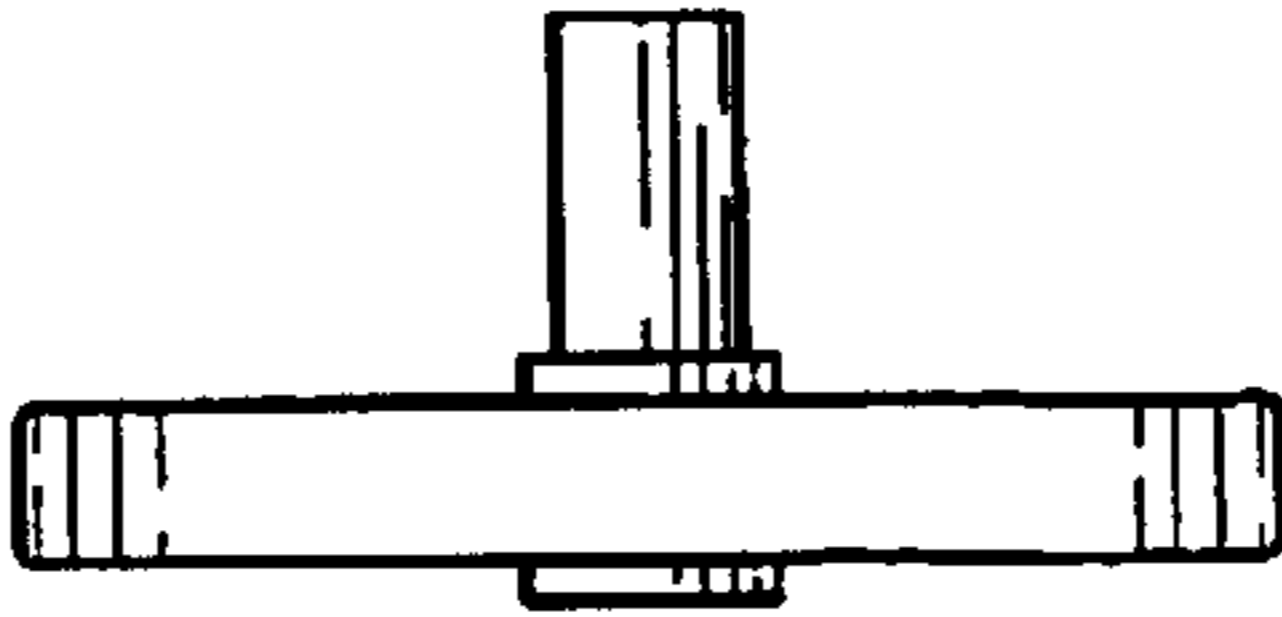
