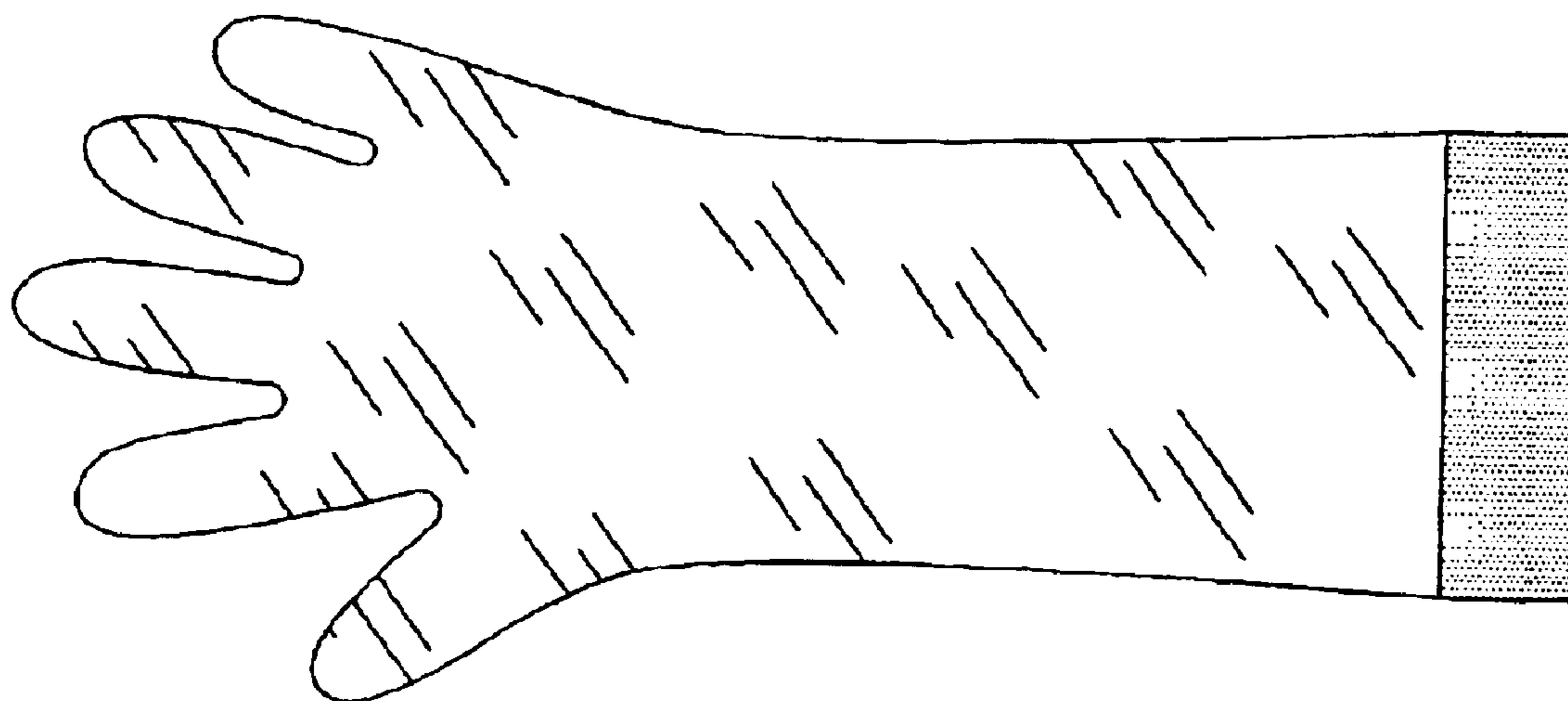
(57) **CLAIM**

The ornamental design for an I-V covering glove, as shown and described.

DESCRIPTION

FIG. 1 shows a top plan view of an I-V covering glove. FIG. 2 shows a bottom plan view thereof. FIG. 3 shows a right side elevational view thereof. FIG. 4 shows a left side elevational view thereof. FIG. 5 shows a front side elevational view thereof magnified three times relative to the scale of FIGS. 1-4. FIG. 6 shows a rear side elevational view thereof magnified three times relative to the scale of FIGS. 1-4. FIG. 7 shows a top plan view of an alternative embodiment I-V covering glove. FIG. 8 shows a bottom plan view thereof. FIG. 9 shows a right side elevational view thereof. FIG. 10 shows a left side elevational view thereof. FIG. 11 shows a front side elevational view thereof magnified three times relative to the scale of FIGS. 7-10; and, FIG. 12 shows a rear side elevational view thereof magnified three times relative to the scale of FIGS. 7-10.

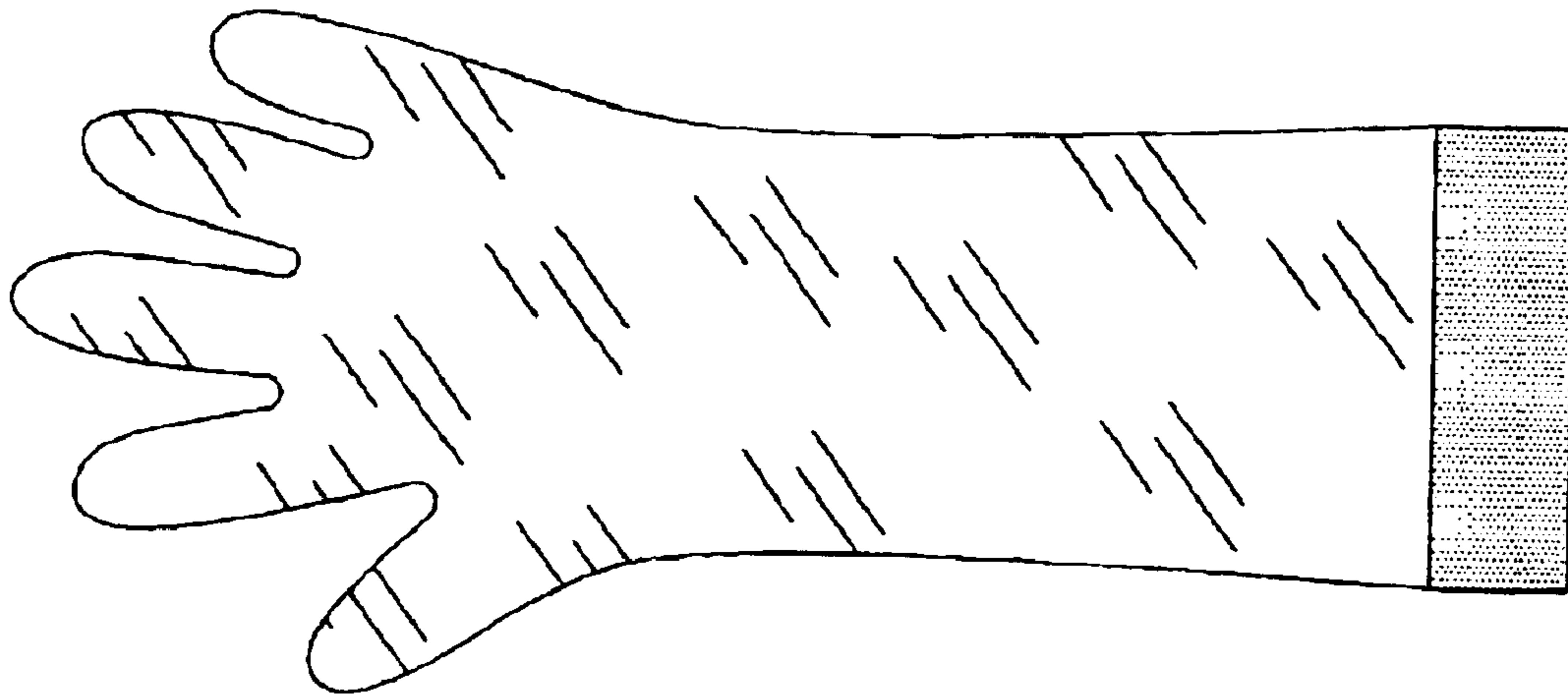

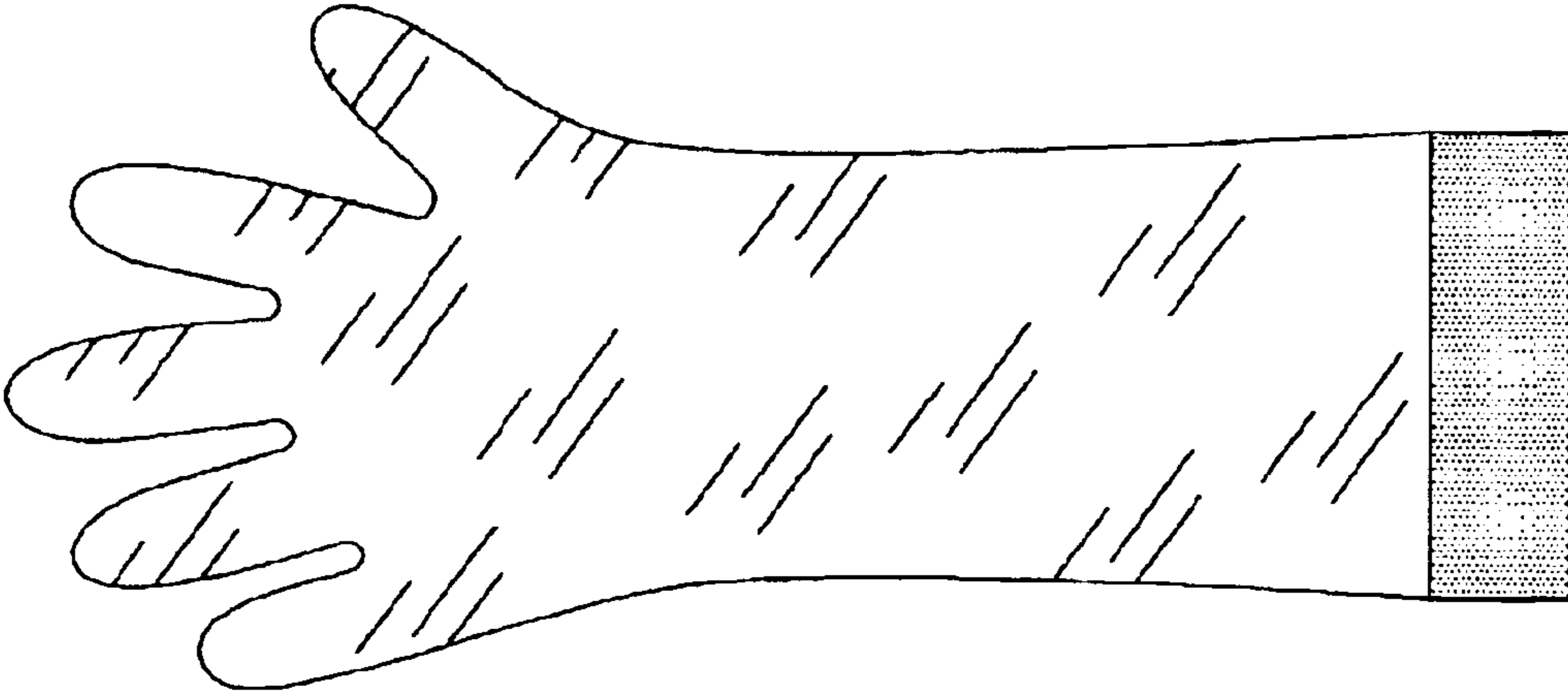

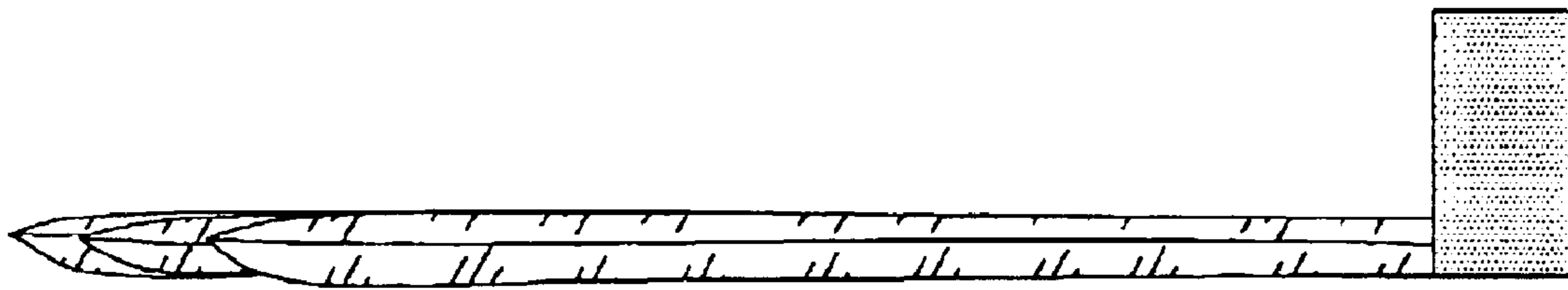

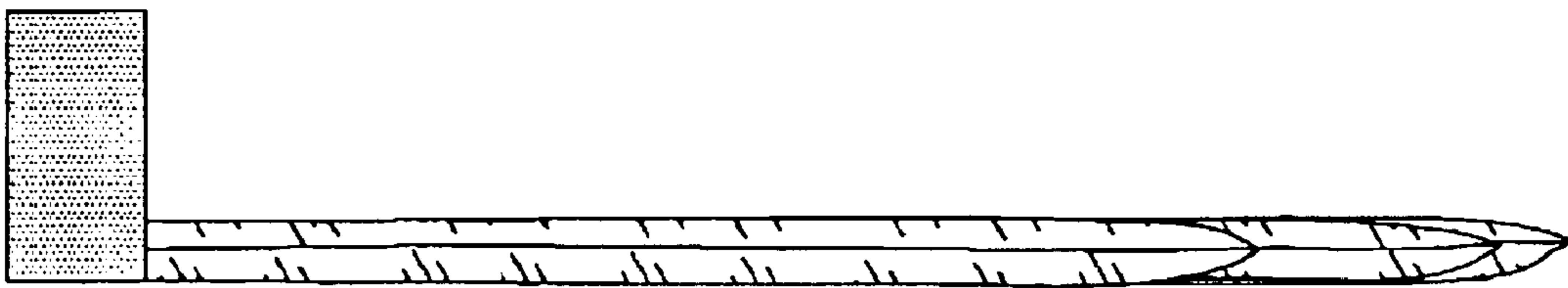

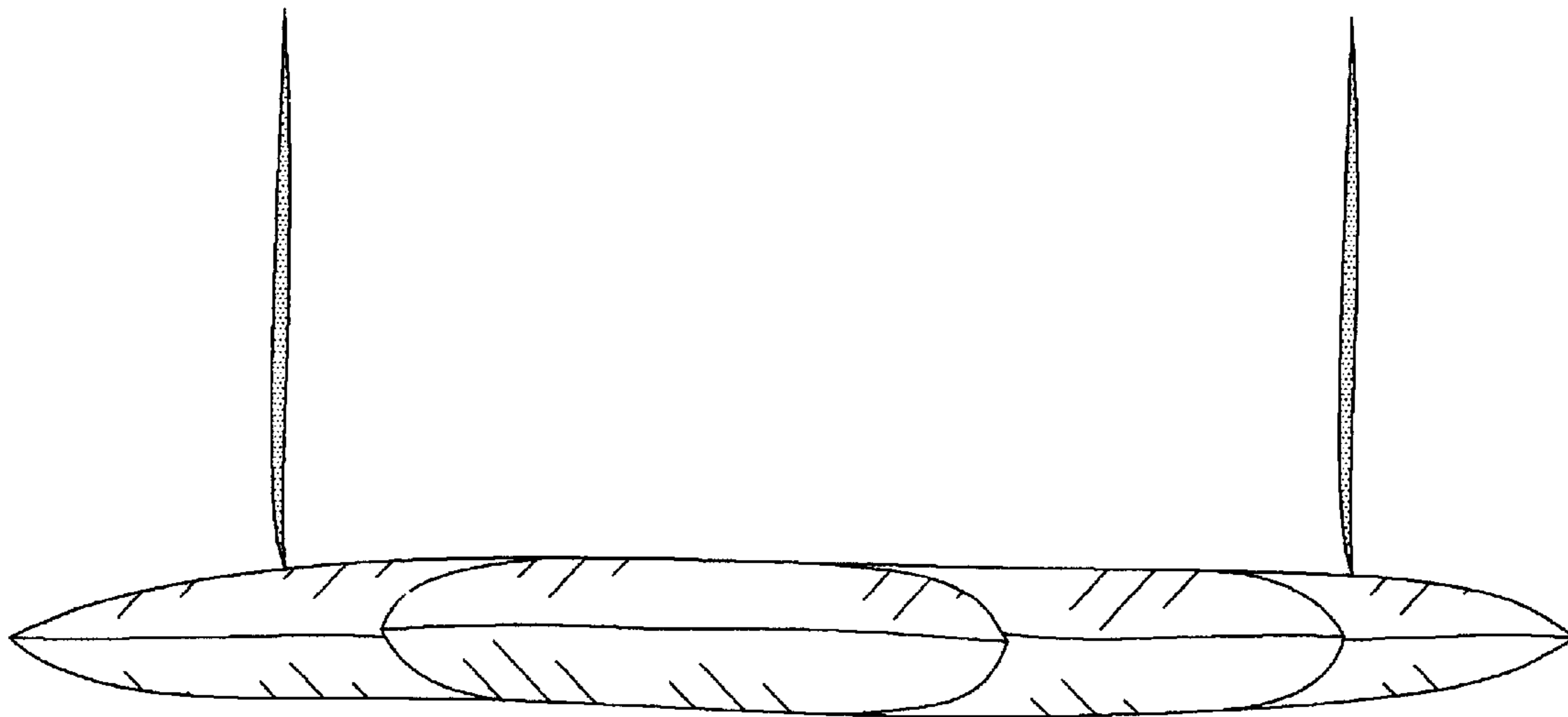

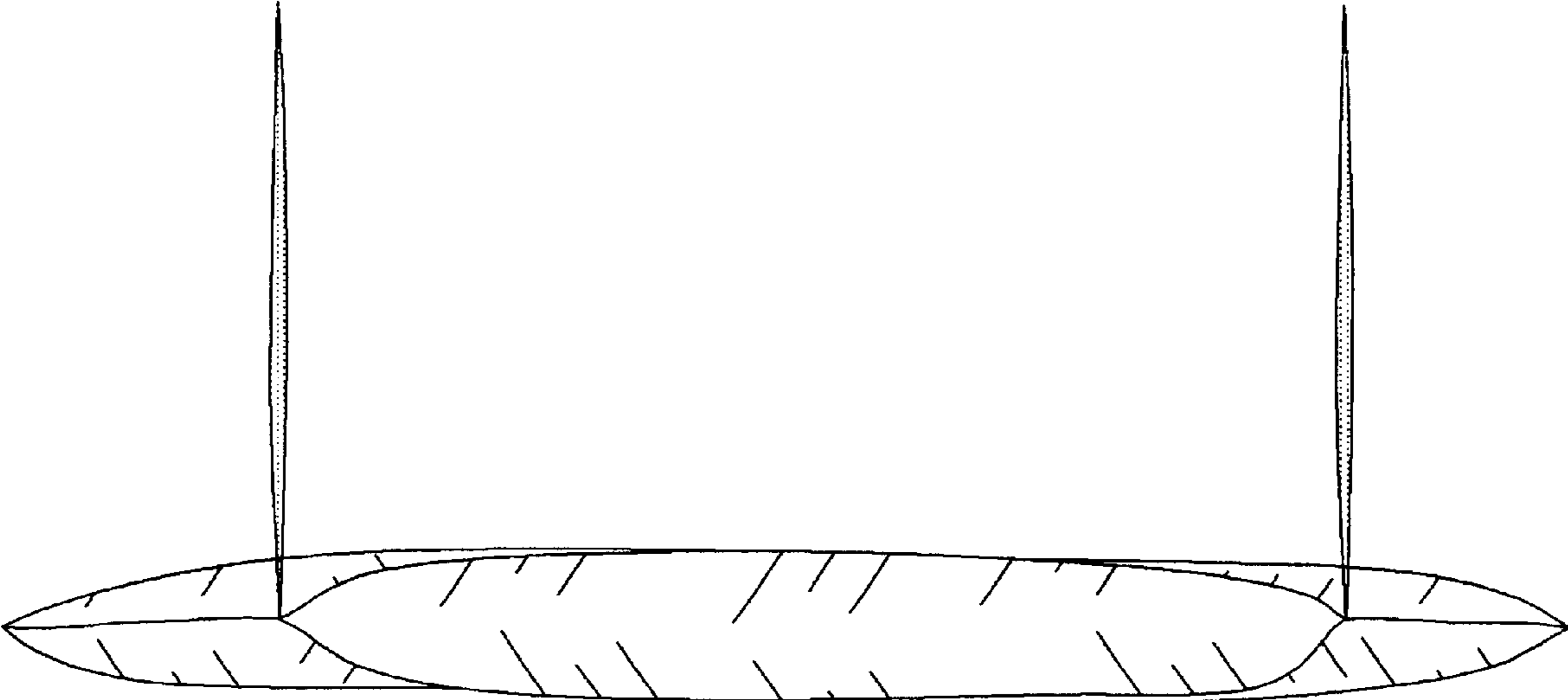

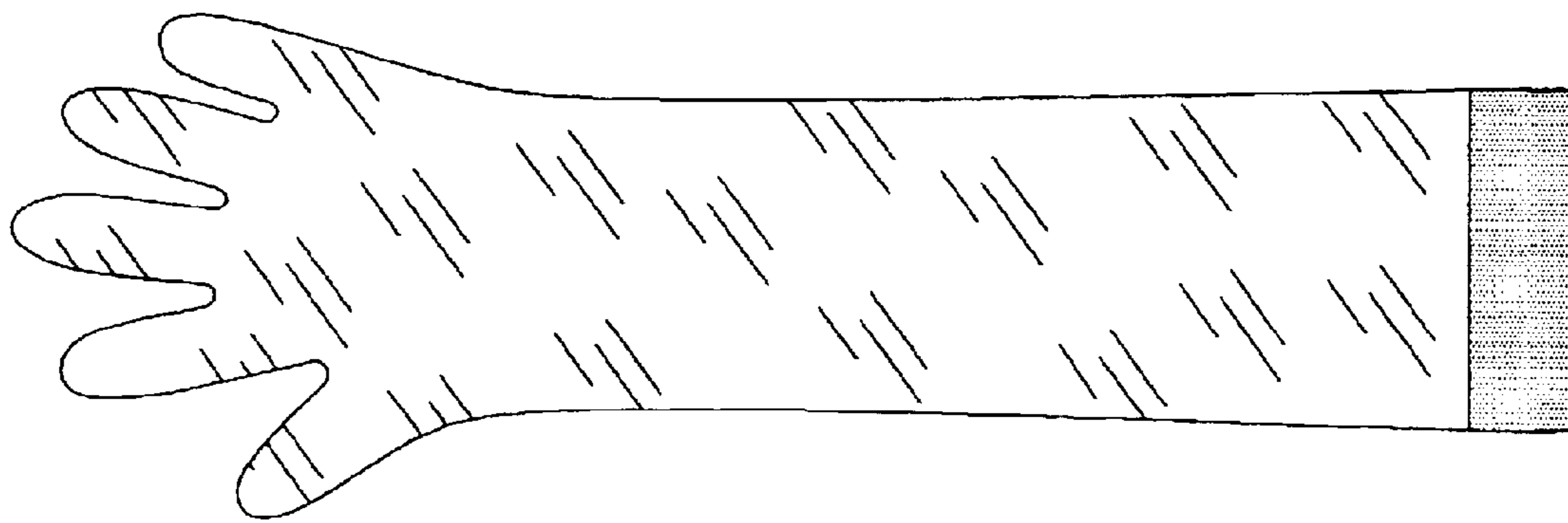

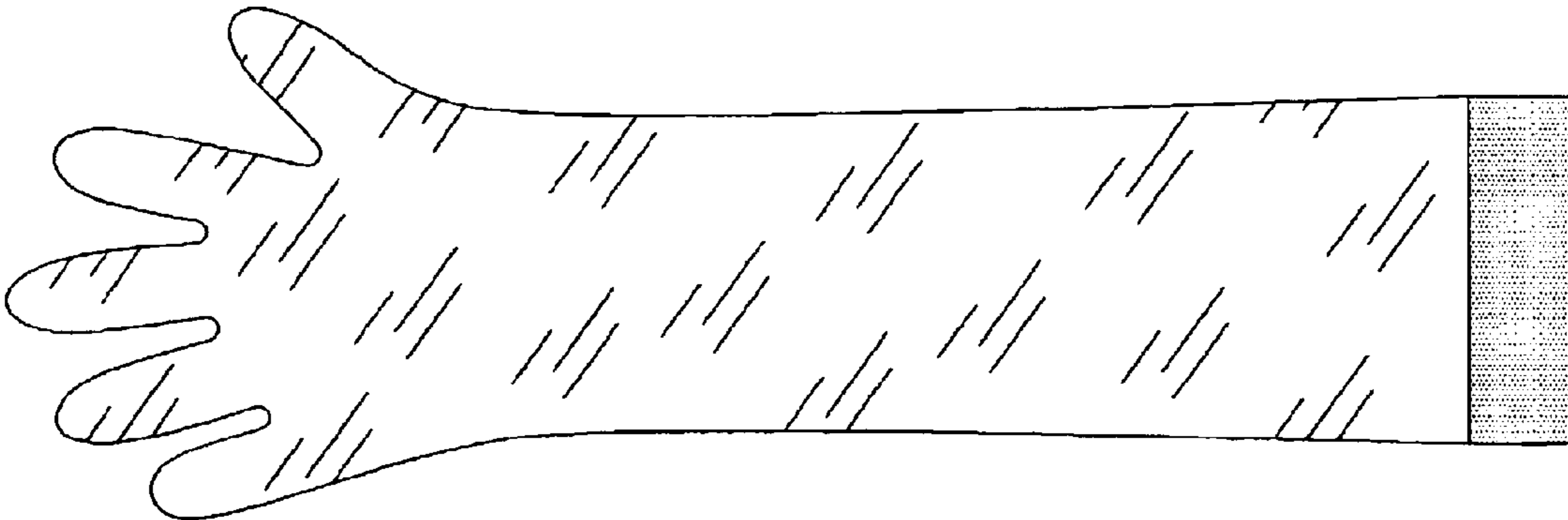

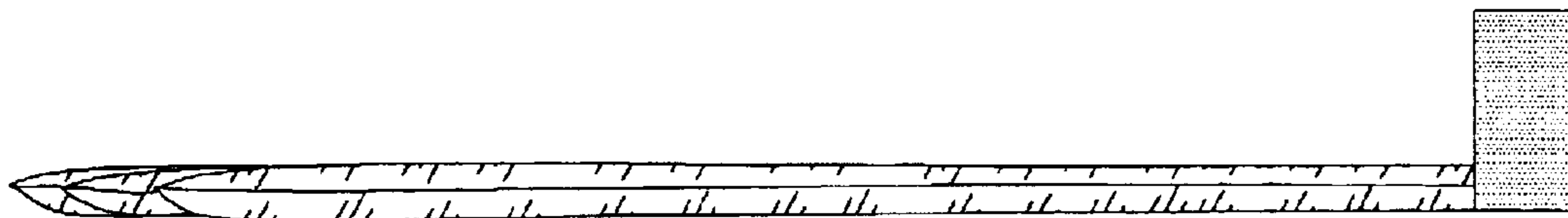

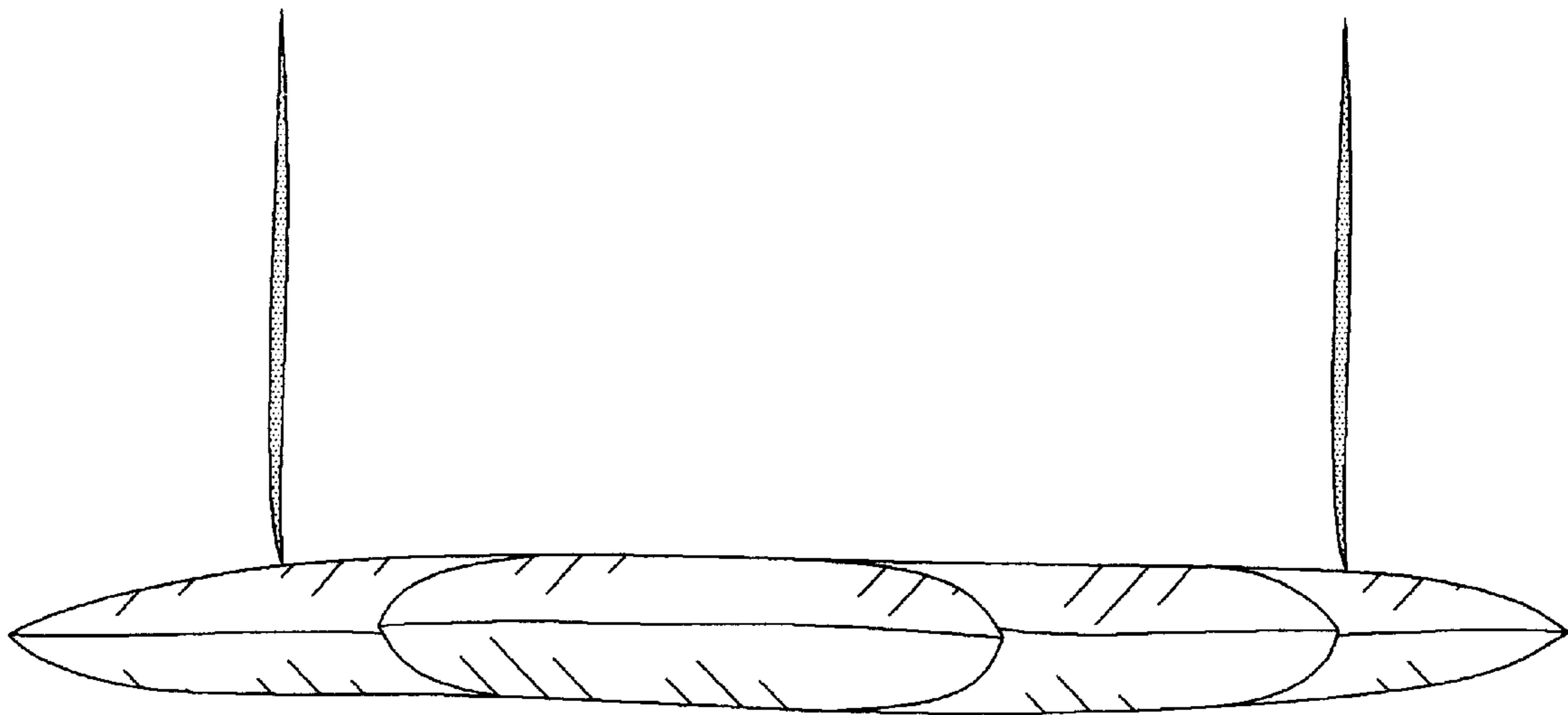

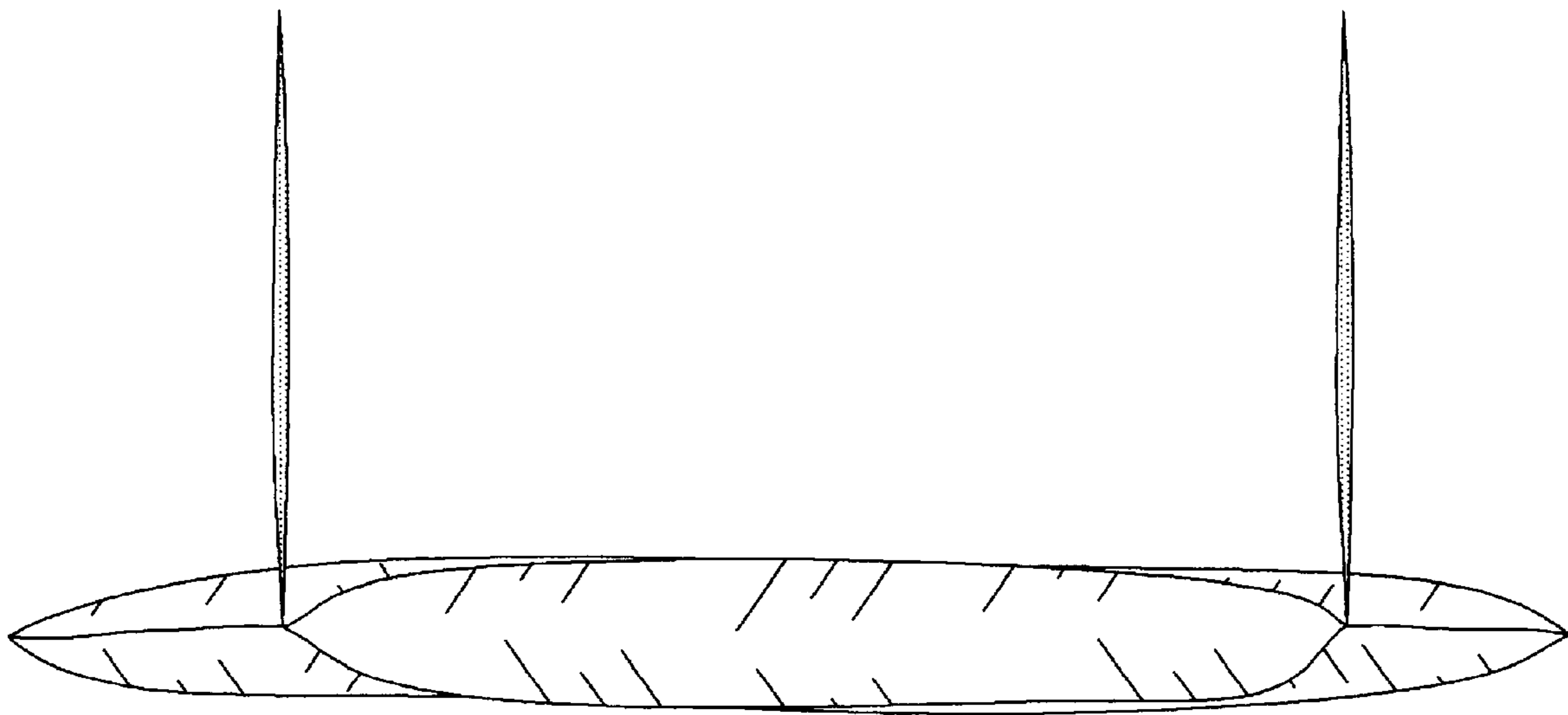
