**DESCRIPTION**

FIG. 1 is a front view of a drum;

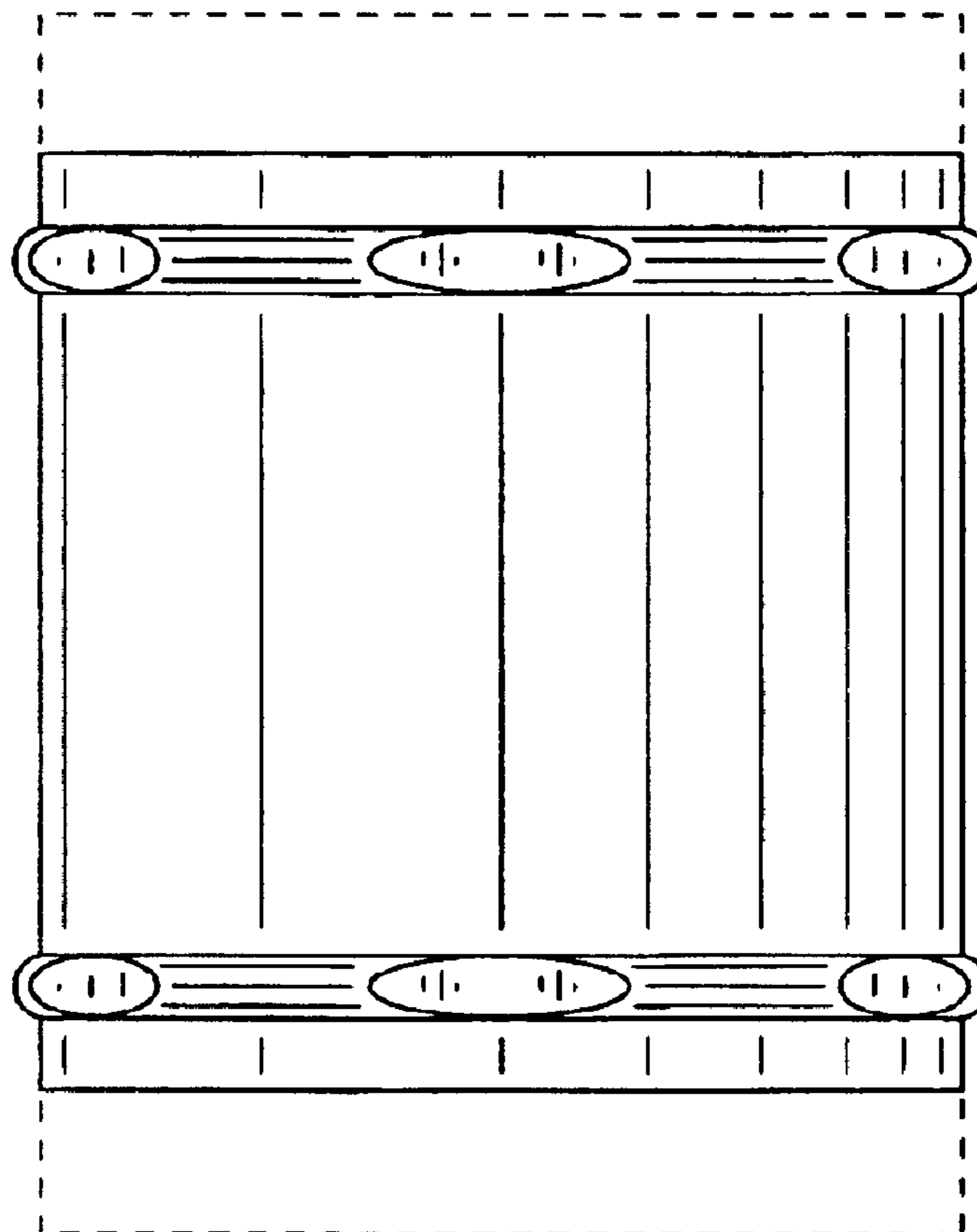

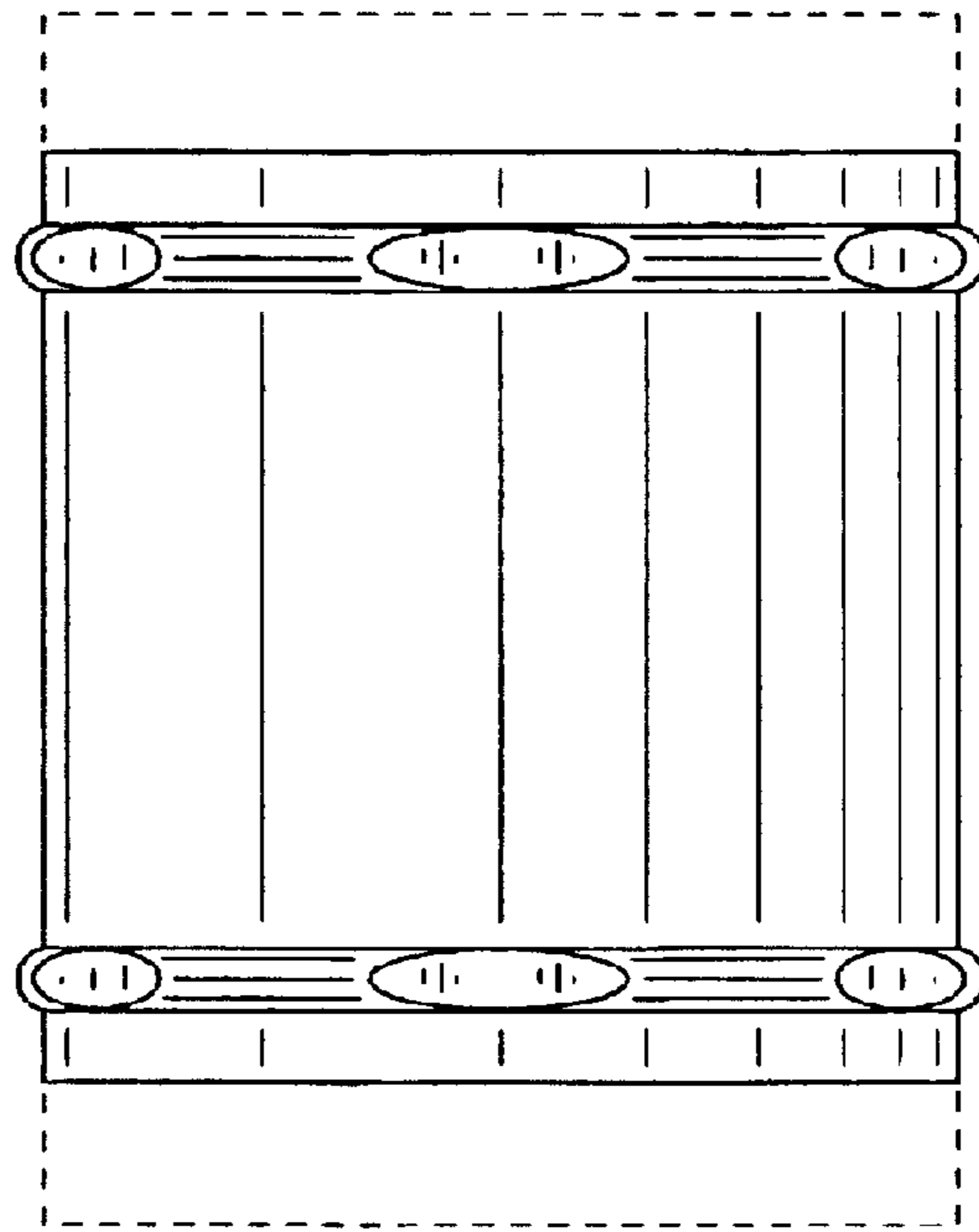

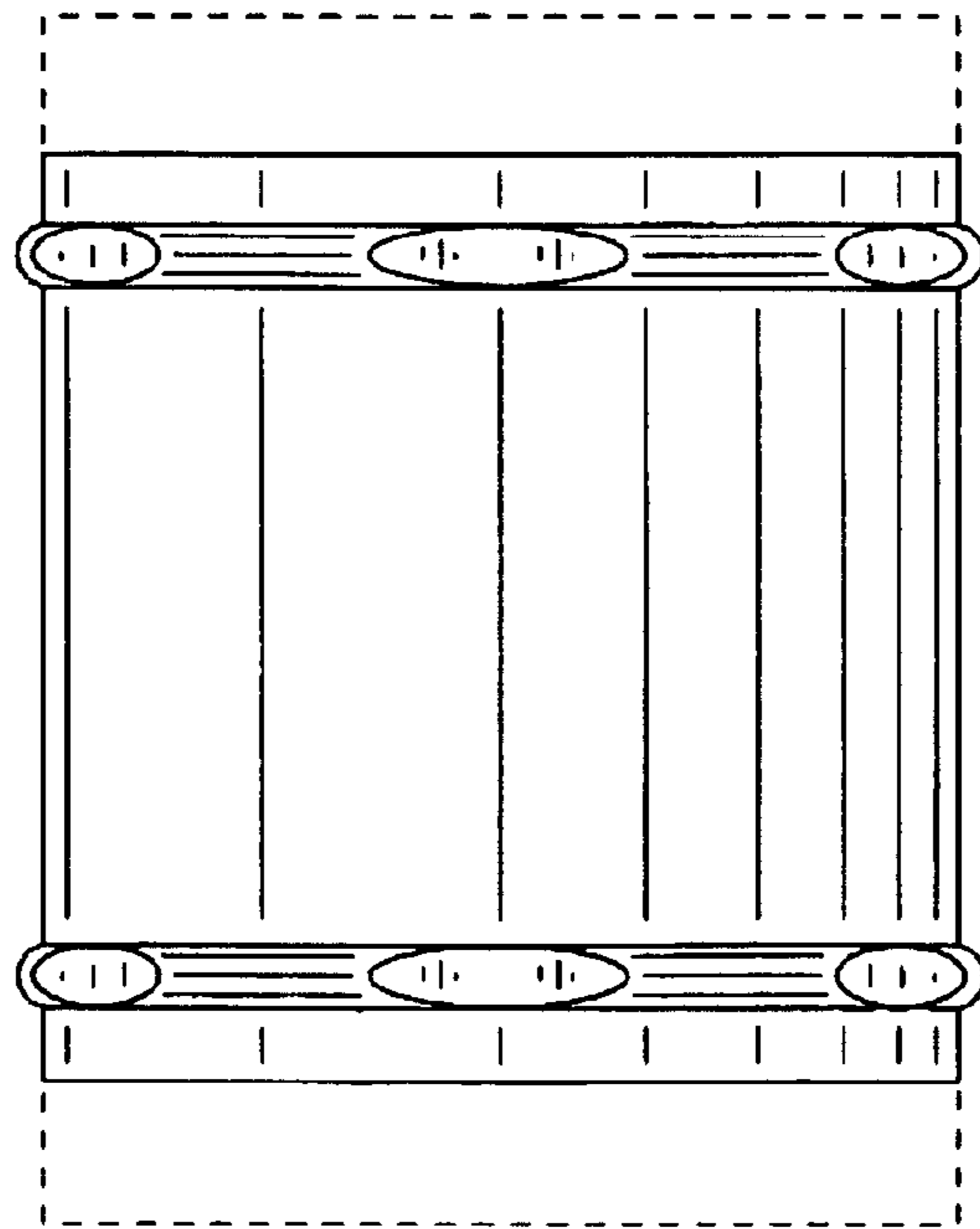

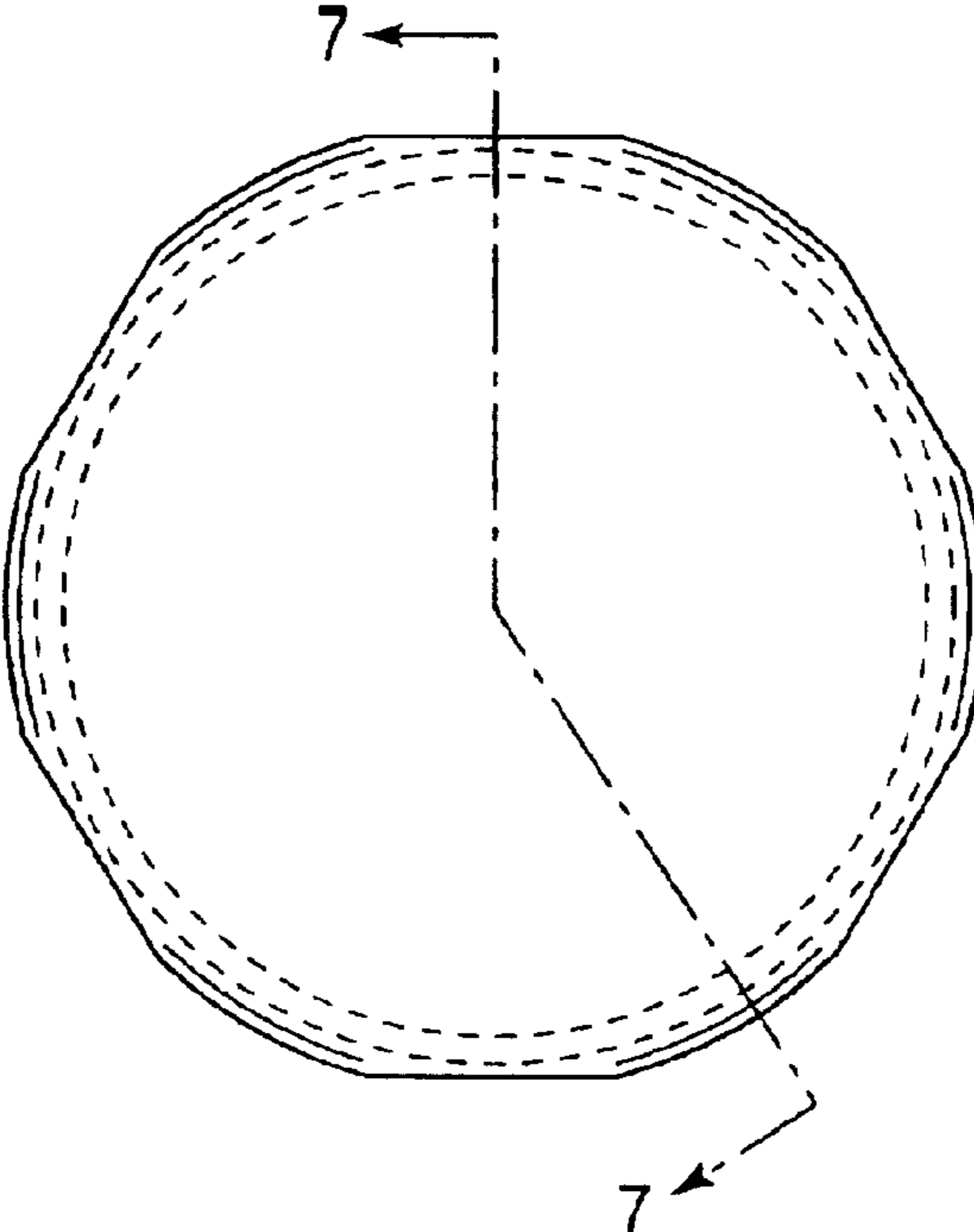

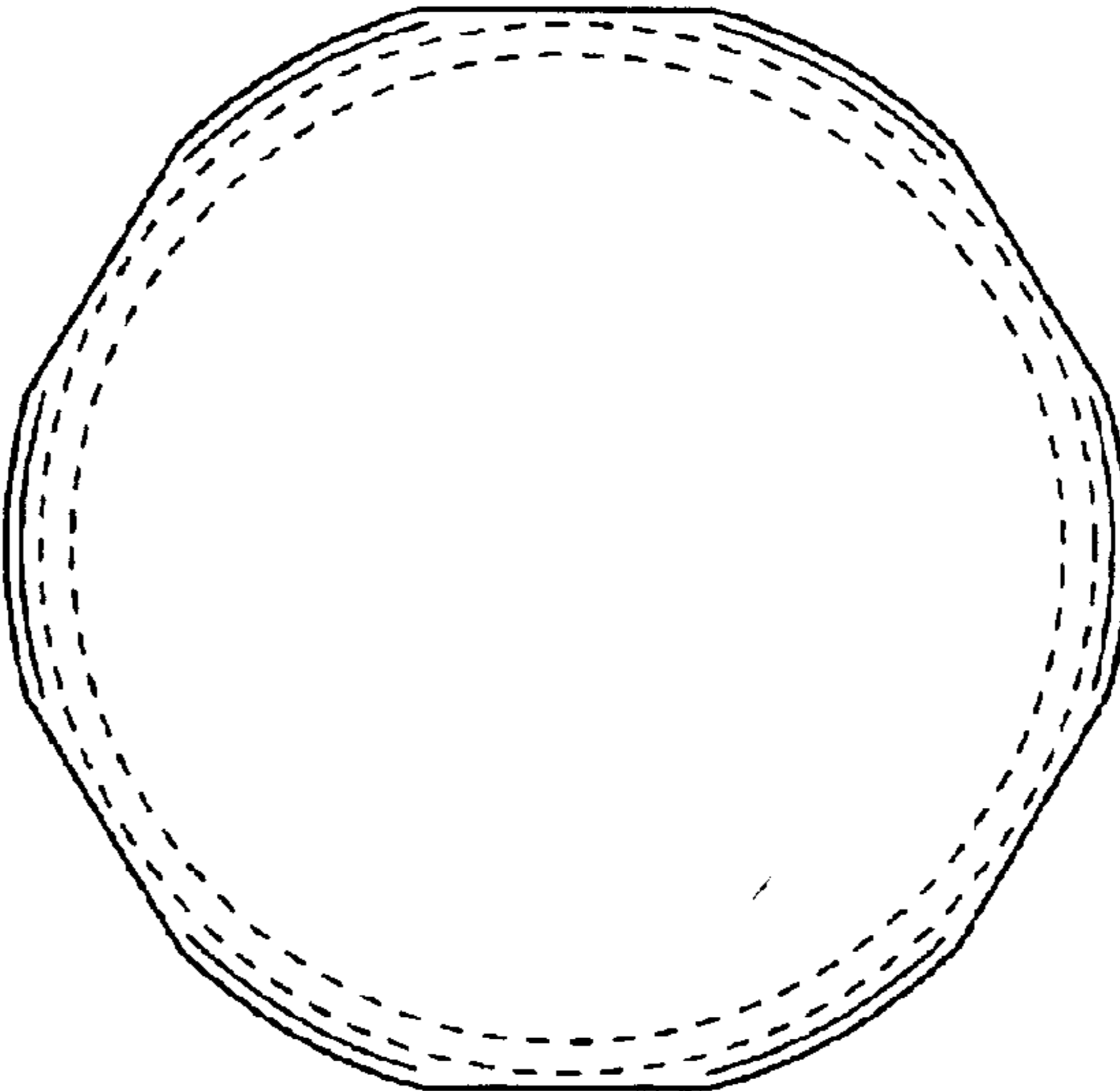

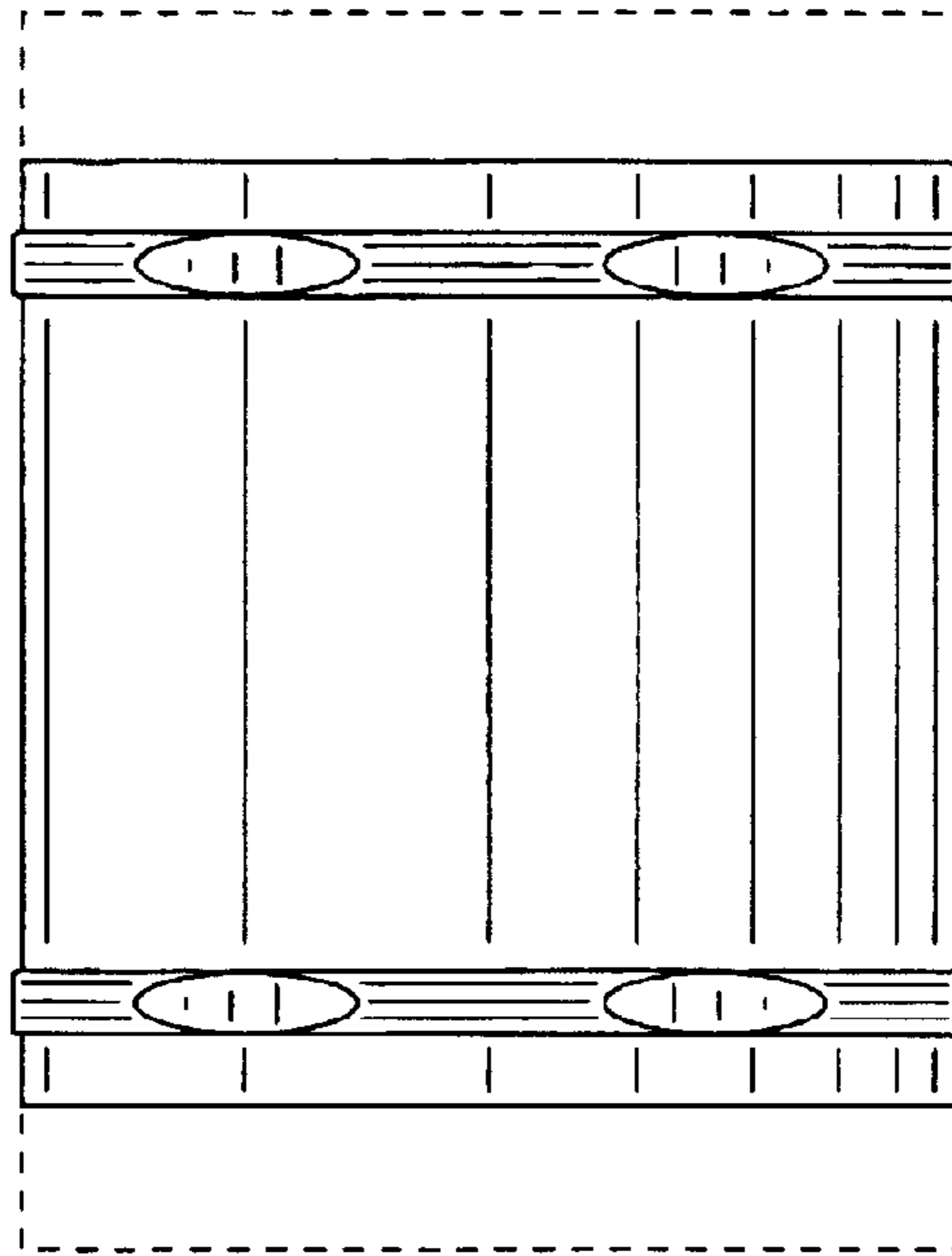

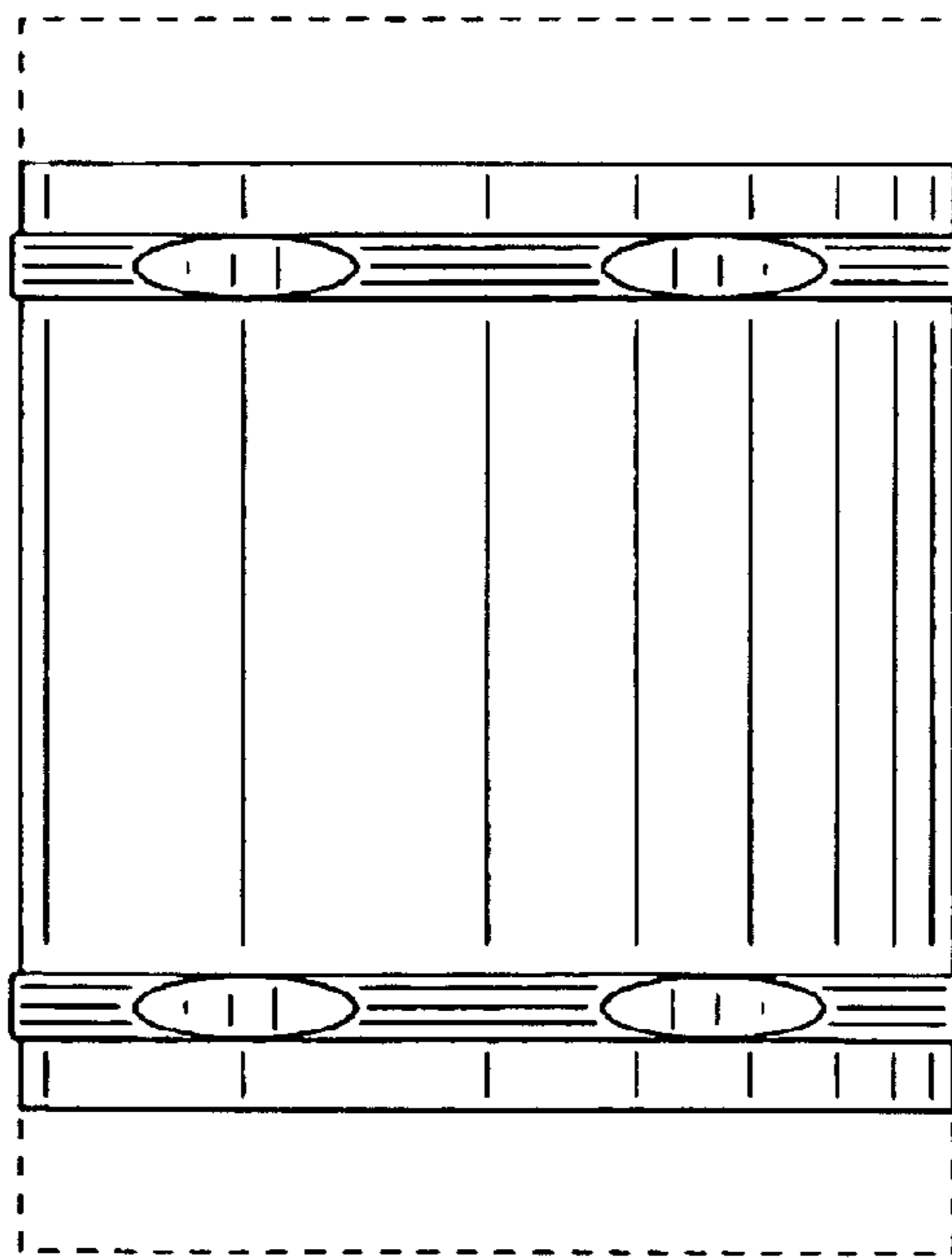

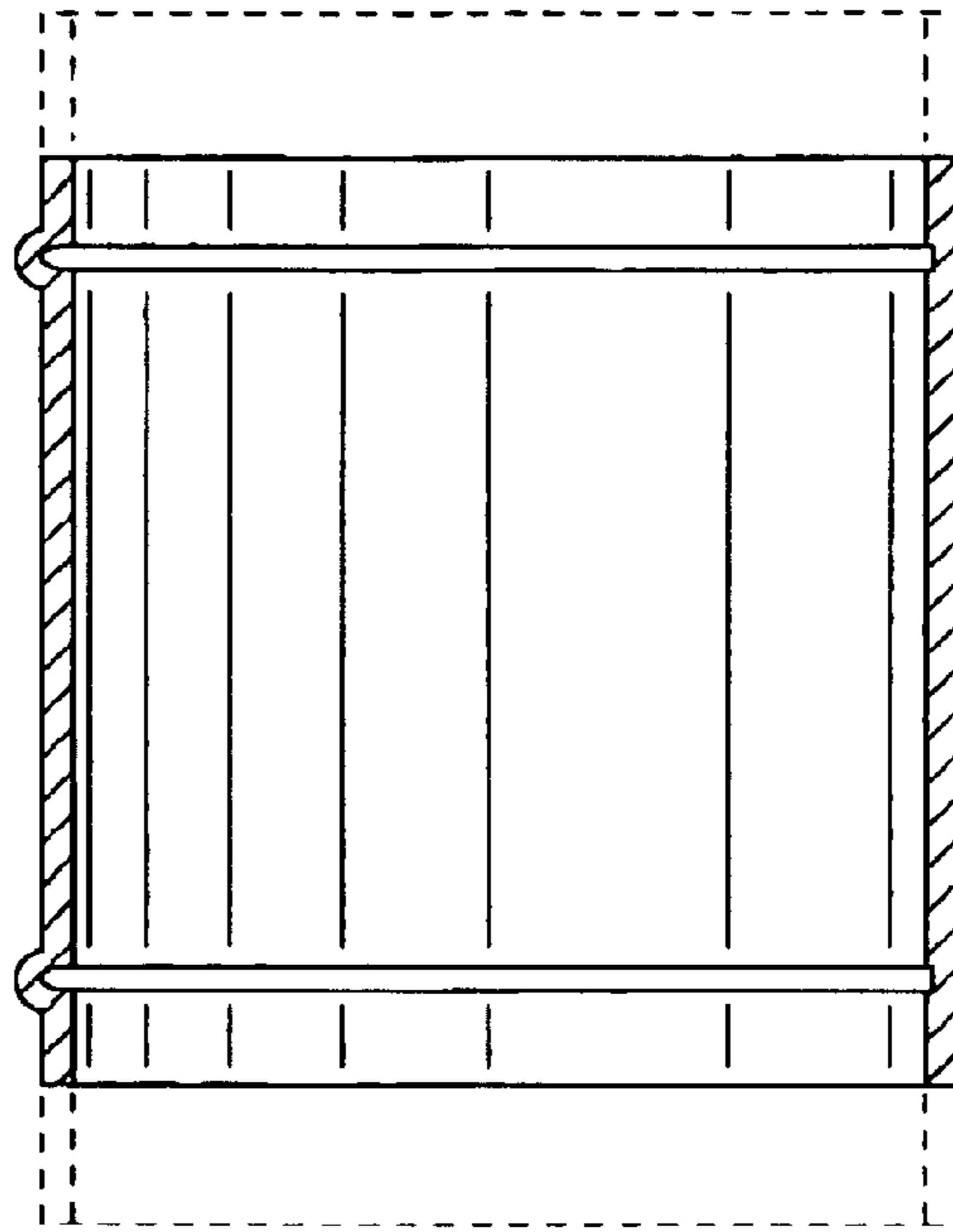
