FIG. 3 is a back elevation view of the embodiment of FIG. 1;

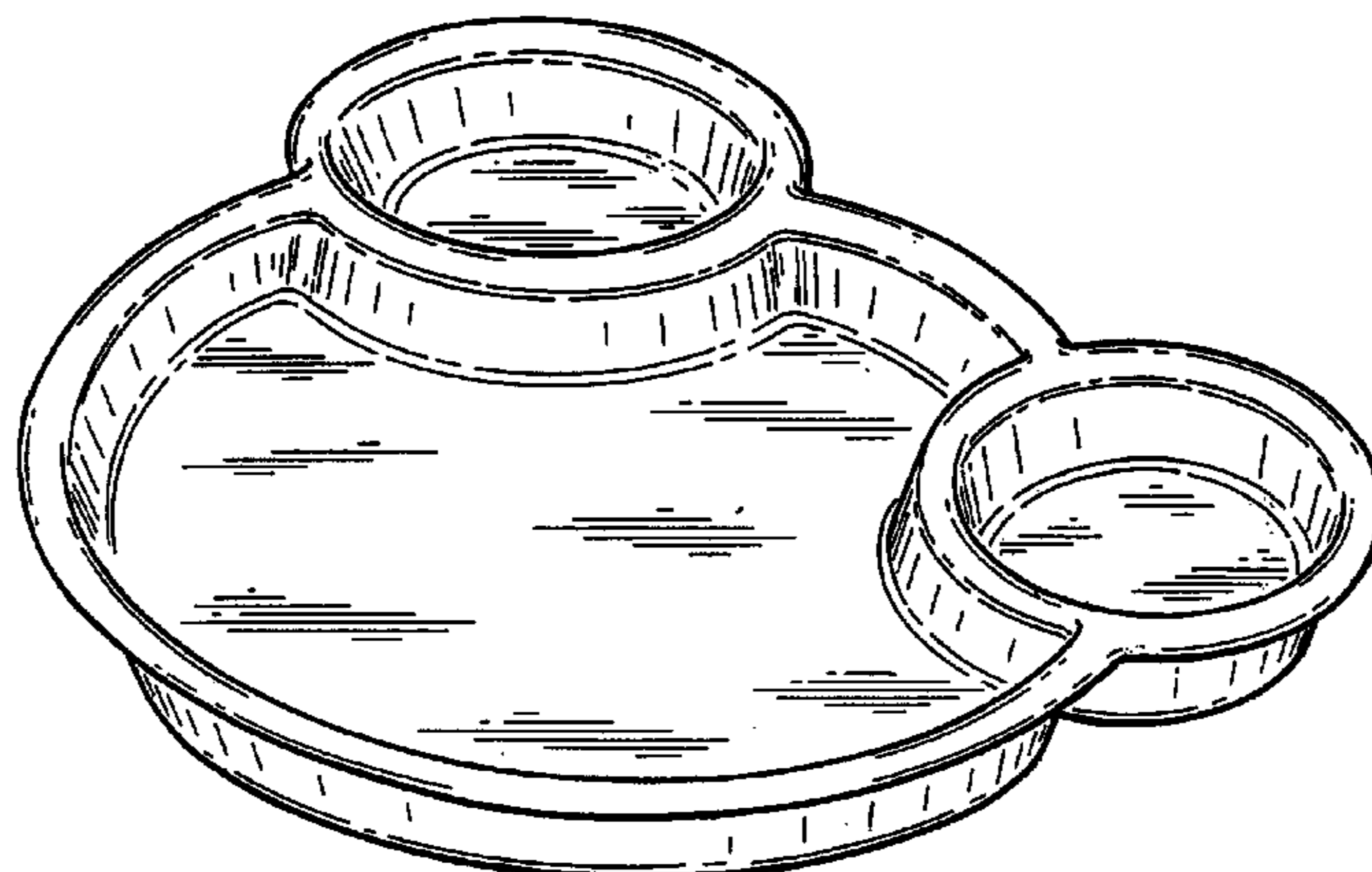
FIG. 4 is a top plan view of the embodiment of FIG. 1;

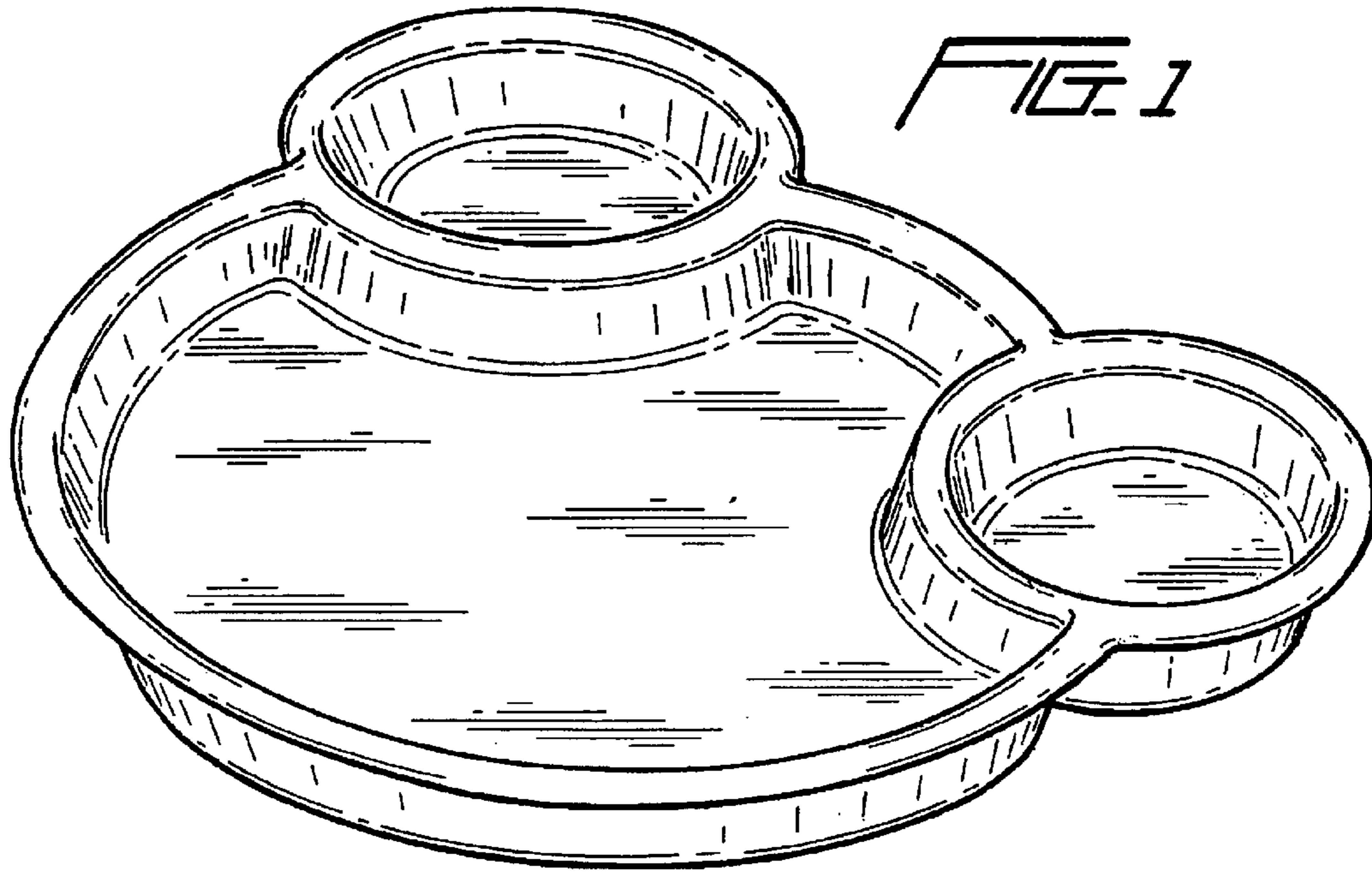

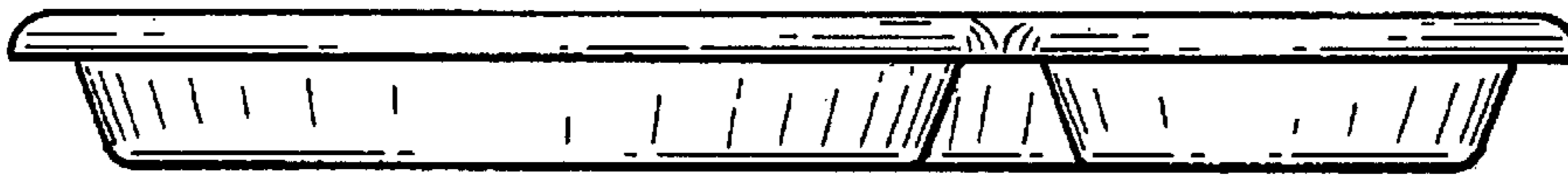
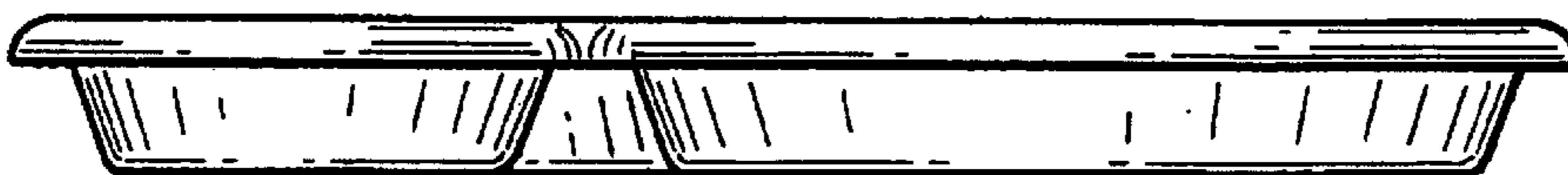

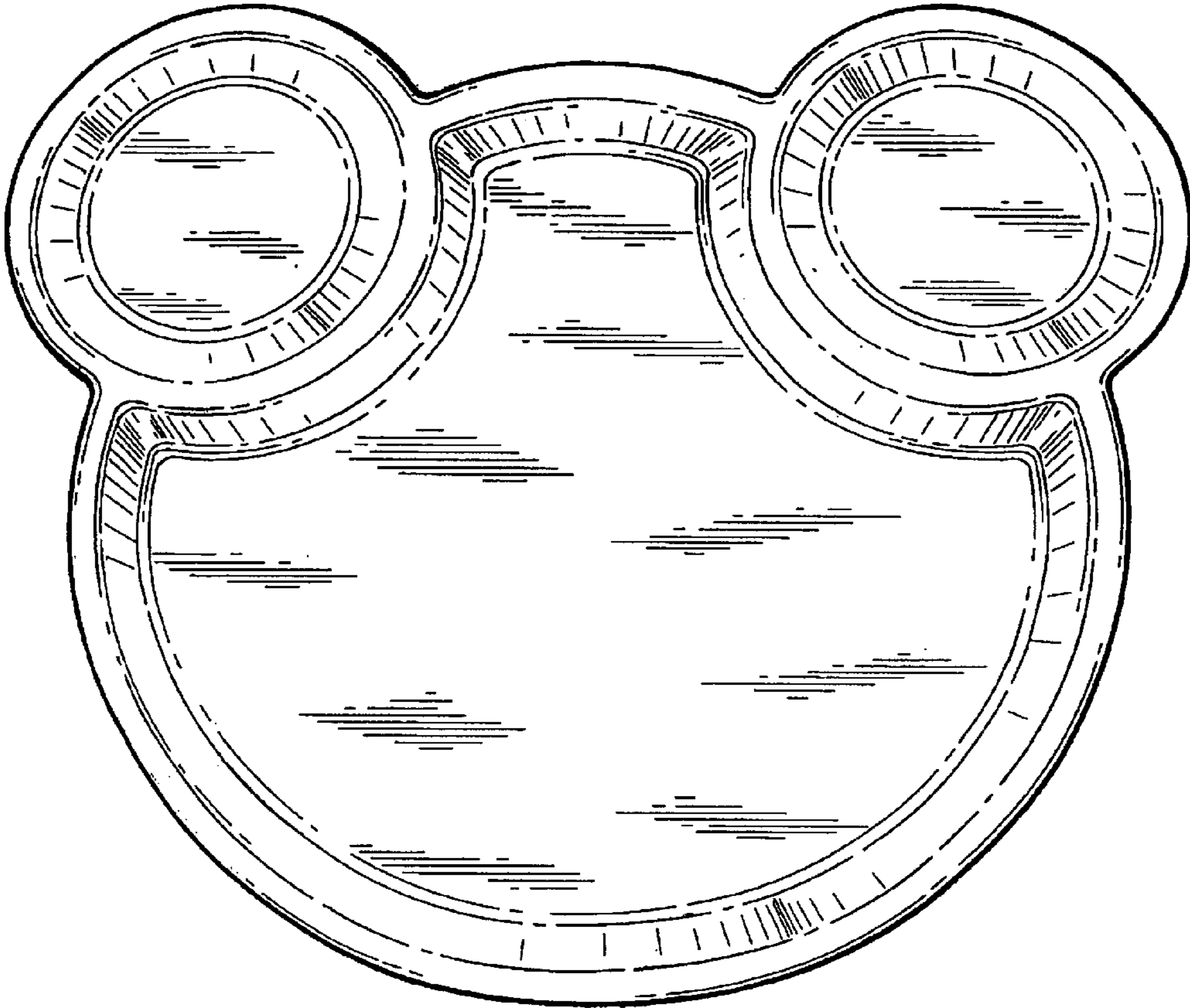
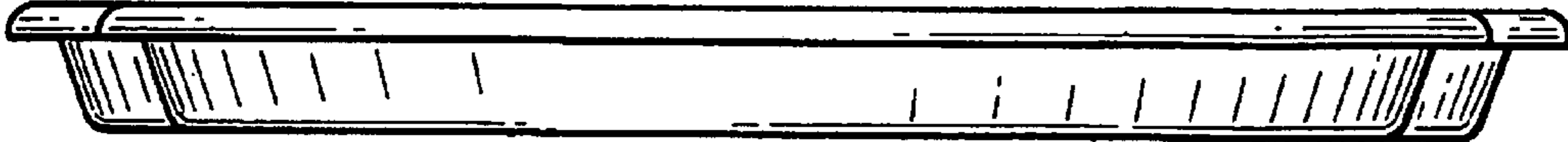

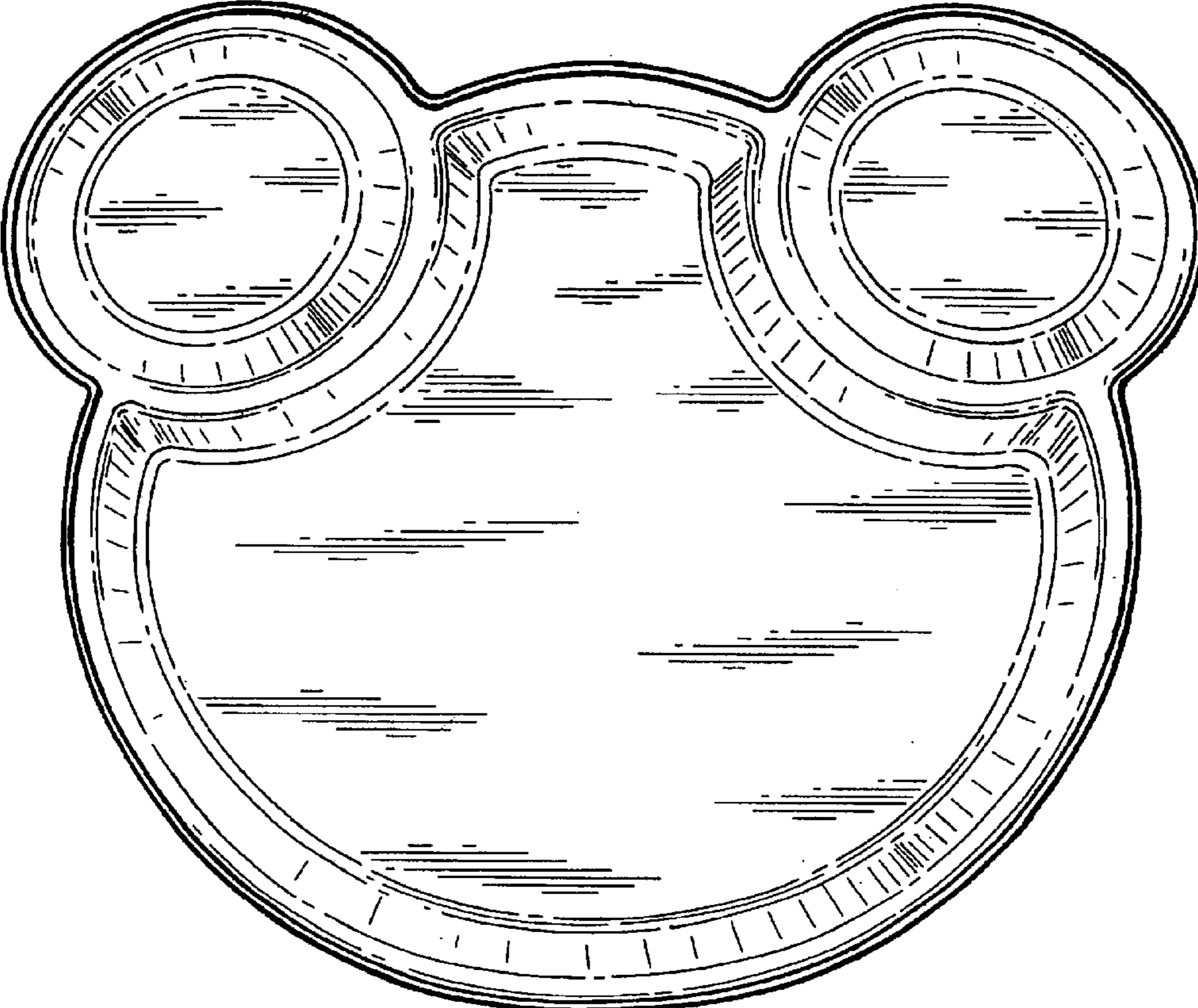
