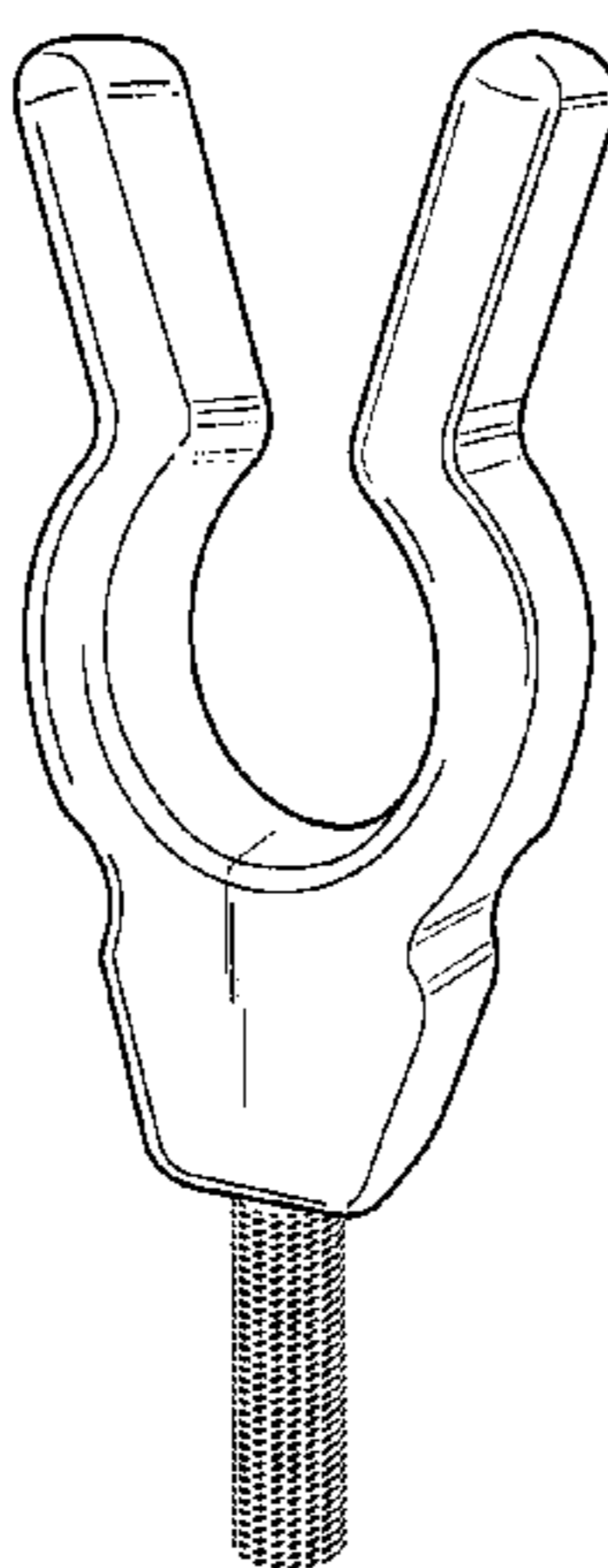
(57) **CLAIM**

What is claimed is the ornamental design for a tool holder, as shown and described herein.

**DESCRIPTION**

FIG. 1 is a perspective view of the tool holder in accordance with our invention;  
FIG. 2 is a front view of our invention as shown in FIG. 1, an opposing rear view being the mirror image thereof;  
FIG. 3 is a side view of our invention as shown in FIG. 1, an opposing side view being the mirror image thereof;  
FIG. 4 is top view of our invention in FIG. 1; and,  
FIG. 5 is bottom view of our invention shown in FIG. 1.  
The broken line showing of the lower attachment bolt is for illustrative purposes only and forms no part of the claimed design.

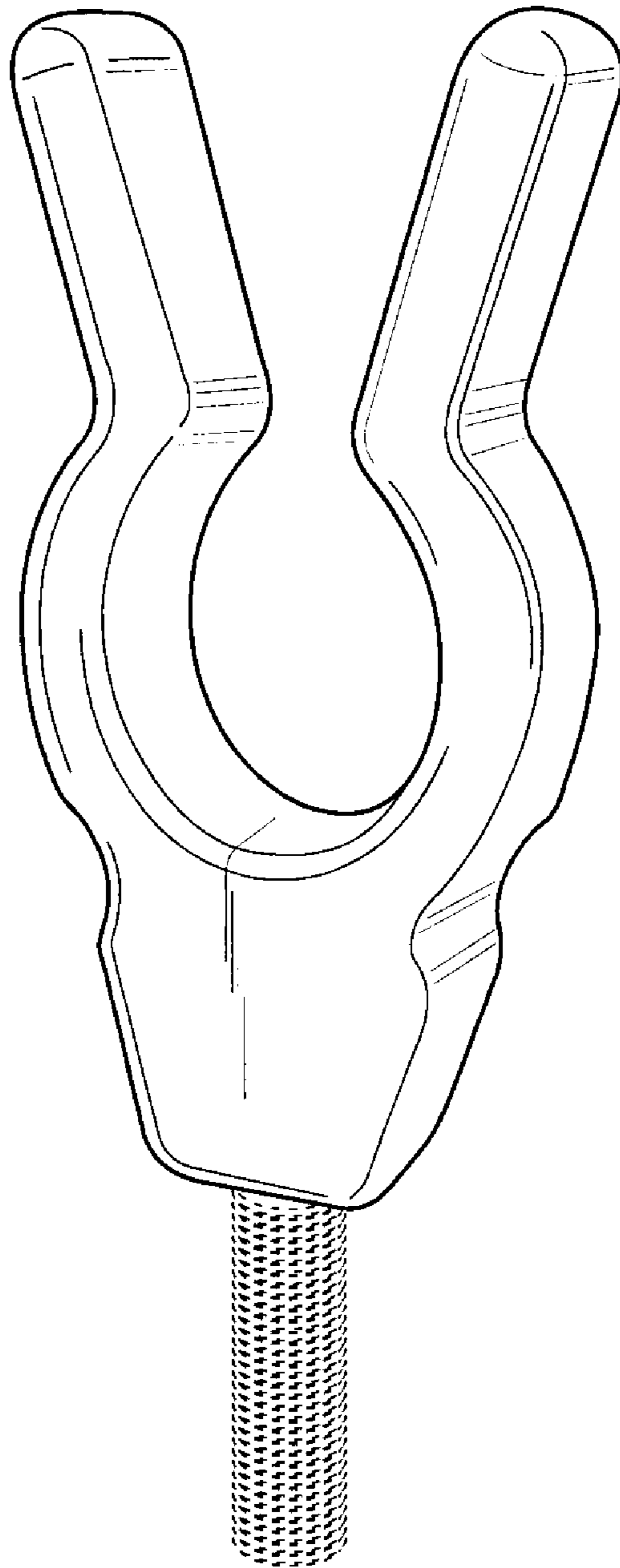

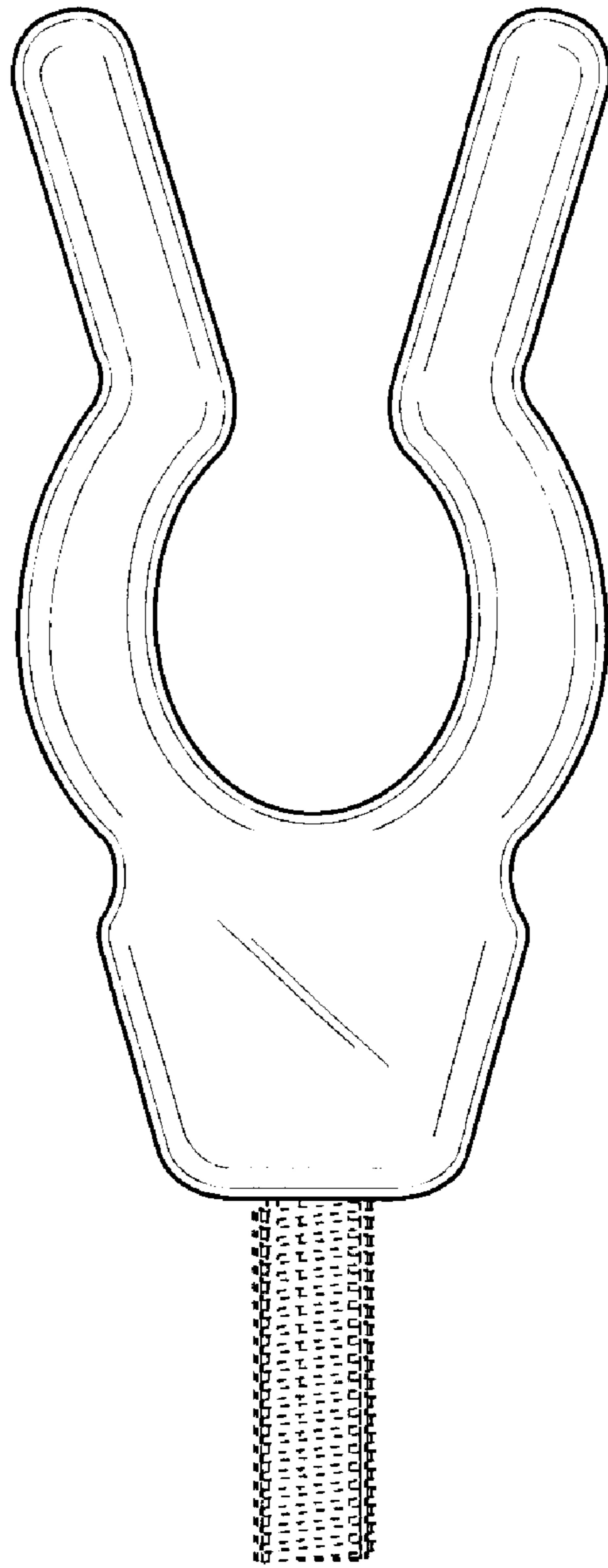

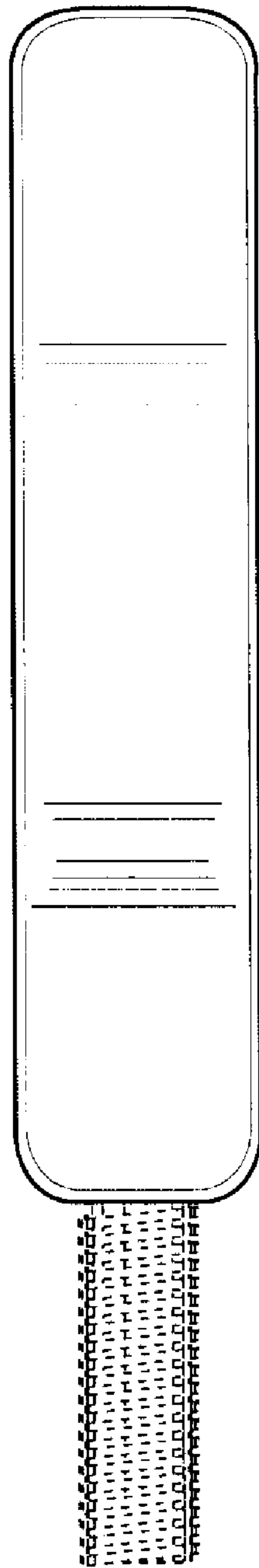

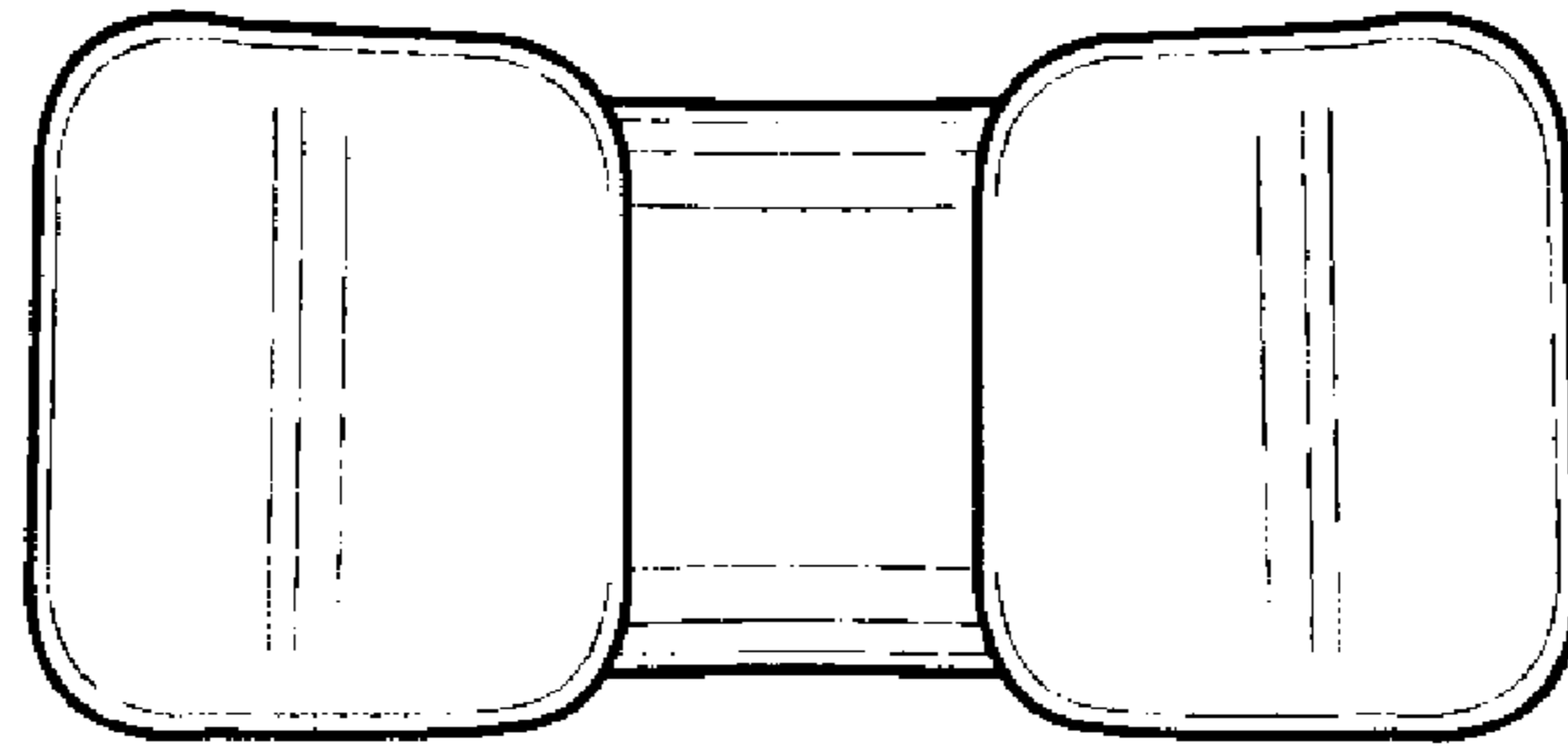

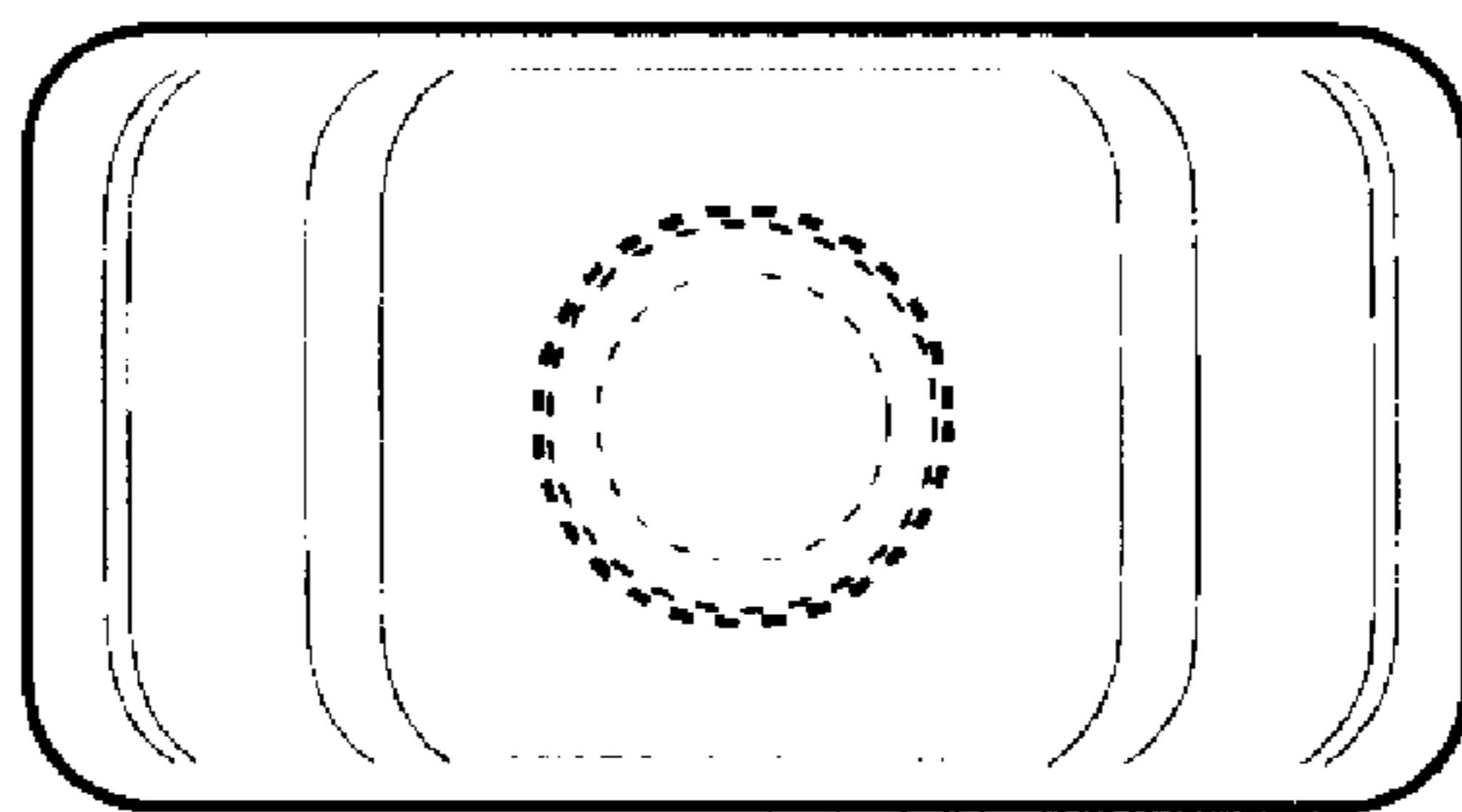
