FIG. 2 is a bottom, front and right side perspective view thereof;

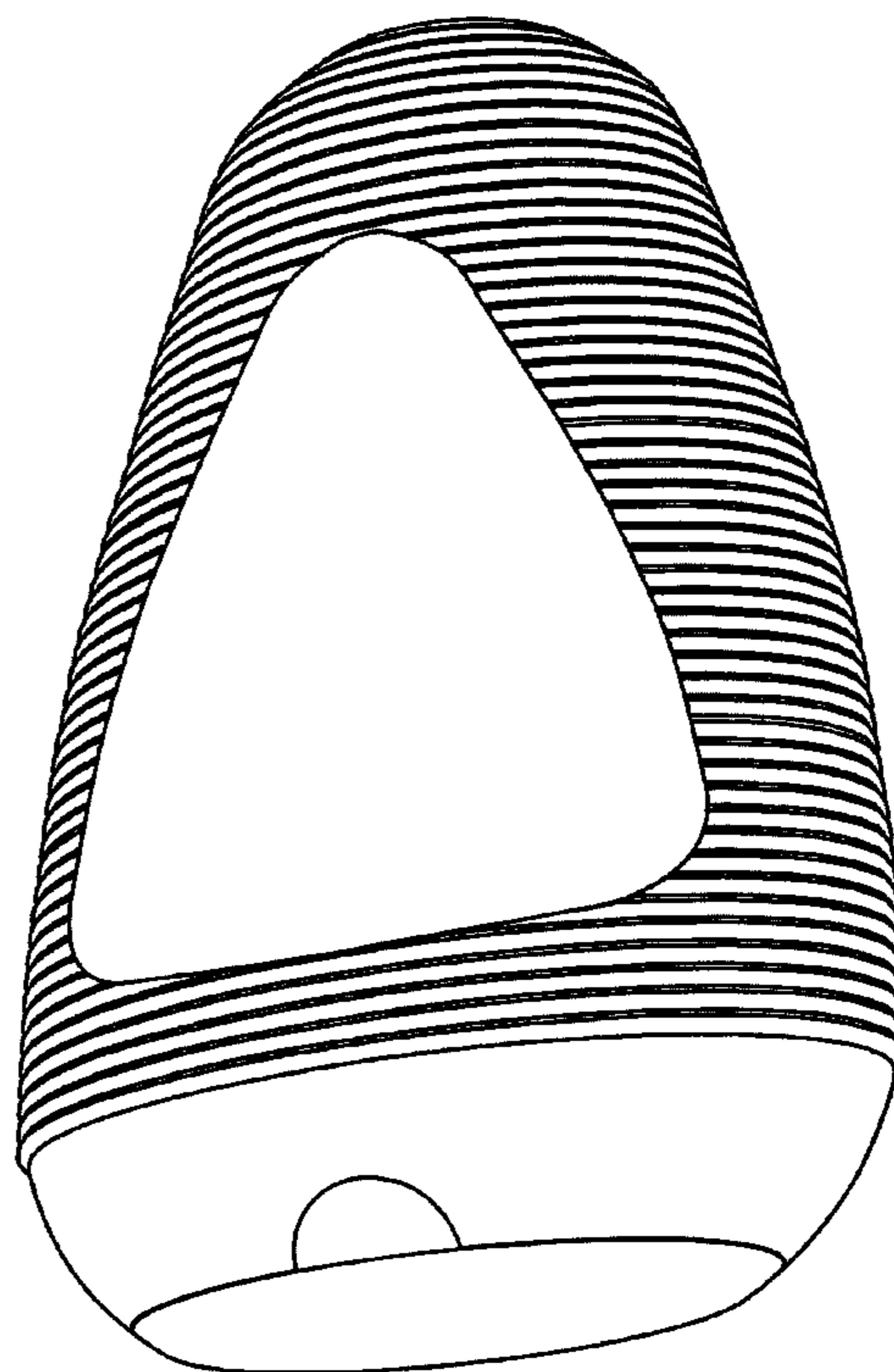
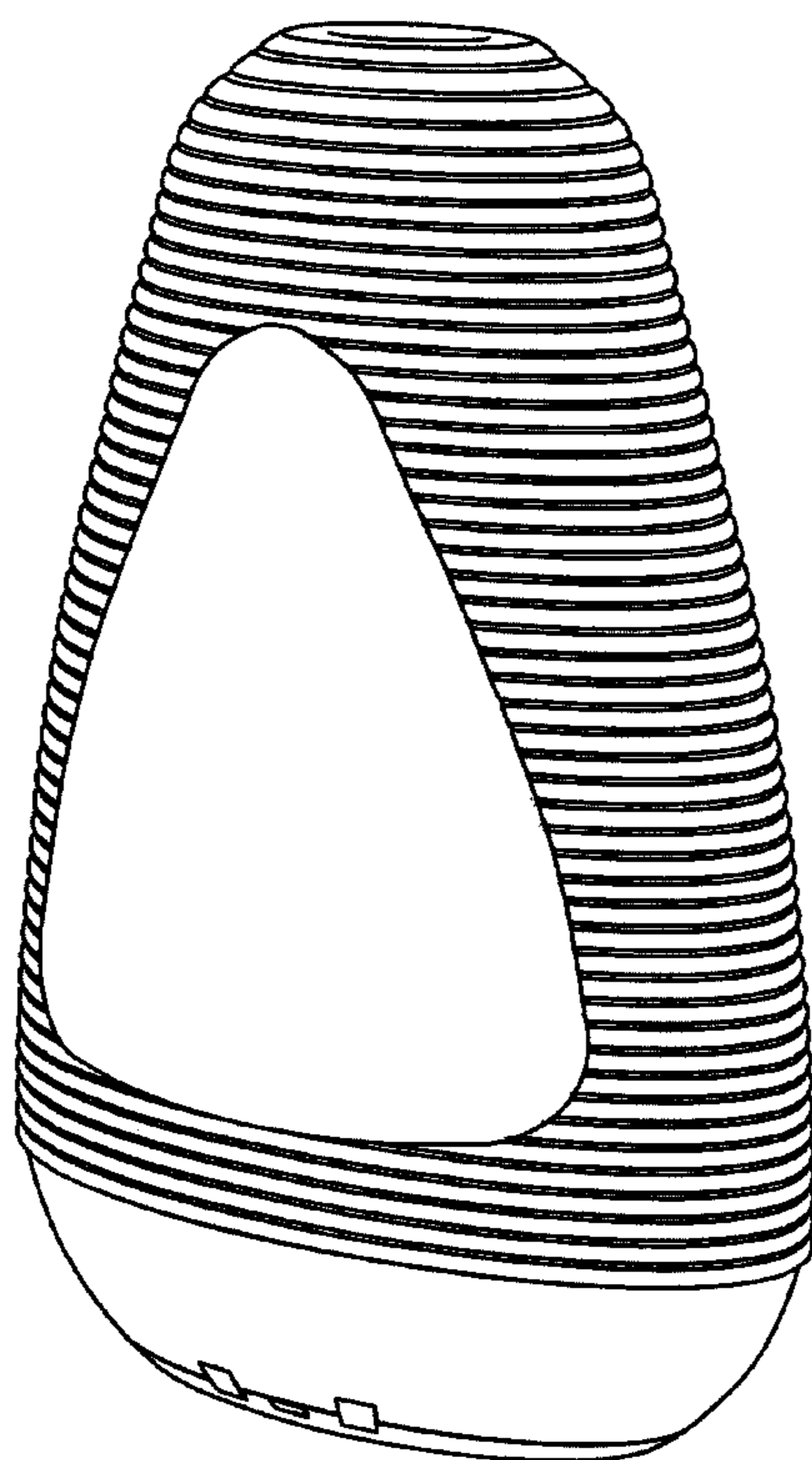
FIG. 3 is a front and right side perspective view thereof;

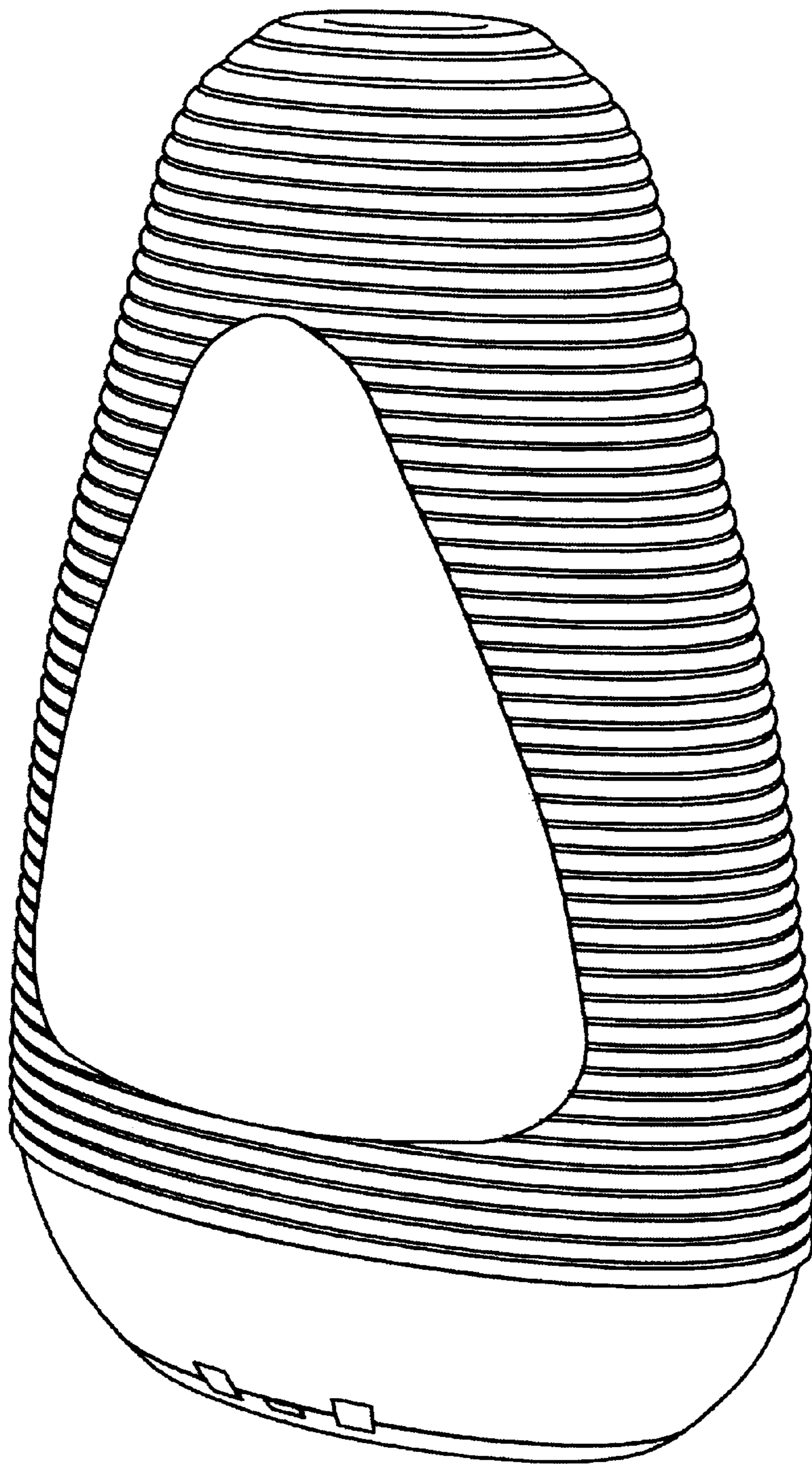

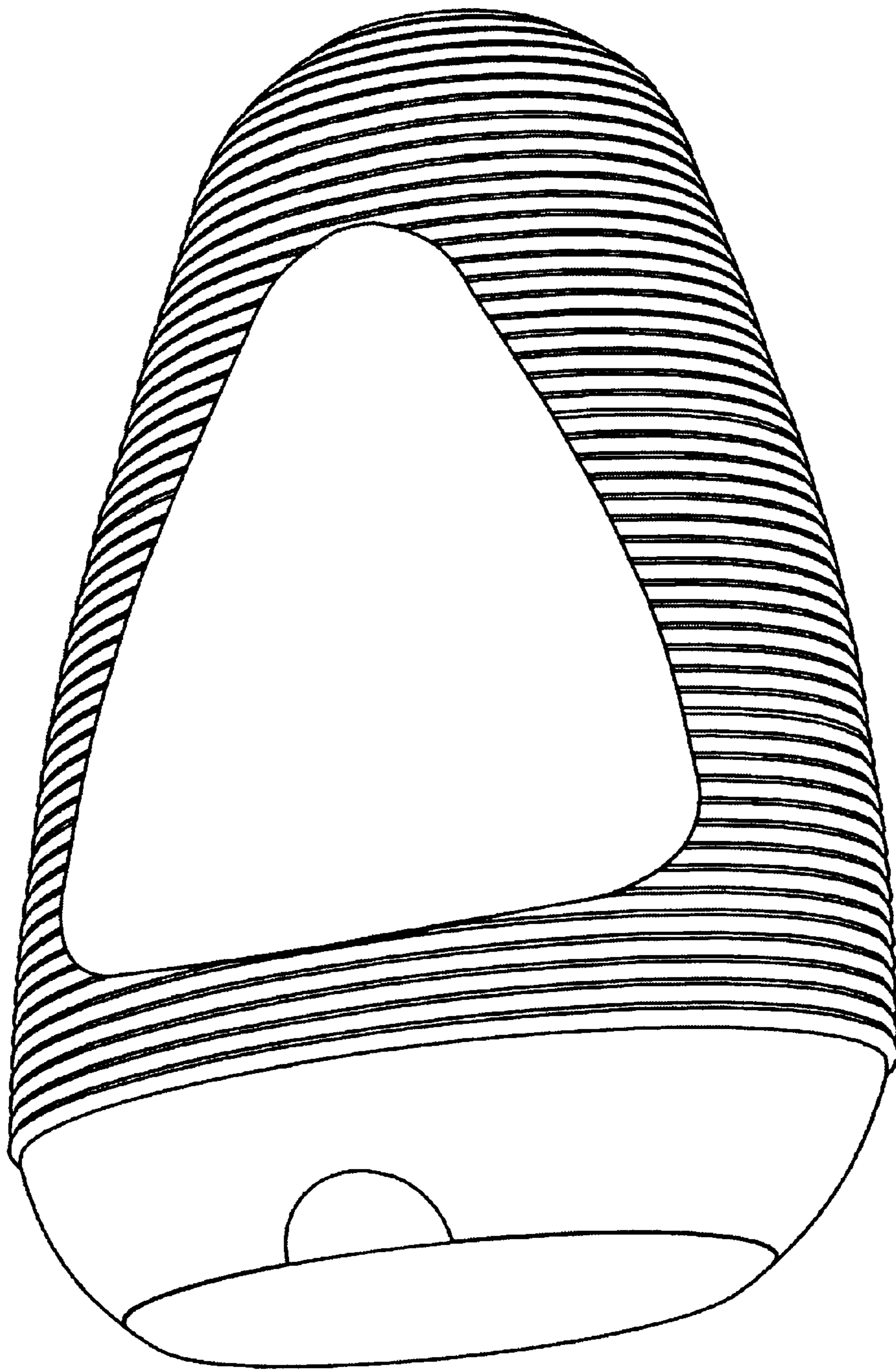

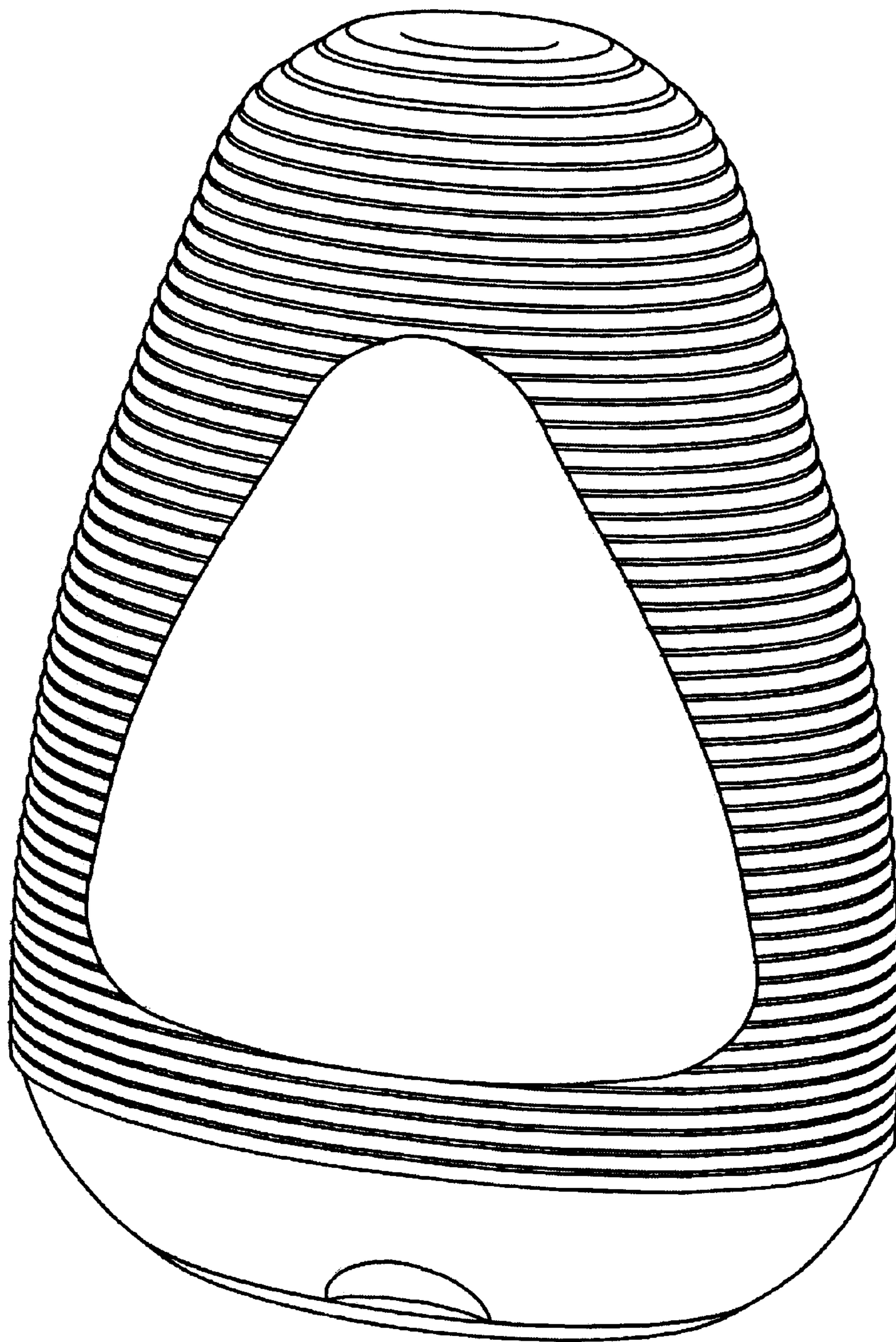

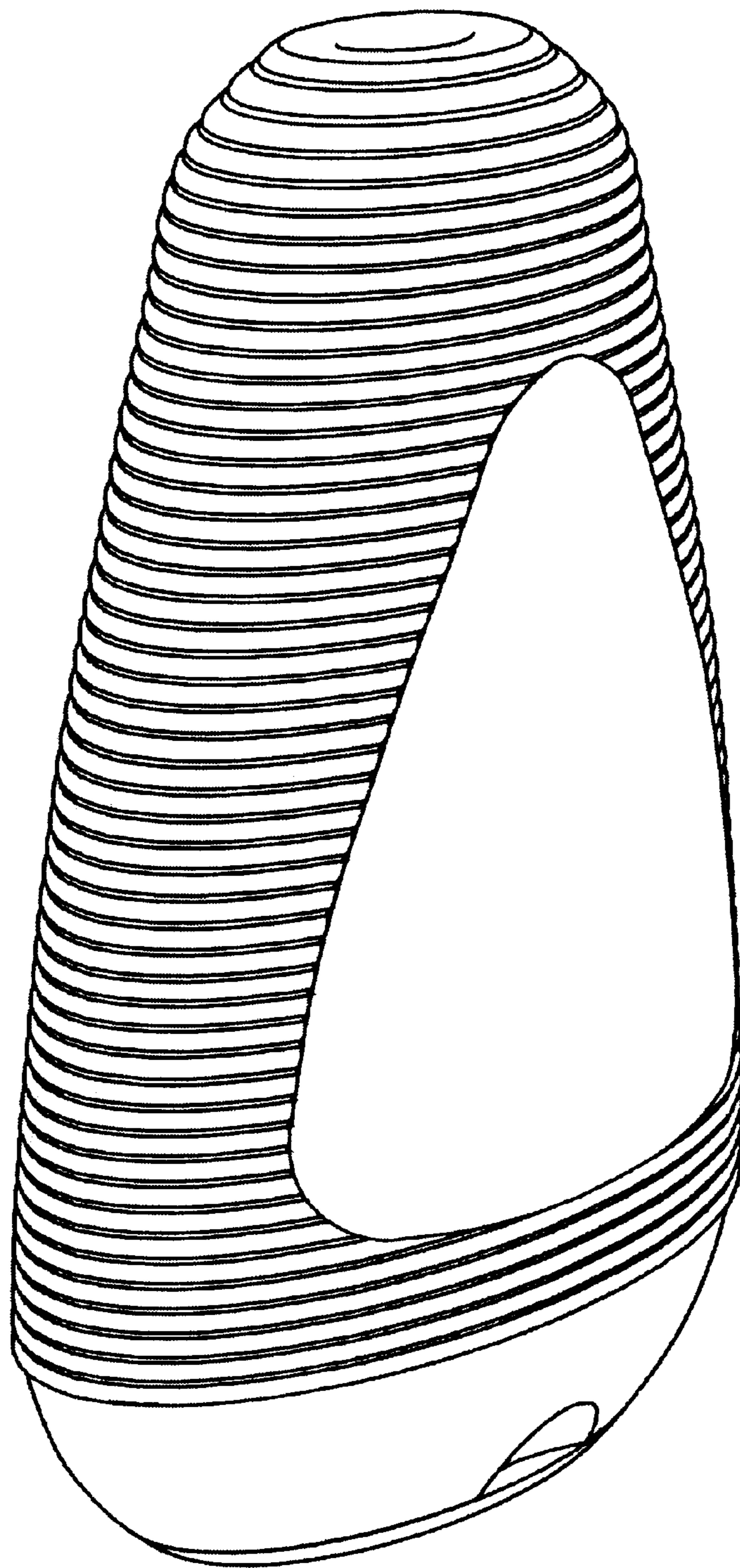

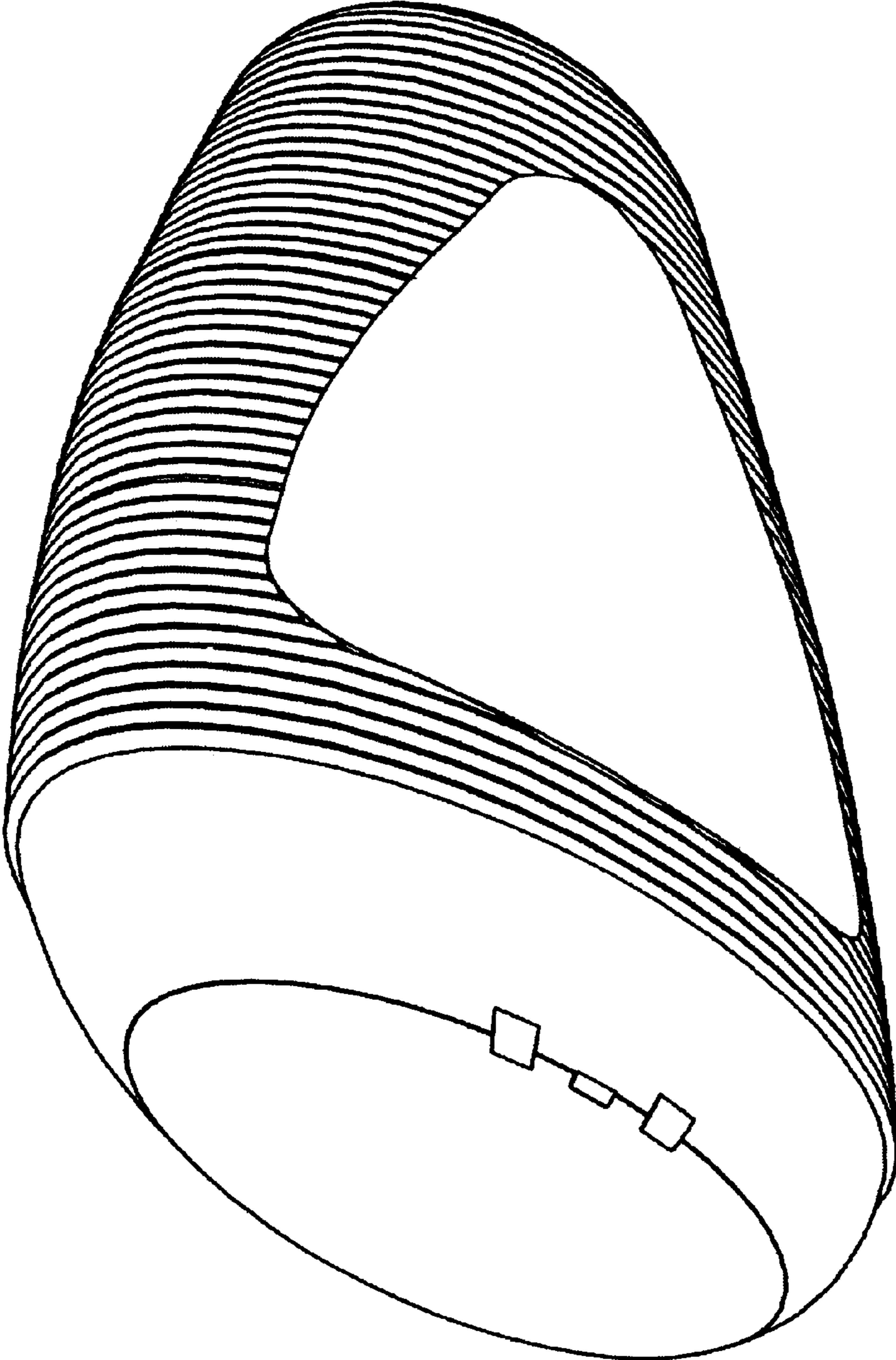

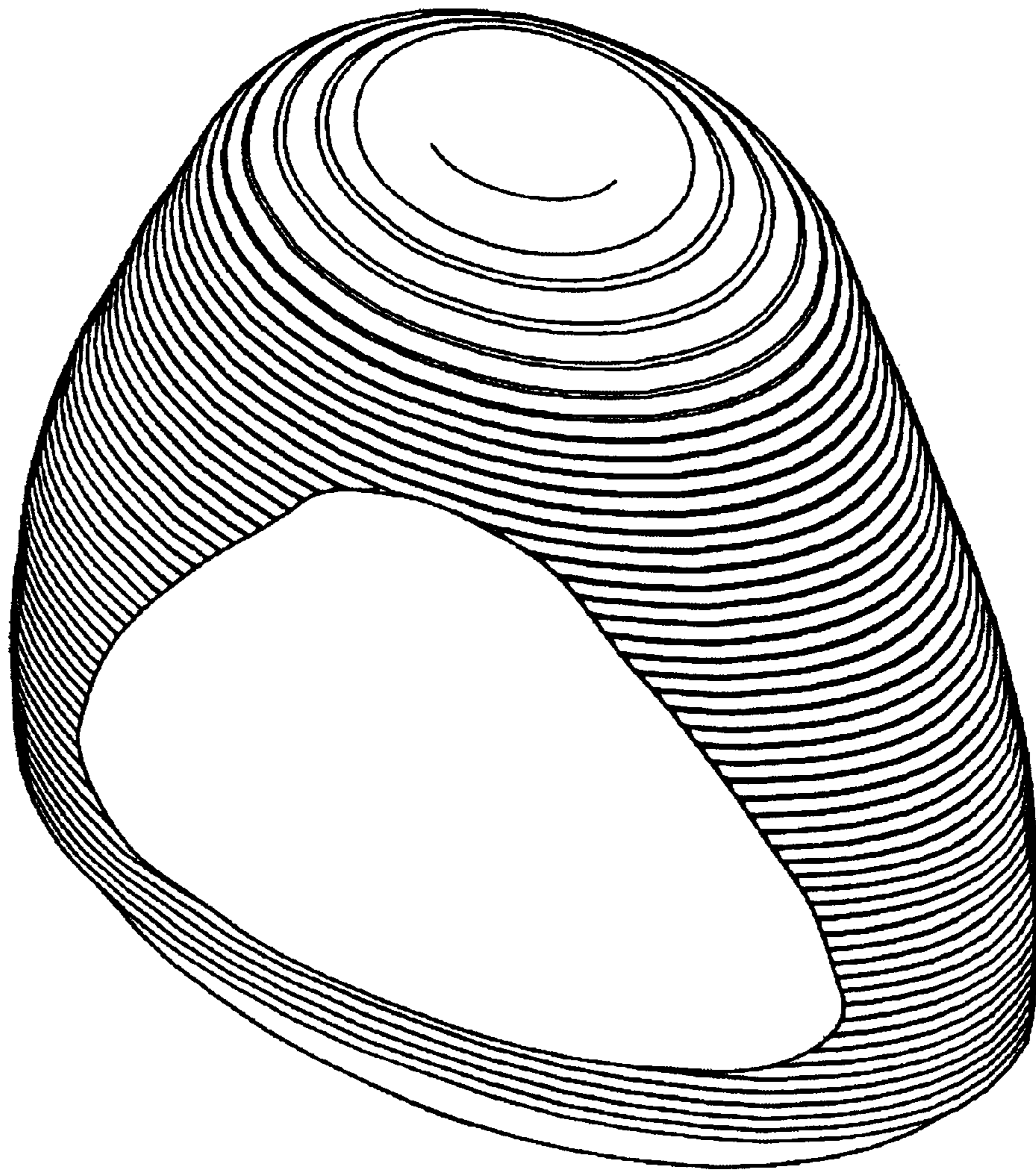
