**DESCRIPTION**

FIG. 1 is a front perspective view of a jewellery showing my  
new design;

FIG. 2 is a top end view of FIG. 1;

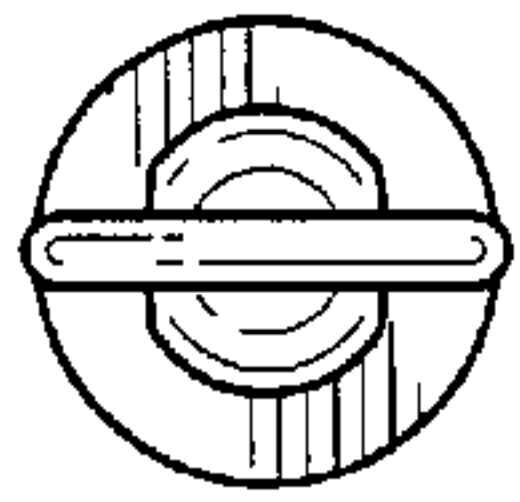

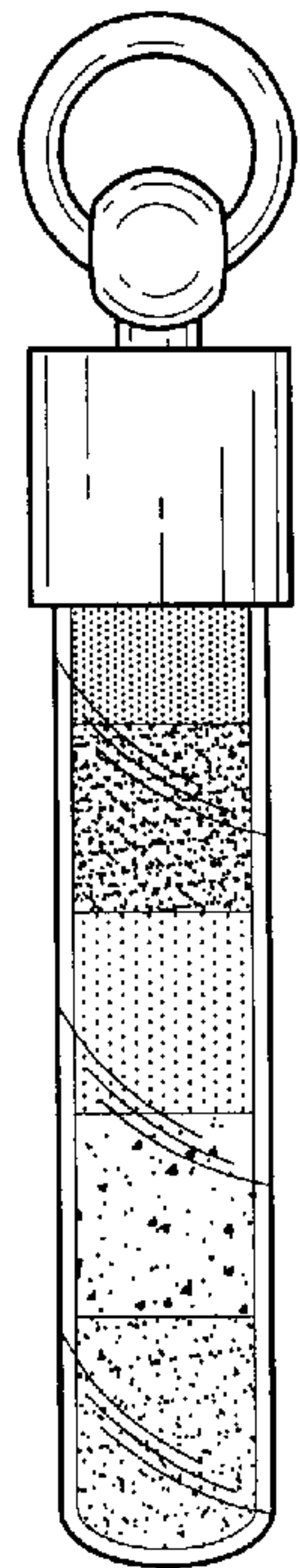

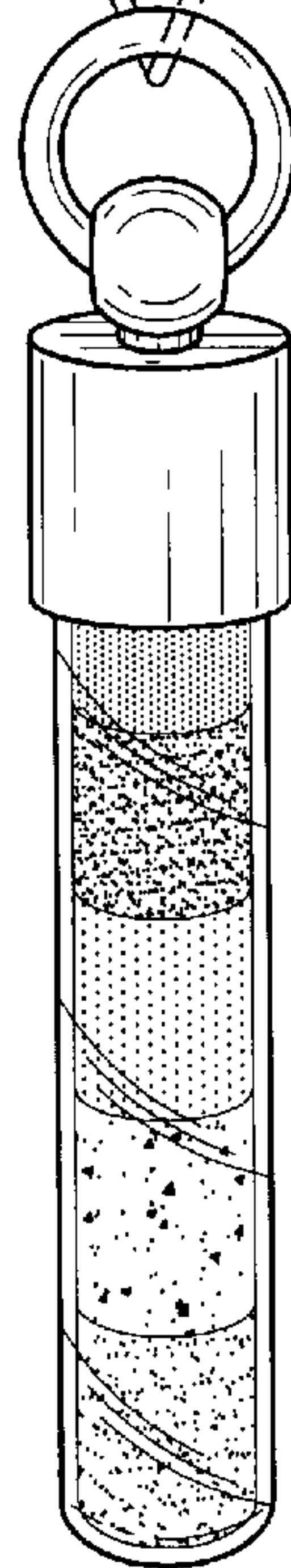

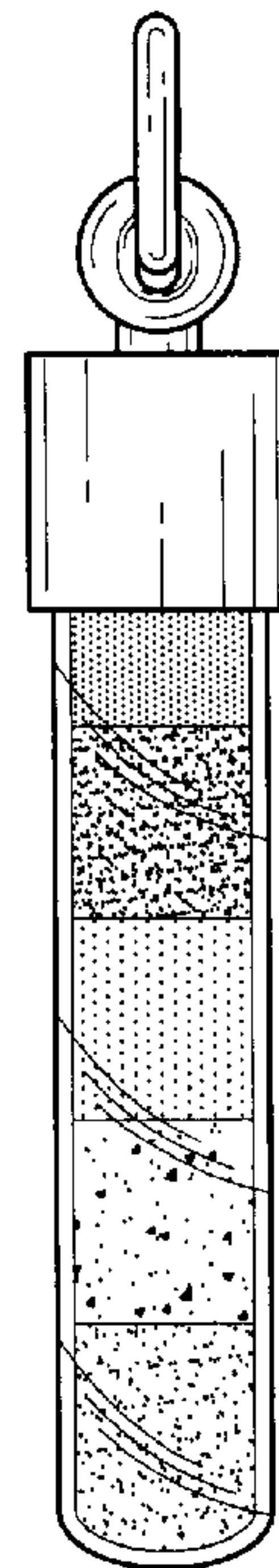

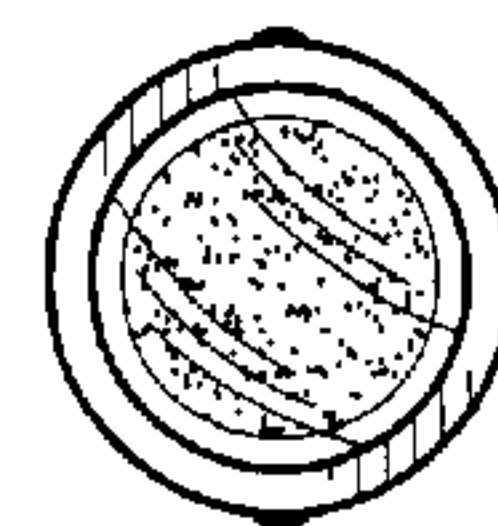
