FIG. 6 is a bottom plan view of the pregnancy symbol.

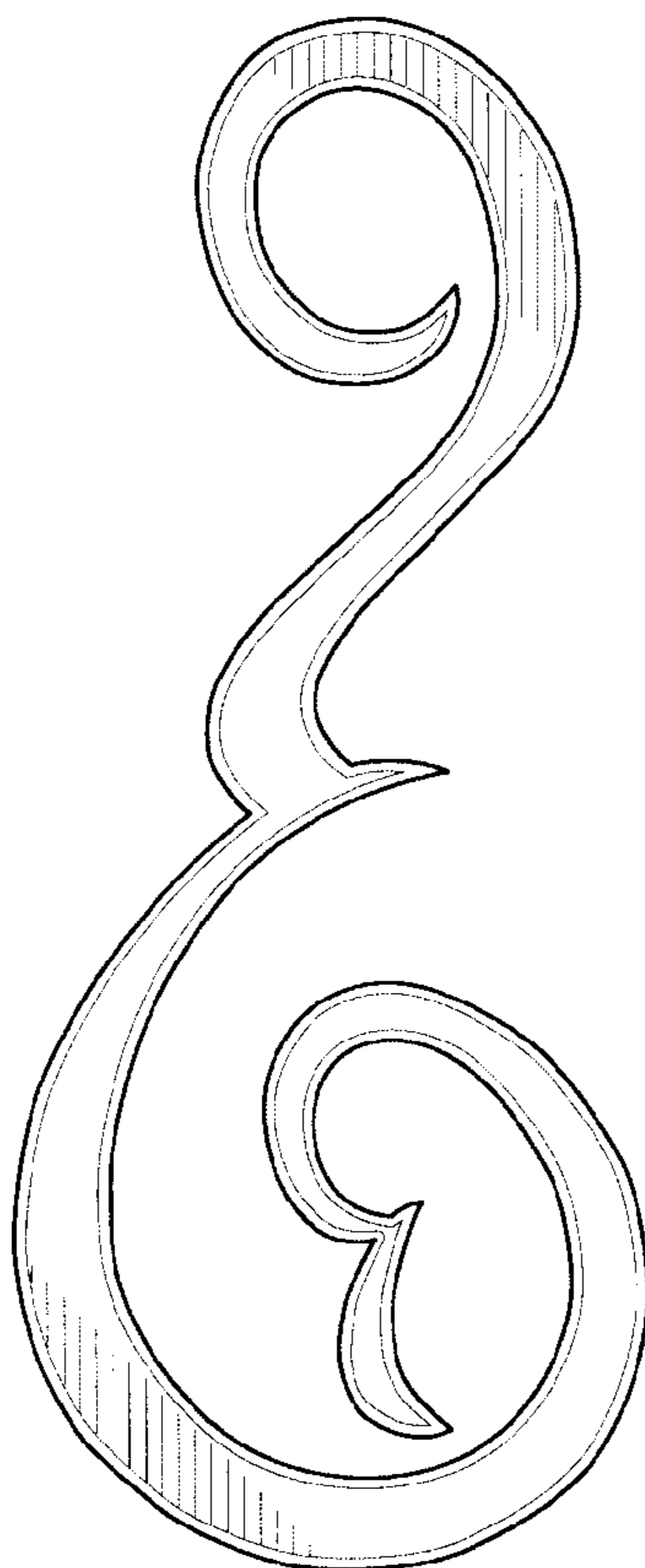
The disclosed embodiment can also be mirror imaged and

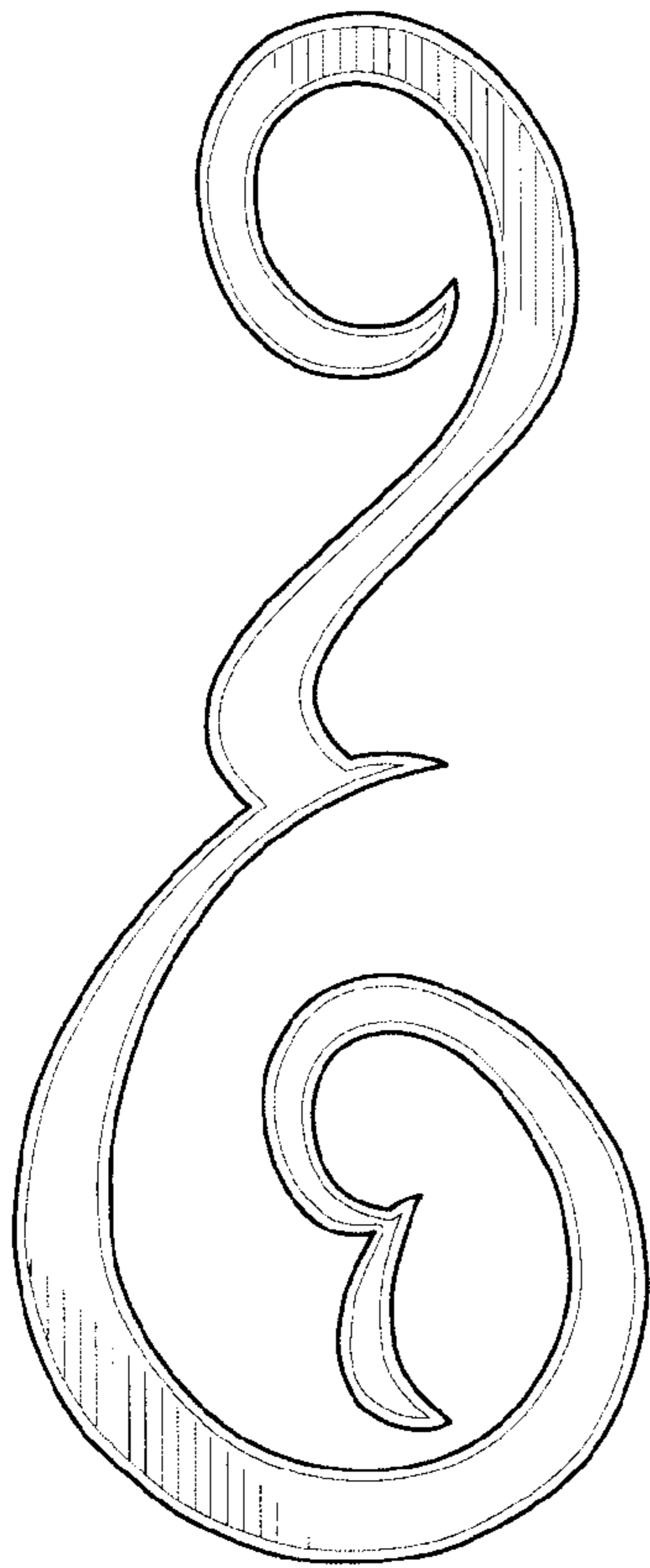

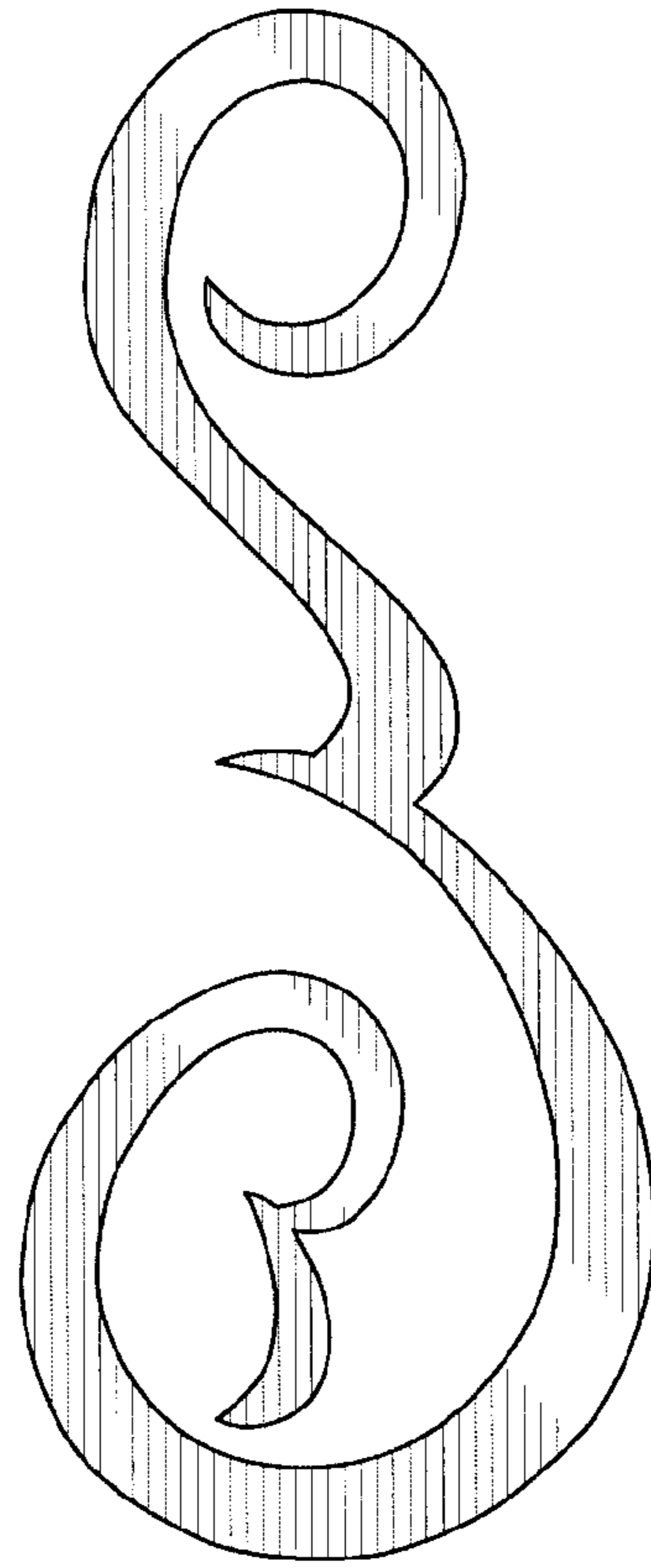

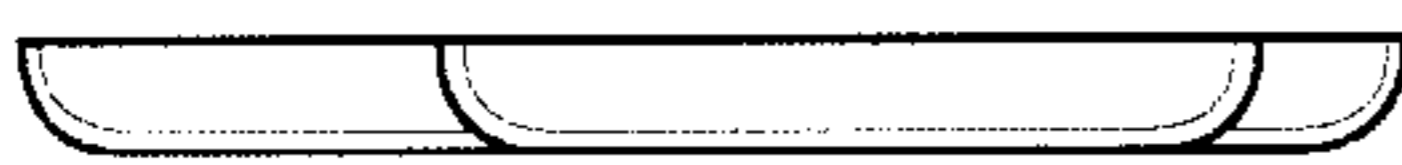

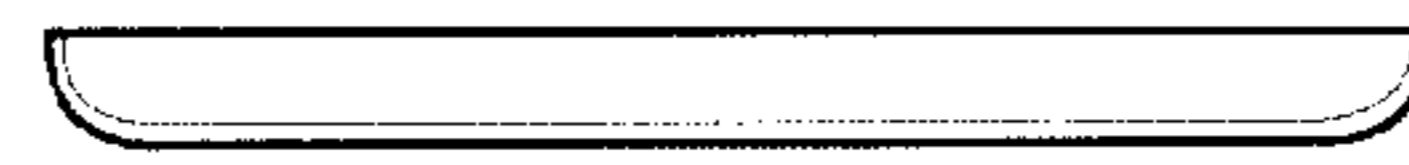
