**DESCRIPTION**

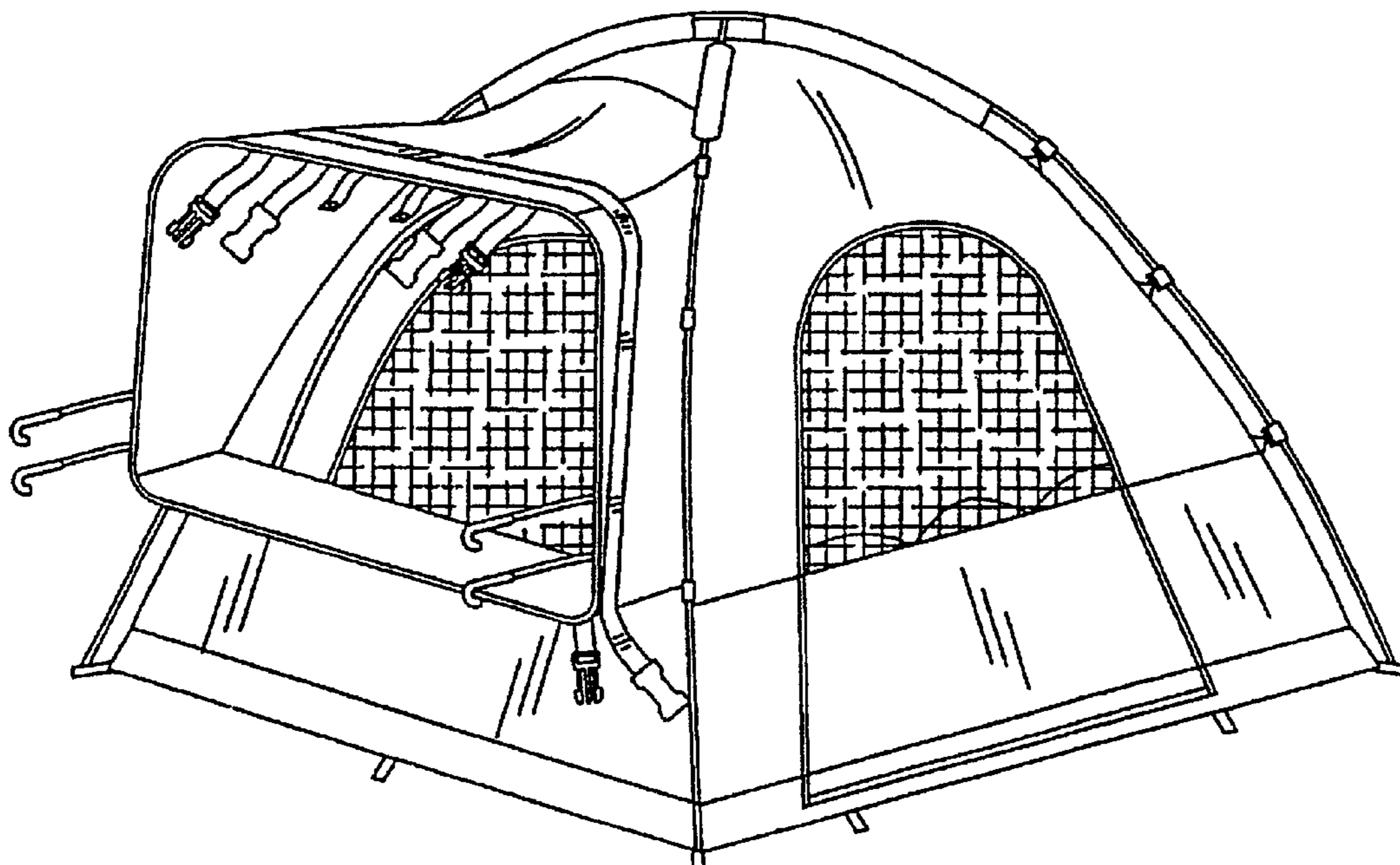
FIG. 1 is a perspective view of an SUV tent showing the new design;

FIG. 7 is a perspective view of the SUV tent shown in its position of use with the environment shown in broken lines for illustrative purposes only forming no part of the claimed design.

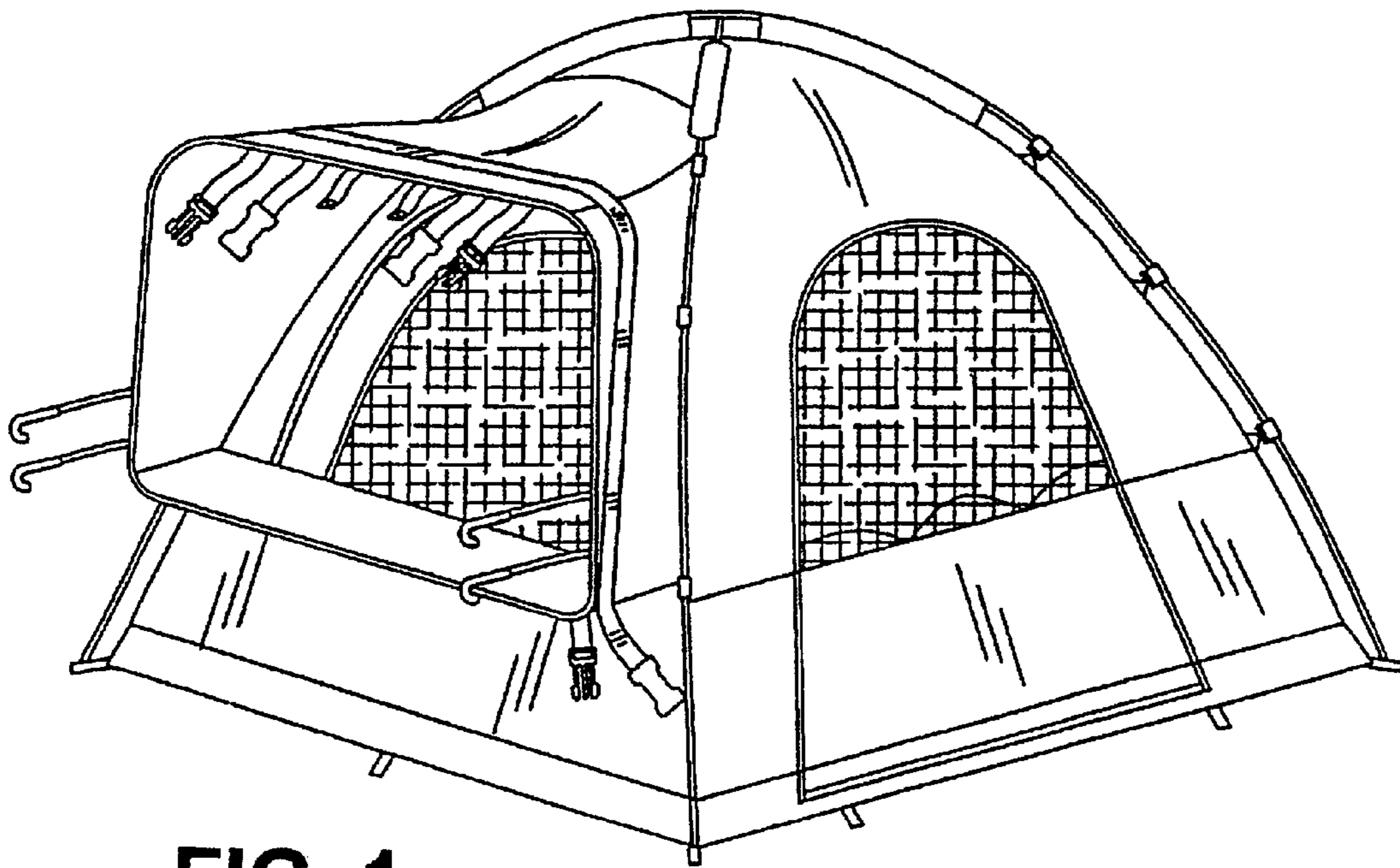

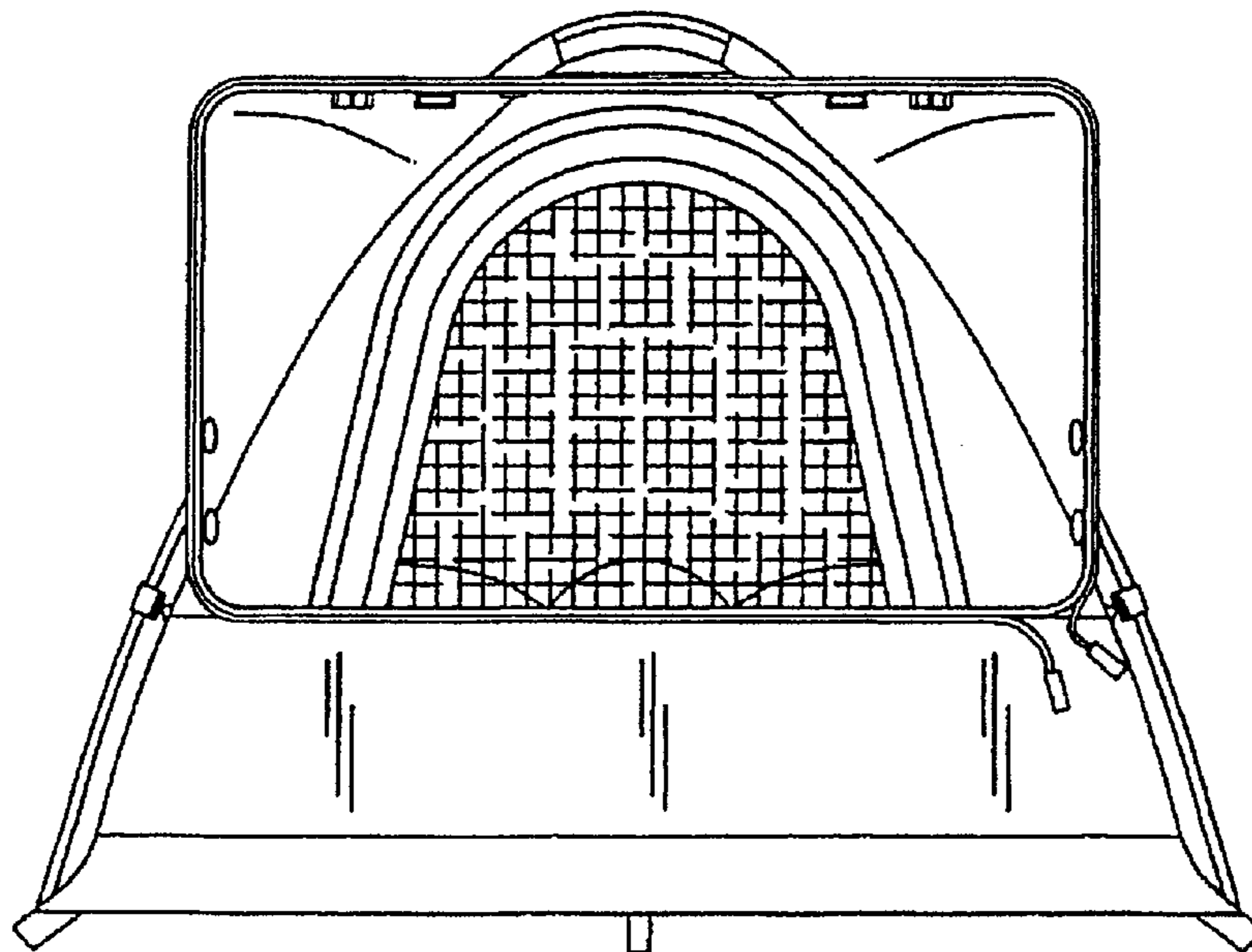

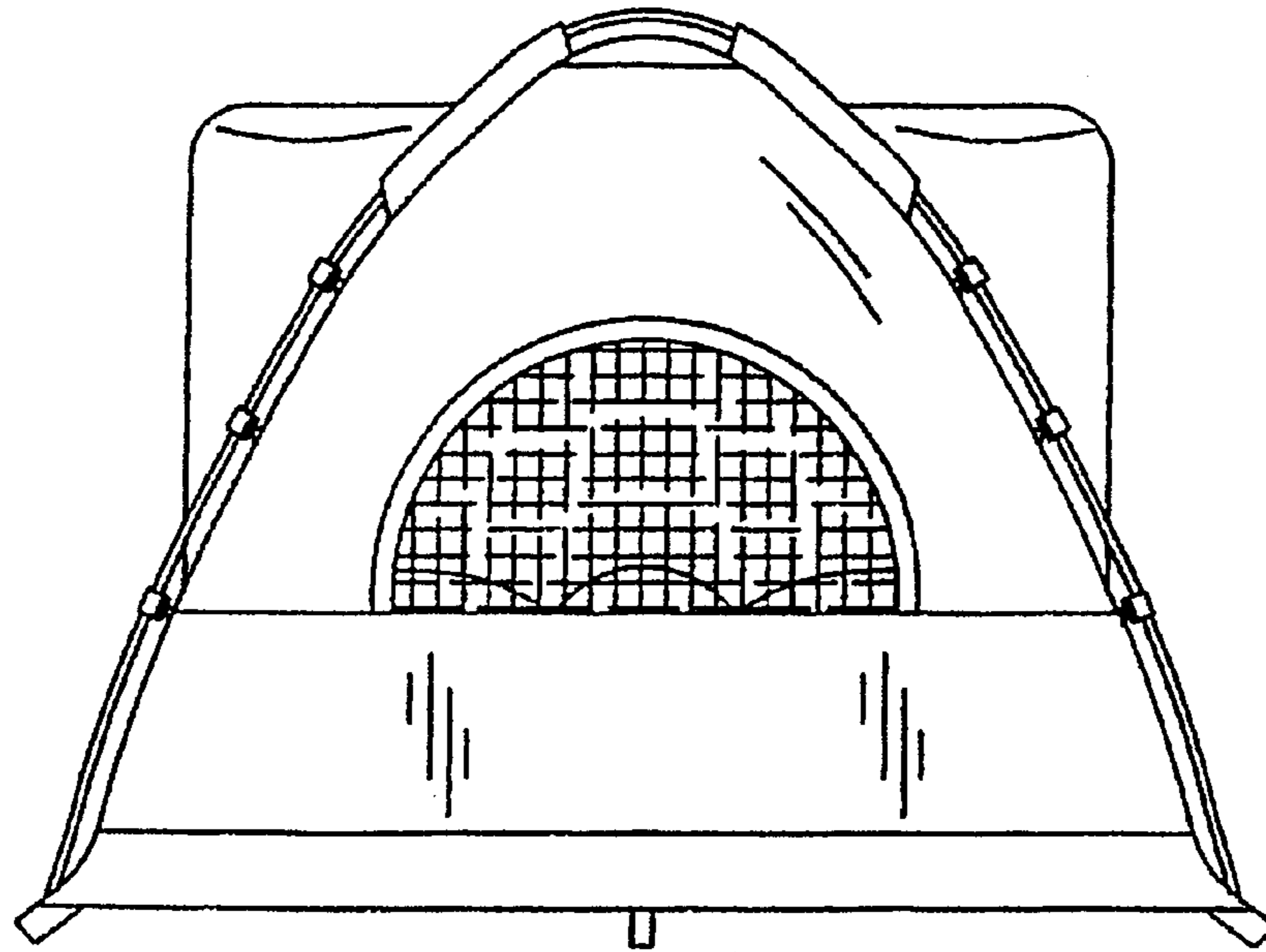




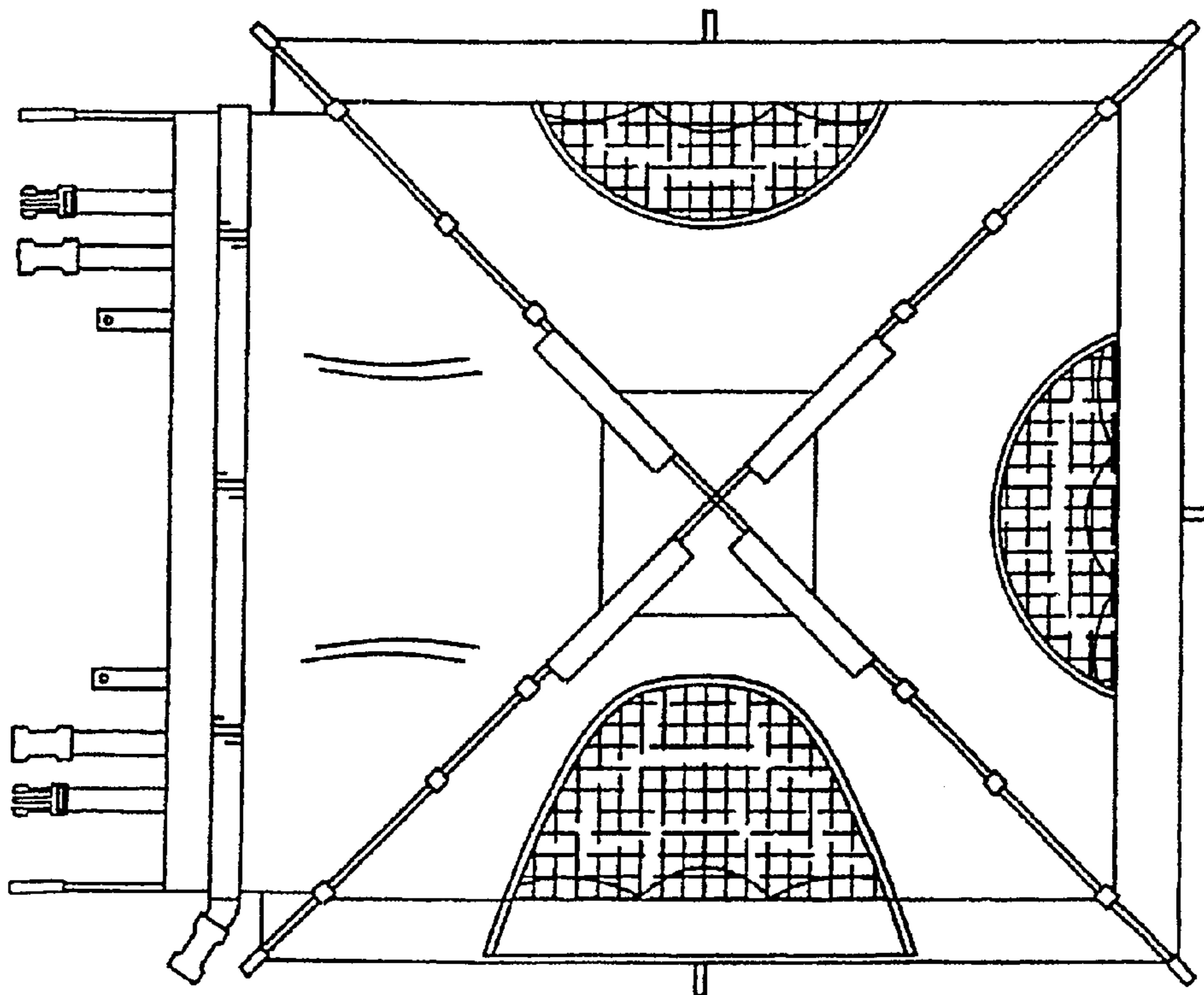

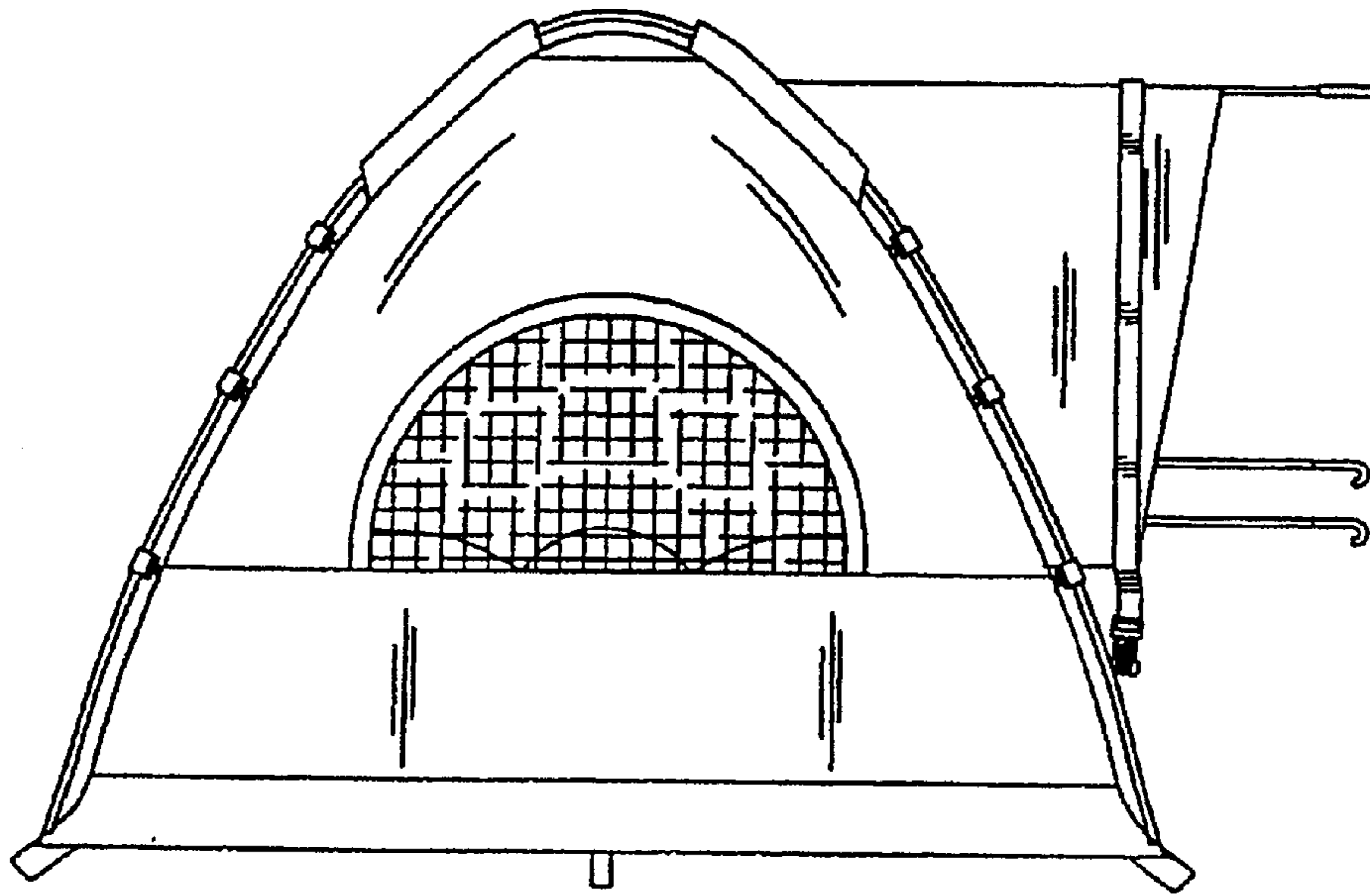

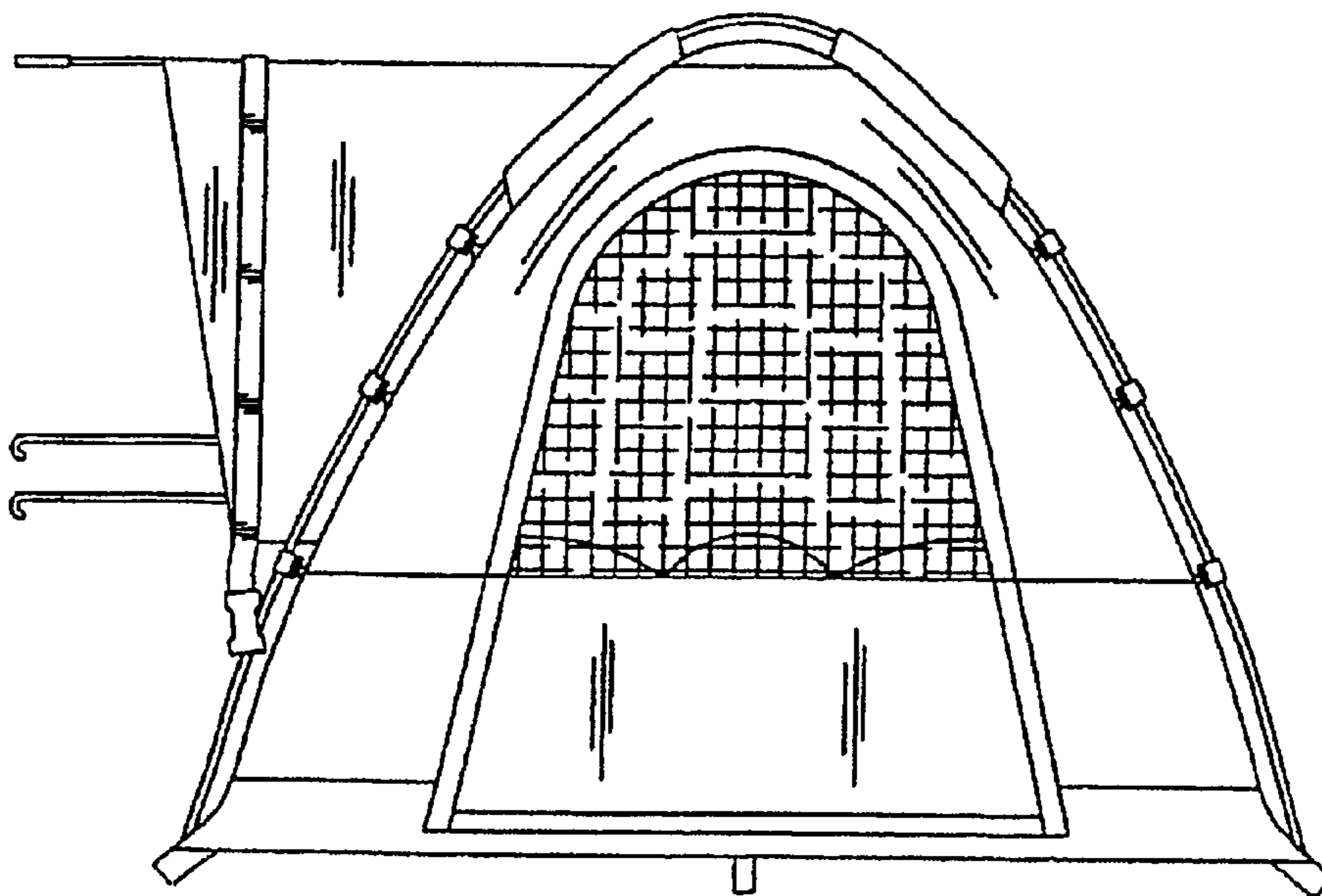

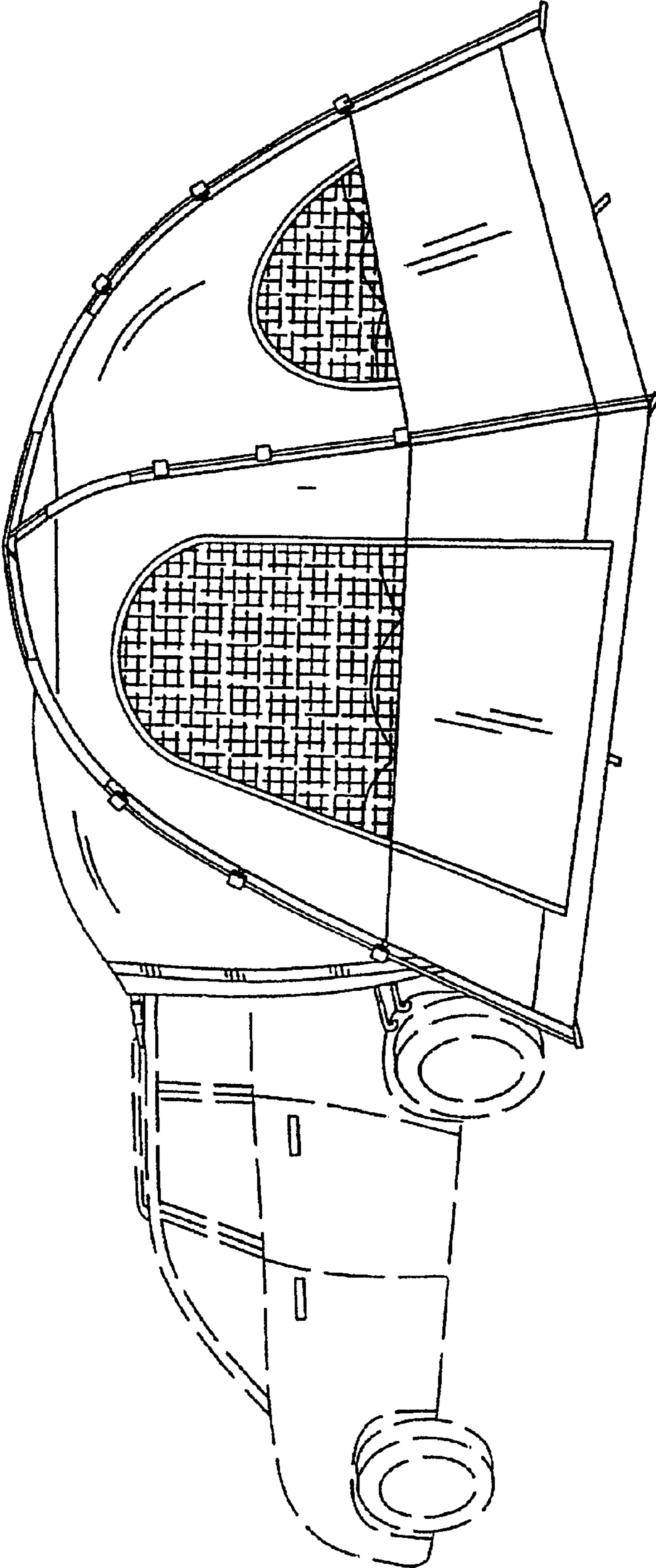
