(57) **CLAIM**

The ornamental design for an audio connector cable with twisted mold and plated tip, as shown and described.

FIG. 3 is a left side elevation thereof;

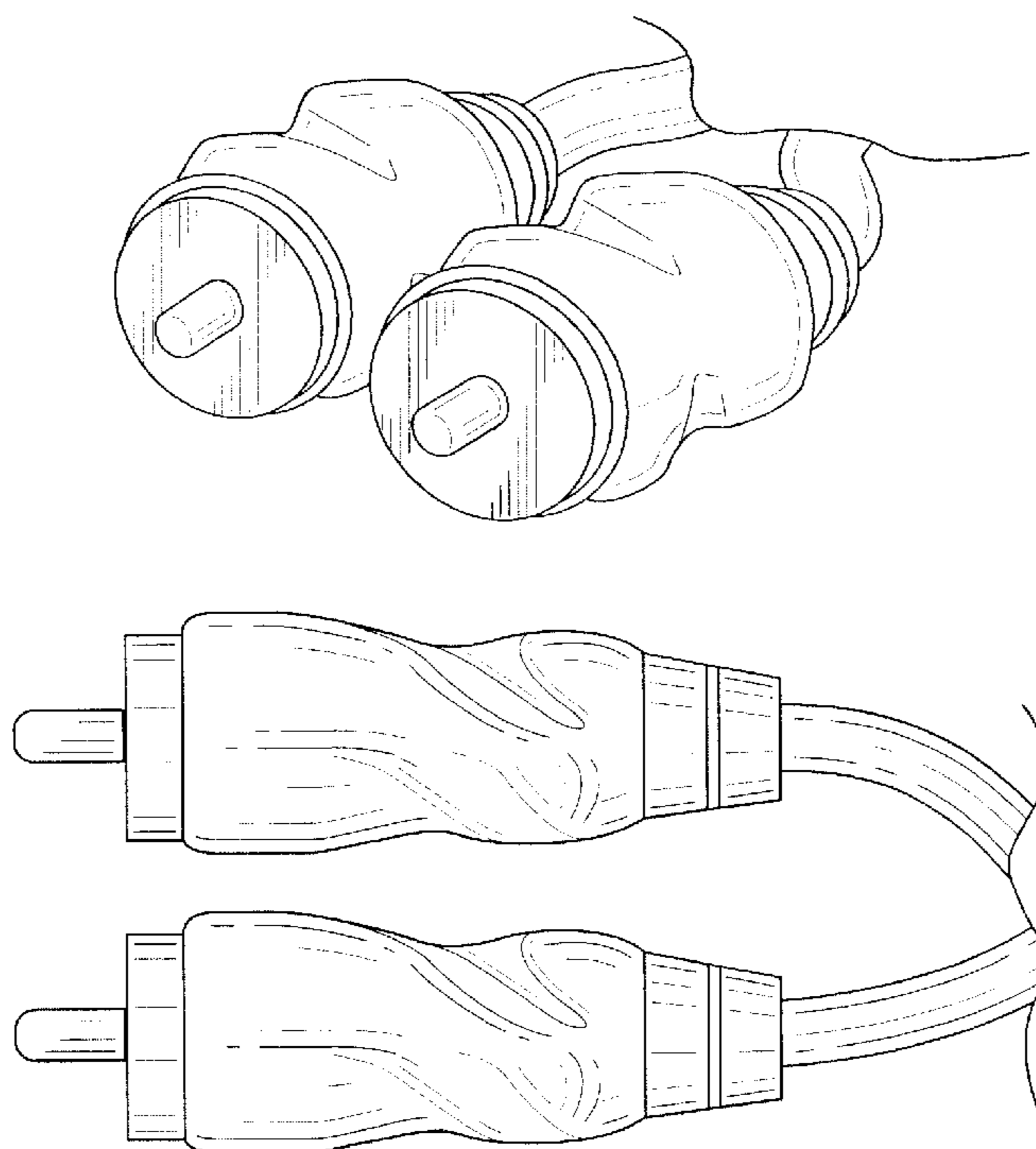
FIG. 4 is a right side elevation thereof;

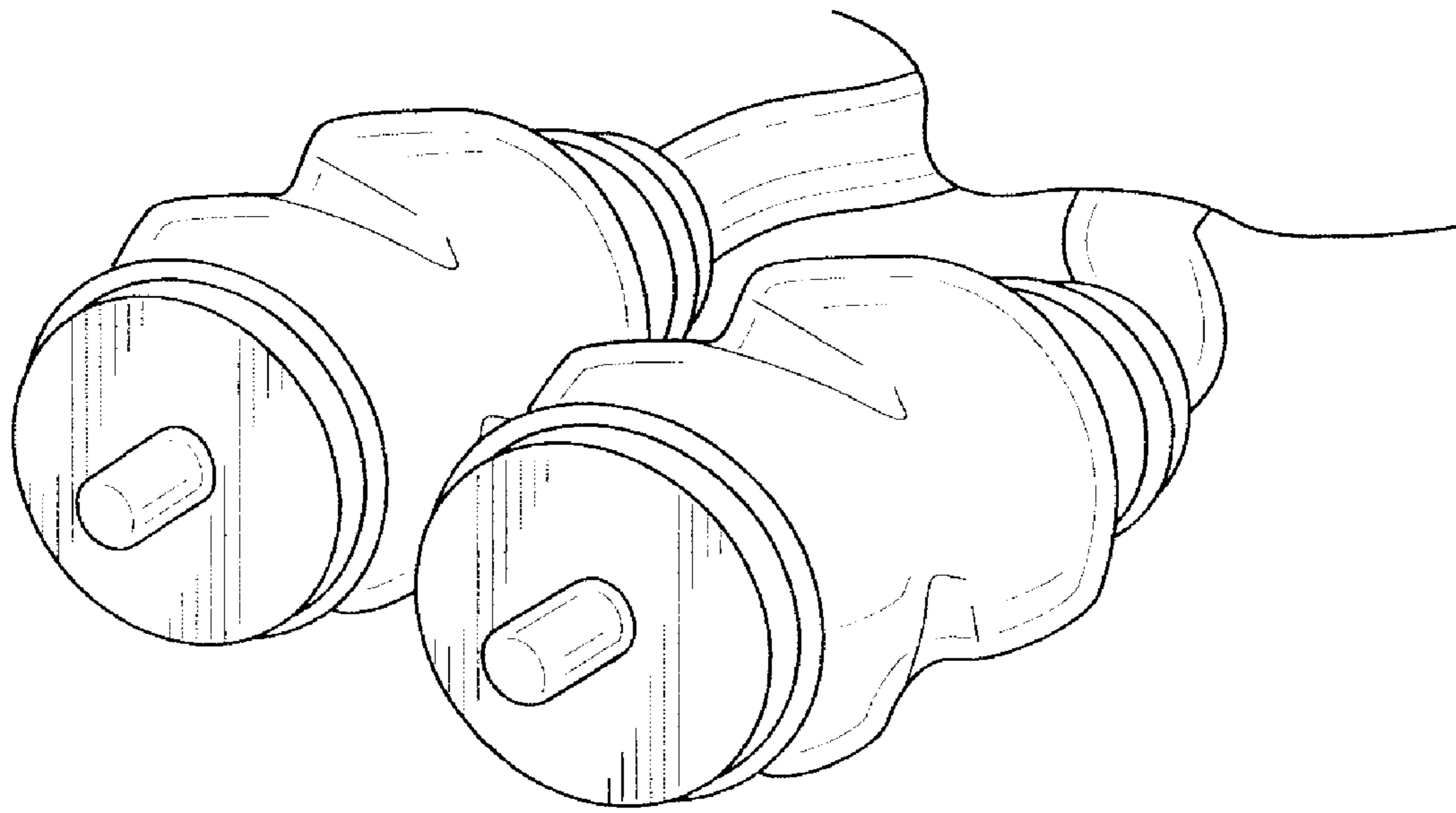
FIG. 5 is a front elevation thereof;

FIG. 6 is a rear elevation thereof; and,

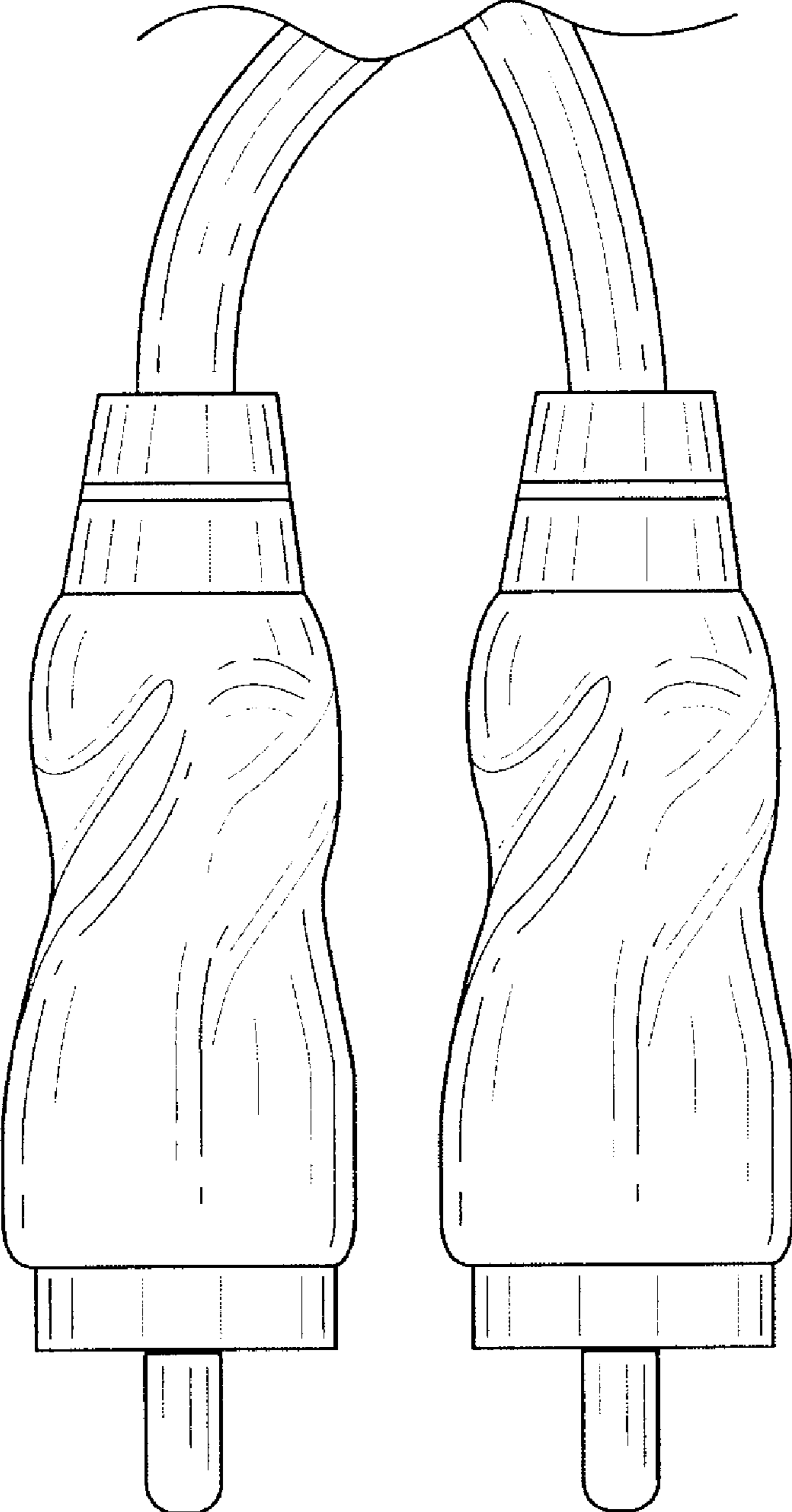
FIG. 7 is a bottom plan view thereof.

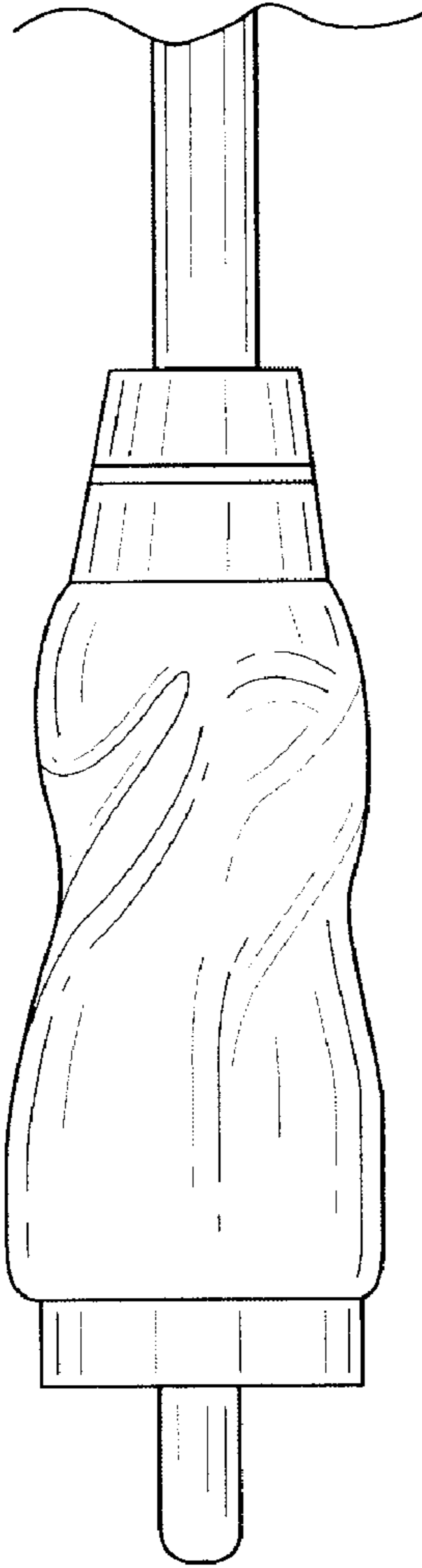




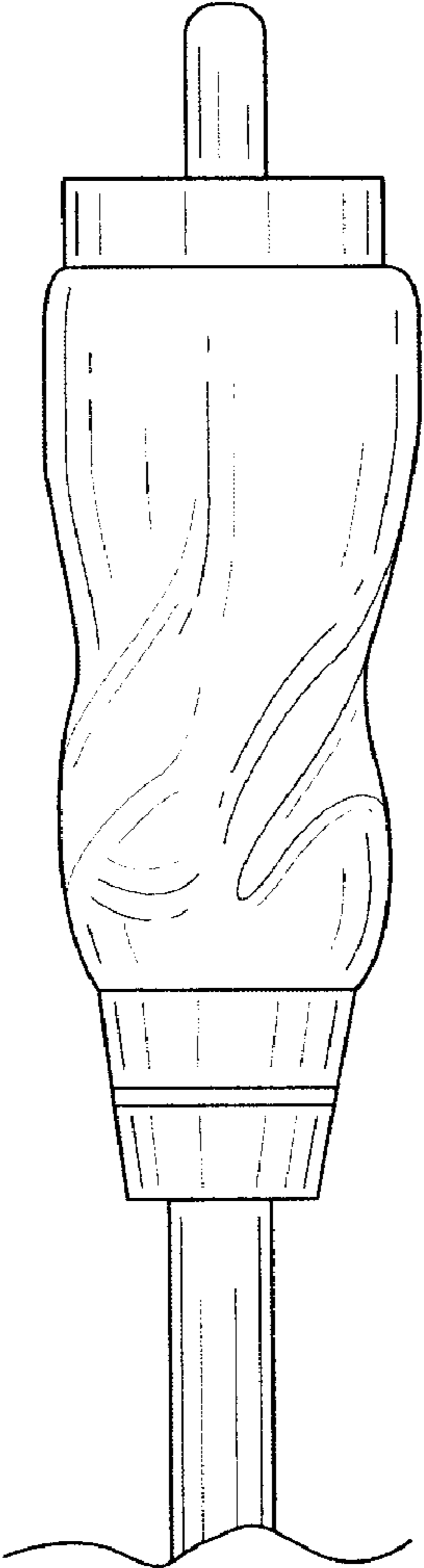

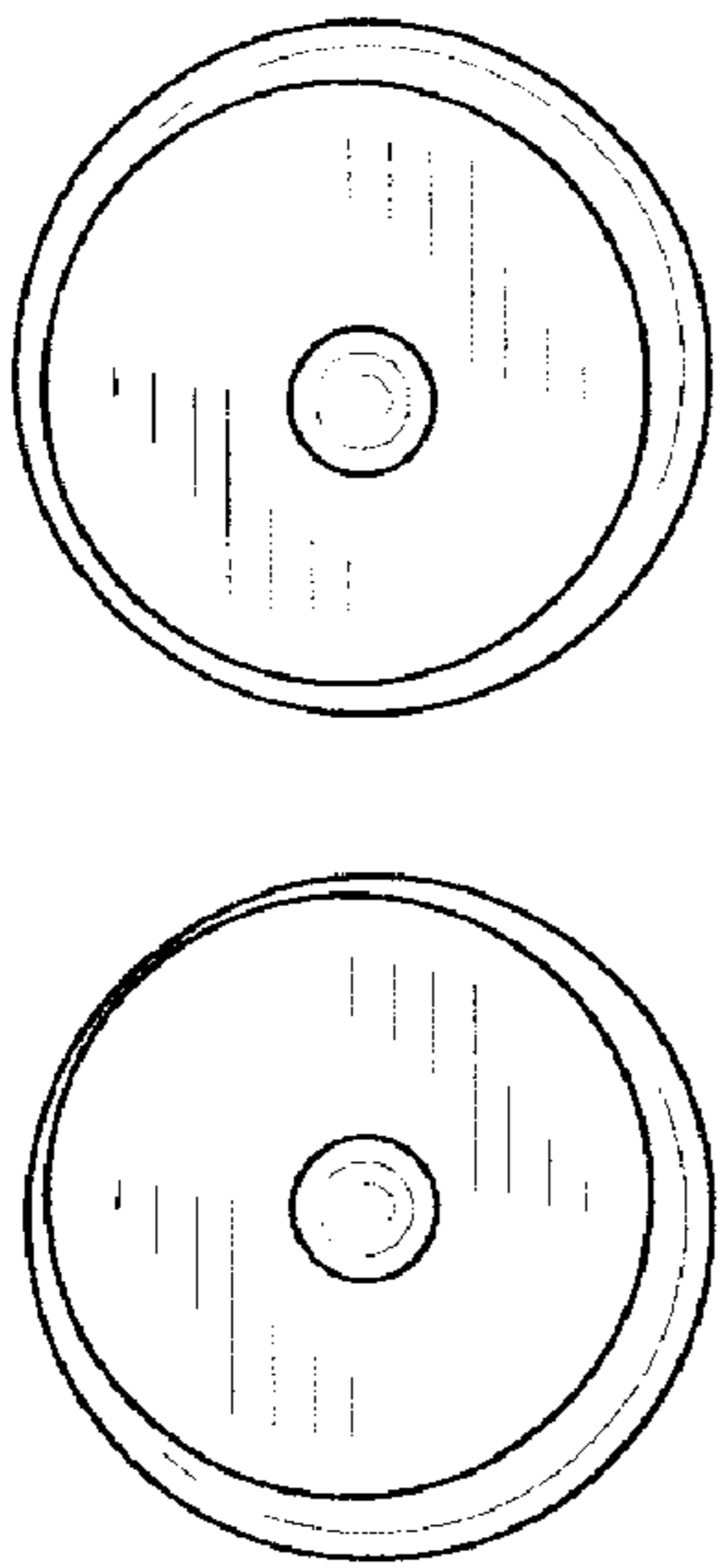

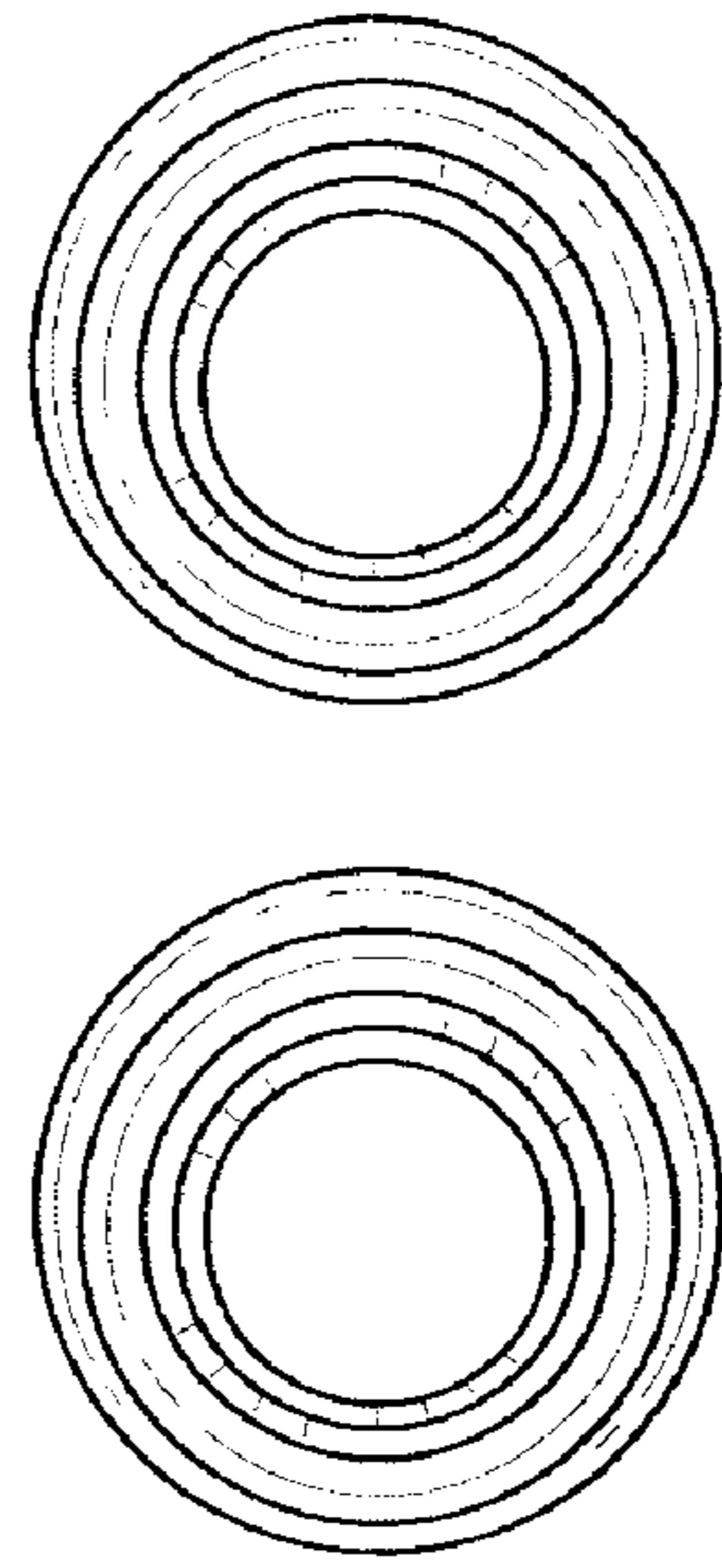

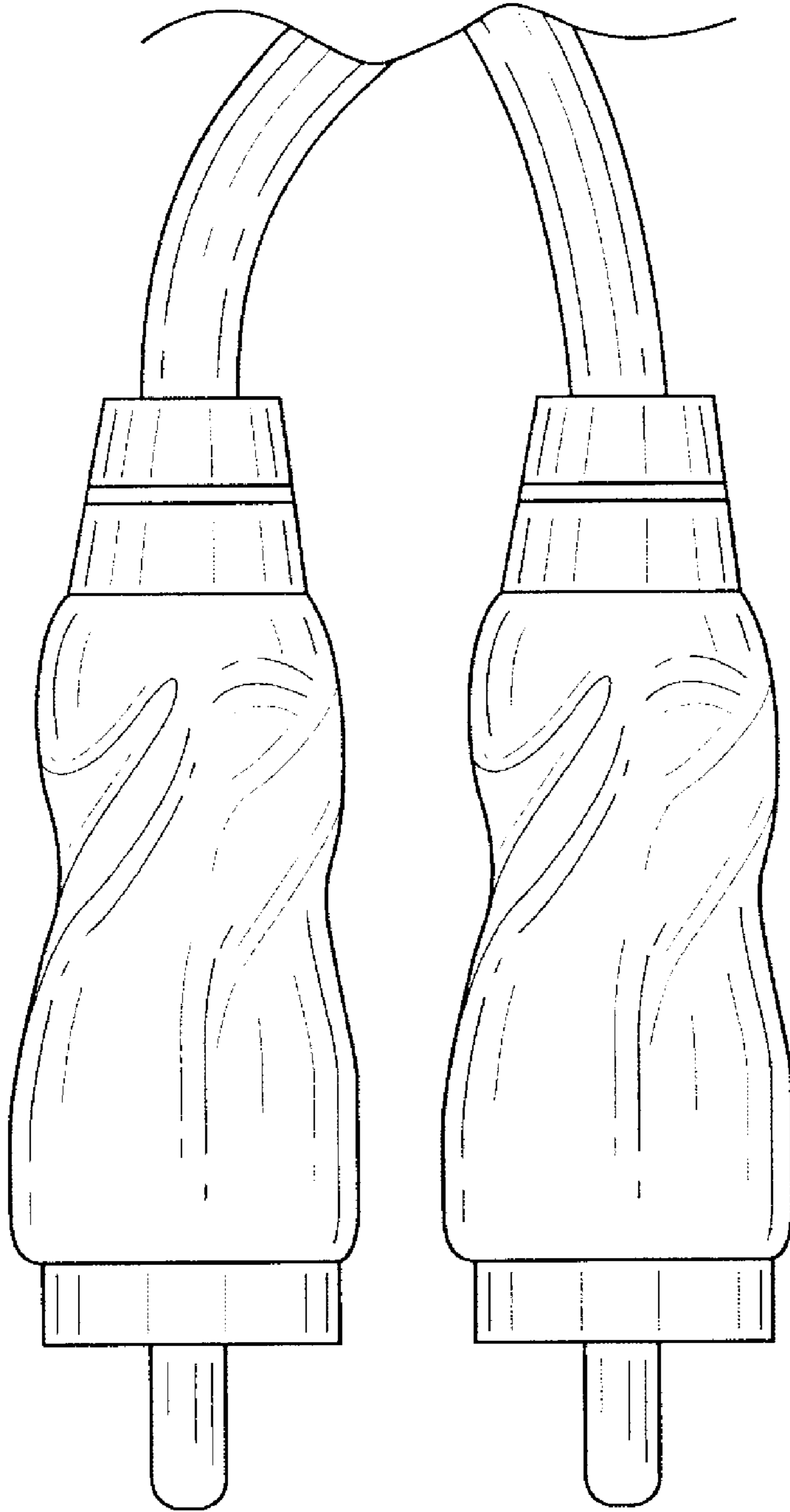
