The ornamental design for a guitar body, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of a first embodiment of the guitar body;

FIG. 2 is a lower side view of the guitar body;

FIG. 3 is an upper side view of the guitar body;

FIG. 4 is a left side view of the guitar body;

FIG. 5 is a right side view of the guitar body;

FIG. 6 is a top view of the first embodiment of the guitar body;

FIG. 7 is a bottom view of the guitar body;

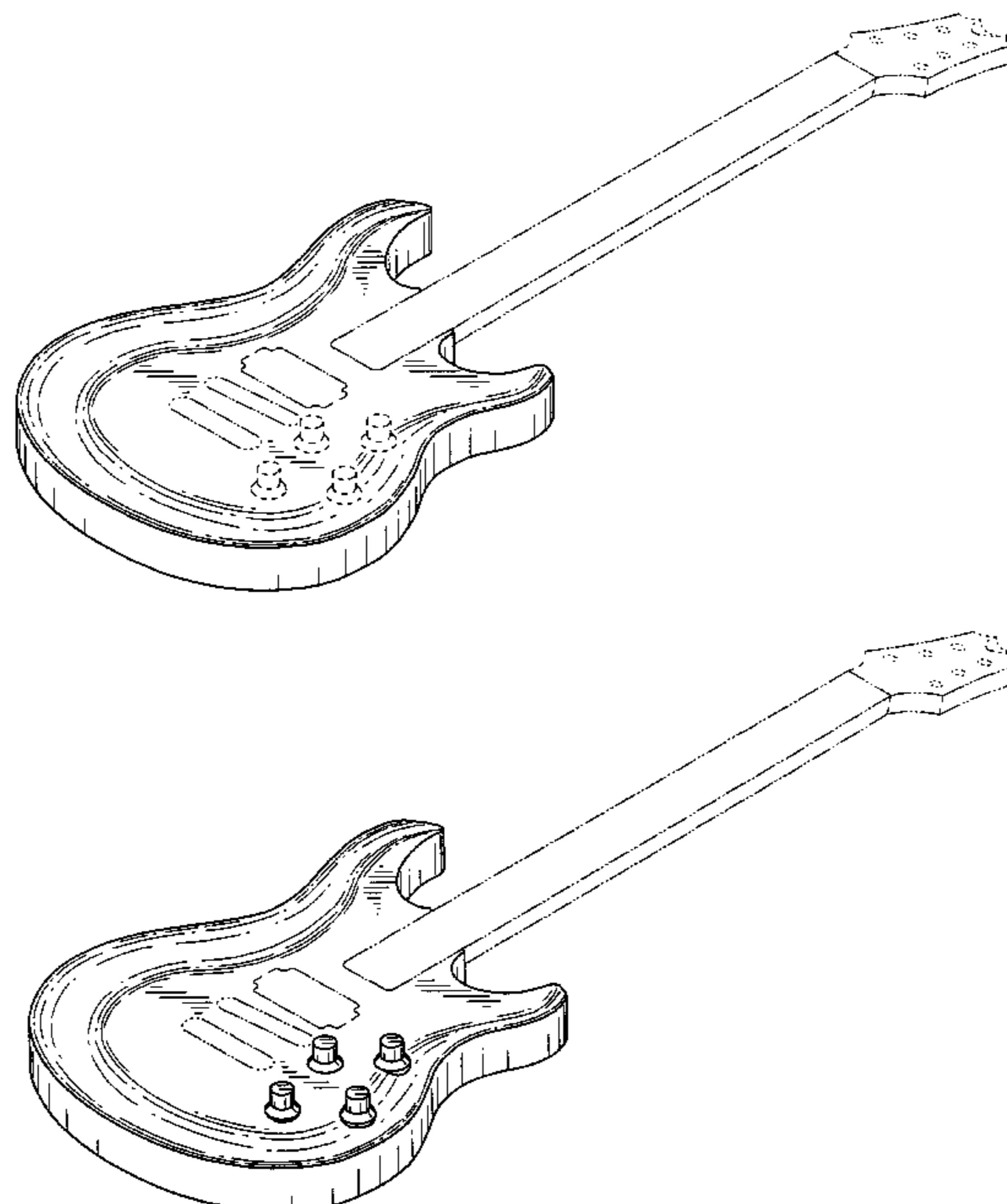
FIG. 8 is a cross-sectional view of the guitar body taken through line 8—8 in FIG. 6;

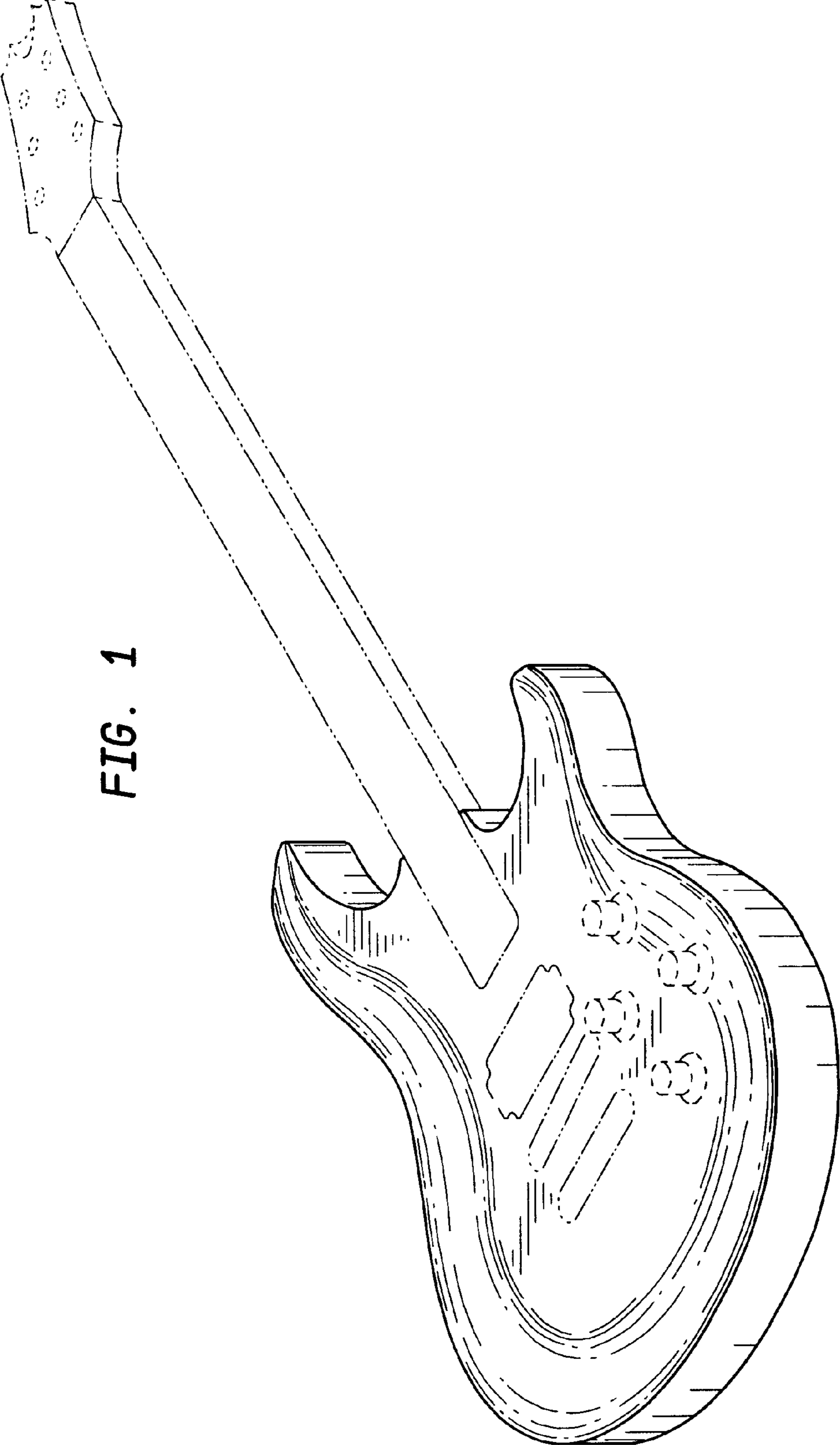
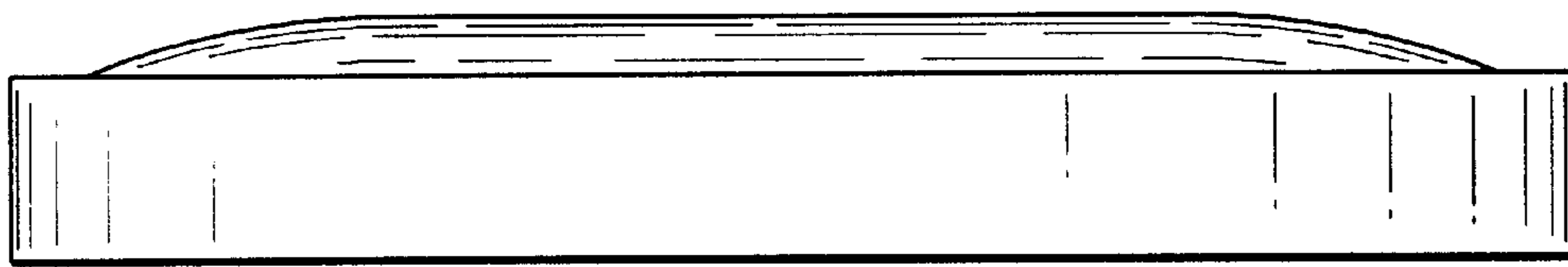

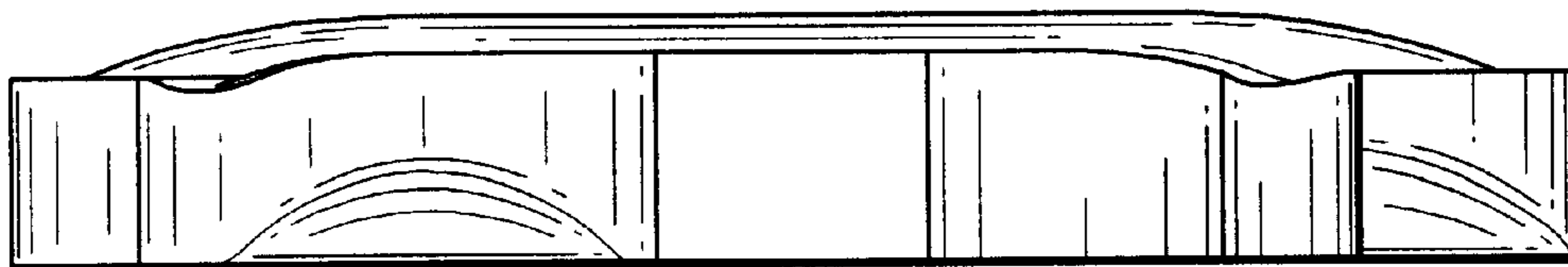

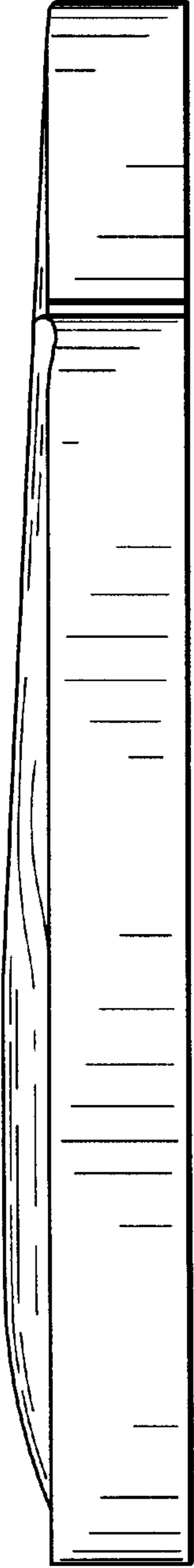
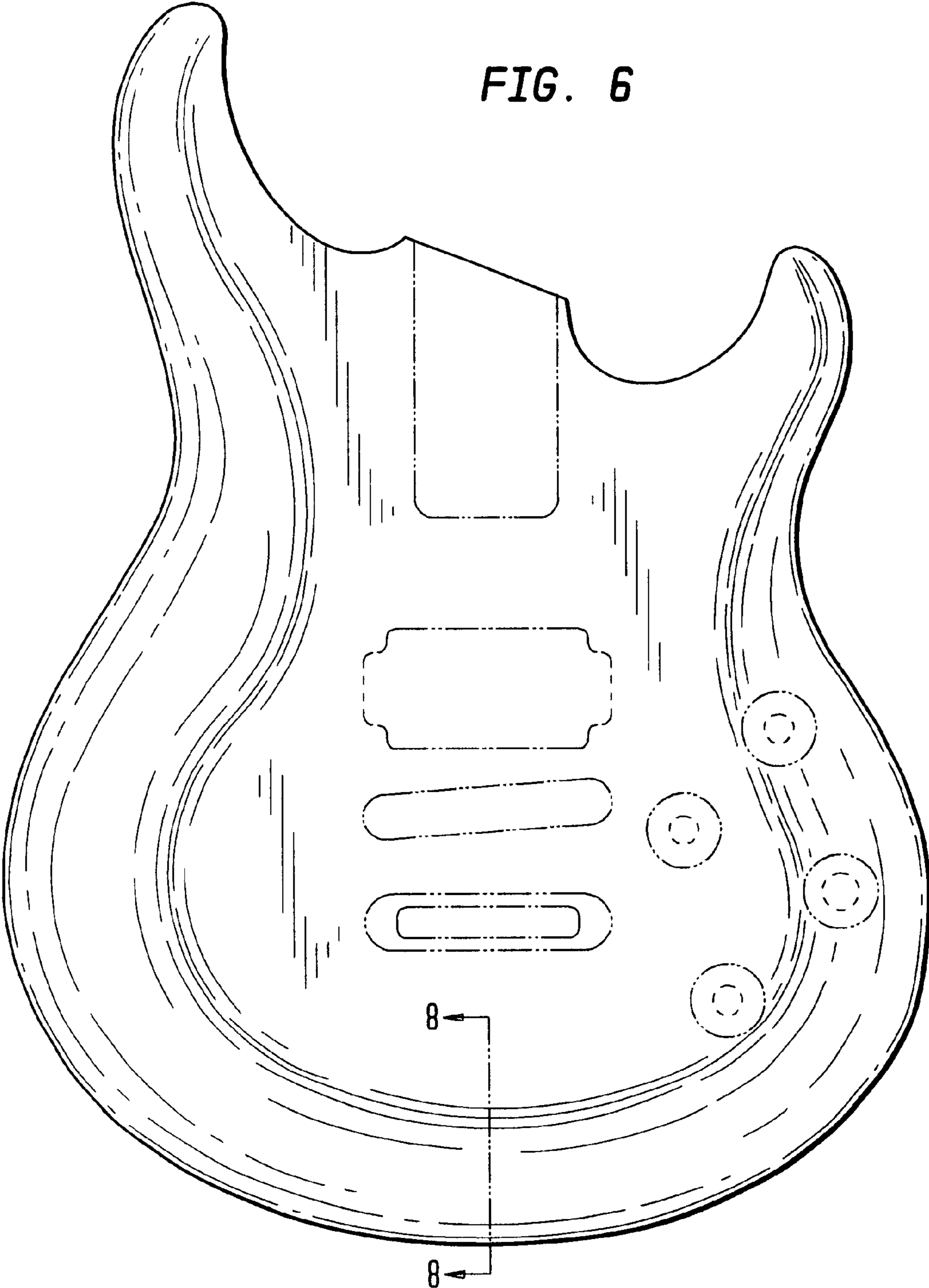
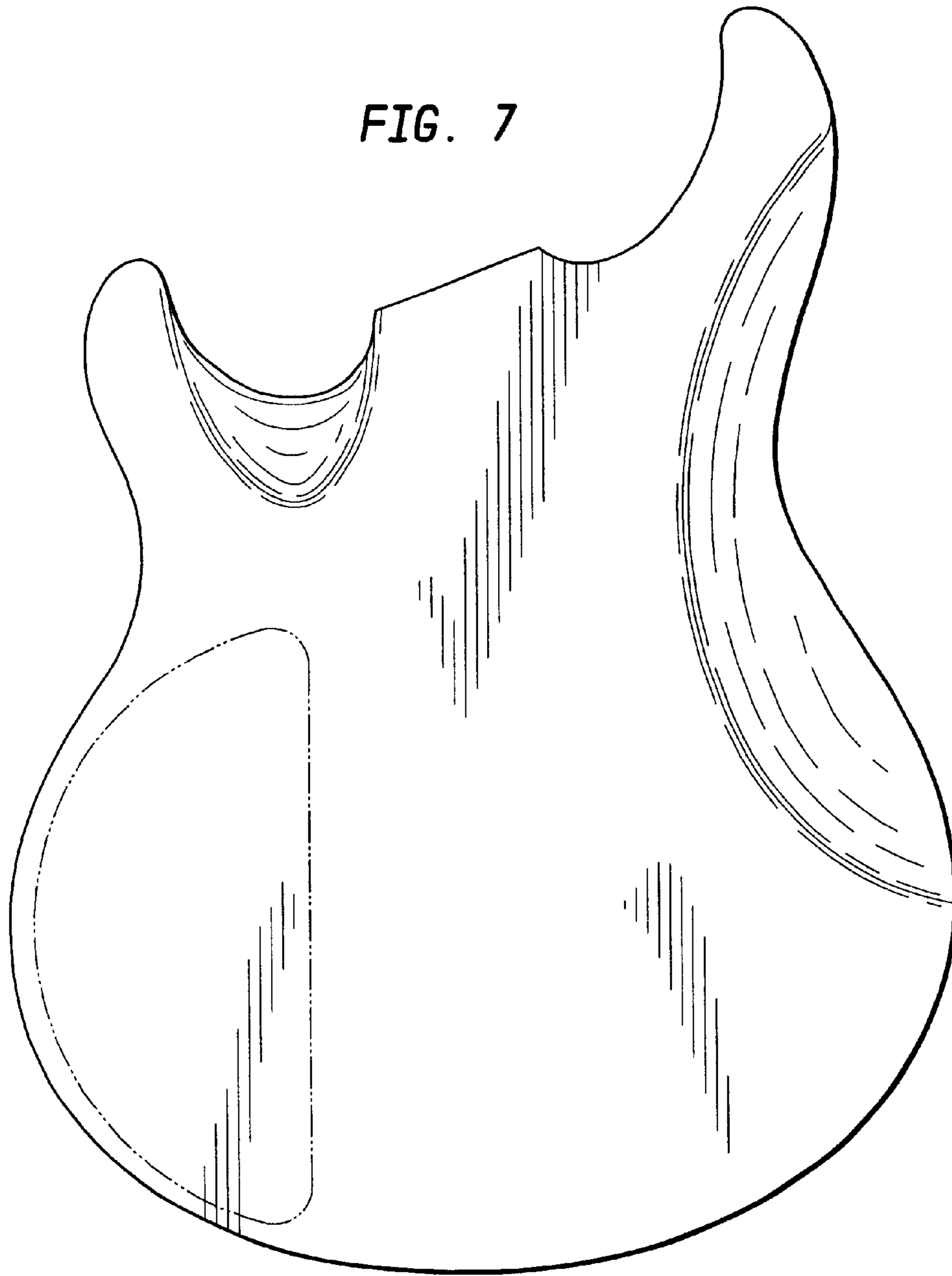

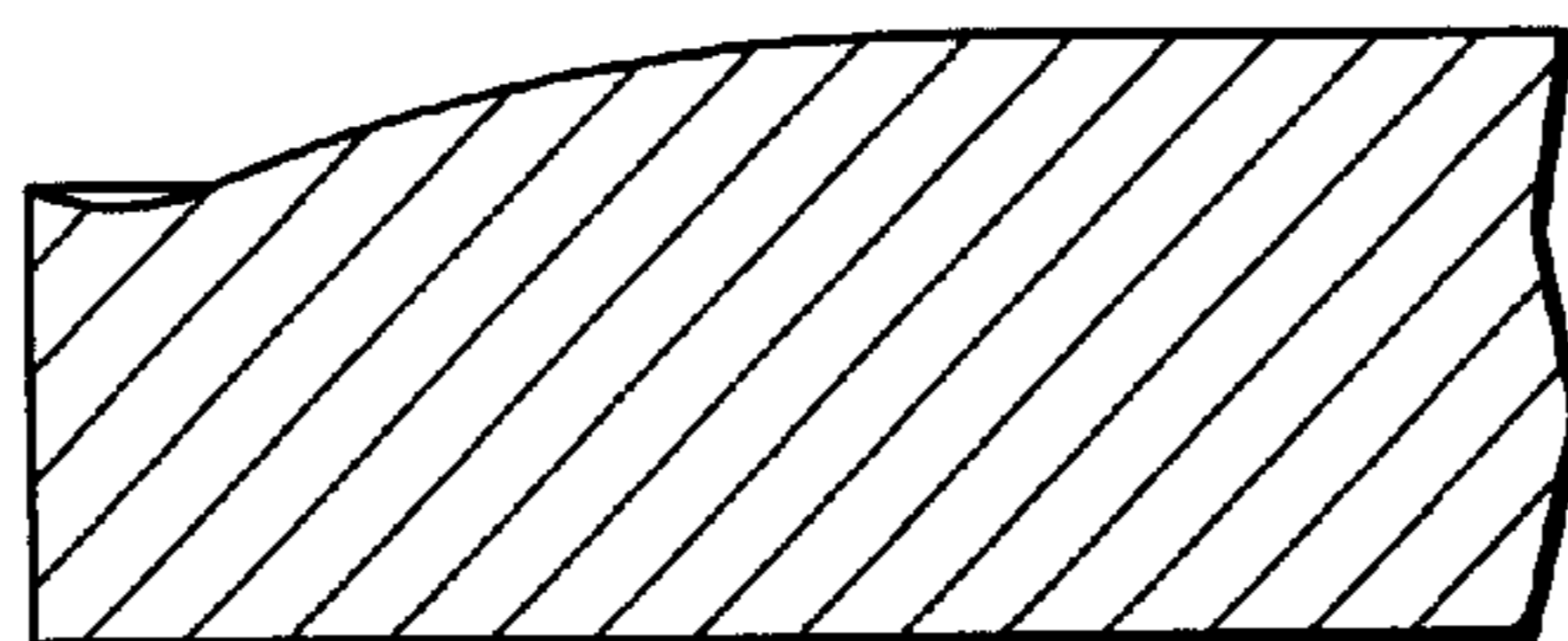
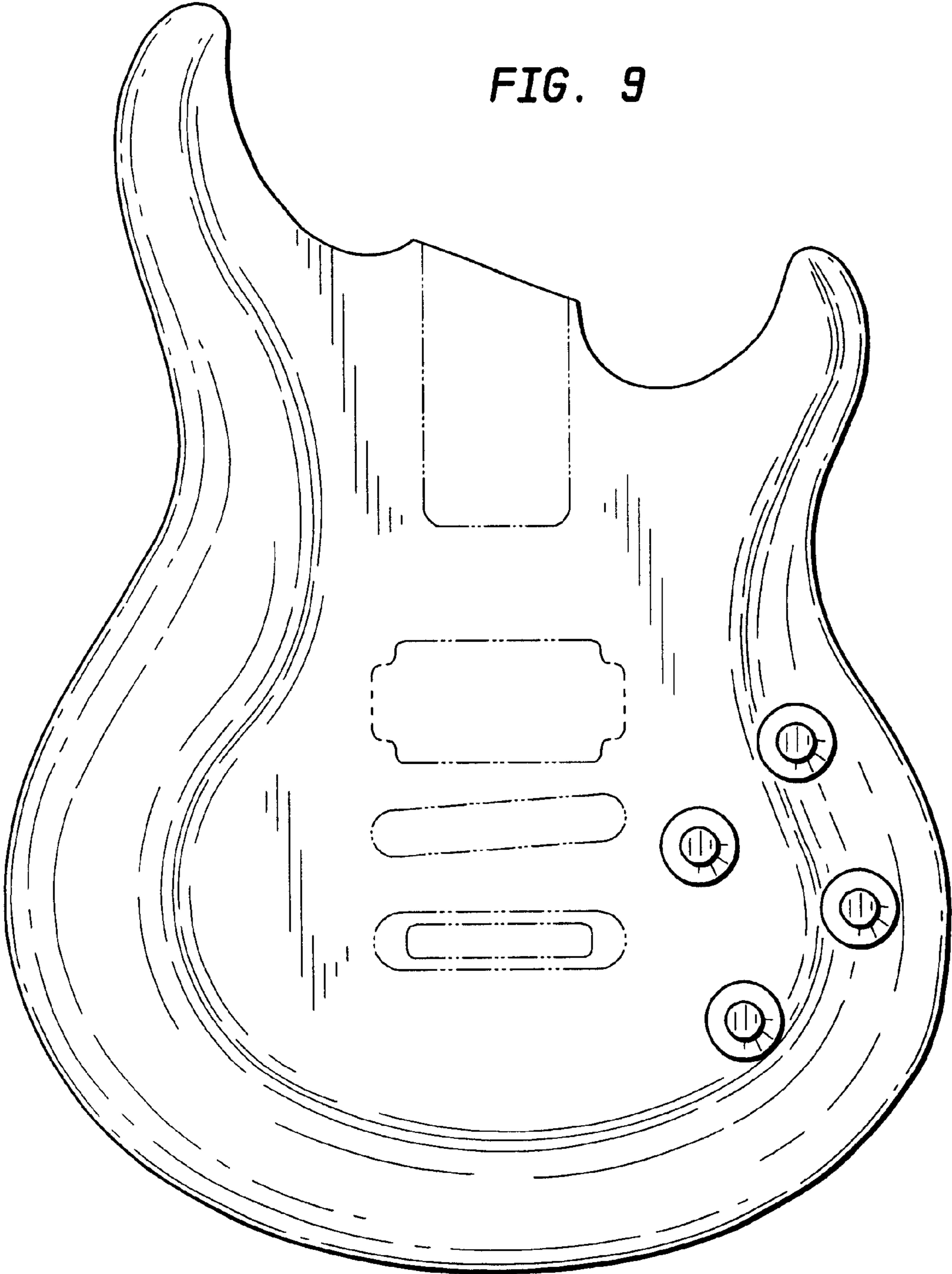

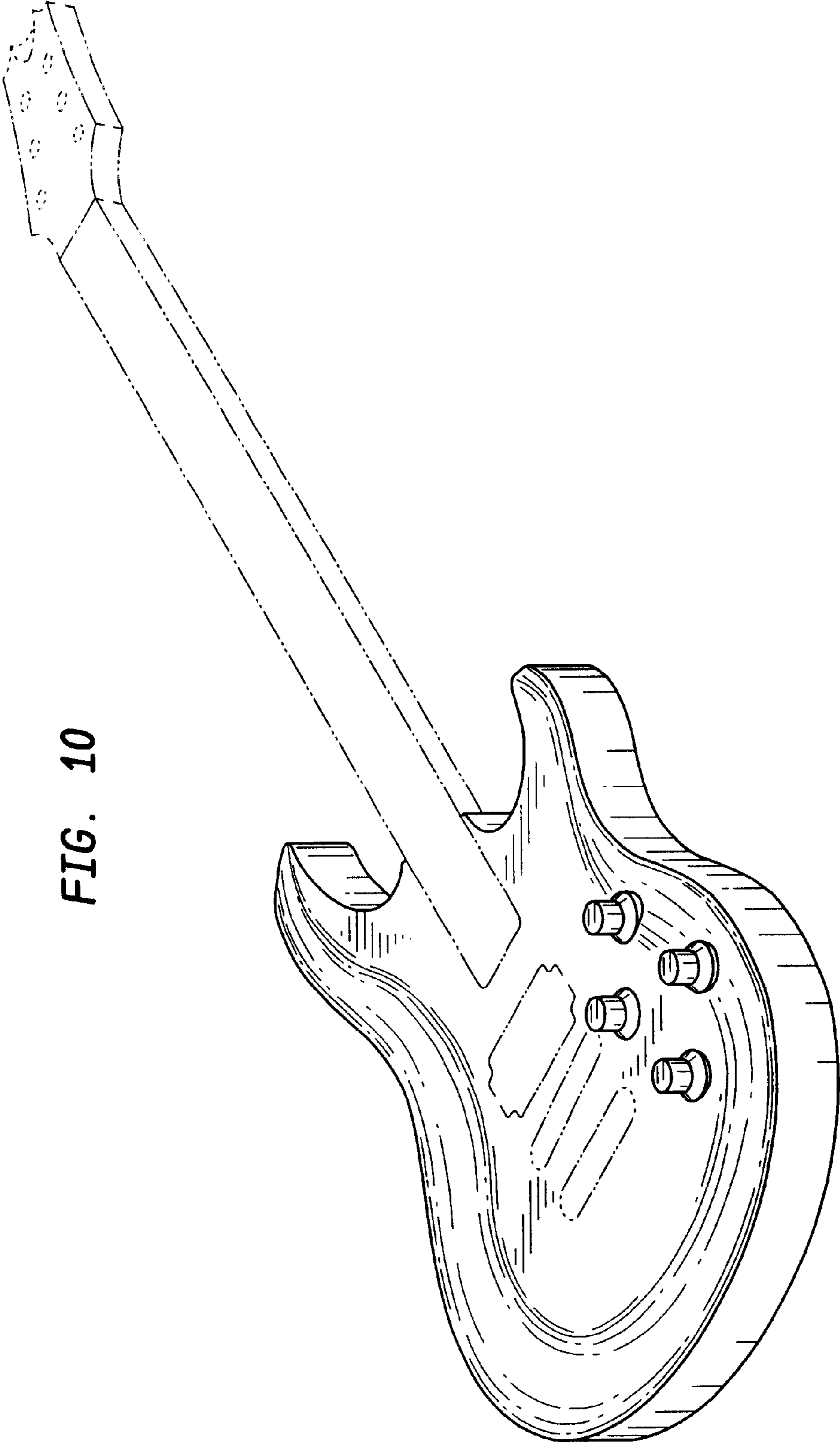
