The ornamental design for a printer, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of the top, front and right side of a printer showing our new design;
FIG. 2 is a front elevational view thereof;
FIG. 3 is a rear elevational view thereof;
FIG. 4 is a left side elevational view thereof;
FIG. 5 is a right side elevational view thereof;
FIG. 6 is a top plan view thereof;
FIG. 7 is a bottom plan view thereof; and,
FIG. 8 is another perspective view showing the upper and lower paper trays in the extended position.

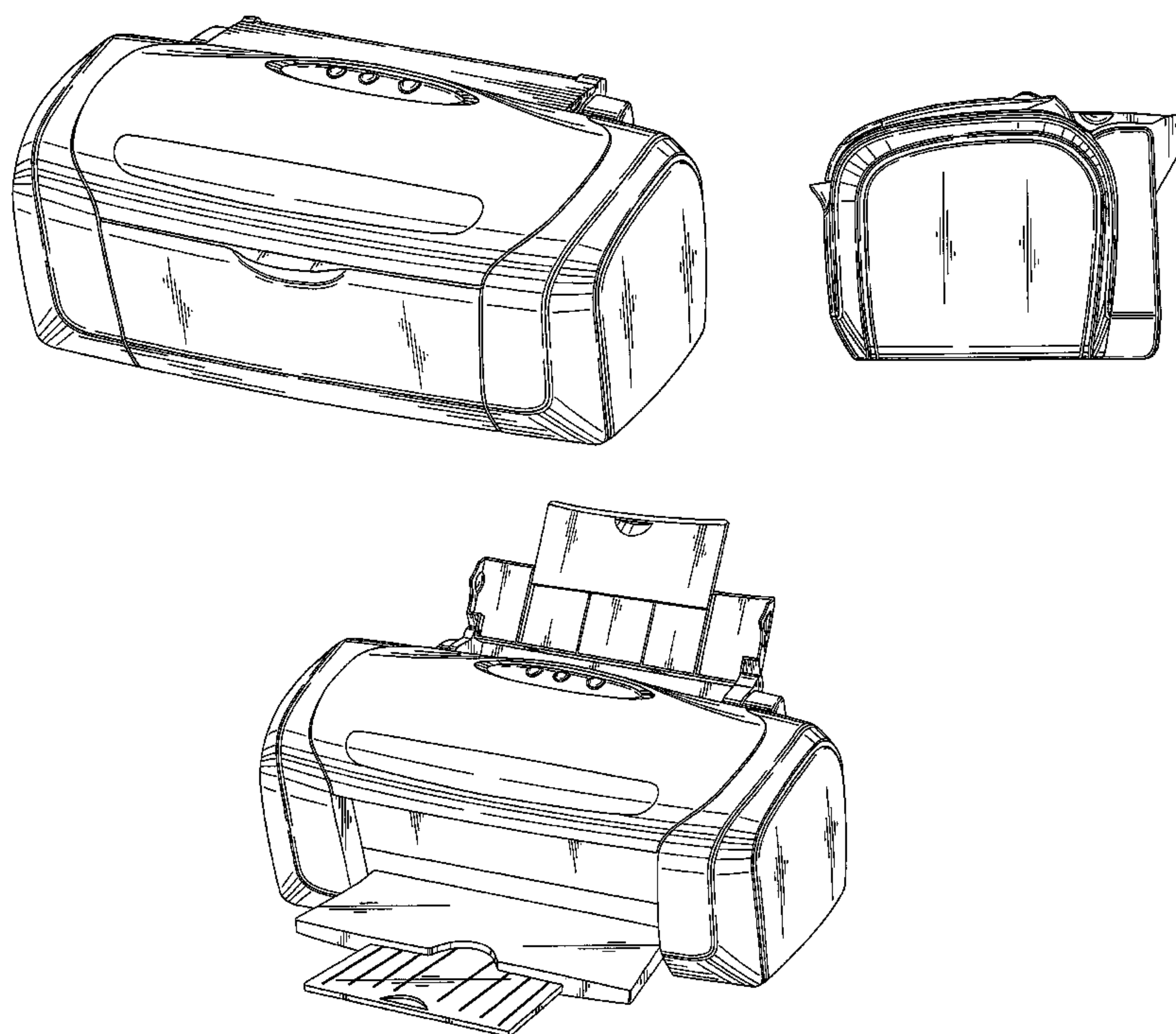

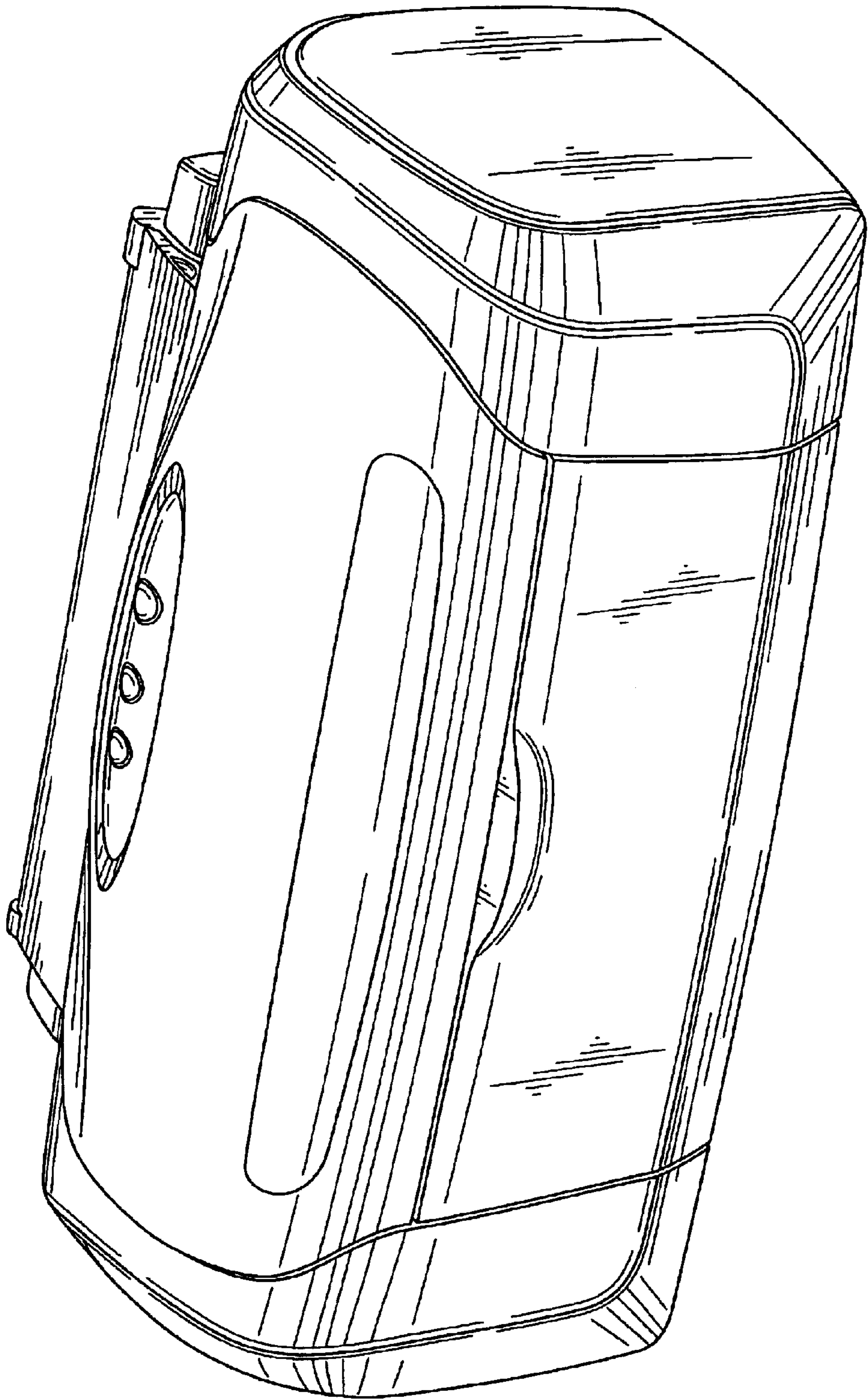

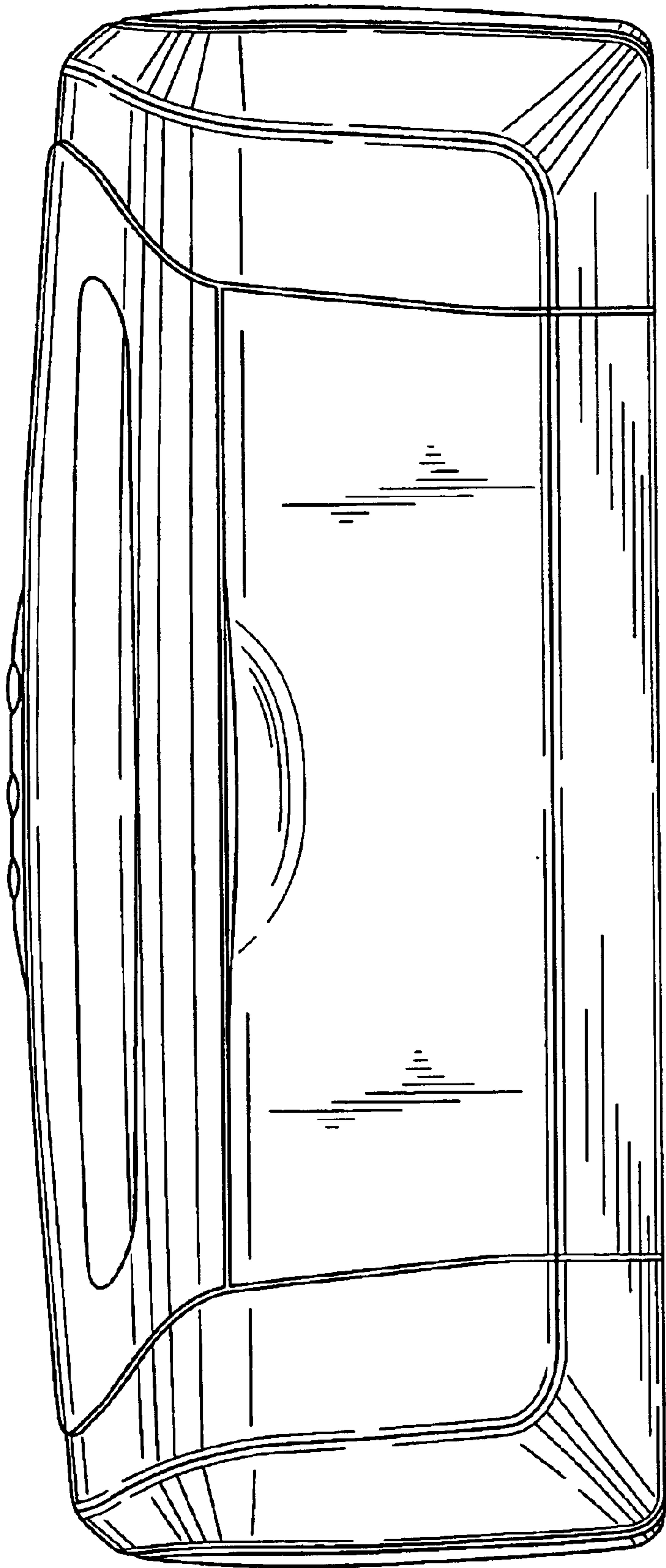

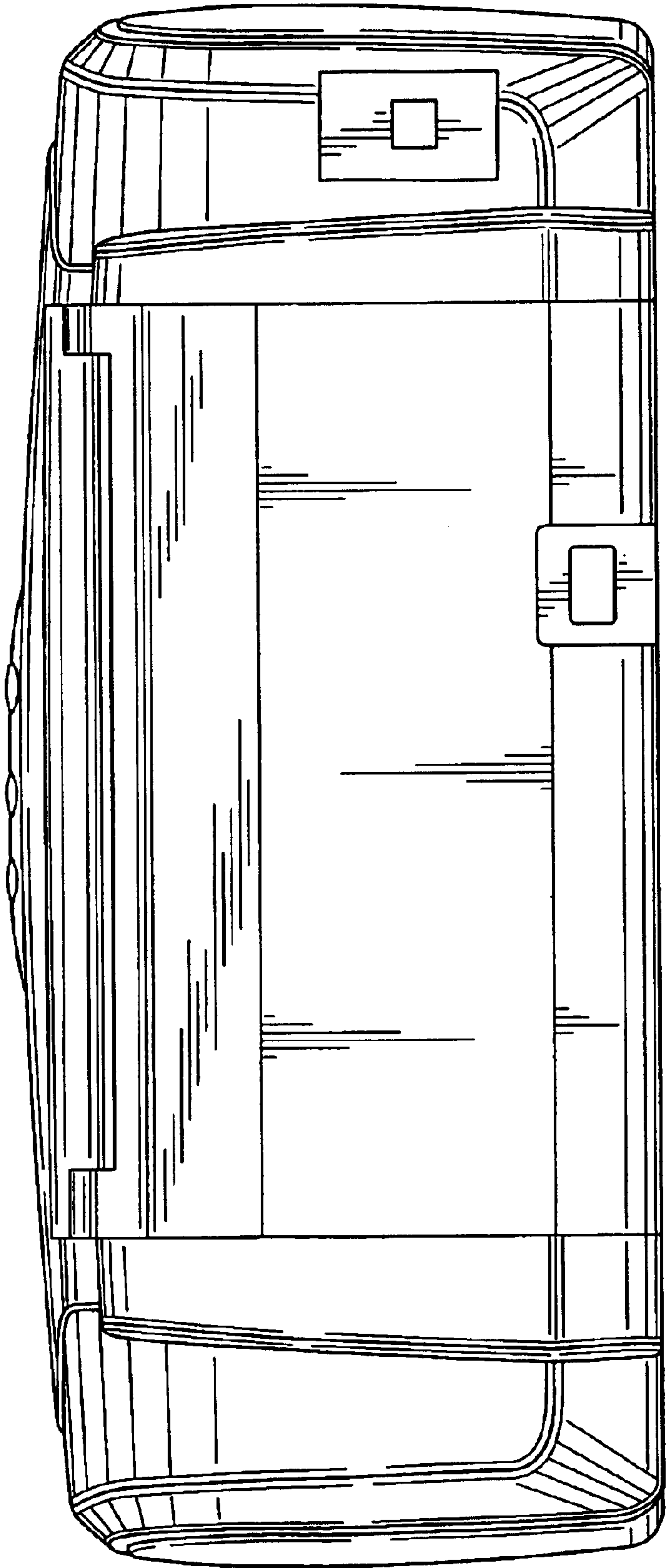

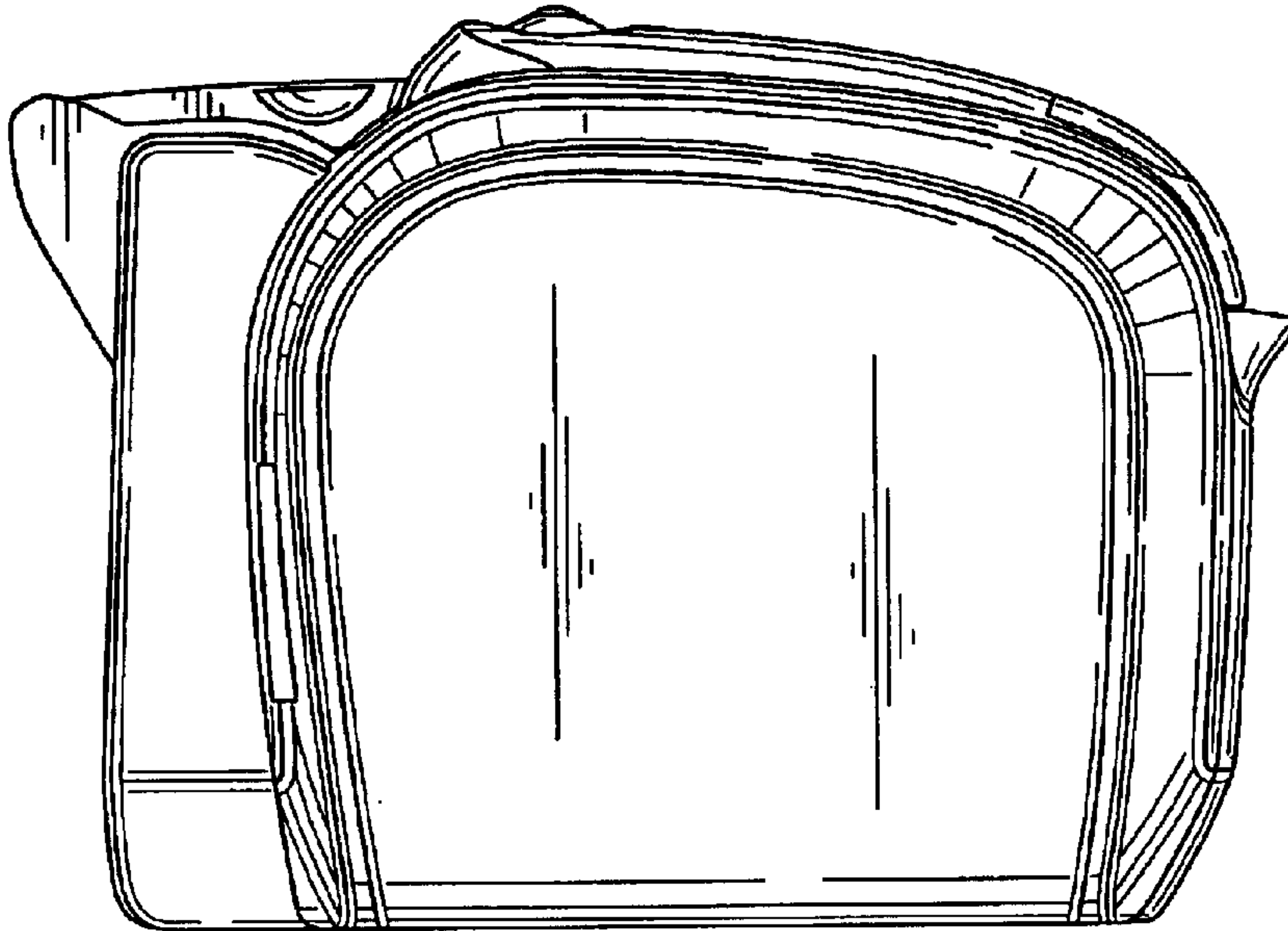

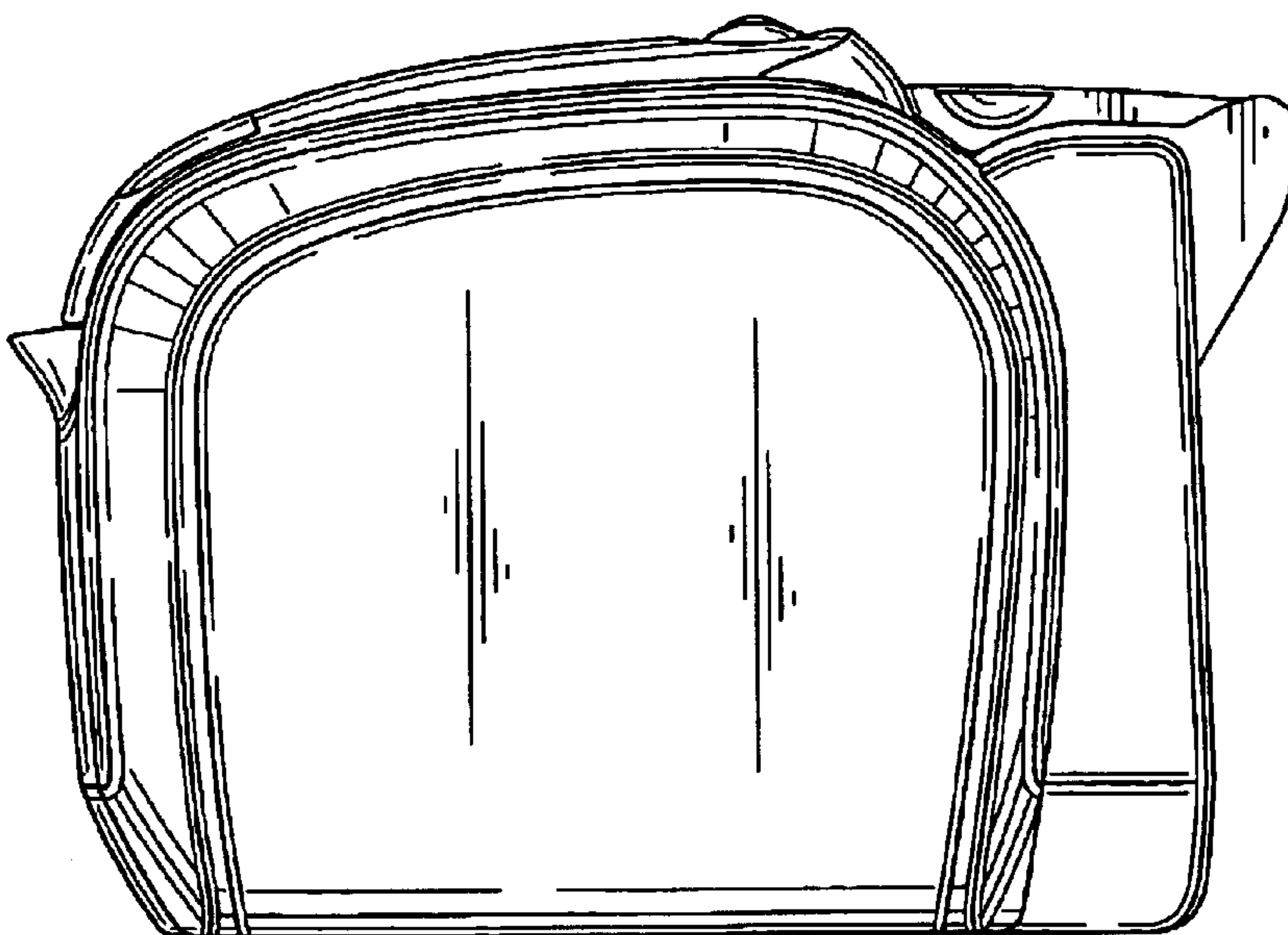

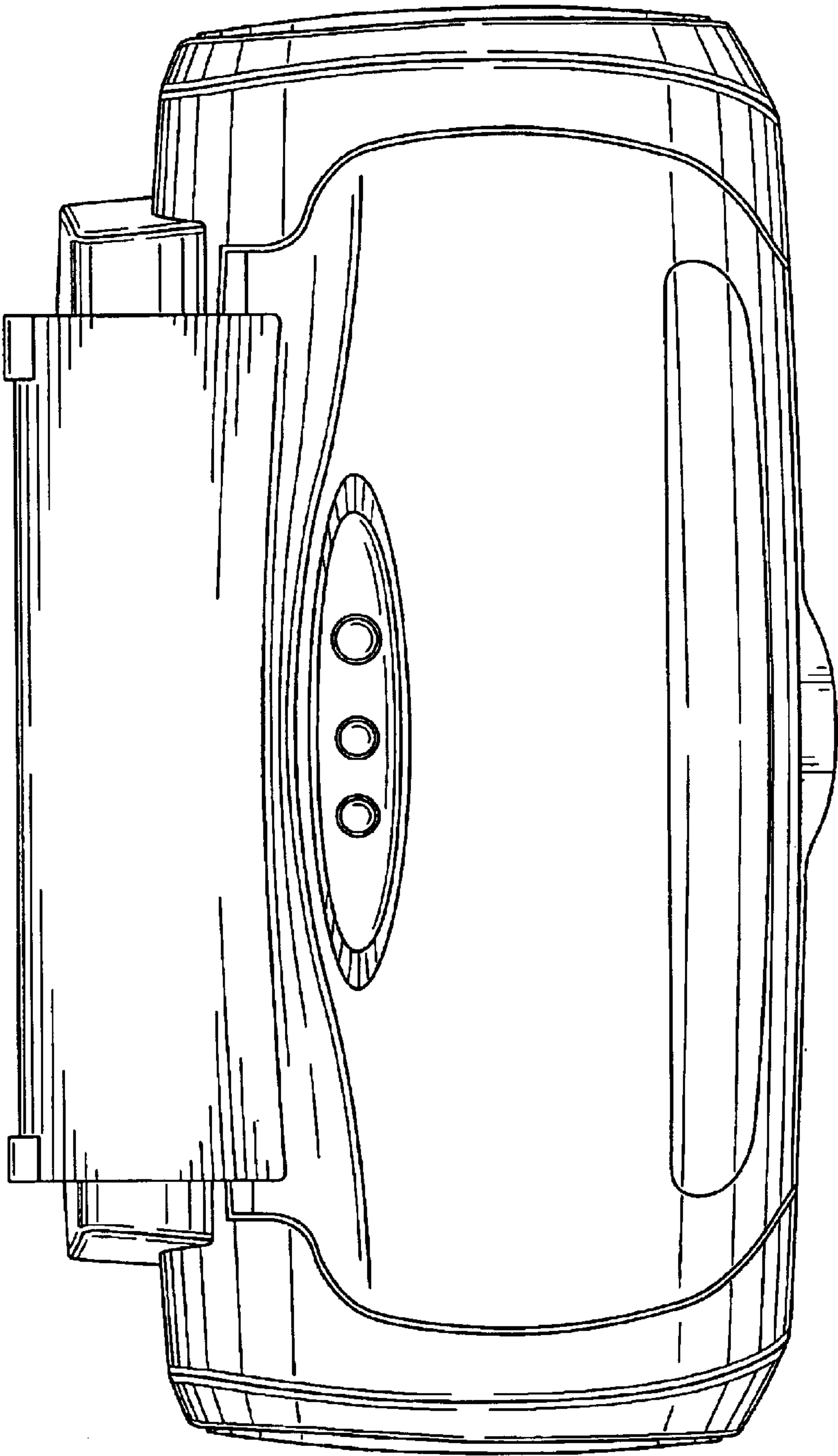
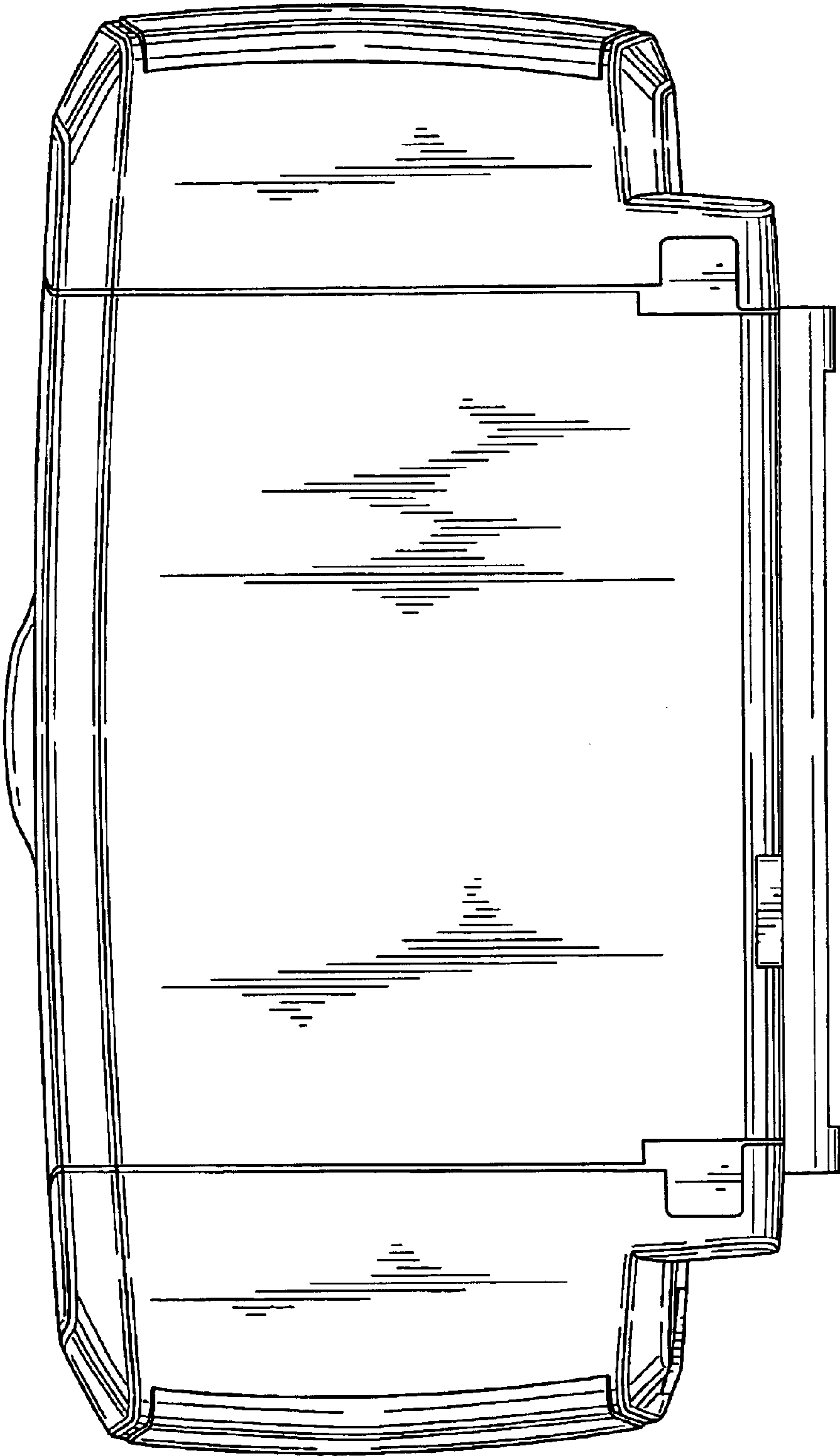

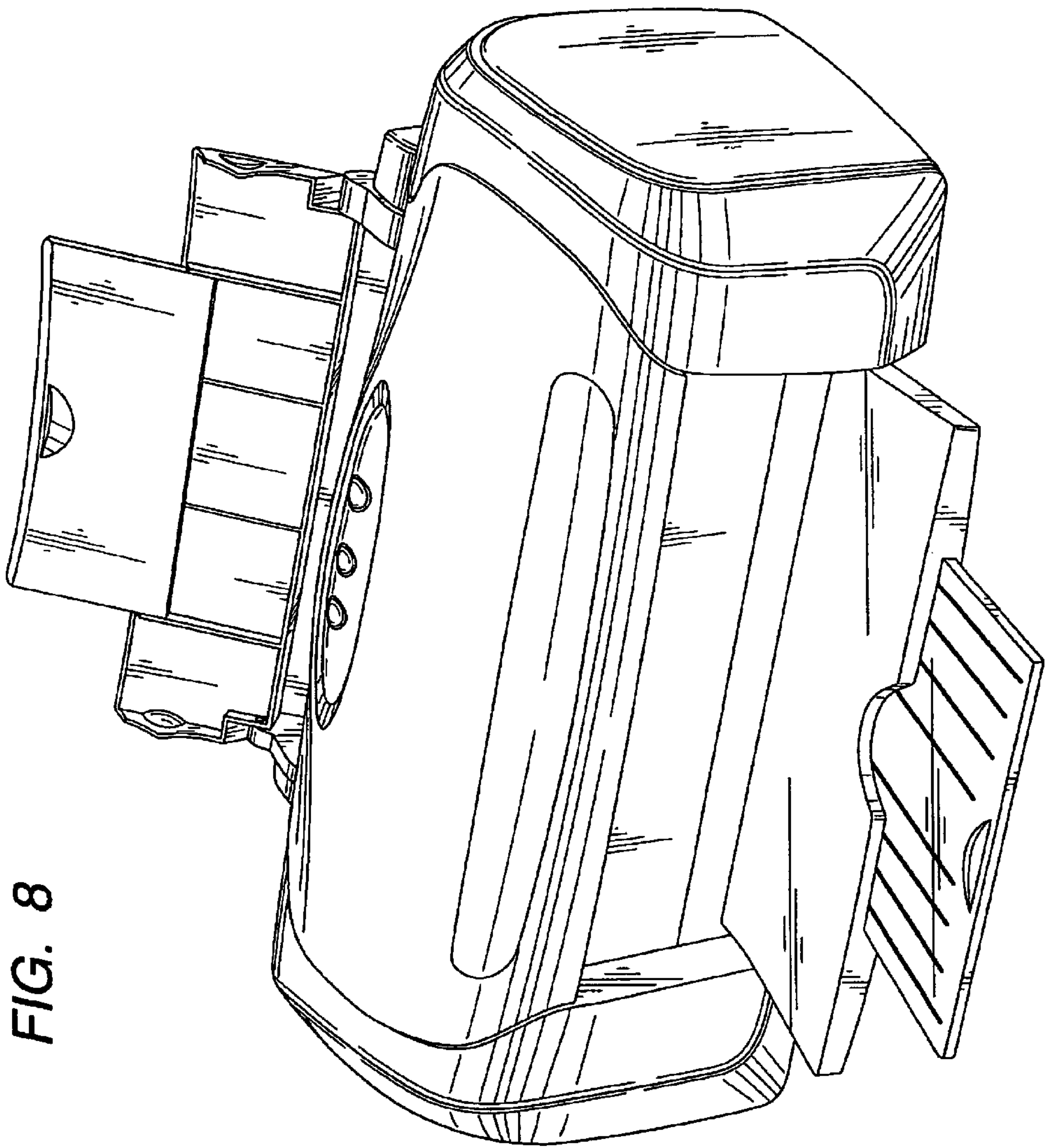
