(57) **CLAIM**

The ornamental design for a novelty promotional item, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of the present new design of a novelty promotional item;

FIG. 2 is a front view of the novelty promotional item of FIG. 1;

FIG. 3 is a bottom view of the novelty promotional item of FIG. 1;

FIG. 4 is a top view of the novelty promotional item of FIG. 1;

FIG. 5 is a side view of the novelty promotional item of FIG. 1, both sides being identical;

FIG. 6 is a perspective view of the novelty promotional item of FIG. 1, shown bent in the longitudinal direction;

FIG. 7 is a perspective view of the novelty promotional item of FIG. 1, shown with a top end and a bottom end twisted in opposite directions;

FIG. 8 is a perspective view of an alternate embodiment of the novelty promotional item of the present new design;

FIG. 9 is a front view of the novelty promotional item of FIG. 8, the bottom, top and both side views being identical to the bottom, top and both side views shown in FIGS. 3, 4 and 5, respectively;

FIG. 10 is a perspective view of the novelty promotional item of FIG. 8, shown bent in the longitudinal direction;

FIG. 11 is a perspective view of the novelty promotional item of FIG. 8, shown with a top end and a bottom end twisted in opposite directions; and,

FIG. 12 is a perspective view of the novelty promotional item of FIG. 8, shown in one sample environment.

The details shown in broken lines are for illustrative purposes only and form no part of the claimed design.

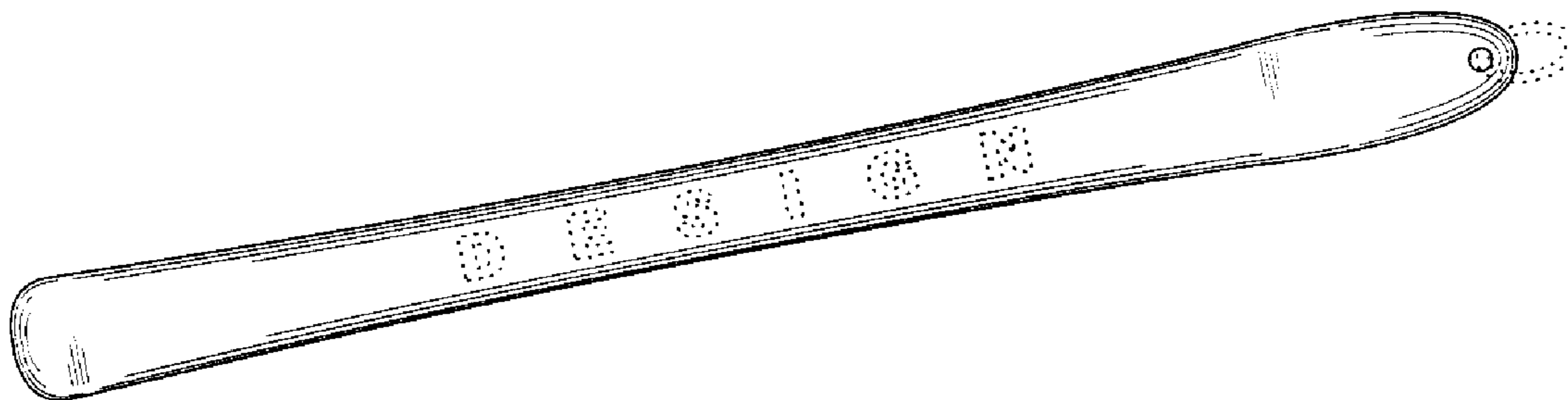

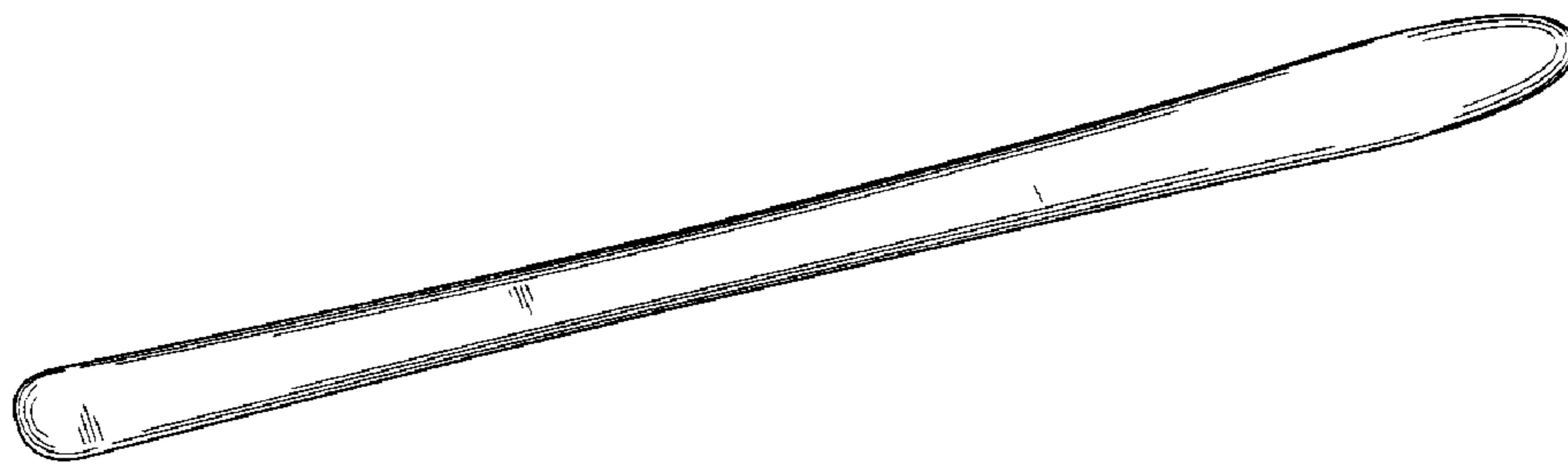

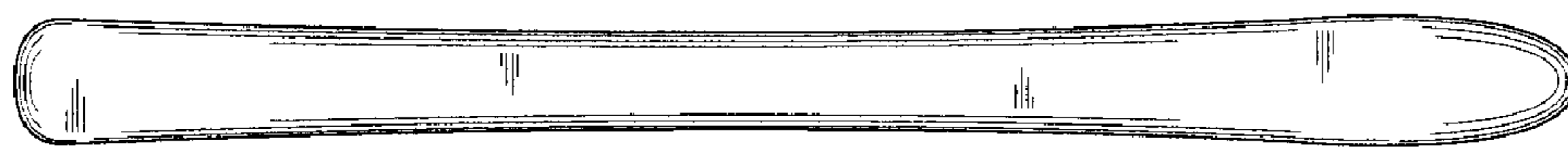


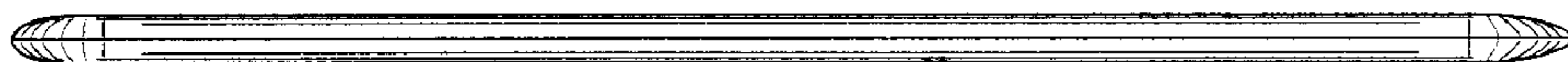

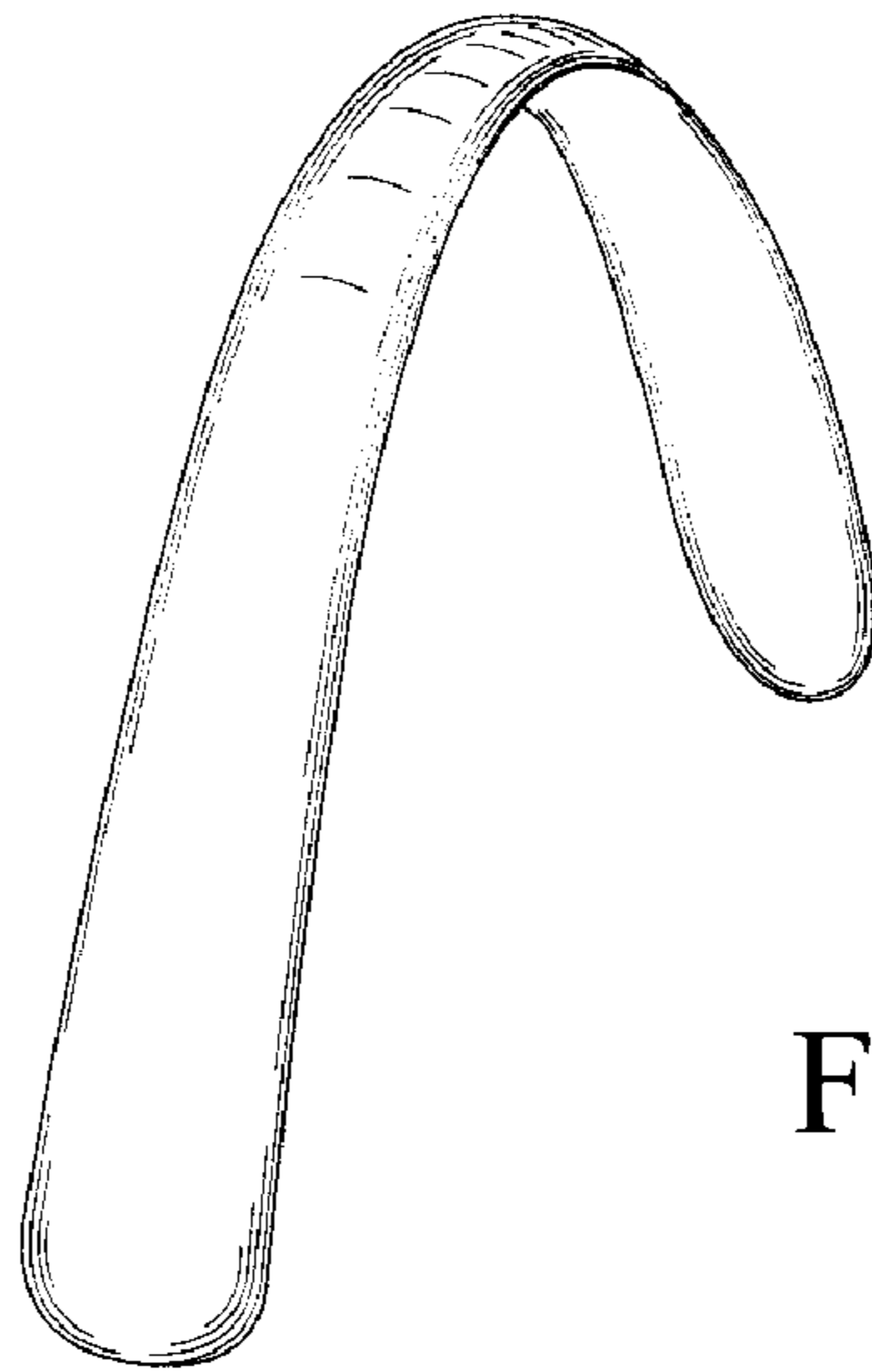

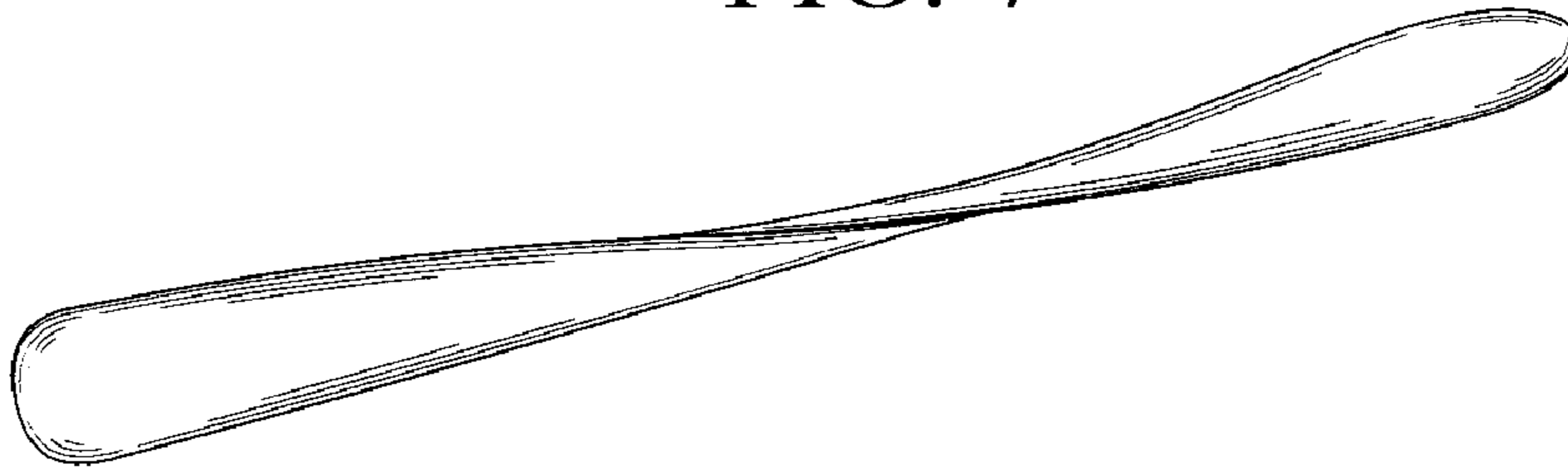

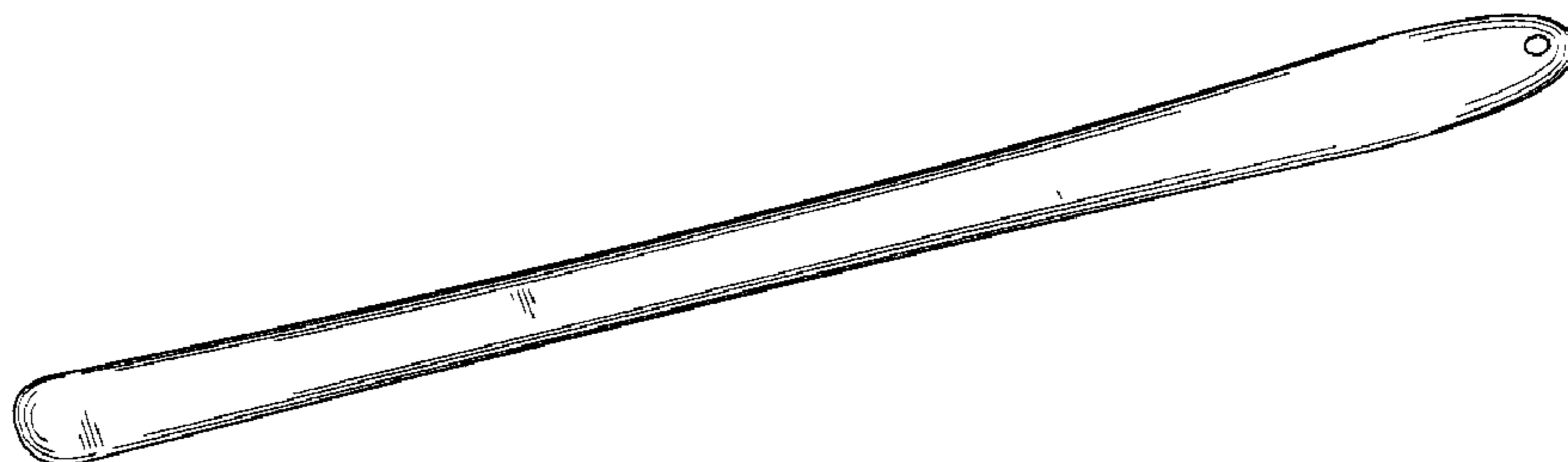

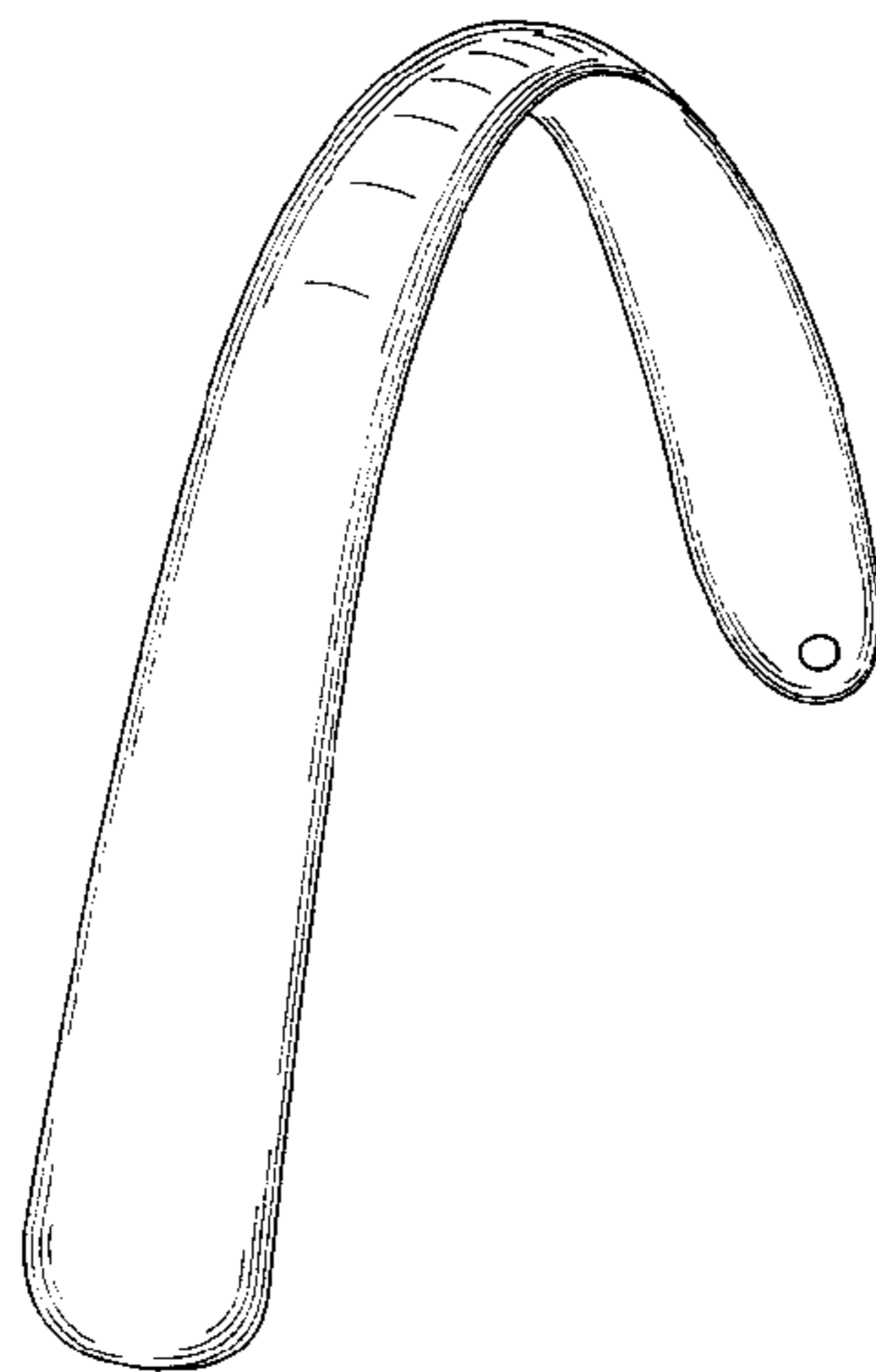
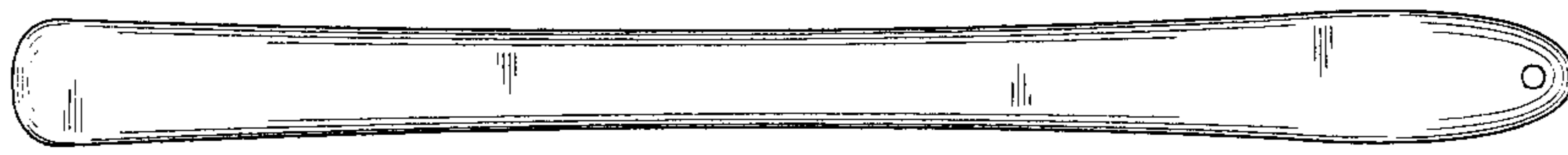

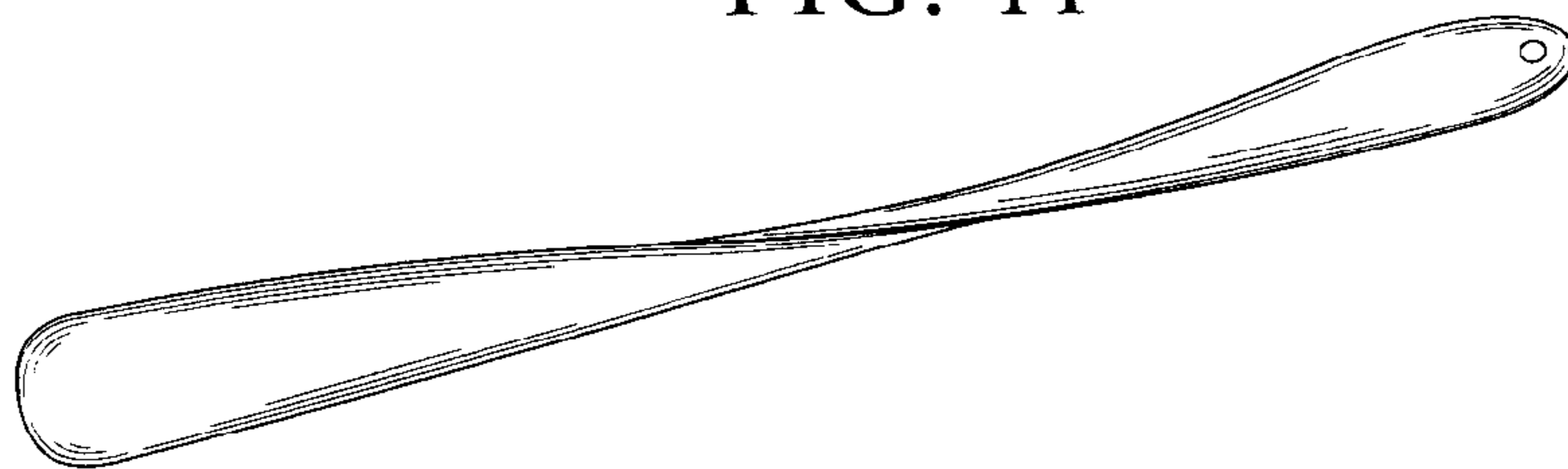
