DESCRIPTION

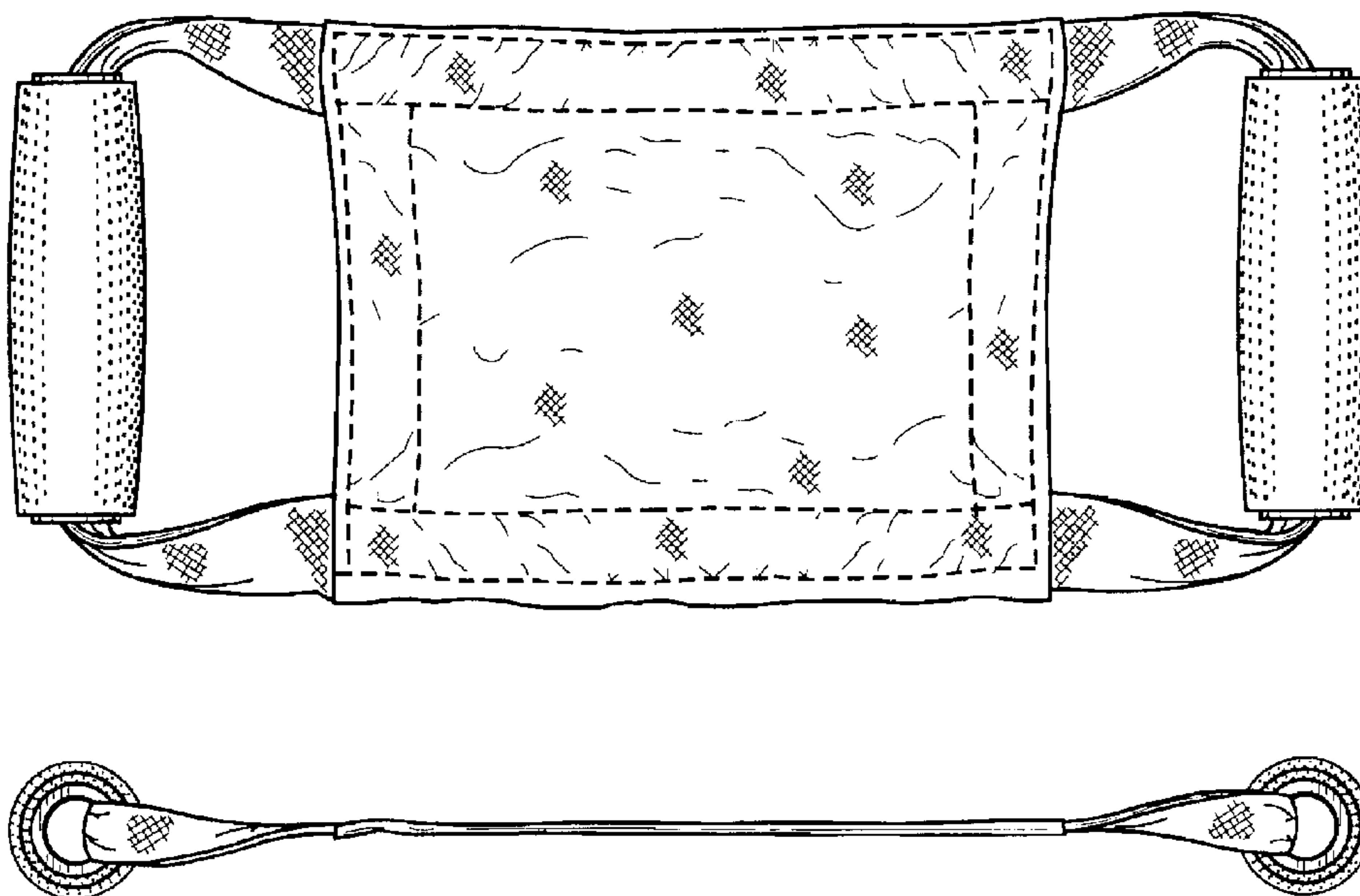
FIG. 1 is a elevation view of an exercise device showing my new design;

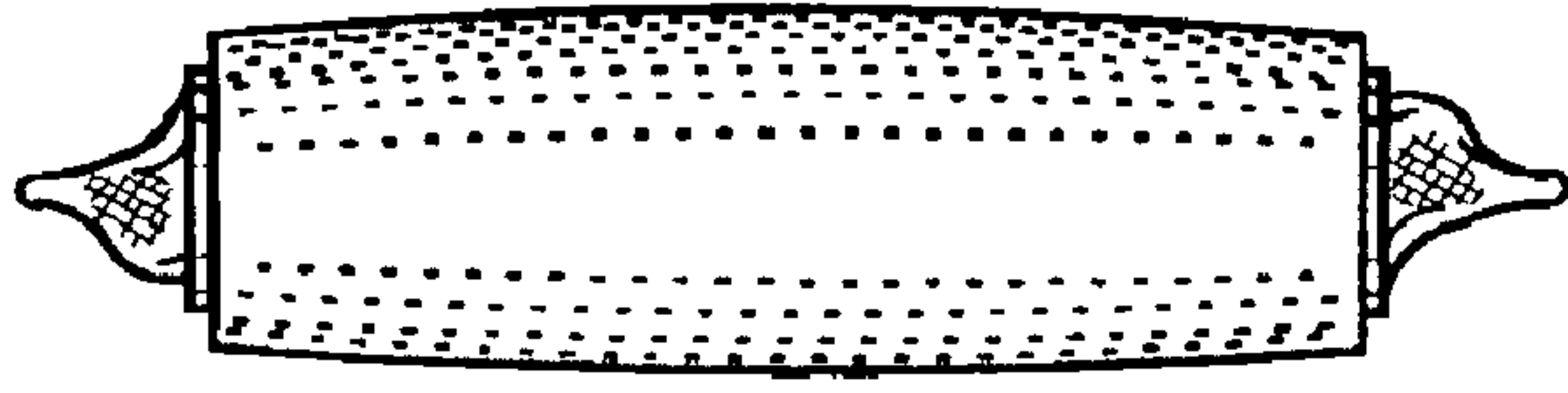

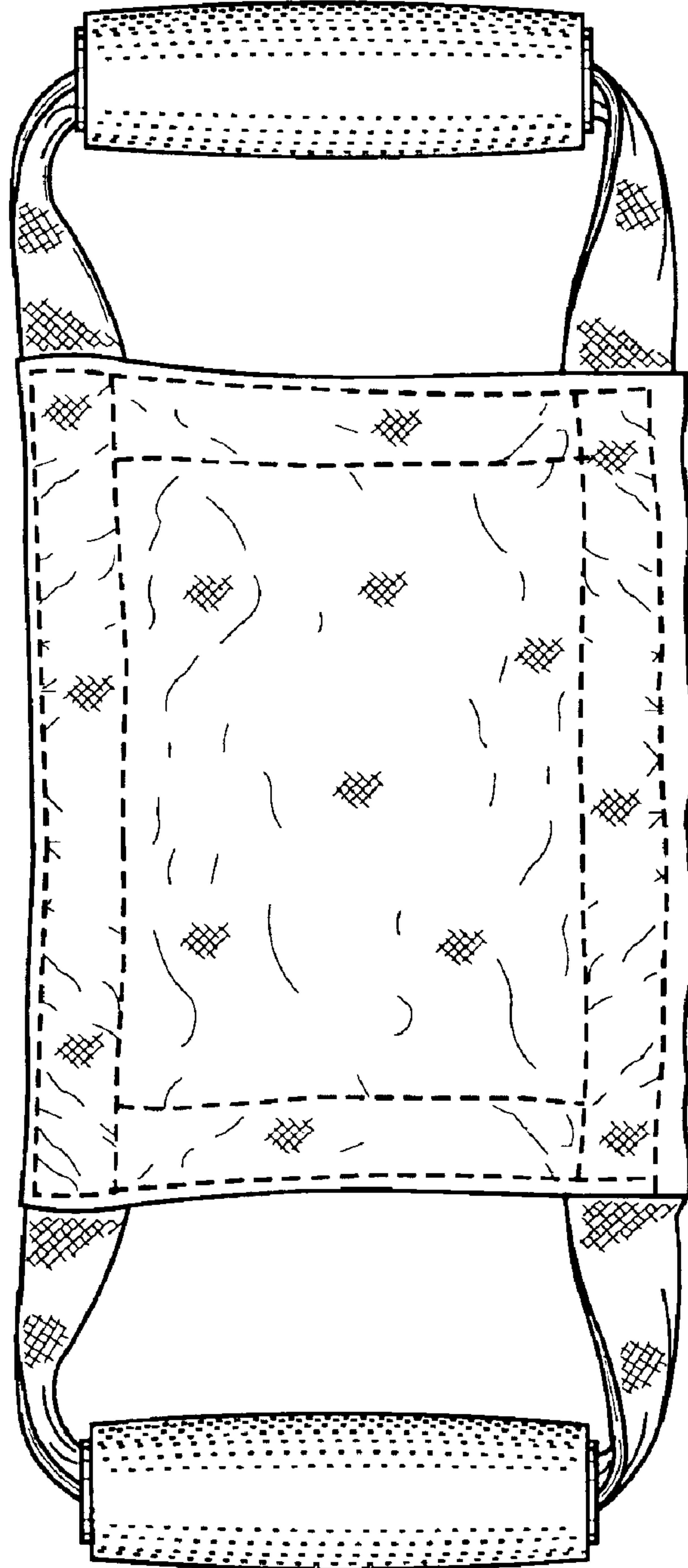

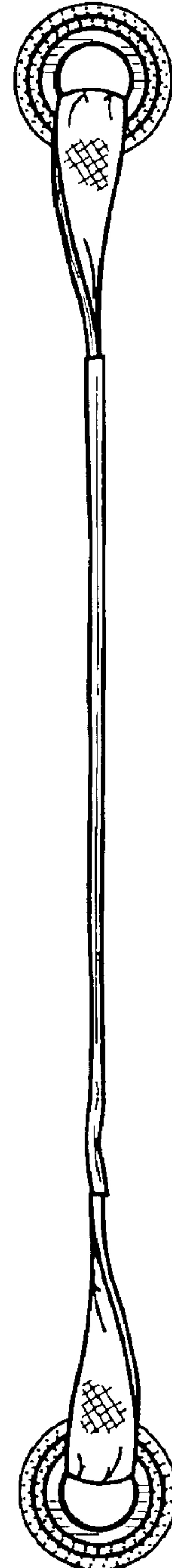
