(57) **CLAIM**

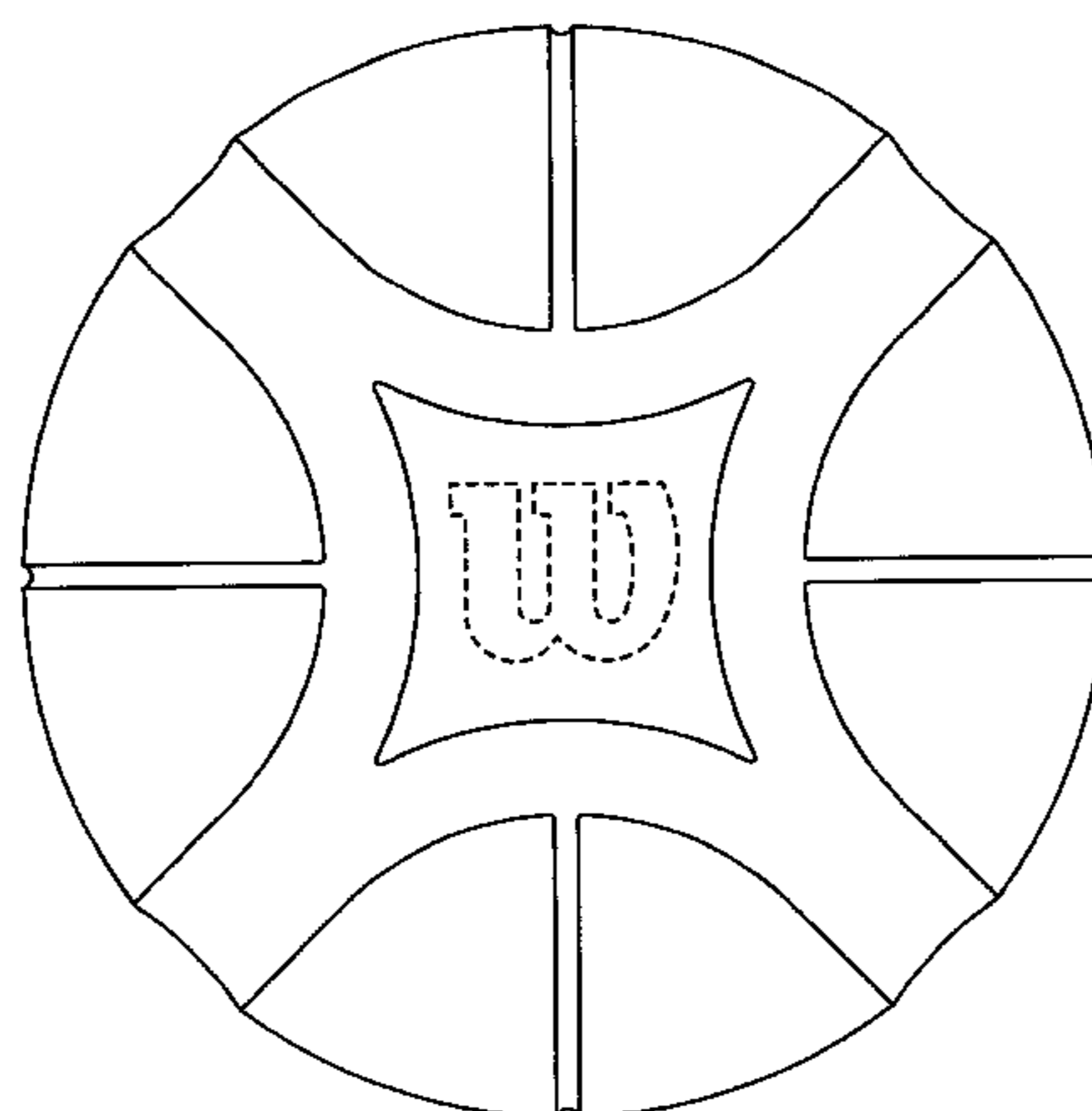
We claim the ornamental design for a basketball, as shown and described.

DESCRIPTION

FIG. 1 is a front view of a basketball of the present design; FIG. 2 is a top view of the basketball of FIG. 1; FIG. 3 is a rear view of the basketball of FIG. 1; and, FIG. 4 is a bottom view of the basketball of FIG. 1.

The ornamental design that is claimed is shown in solid lines in the drawings. The broken (dashed) lines shown in FIGS. 1 and 3 are included only for the purpose of illustrating environmental elements, and form no part of the claimed design.

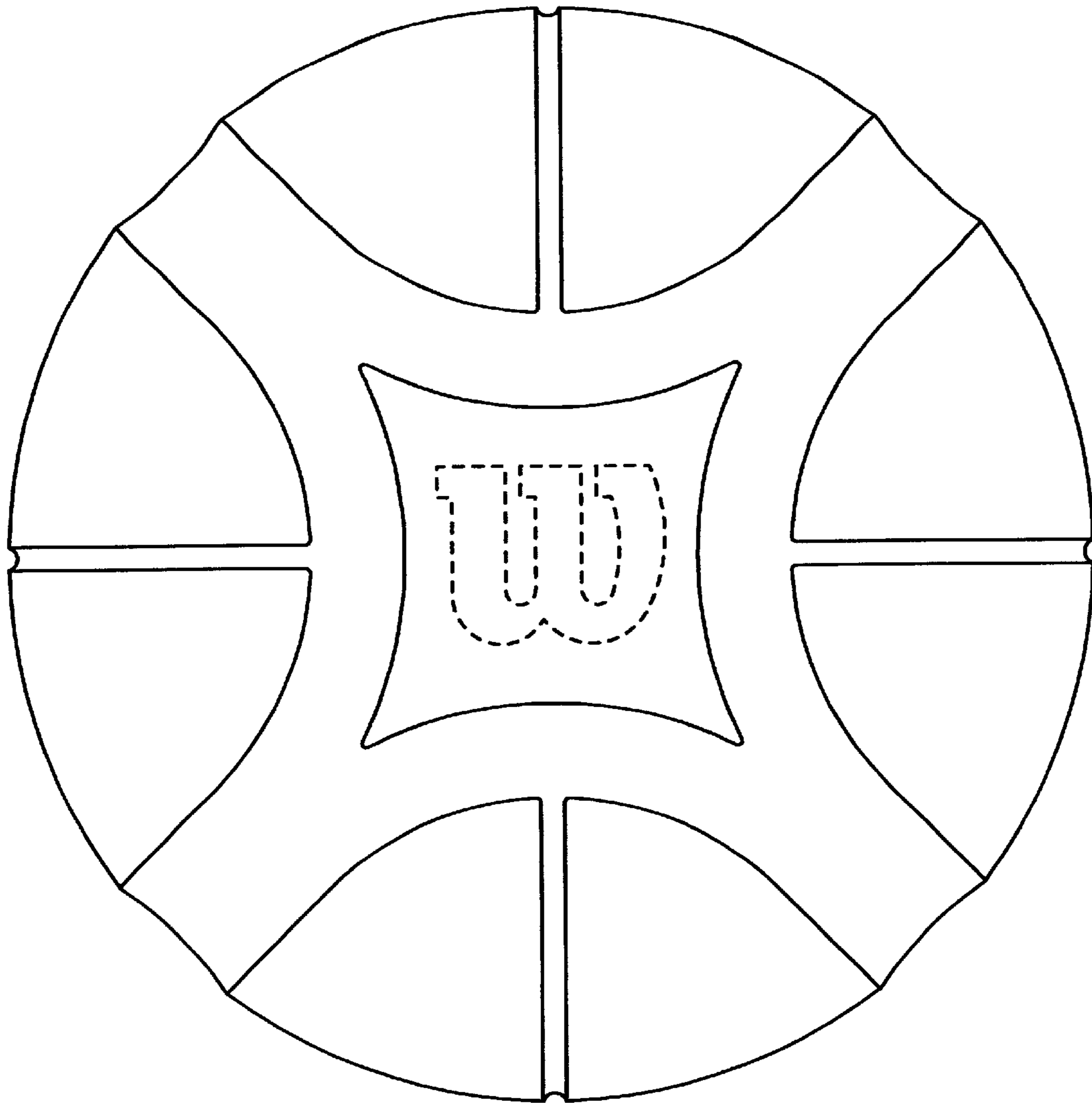

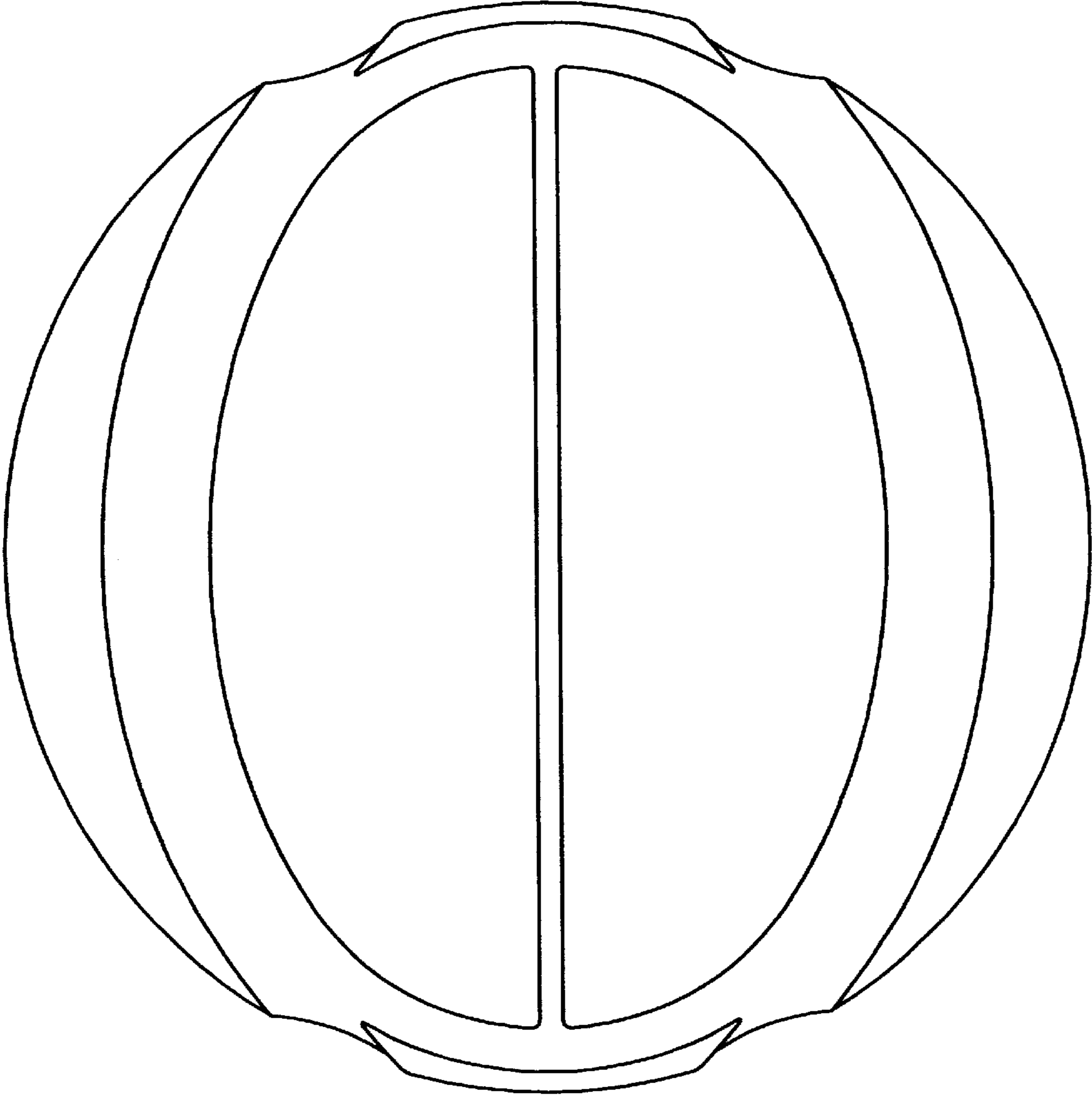

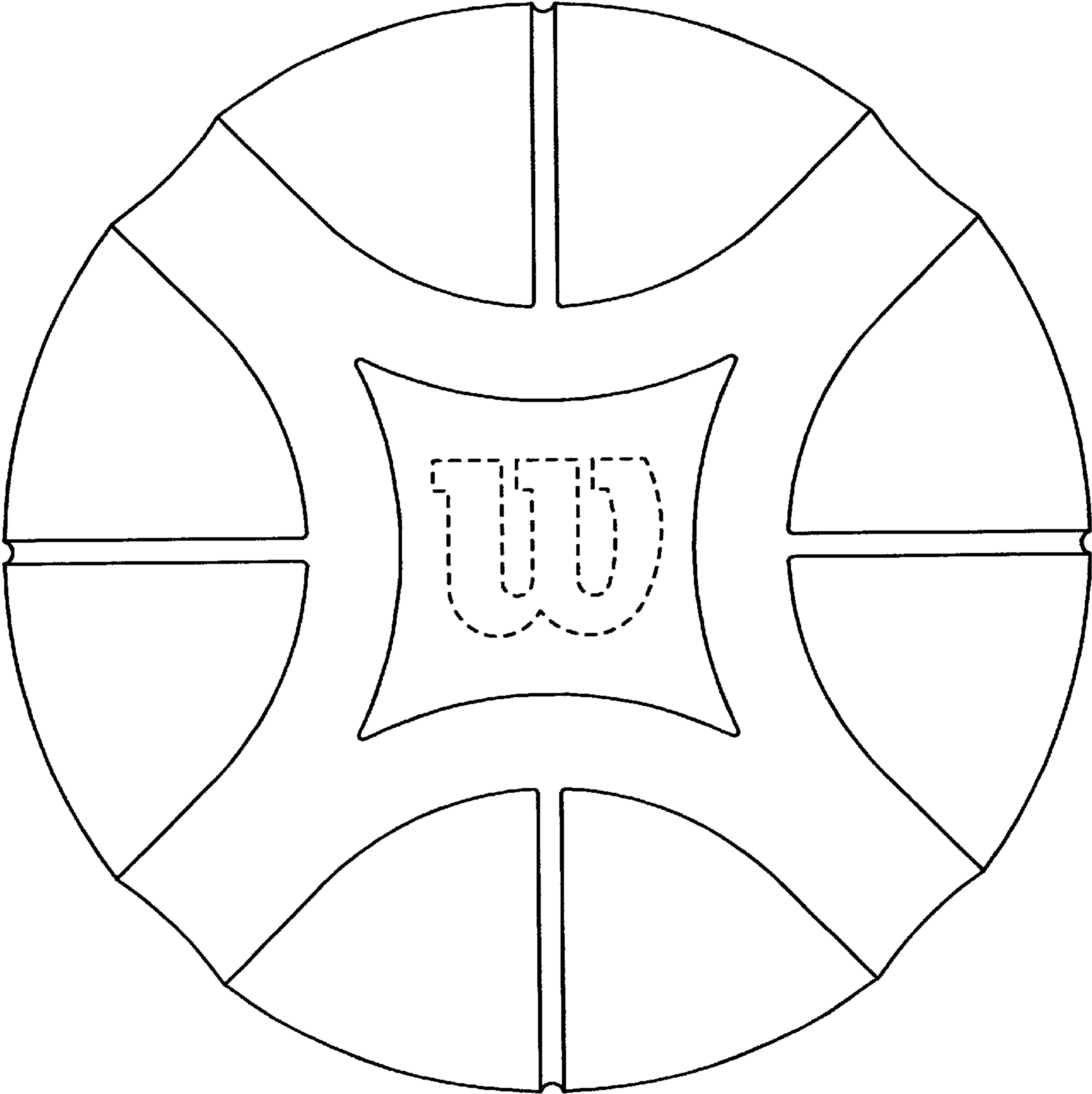
