(57) **CLAIM**

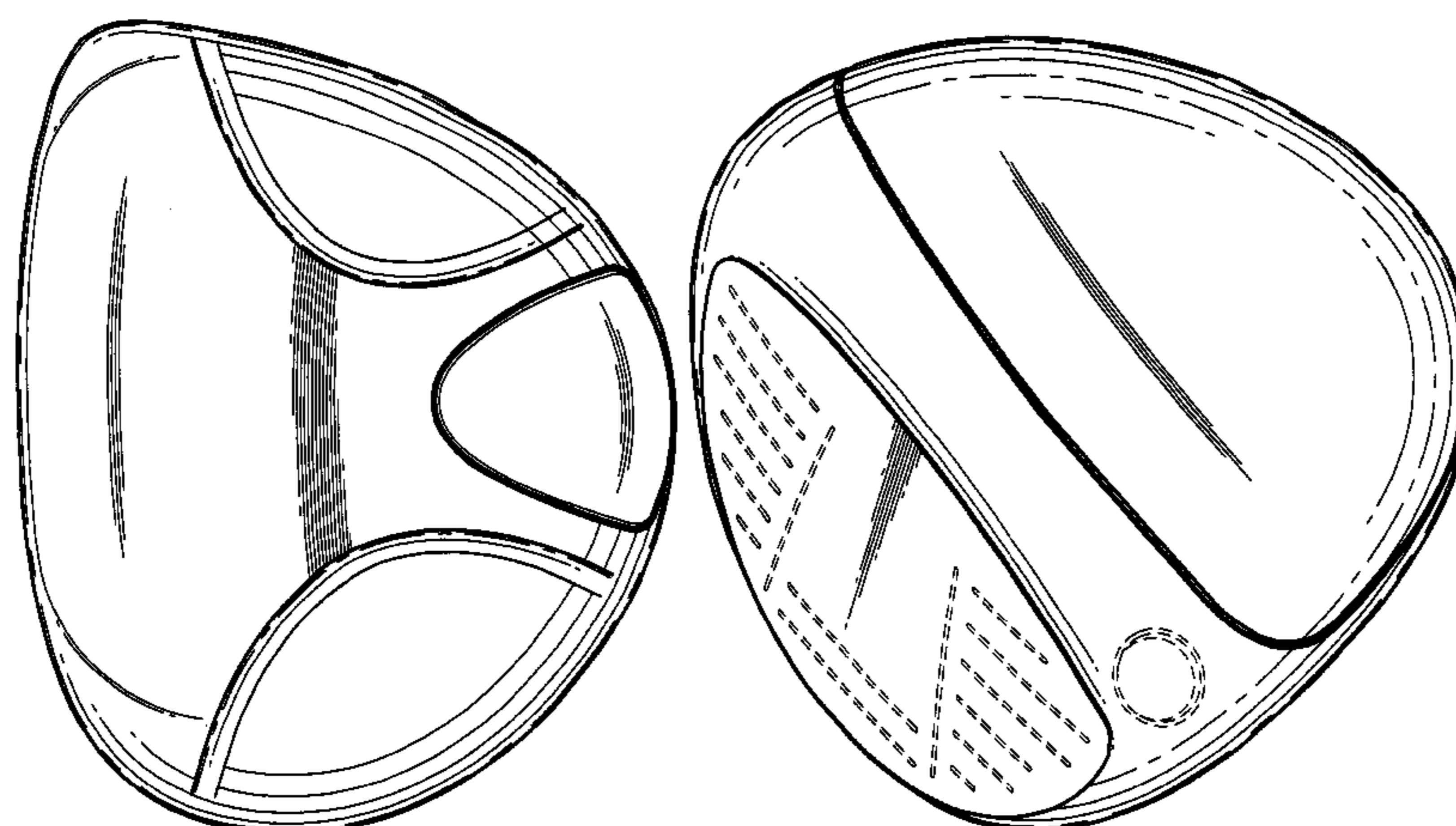
The ornamental design for a golf club head, as shown and described.

DESCRIPTION

FIG. 1 is a bottom plan view of sole for a golf club head; FIG. 2 is a top plan view thereof; FIG. 3 is top perspective view thereof; FIG. 4 is a rear perspective view thereof; FIG. 5 is a toe plan view thereof; and, FIG. 6 is a heel plan view thereof.

The broken line showing is for illustrative purposes only and forms no part of the claimed design.

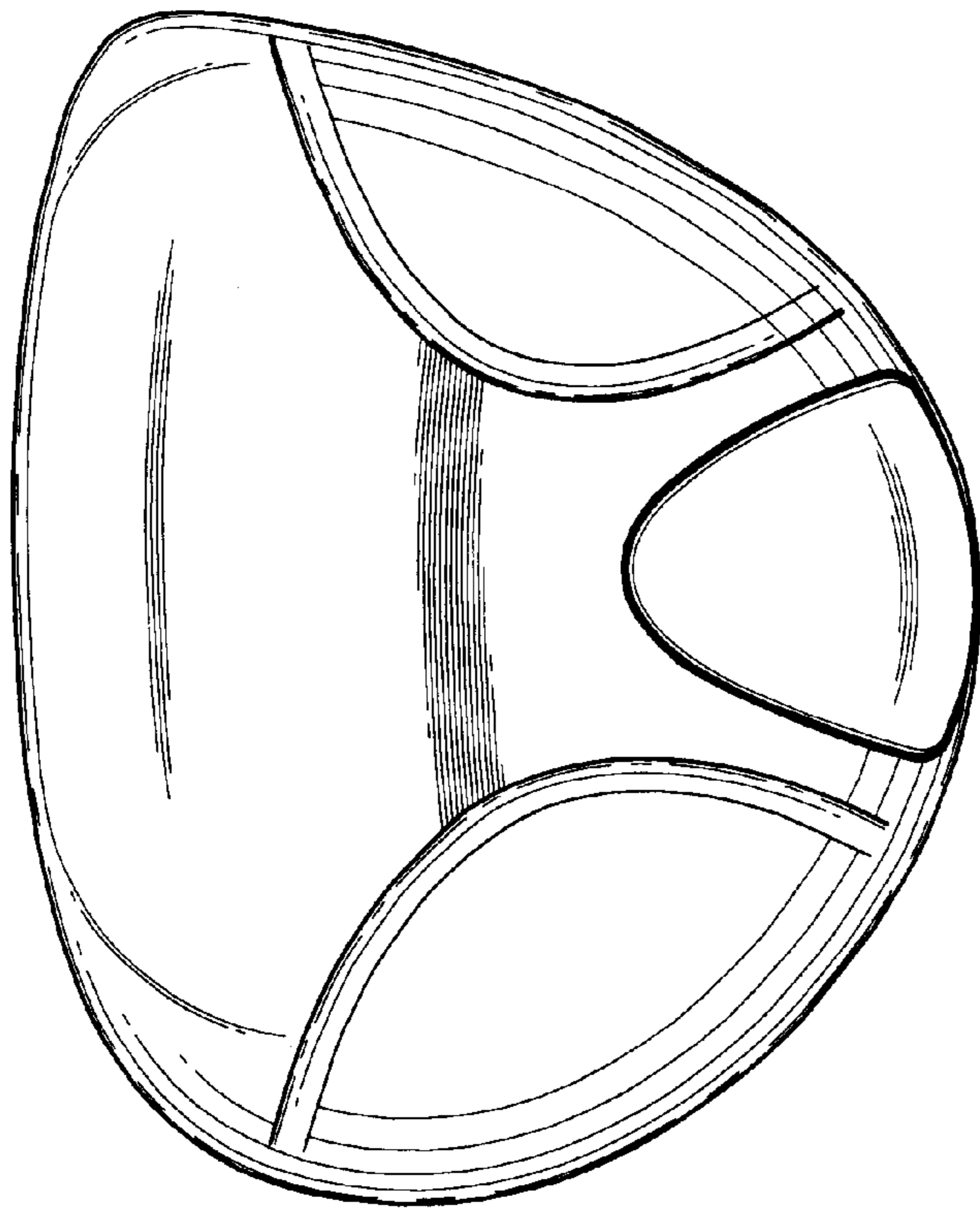

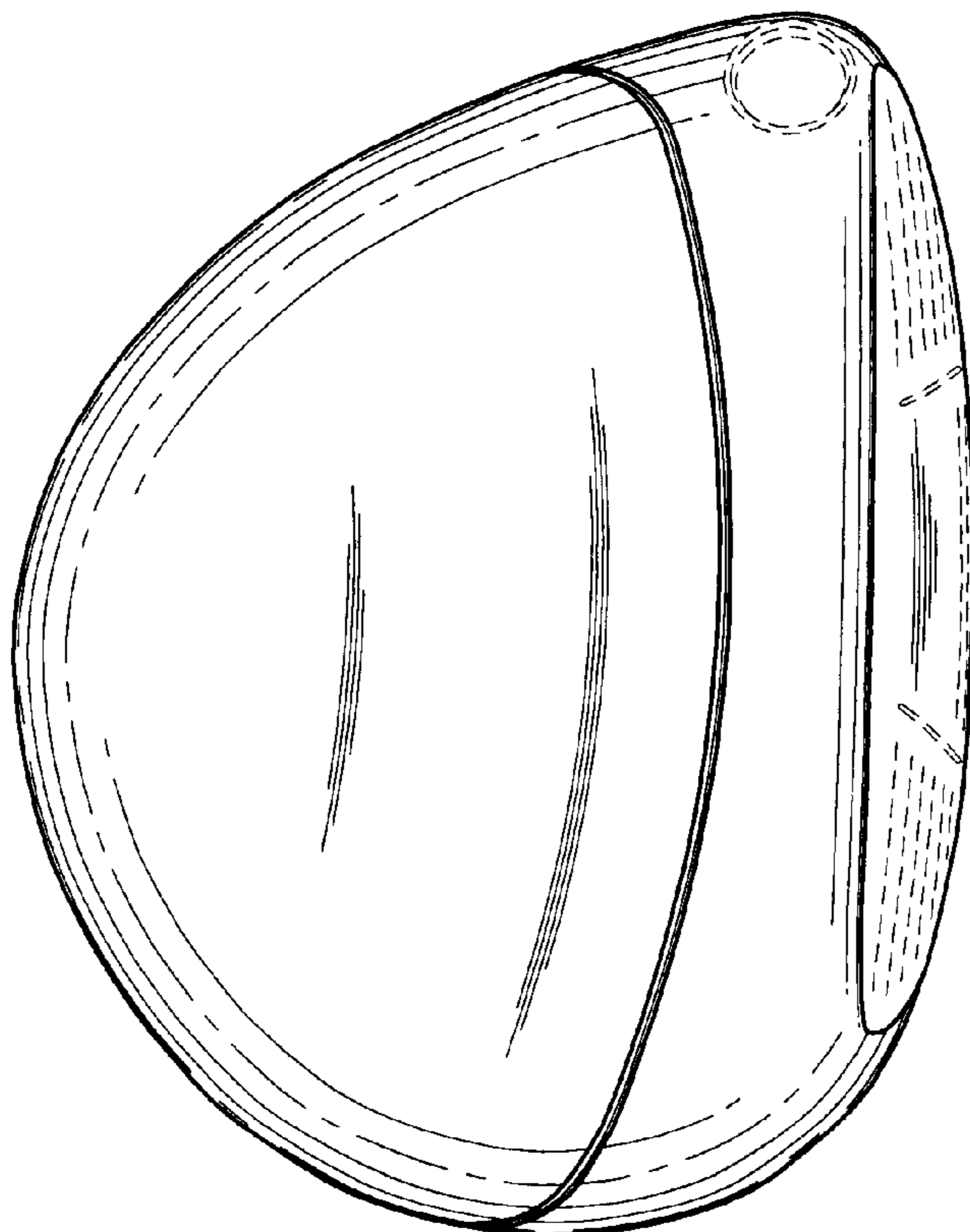

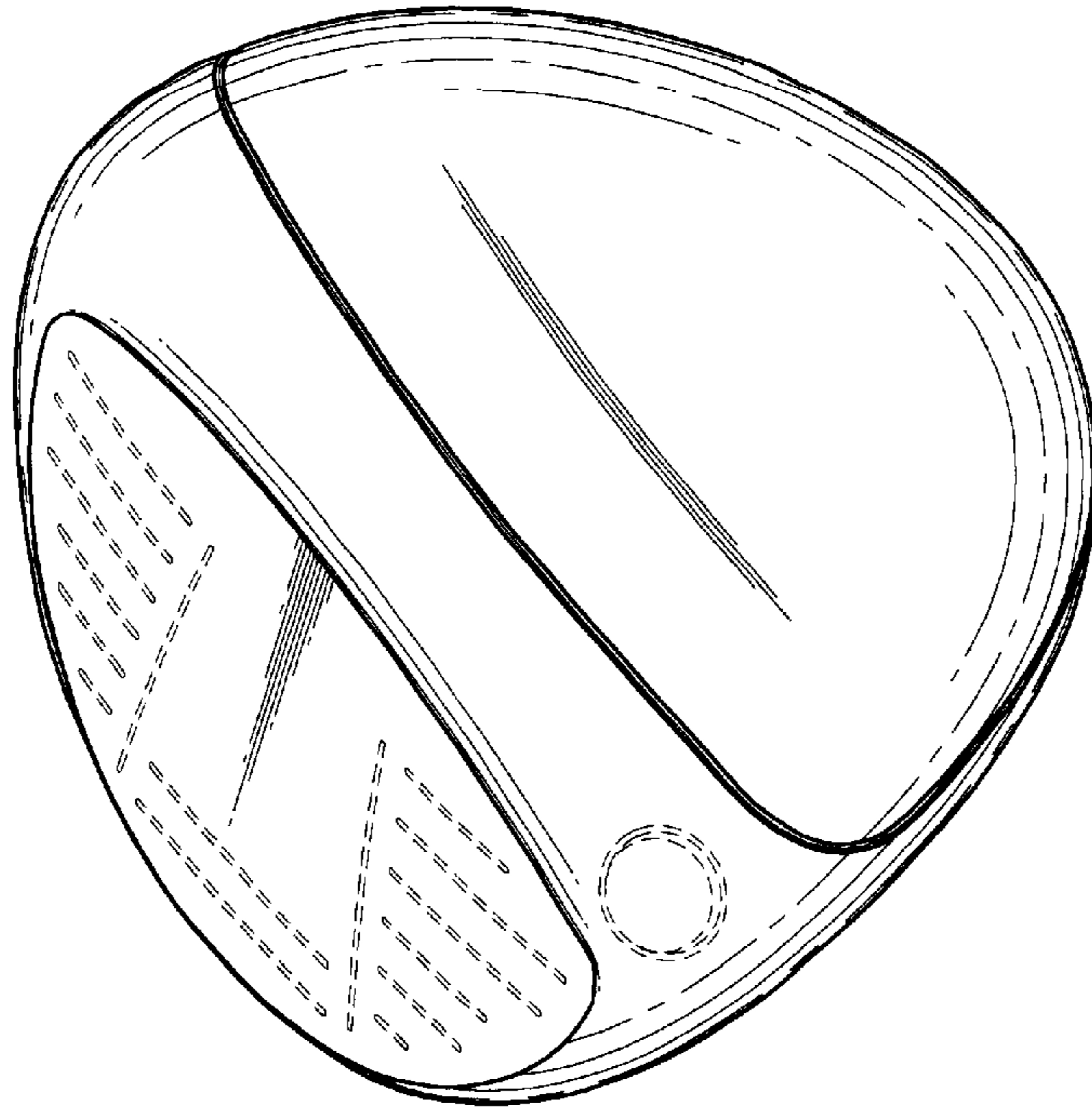

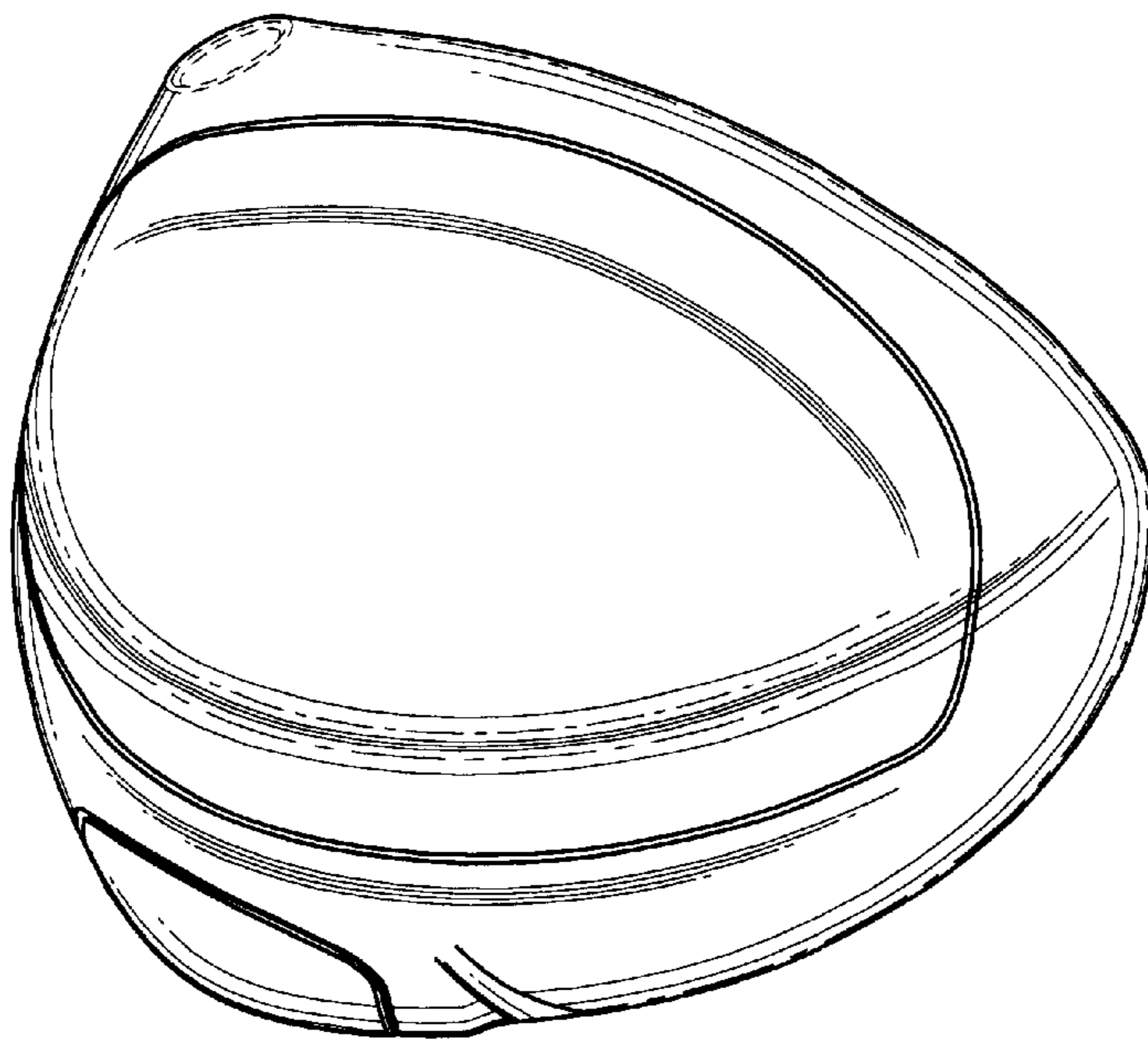

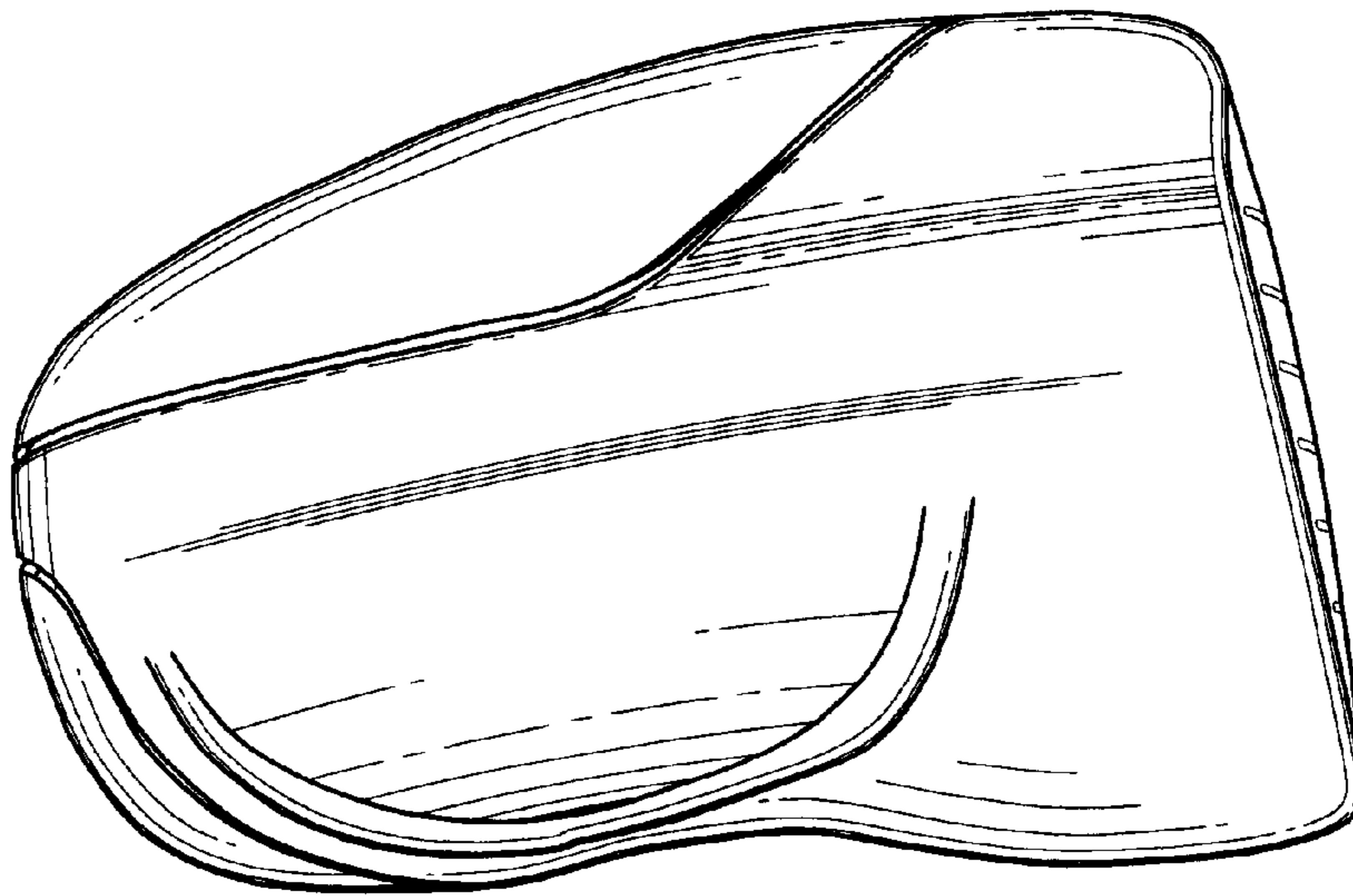

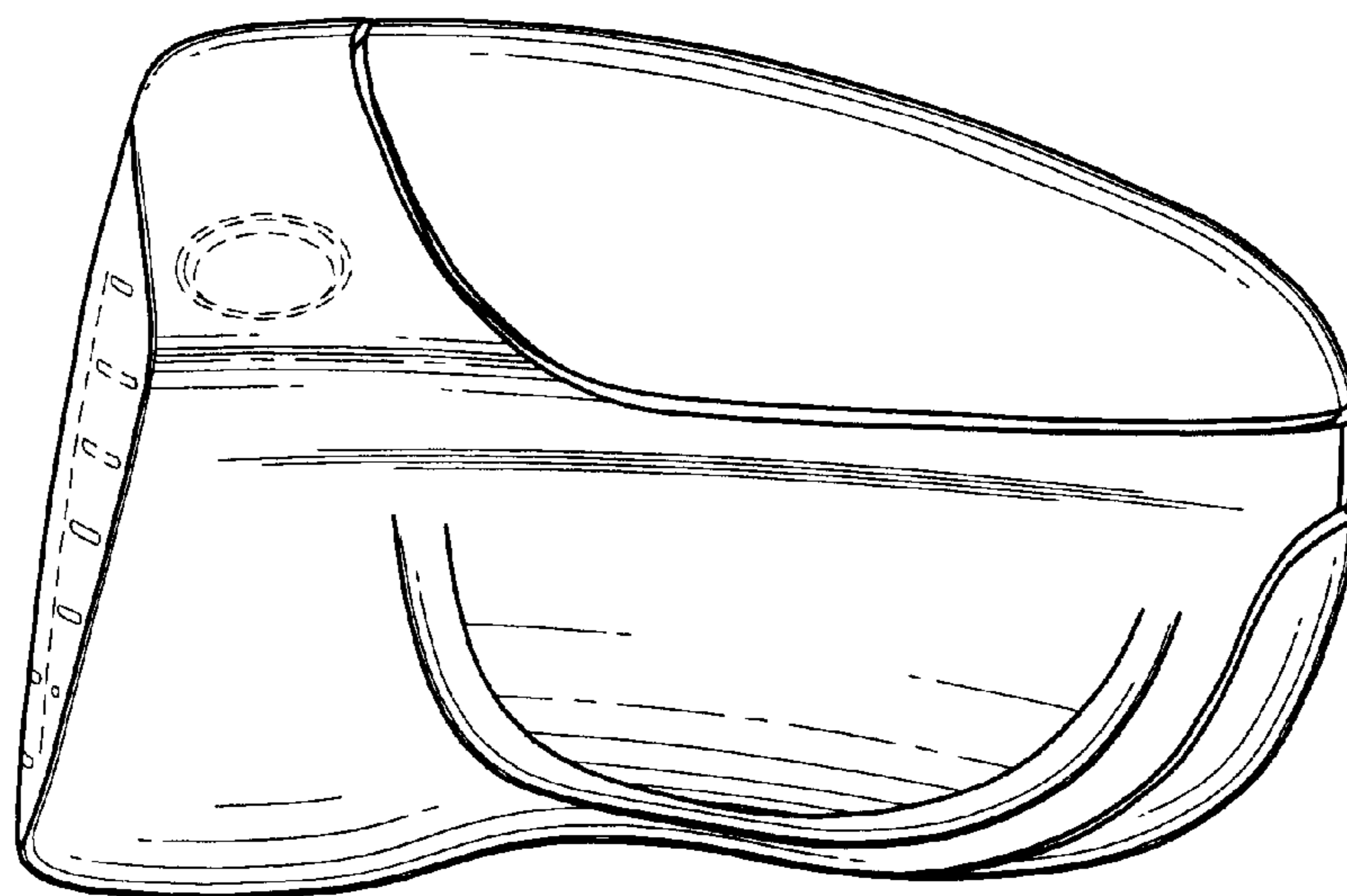
